FIG. 3 is a front, top, right-hand side perspective view thereof;

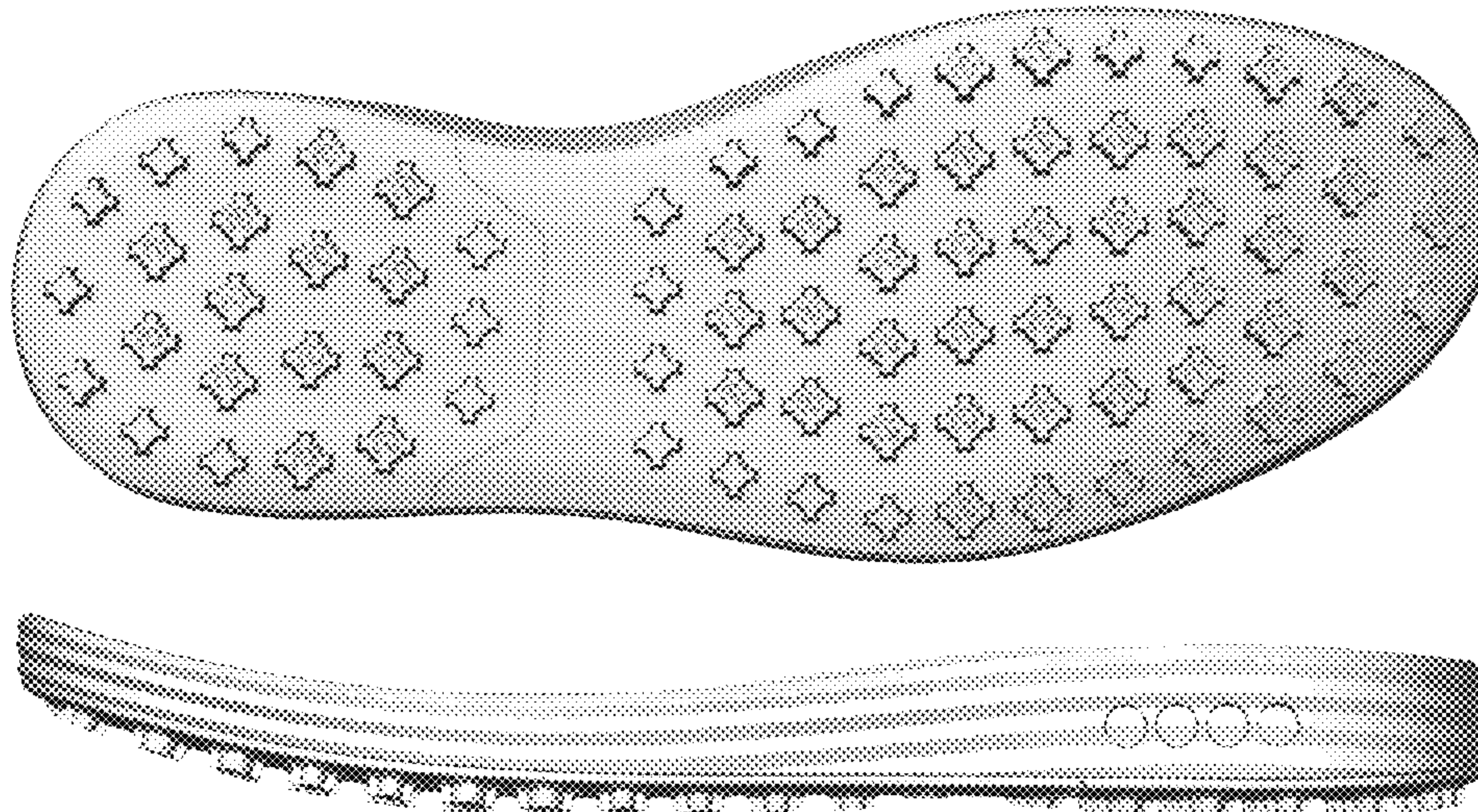
FIG. 4 is a top view thereof;

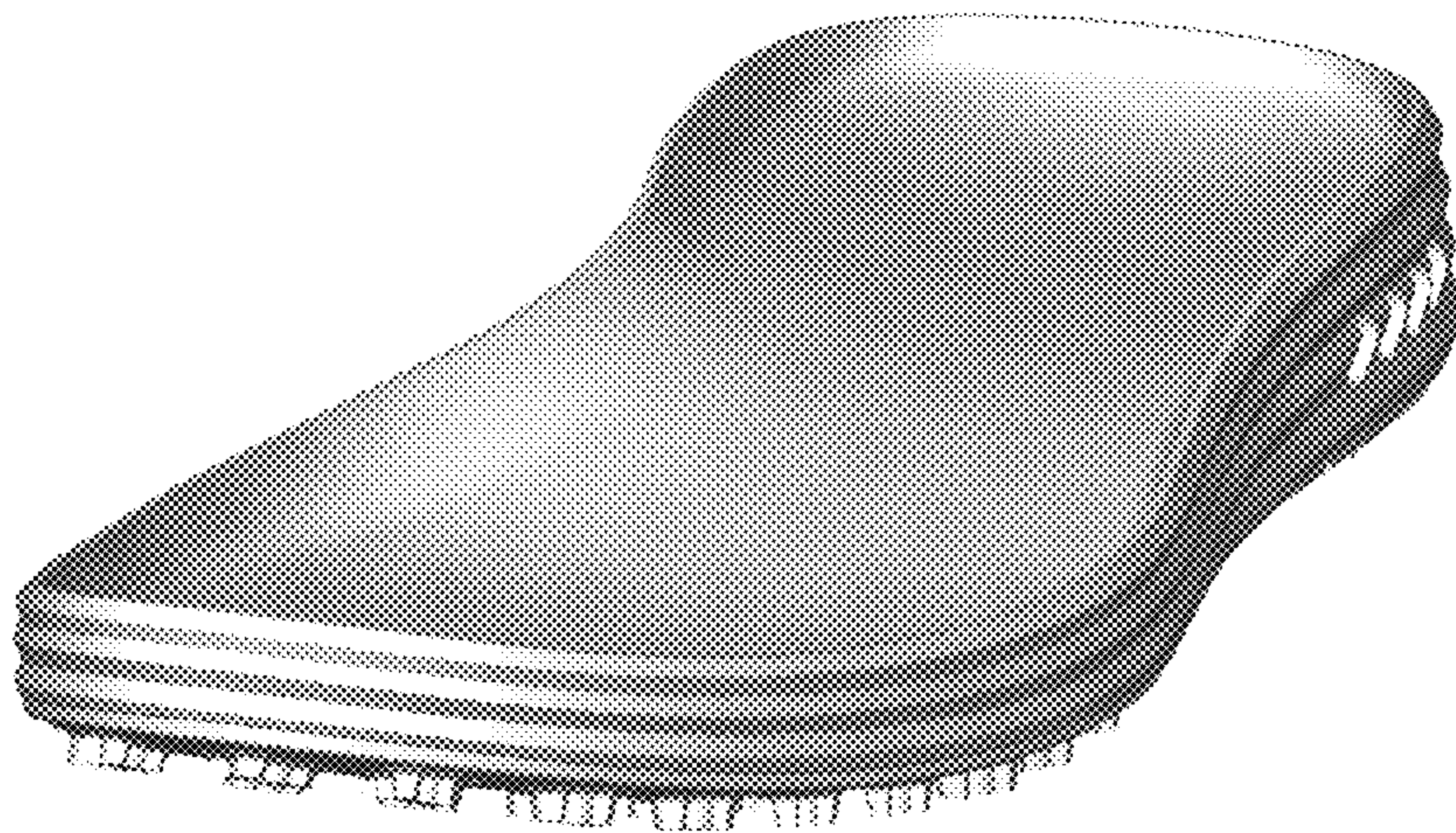

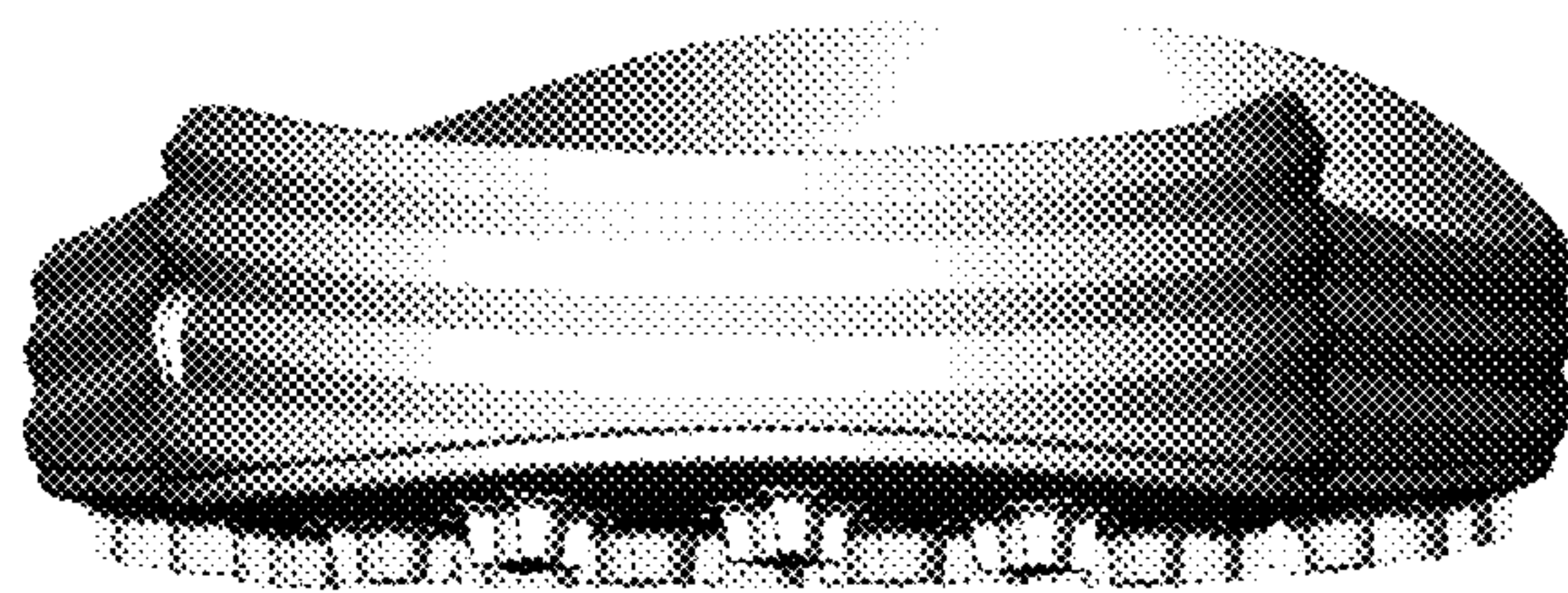

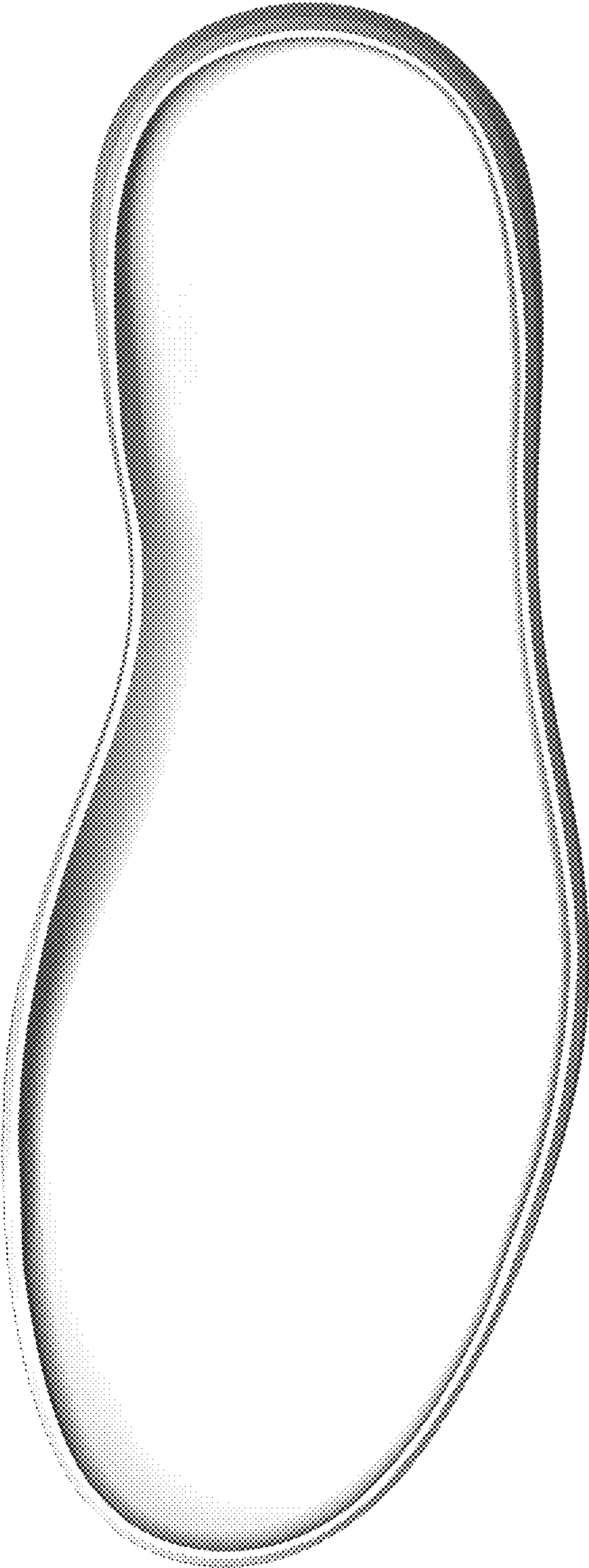

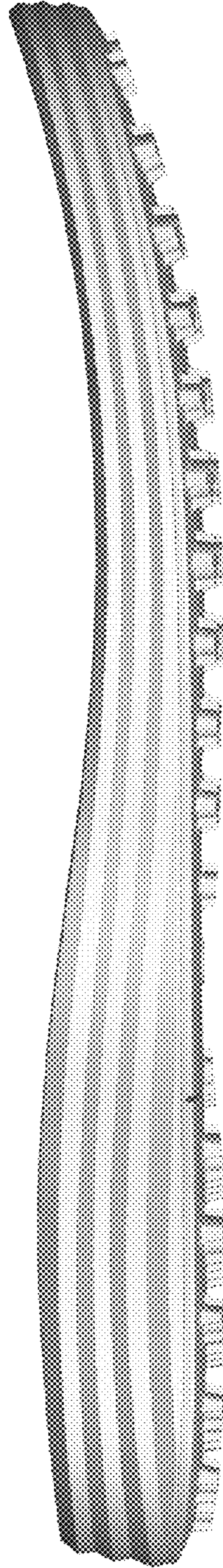

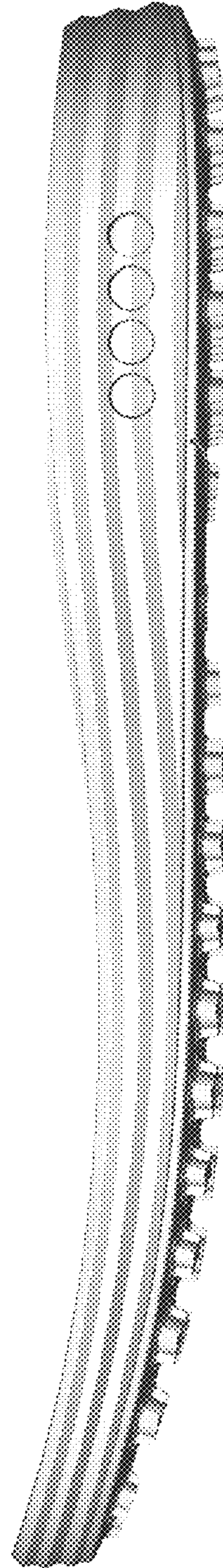
