(57) **CLAIM**

The ornamental design for a suitcase, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a suitcase with the strap shown in an upright position;
 FIG. 2 is a front view of the suitcase depicted in FIG. 1;
 FIG. 3 is a back view of the suitcase depicted in FIG. 1;
 FIG. 4 is a right view of the suitcase depicted in FIG. 1;
 FIG. 5 is a left view of the suitcase depicted in FIG. 1;
 FIG. 6 is a top view of the suitcase depicted in FIG. 1 with the strap in a downward draped position; and,
 FIG. 7 is a bottom view of the suitcase depicted in FIG. 1.

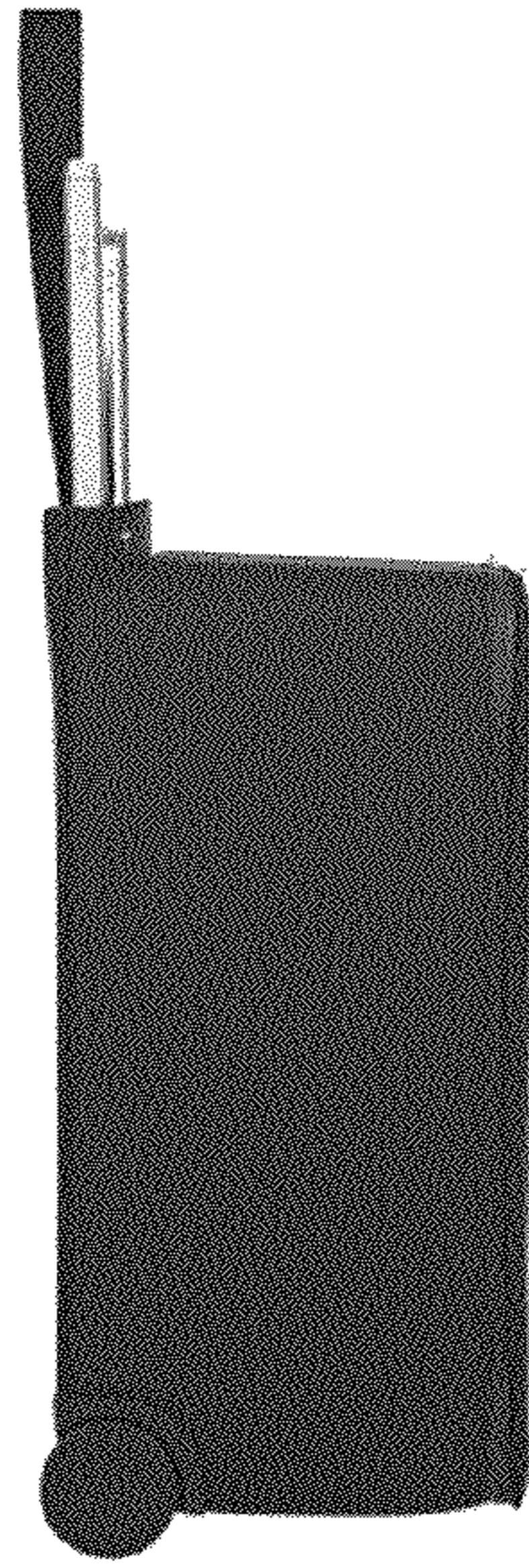
