our new design, the left side being a mirror image;

FIG. 2 is a top plan view thereof;

FIG. 5 is a rear elevational view thereof.

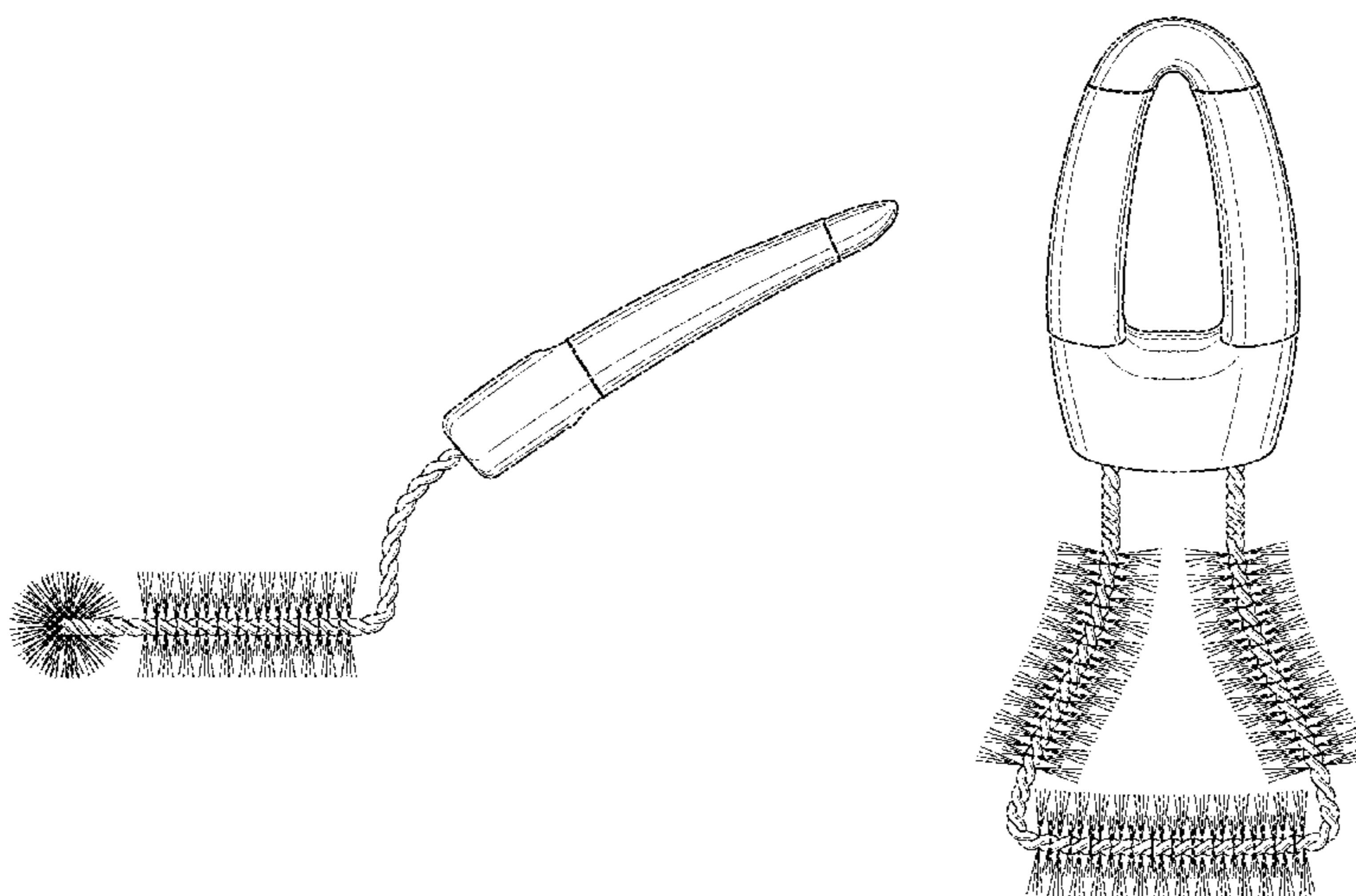
The bristles are partially shown for ease of illustration, it

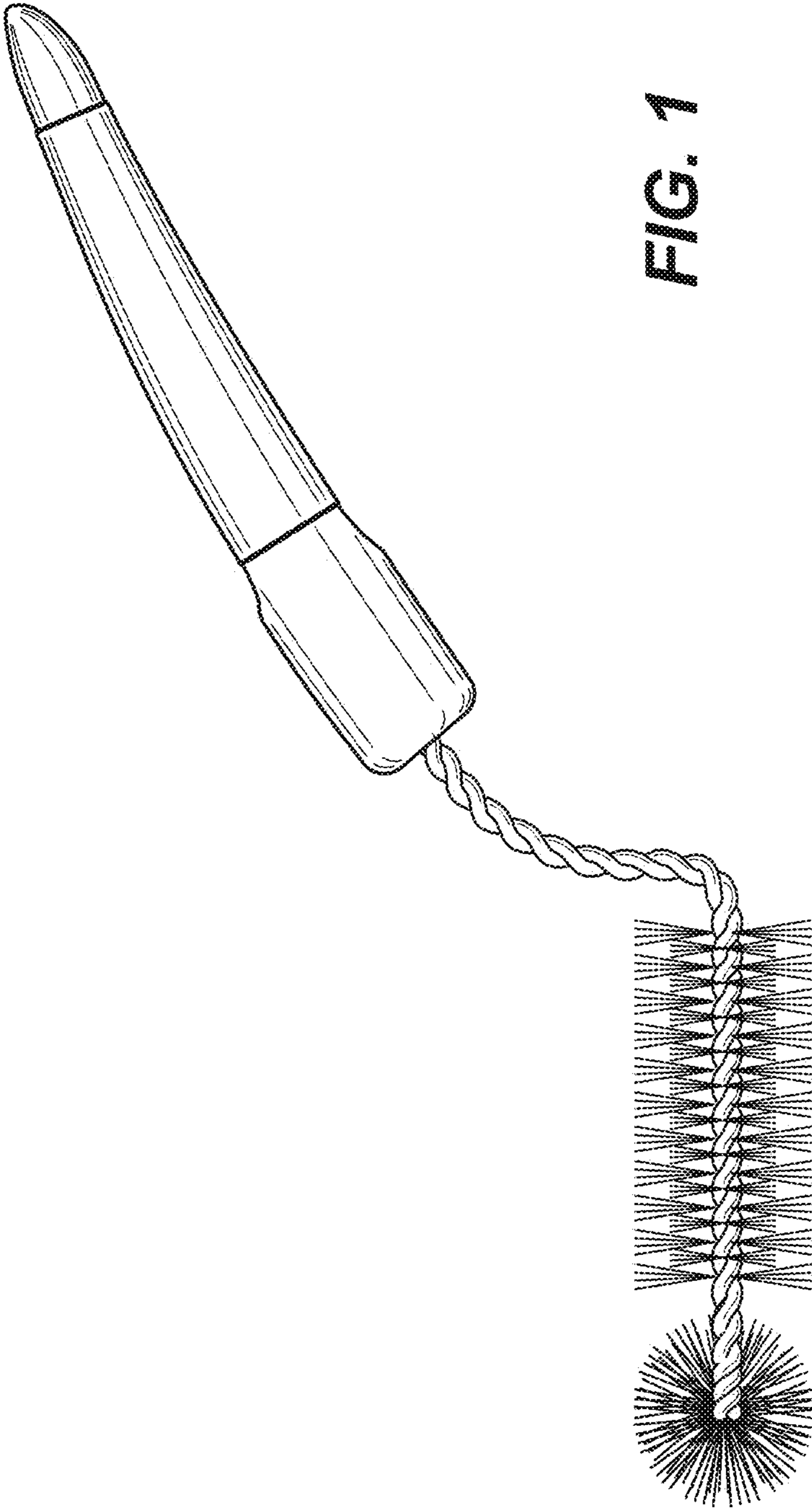
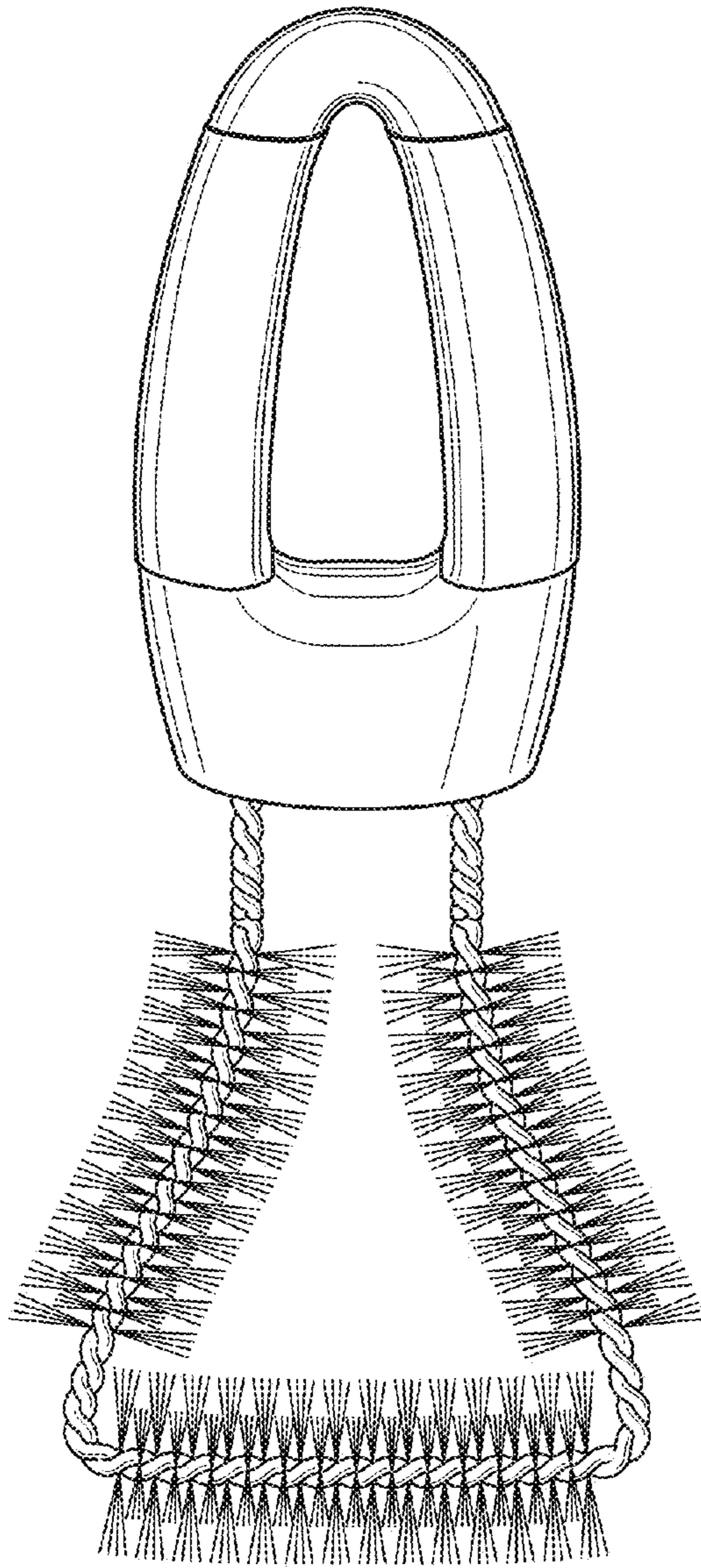
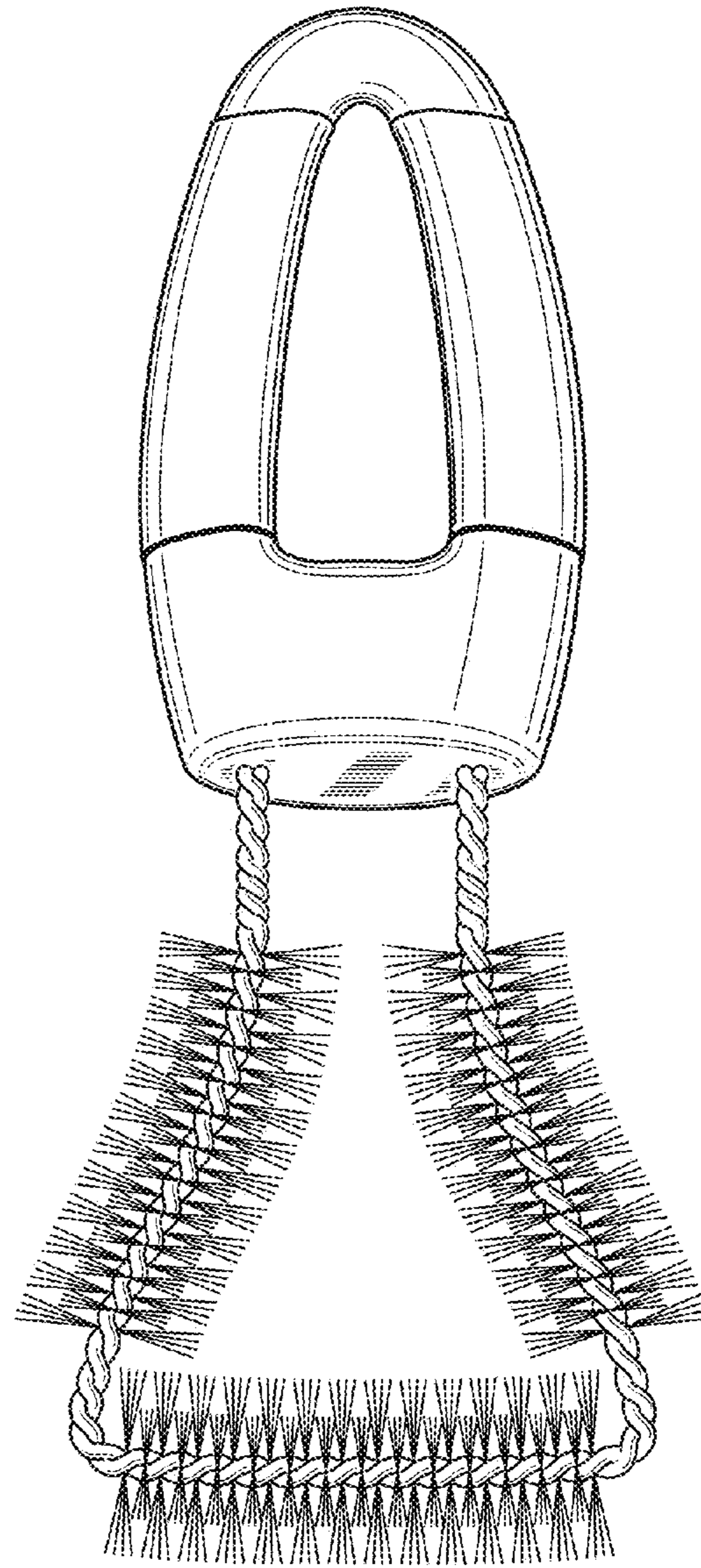

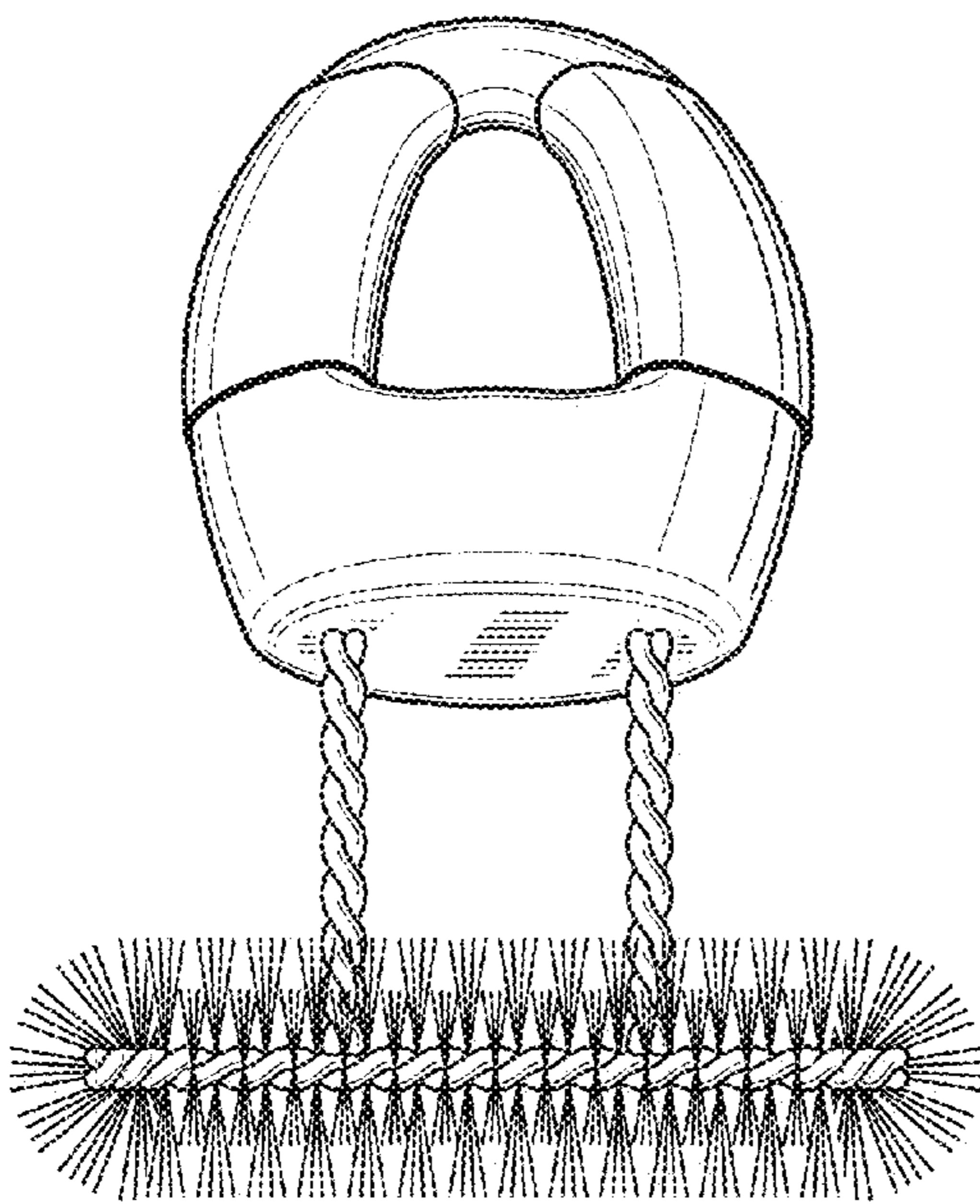




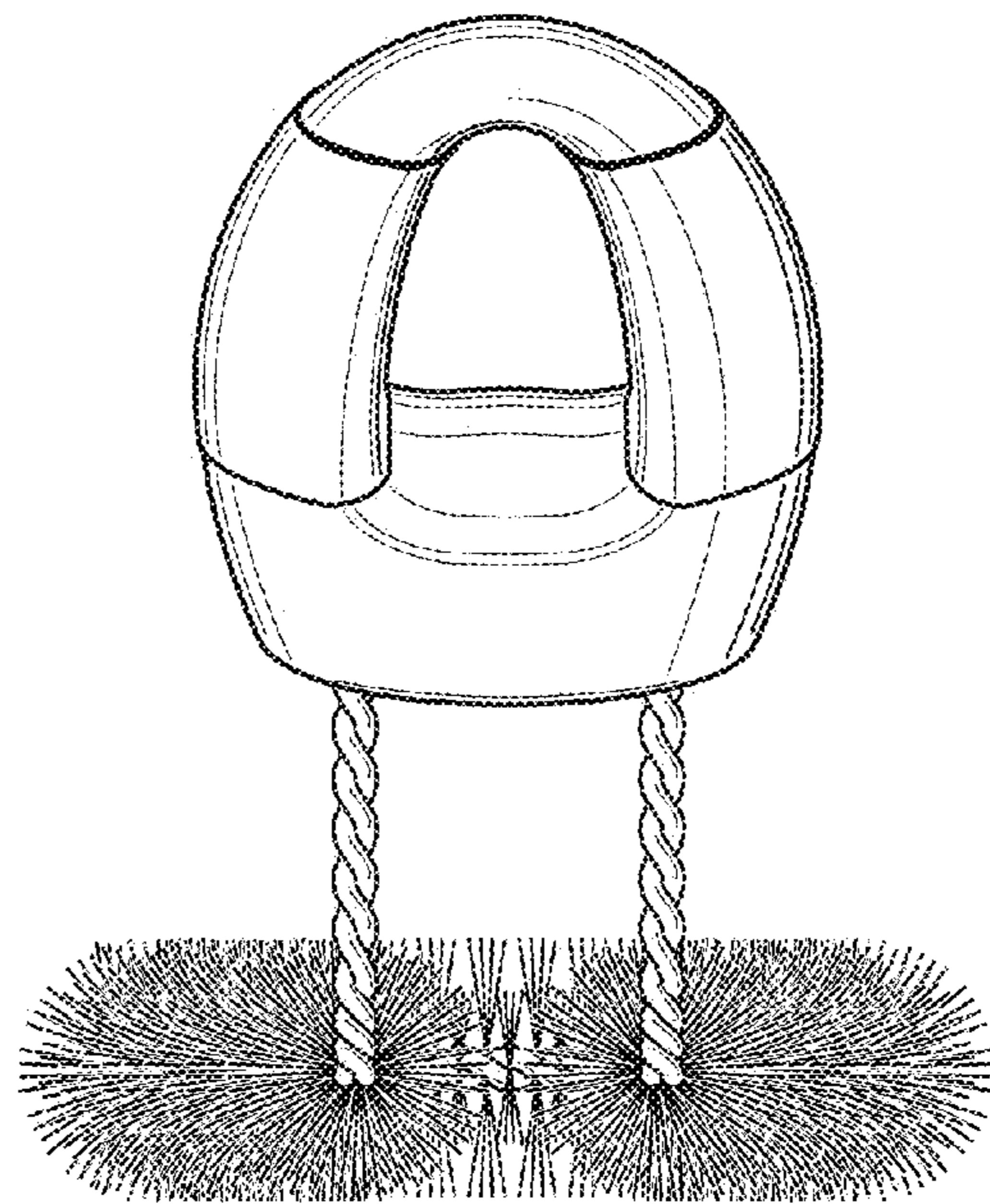
