FIG. 9 shows a top view of the embodiment of FIG. 6.

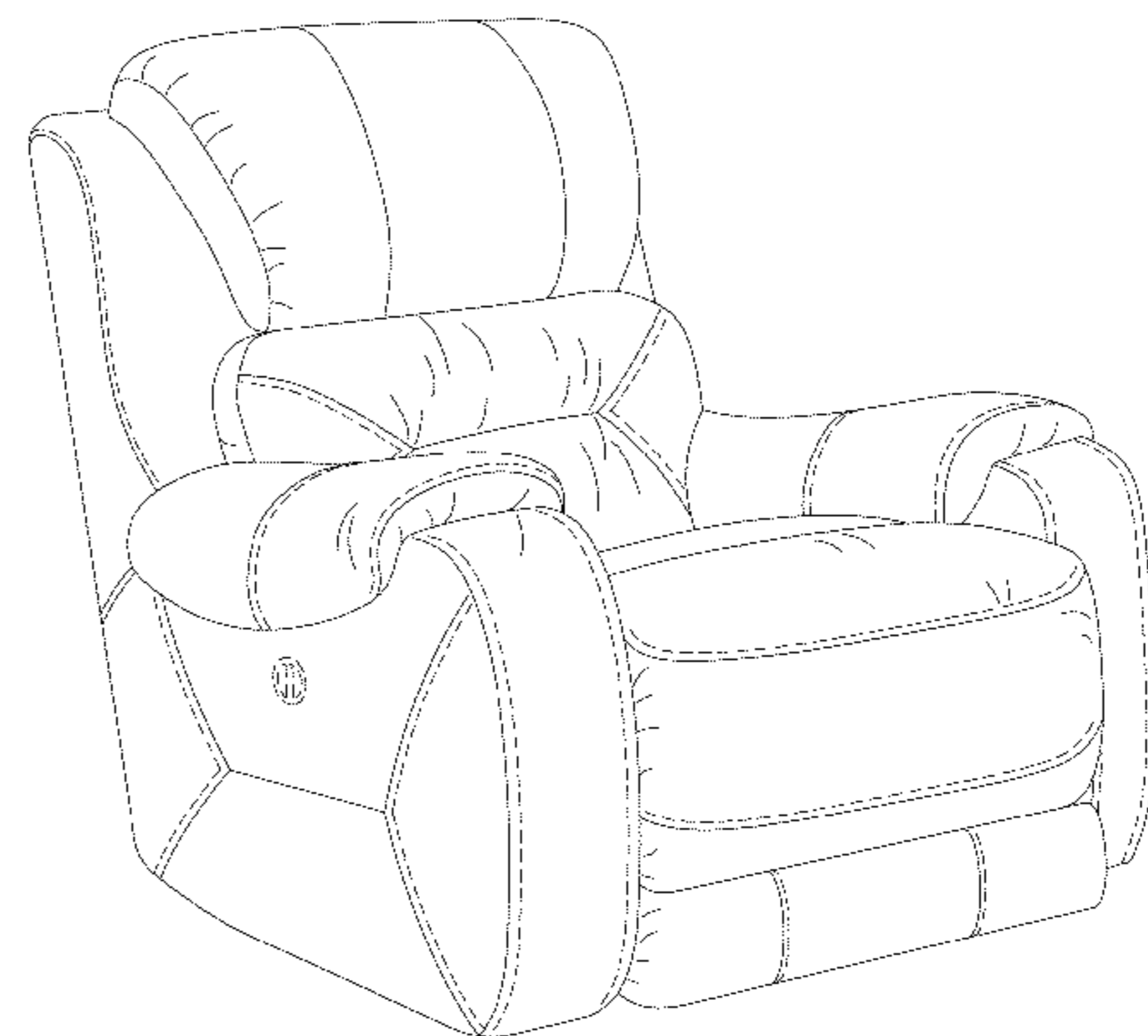
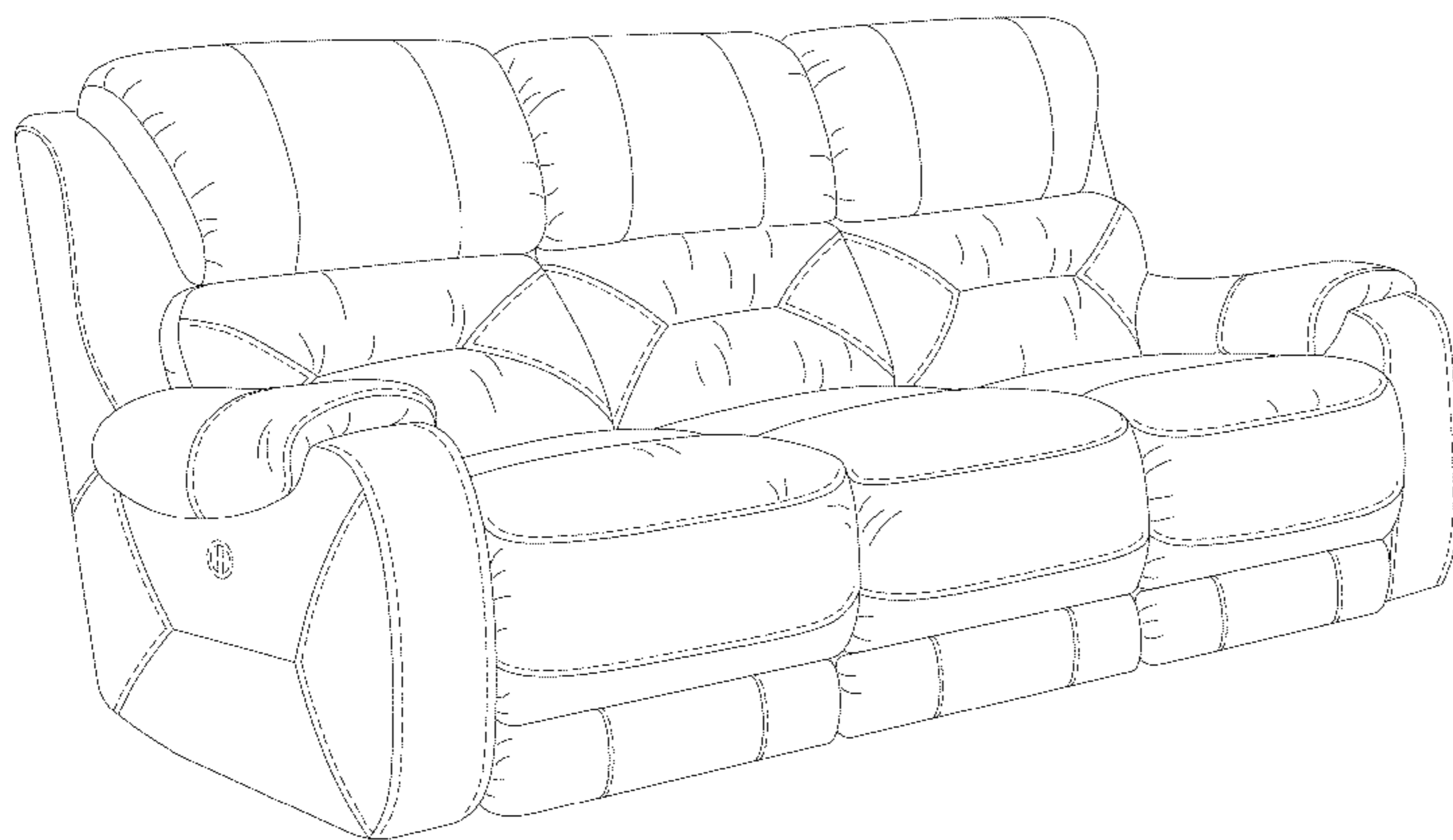
FIG. 10 shows a perspective view of a third embodiment of the seat in accordance with the new design.

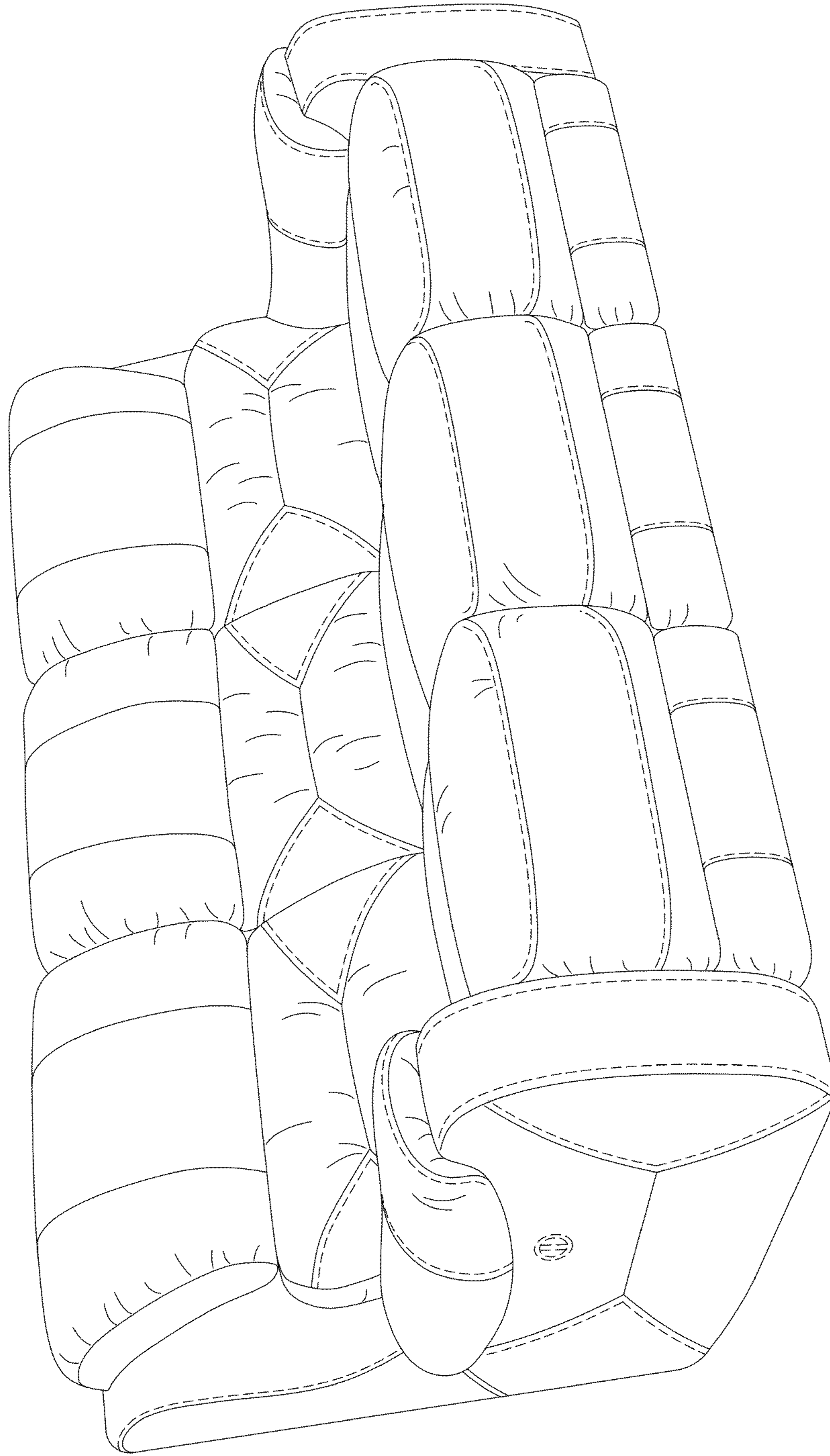

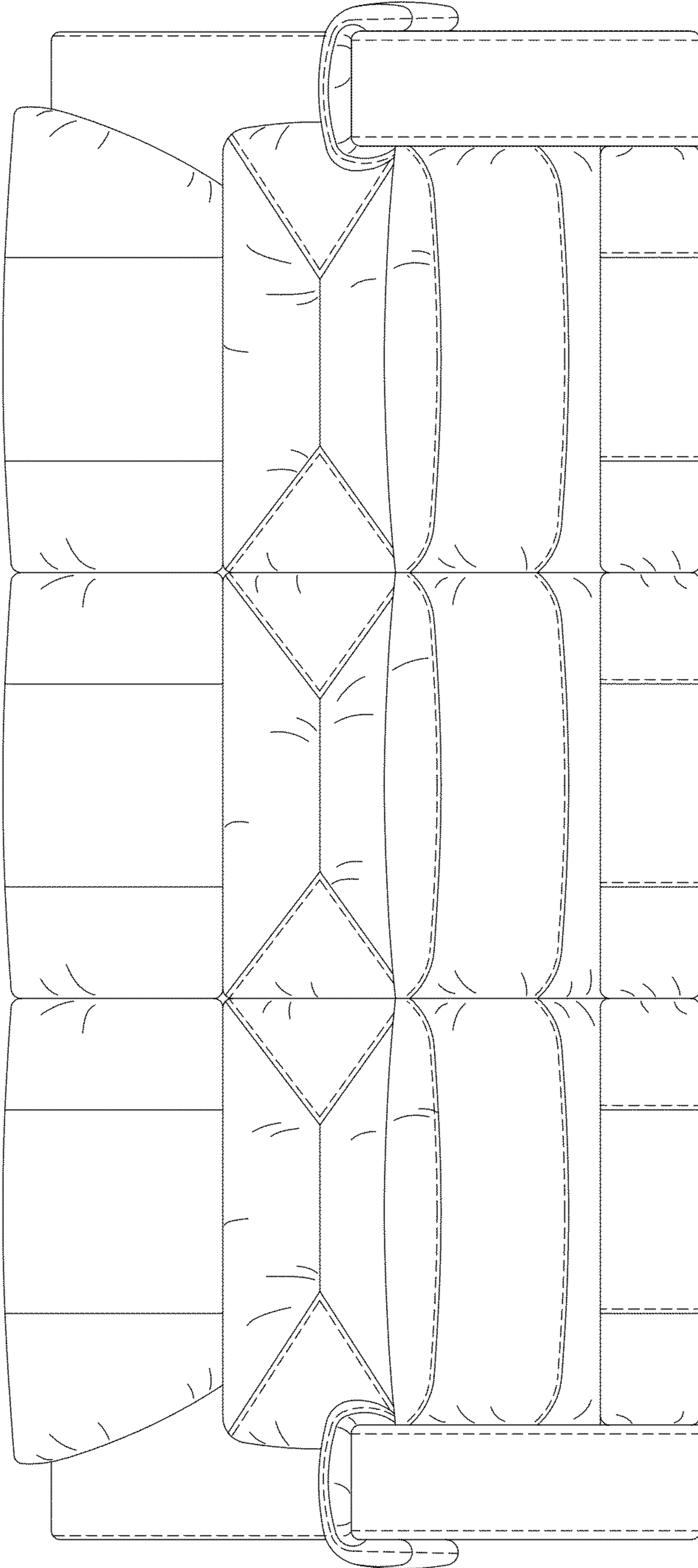

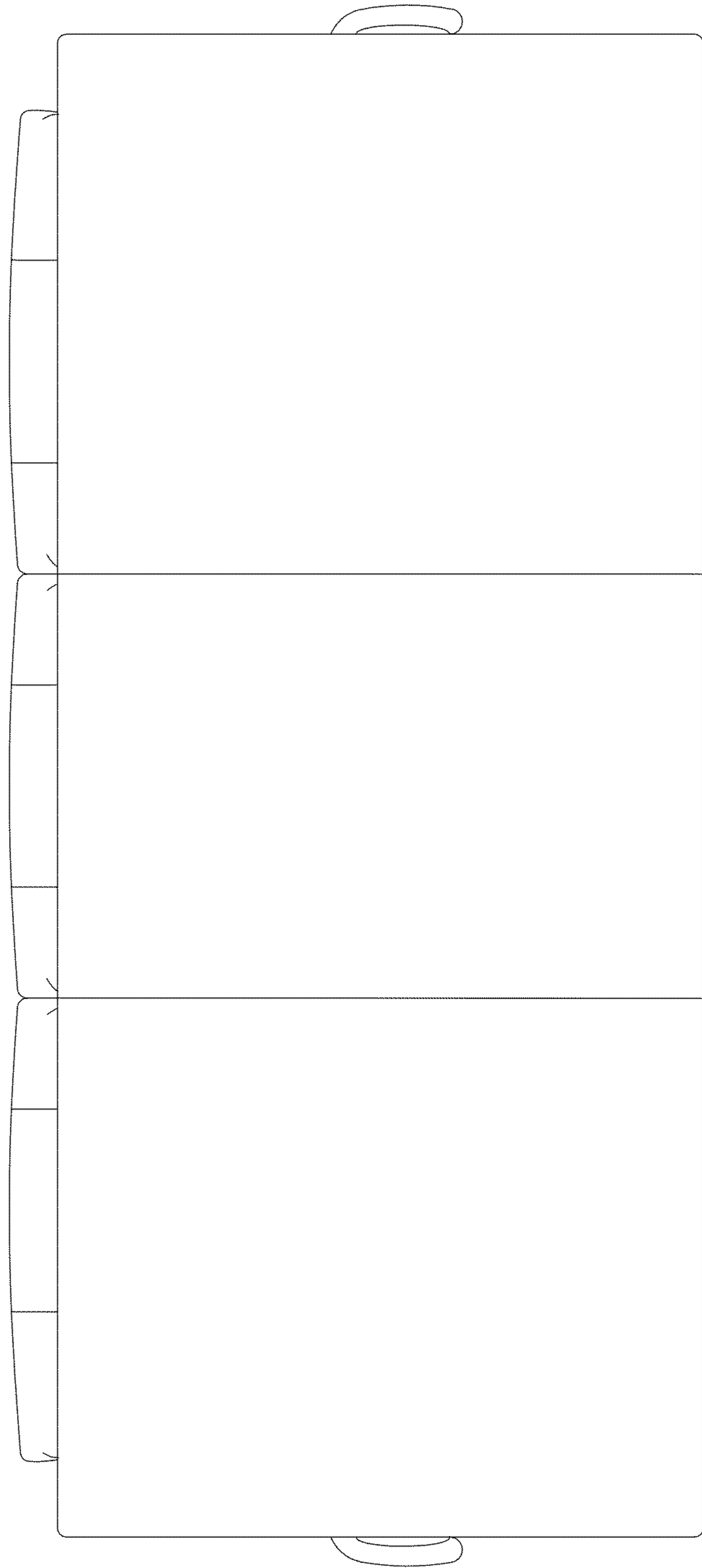

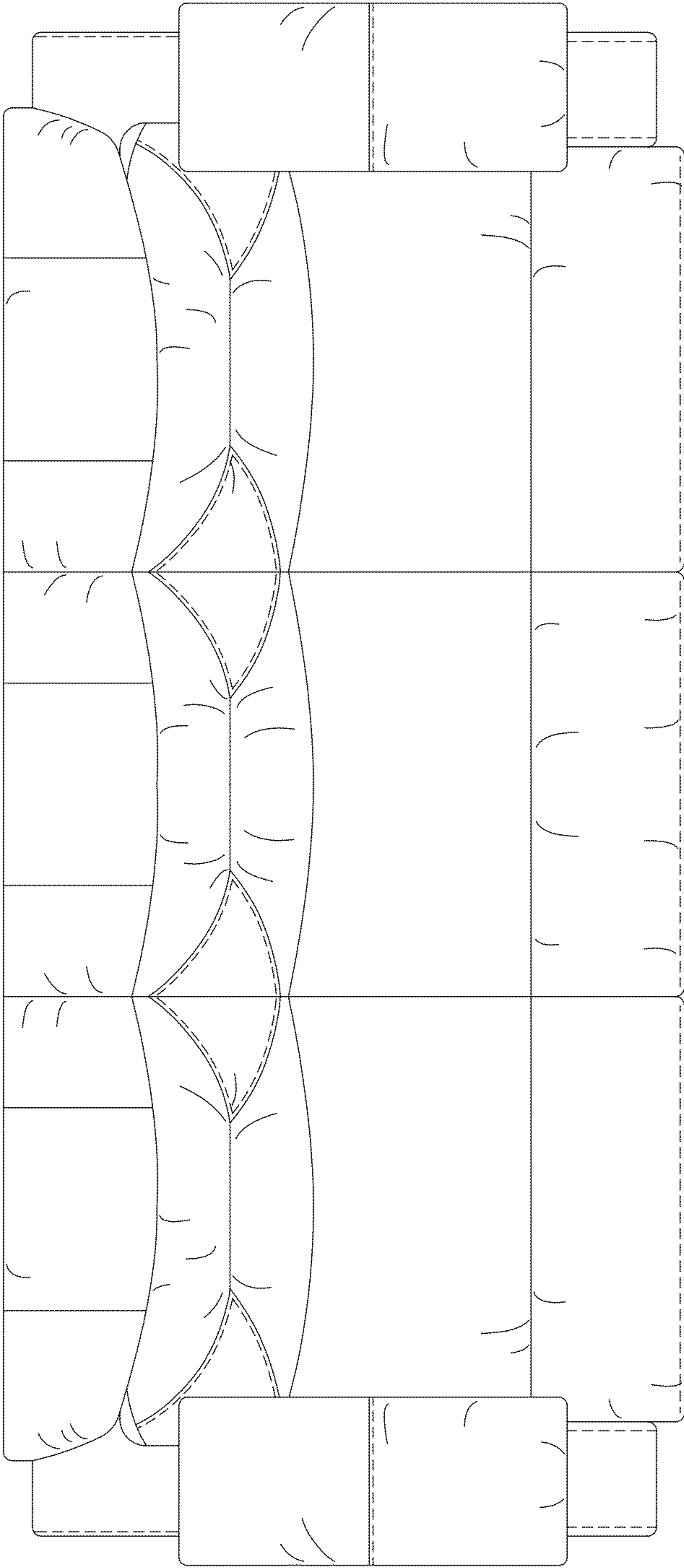

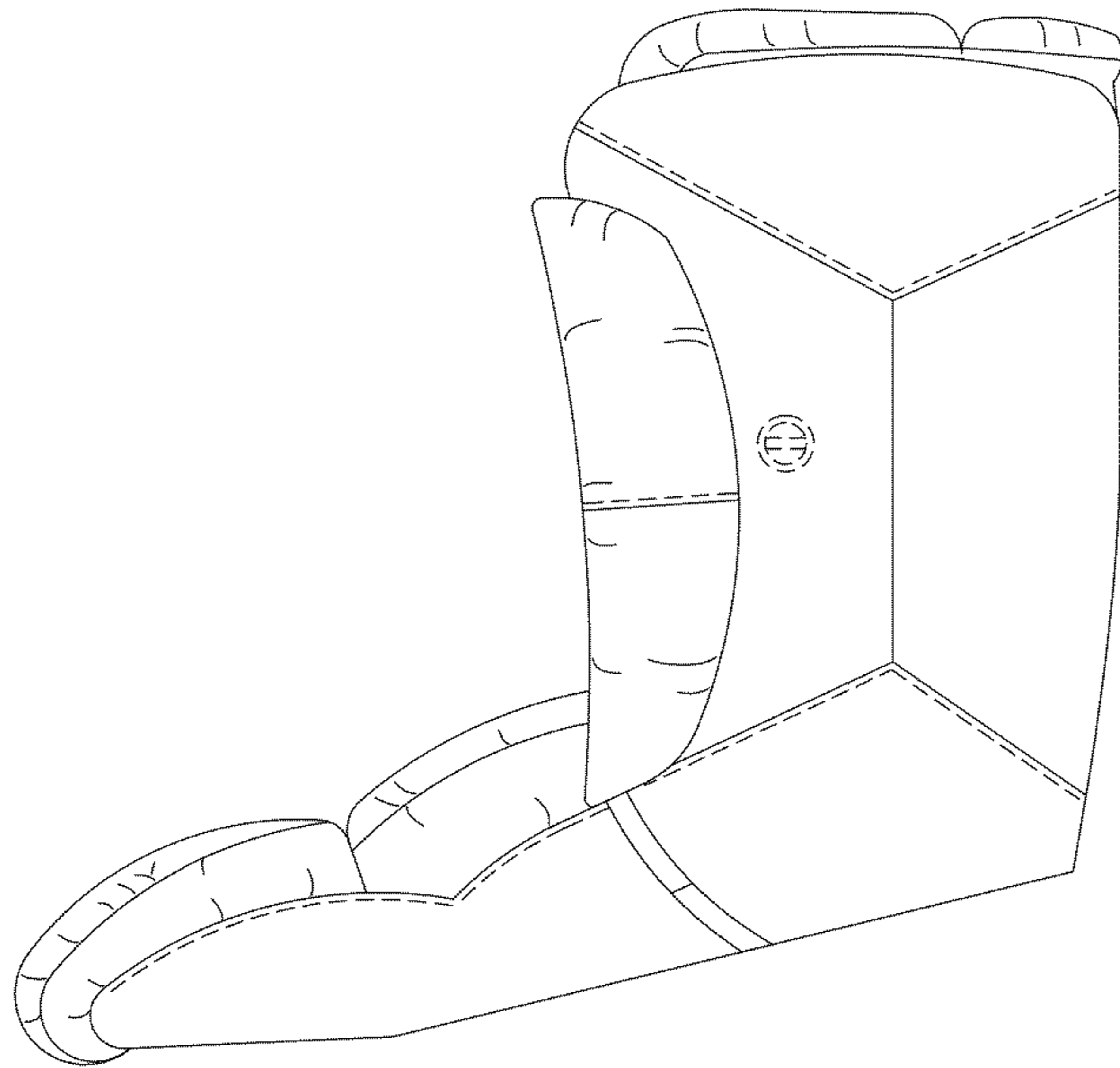

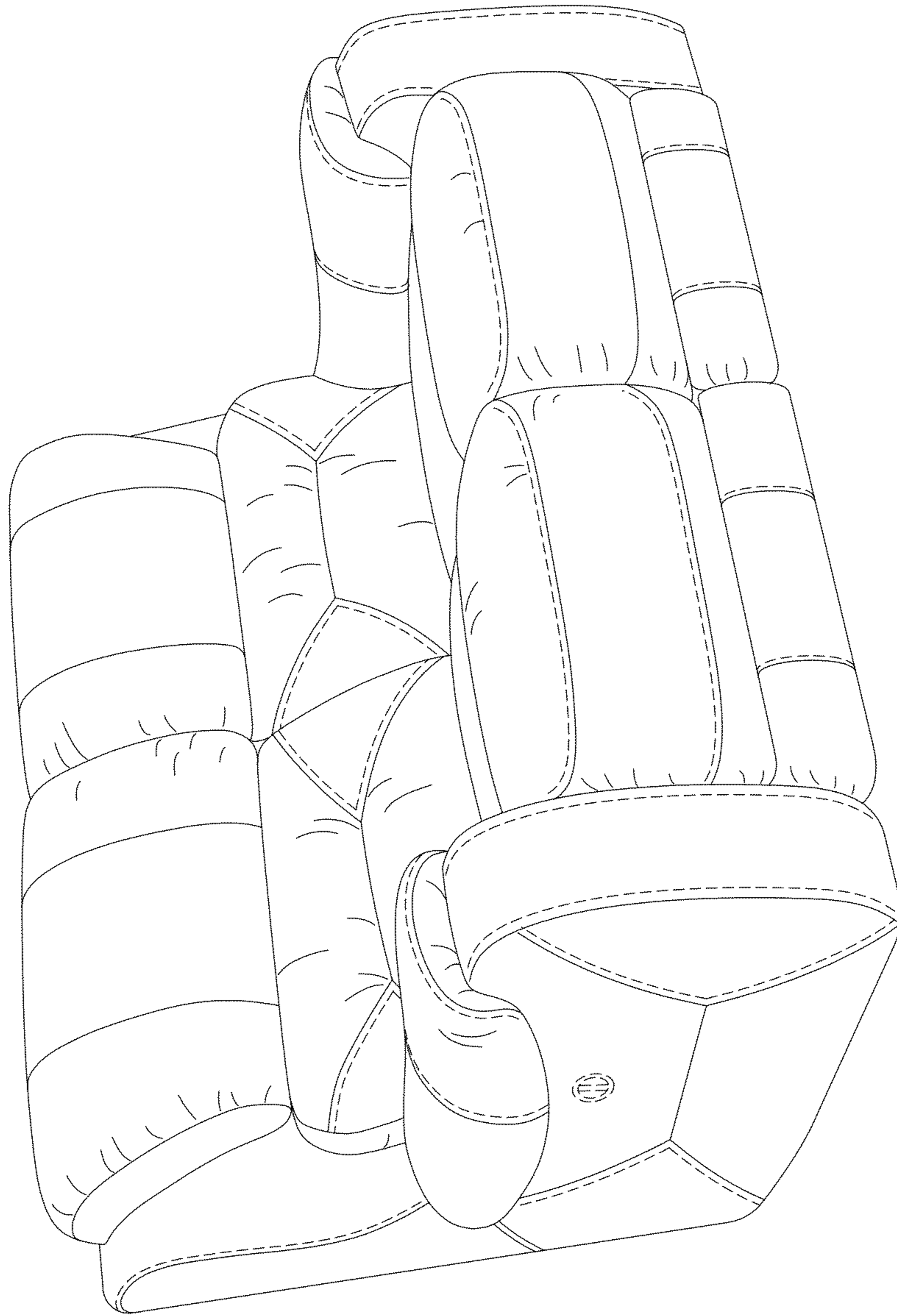

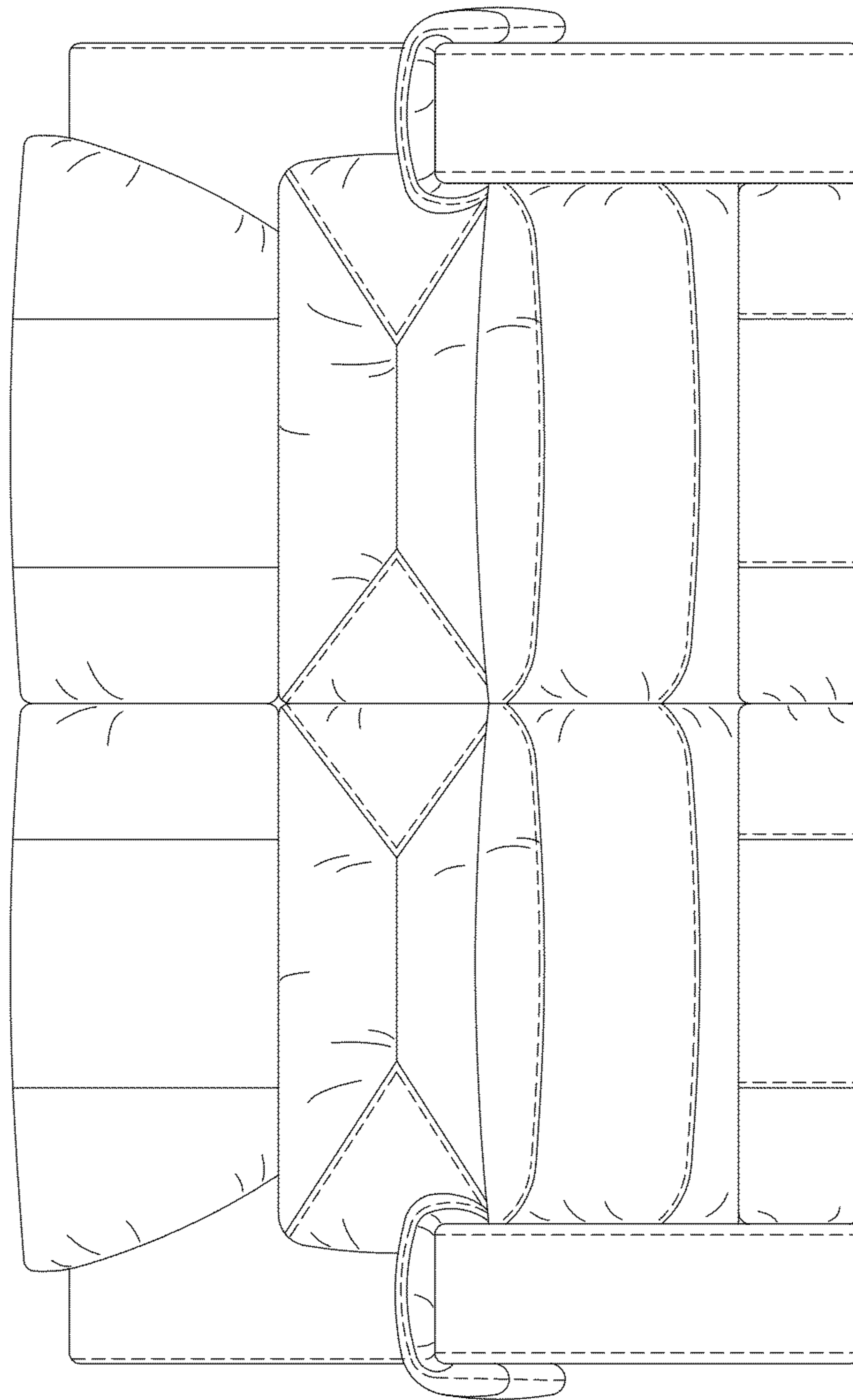

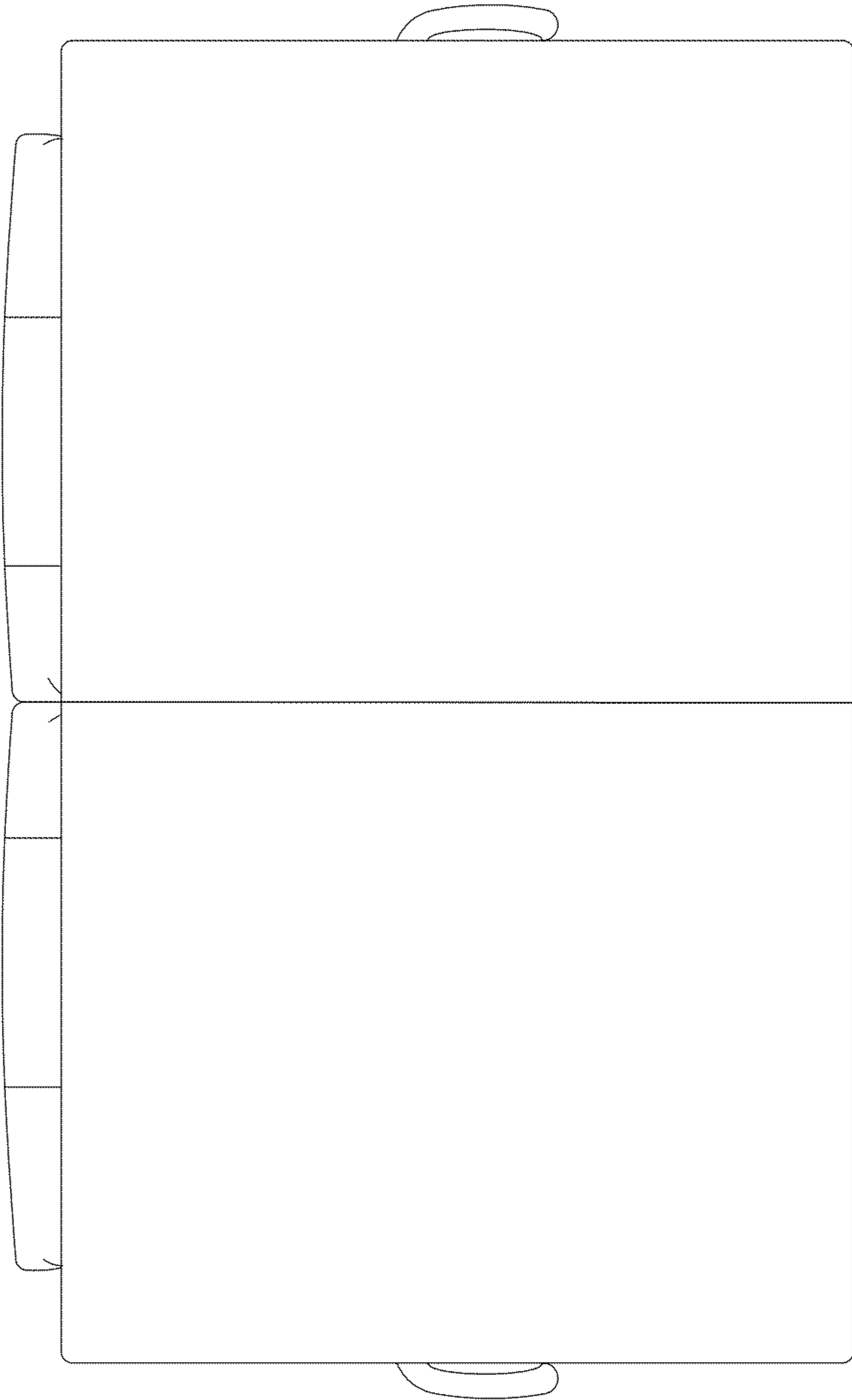

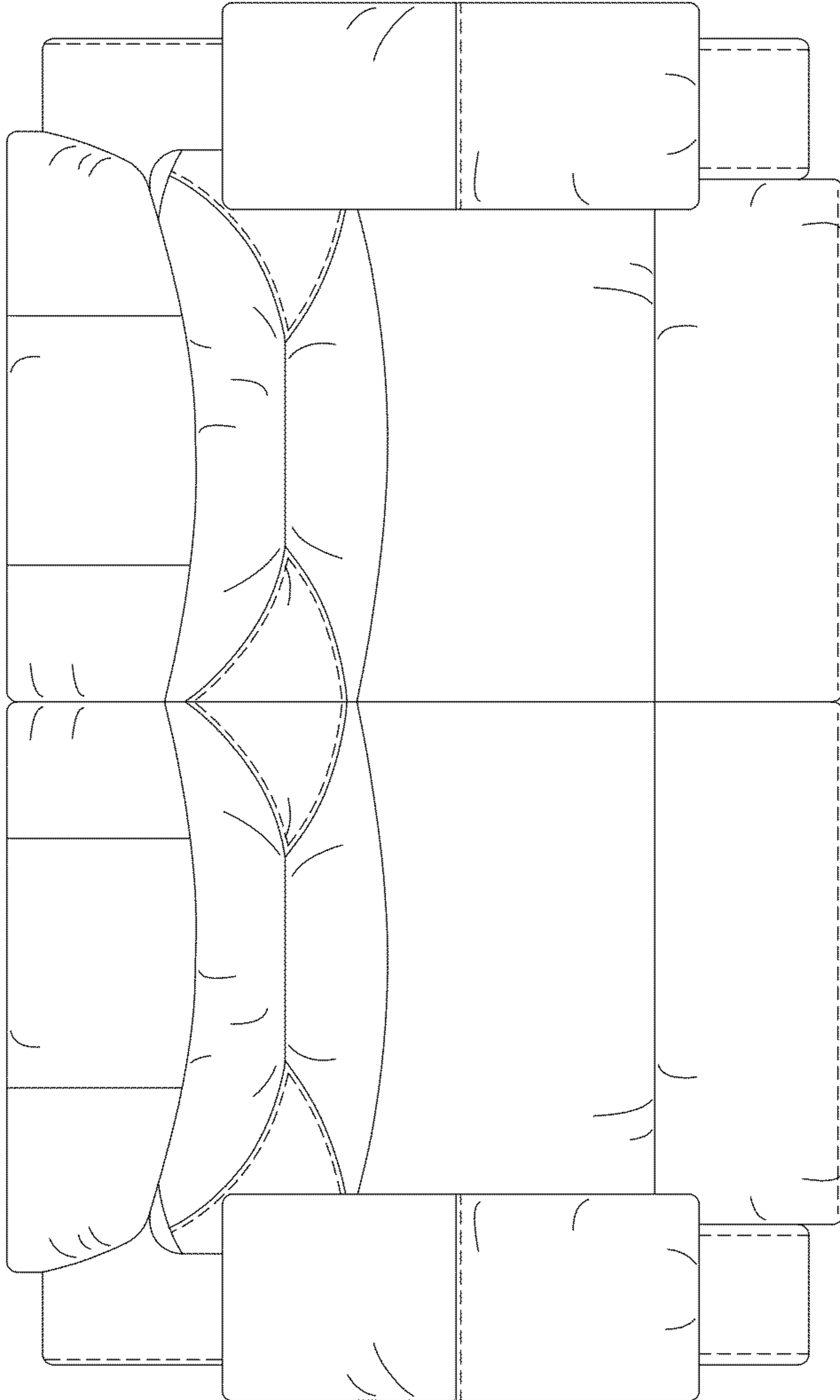

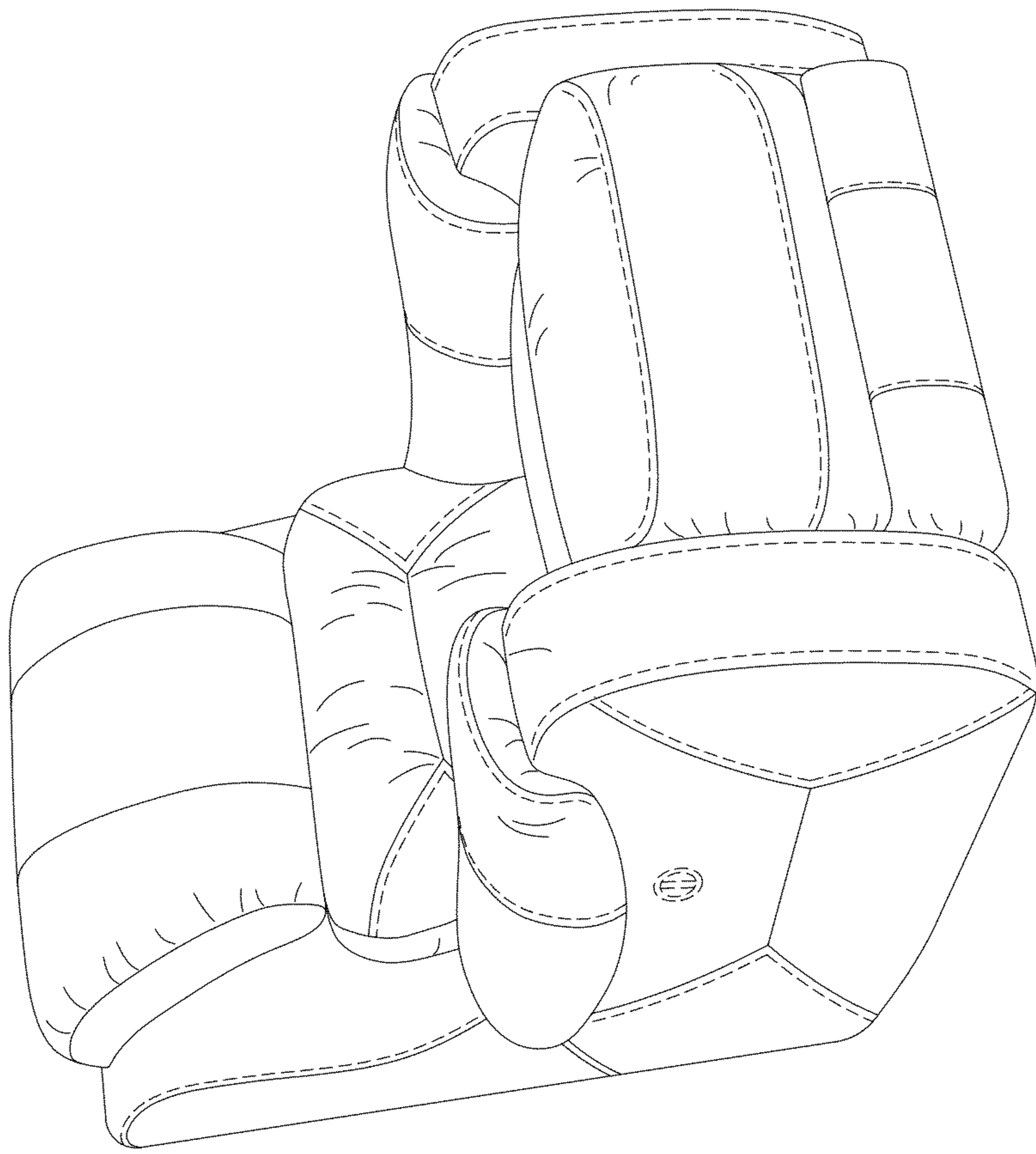

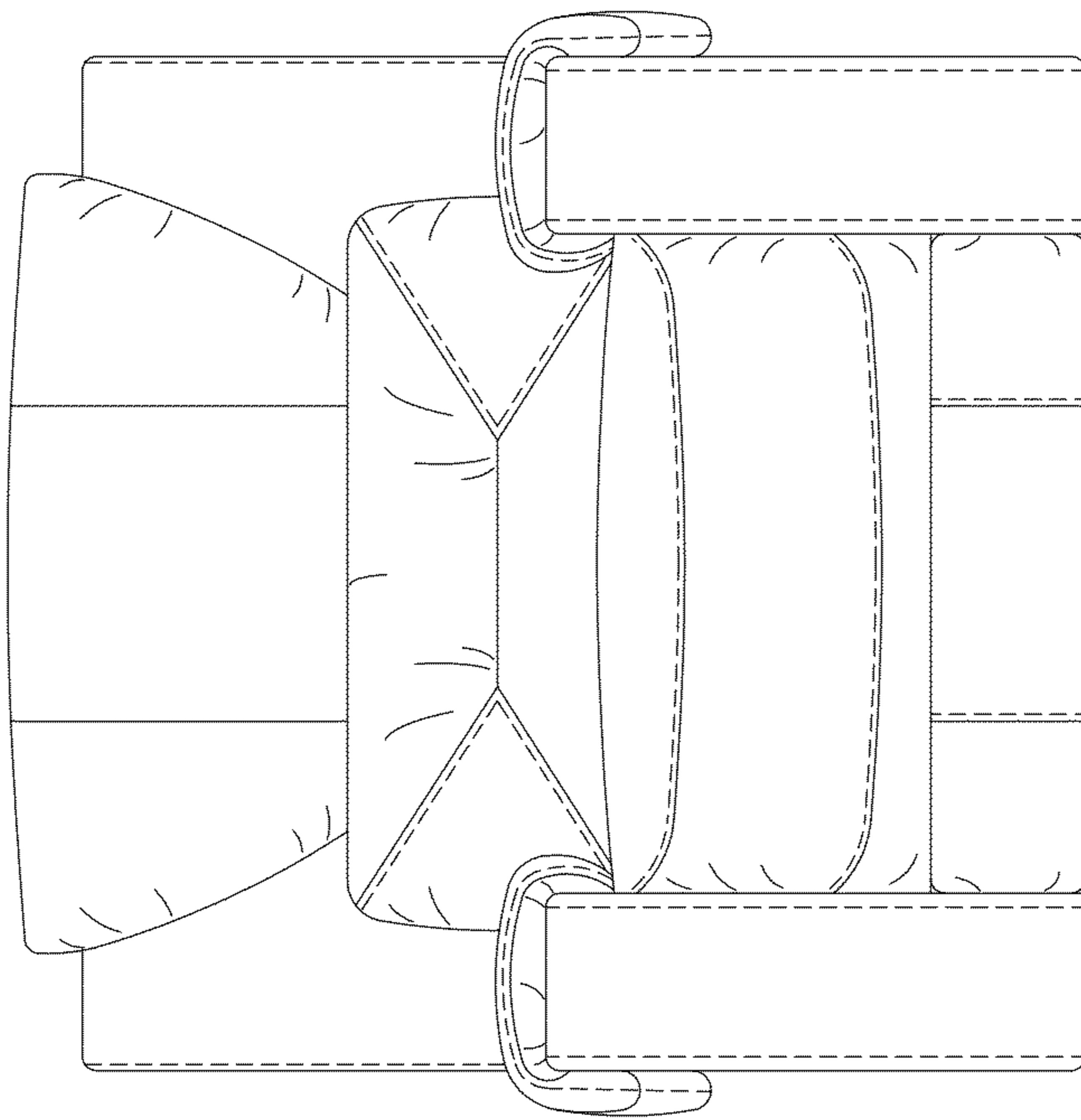

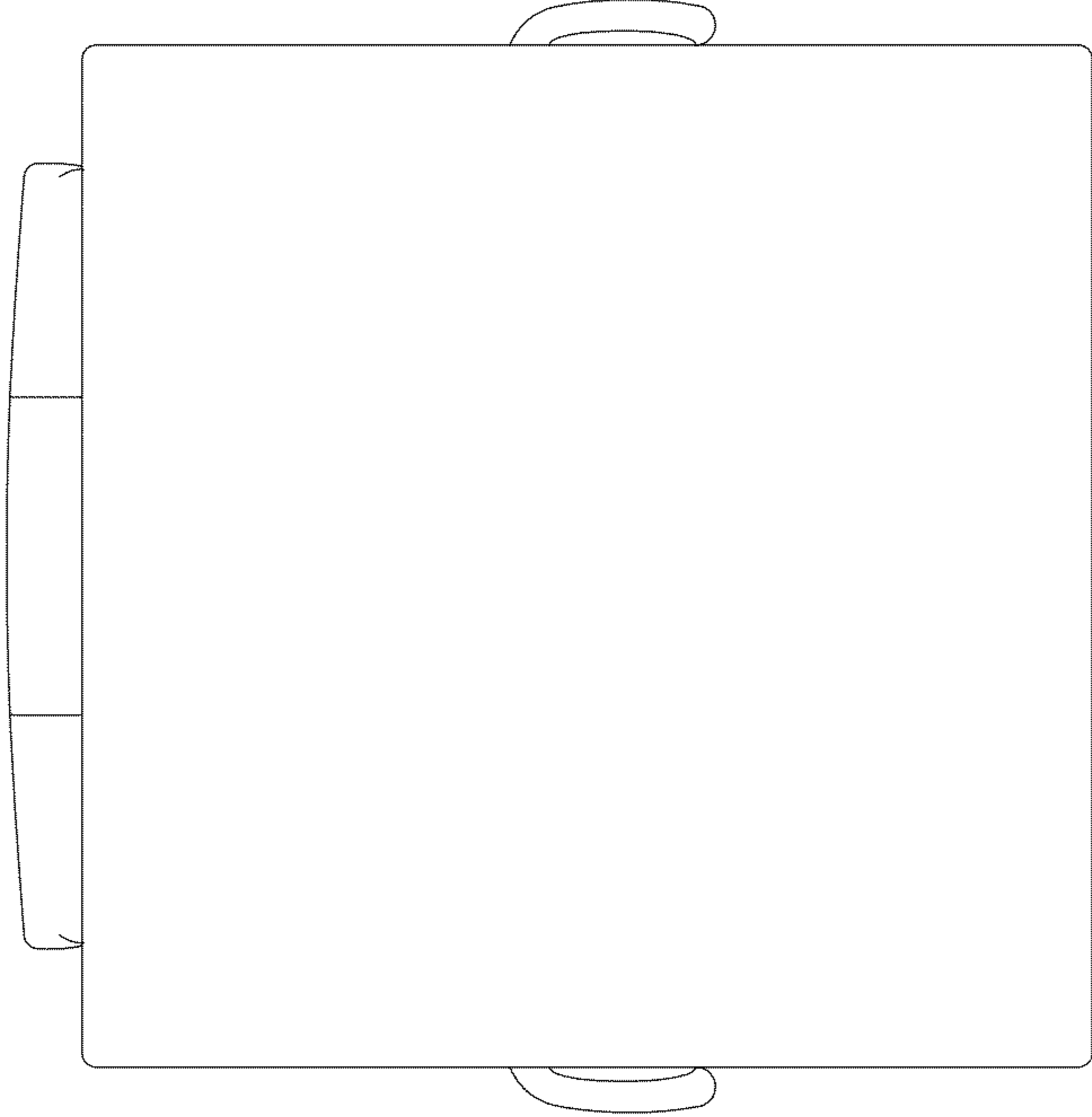

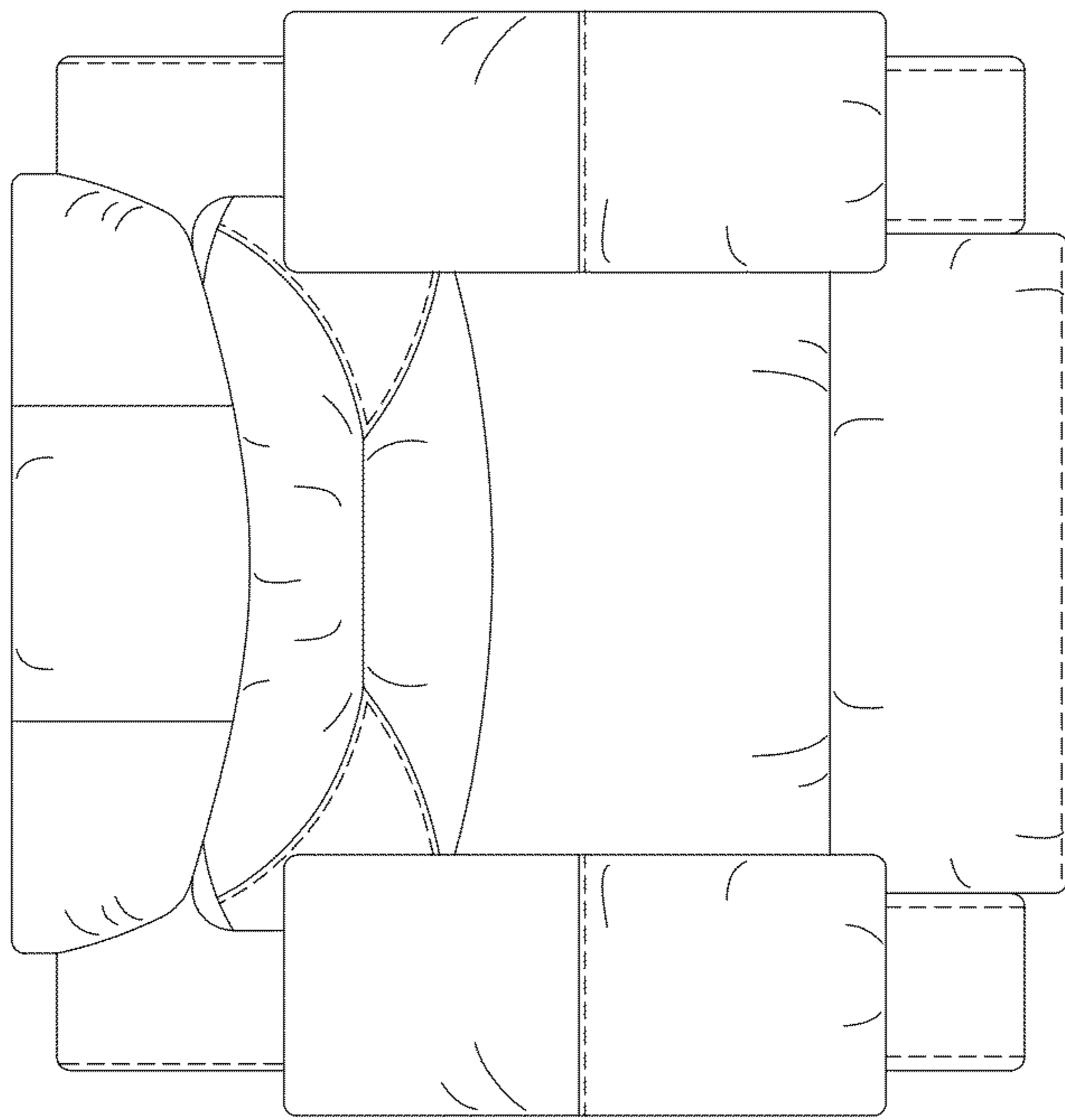
