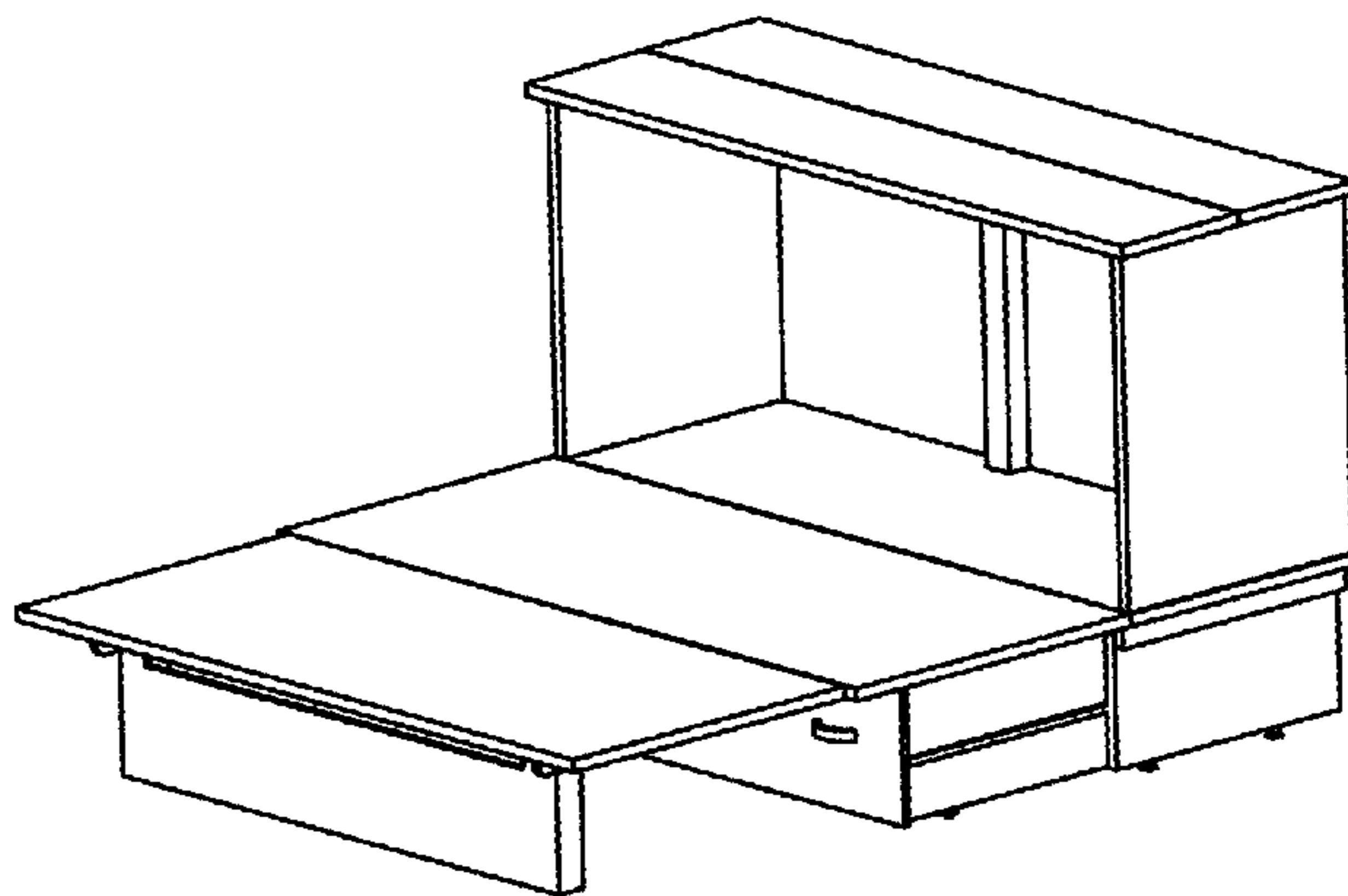
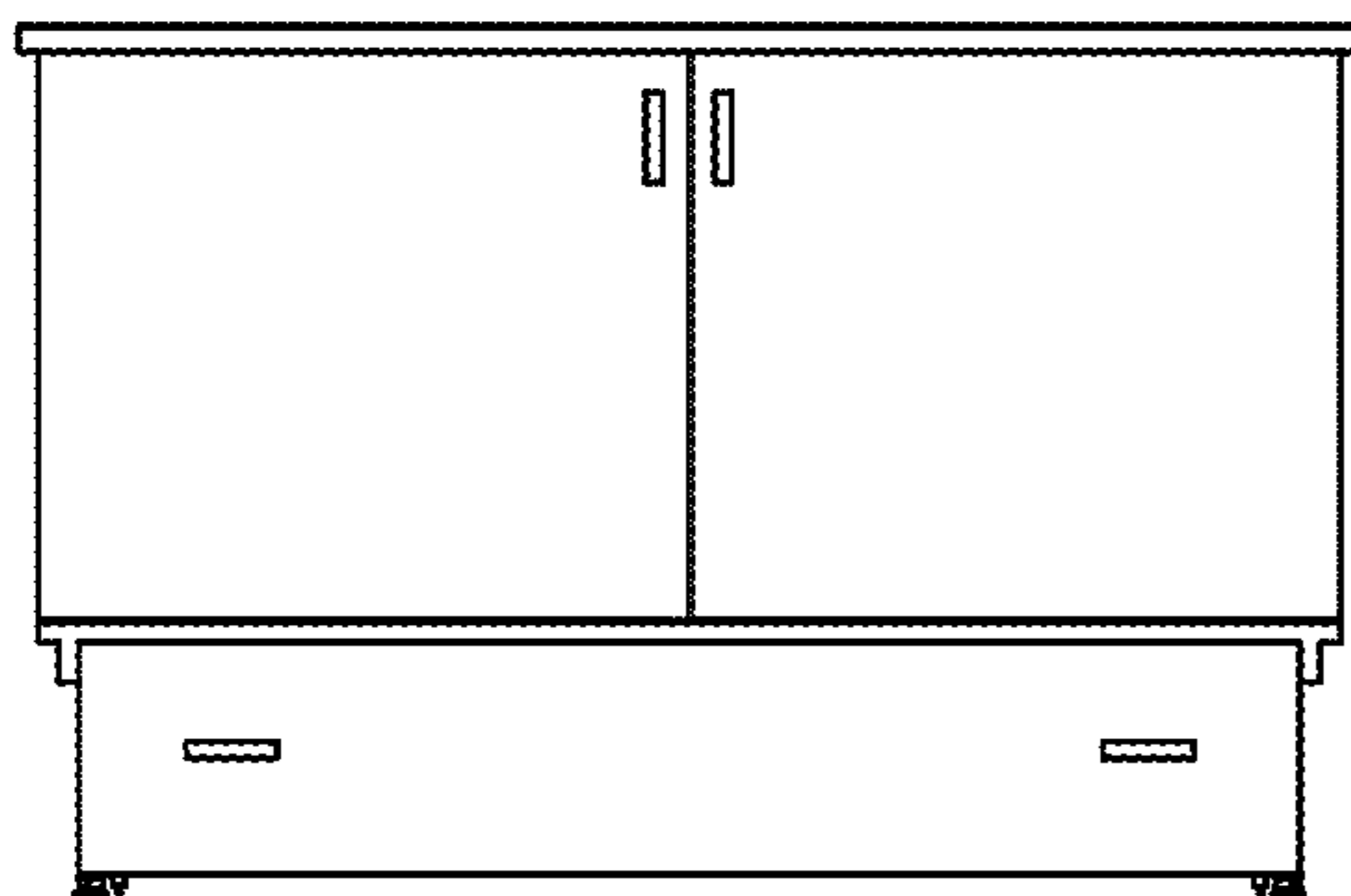
(57) **CLAIM**

The ornamental design for a fold-out cabinet bed, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the design in a closed position; FIG. 2 is a rear view of the design in the closed position; FIG. 3 is a left side view of the design in the closed position, the right side view being a mirror image thereof; FIG. 4 is a top view of the design in the closed position; FIG. 5 is a bottom view of the design in the closed position; FIG. 6 is a perspective view of the design in a partially open position; FIG. 7 is a left side view of the design in the partially open position, the right side view being a mirror image thereof; FIG. 8 is a front view of the design in the partially open position; FIG. 9 is a perspective view of the design in a fully open position; FIG. 10 is a front view of the design in the fully open position; FIG. 11 is a rear view of the design in the fully open position; FIG. 12 is a top view of the design in the fully open position; FIG. 13 is a left side view of the design in the fully open position, the right side view being a mirror image thereof; and, FIG. 14 is a bottom view of the design in the fully open position.

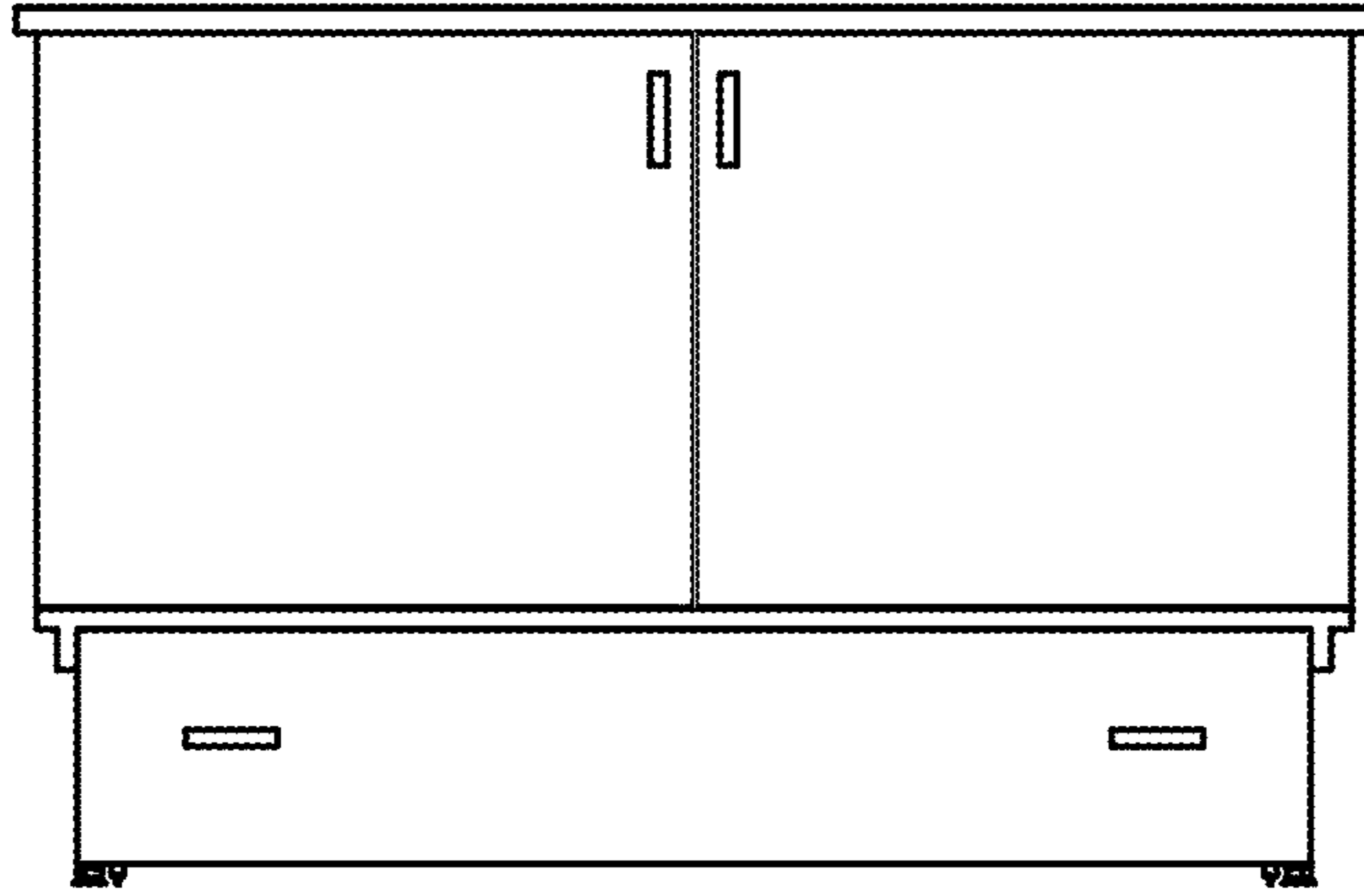

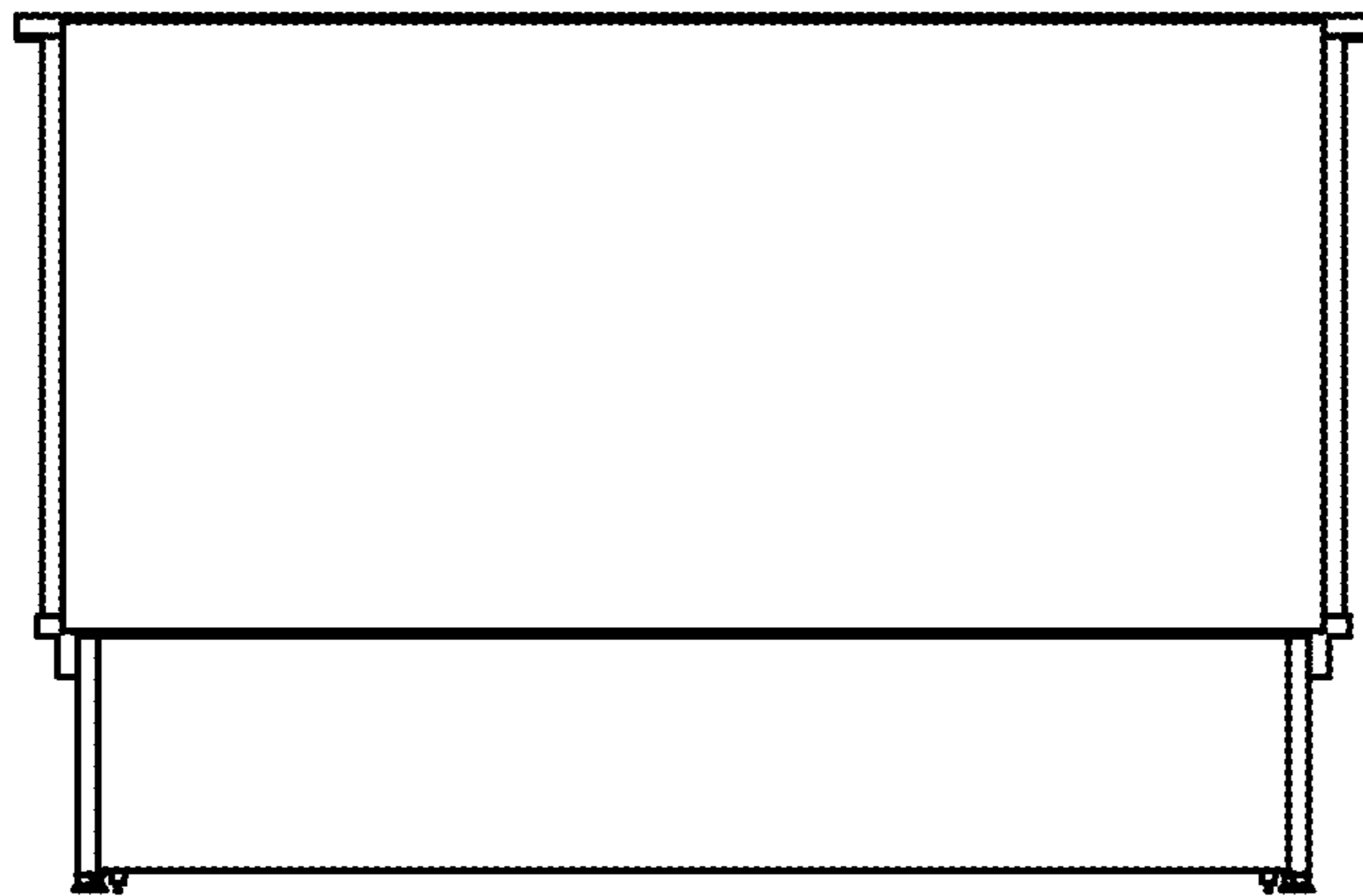

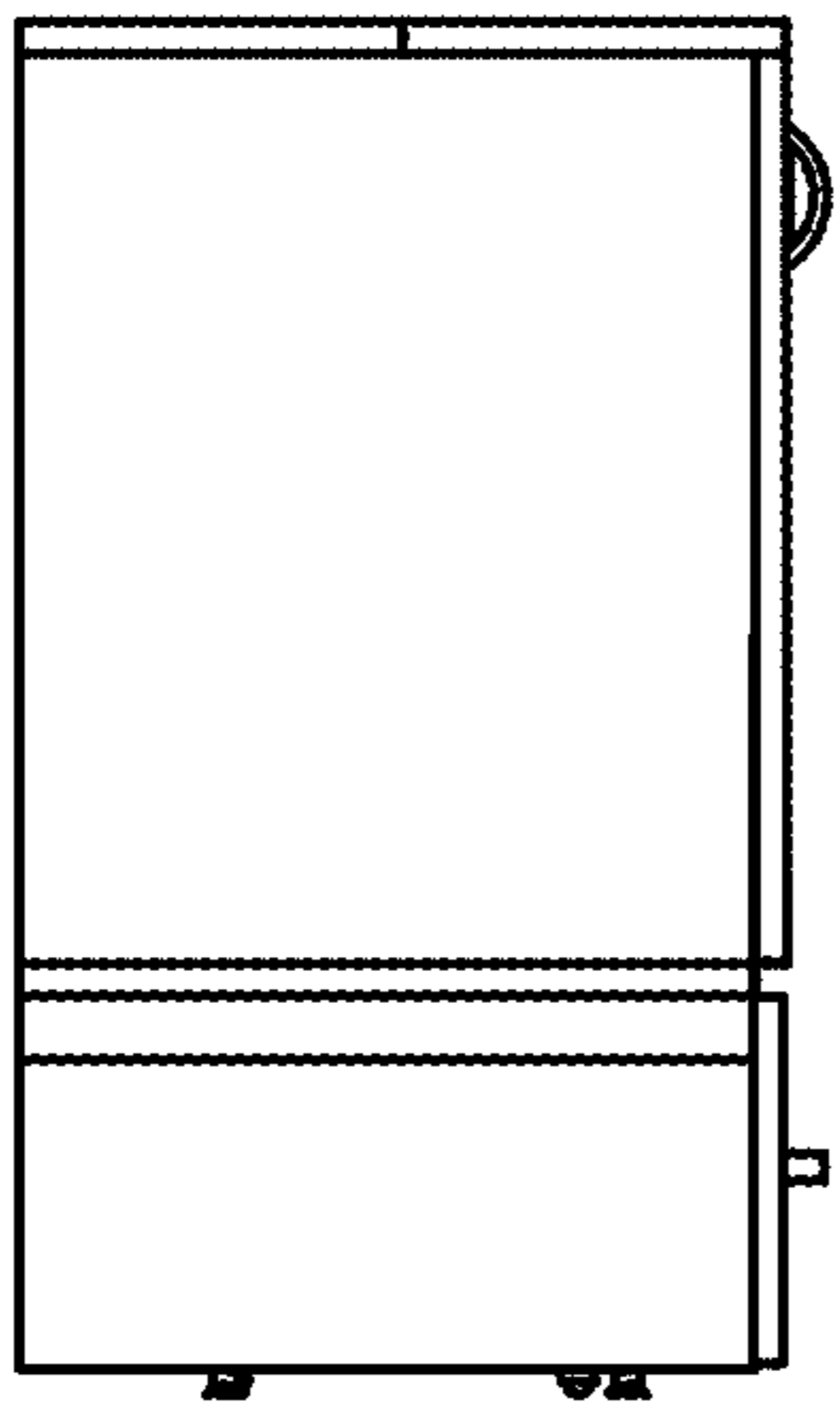

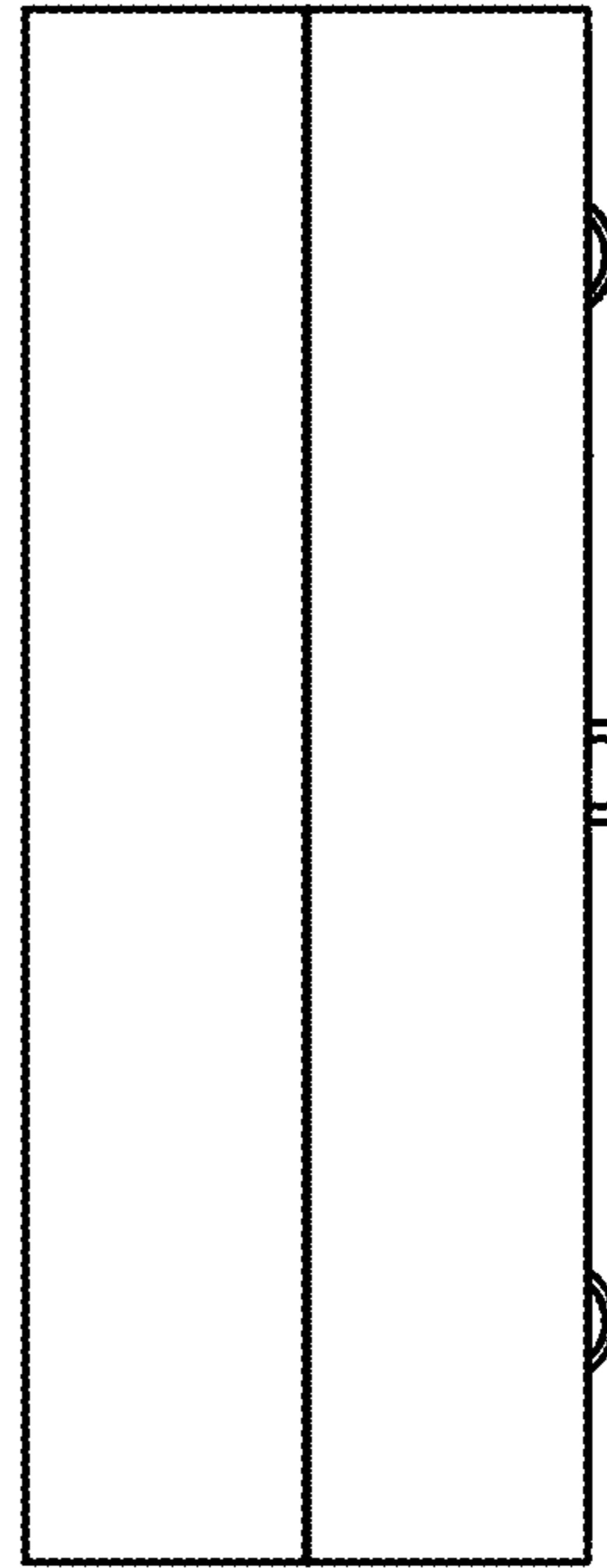
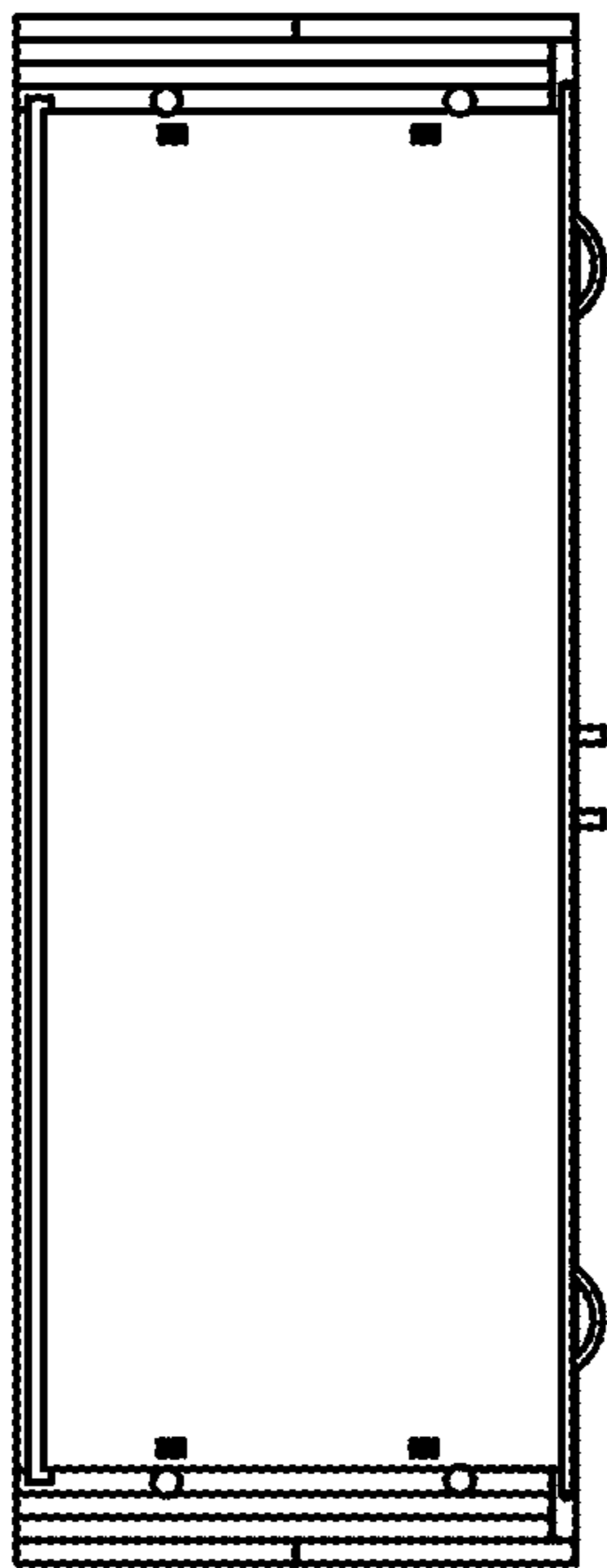

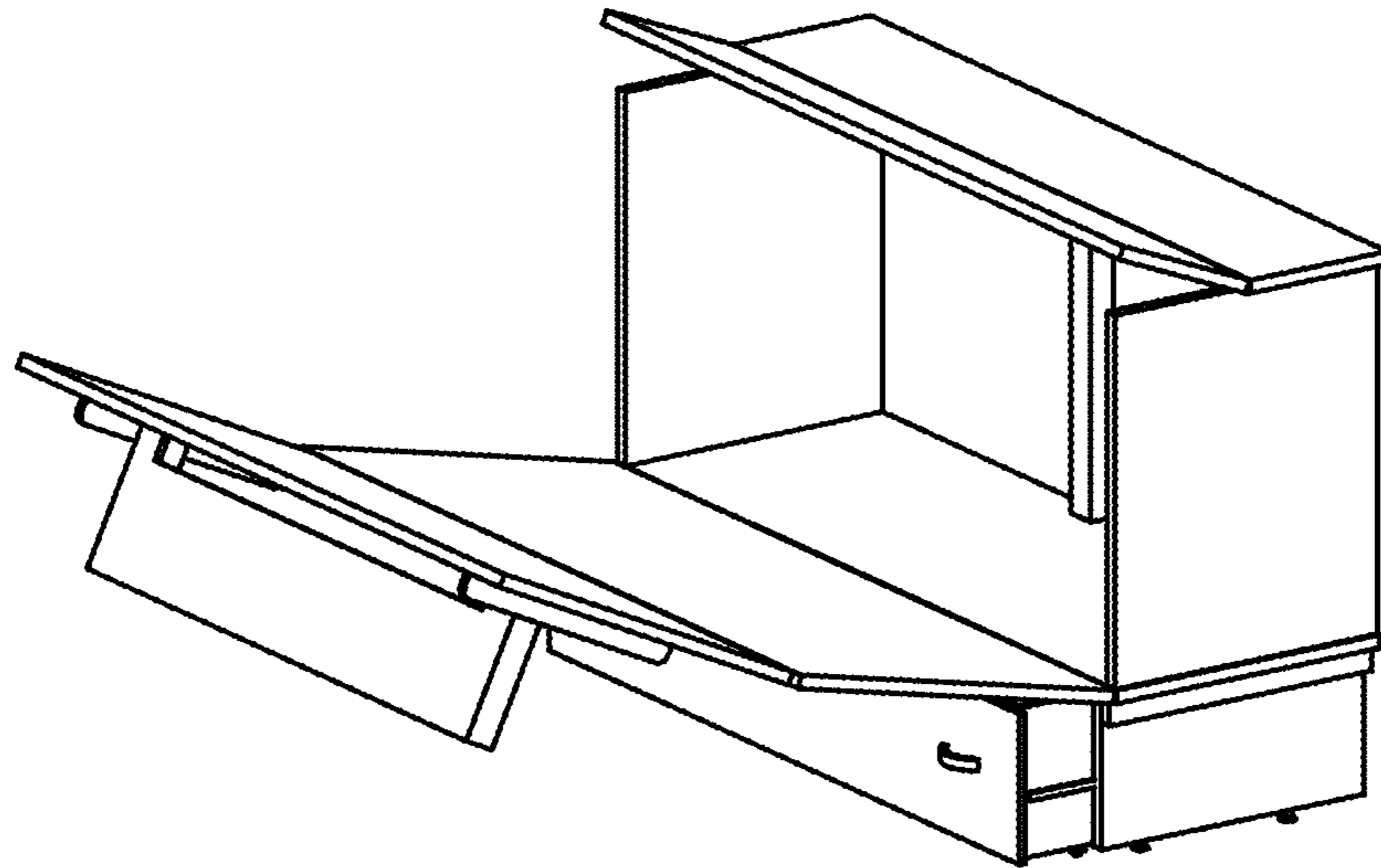

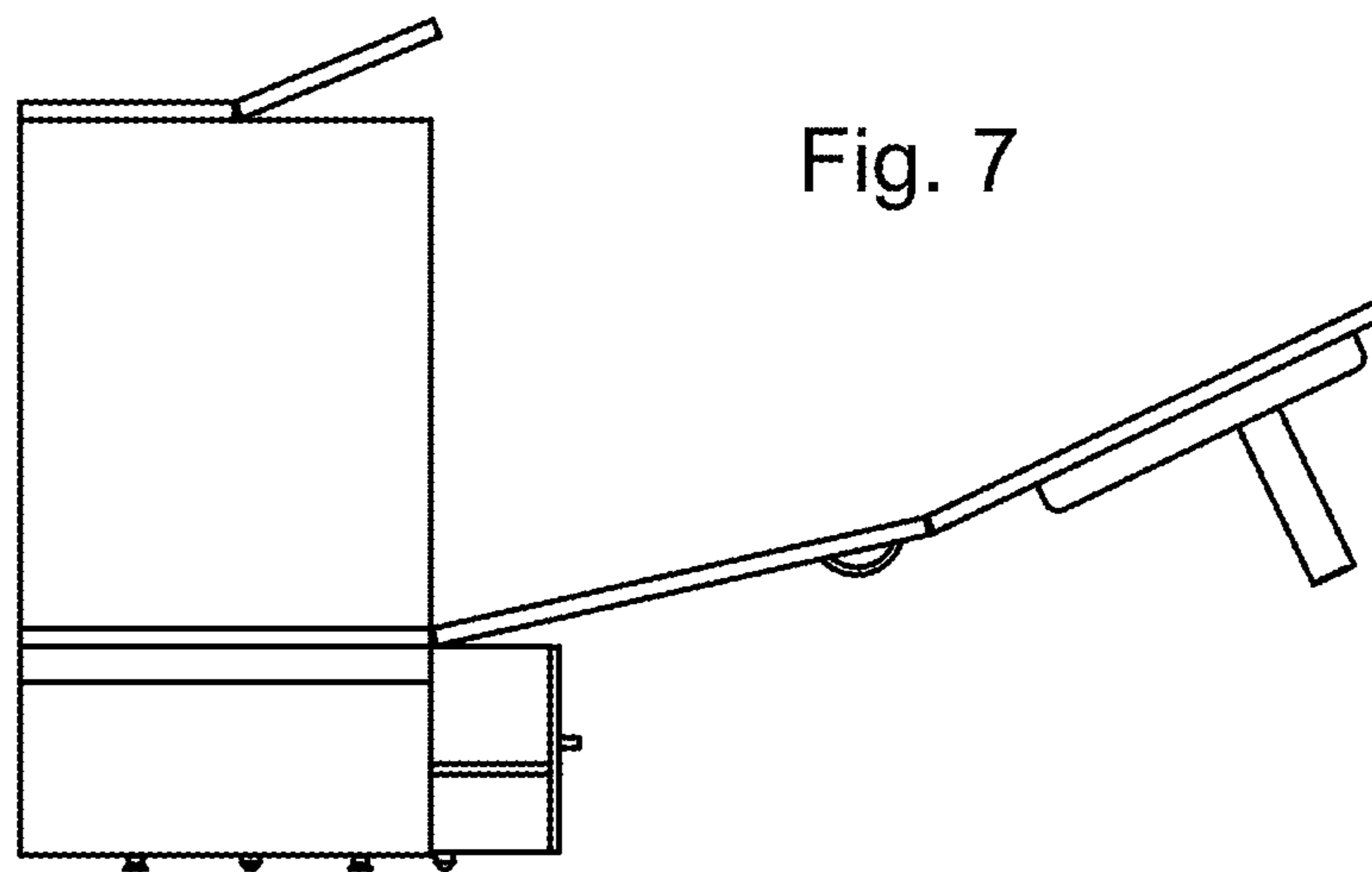

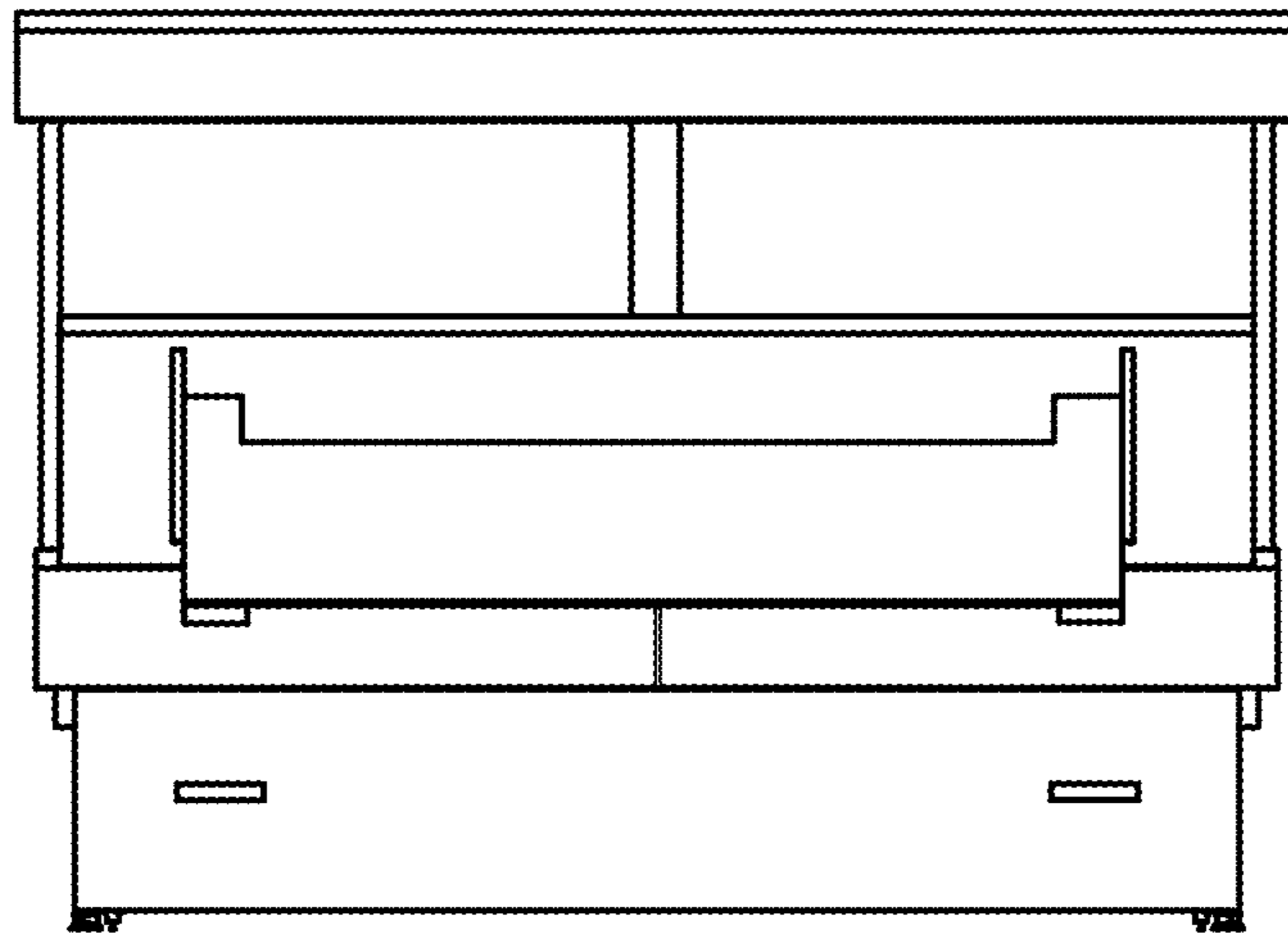

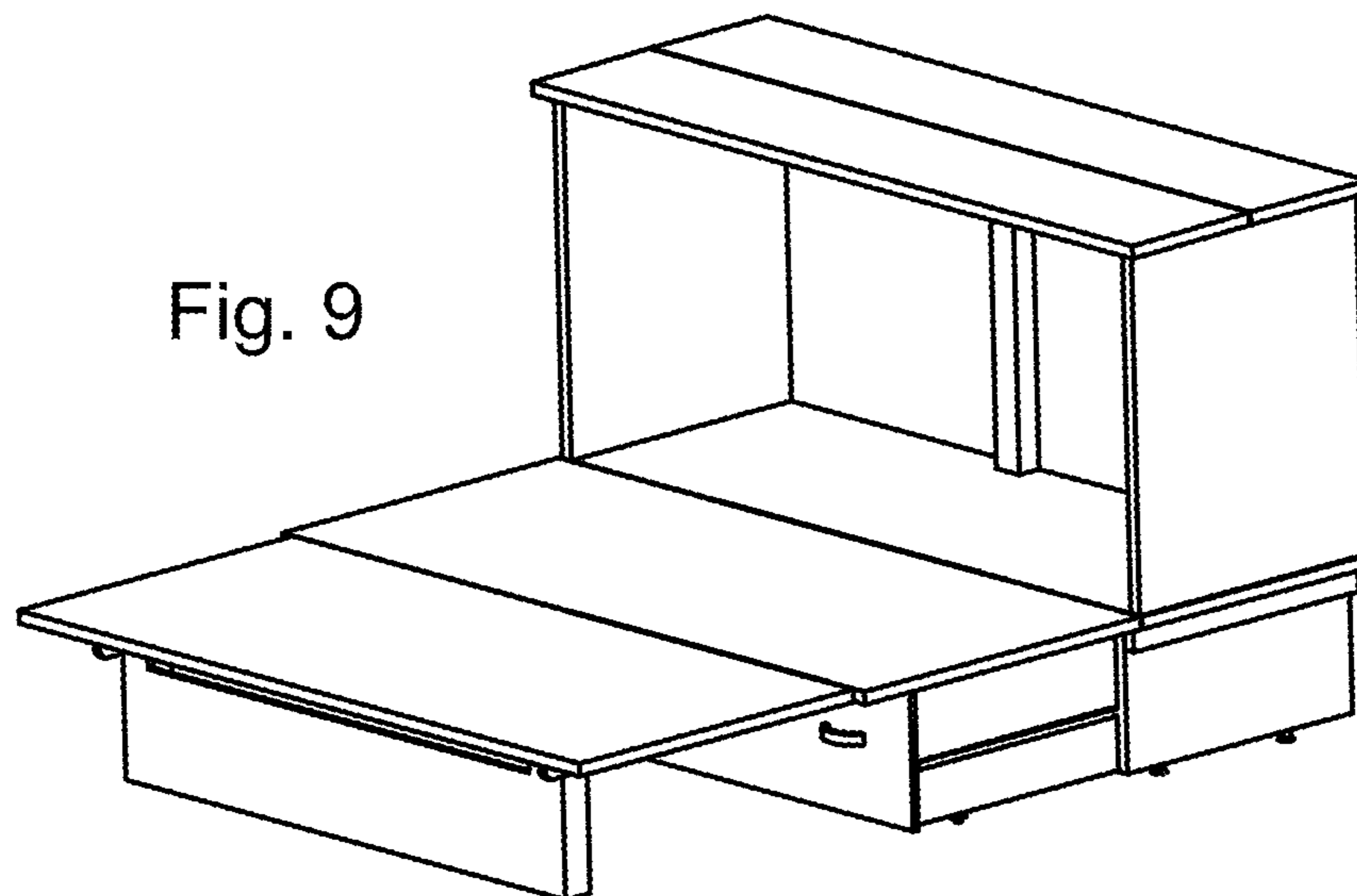

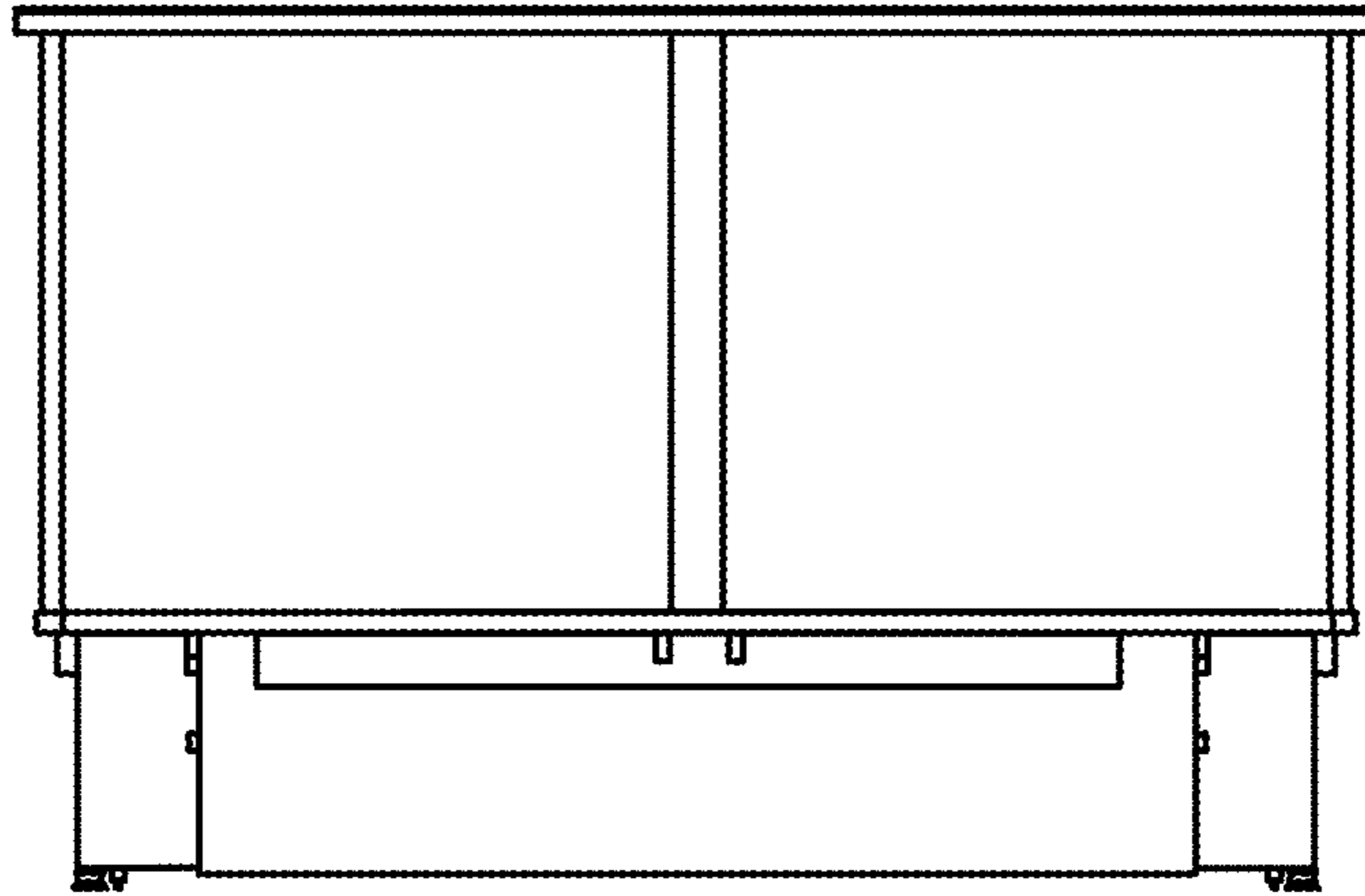
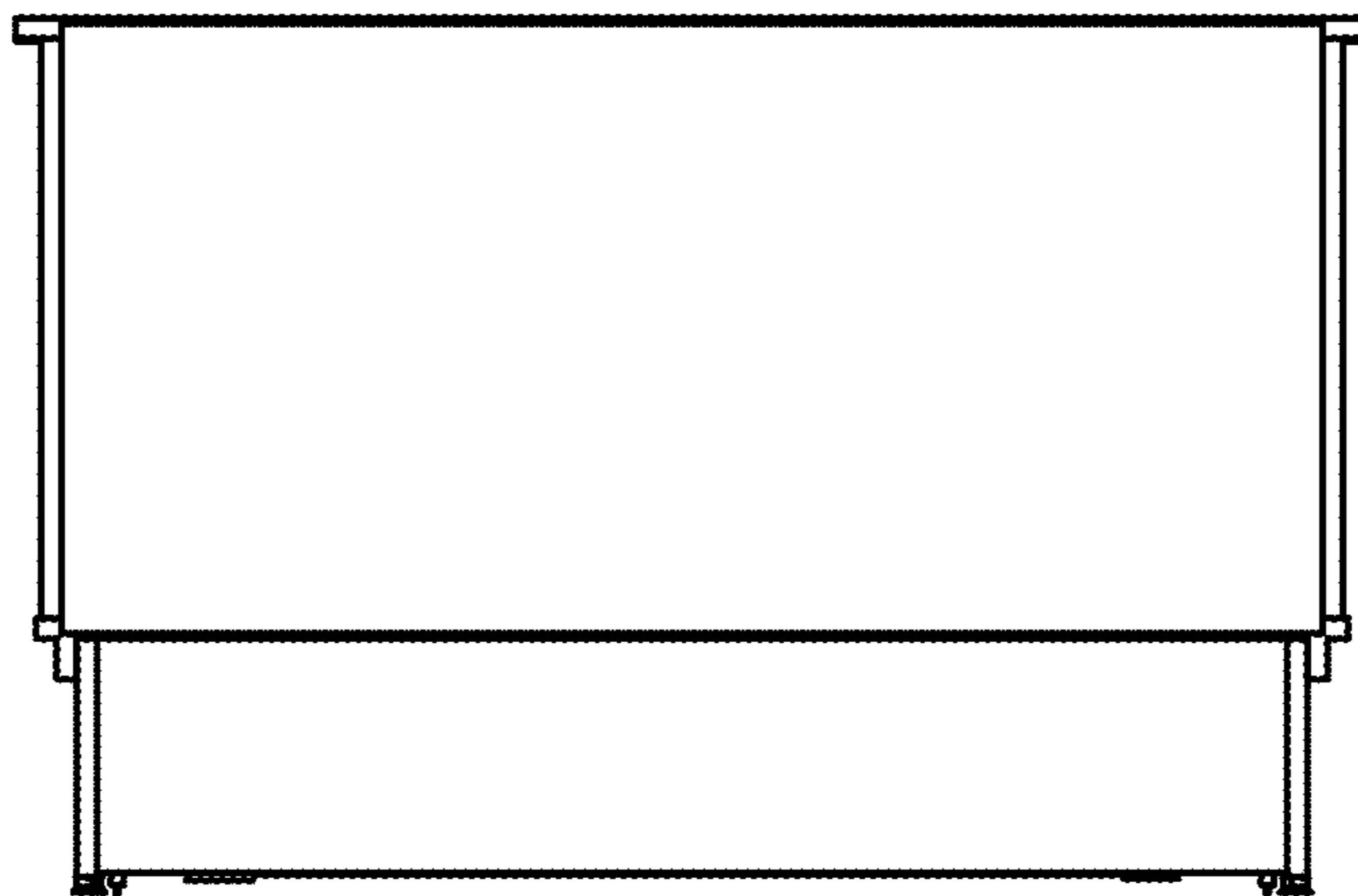

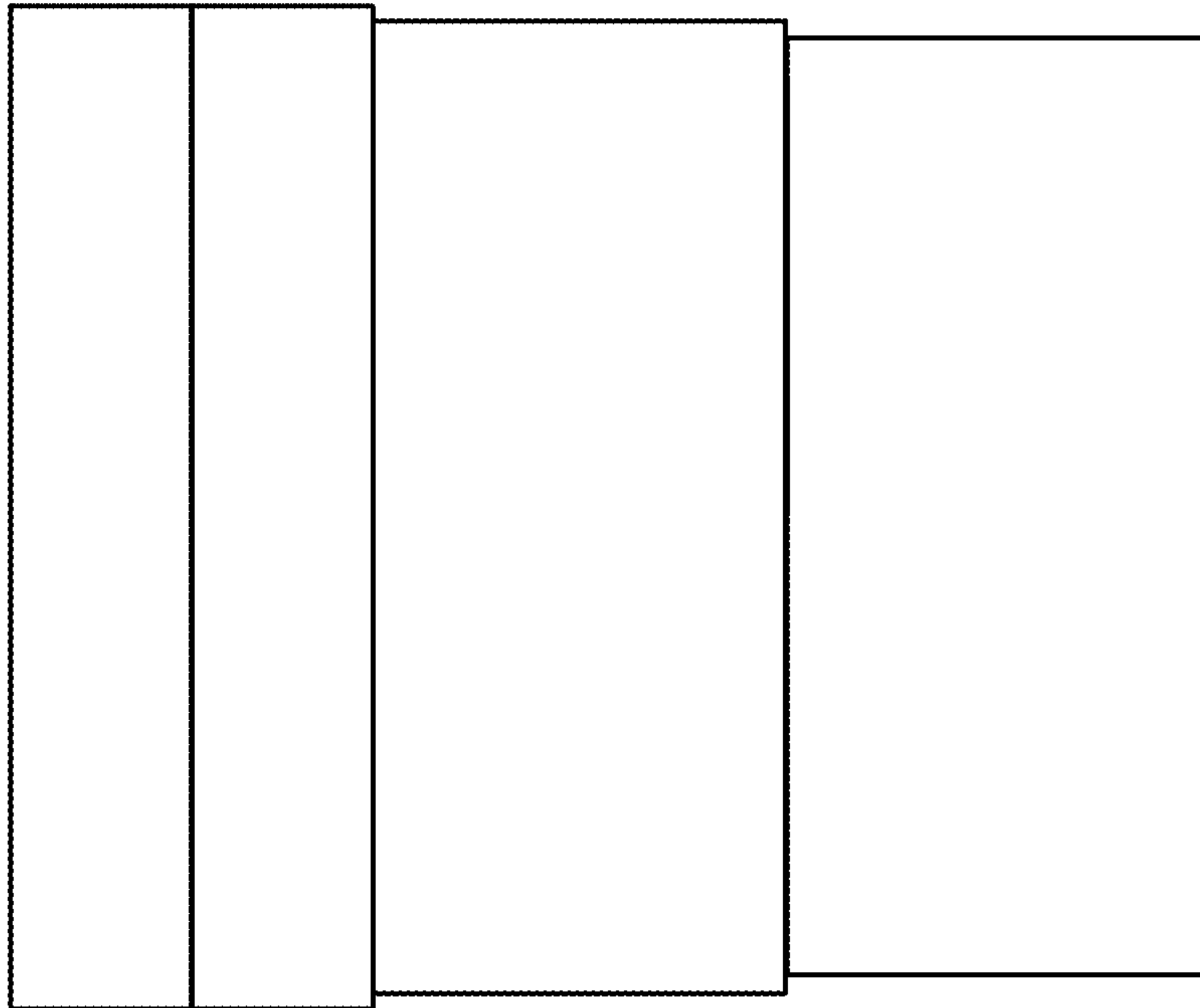

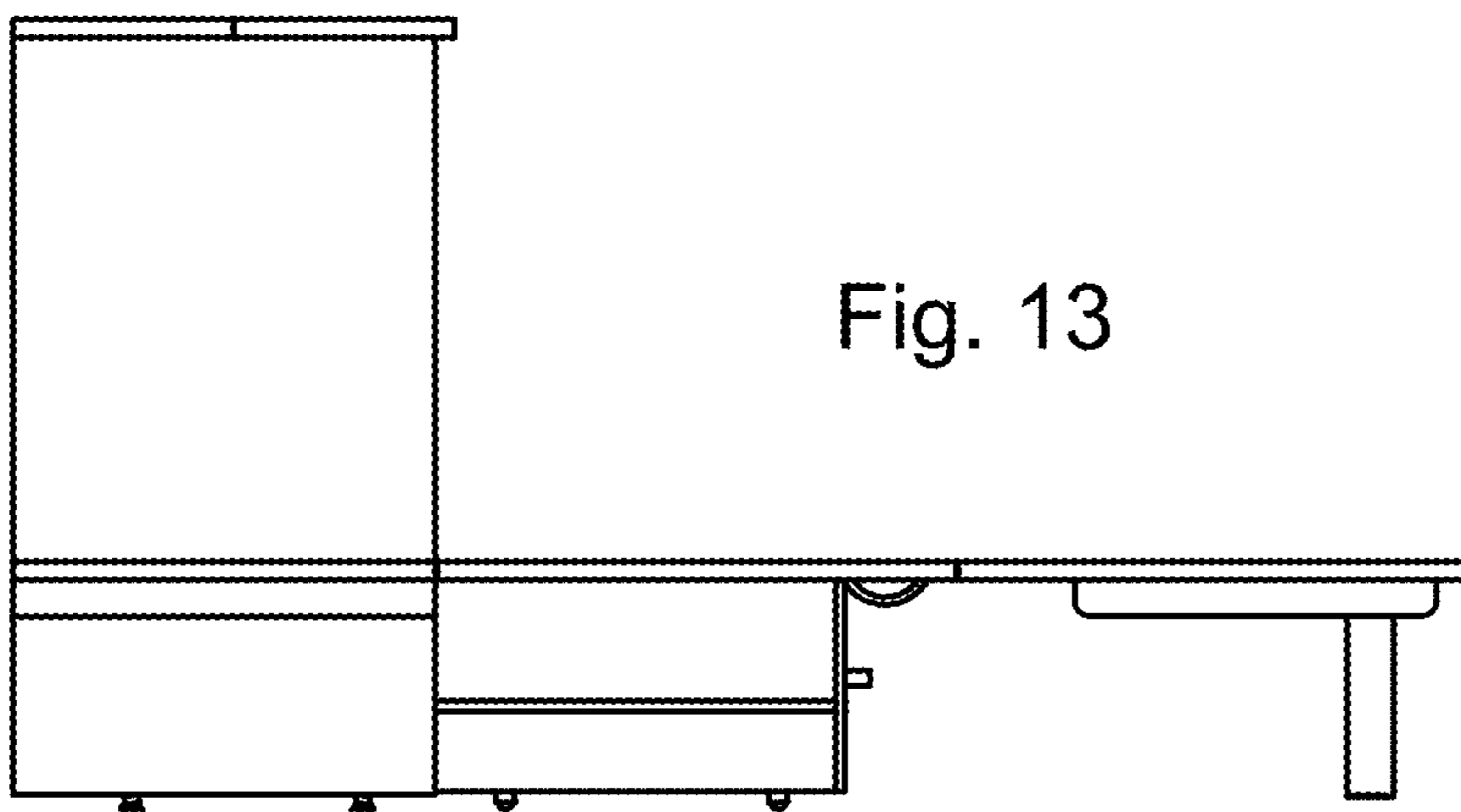

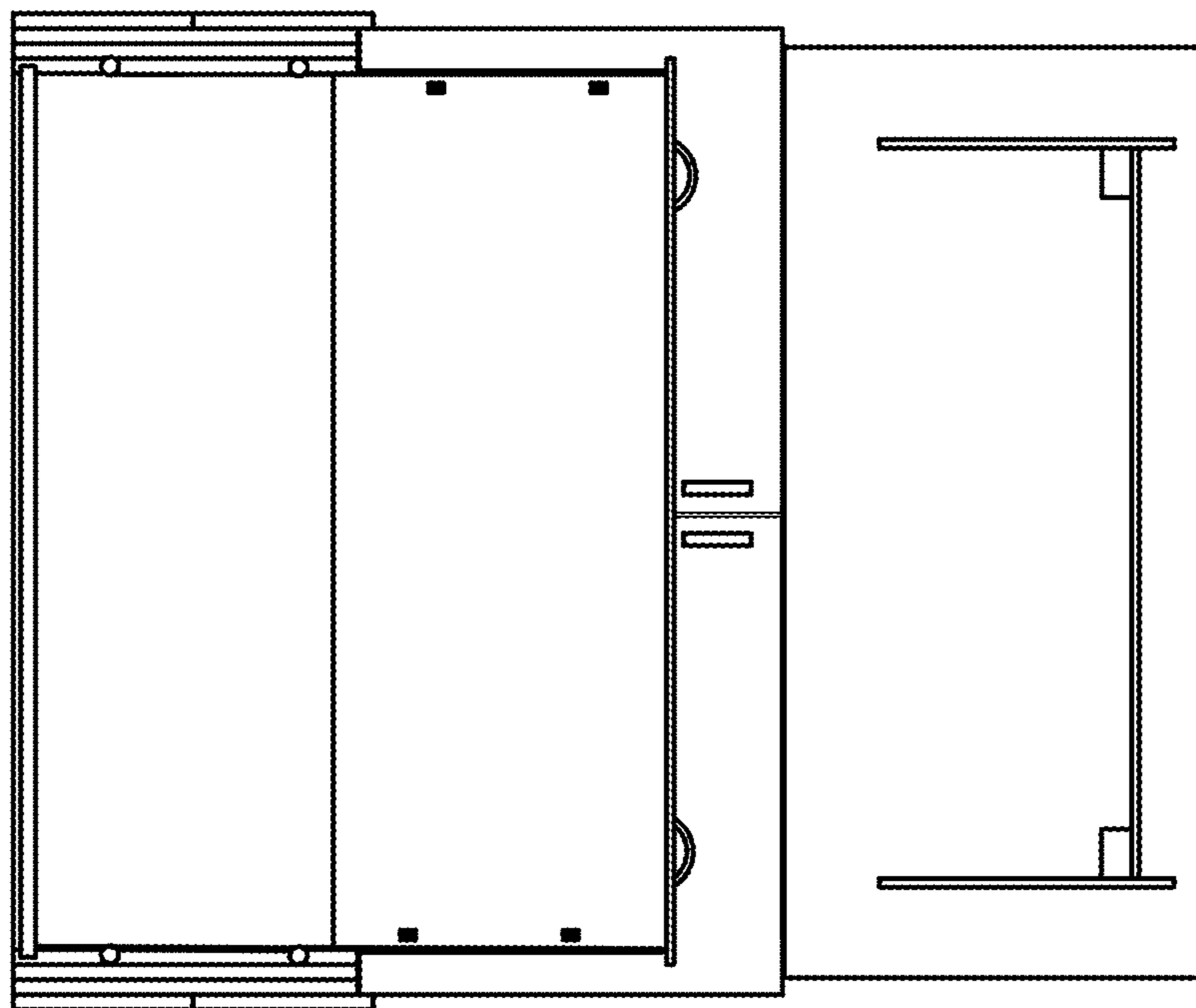
