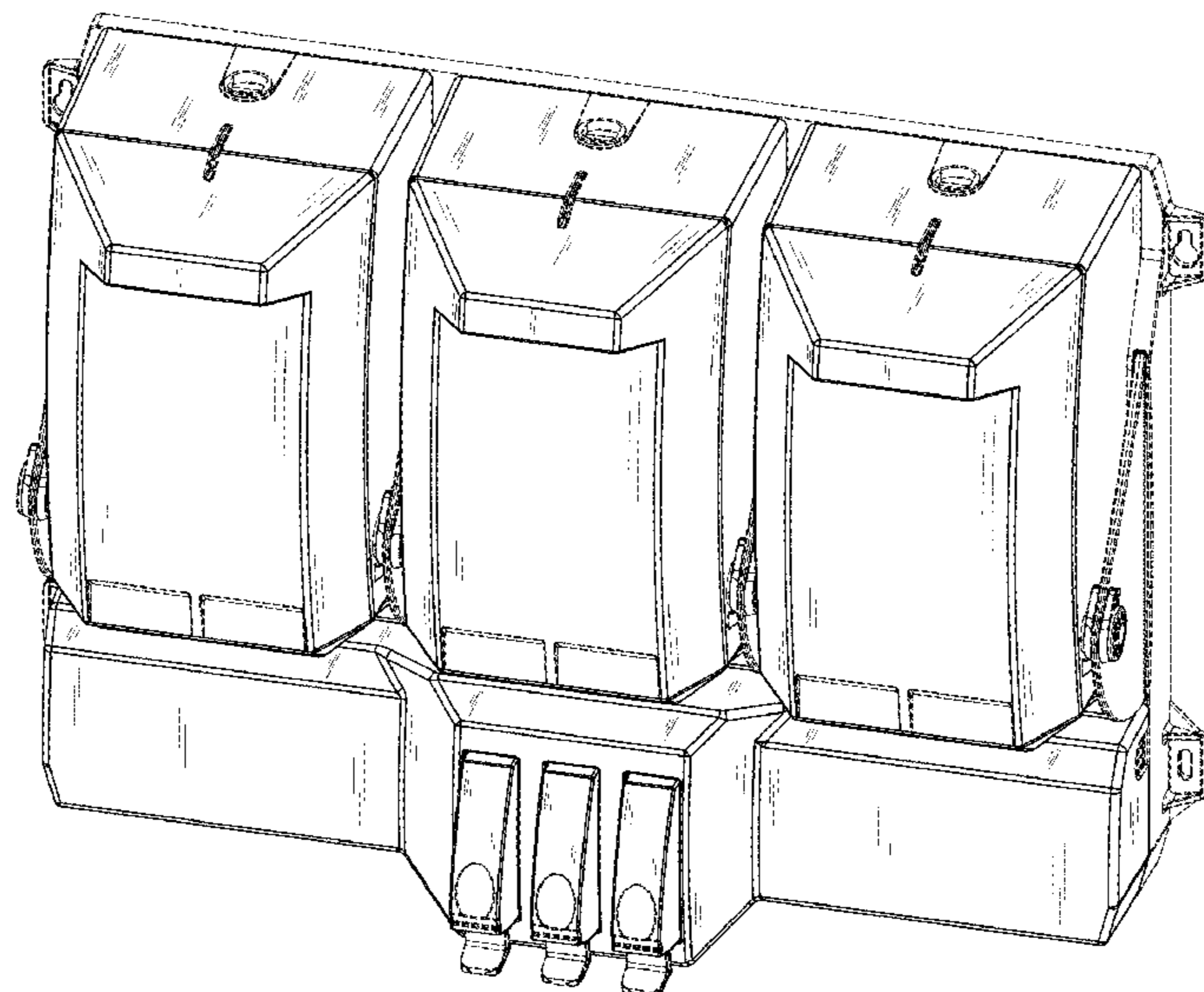
(57) **CLAIM**

The ornamental design for a dispenser for dispensing cleaning solutions, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective of a dispenser of the present invention; FIG. 2 is a front view of the dispenser of FIG. 1, the rear view forming no part of the invention; FIG. 3 is a right side elevation of the dispenser of FIG. 1, the left side elevation being a mirror image thereof; FIG. 4 is a top plan of the dispenser of FIG. 1; and, FIG. 5 is a bottom plan of the dispenser of FIG. 1. The elements shown in broken lines illustrate unclaimed features and boundary lines between claimed and unclaimed features and form no part of the claimed design.

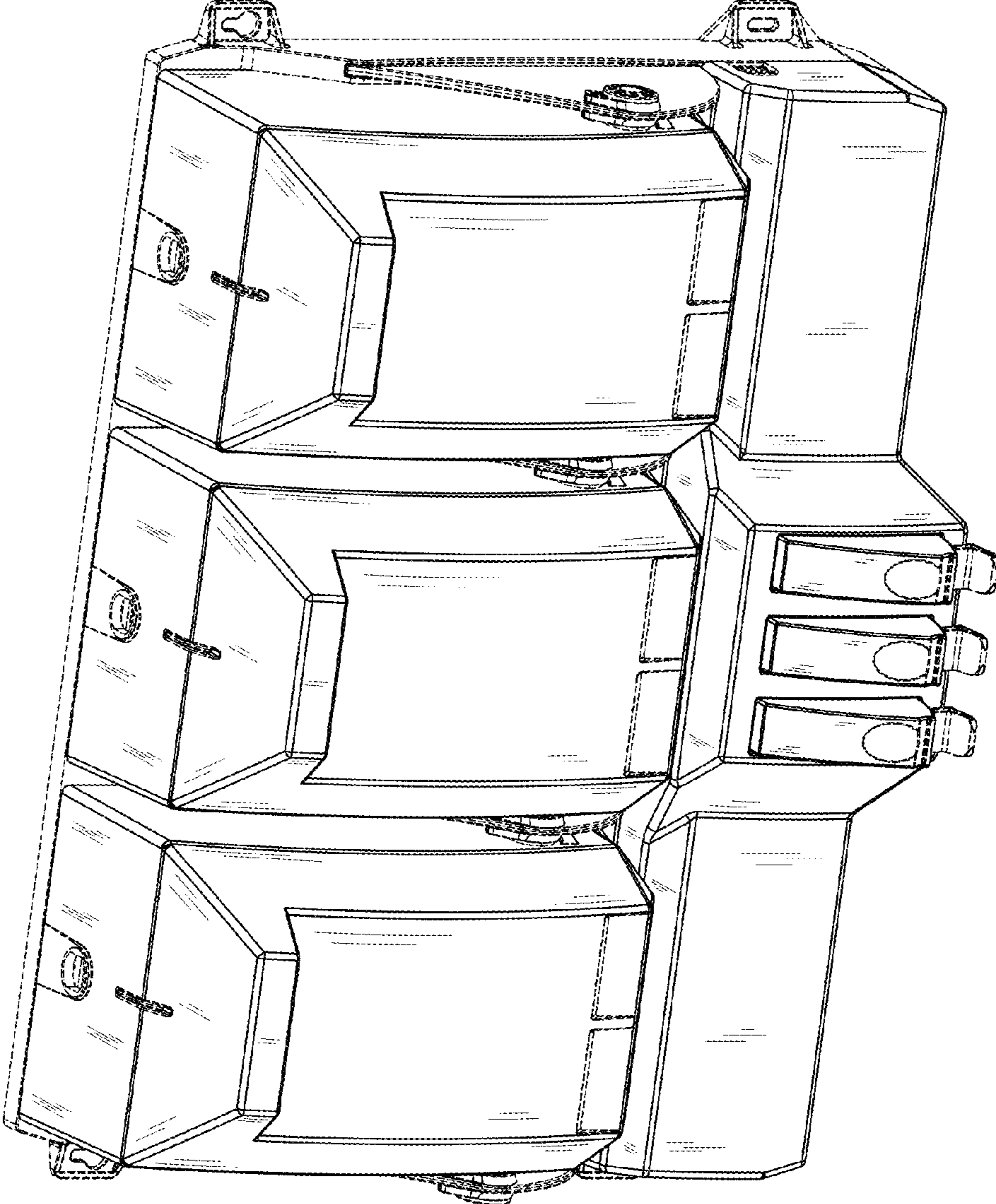

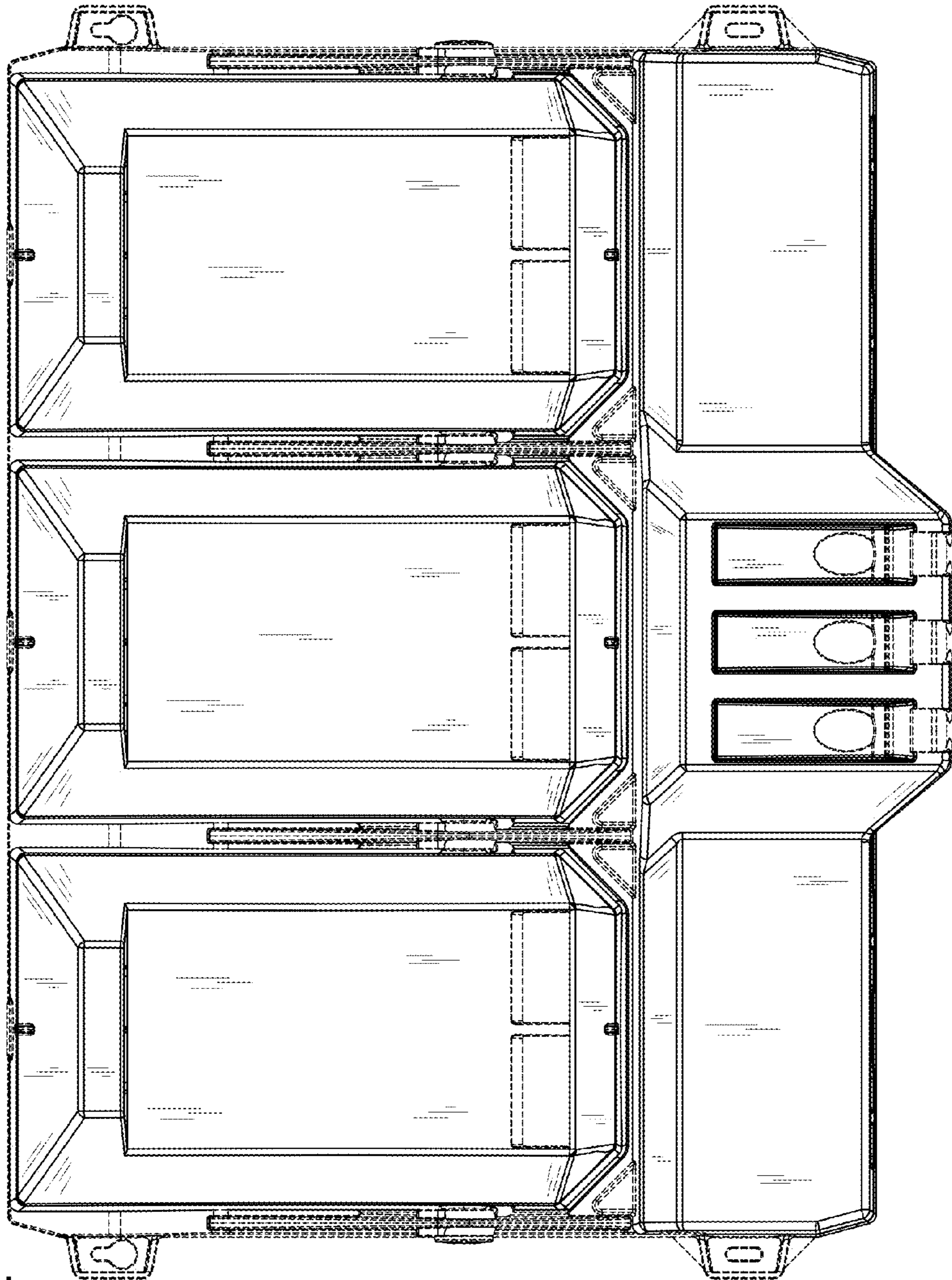

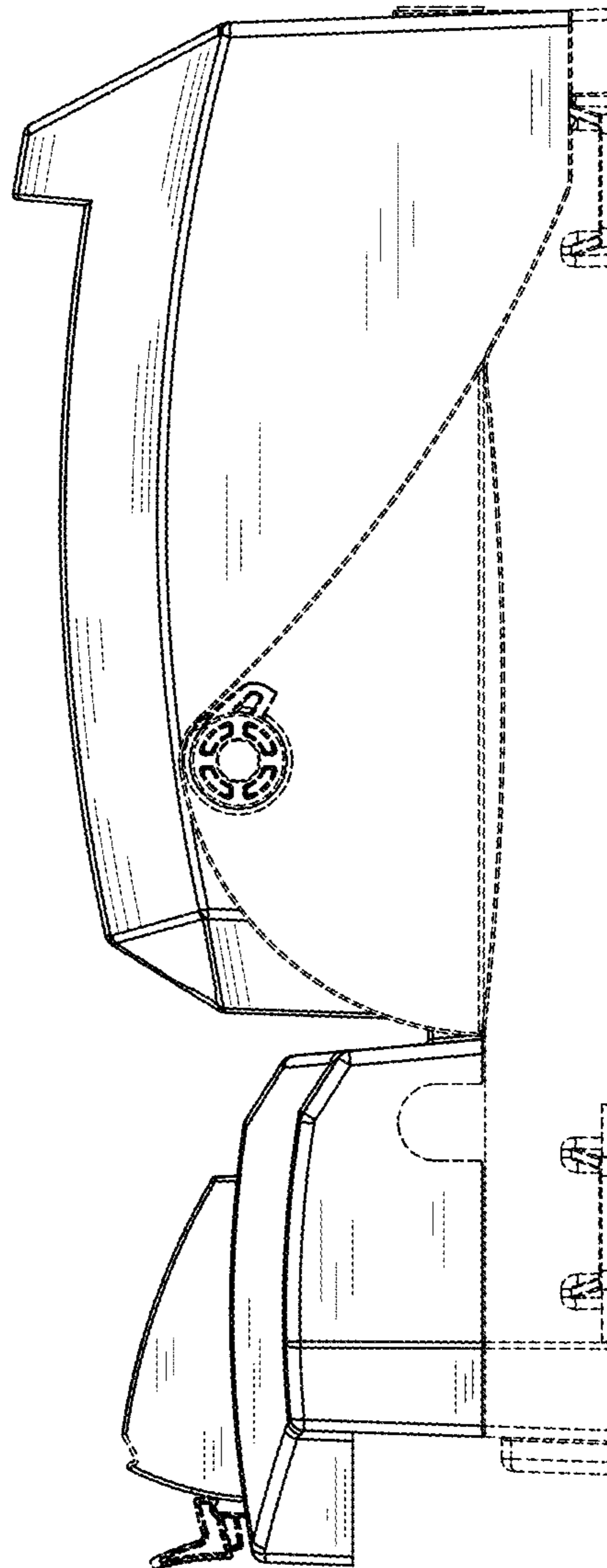

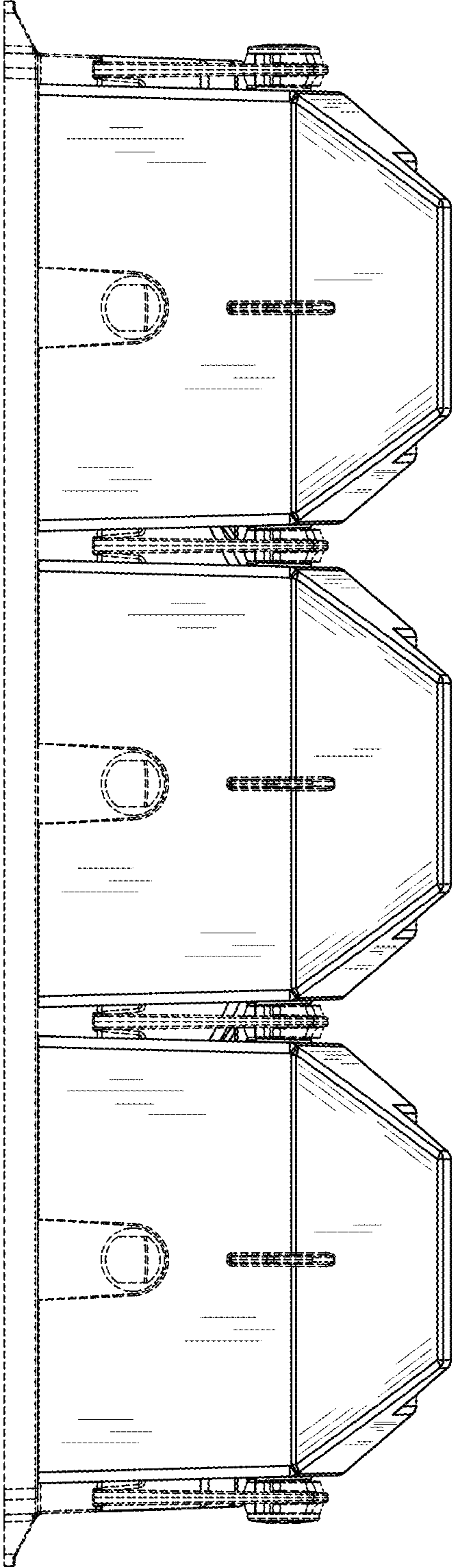
