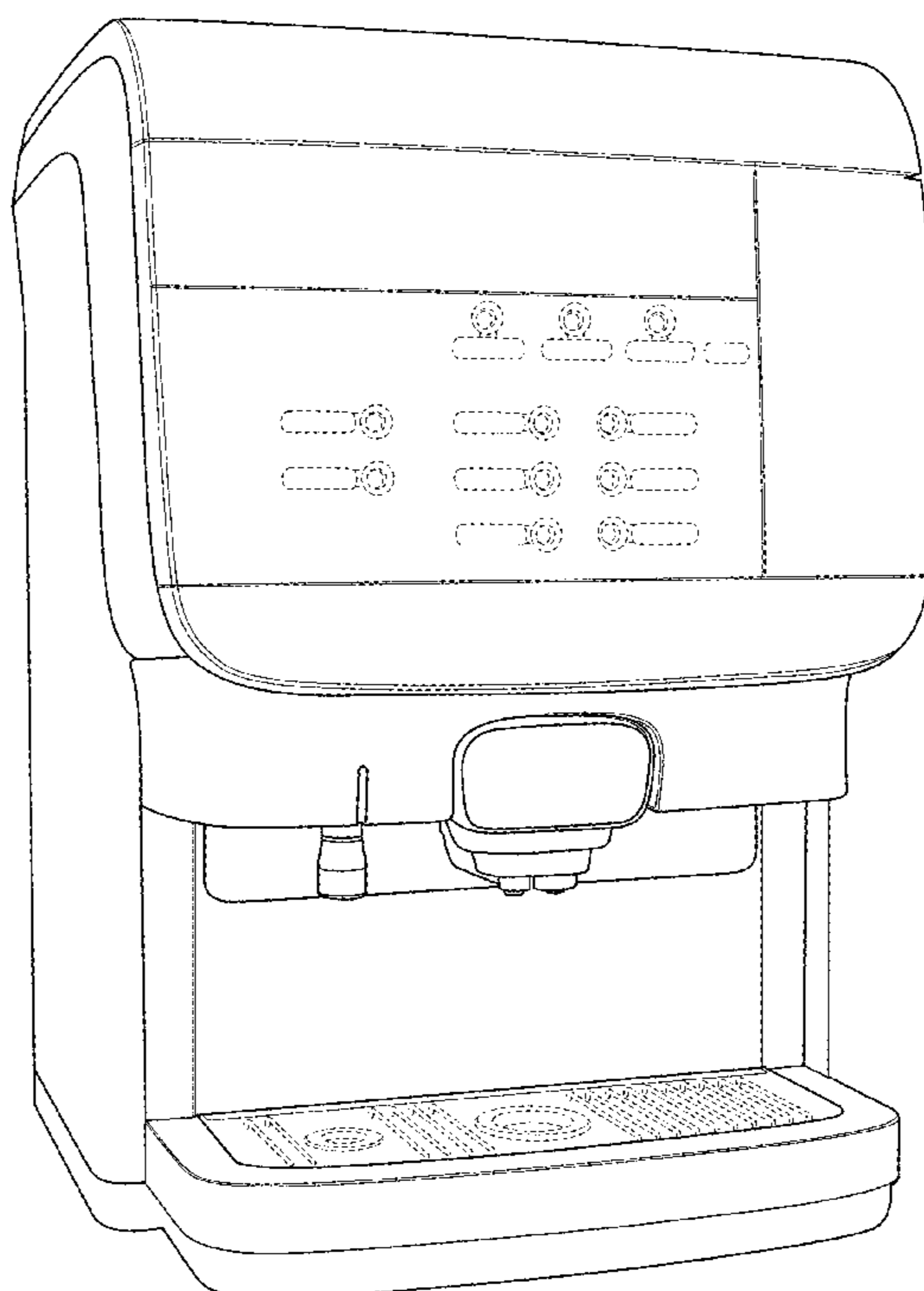
(57) **CLAIM**

The ornamental design for a beverage dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a beverage dispenser. FIG. 2 is a front view of the beverage dispenser of FIG. 1. FIG. 3 is a rear view of the beverage dispenser of FIG. 1. FIG. 4 is a right side view of the beverage dispenser of FIG. 1. FIG. 5 is a left side view of the beverage dispenser of FIG. 1. FIG. 6 is a top view of the beverage dispenser of FIG. 1; and, FIG. 7 is a bottom view of the beverage dispenser of FIG. 1. The portions of the figures shown in broken lines form no part of the claimed design.

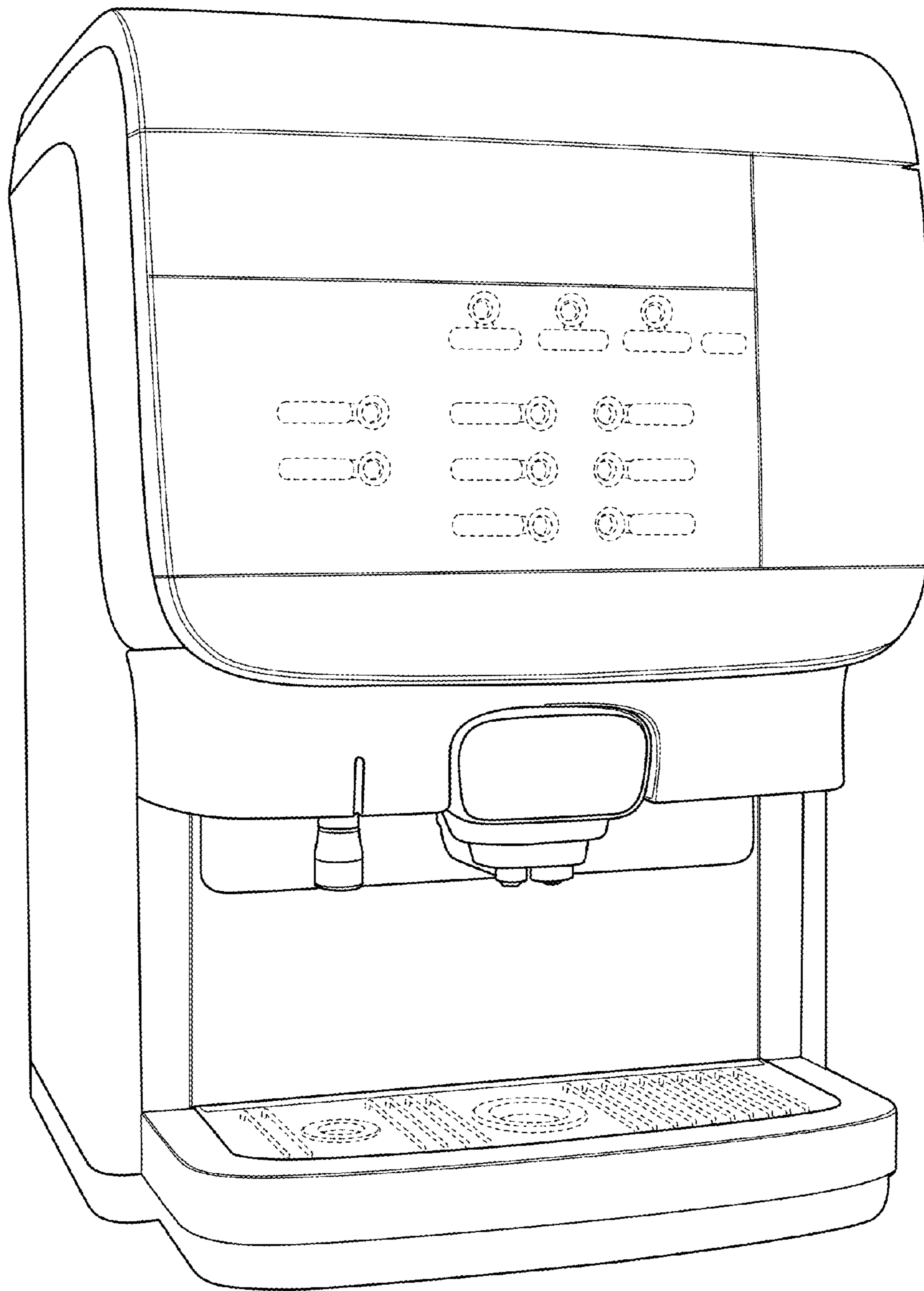

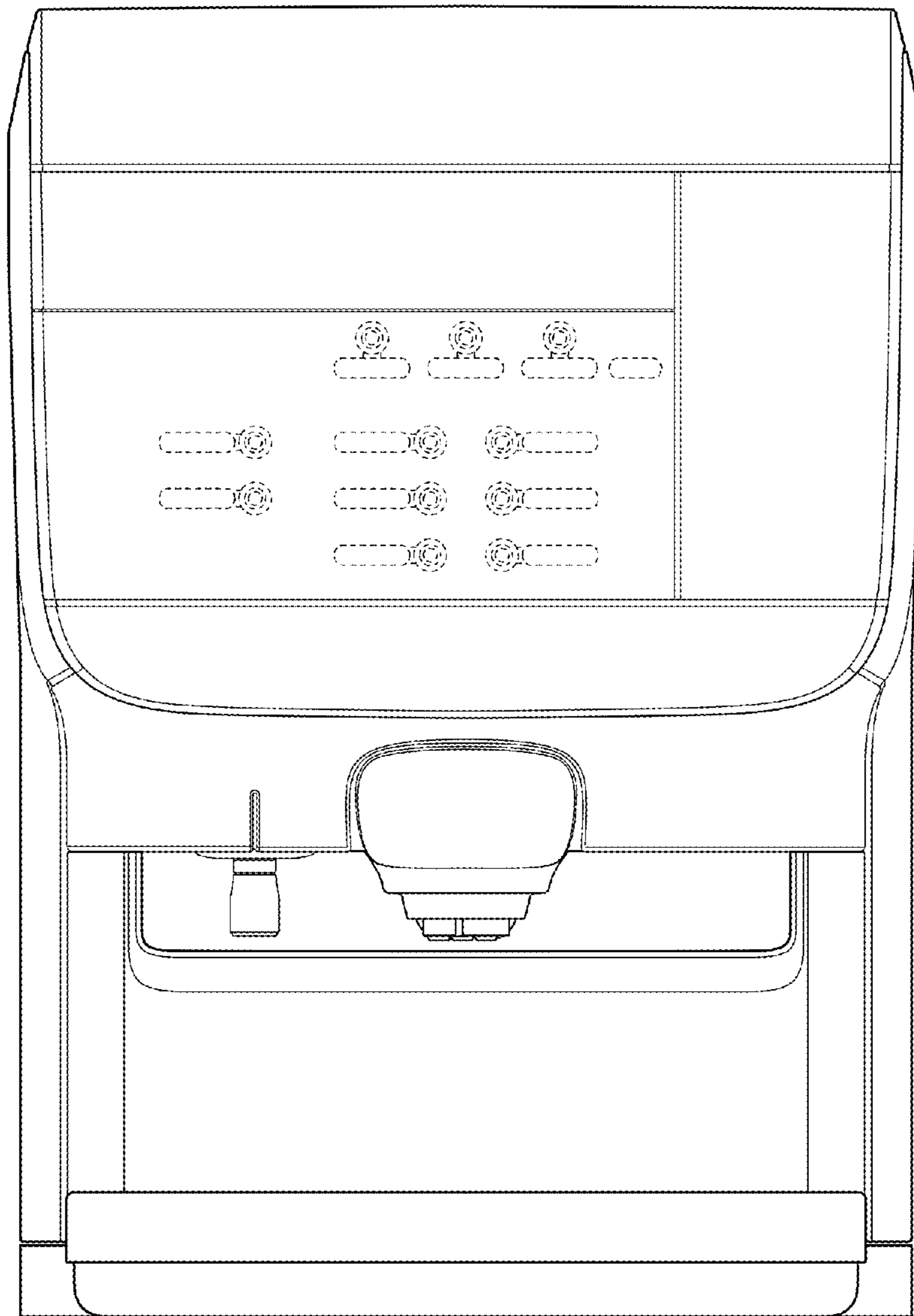

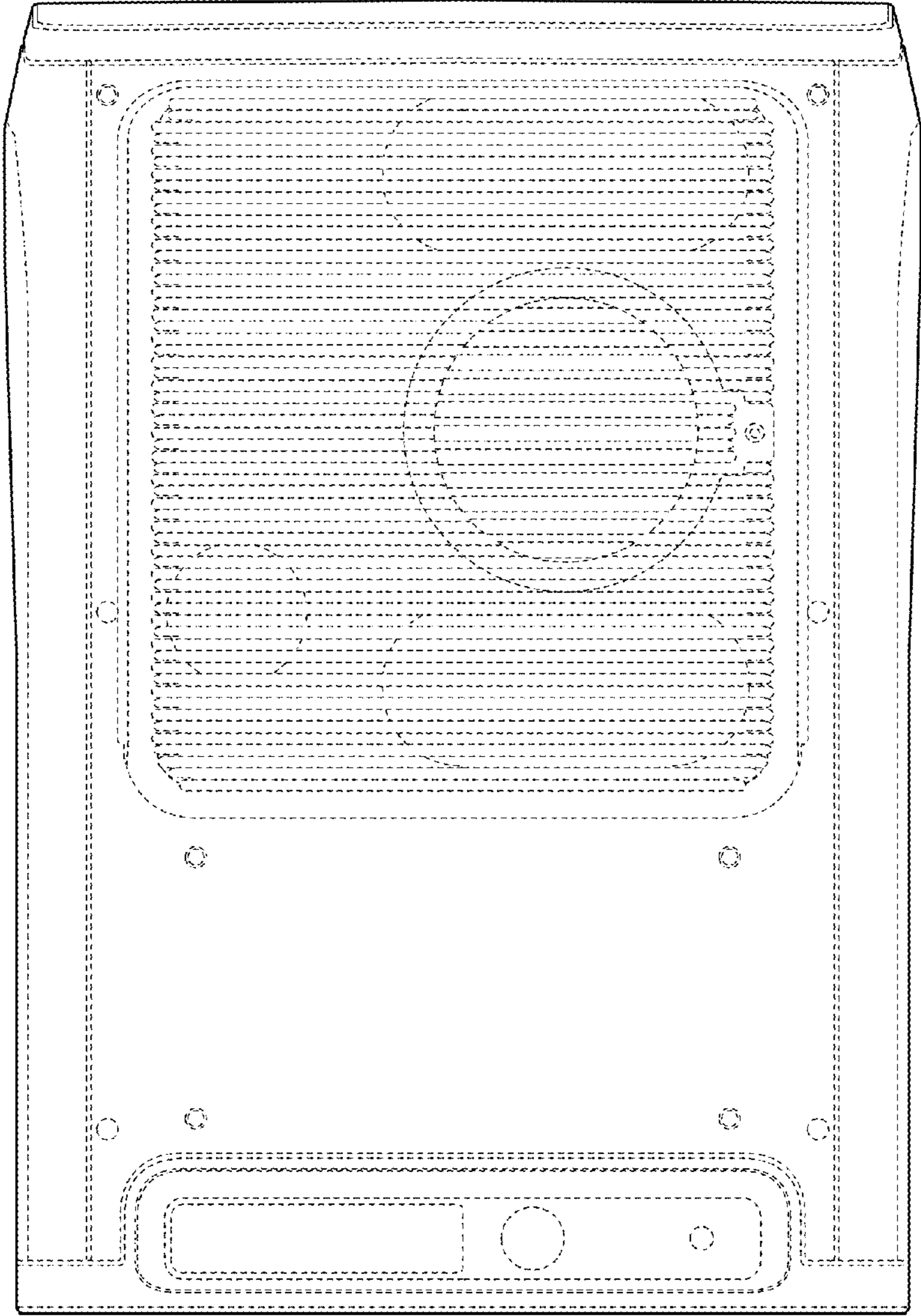

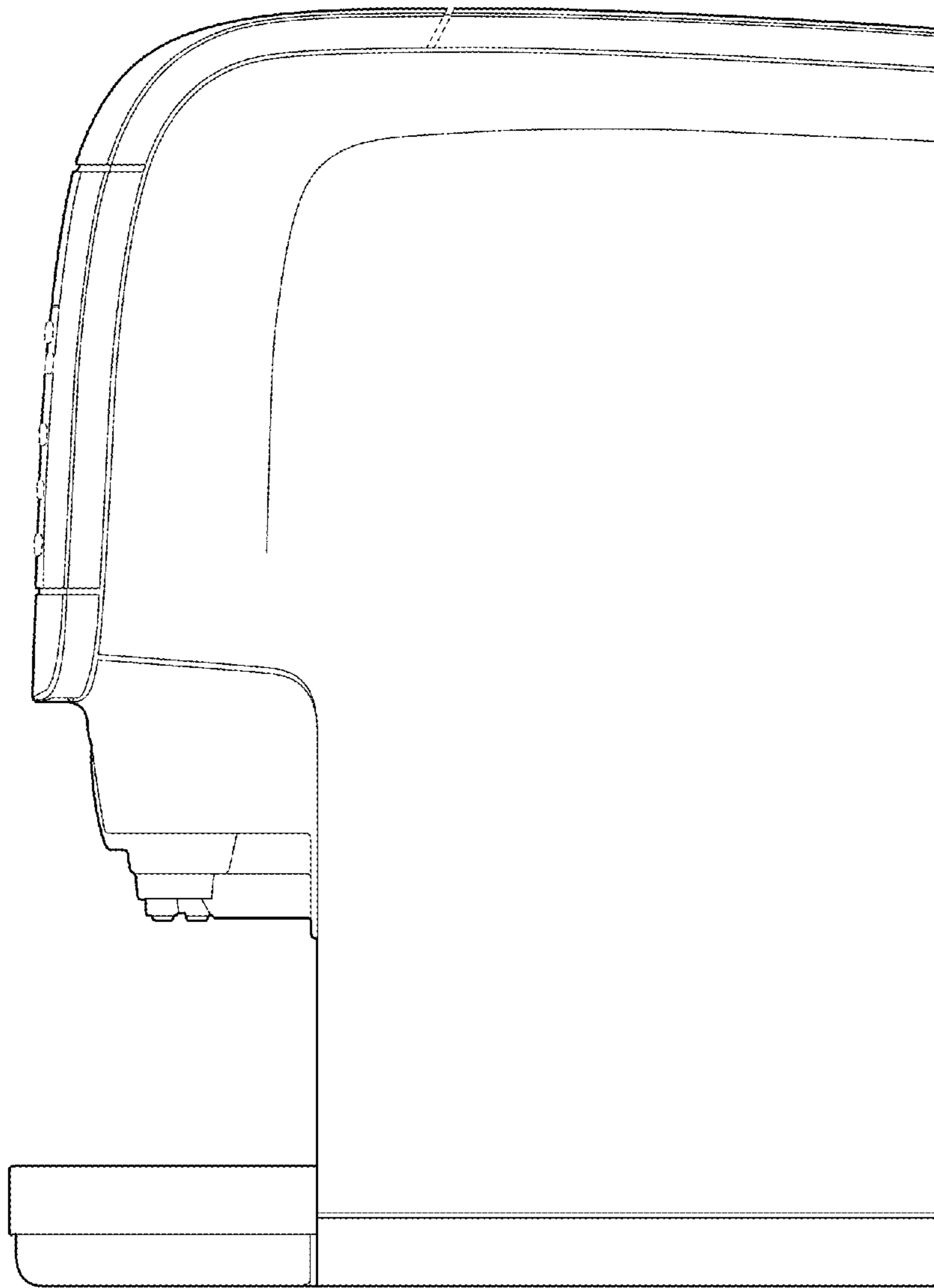

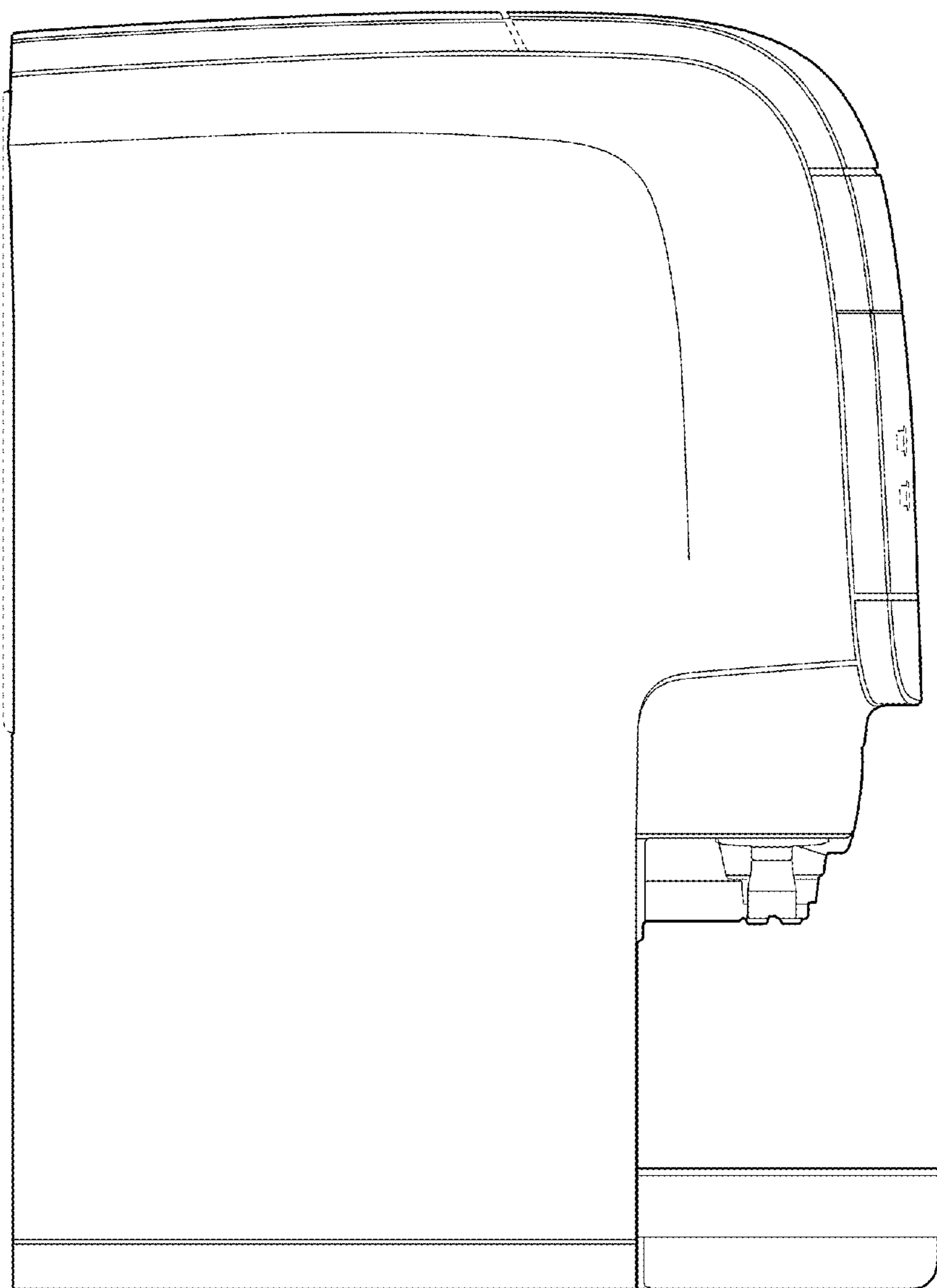

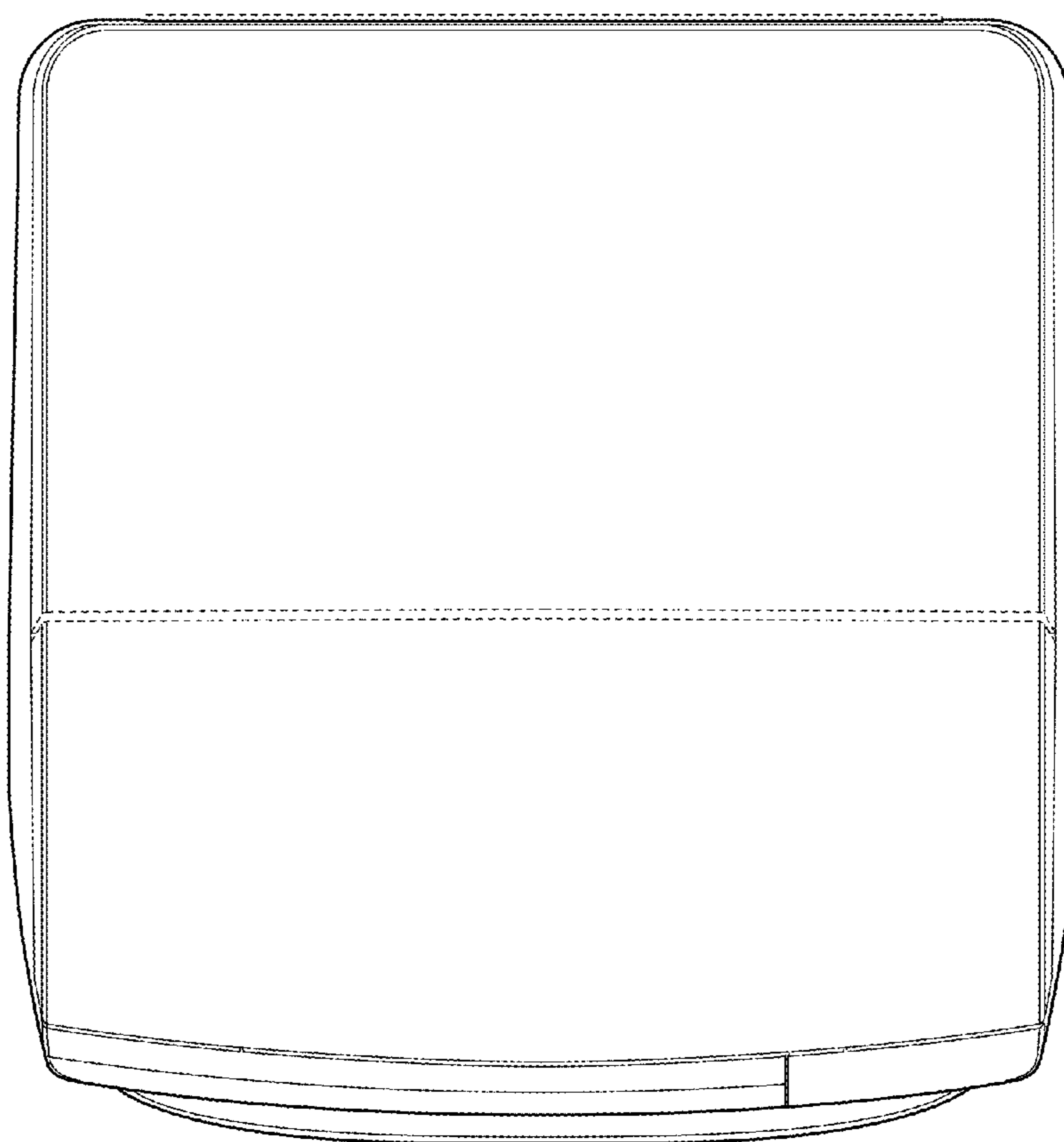

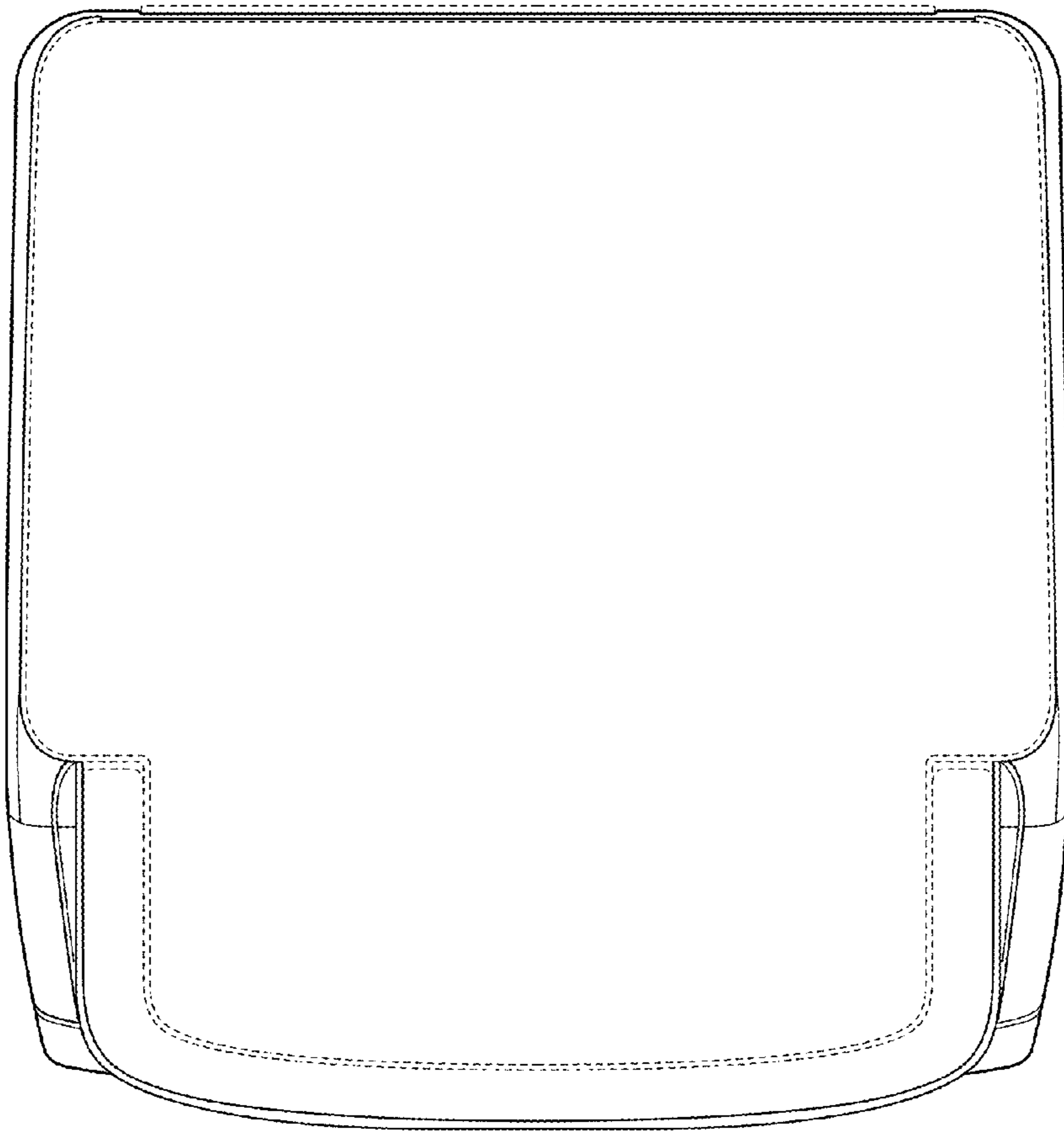
