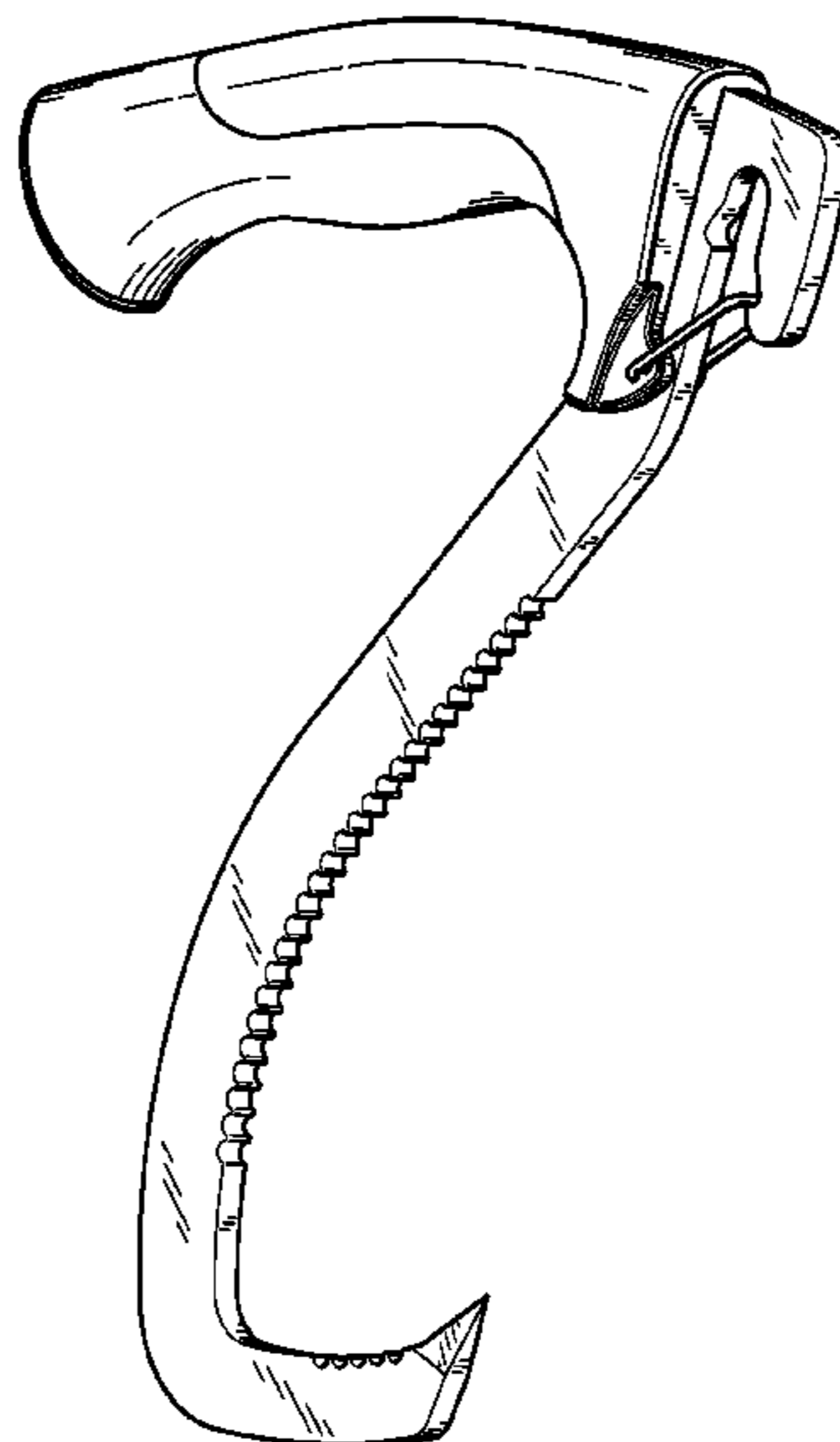
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front top perspective view of an embodiment of the claimed design;

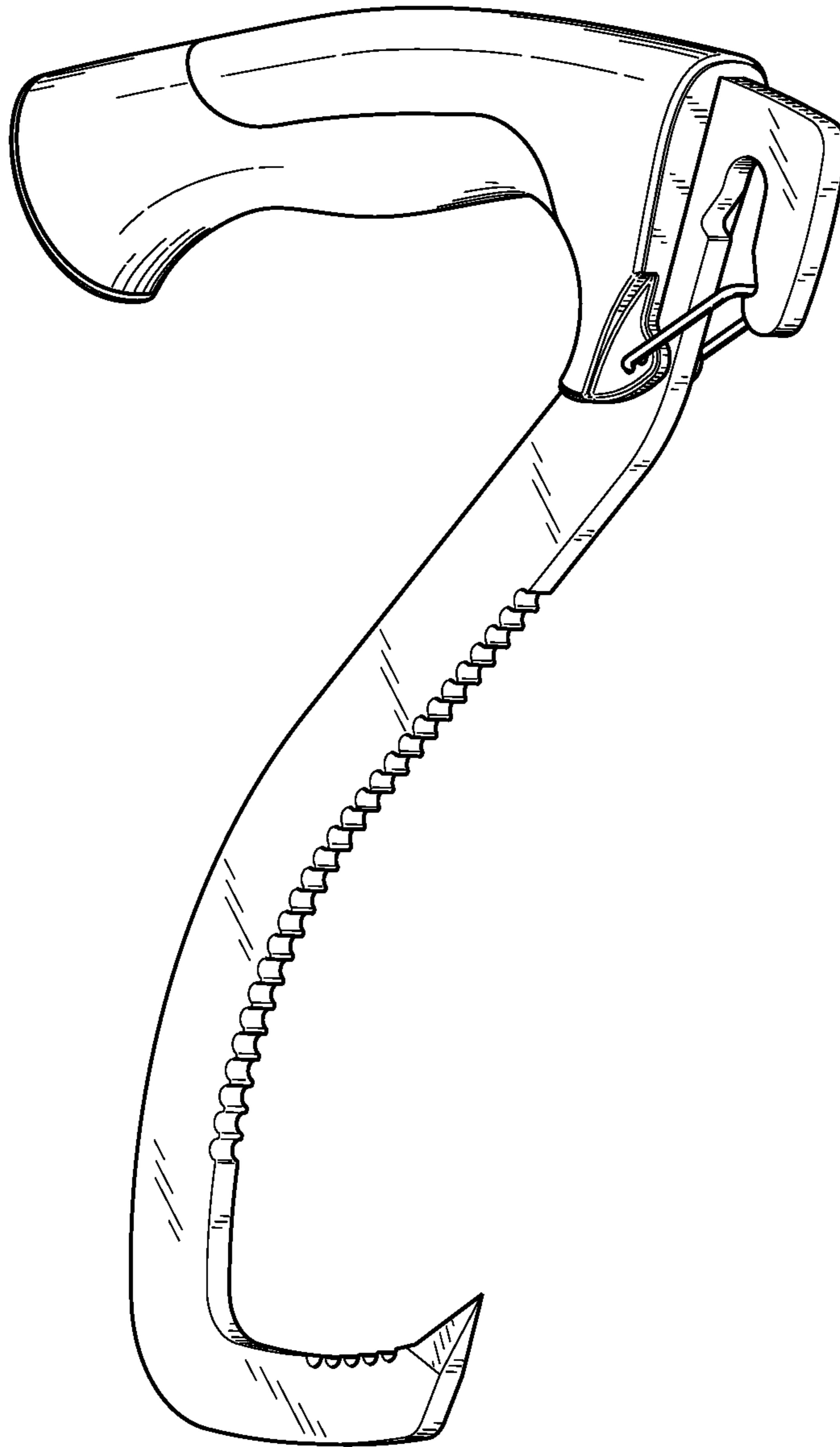

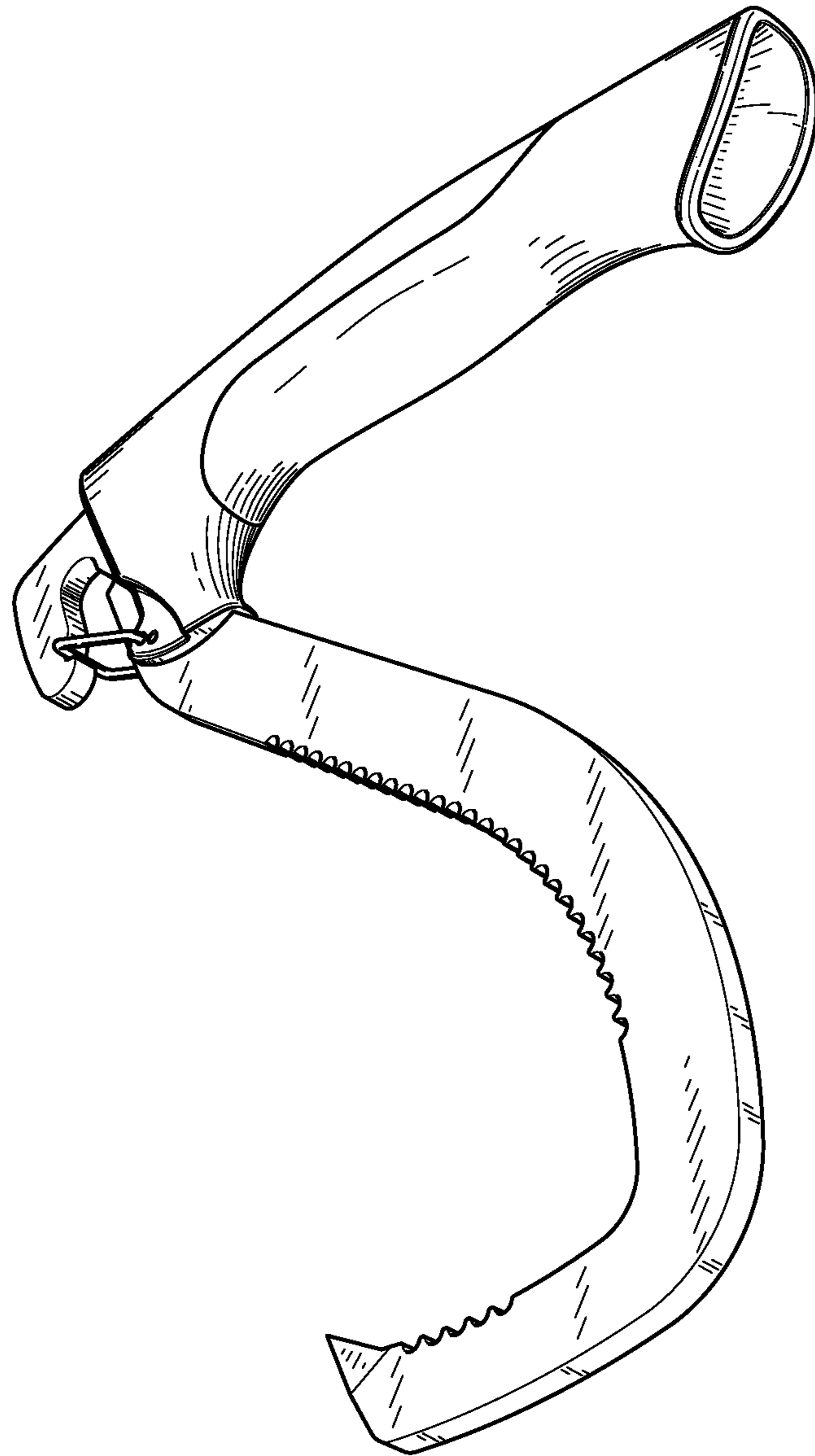

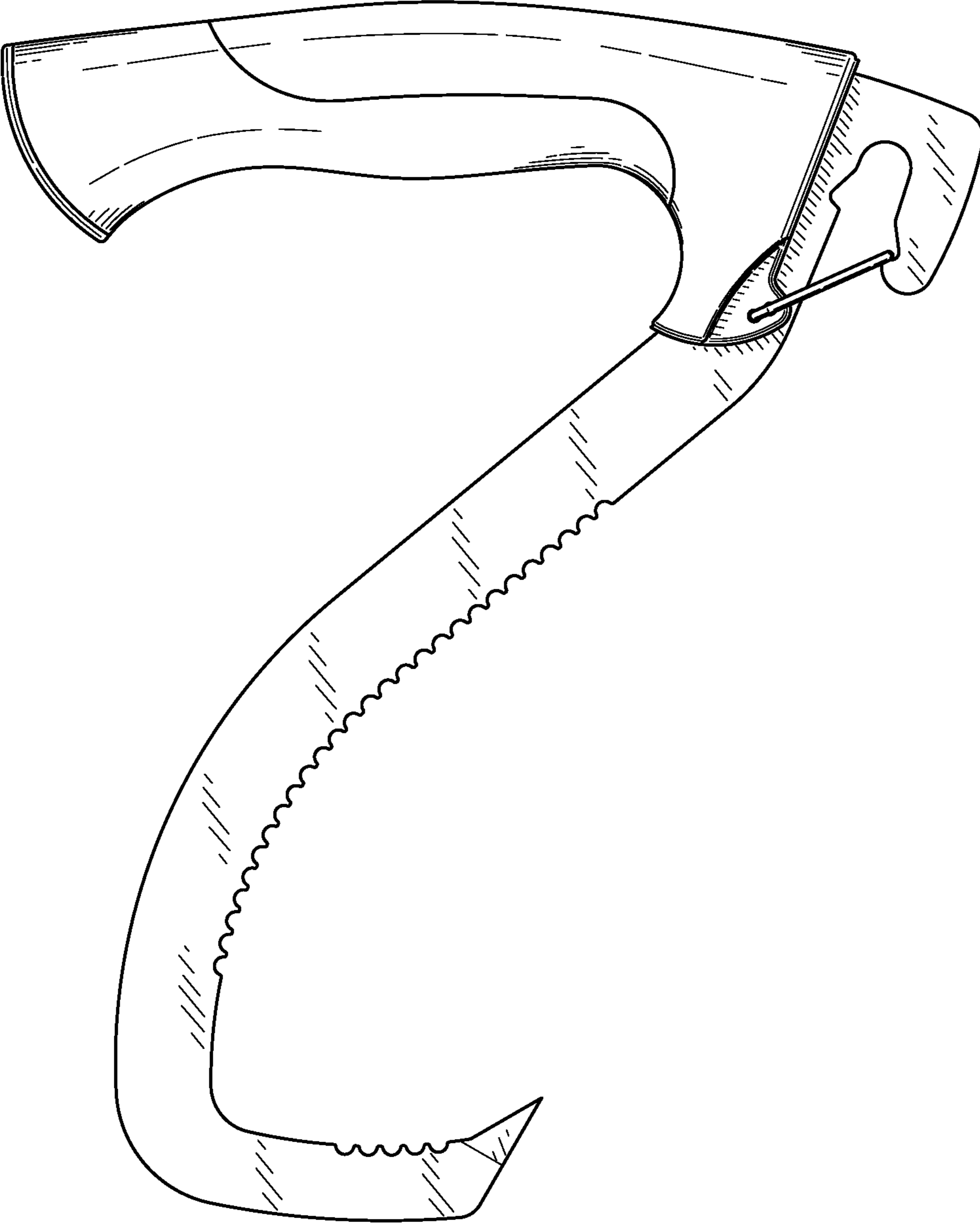

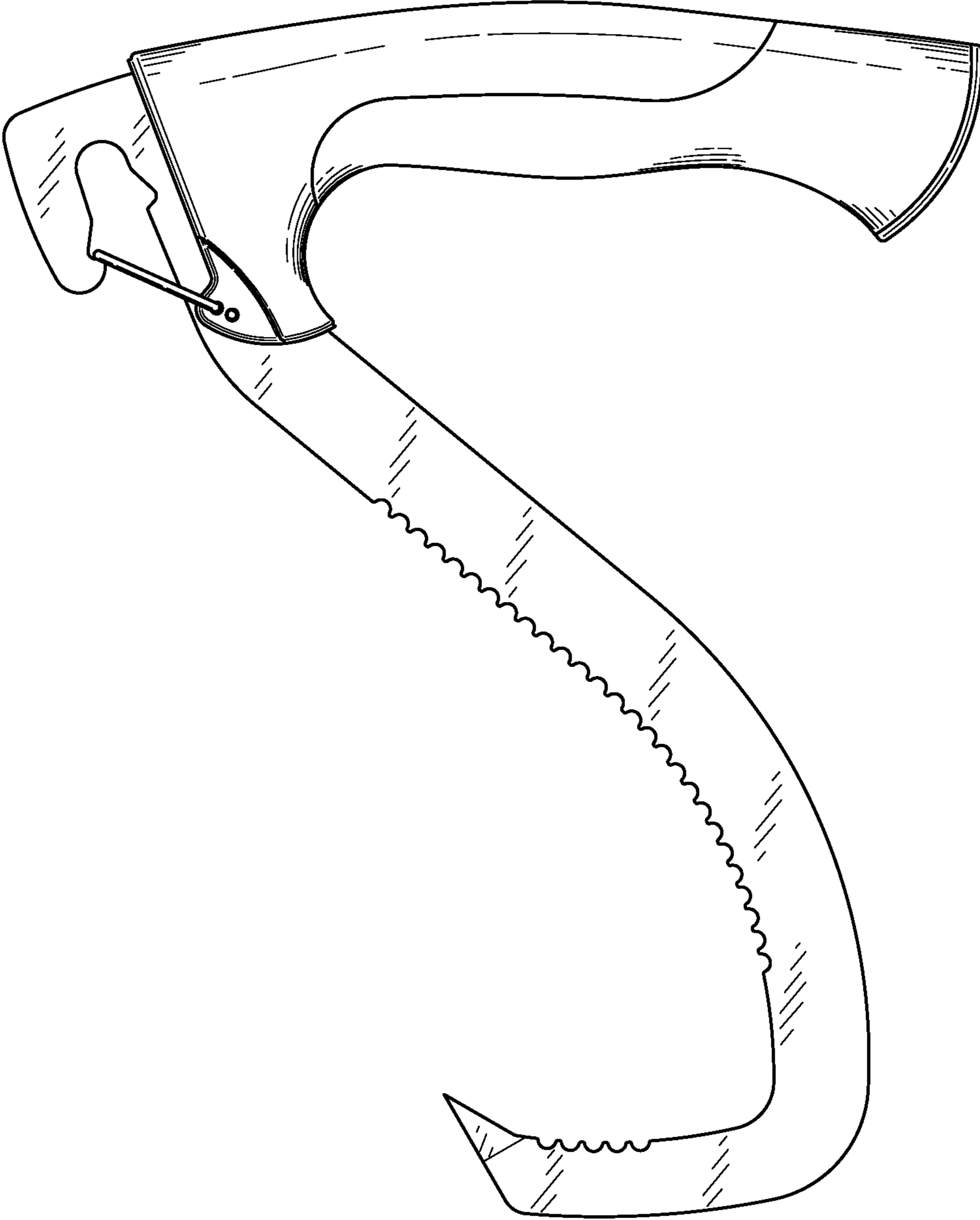

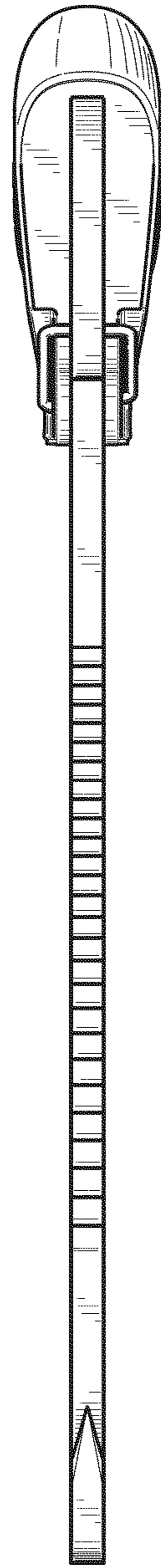

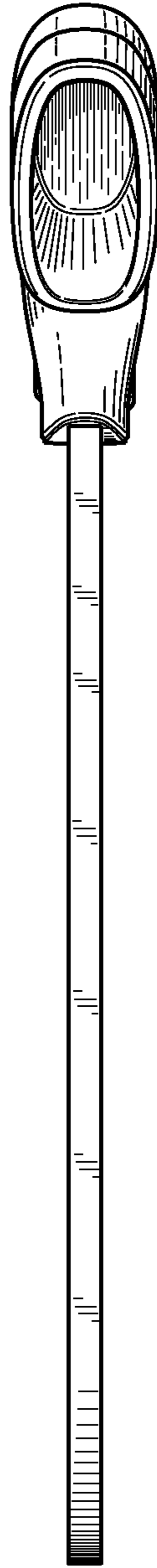

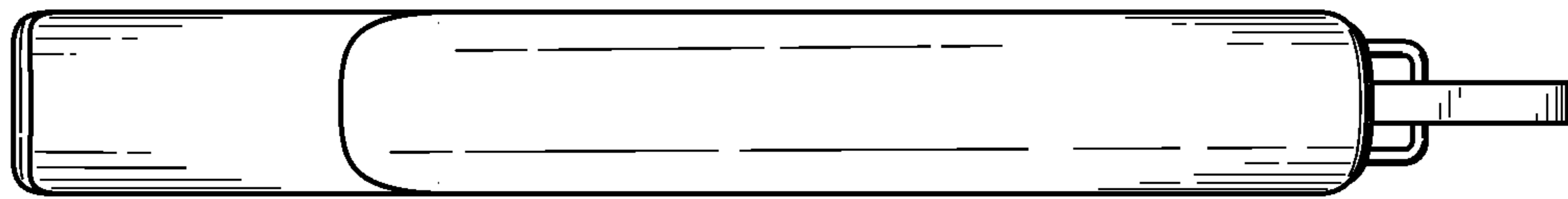
