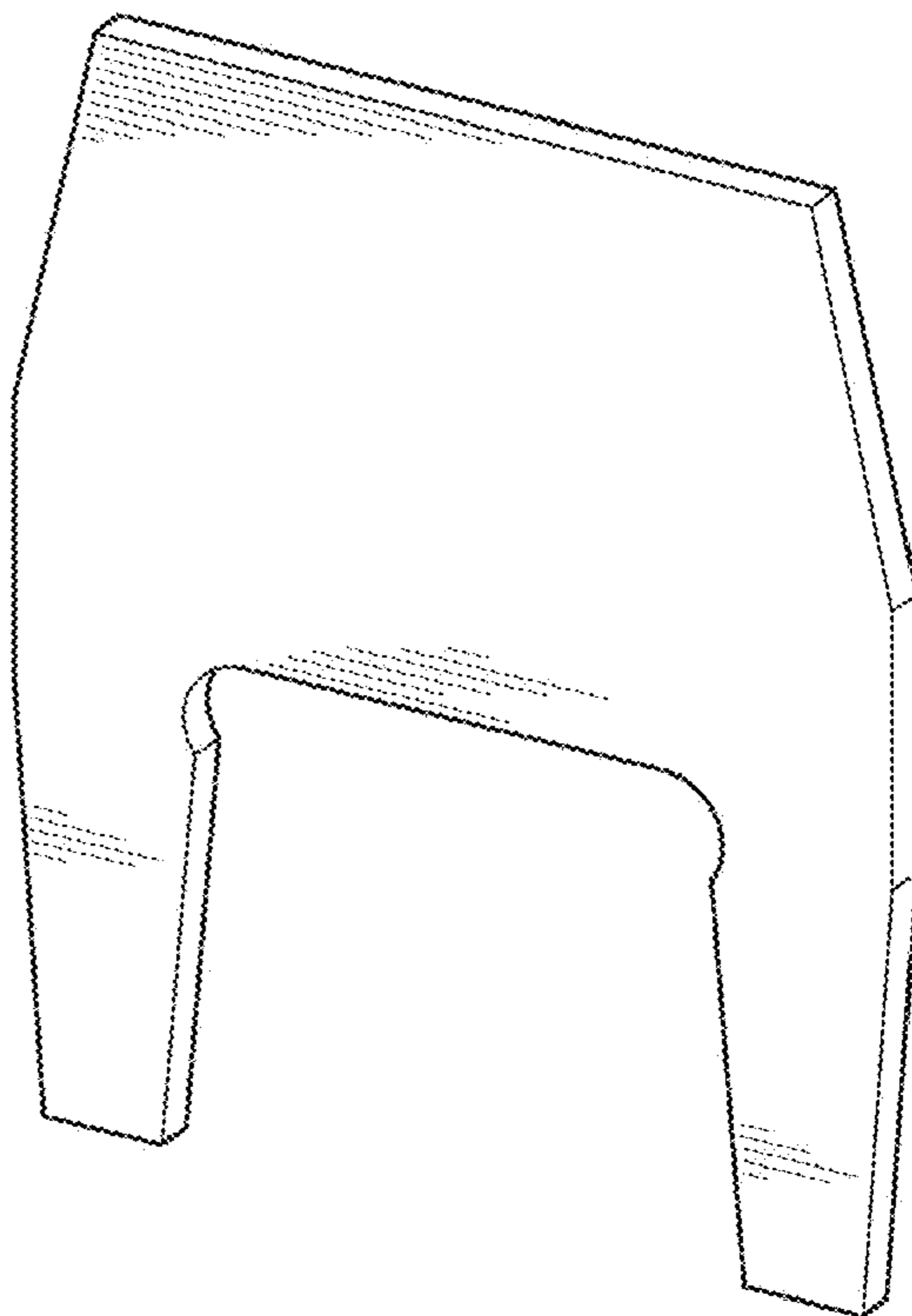
(57) **CLAIM**

The ornamental design for a sign frame key, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a sign frame key showing our new design;  
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;  
FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;  
FIG. 4 is top plan view thereof; and,  
FIG. 5 is a bottom plan view thereof.  
The shading lines shown in the drawings represent the approximate three-dimensional contour of the design, and are not intended to indicate surface decoration.

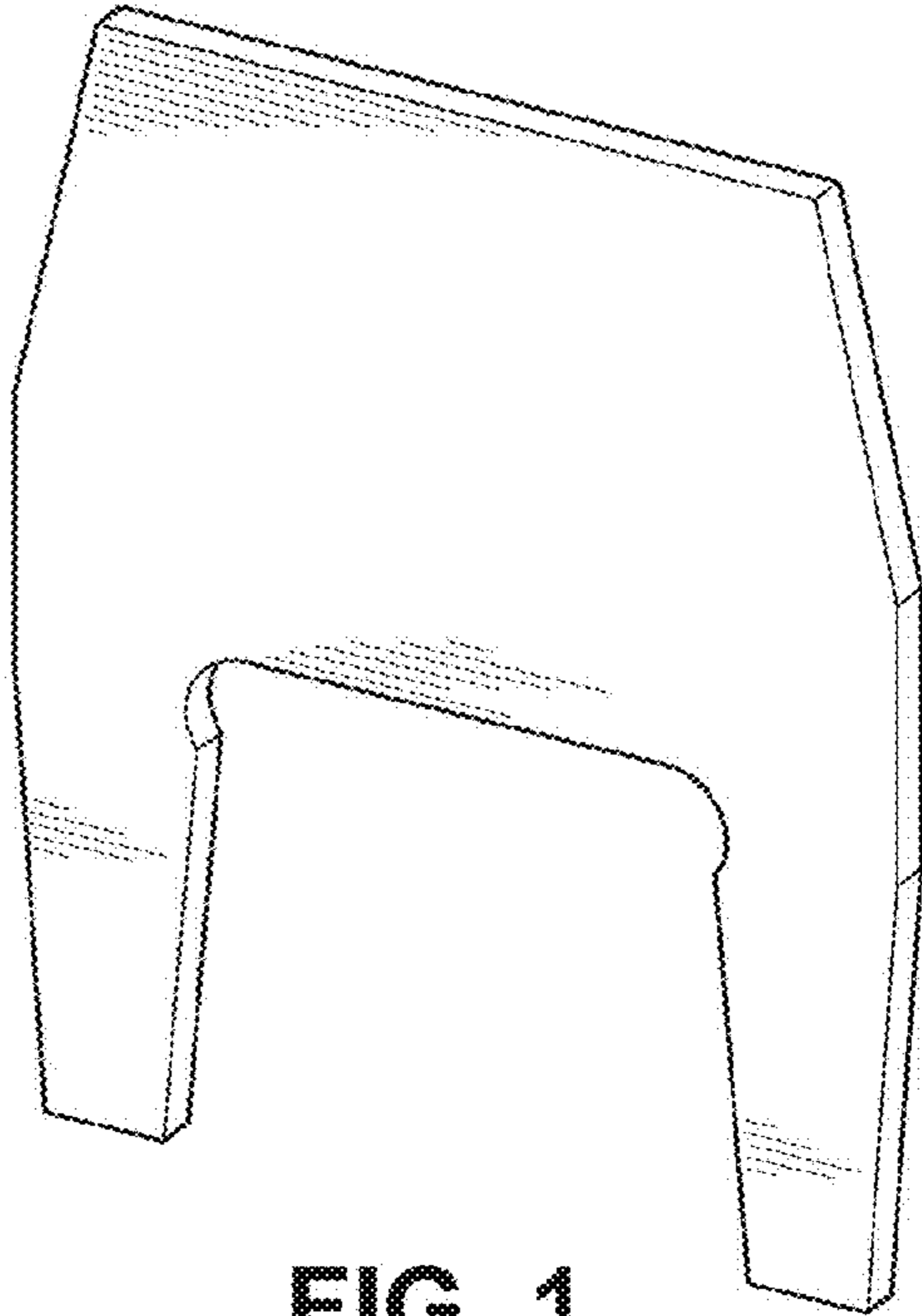

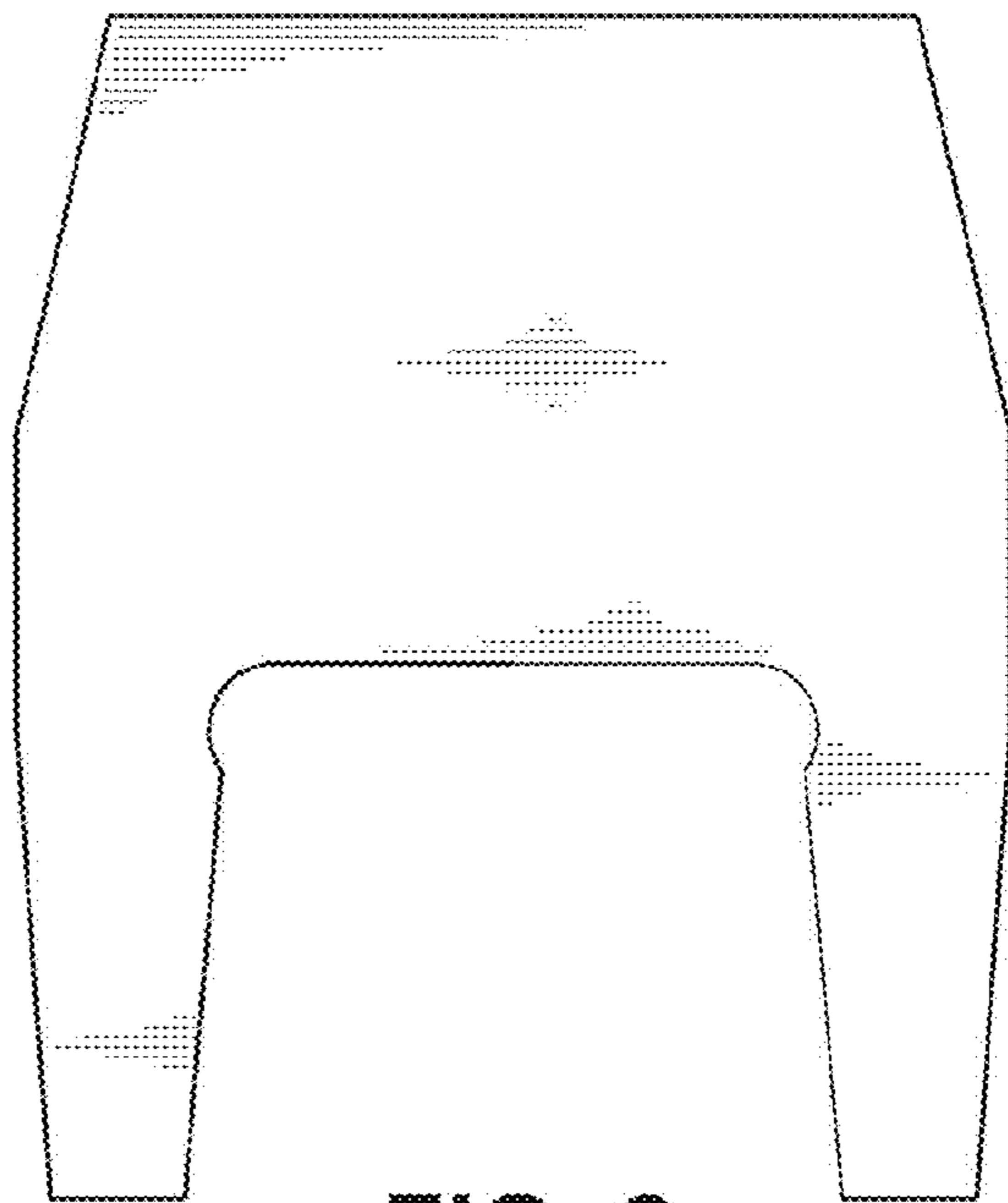

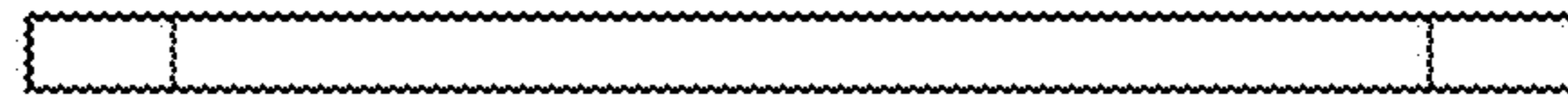
