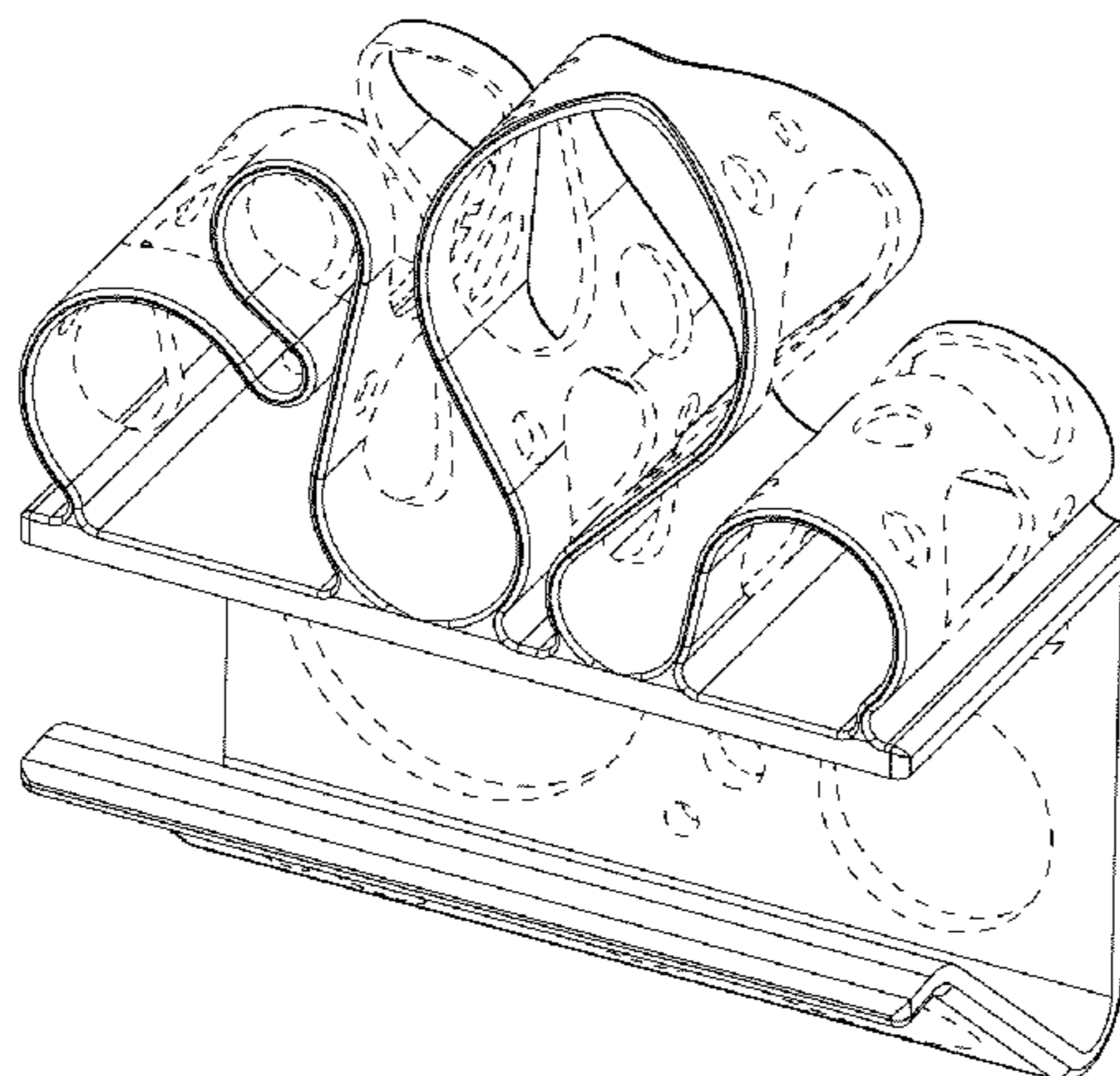
(57) **CLAIM**

The ornamental design for a cable tidy, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right-side perspective view of the cable tidy showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left-side view thereof;  
FIG. 5 is a right-side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof;  
FIG. 8 is a rear, bottom, right-side perspective view thereof; and,  
FIG. 9 is a front, bottom, left-side perspective view thereof.

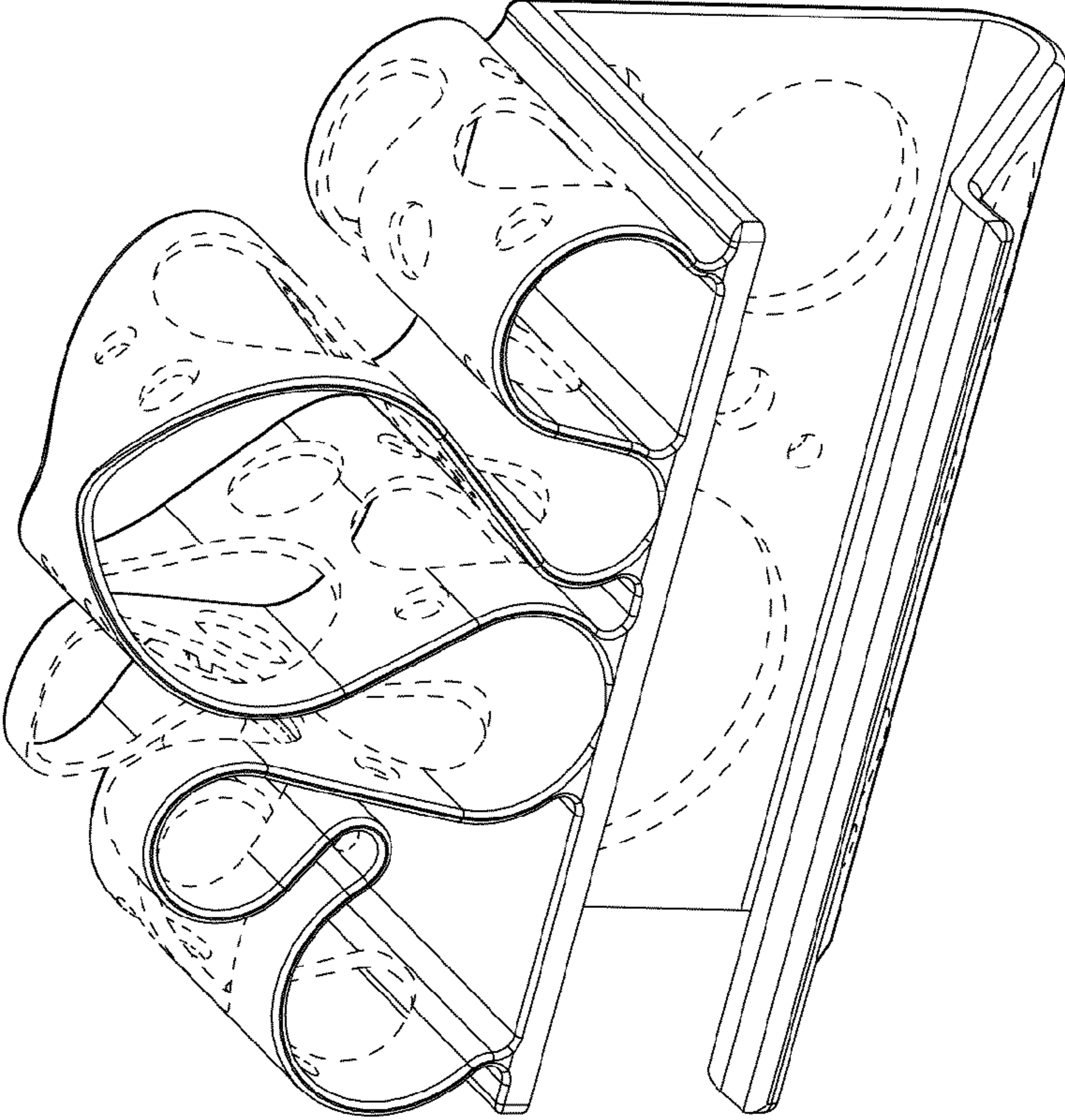

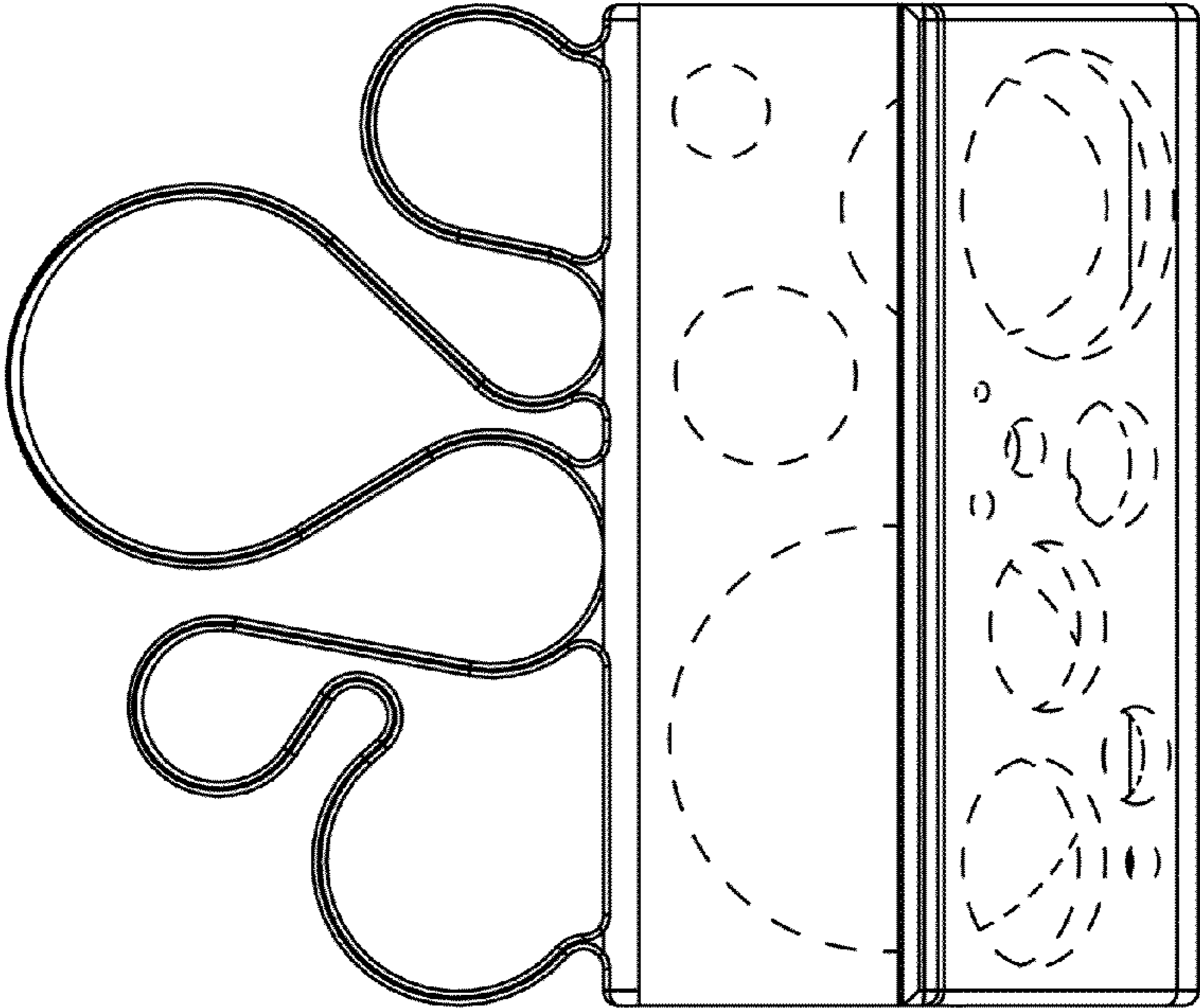

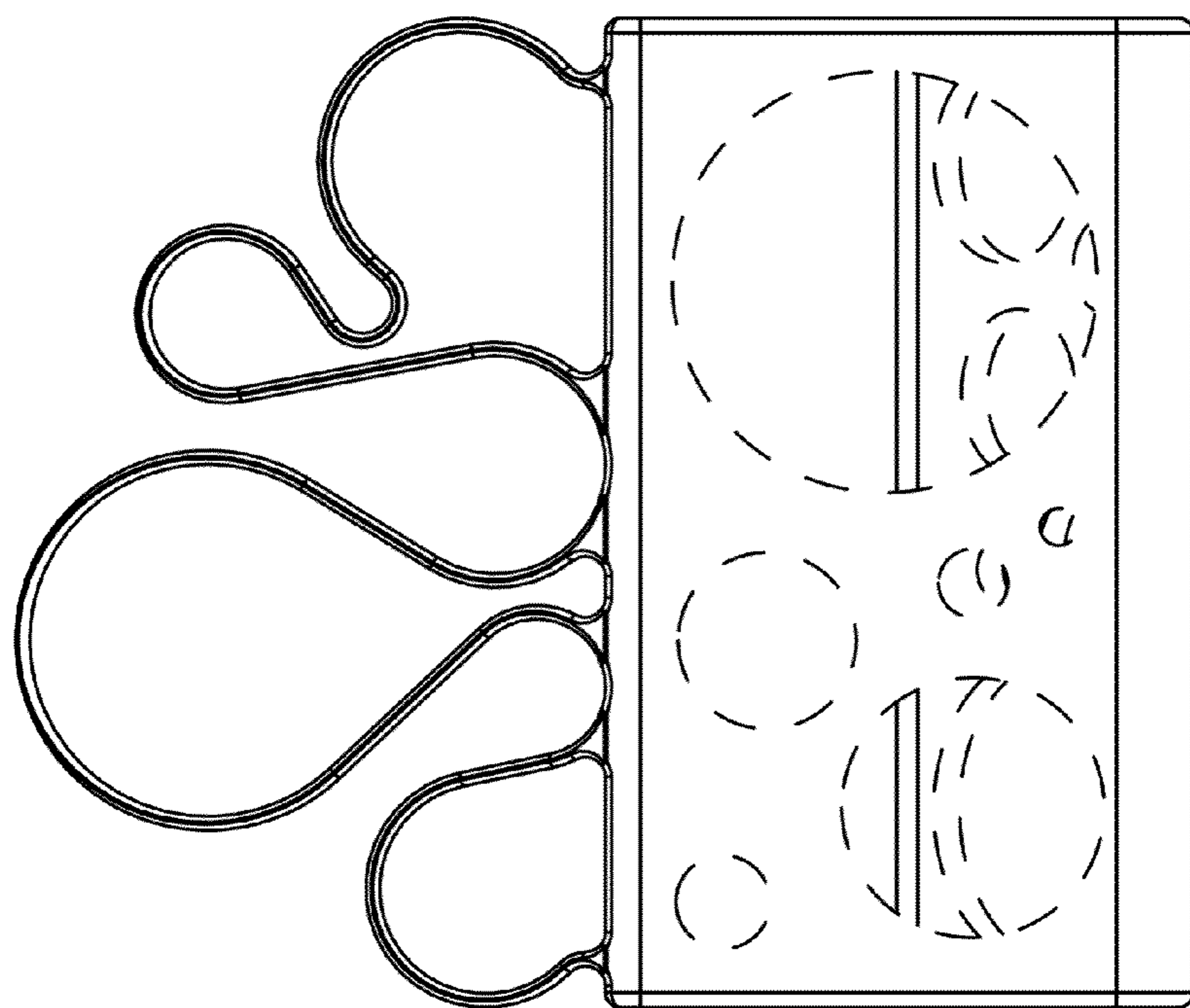

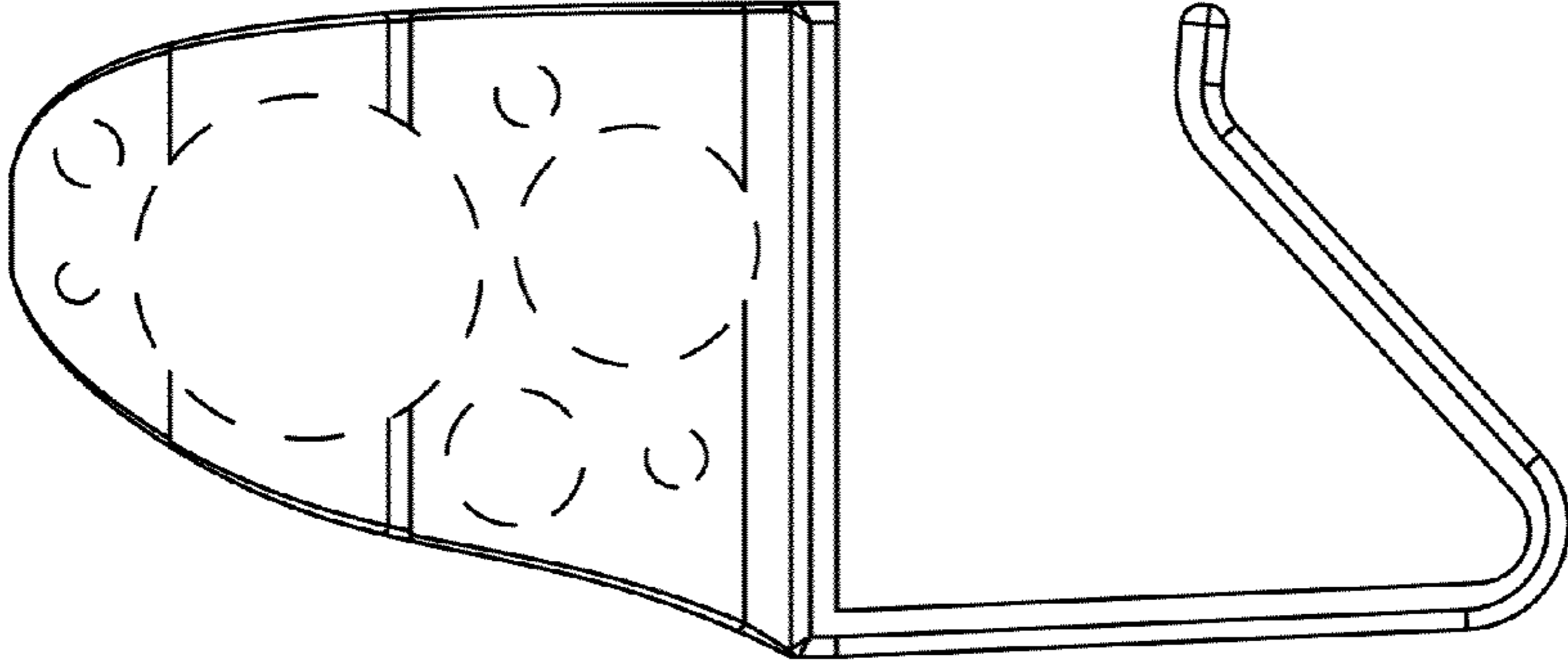

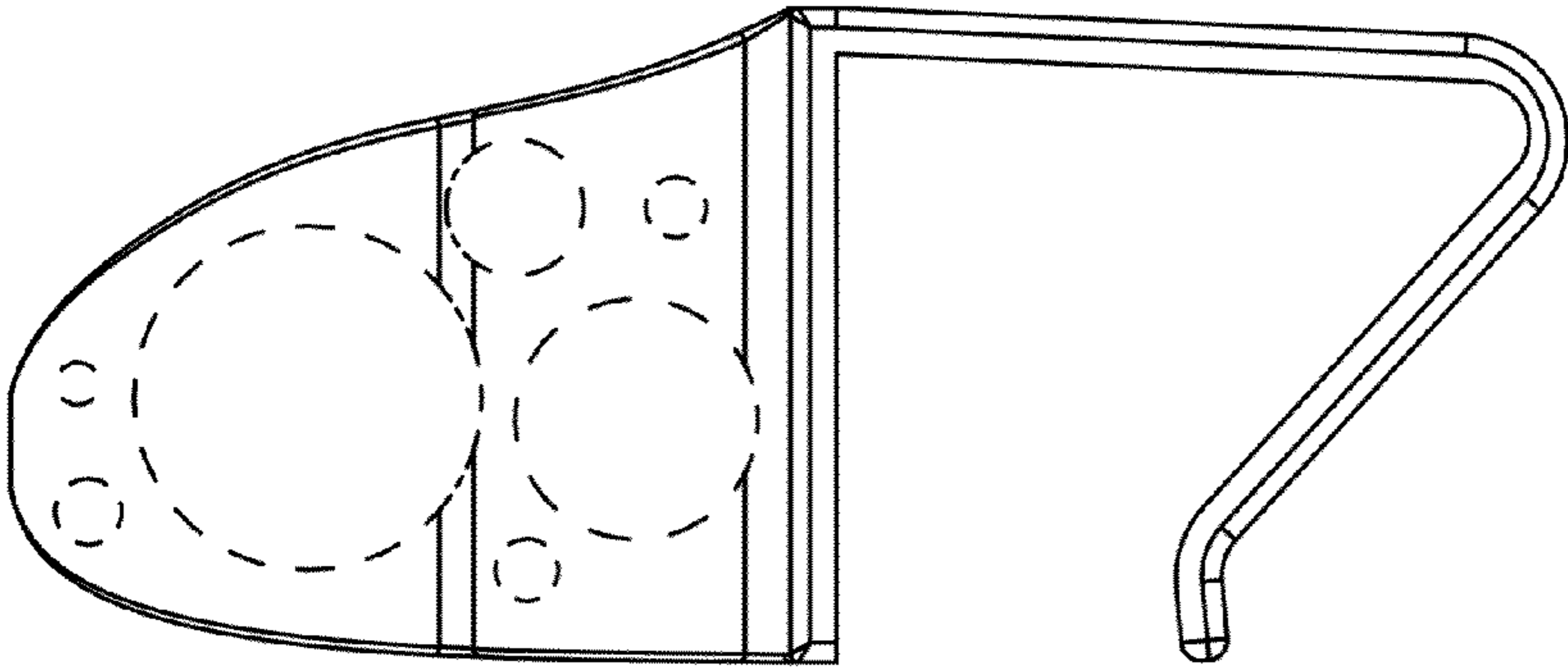

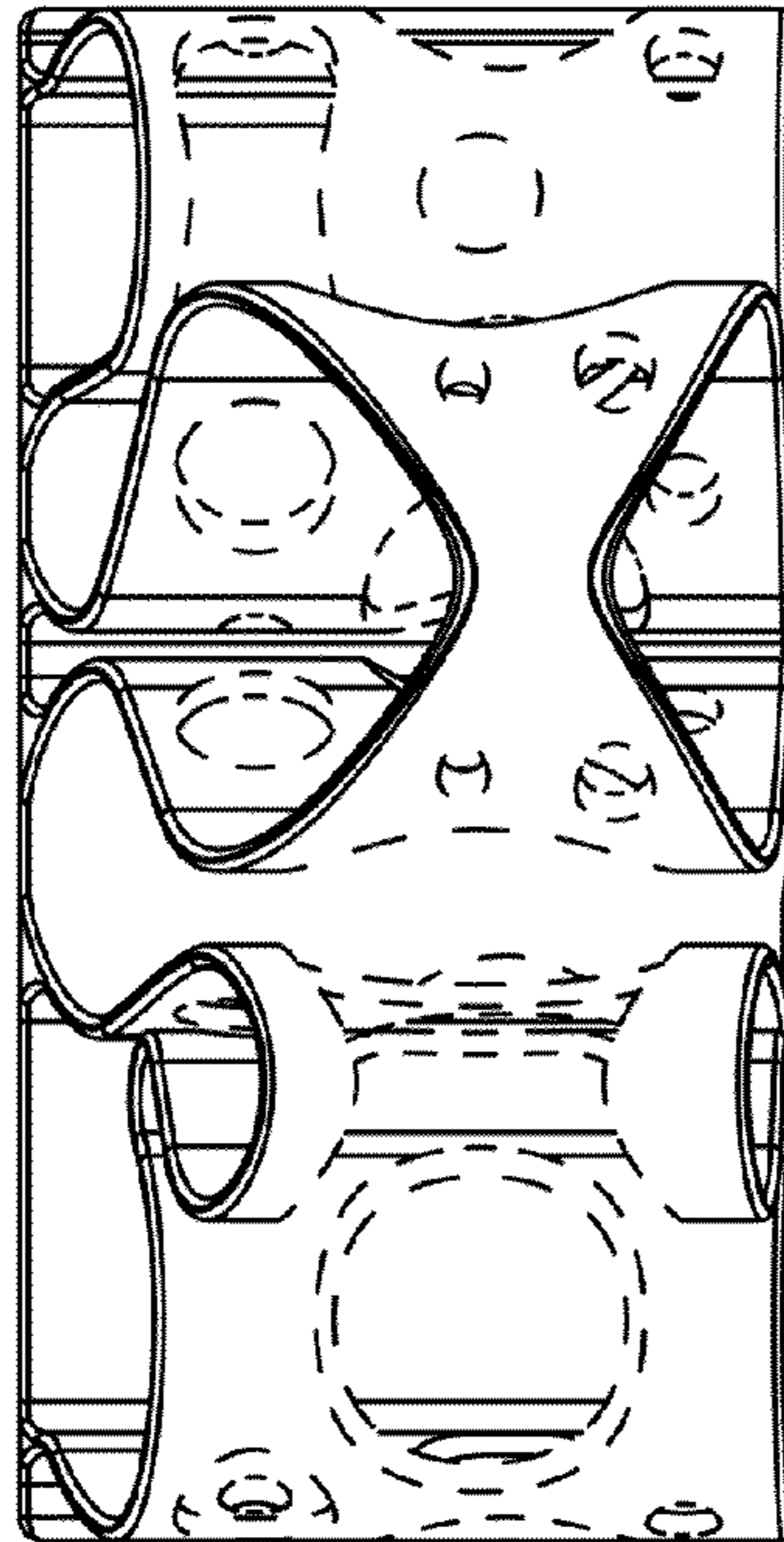

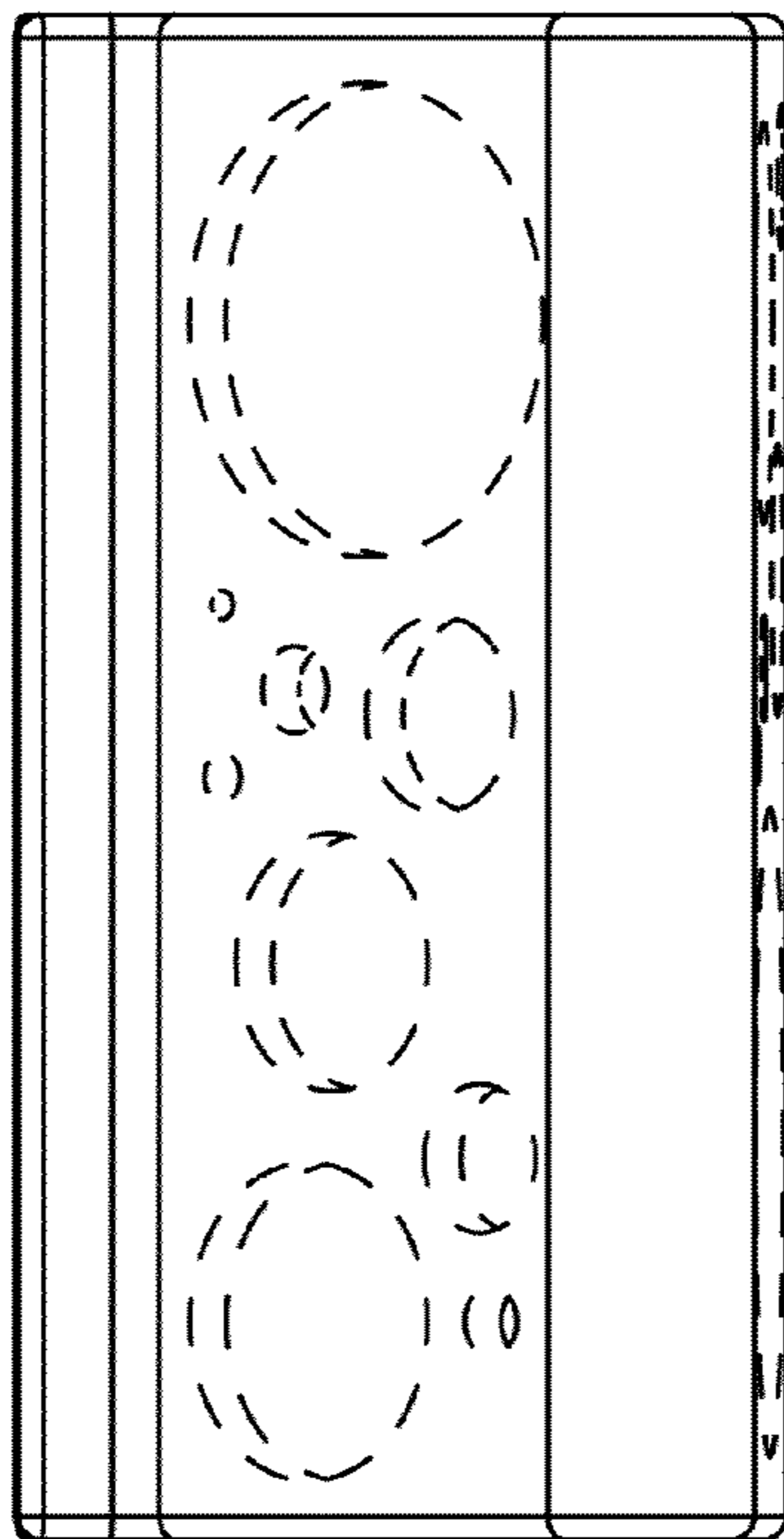

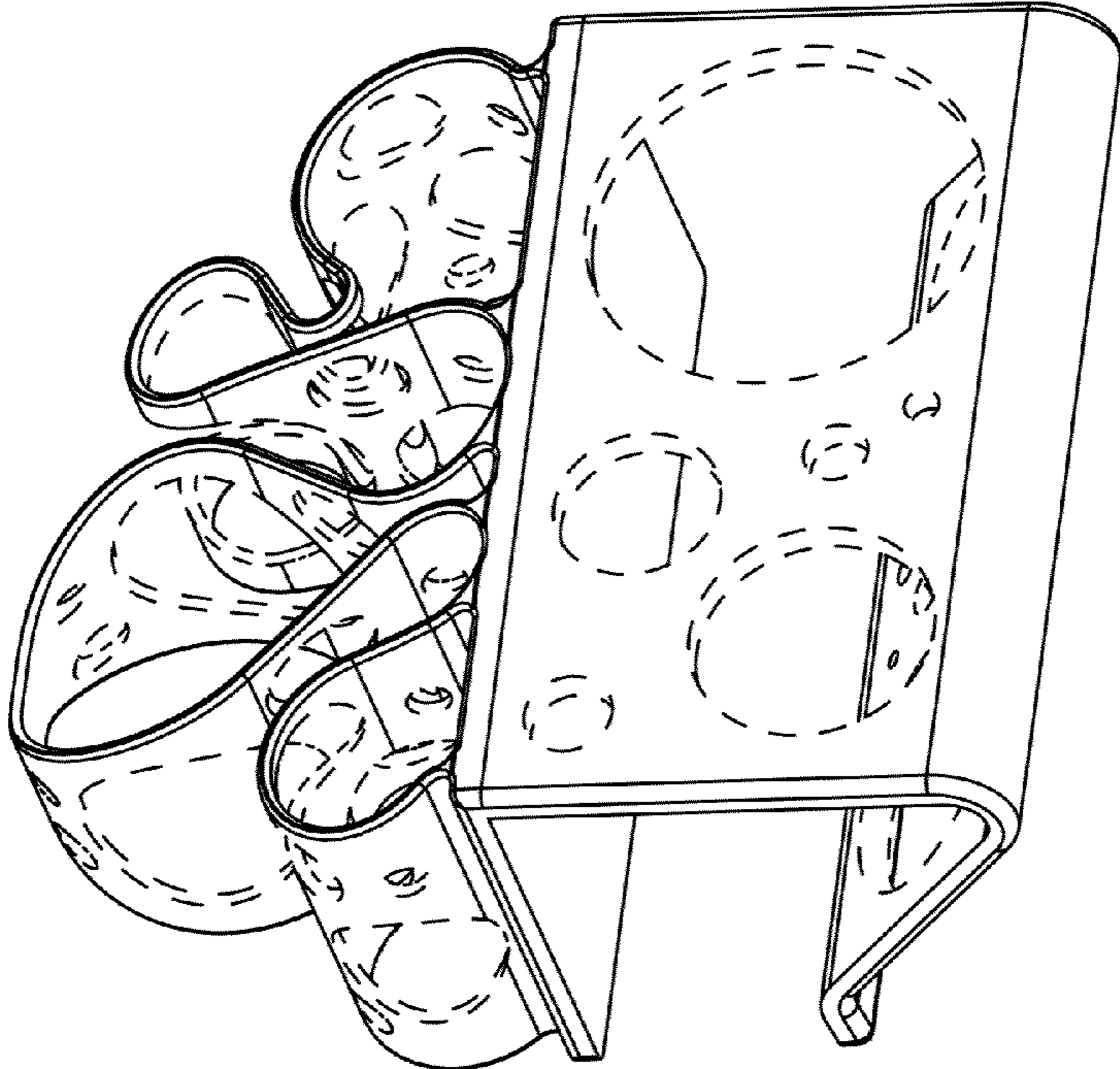

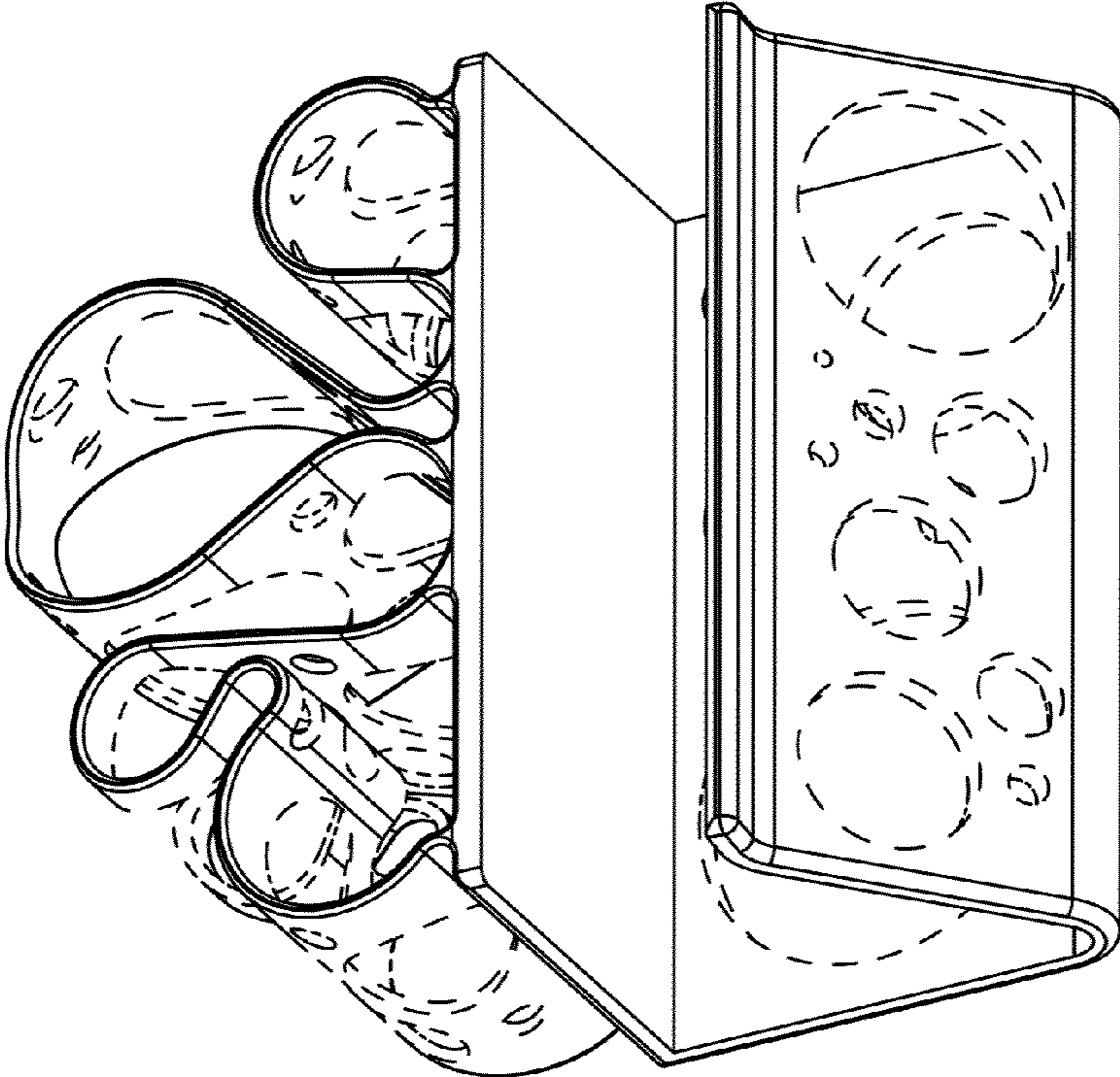
