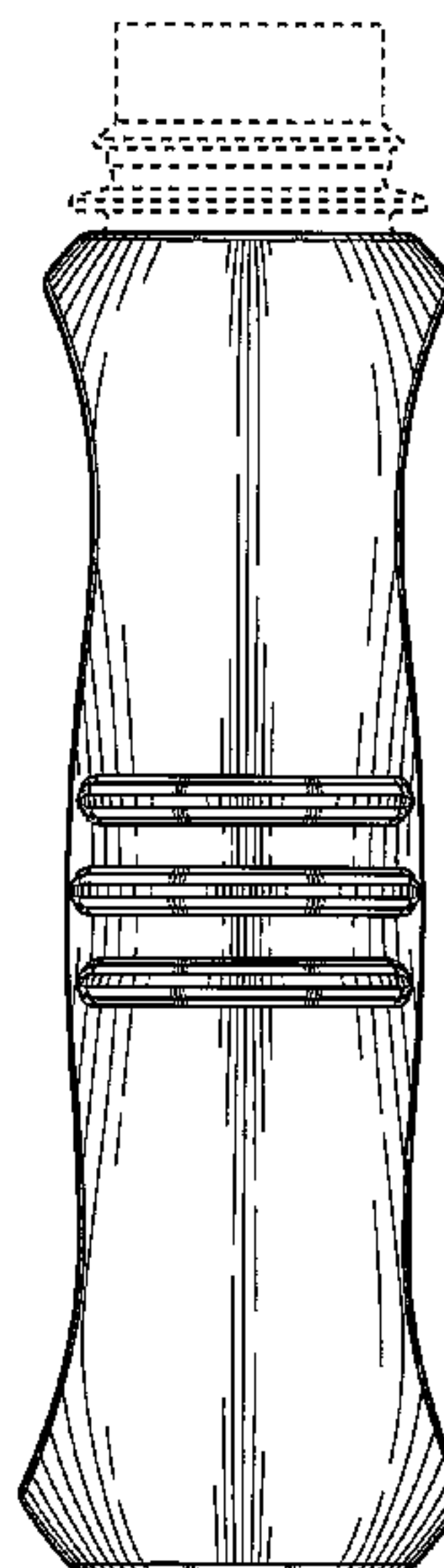
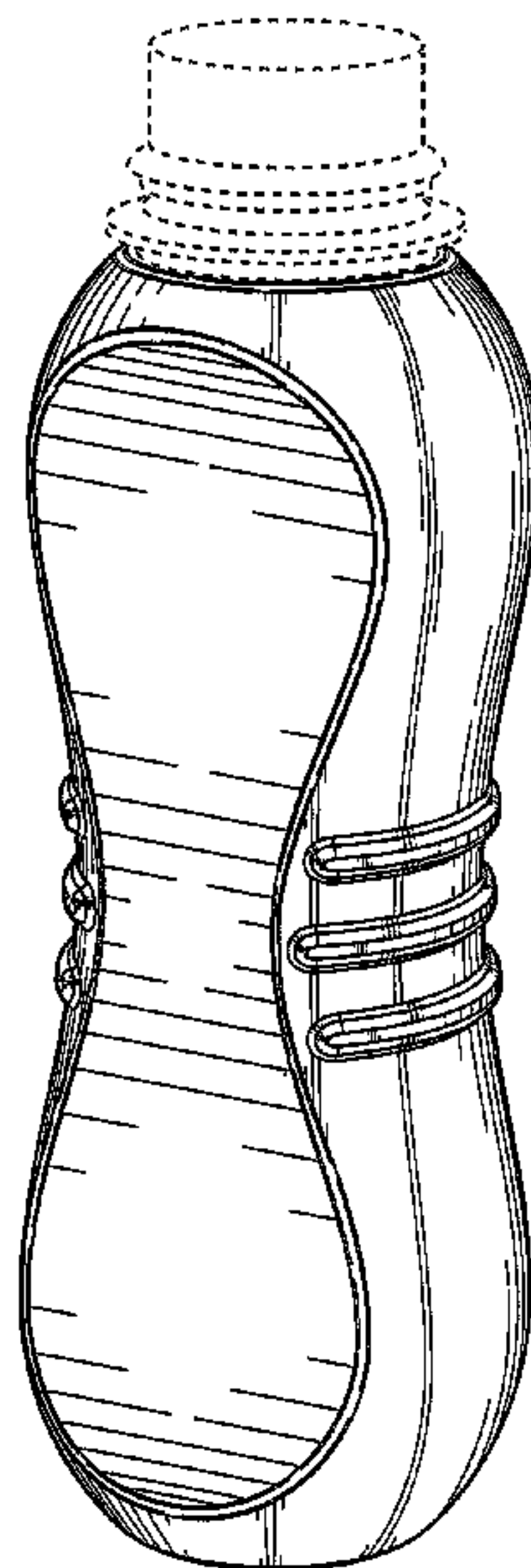
(57) **CLAIM**

I claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my new design;
FIG. 2 is a front elevation view thereof, the rear elevation being a mirror image thereof;
FIG. 3 is a left side elevation view thereof, the right side elevation being a mirror image thereof;
FIG. 4 is a top elevation view thereof; and,
FIG. 5 is a bottom elevation view thereof.
The broken lines, including in FIG. 5, are shown to indicate environmental structure and portions of the bottle and form no part of the claimed design.

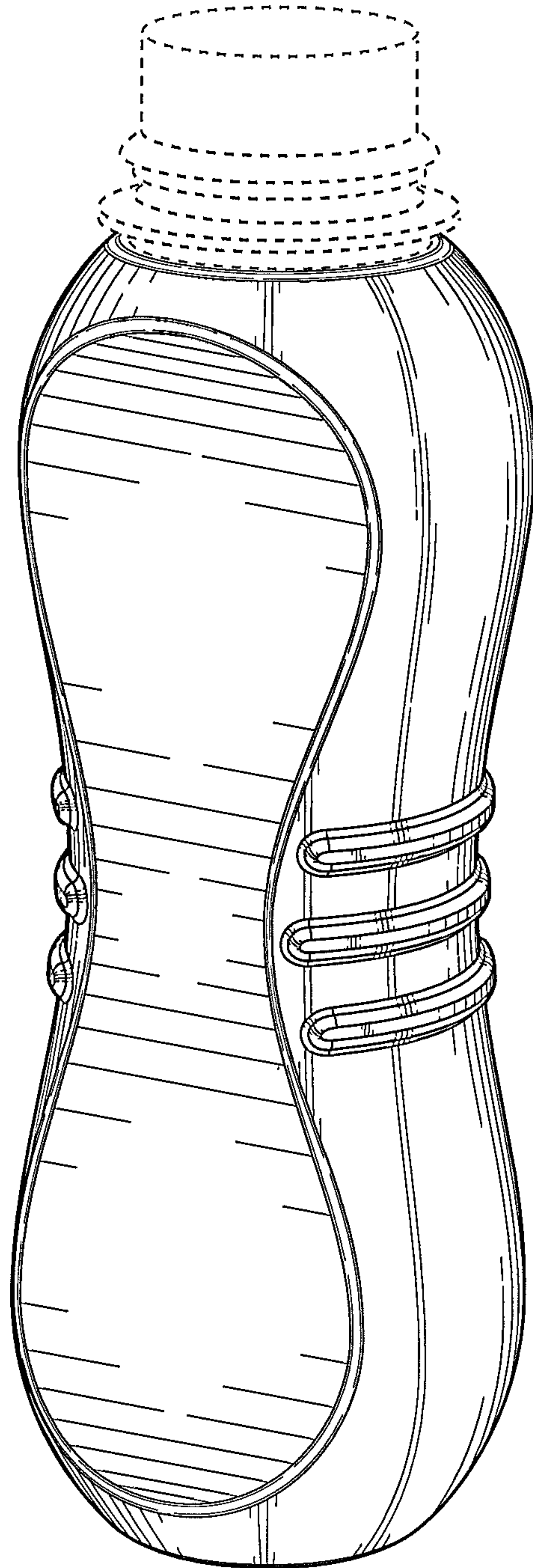

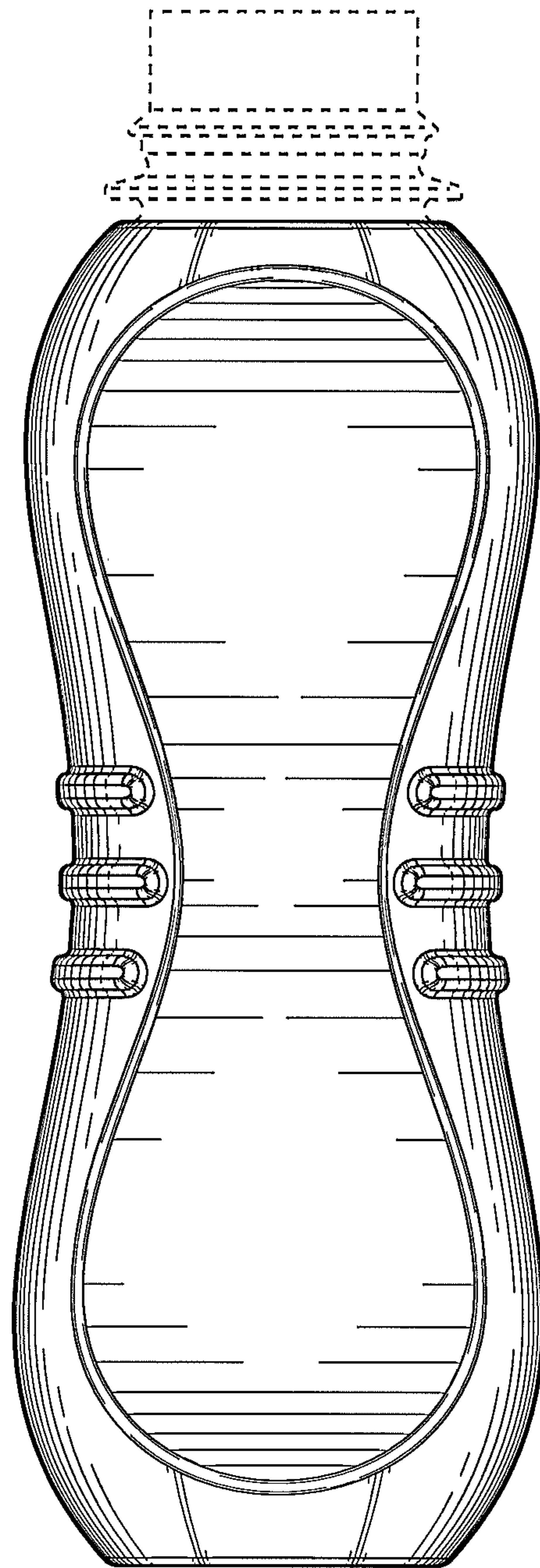

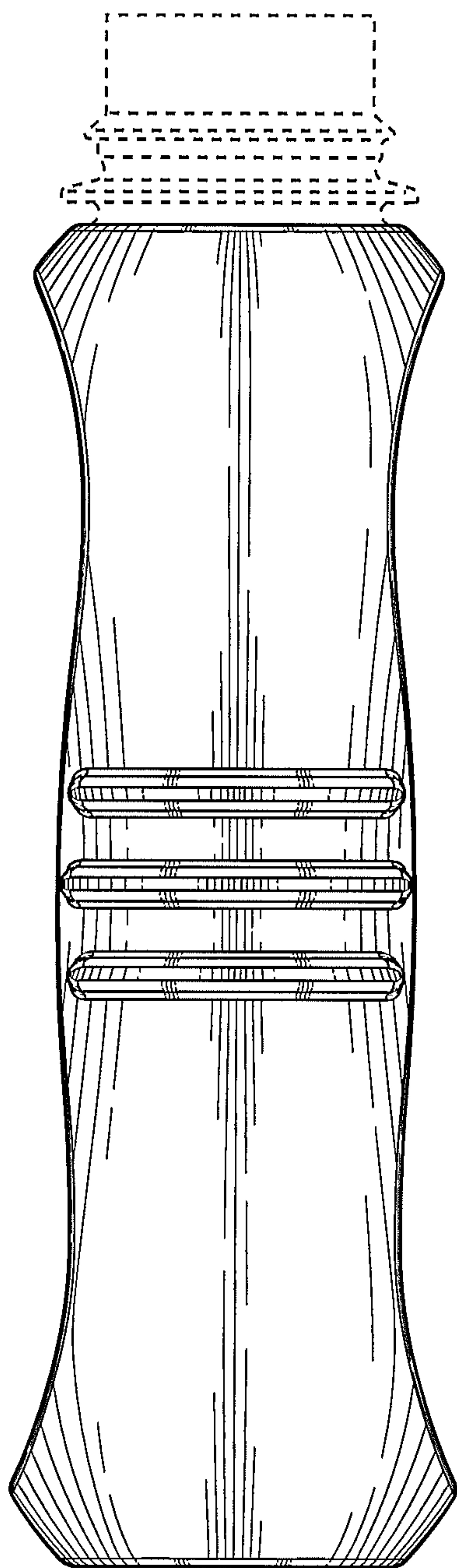

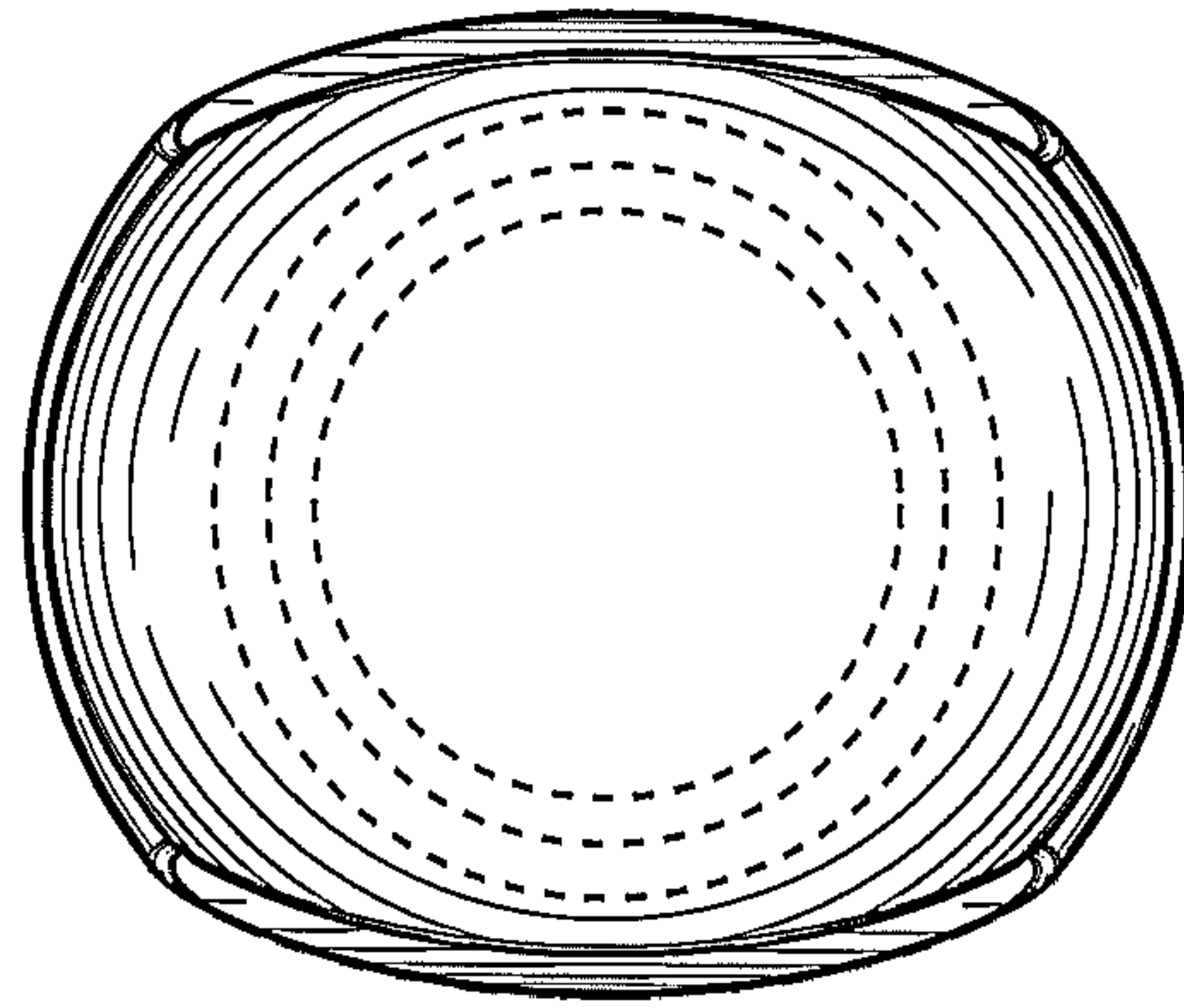

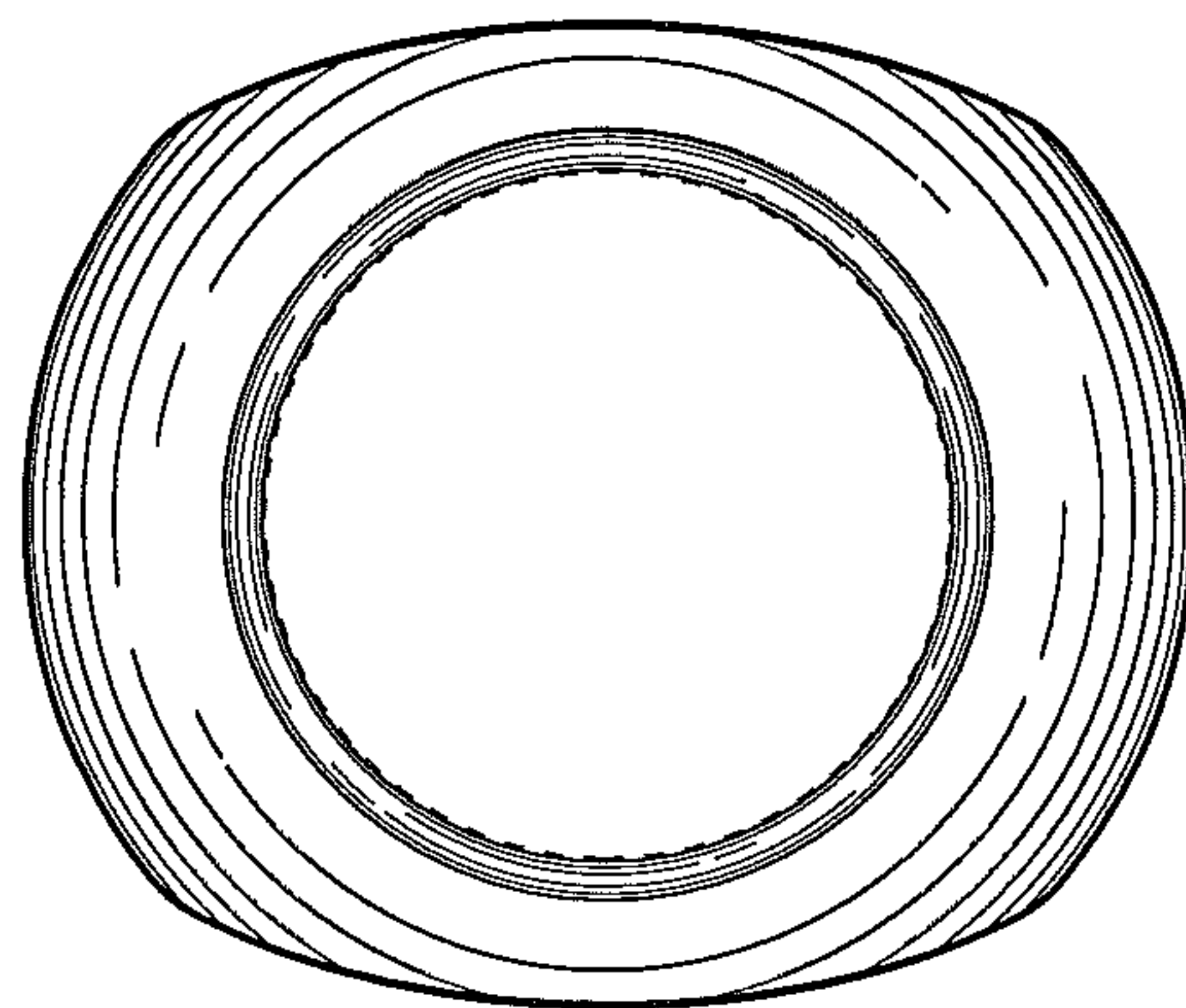
