(57) **CLAIM**

I claim the ornamental design for a planter, as shown and described.

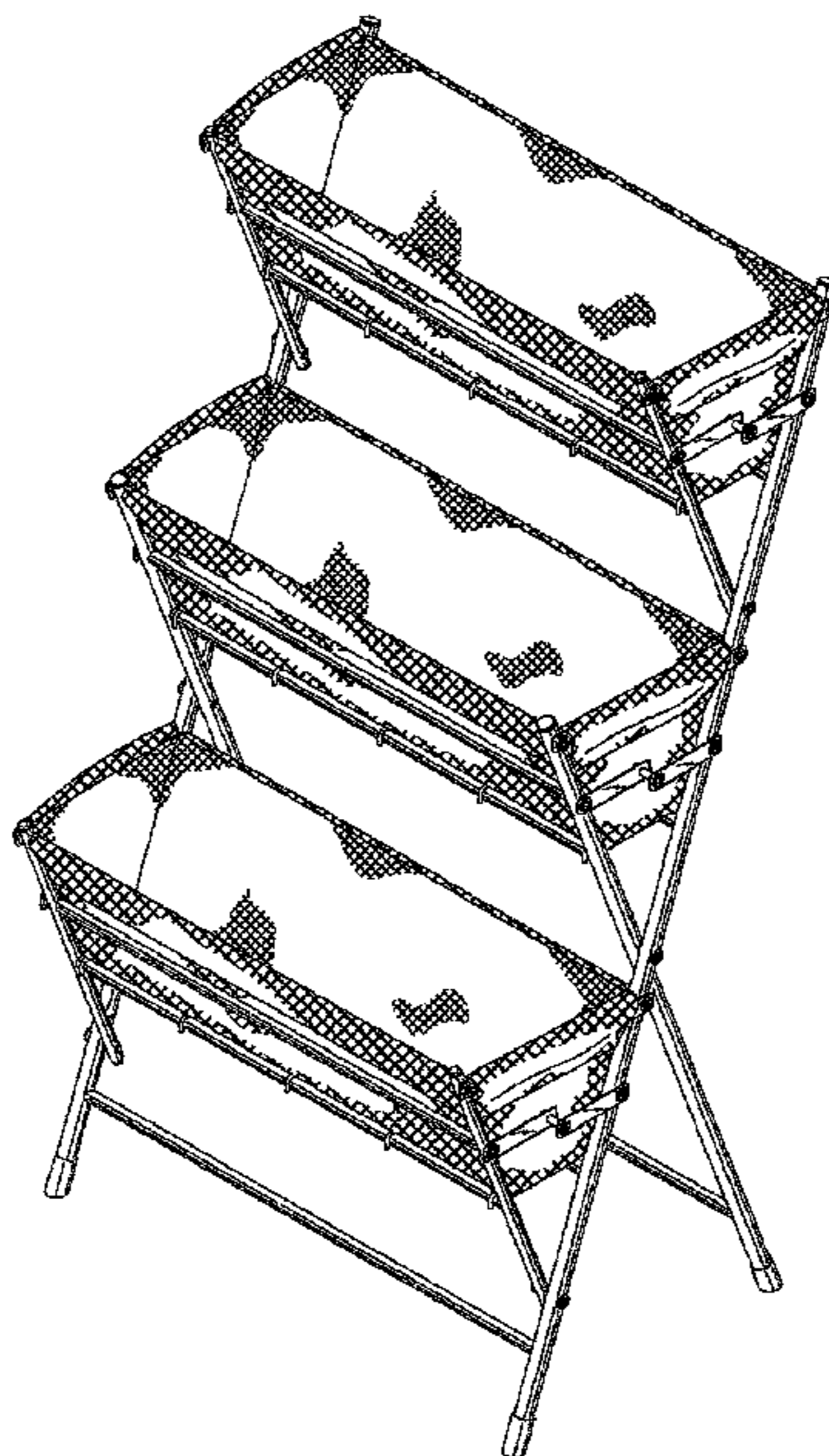
DESCRIPTION

FIG. 1 is a front elevation view of the planter showing my new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a right side elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a top perspective view thereof.

The broken lines showing portions of the planter are included to show features that form no part of the claimed design.

The texture lines of the material, although only intermittently shown, are understood to be uniformly distributed over the surfaces of the planter.

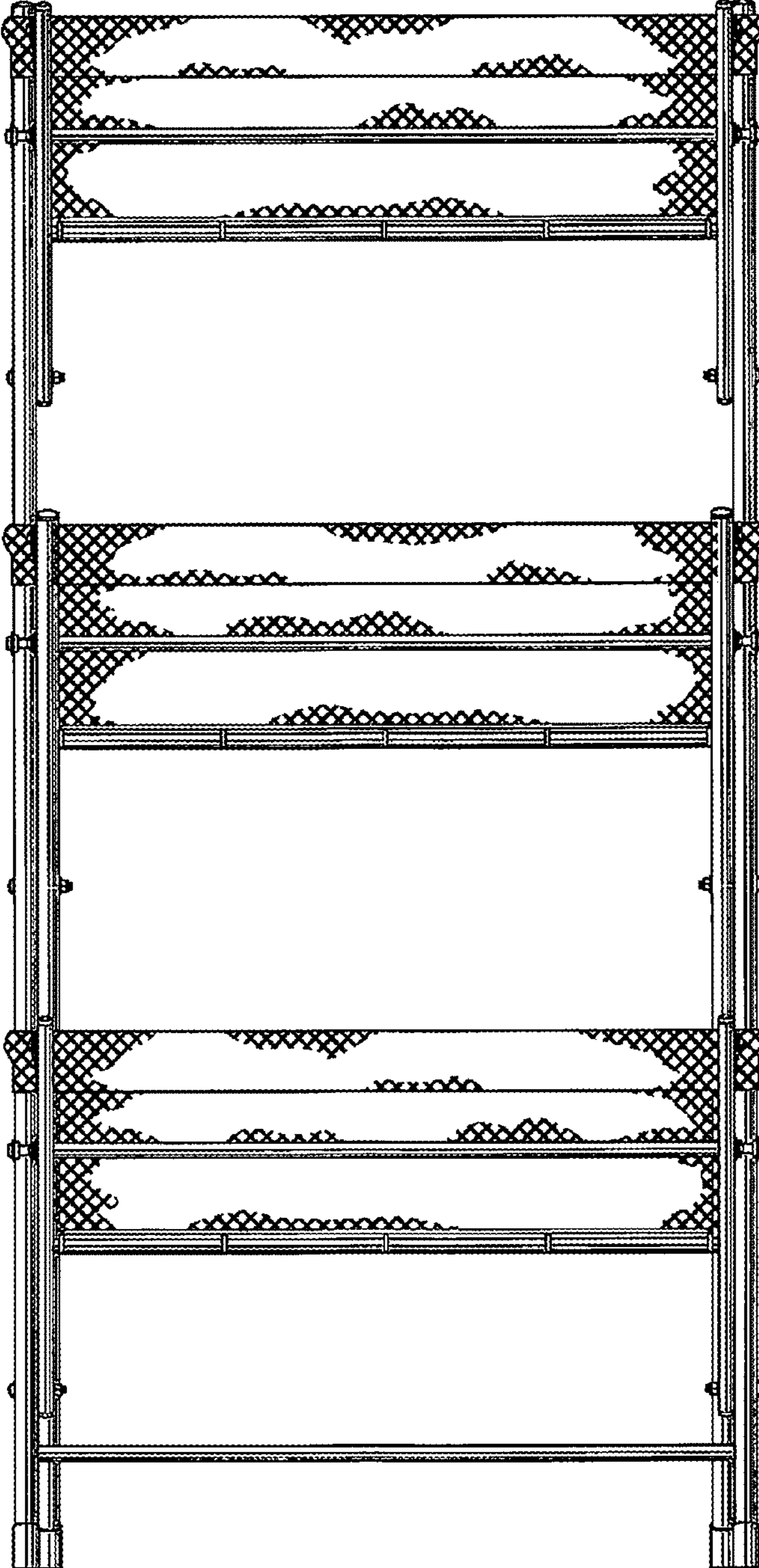

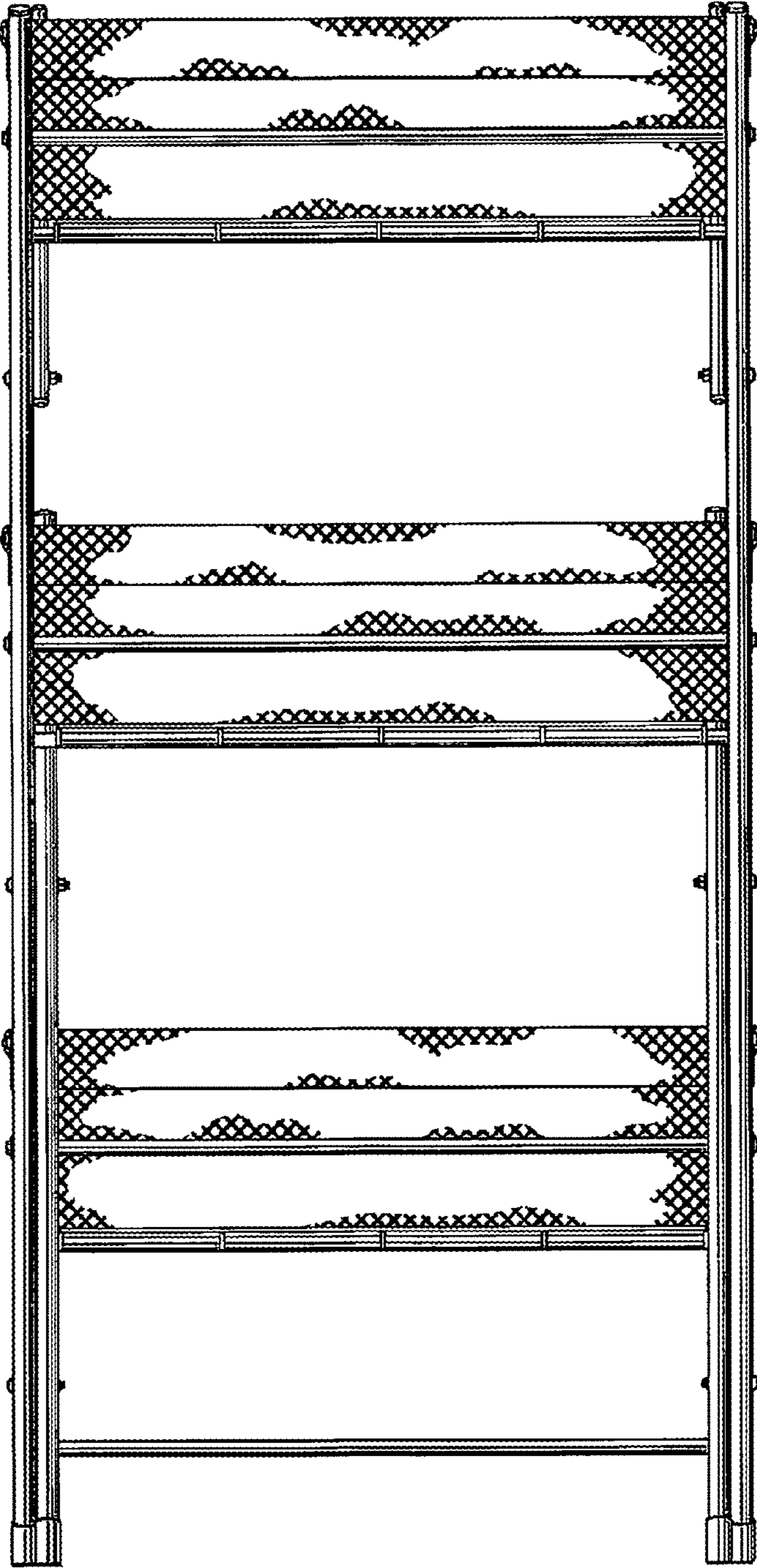
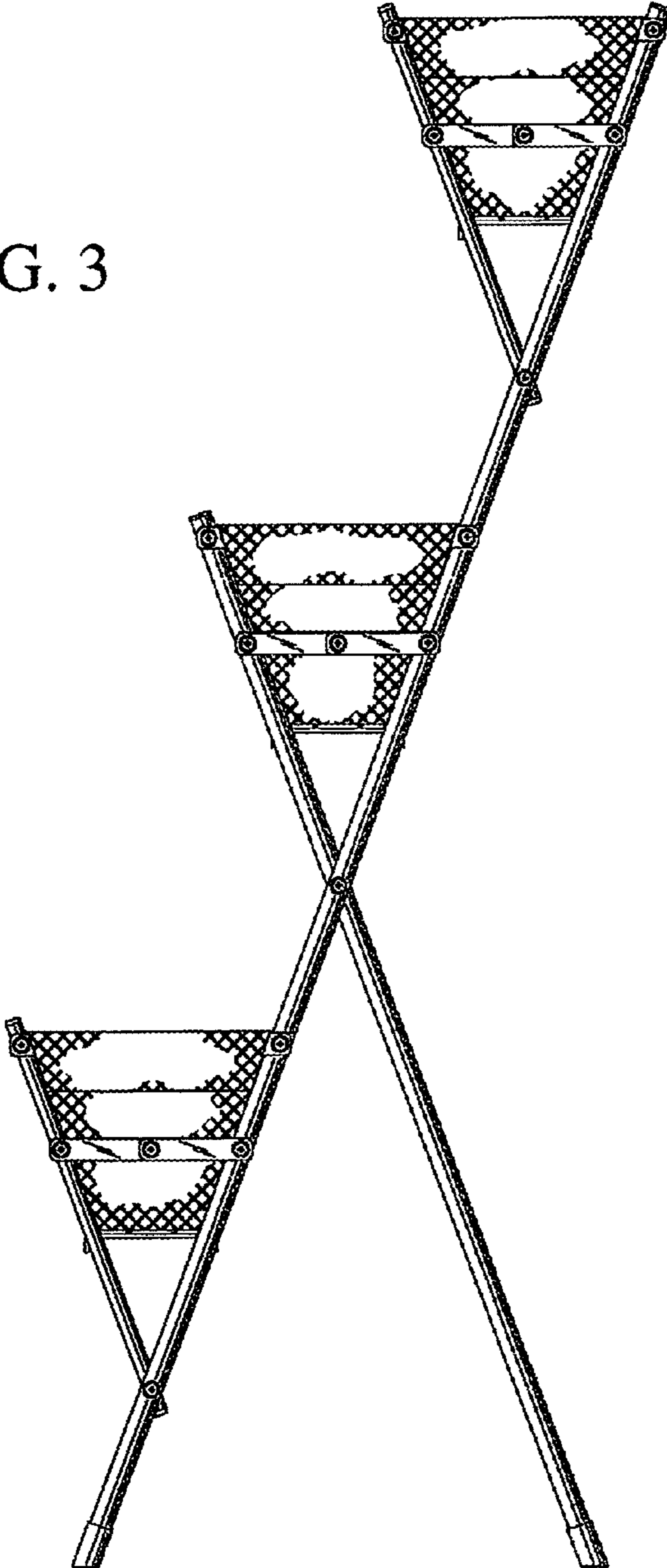

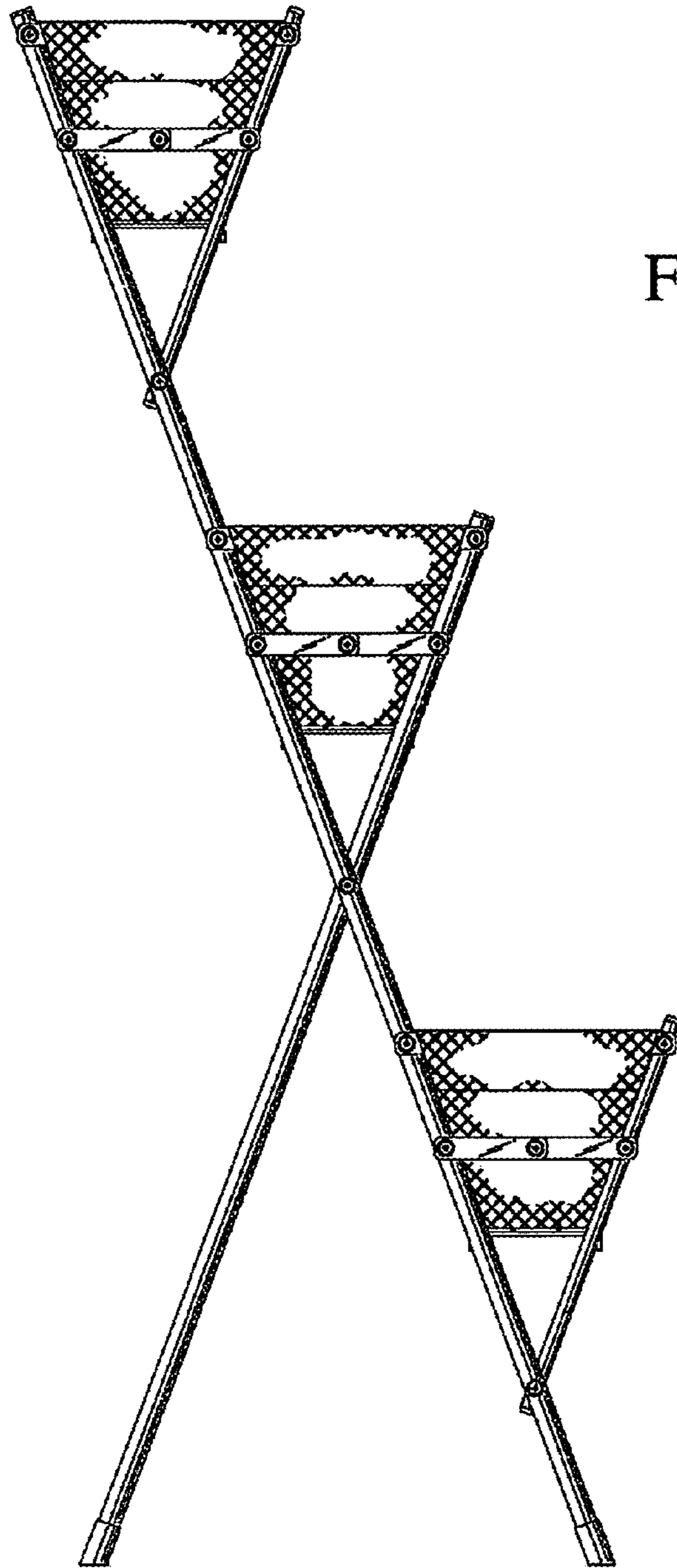

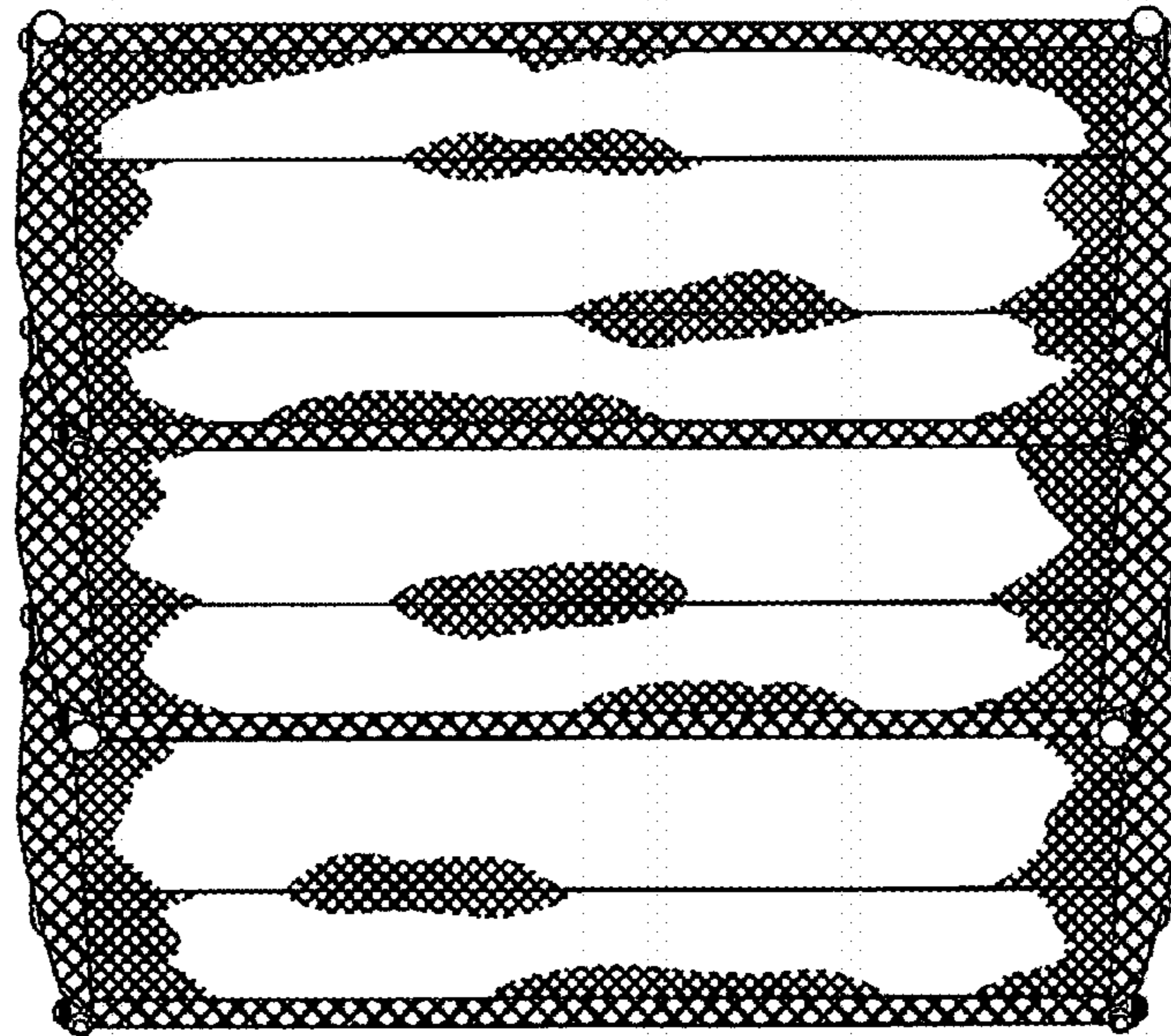

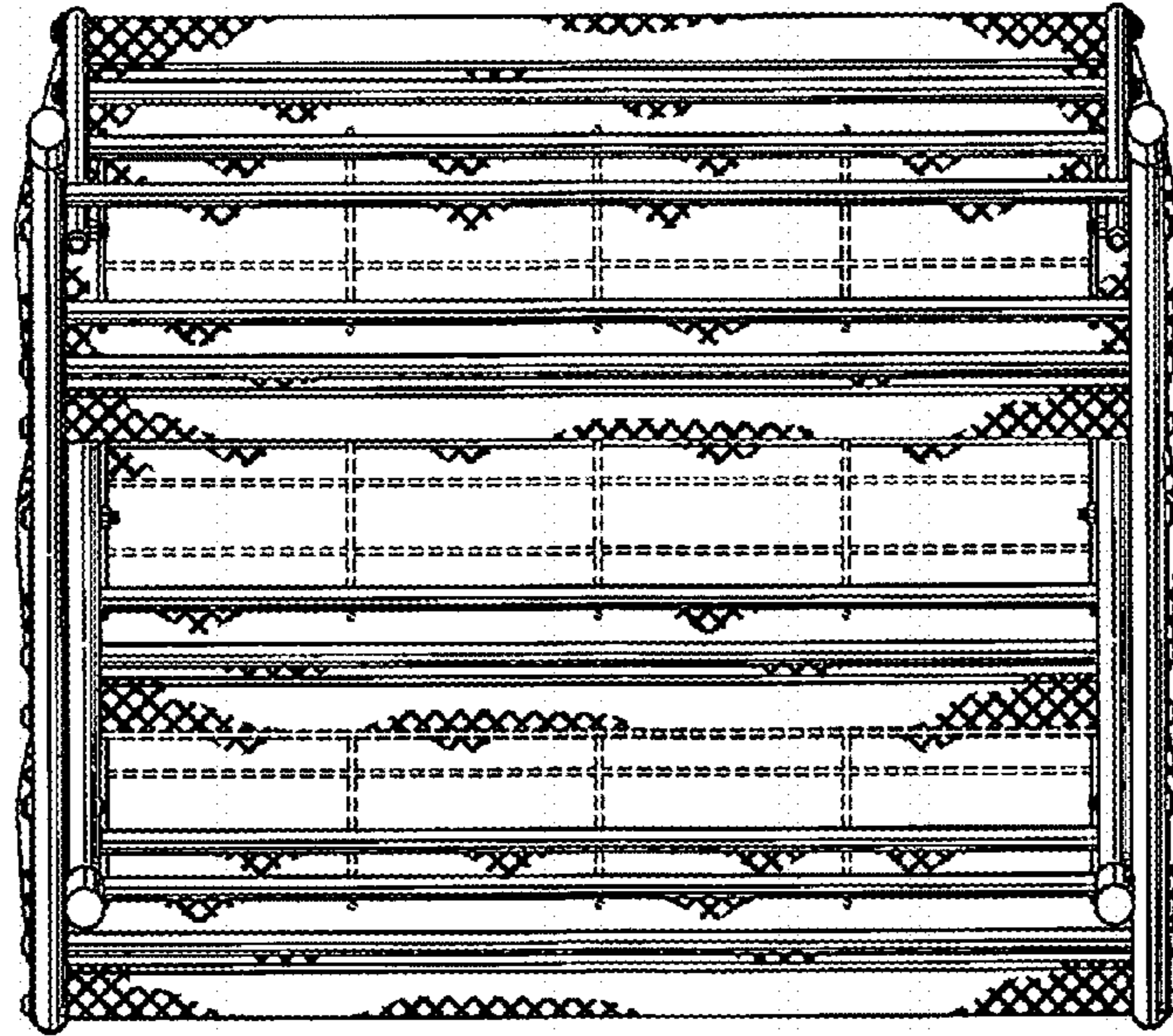

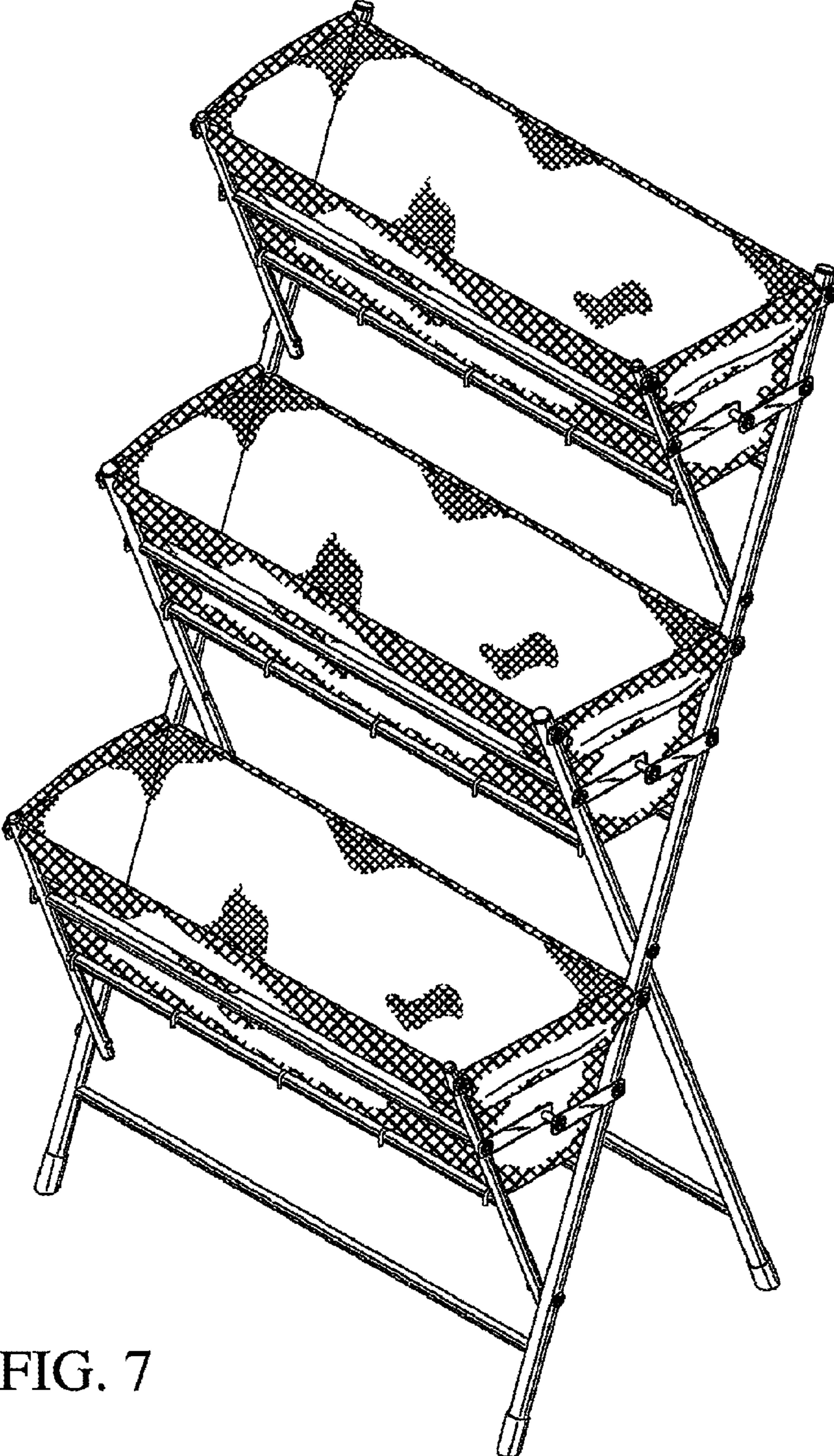
