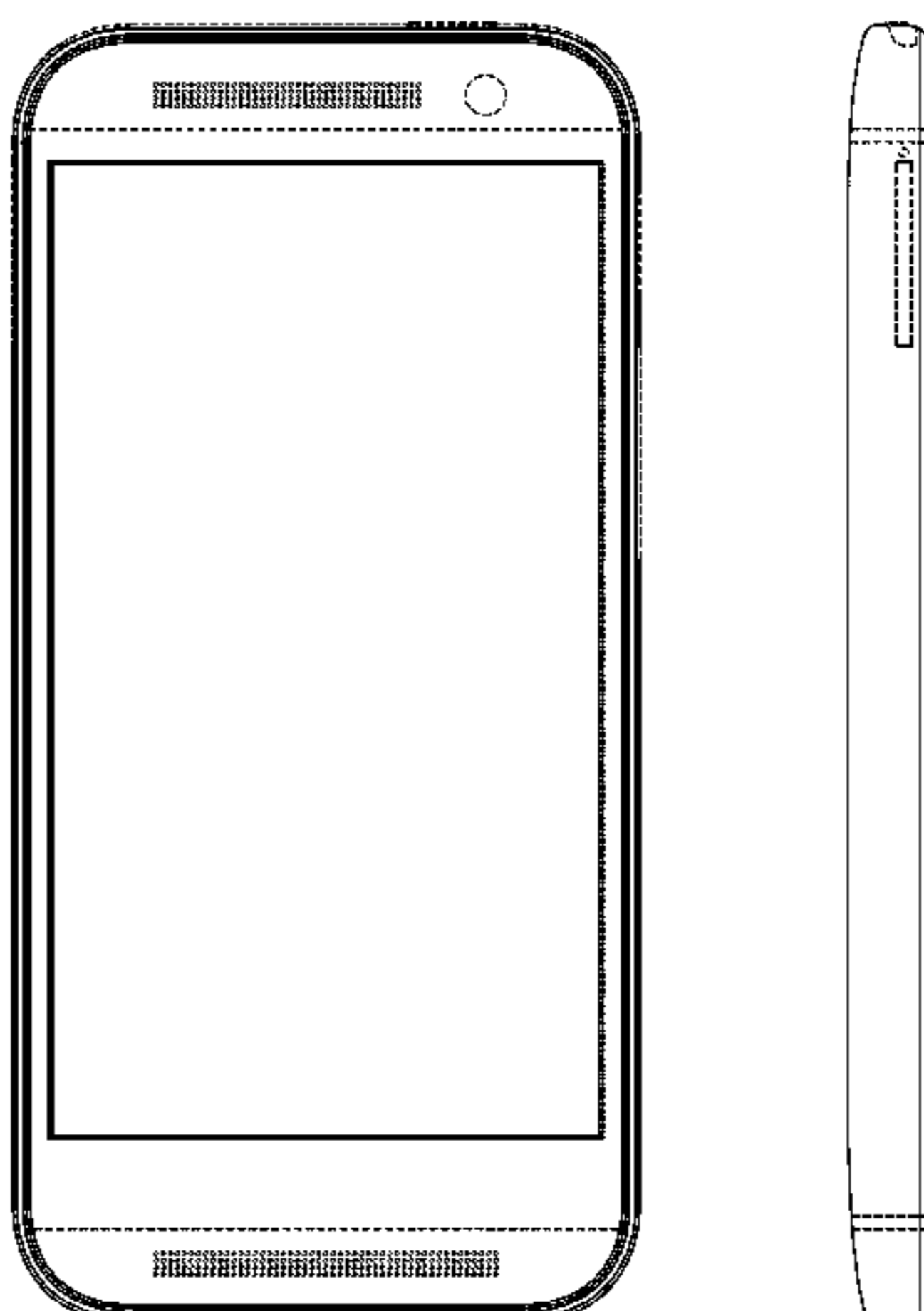

The ornamental design for a portable electronic device, as shown and described.

DESCRIPTION

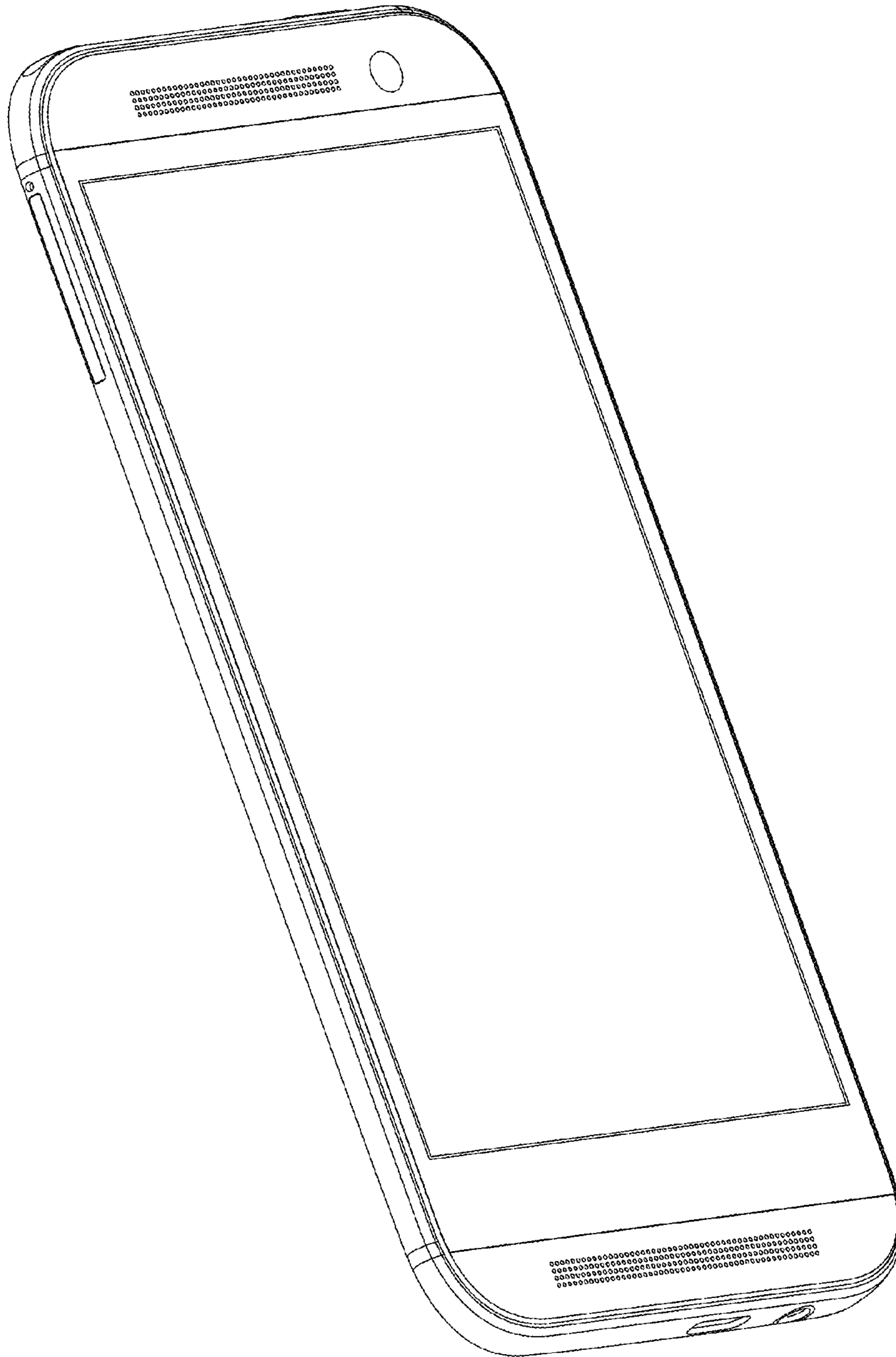

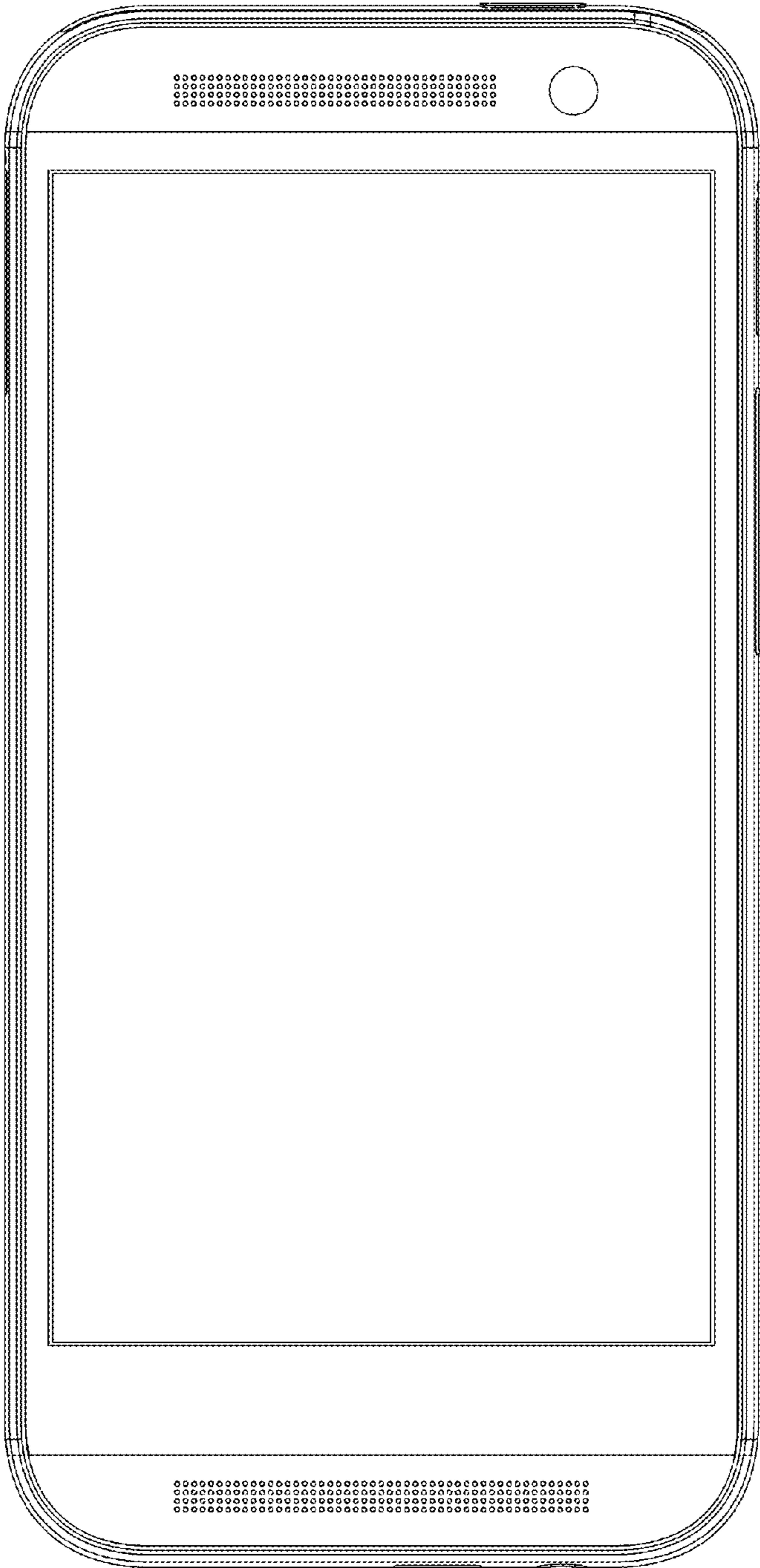

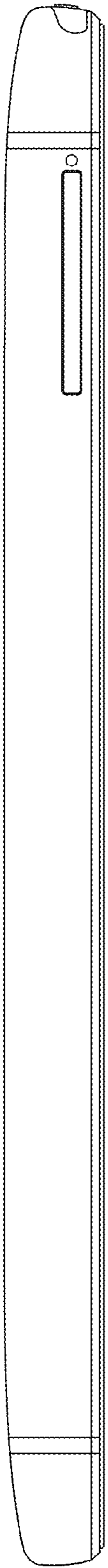

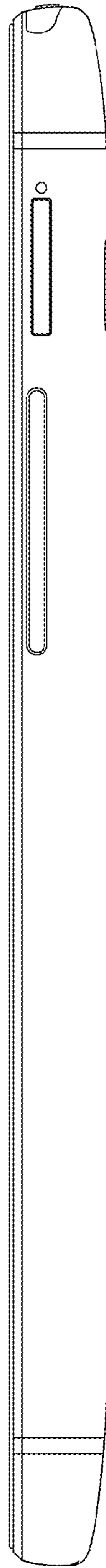

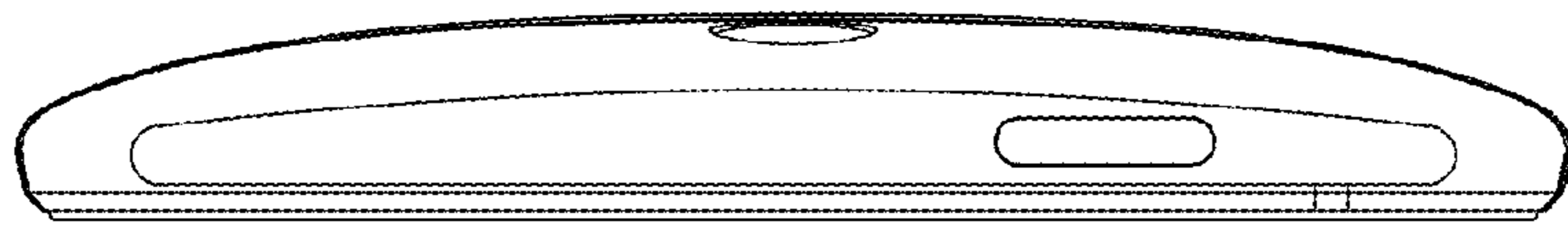

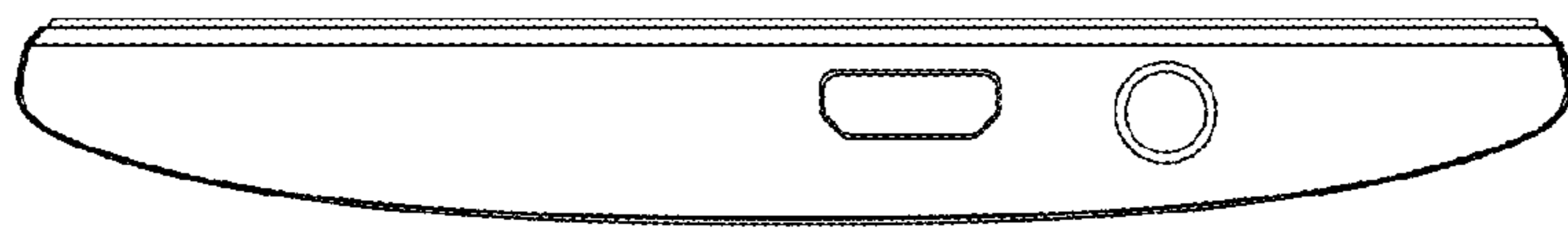

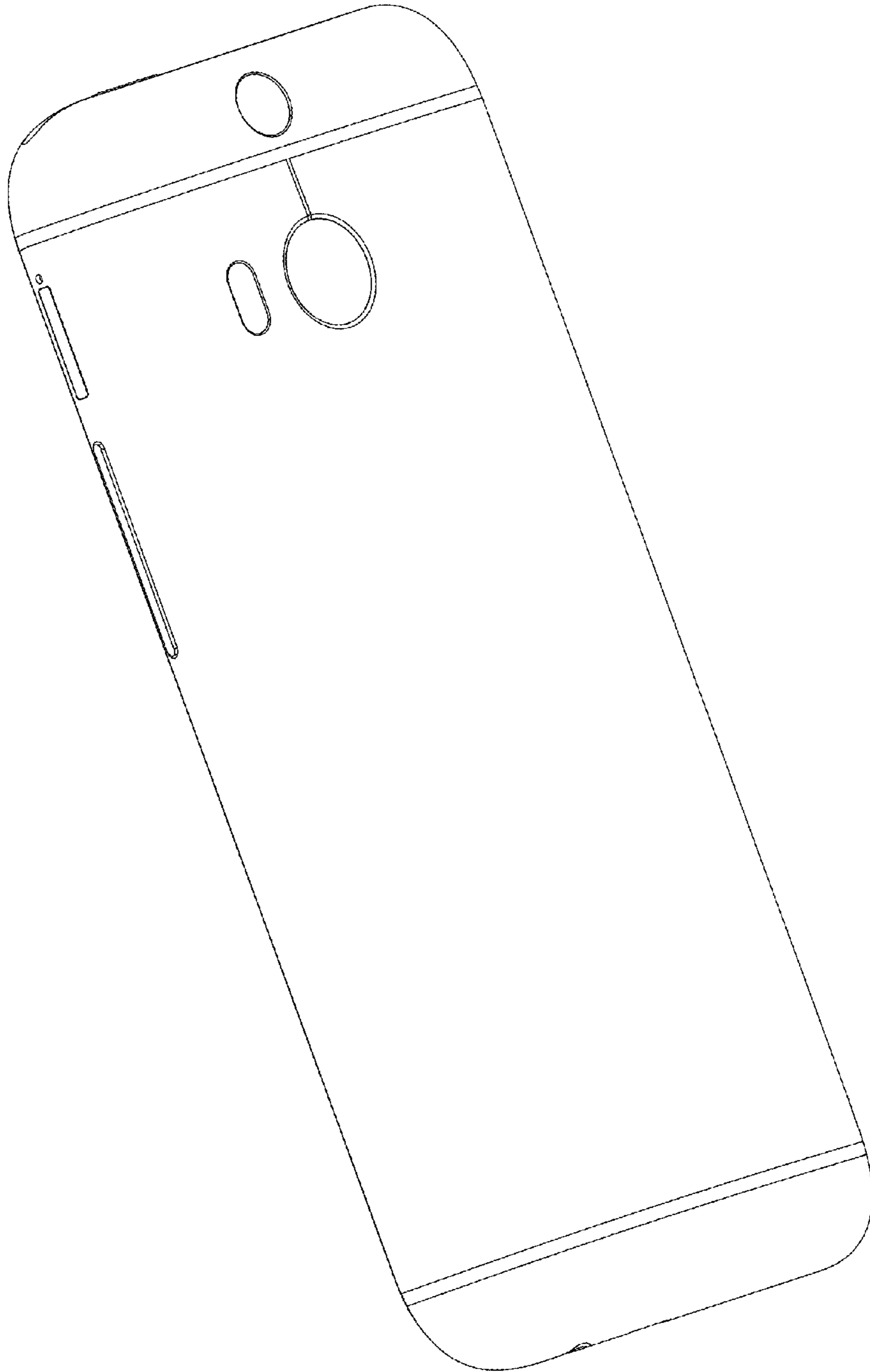

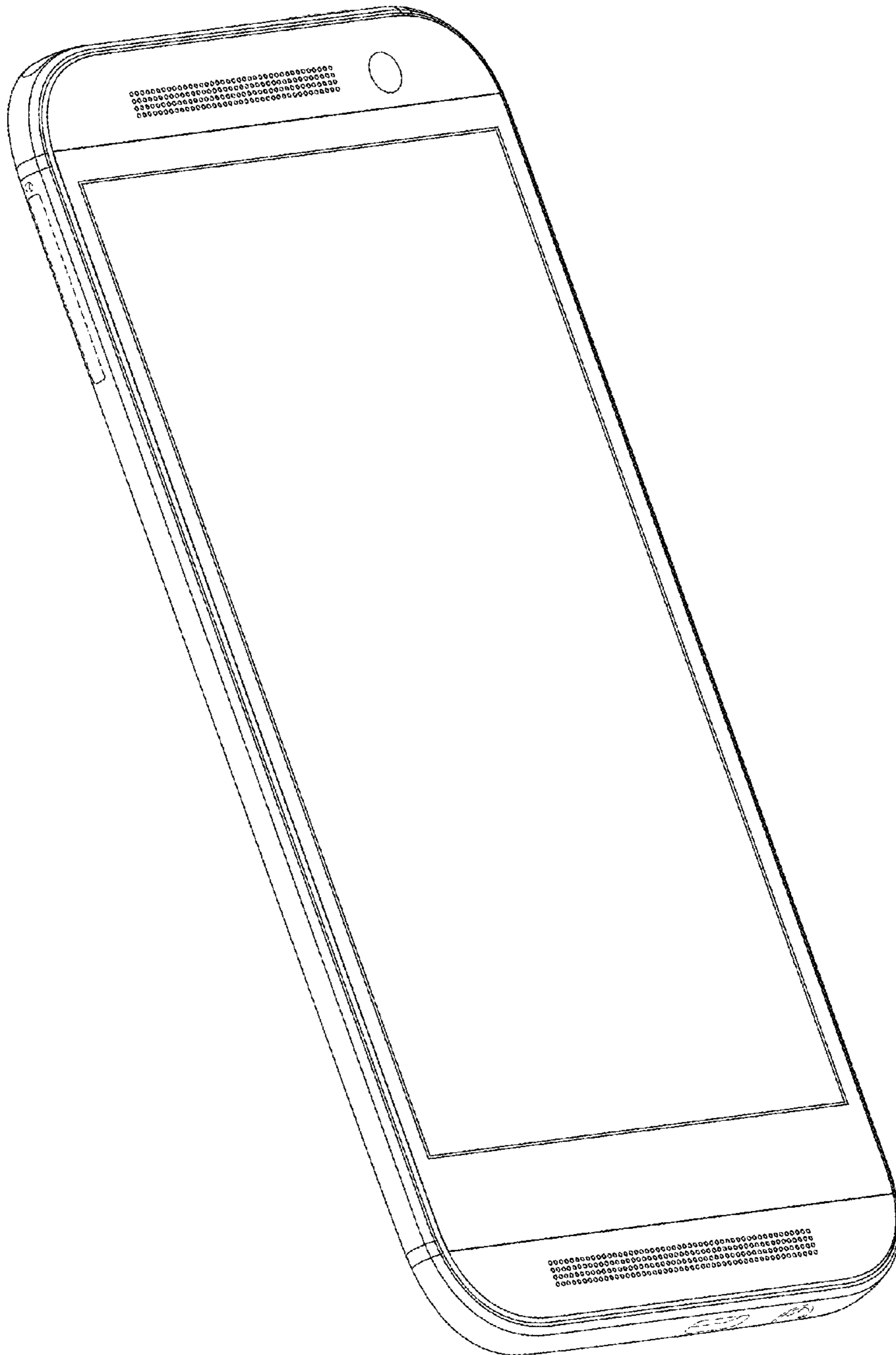

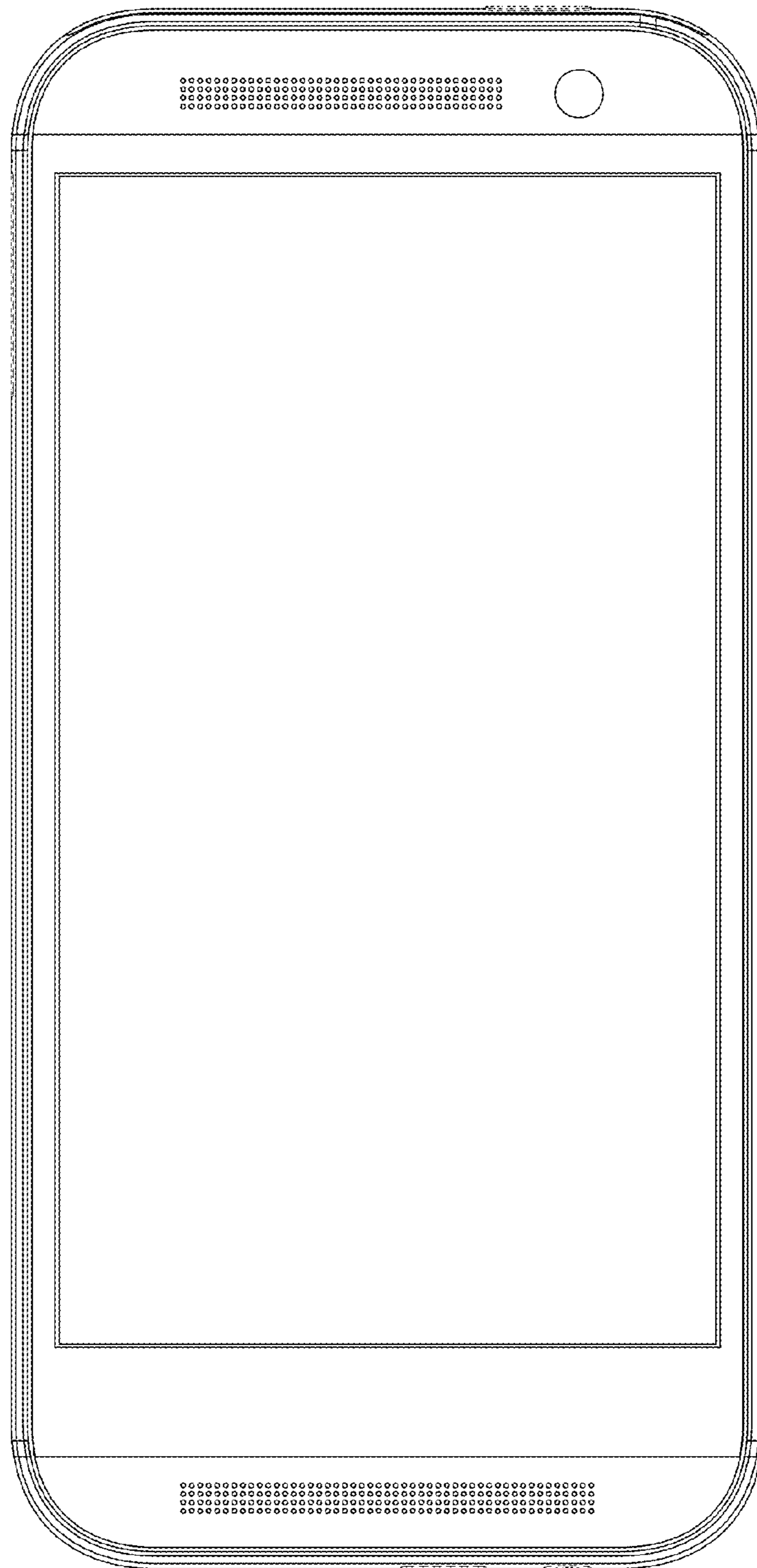

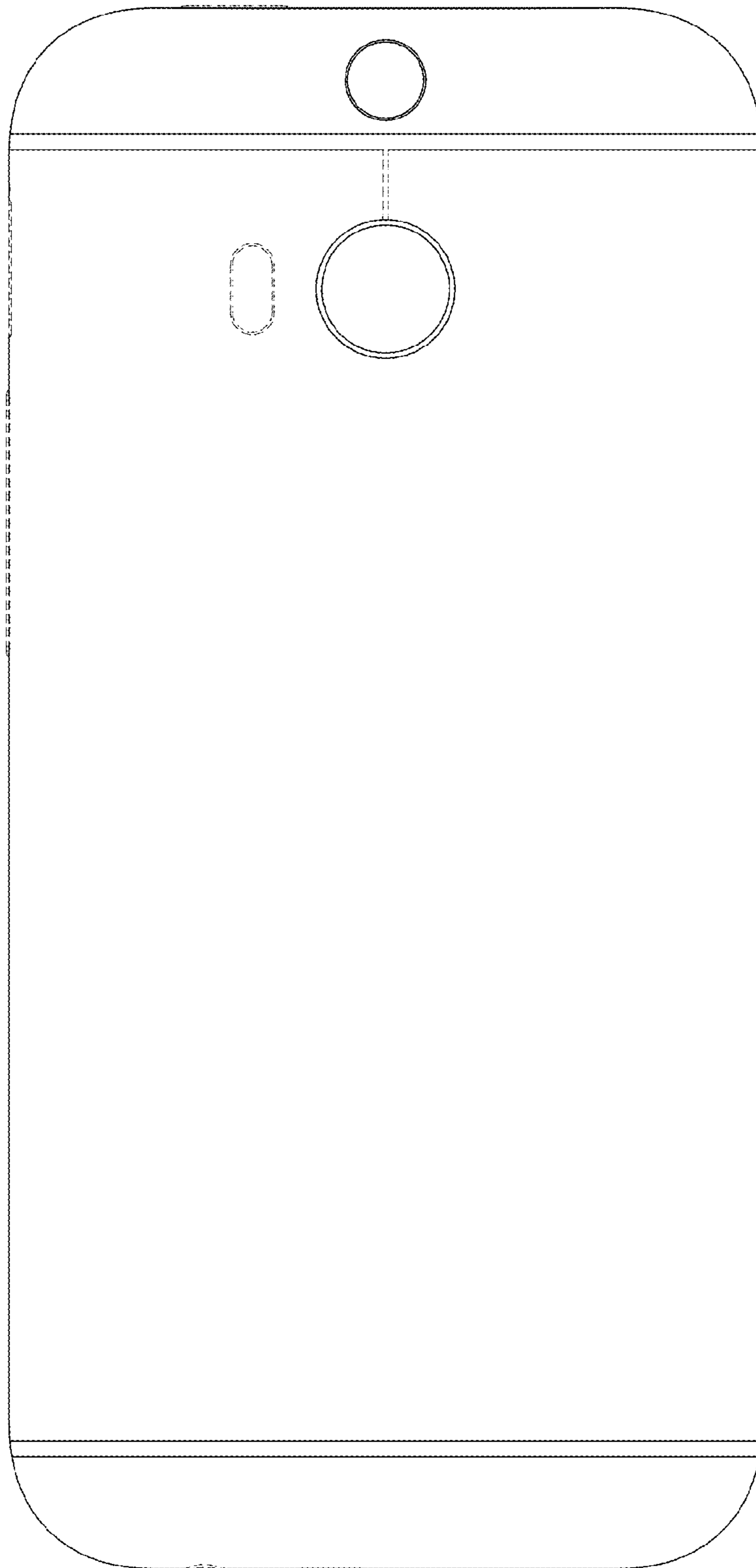

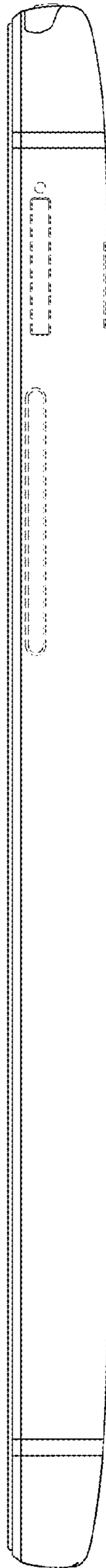

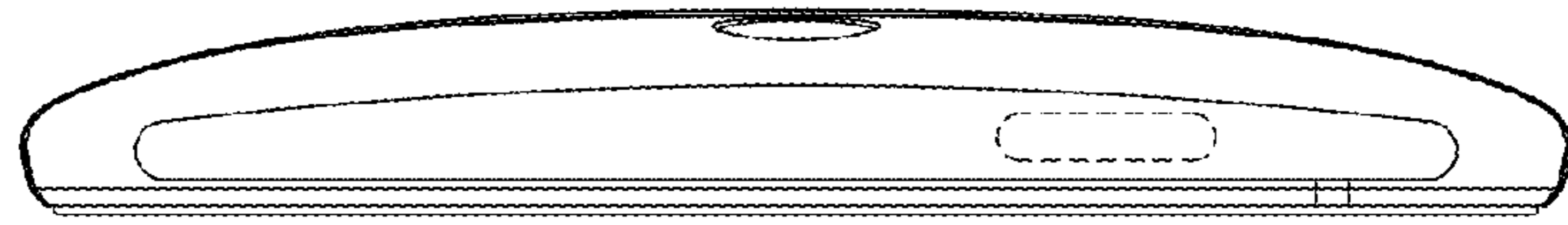

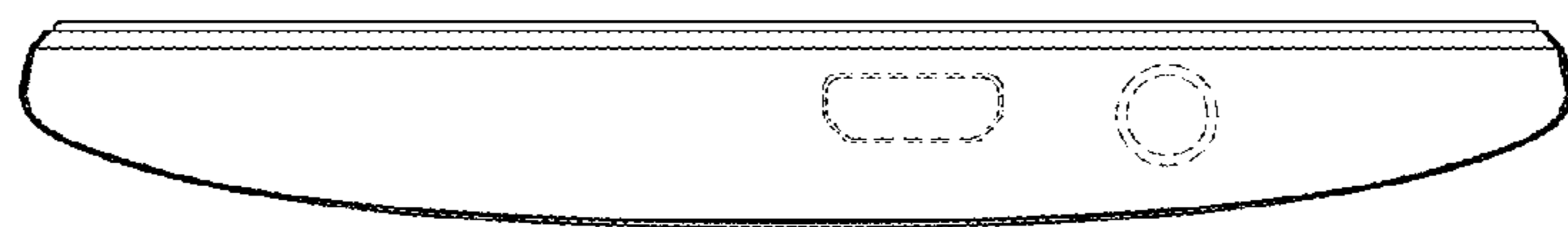

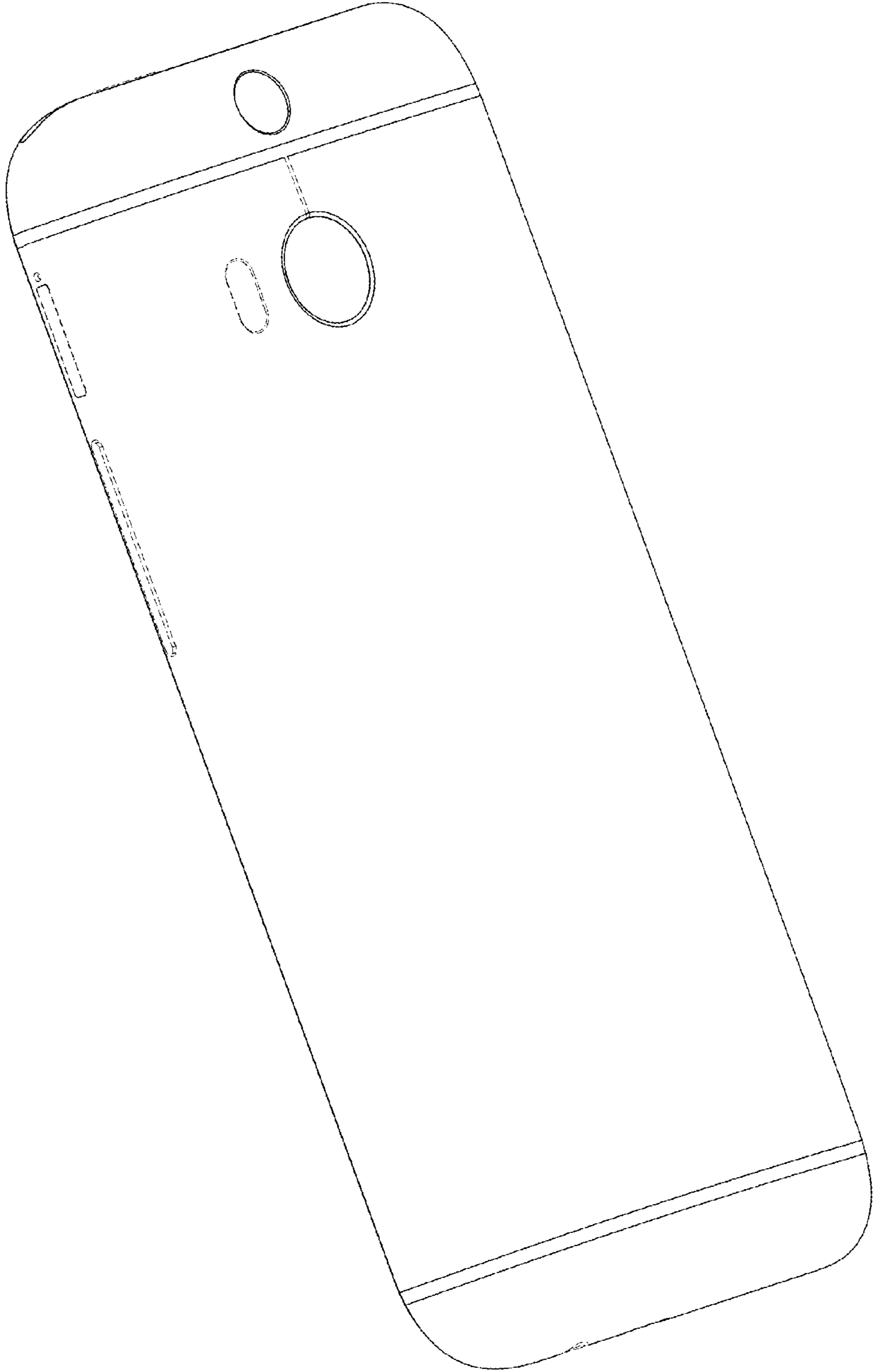

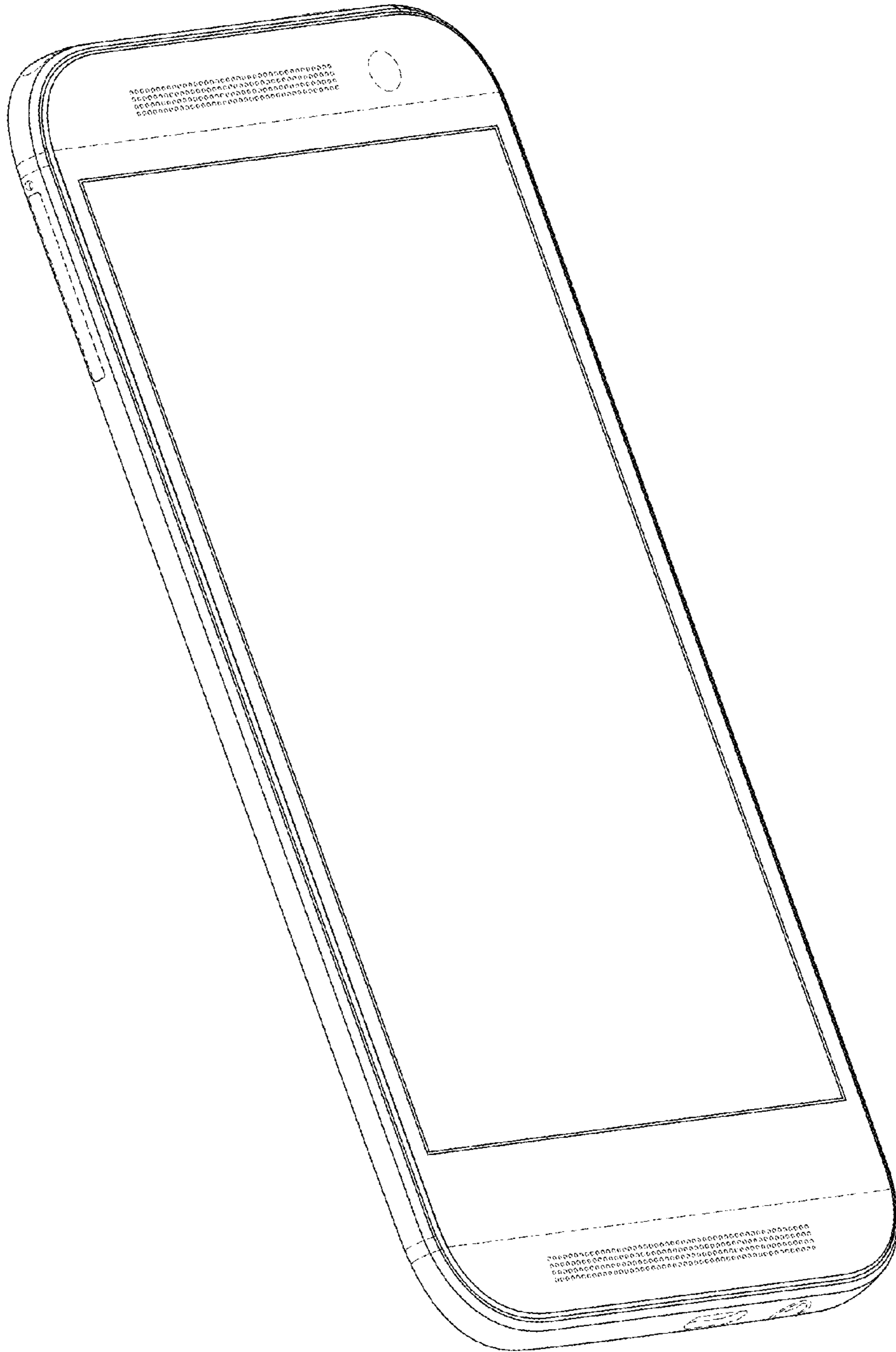

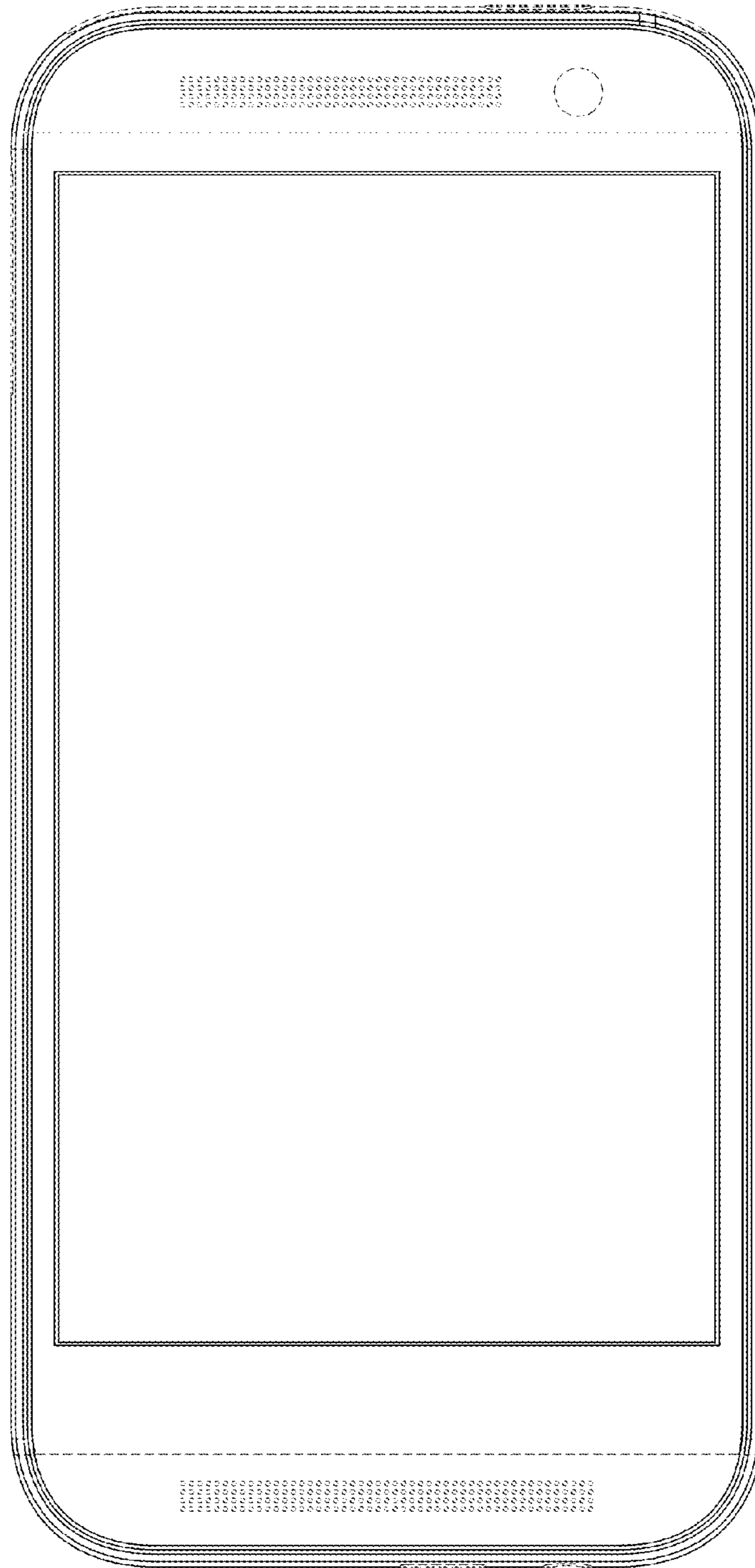

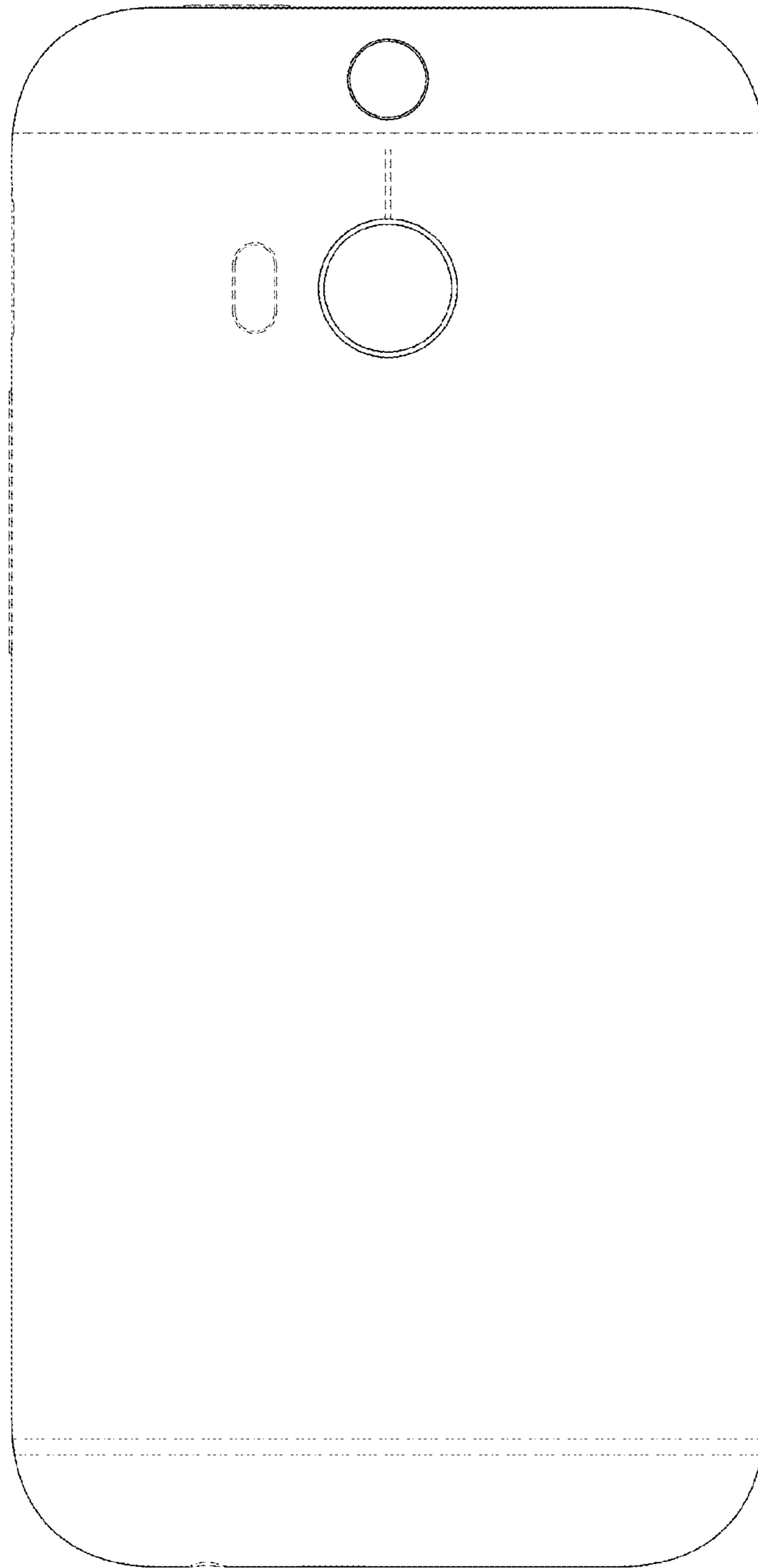

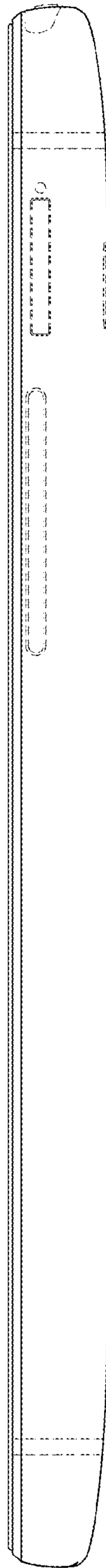

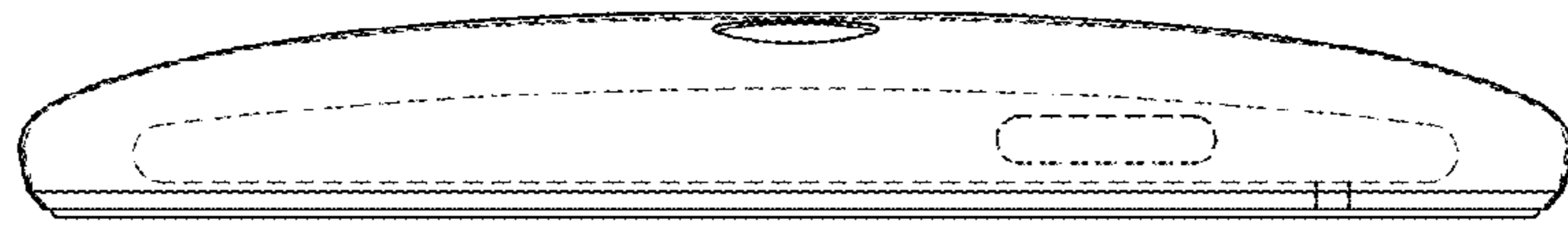

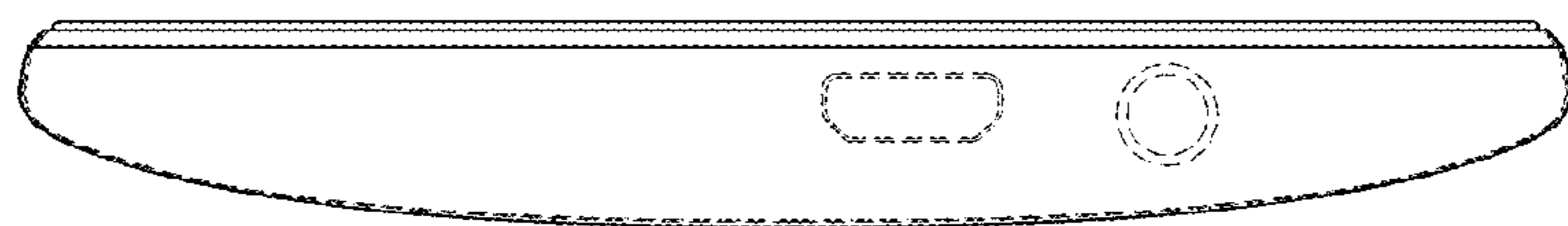

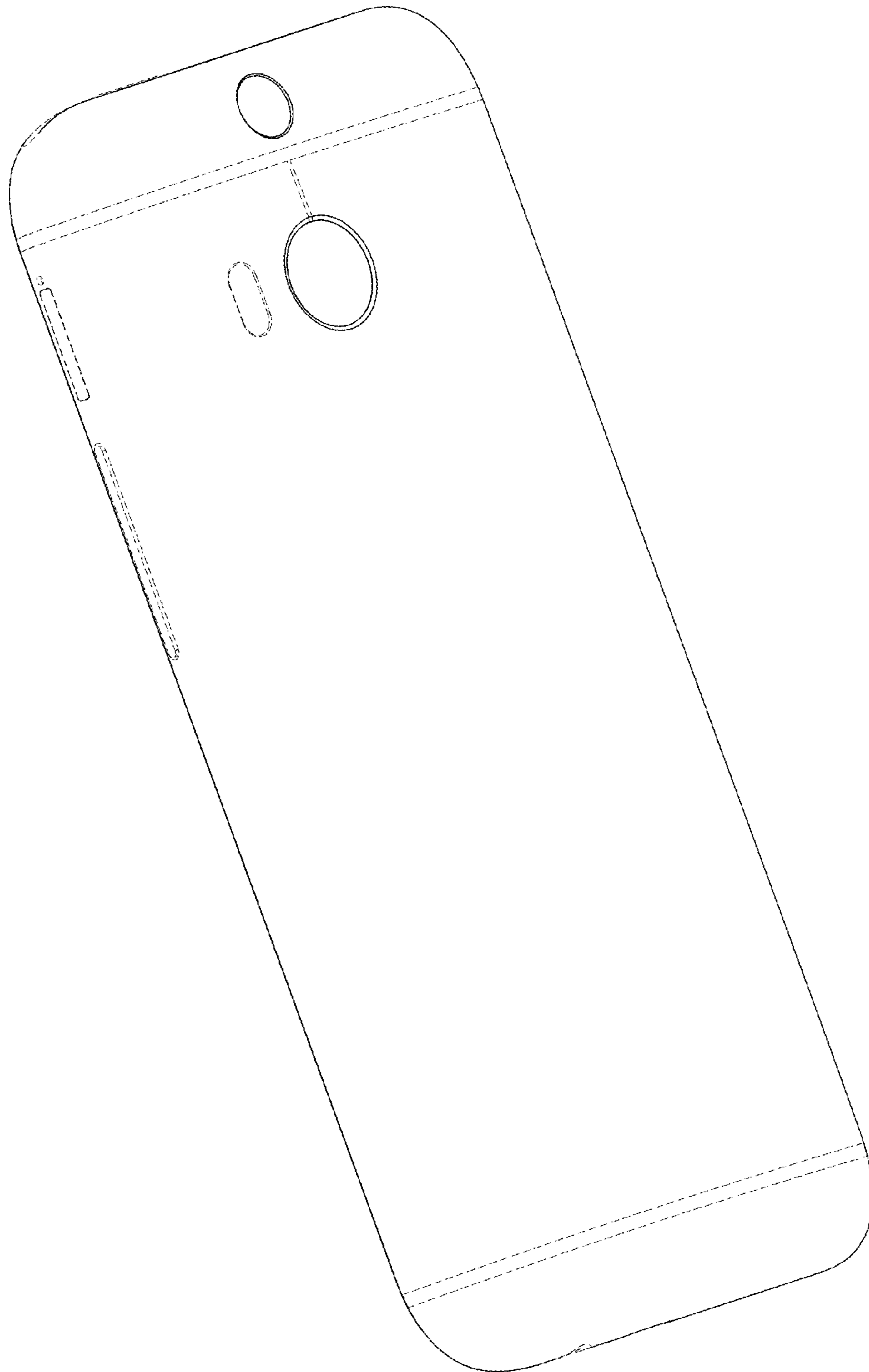
