(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface, showing my new design; and, FIG. 2 is a front view thereof, in which a mobile terminal in broken lines is provided to illustrate an example environment. The broken lines representing the portion of the display screen in all the FIGS. and the mobile terminal in FIG. 2 are included for the purpose of illustrating portions of the article and environmental structure and form no part of the claimed design.

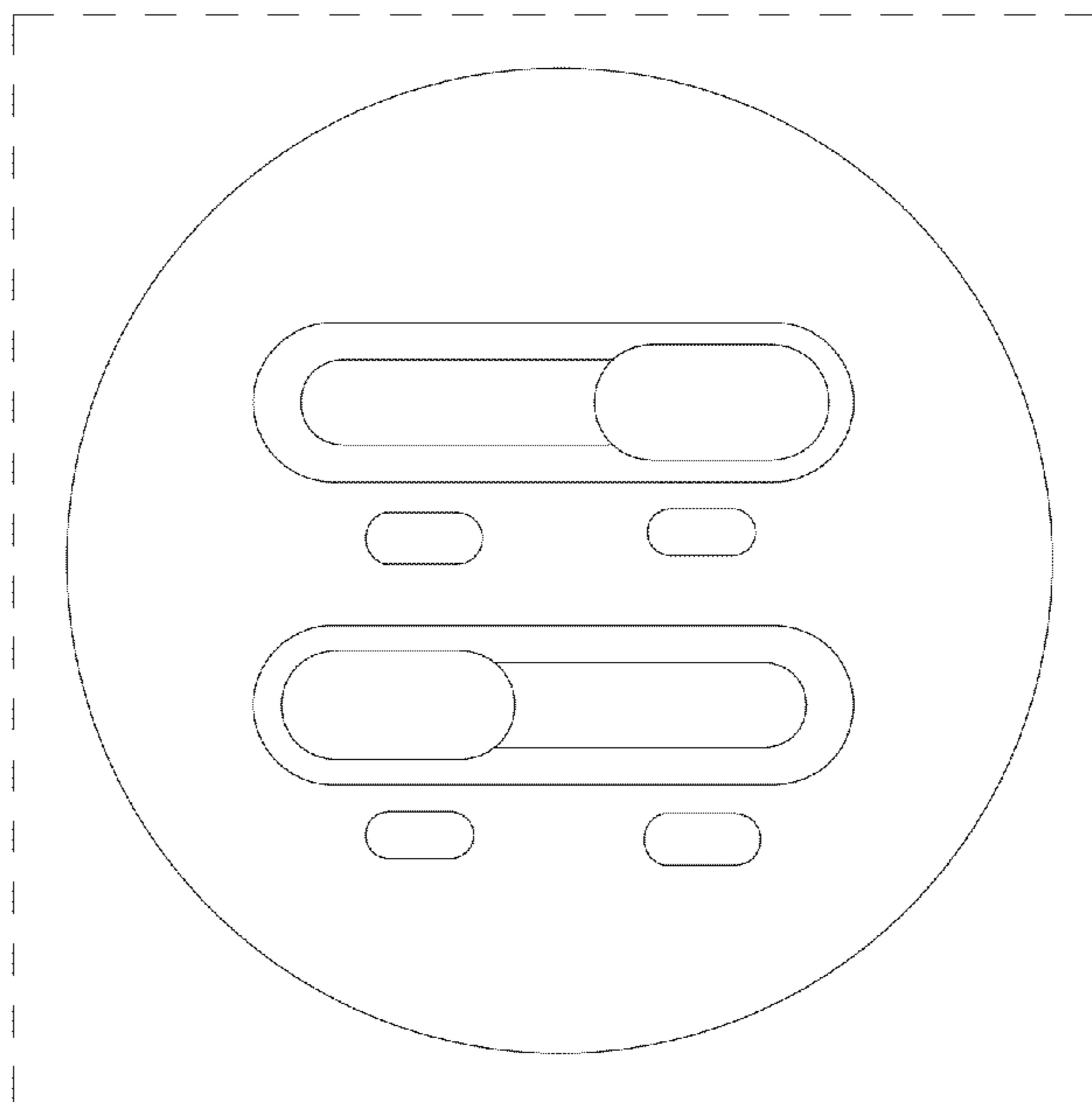

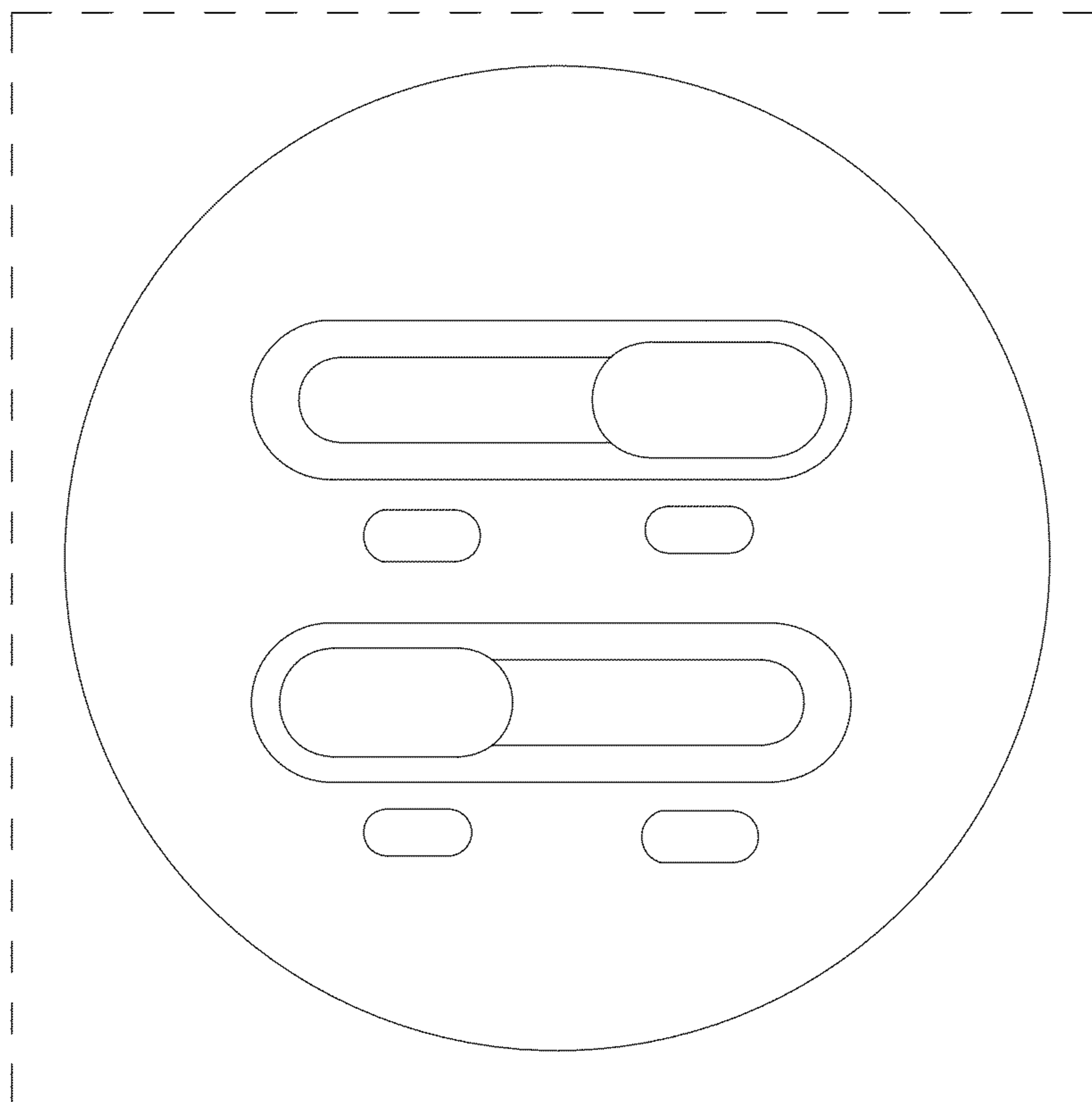
