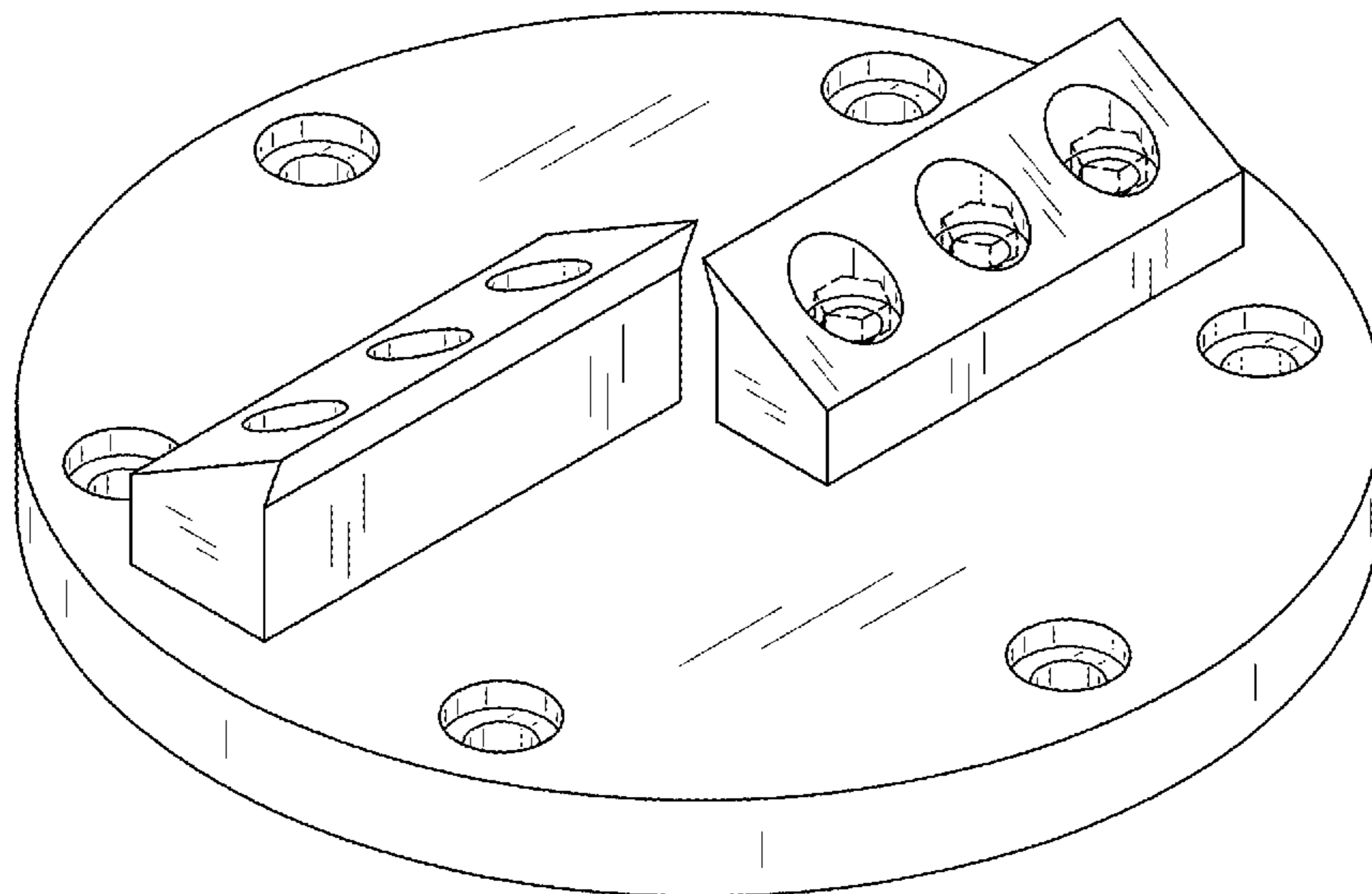
(57) **CLAIM**

The ornamental design for a rotary cutting disc center blade device, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a rotary cutting disc center blade device showing my new design;
 FIG. 2 is a bottom view of the rotary cutting disc center blade device;
 FIG. 3 is a side view of the rotary cutting disc center blade device;
 FIG. 4 is a side view of the rotary cutting disc center blade device;
 FIG. 5 is an inverted back view of the rotary cutting disc center blade device;
 FIG. 6 is a front view of the rotary cutting disc center blade device; and,
 FIG. 7 is a top front side perspective view of the rotary cutting disc center blade device.

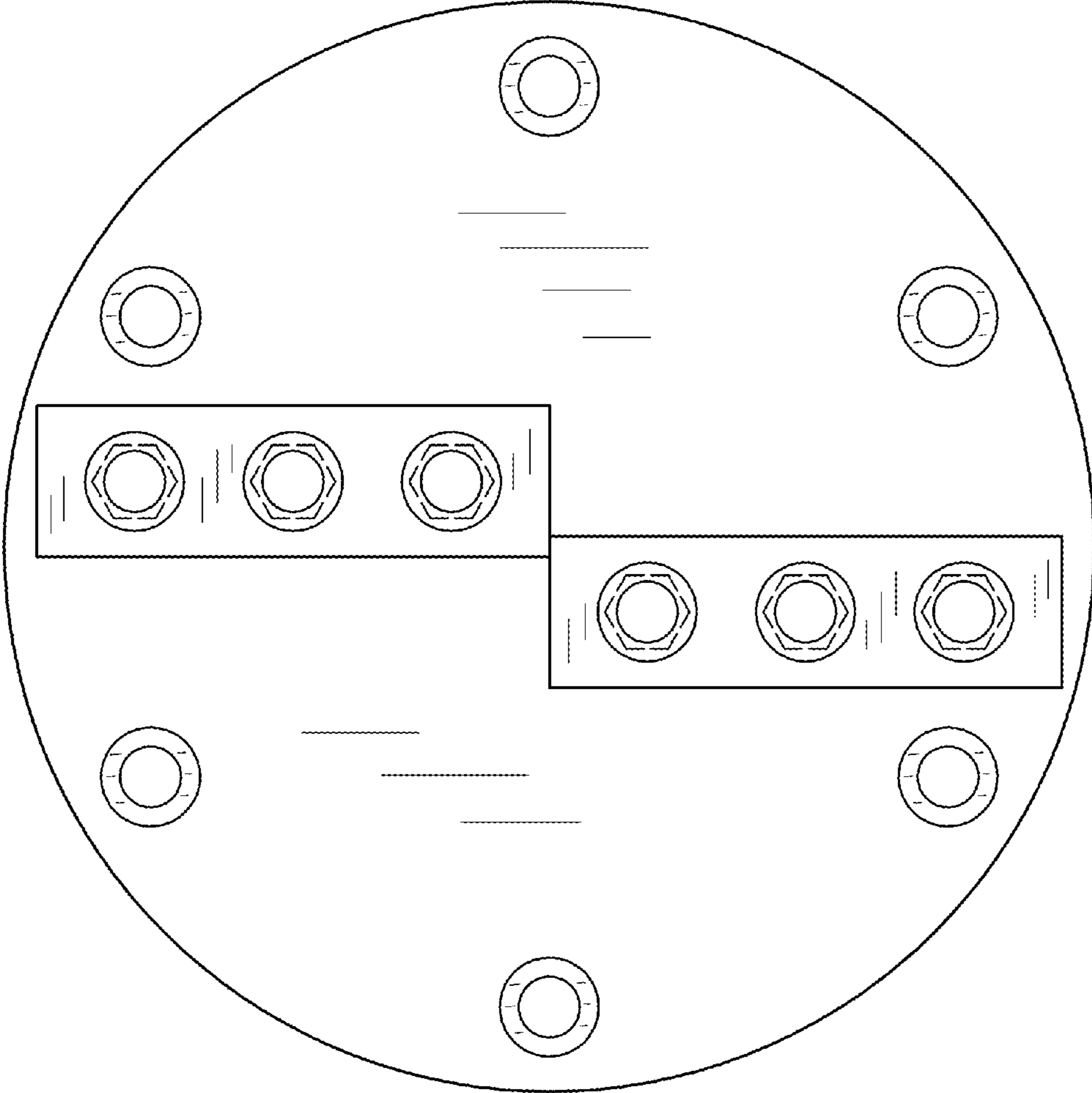

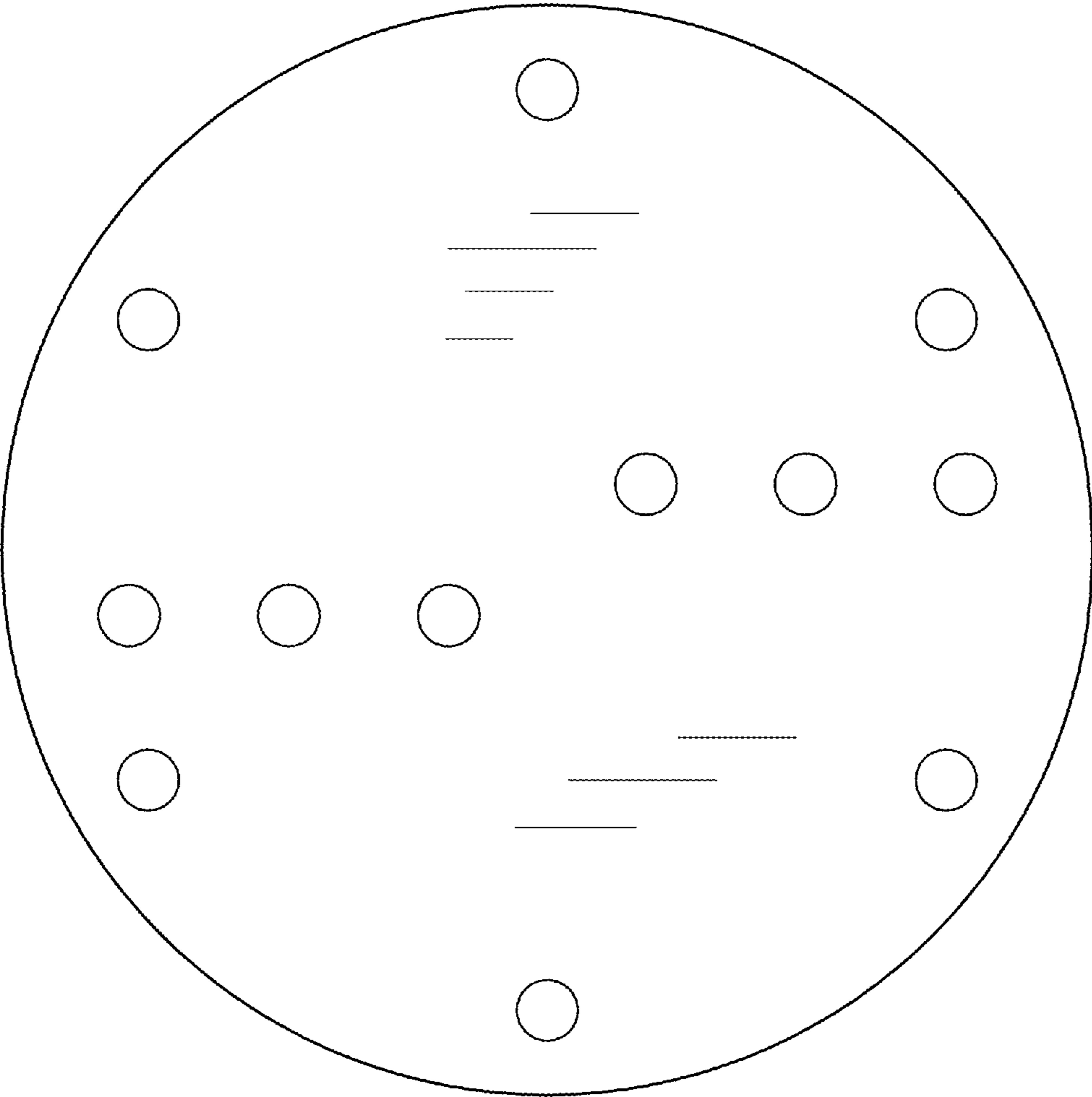

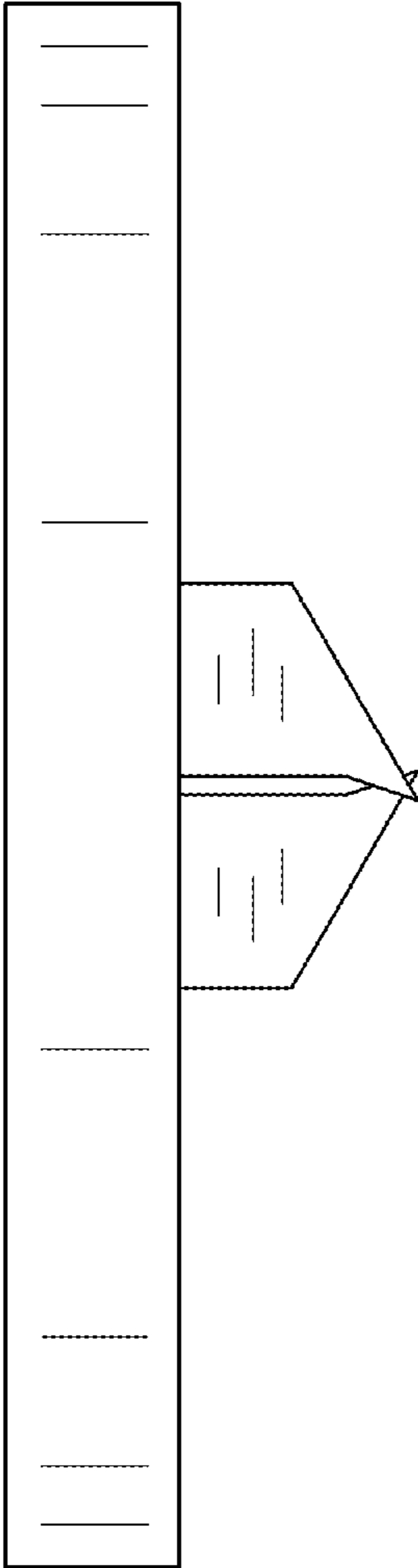

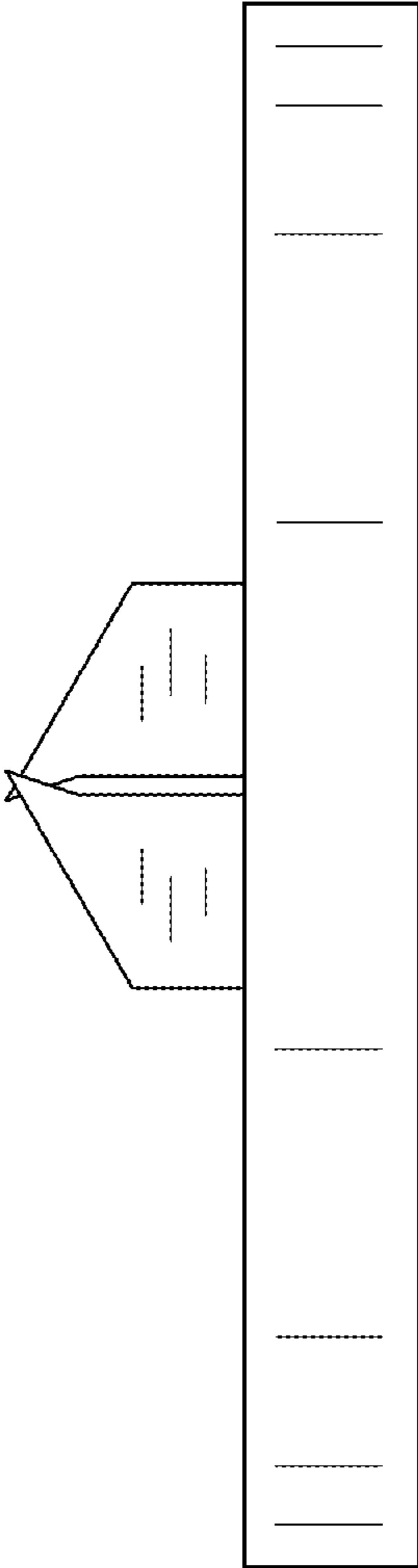

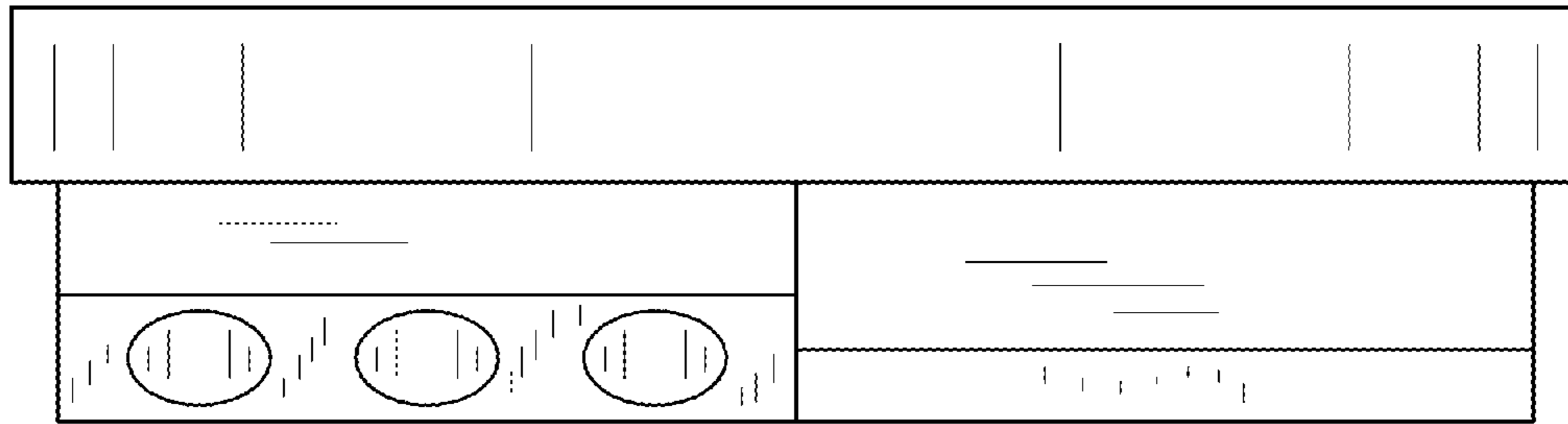

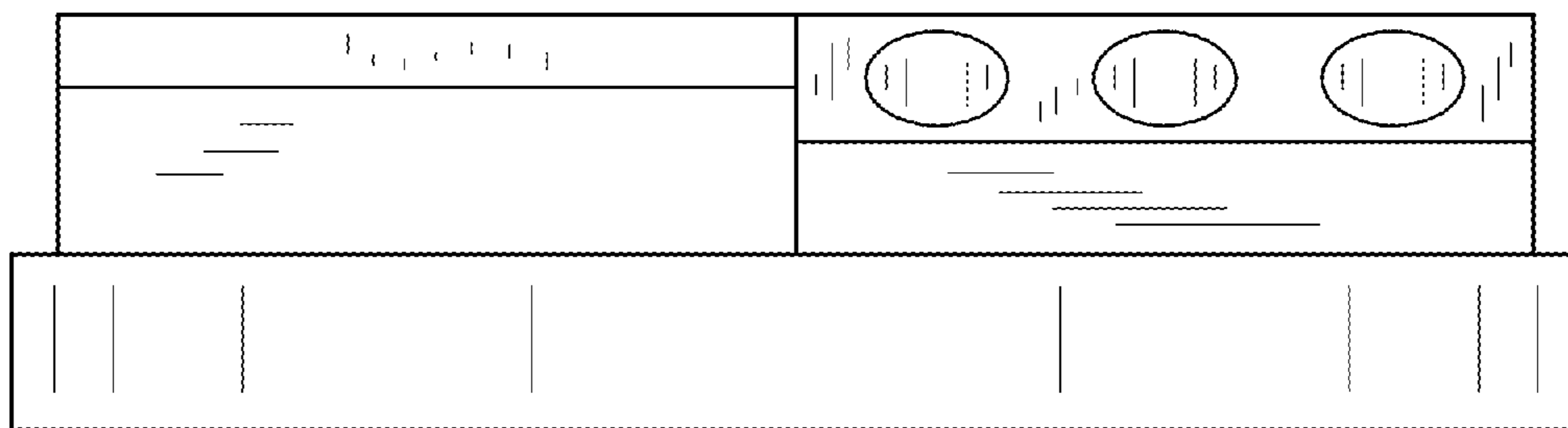

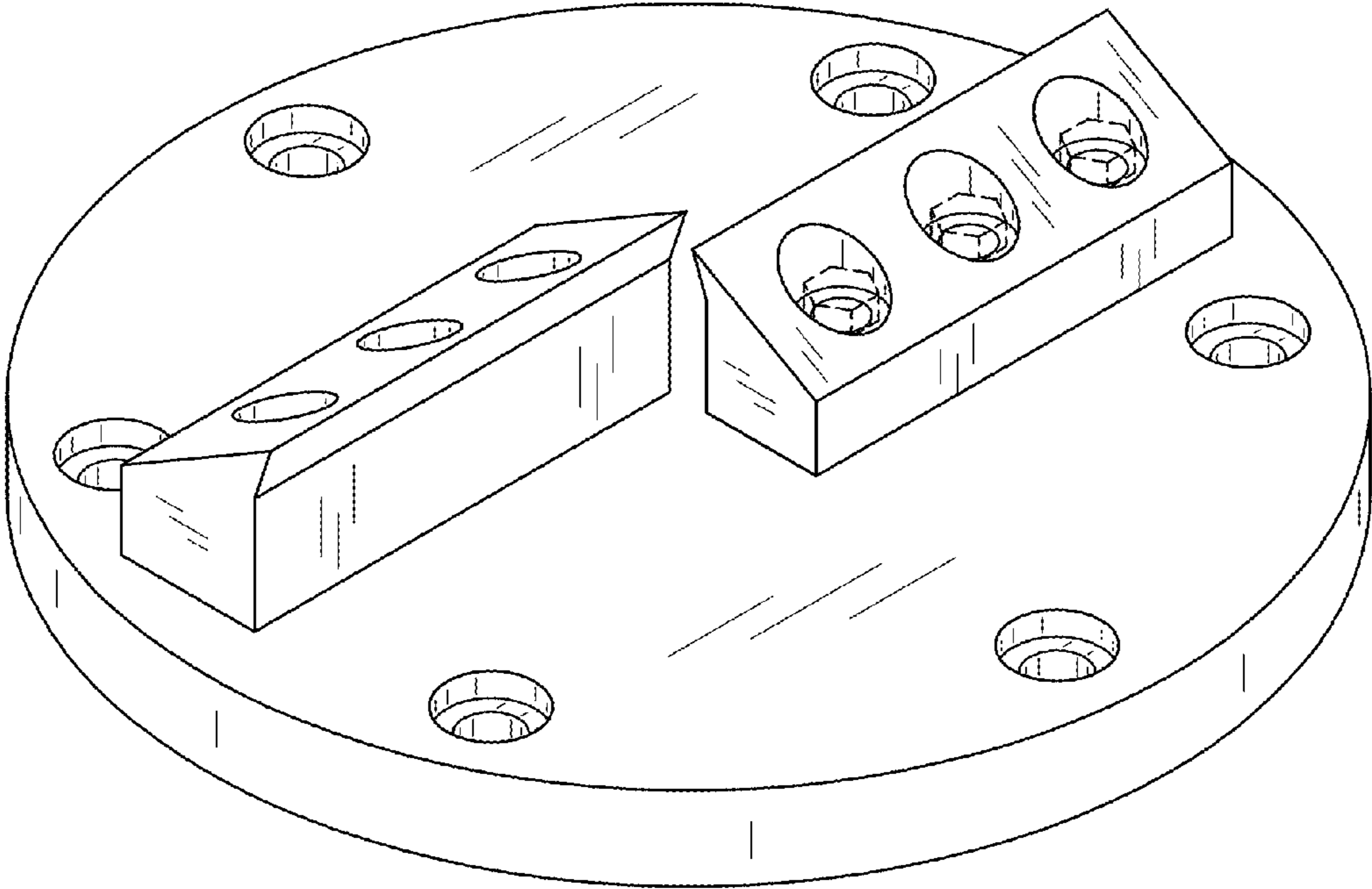
