(57) **CLAIM**

The ornamental design for a blade rake tine, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a first embodiment of a blade rake tine showing my new design in use condition.
 FIG. 2 is an enlarged rear perspective view thereof shown in use condition, the plurality of blade rake tines and blade shown in broken line form no part of the claimed design.
 FIG. 3 is an enlarged first side view thereof.
 FIG. 4 is a front view of FIG. 3 thereof.
 FIG. 5 is a second side view thereof.
 FIG. 6 is a rear view thereof.
 FIG. 7 is a top view thereof.
 FIG. 8 is a bottom view thereof.
 FIG. 9 is a front side perspective view thereof.
 FIG. 10 is another front side perspective view thereof.
 FIG. 11 is a first side view of a second embodiment of a blade rake tine, showing my new design.
 FIG. 12 is a front view of FIG. 11 thereof.

 FIG. 14 is a rear view thereof.
 FIG. 15 is a top view thereof.
 FIG. 16 is a bottom view thereof.

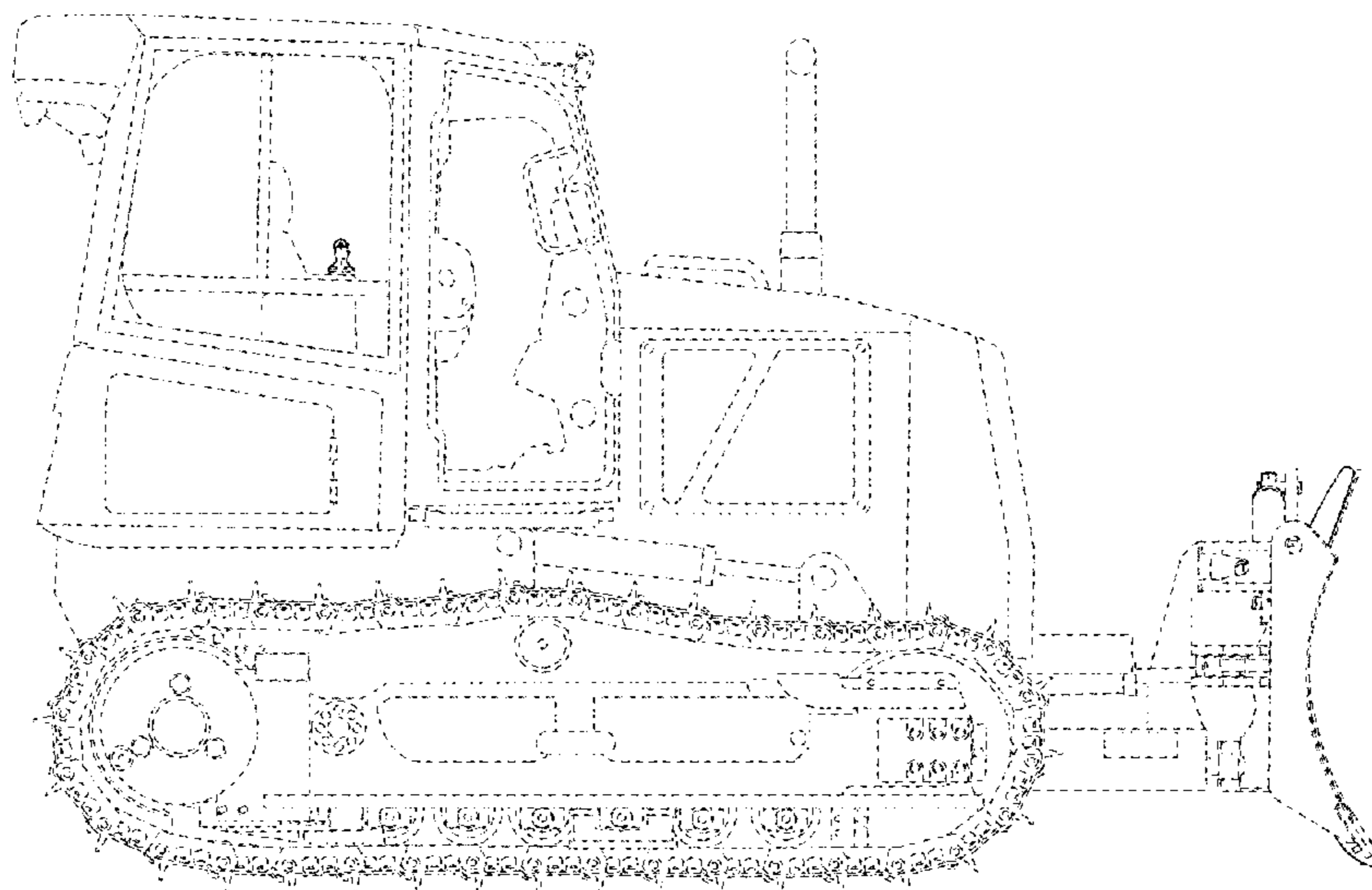

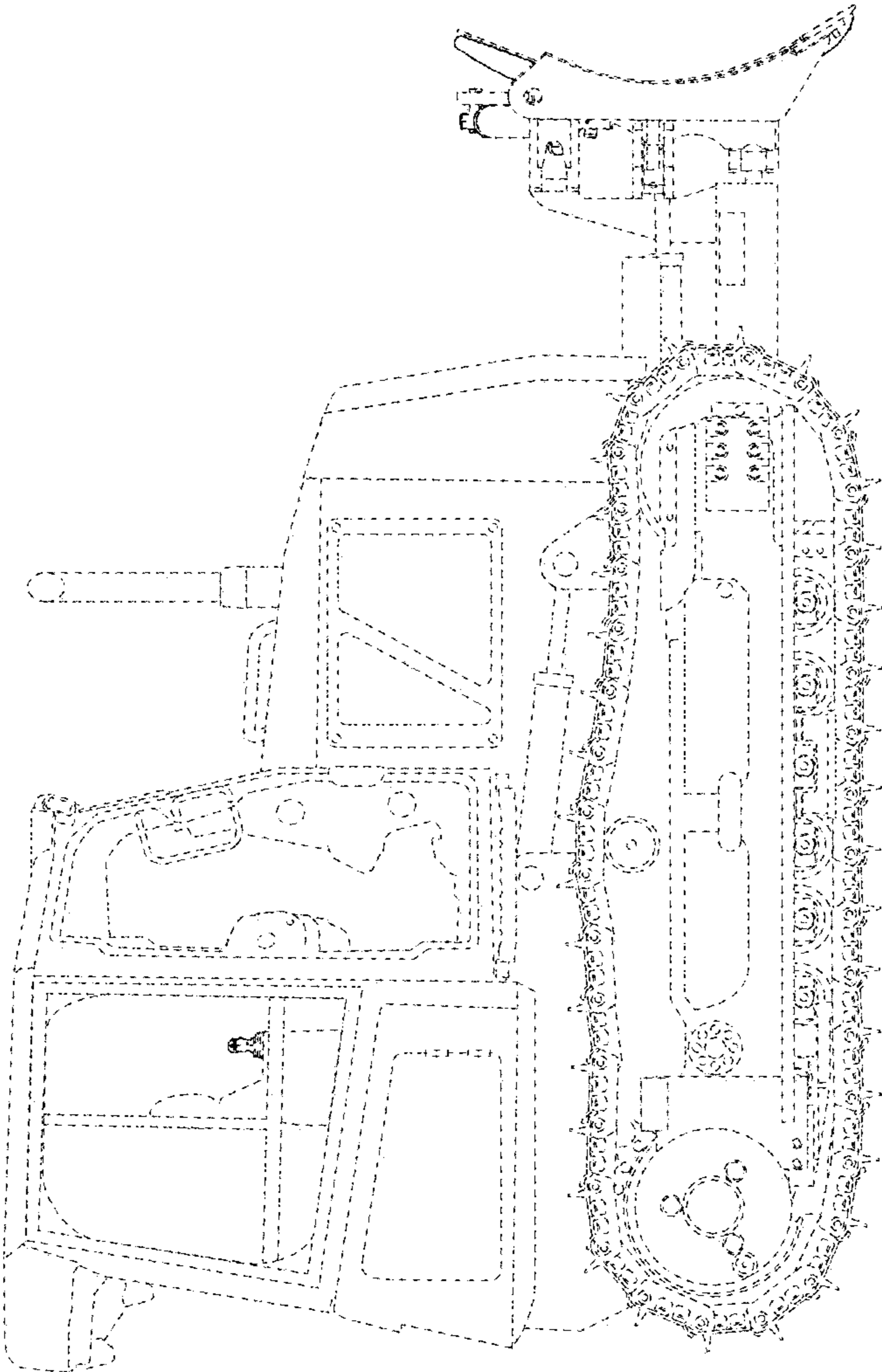

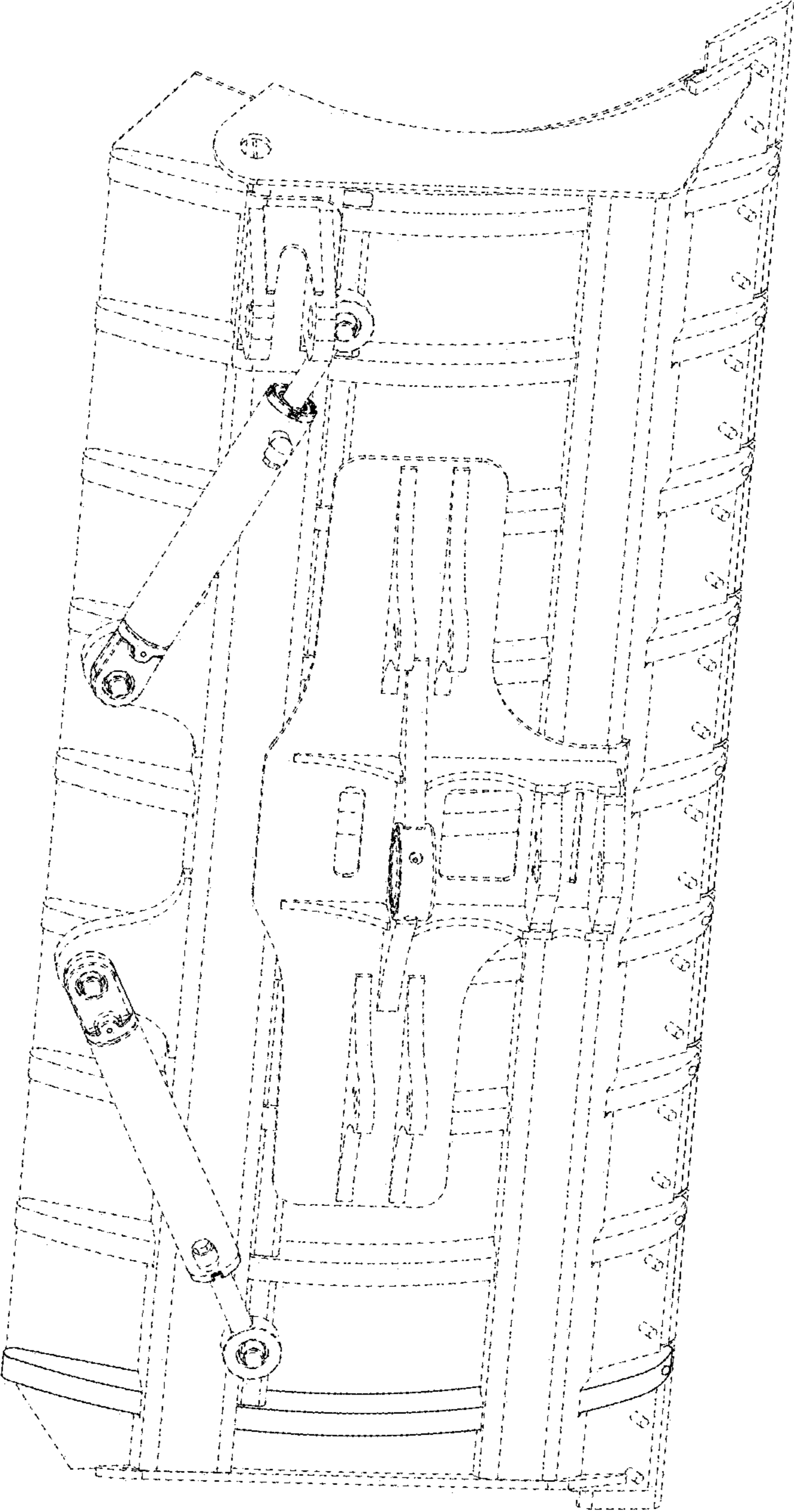

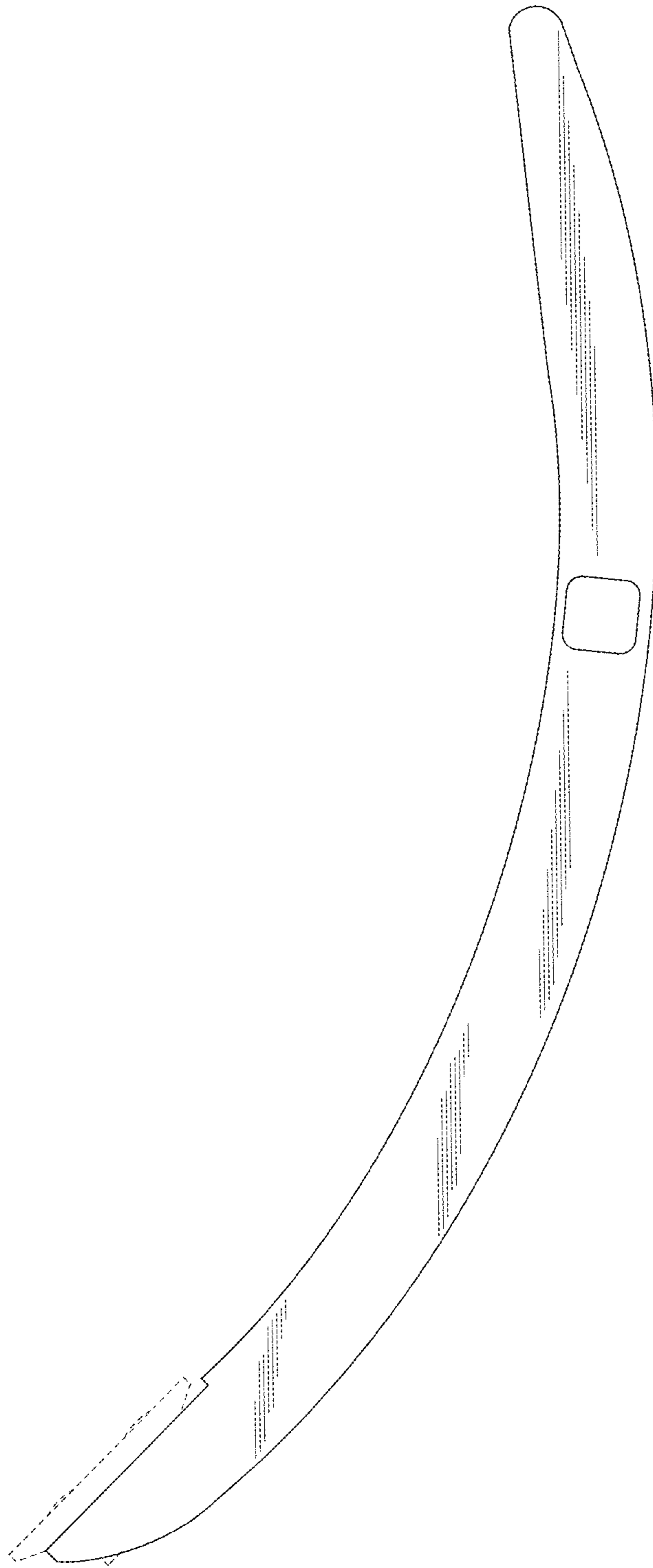

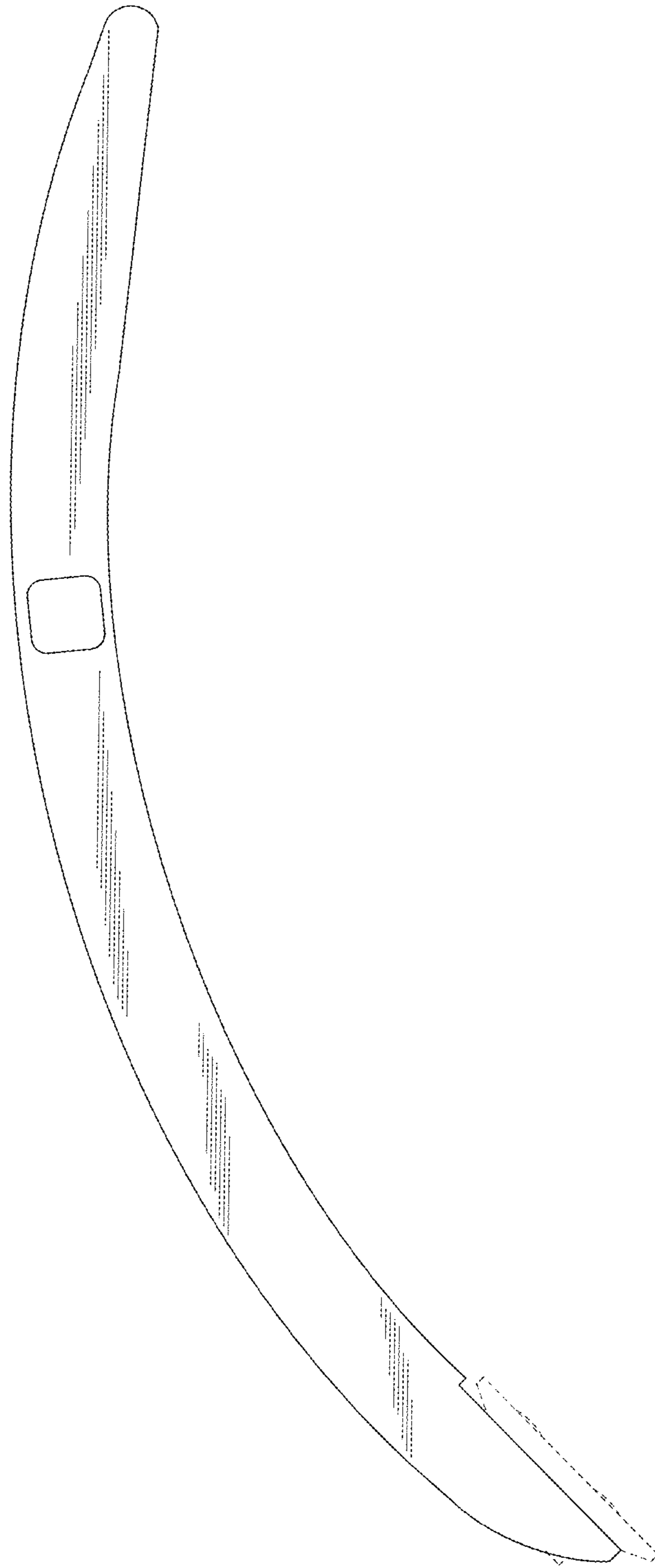

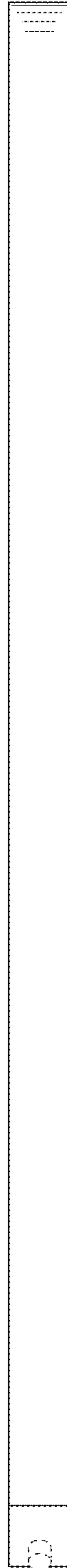

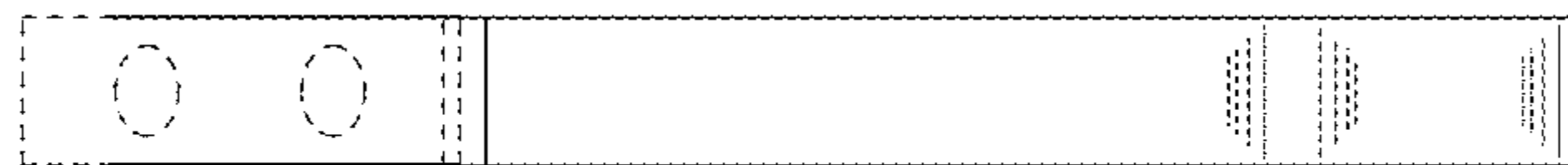

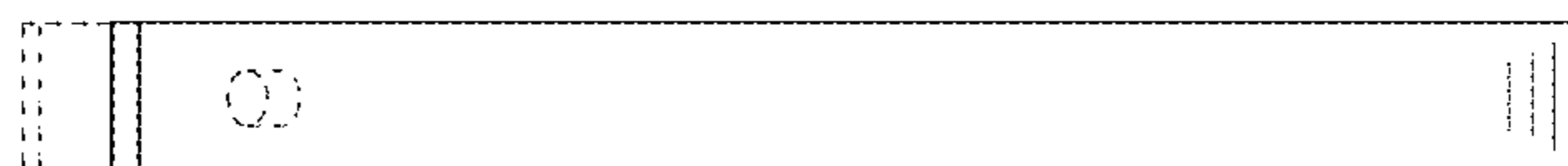

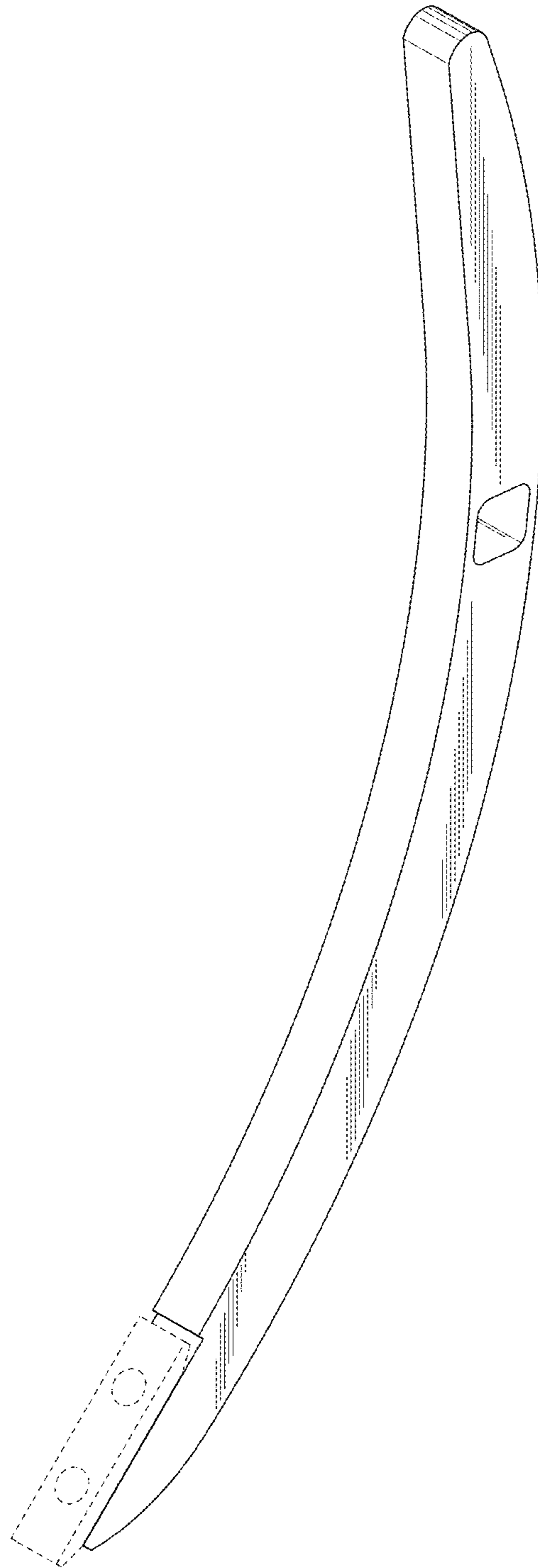

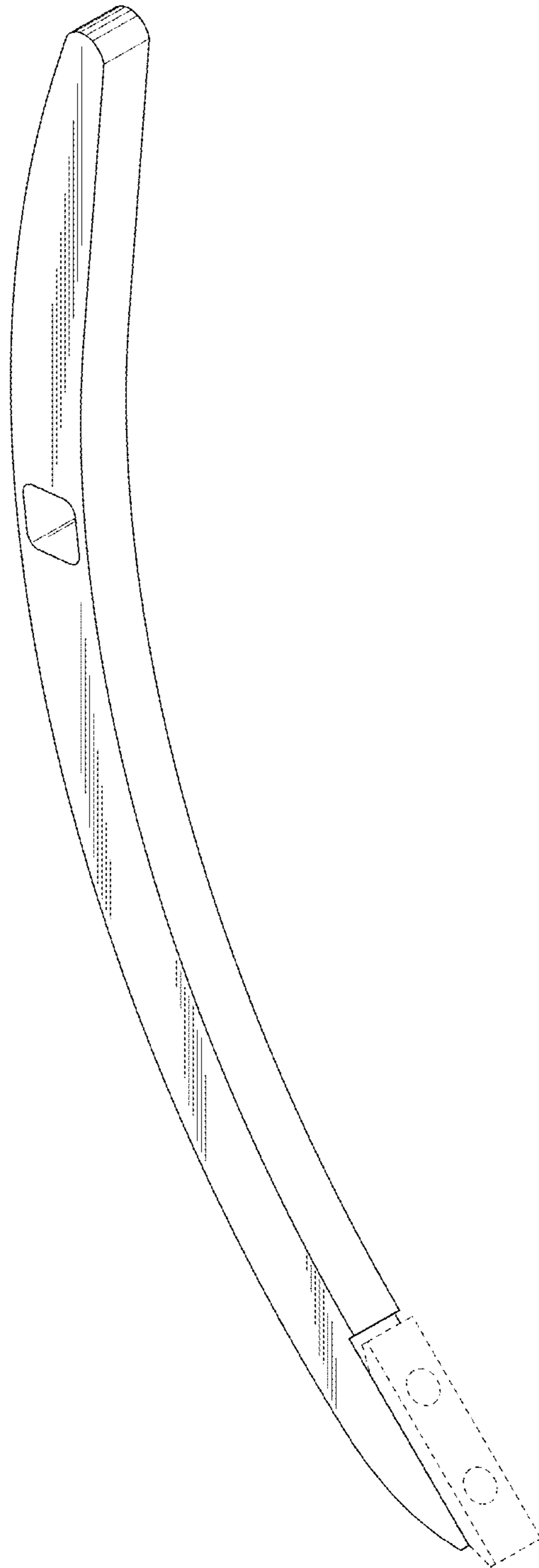

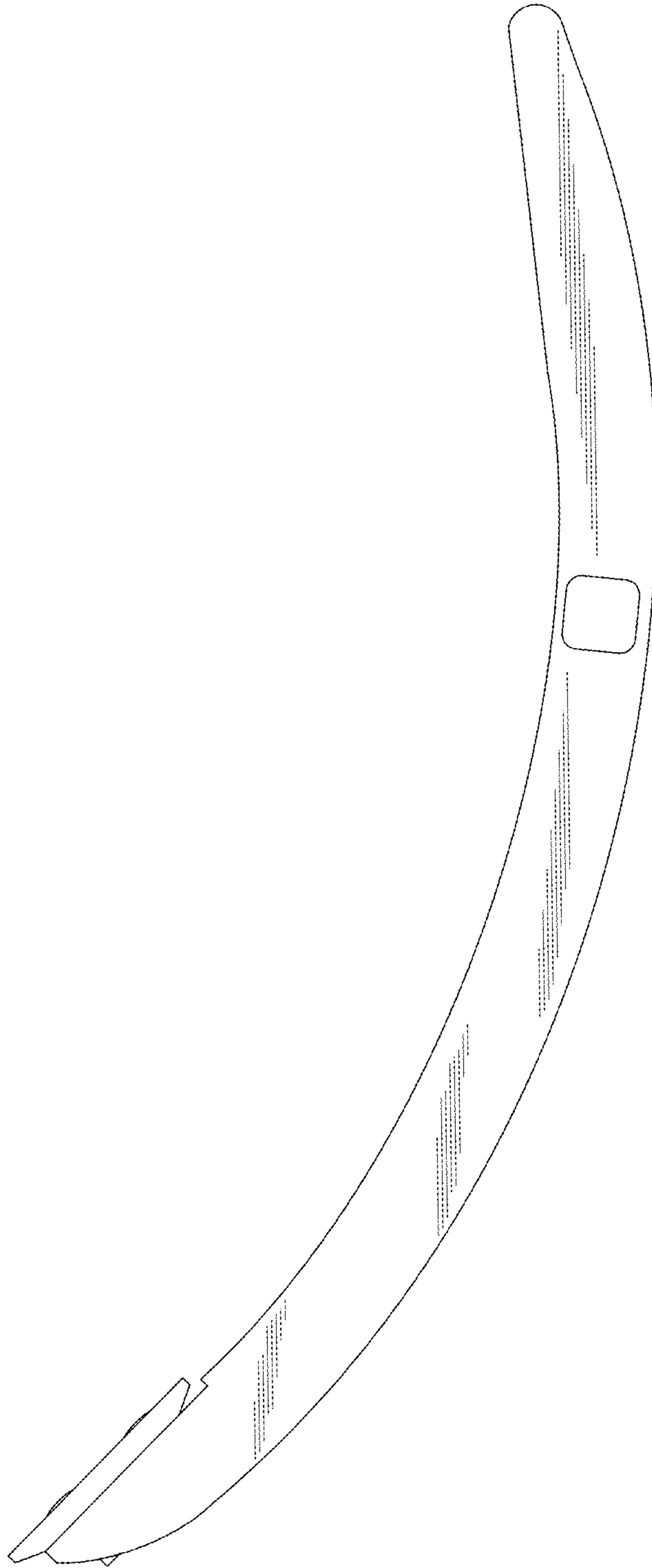

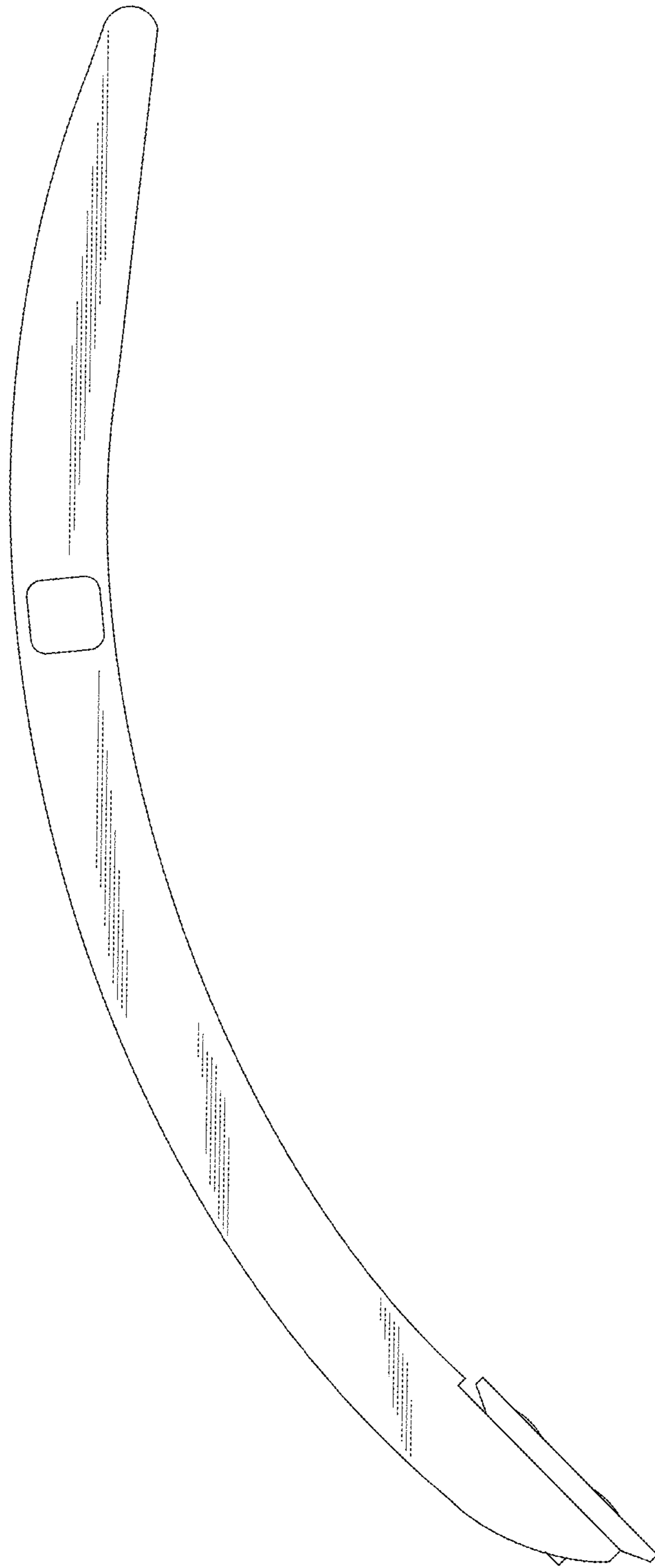

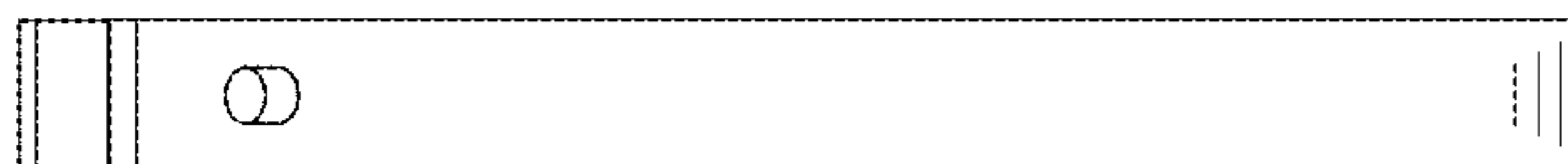

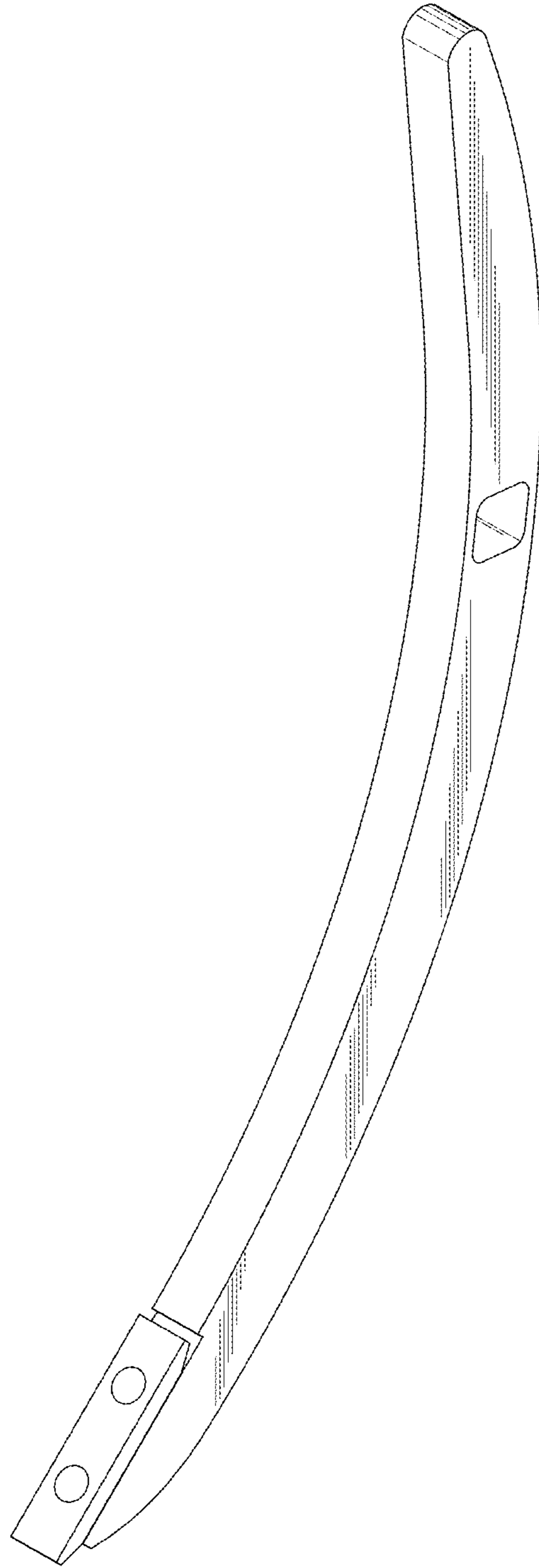
