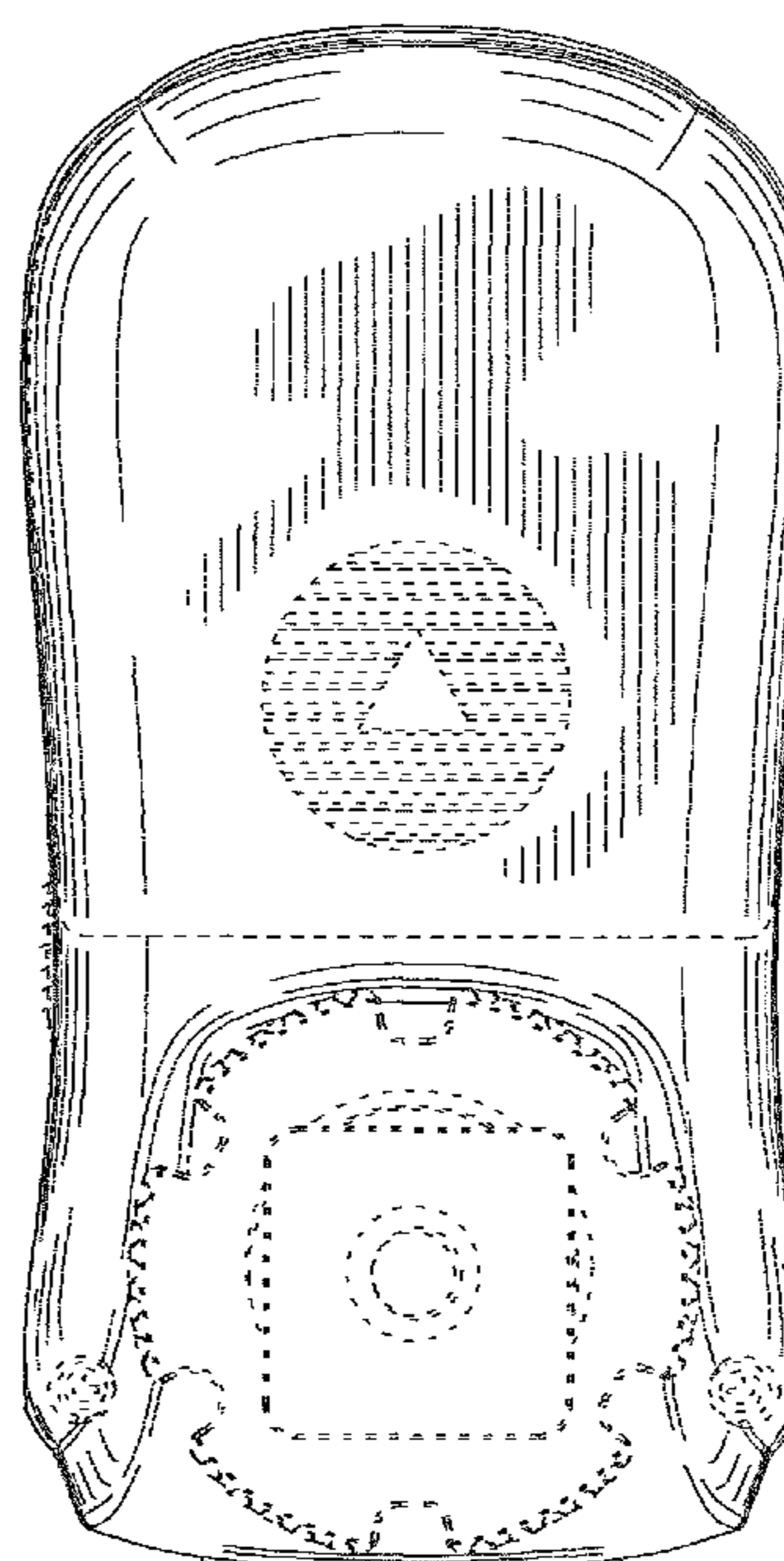
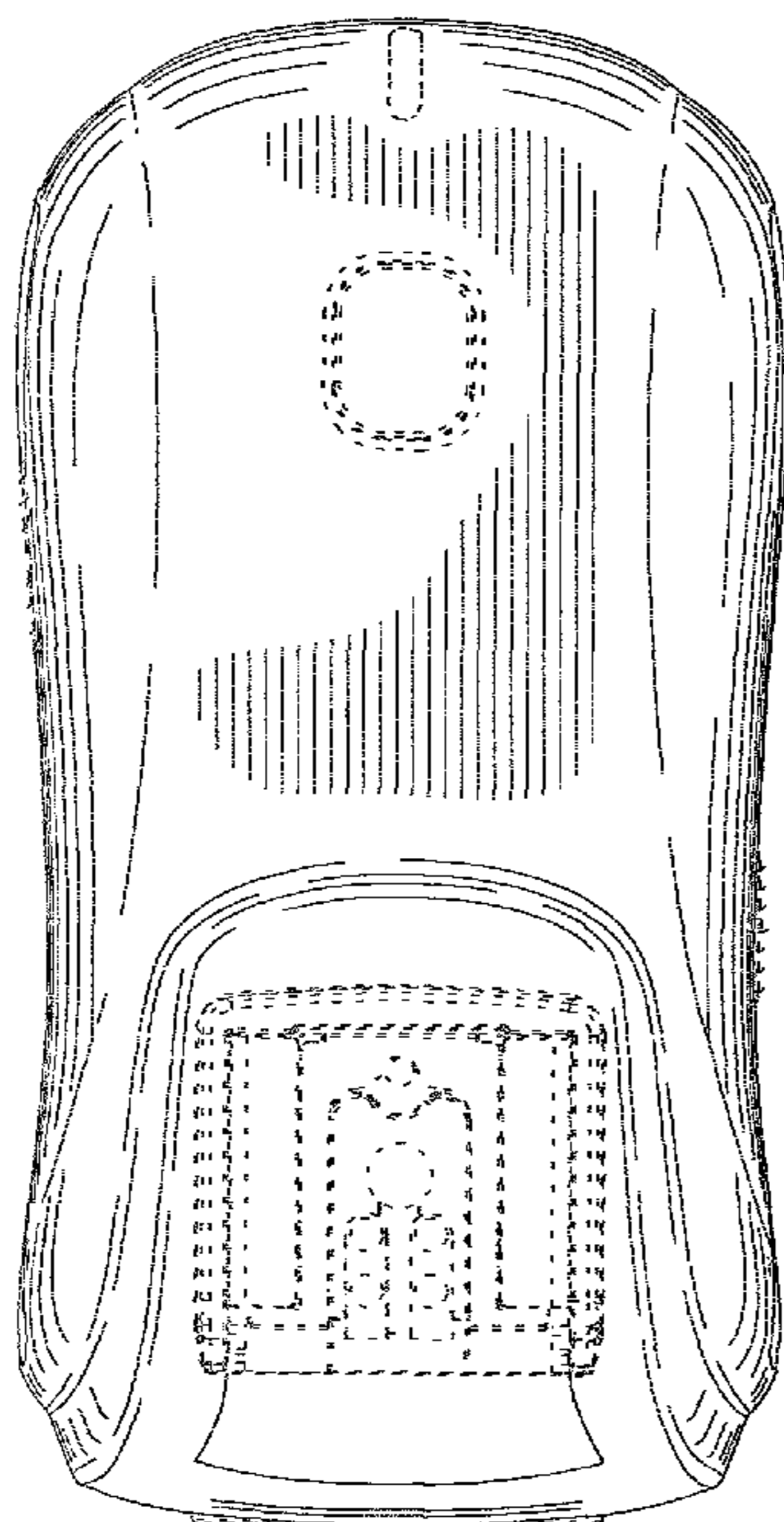
The ornamental design for a photographic flash trigger, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a photographic flash trigger;
FIG. 2 is a rear view of the photographic flash trigger of FIG. 1;
FIG. 3 is a left view of the photographic flash trigger of FIG. 1;
FIG. 4 is a right view of the photographic flash trigger of FIG. 1;
FIG. 5 is a top view of the photographic flash trigger of FIG. 1; and,

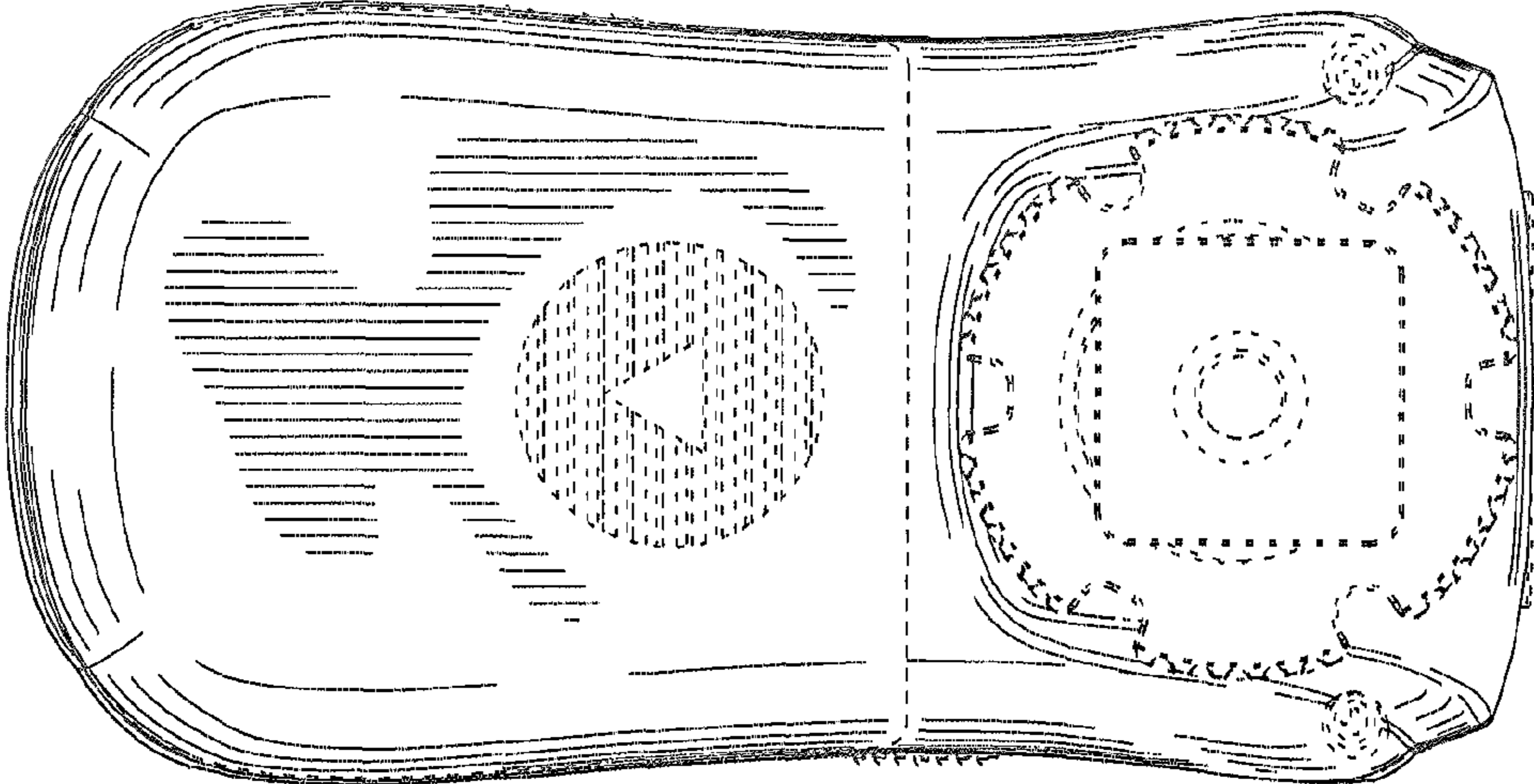

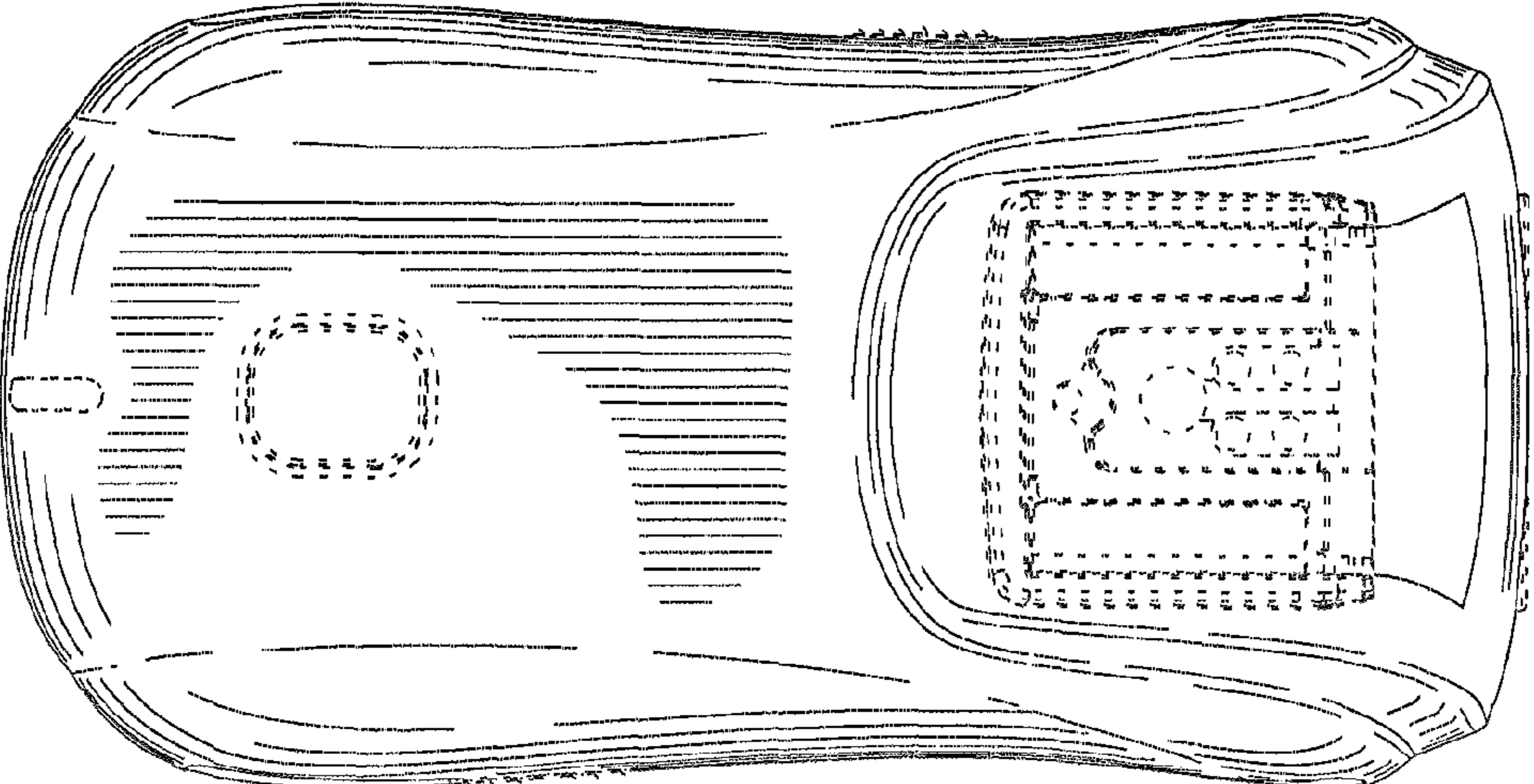

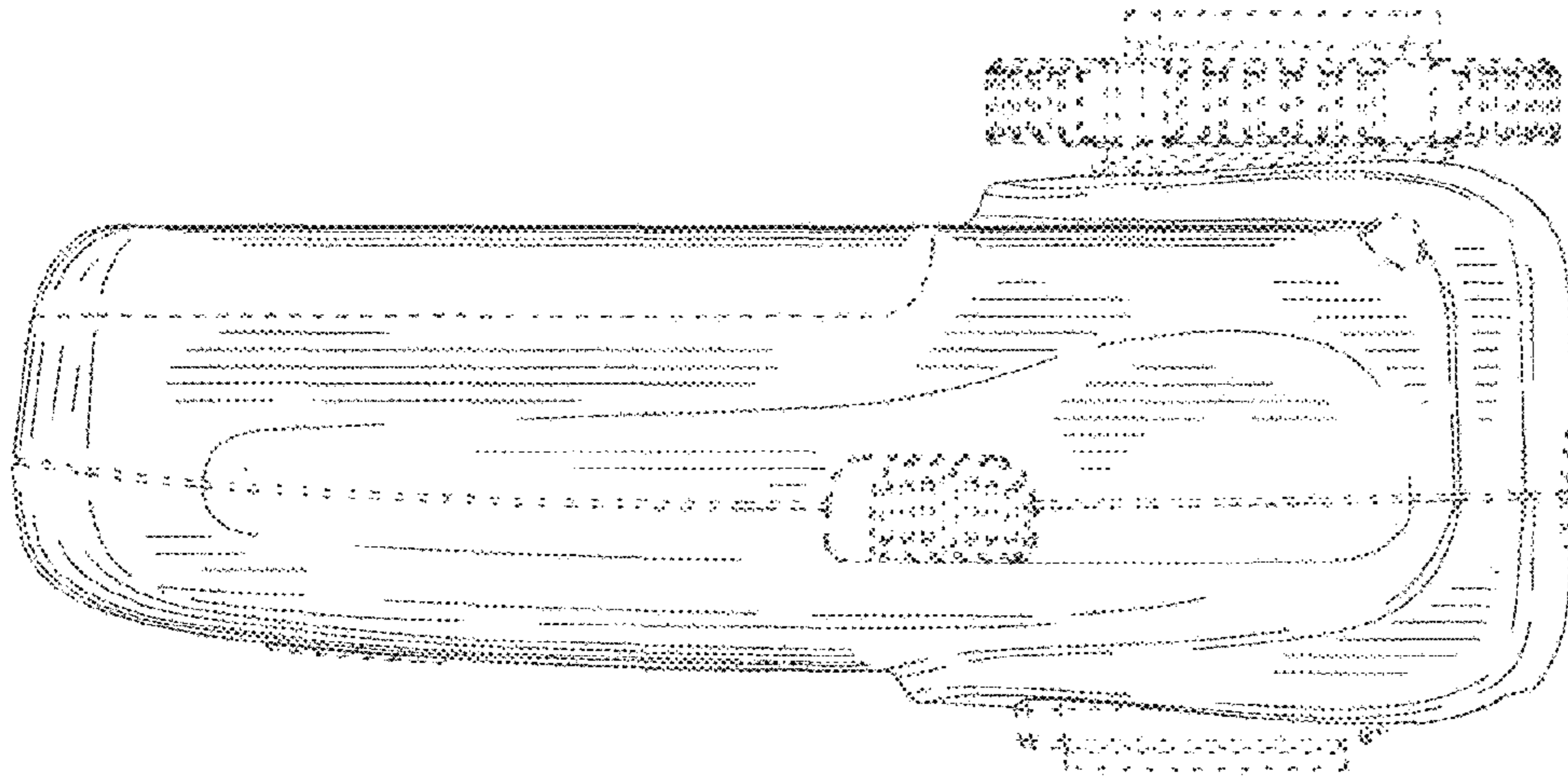

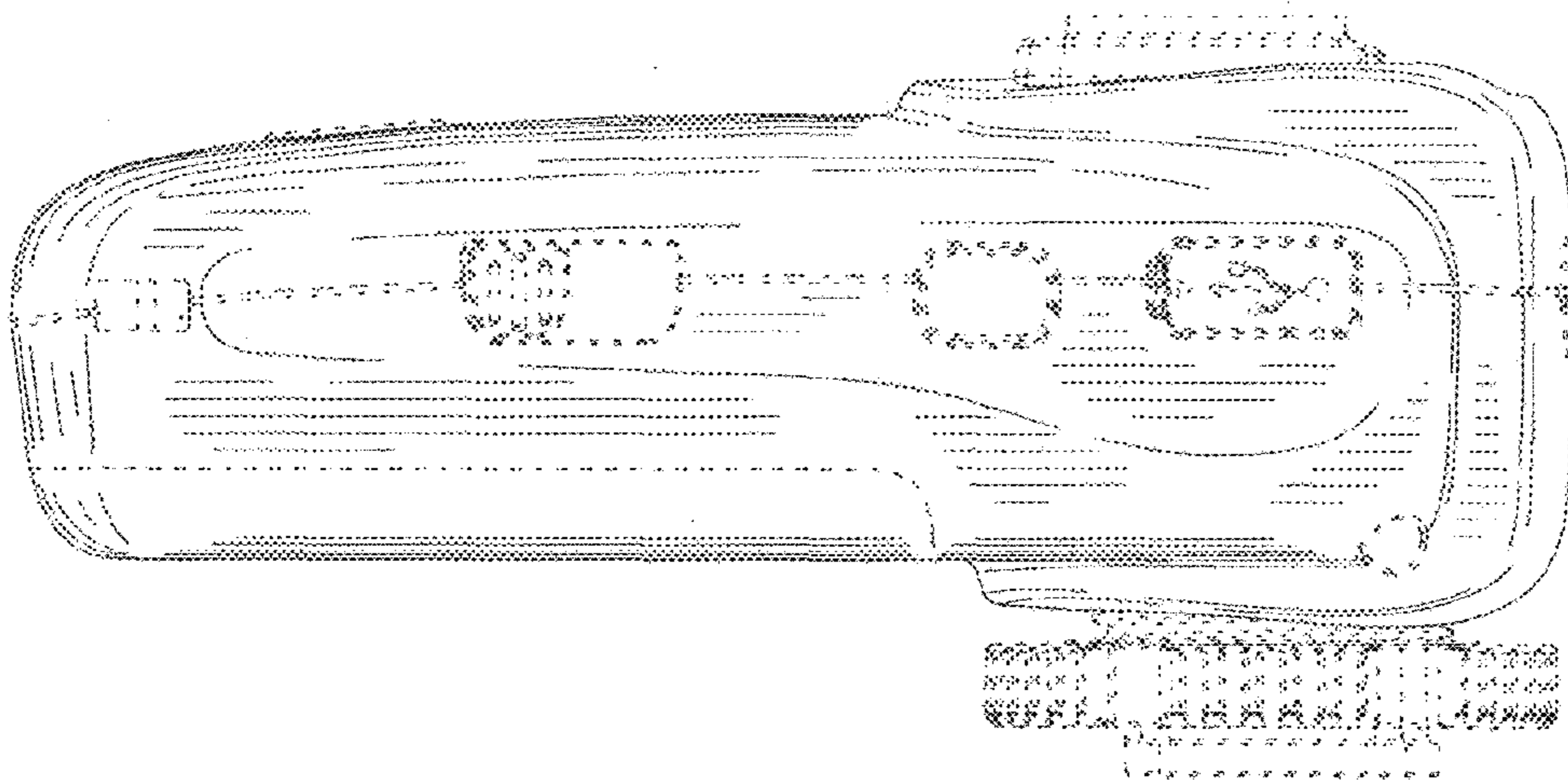

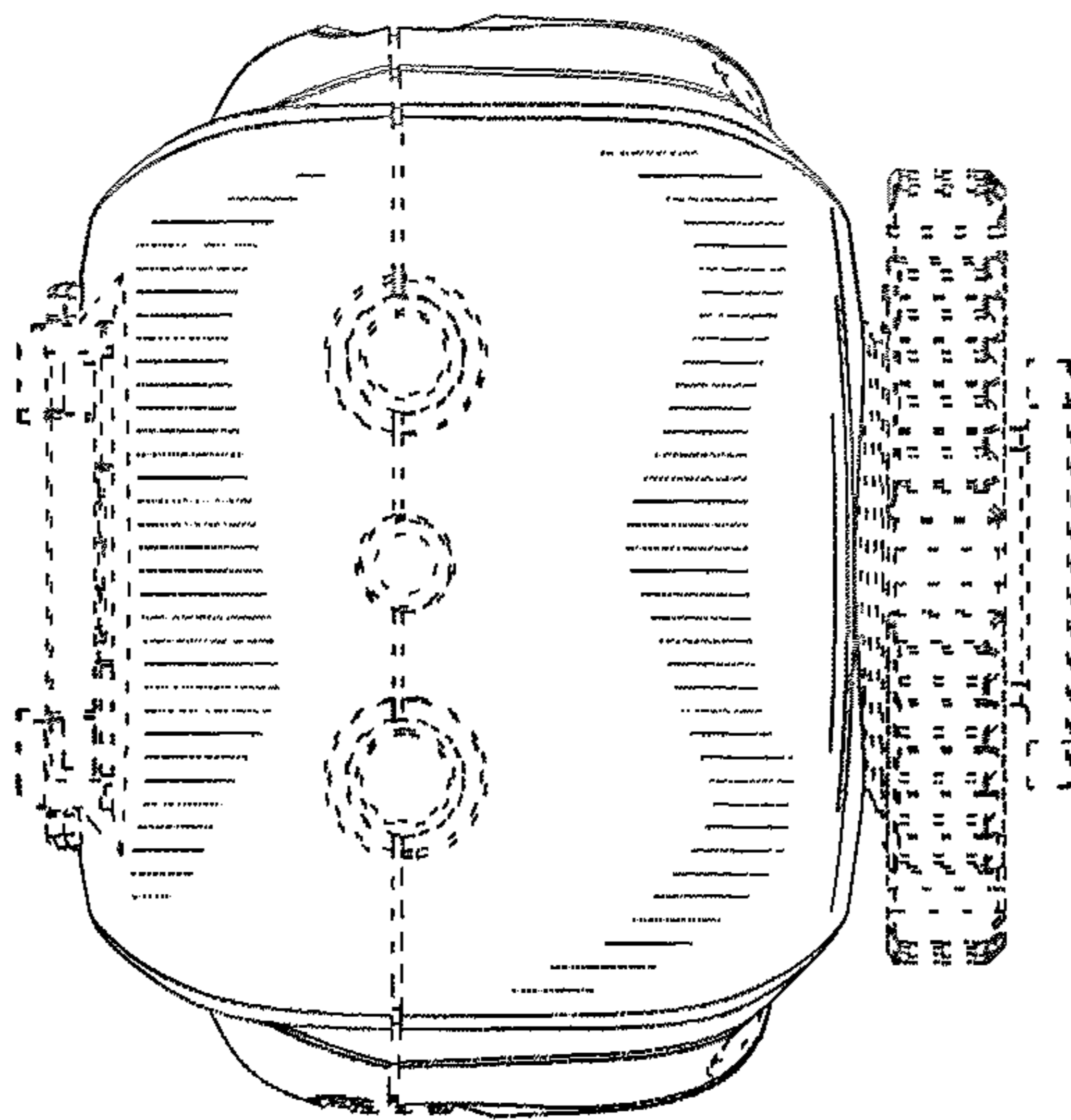

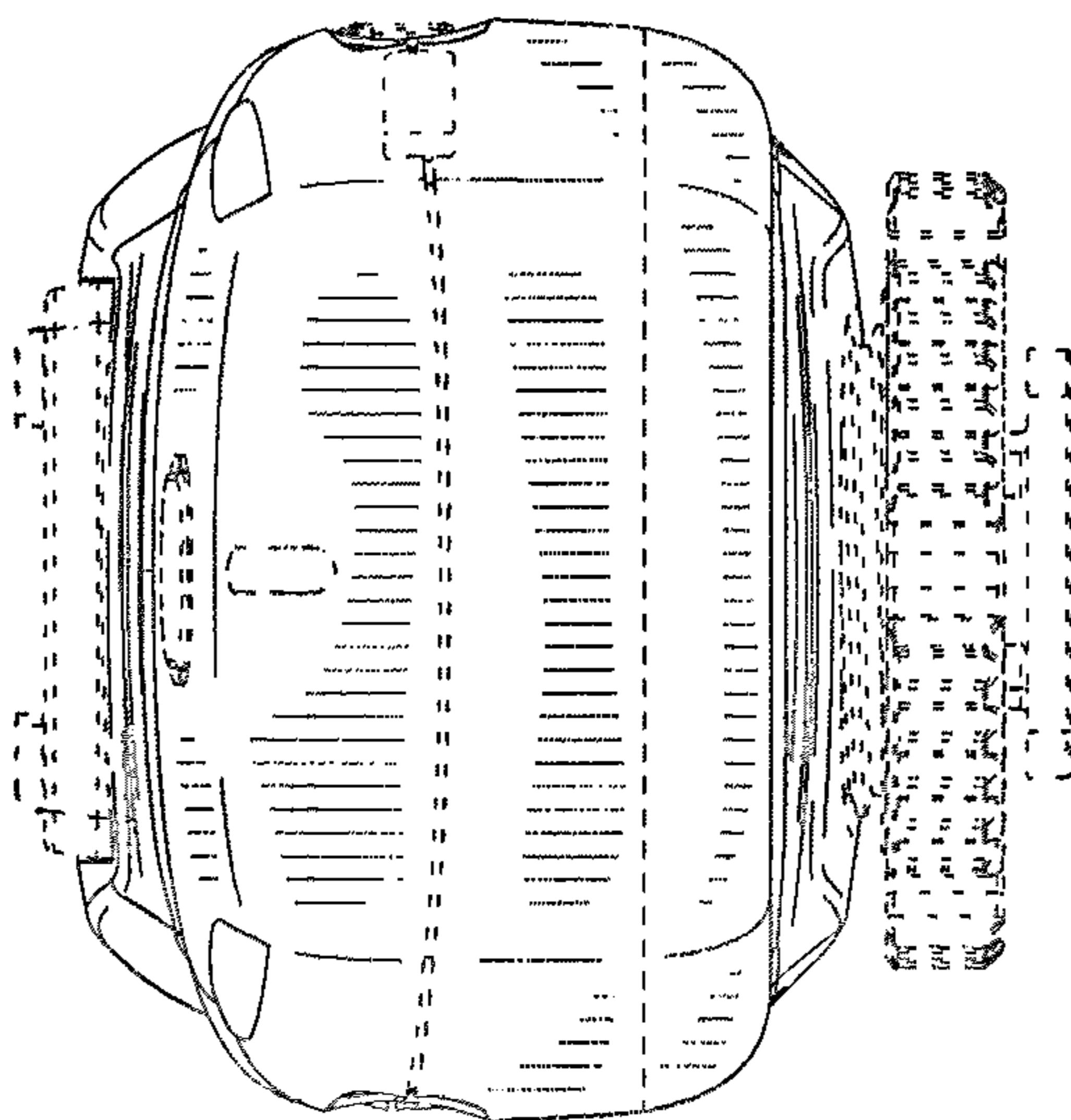
