**DESCRIPTION**

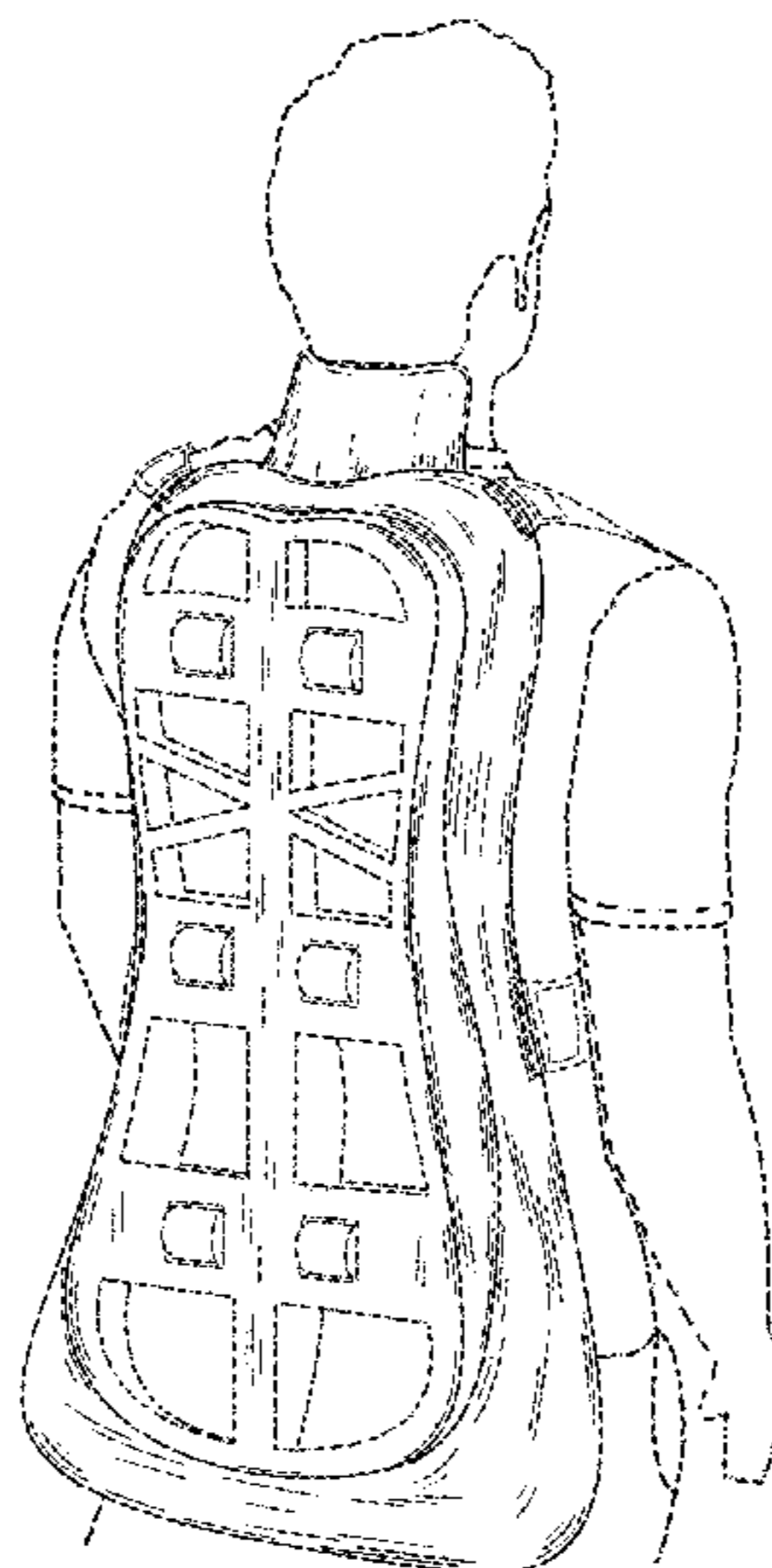

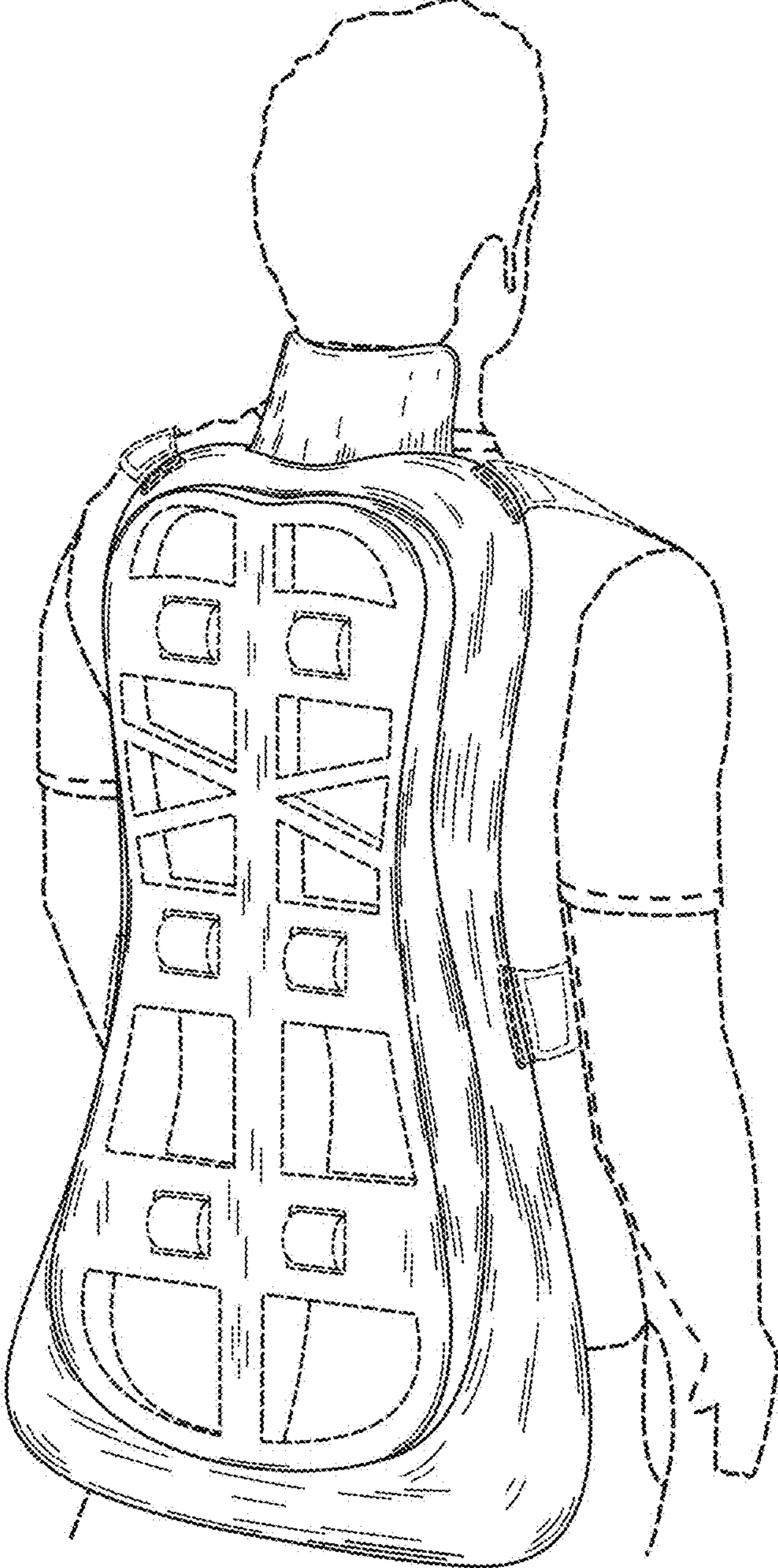

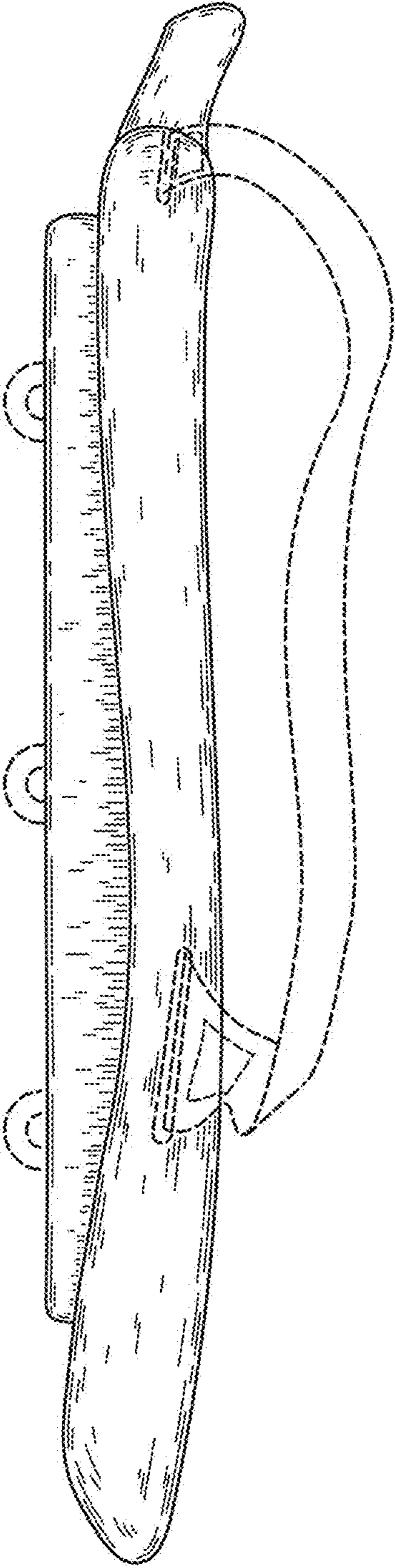

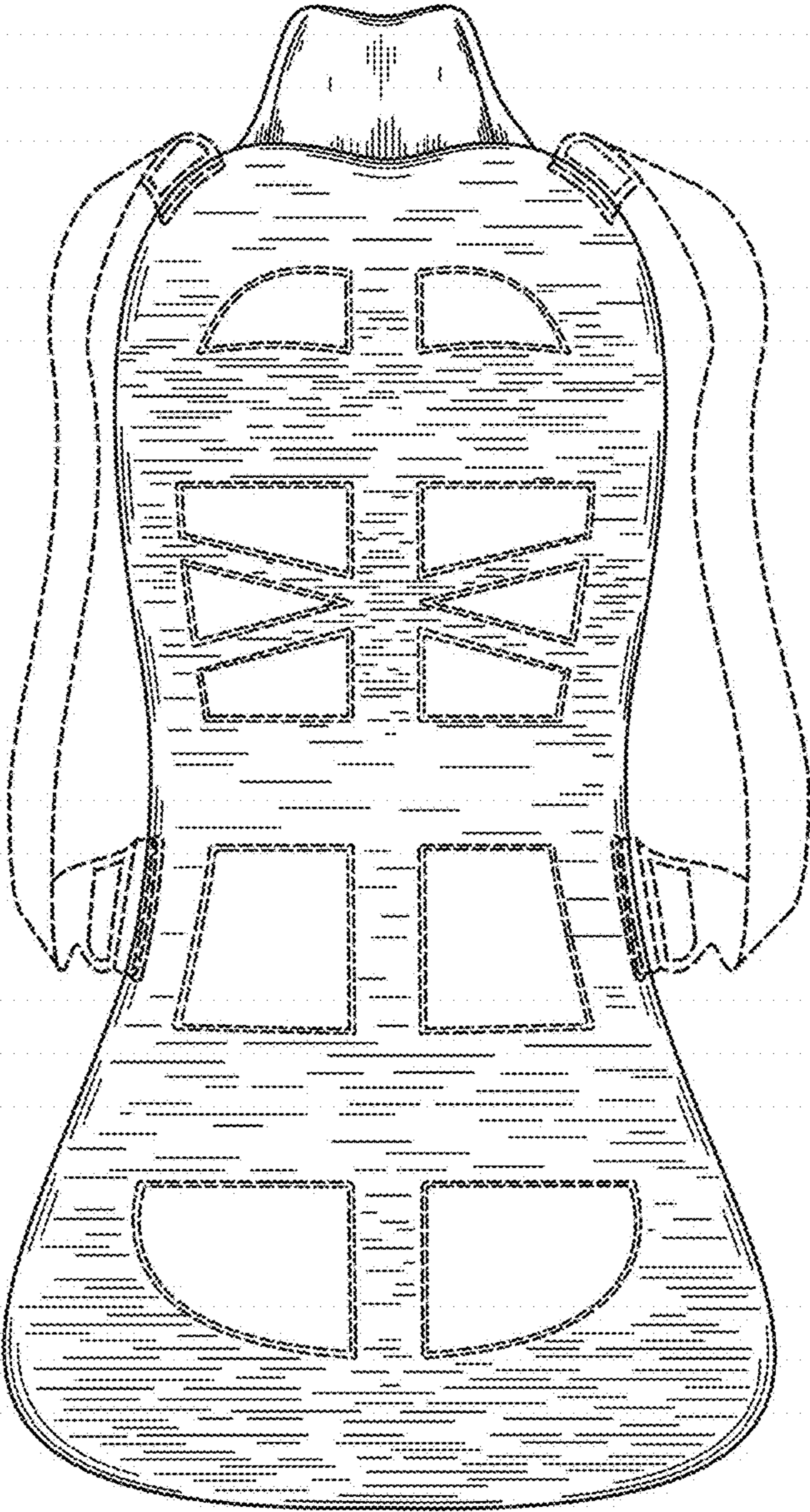

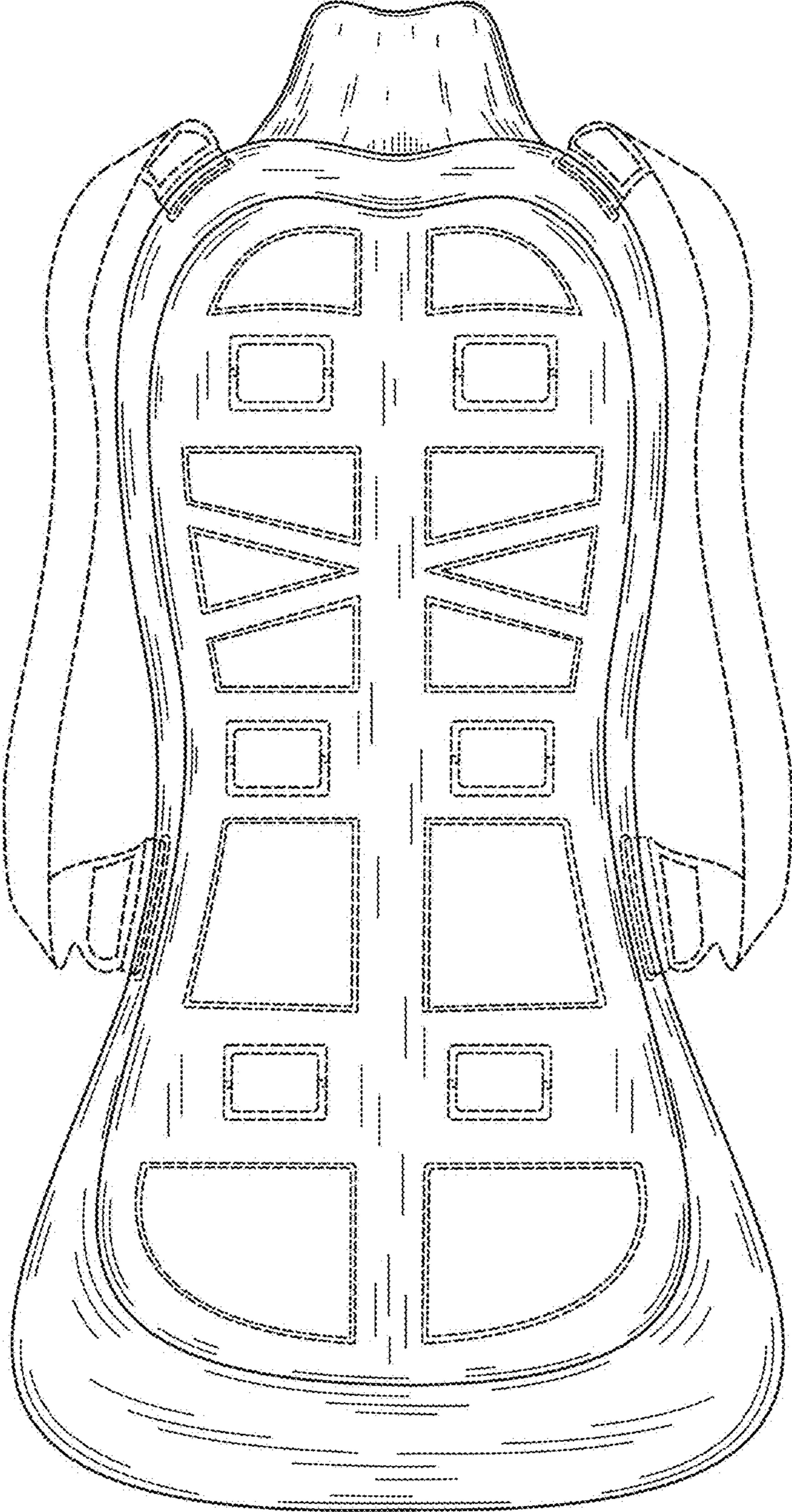




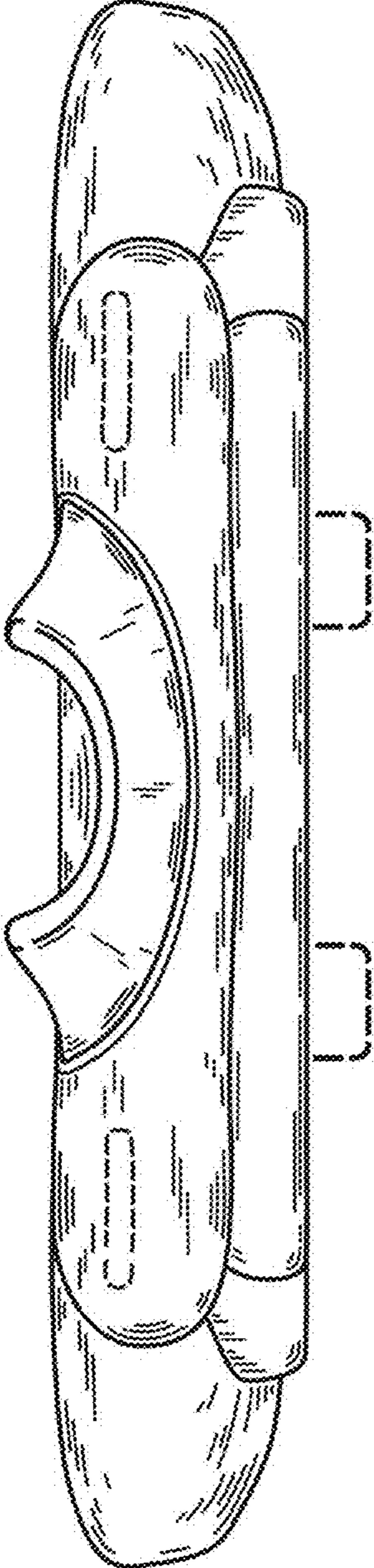
