FIG. 4 illustrates a side view thereof;

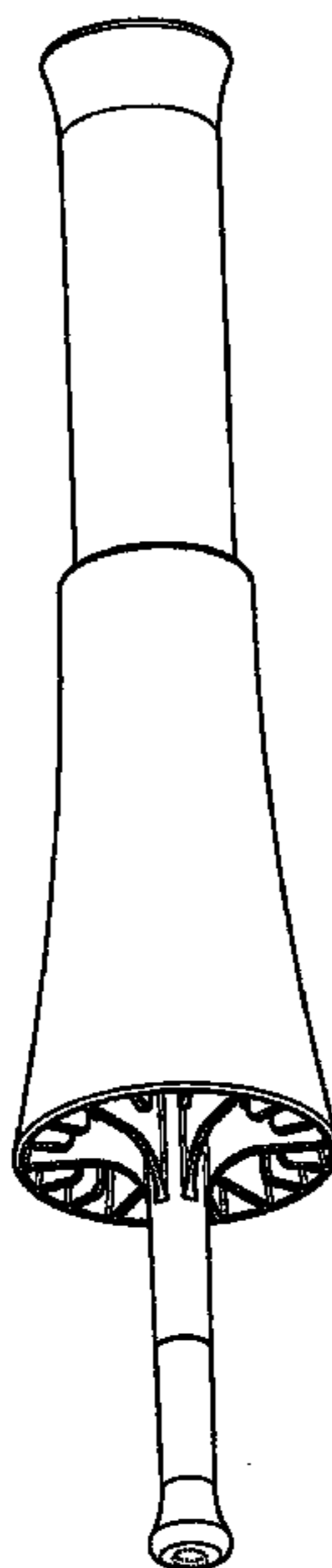
FIG. 5 illustrates a side view thereof;

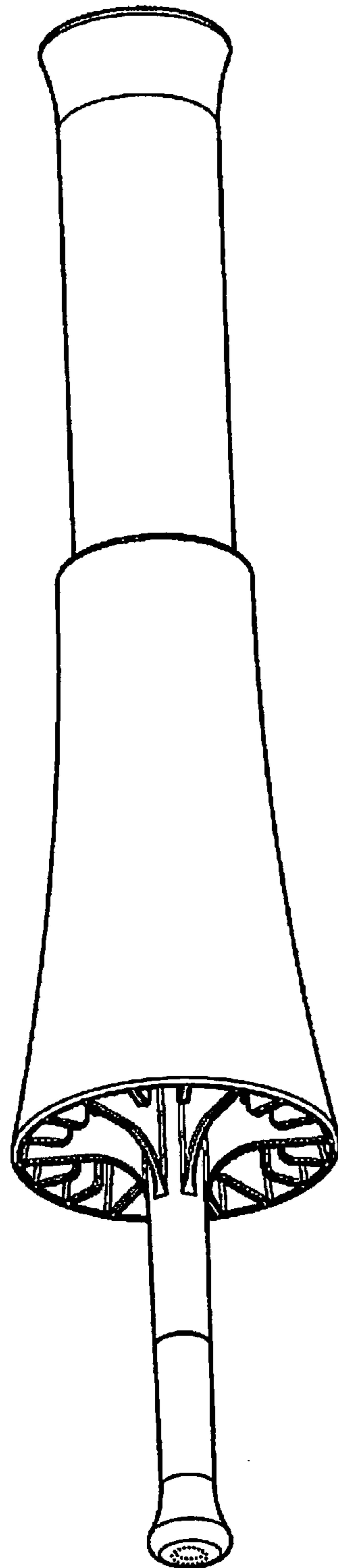

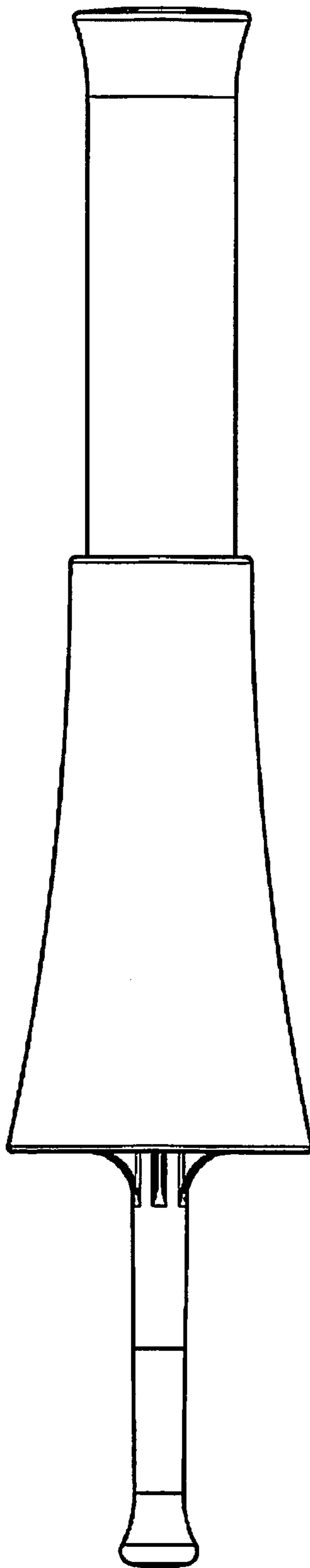

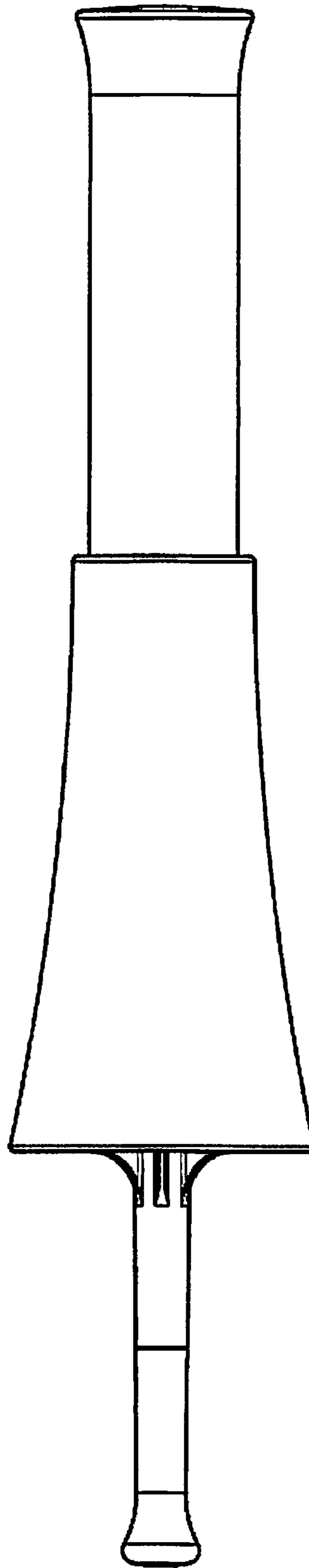

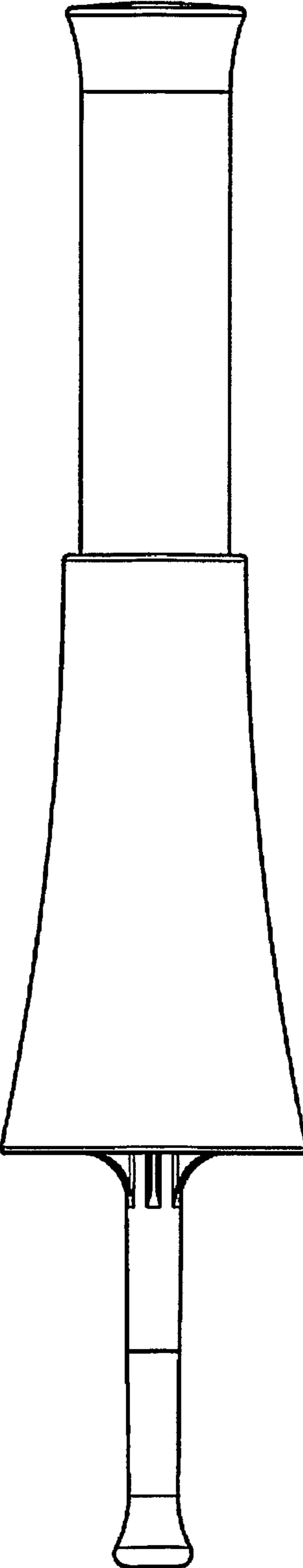

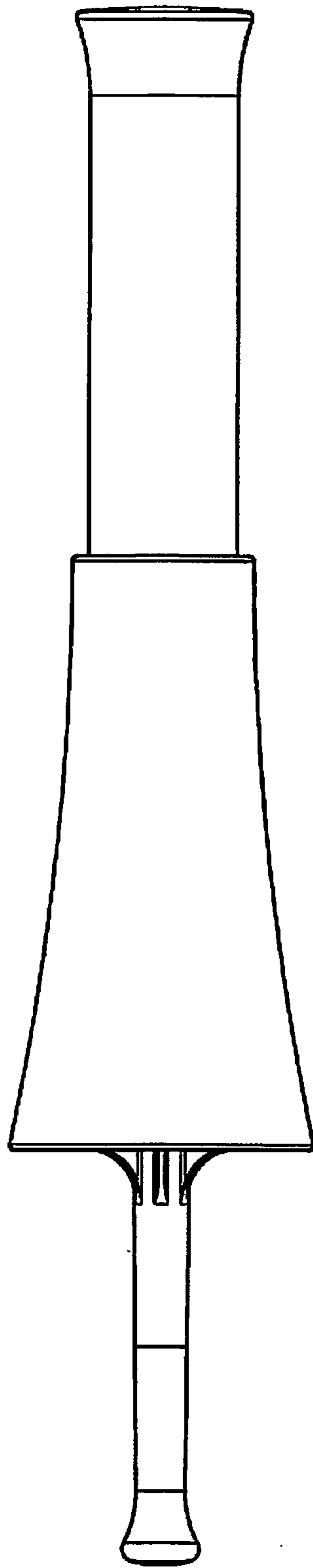

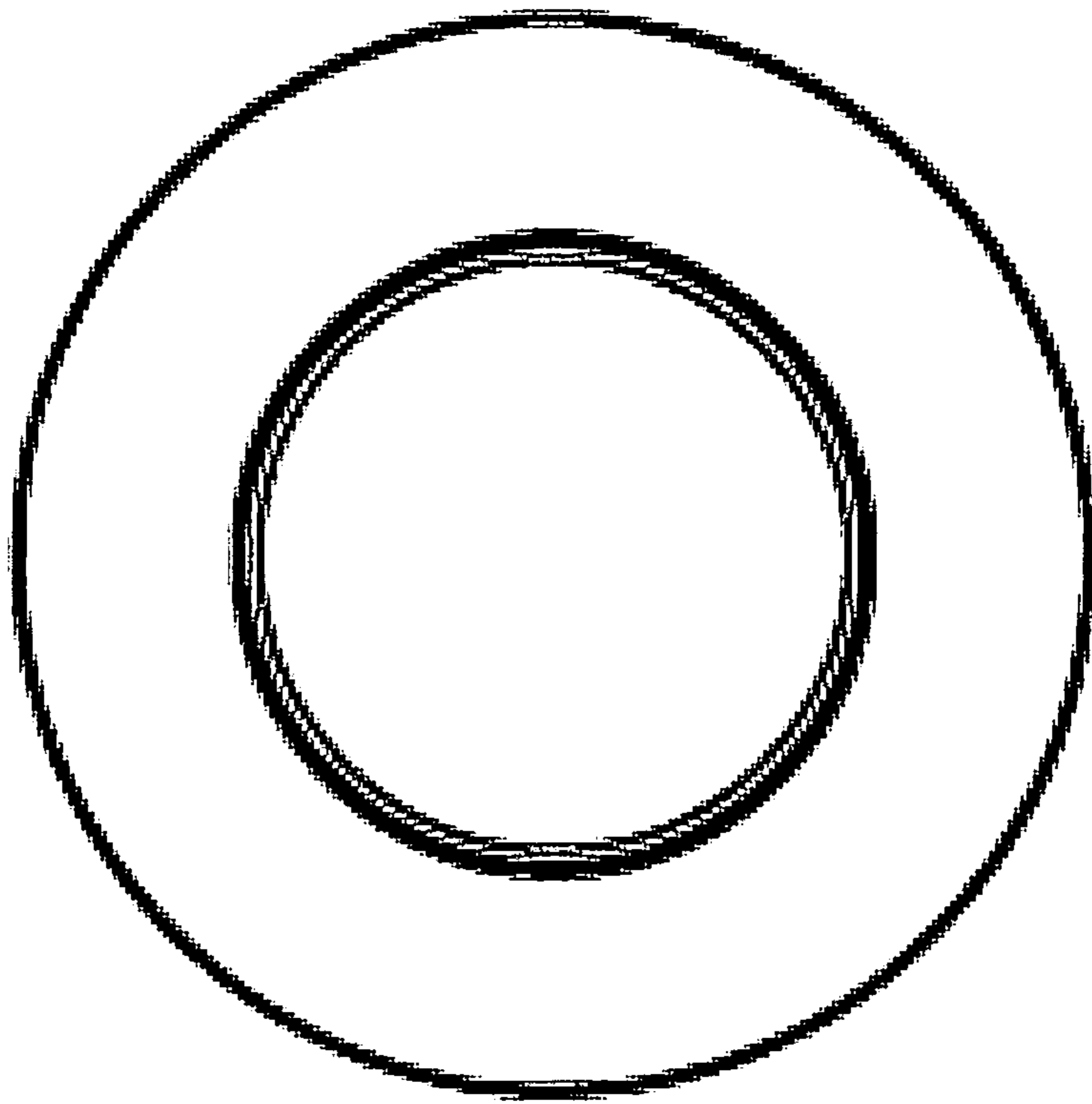

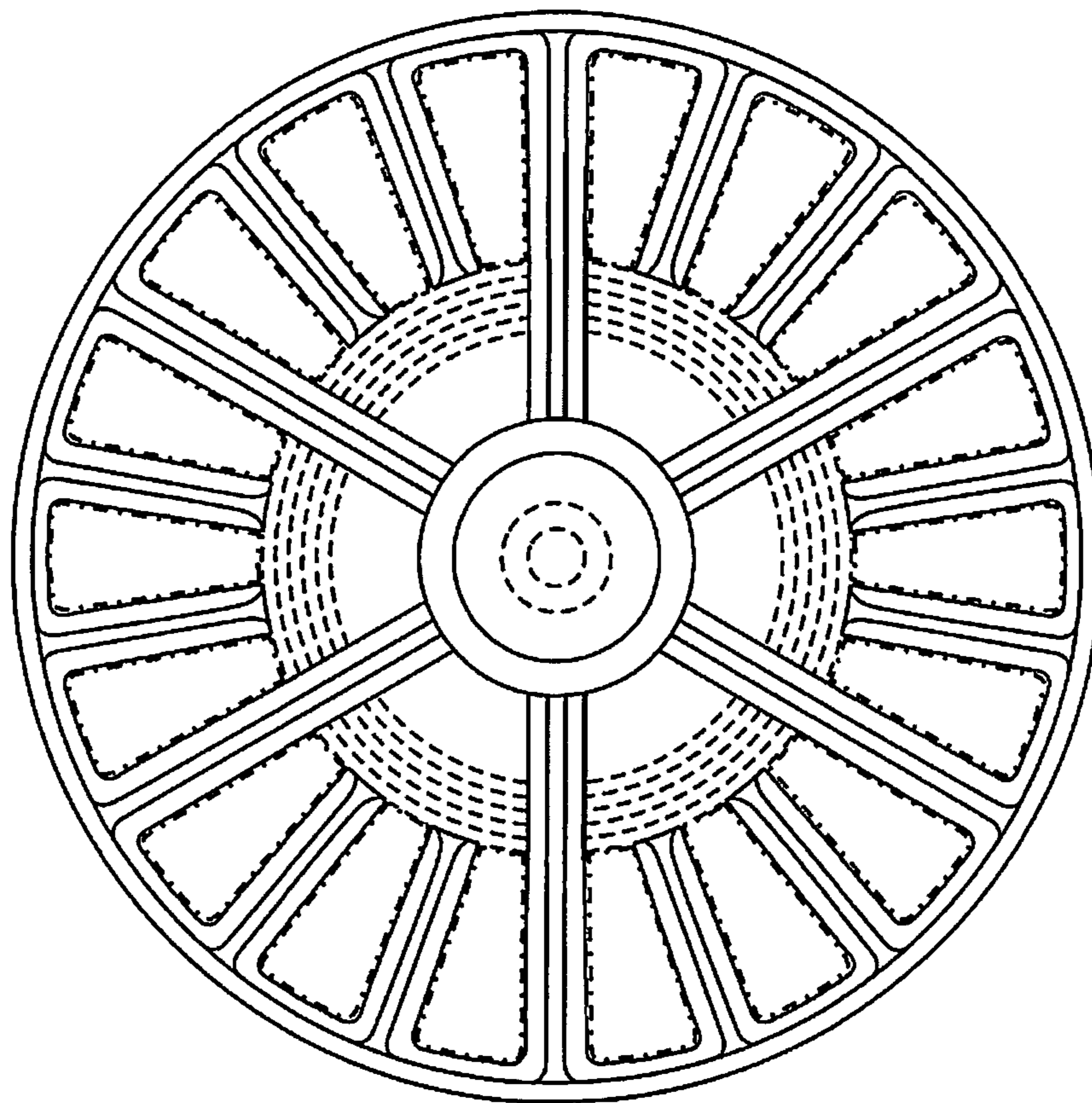
