(57) **CLAIM**

The ornamental design for a medicine applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the medicine applicator of the present invention with a medicine bottle, and with the lid on the applicator.

FIG. 2 is a perspective view of the medicine applicator of FIG. 1 with the lid removed.

FIG. 3 is a front view of the medicine applicator of FIG. 1.

FIG. 4 is a rear view of the medicine applicator of FIG. 1.

FIG. 5 is a left side view of the medicine applicator of FIG. 1.

FIG. 6 is a right side view of the medicine applicator of the present invention with a medicine bottle.

FIG. 7 is a top view of the medicine applicator of FIG. 1.

FIG. 8 is a bottom view of the medicine applicator of FIG. 1 with a medicine bottle.

FIG. 9 is a bottom view of the medicine application of the present invention without a bottle.

FIG. 10 is a top view of the medicine applicator of FIG. 1 without the lid.

FIG. 11 is a perspective view of a second embodiment of the medicine applicator of the present invention with a medicine bottle.

FIG. 12 is a perspective view of the medicine applicator of FIG. 11 with the lid removed.

FIG. 13 is a front view of of the medicine applicator of FIG. 11.

FIG. 14 is a rear view of the medicine applicator of FIG. 11. FIG. 15 is a left side view of the medicine applicator of FIG. 11.

FIG. 16 is a right side view of the medicine applicator of FIG. 11.

FIG. 17 is a top view of the medicine applicator of FIG. 11. FIG. 18 is a bottom view of the medicine applicator of FIG. 11 with a medicine bottle.

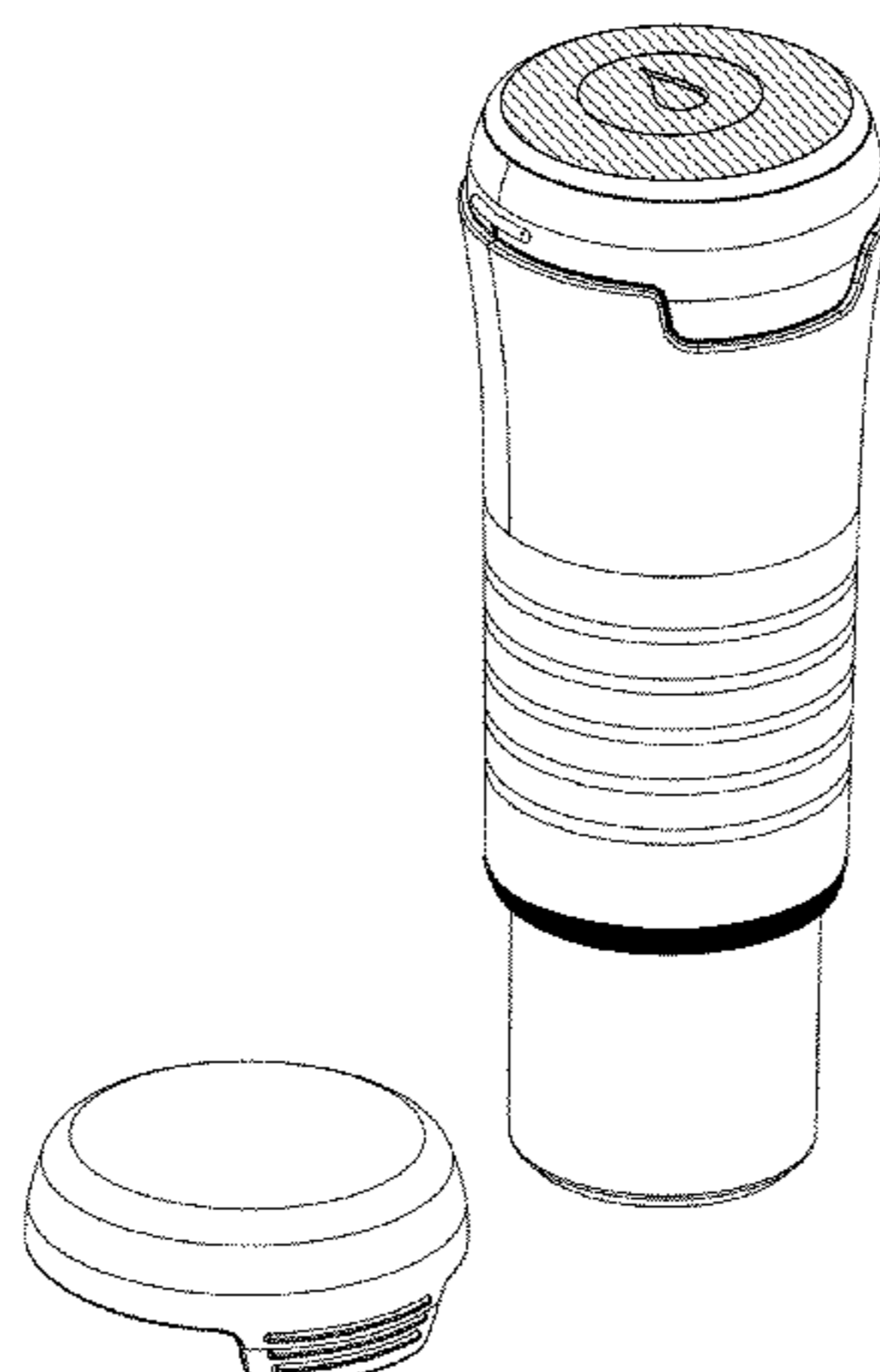
FIG. 19 is a bottom view of the medicine applicator of FIG. 11 without the medicine bottle.

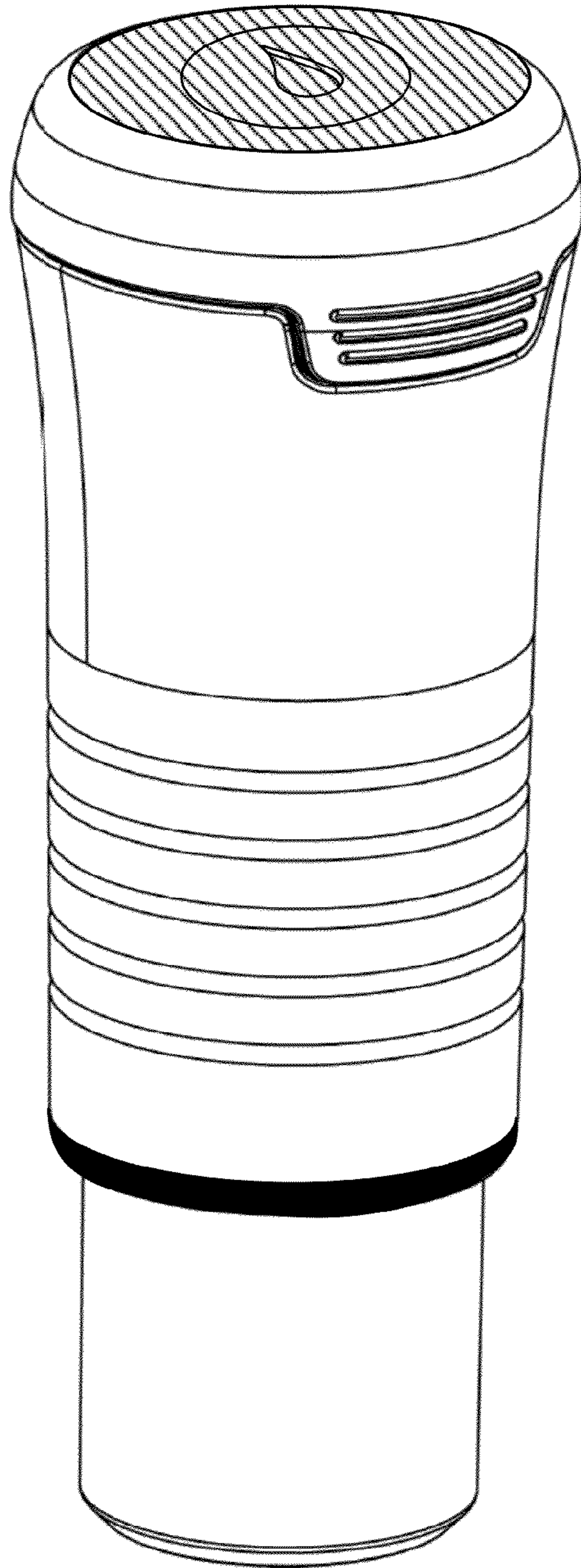

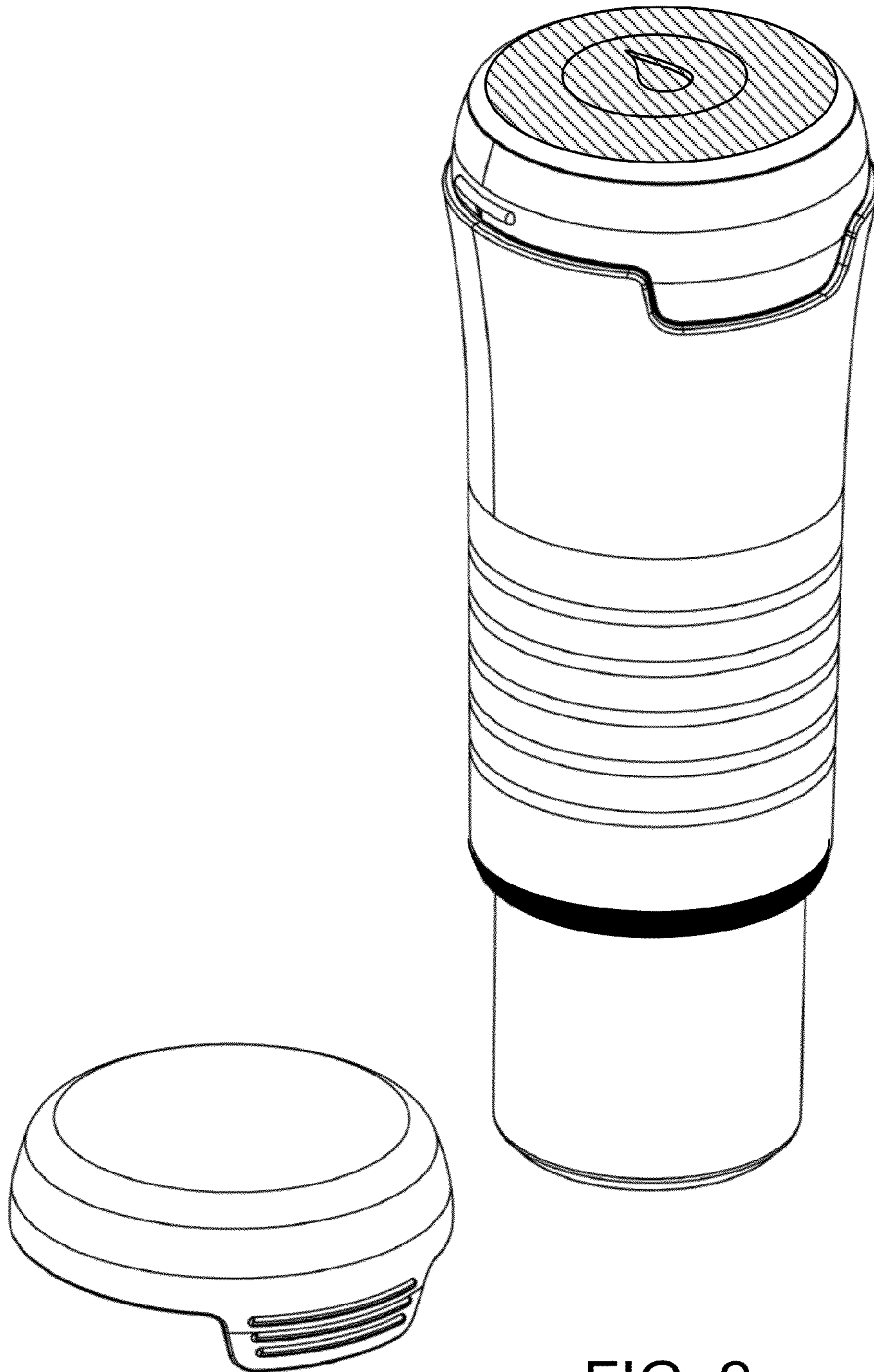

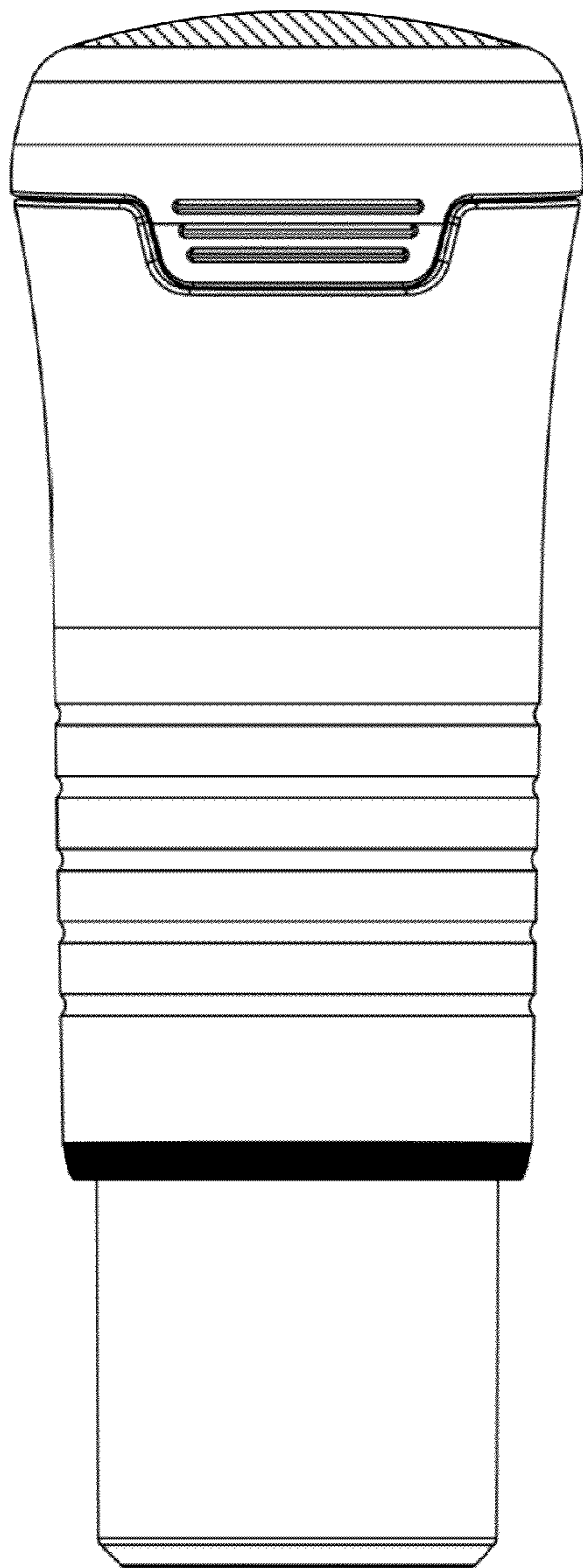

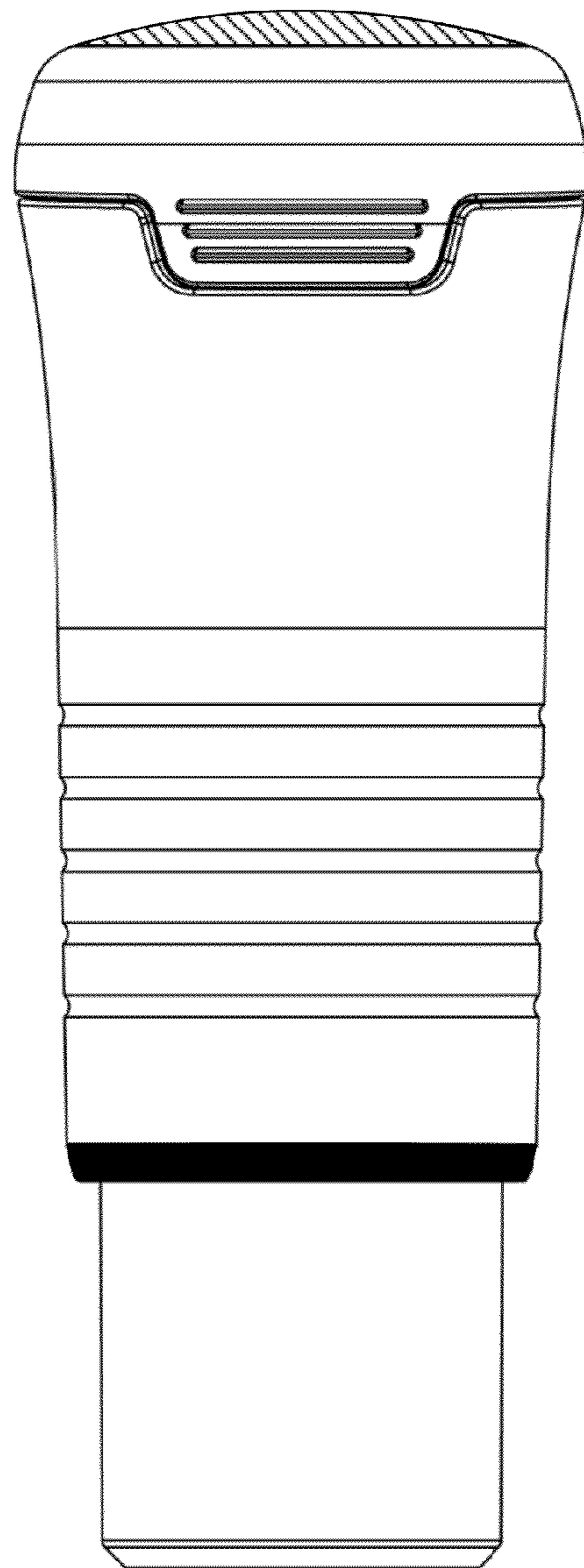

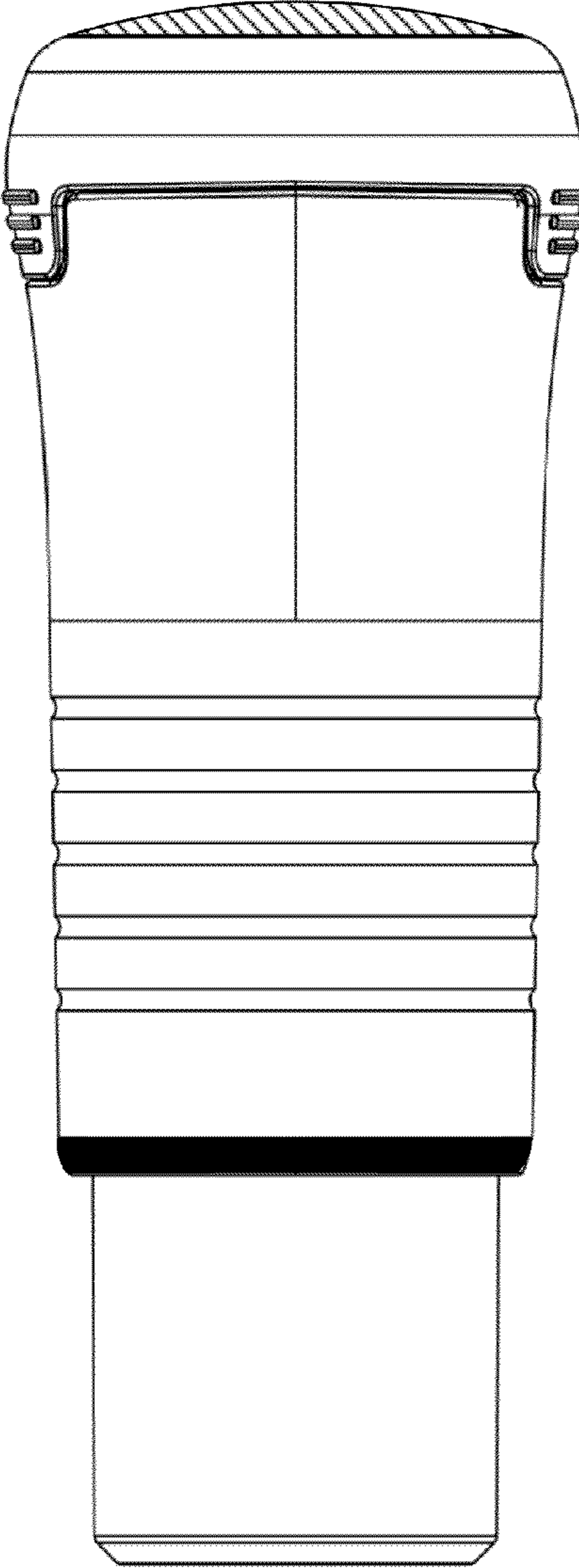

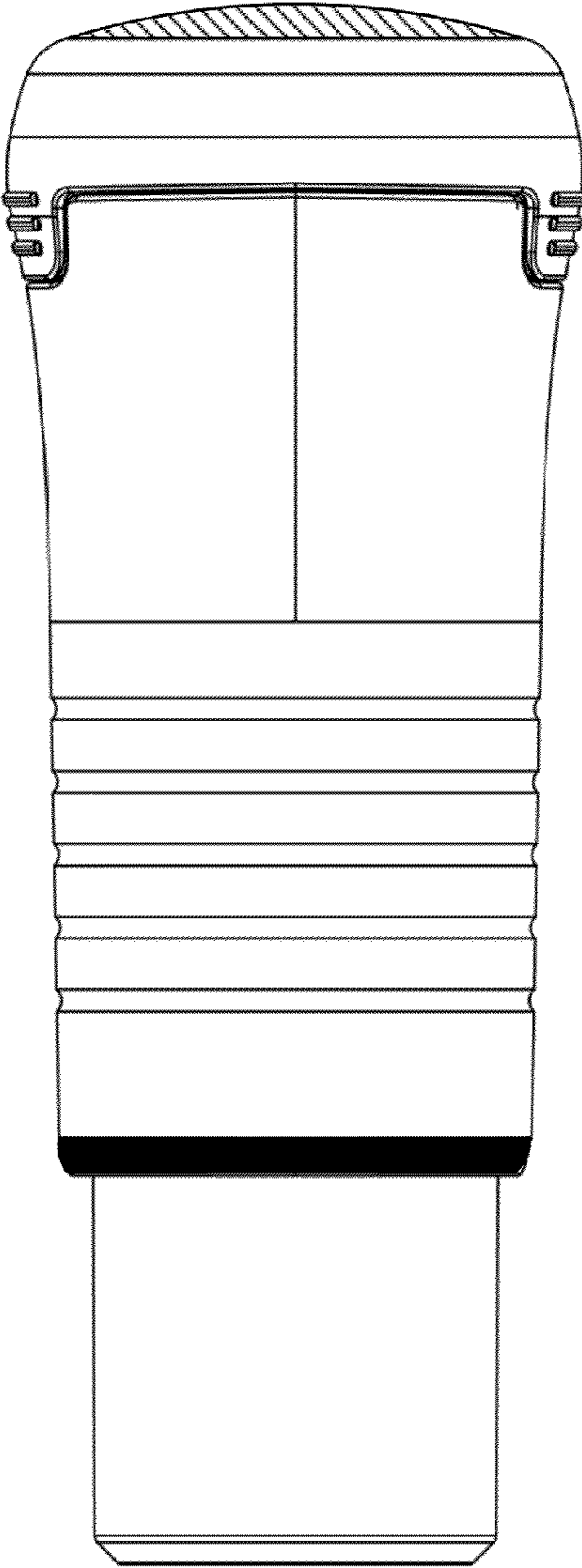

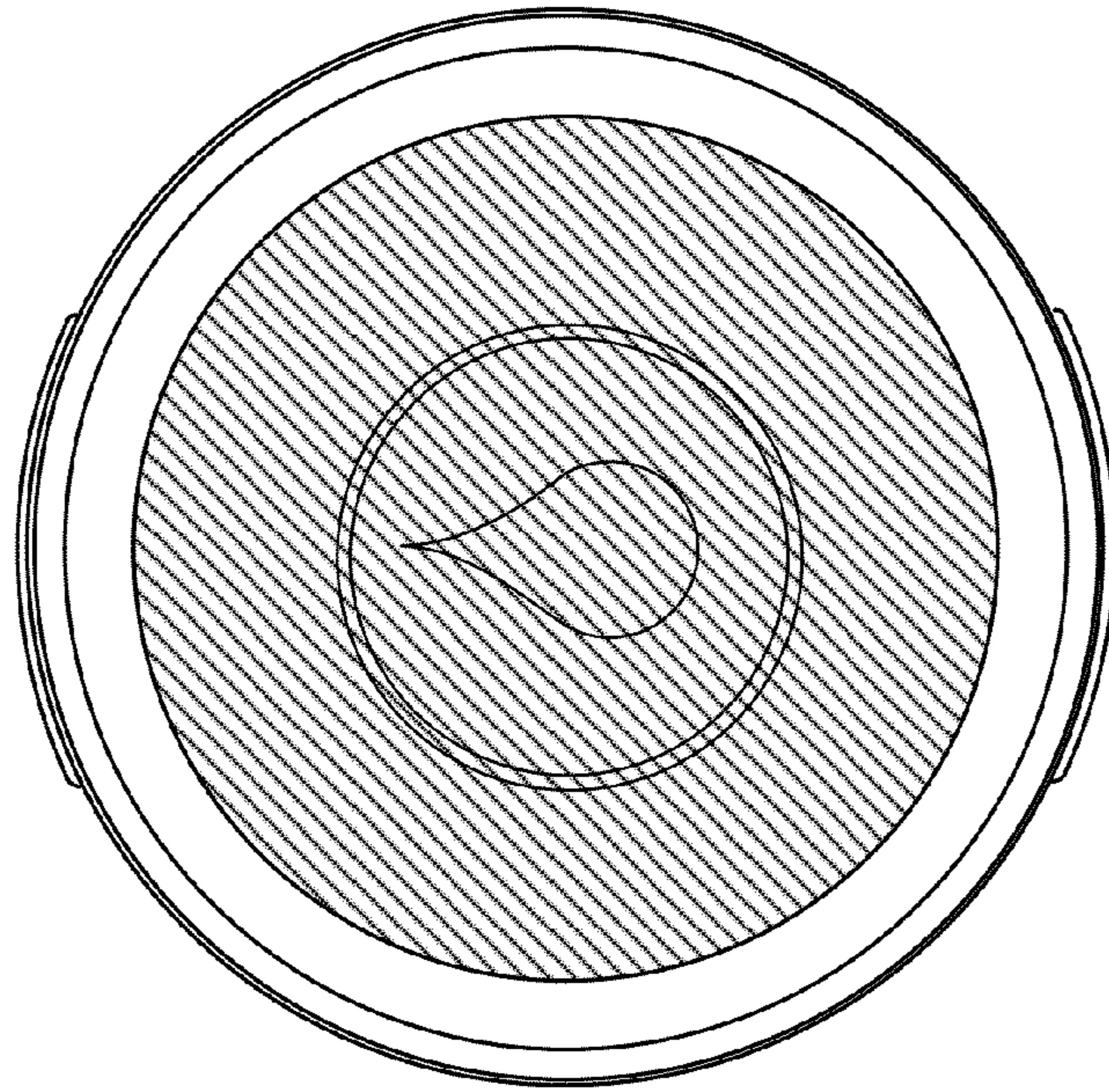

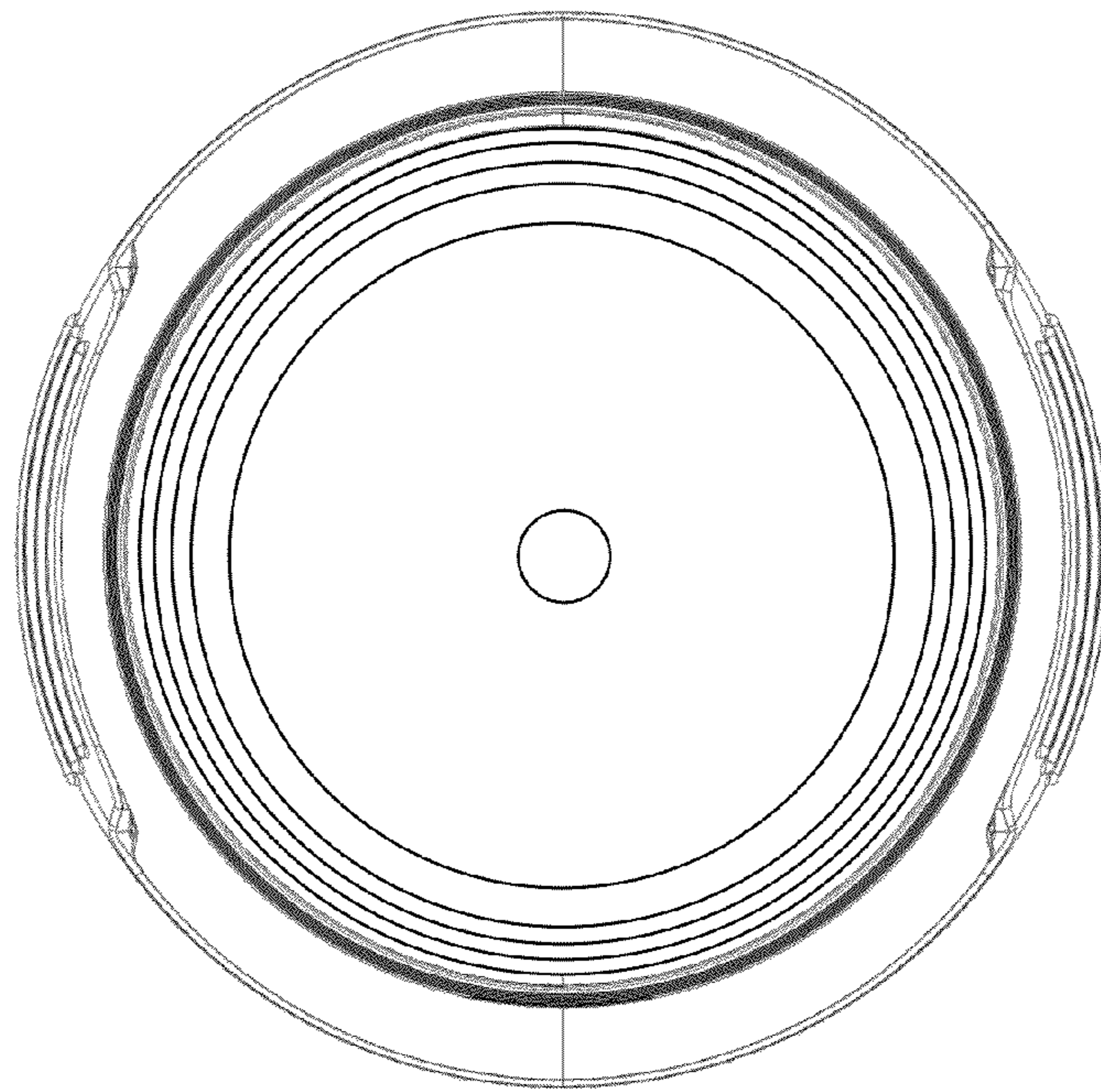

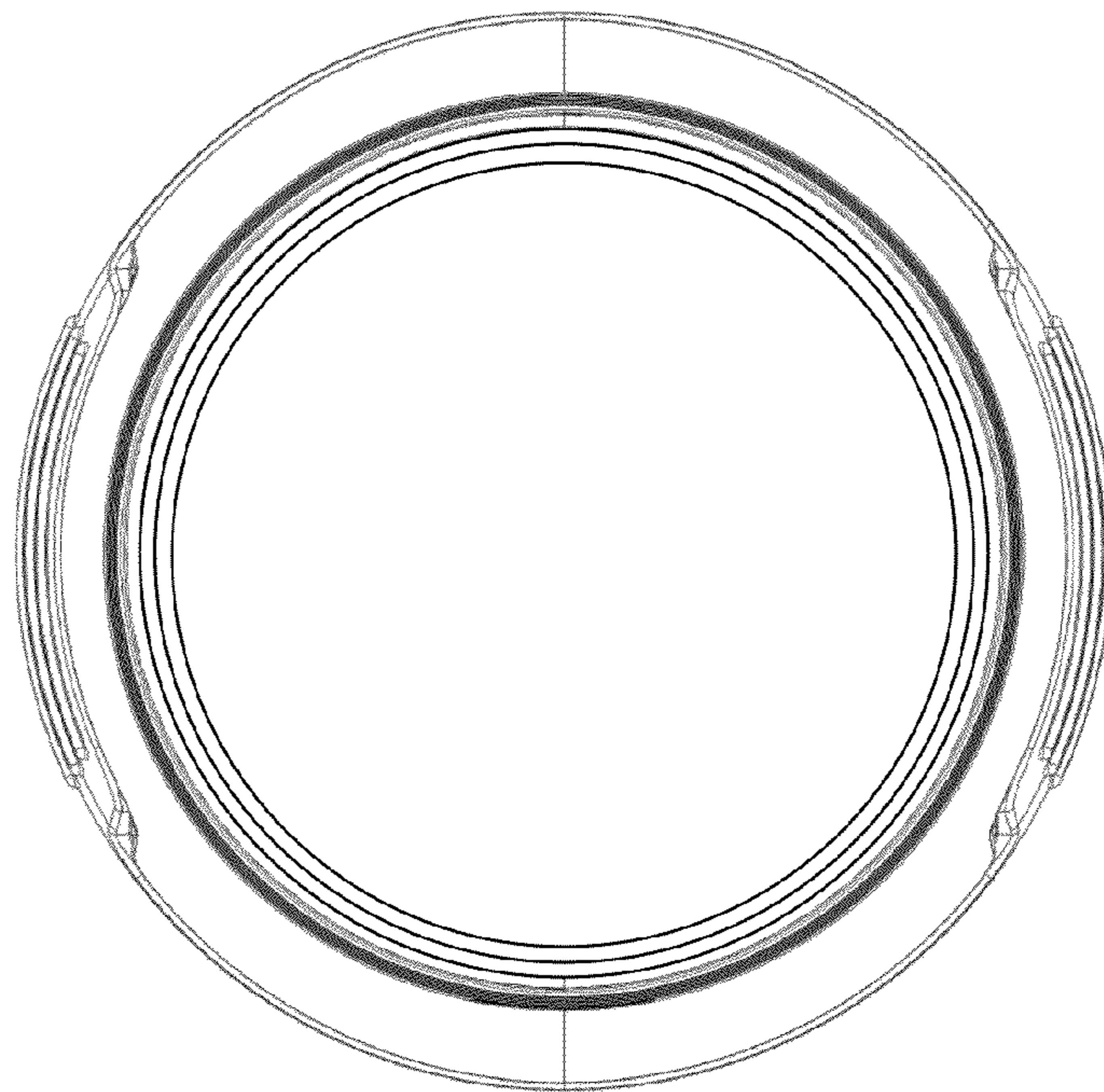

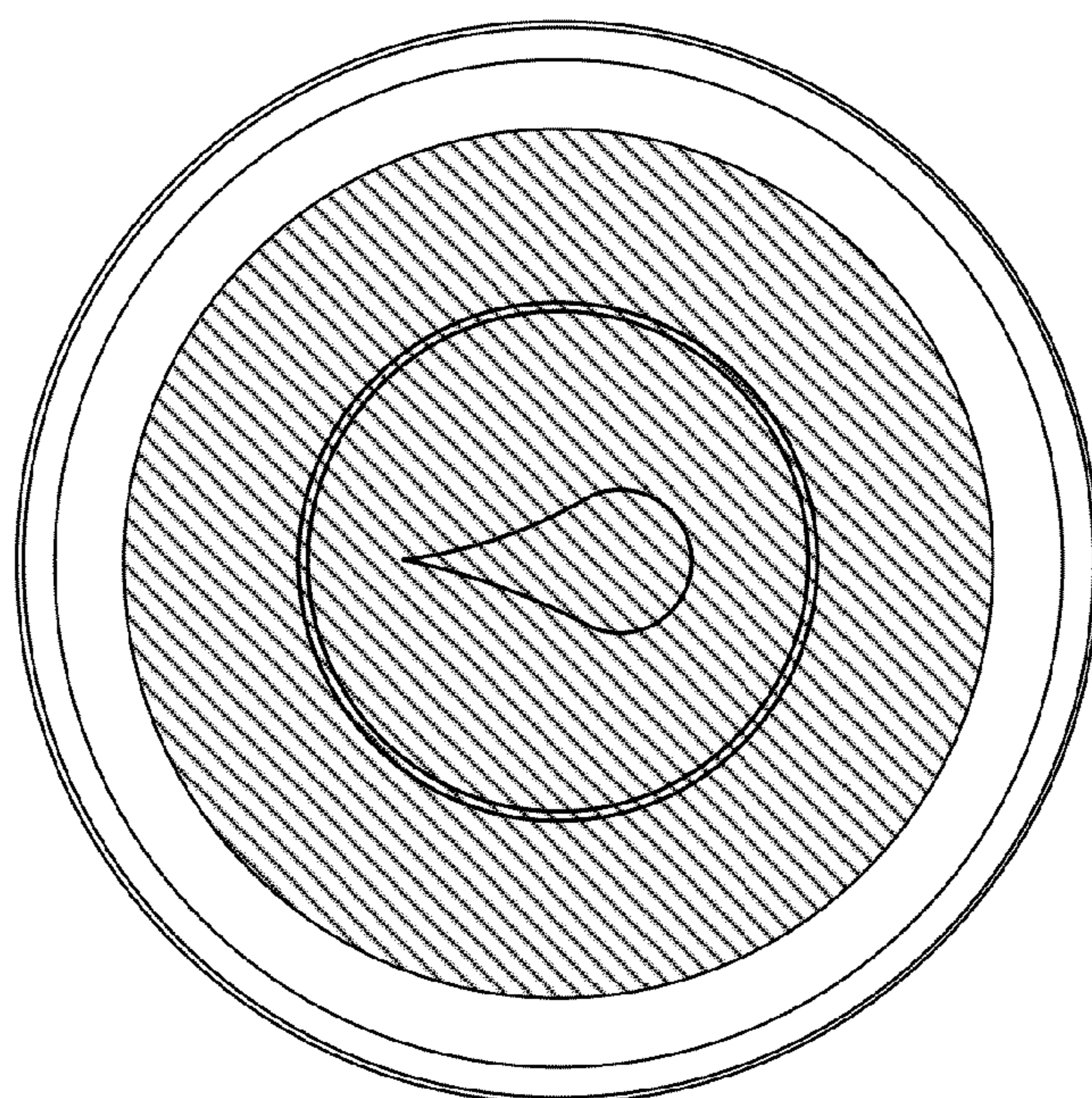

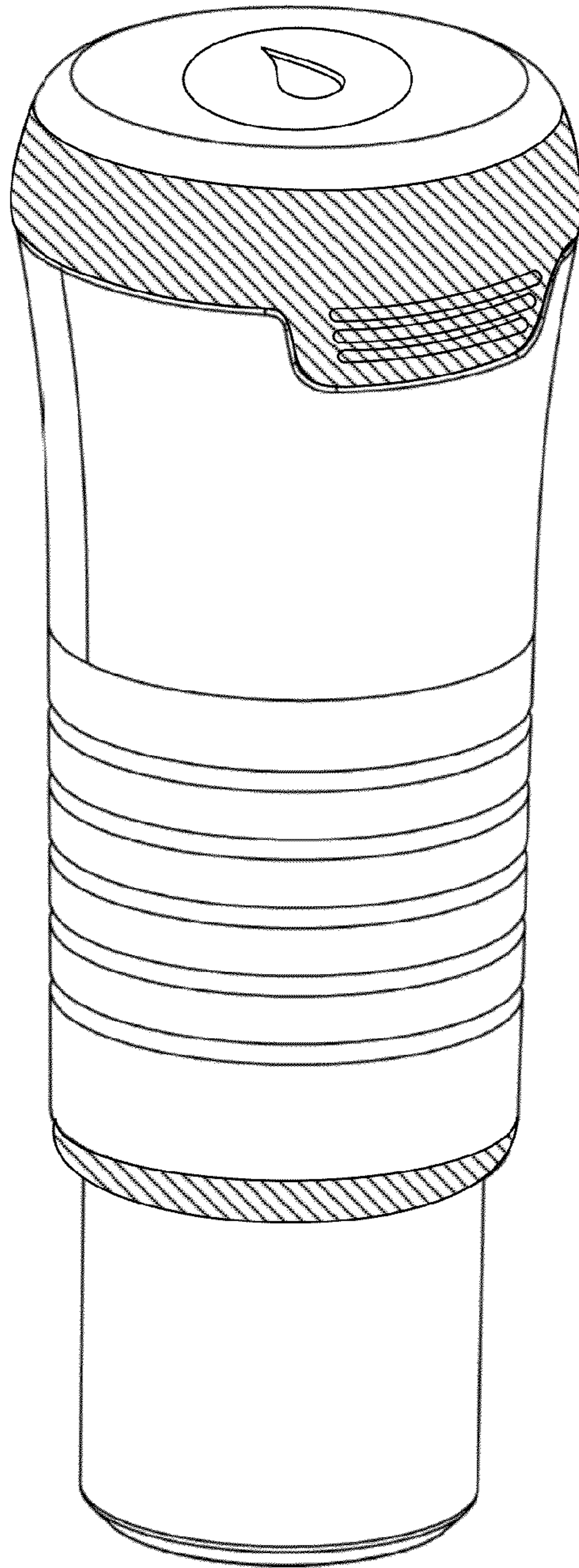

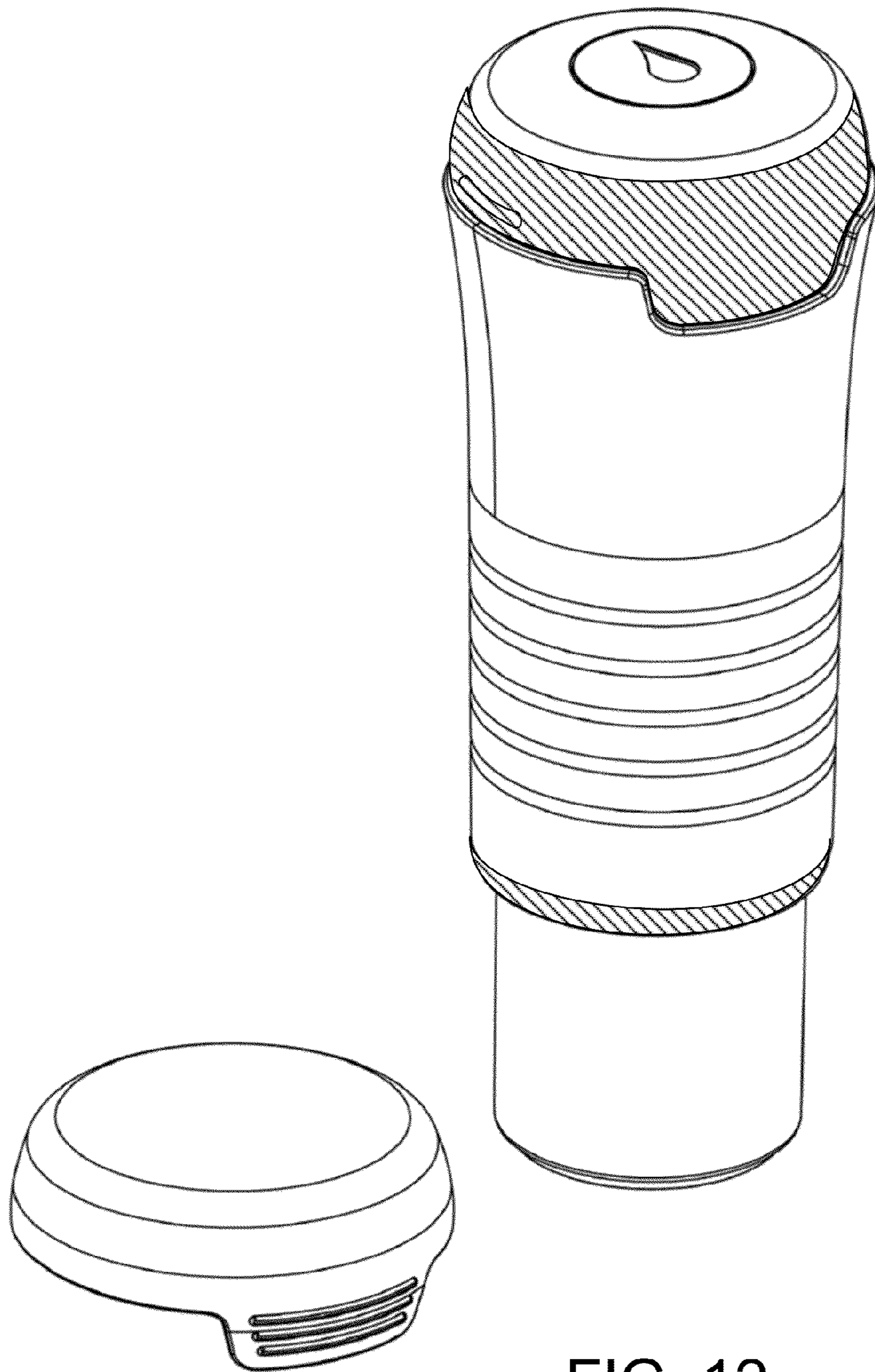

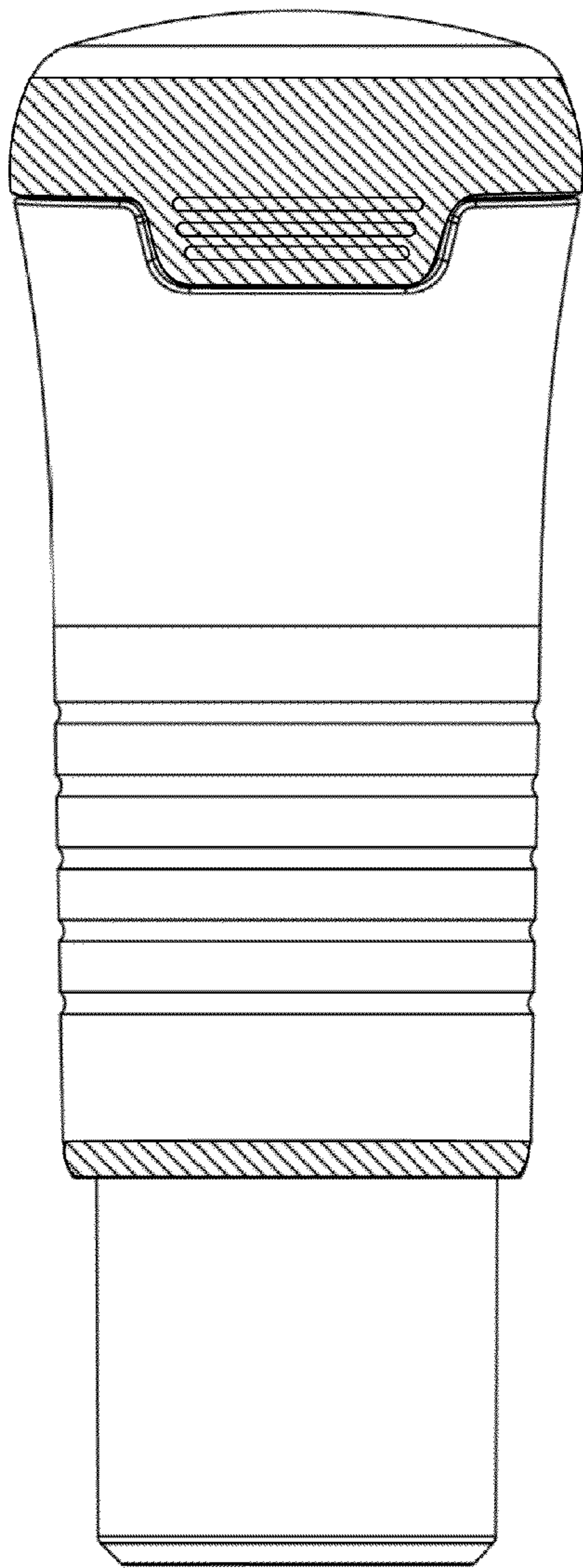

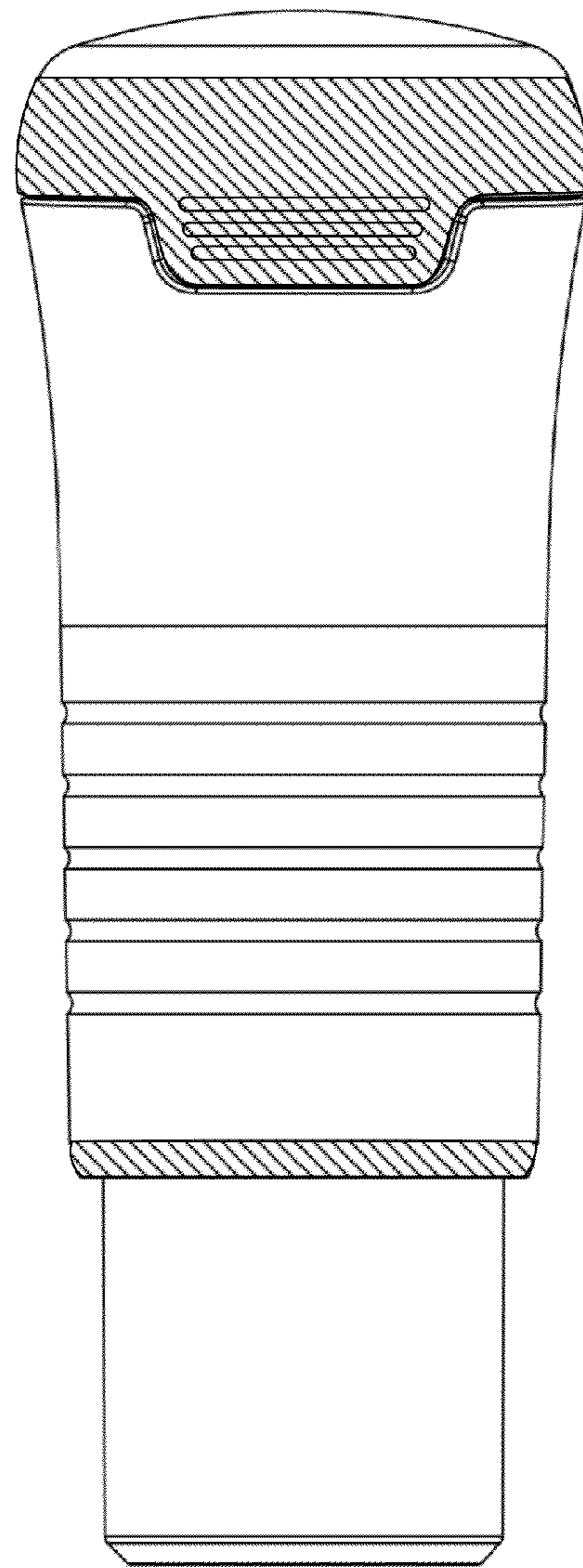

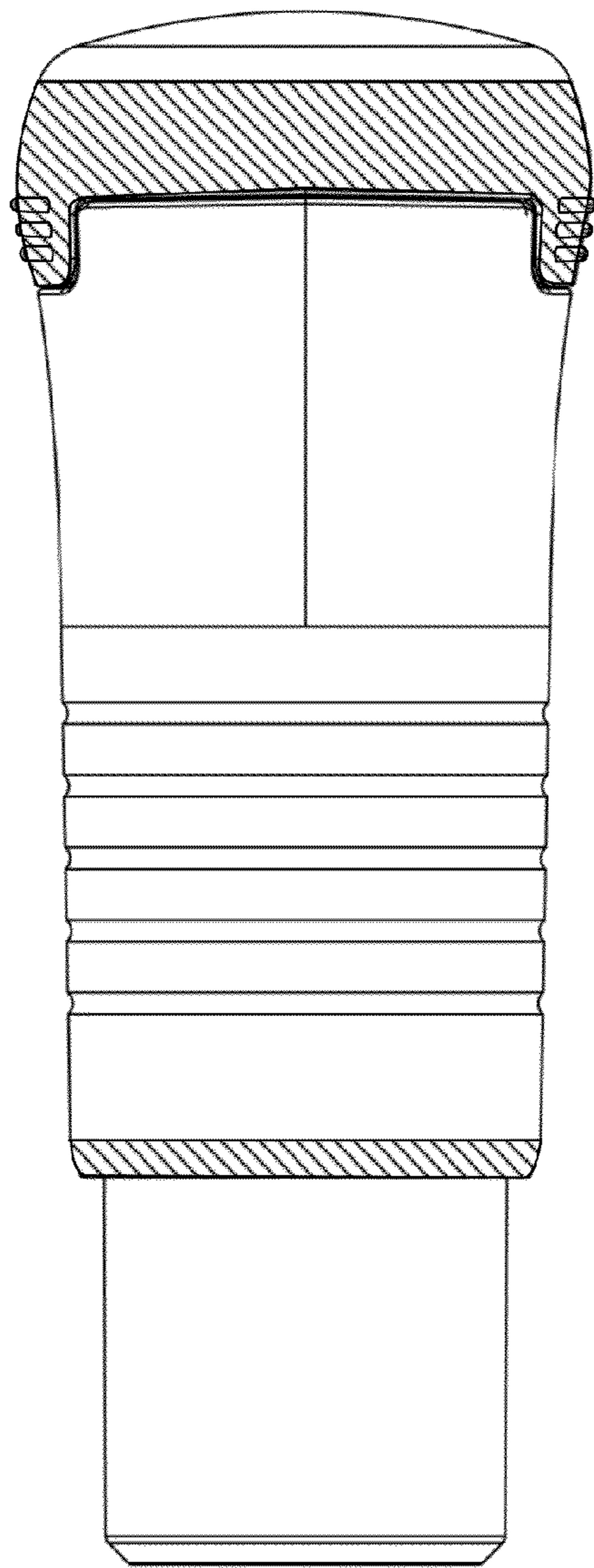

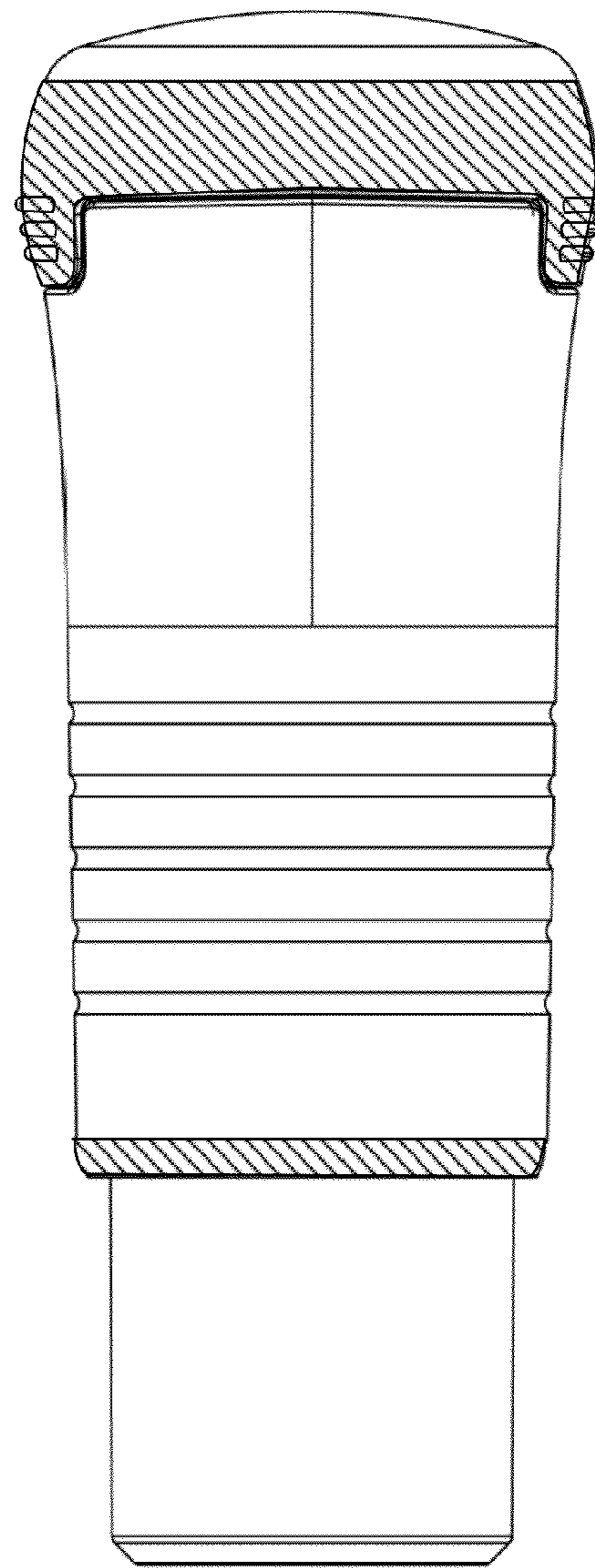

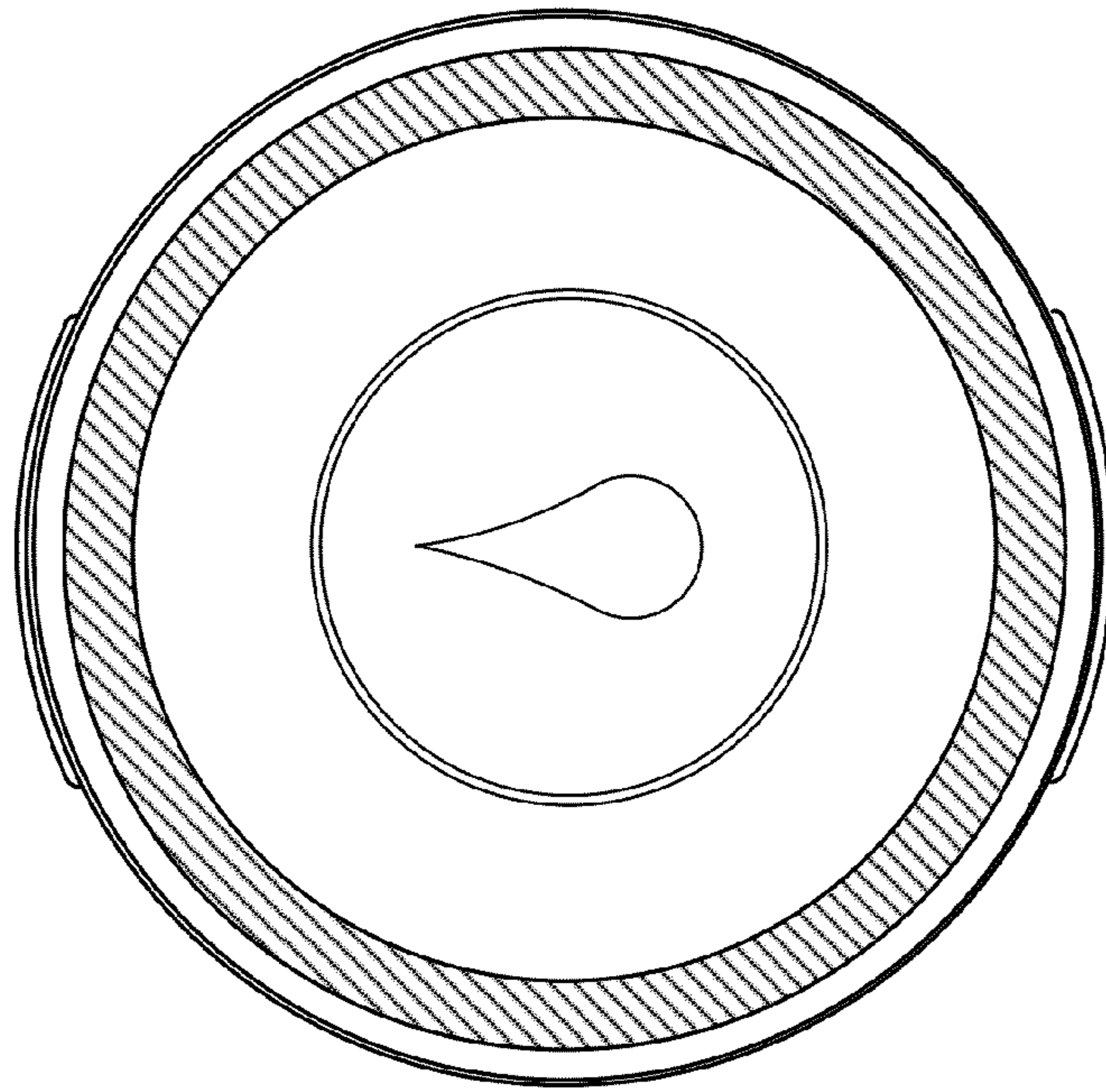

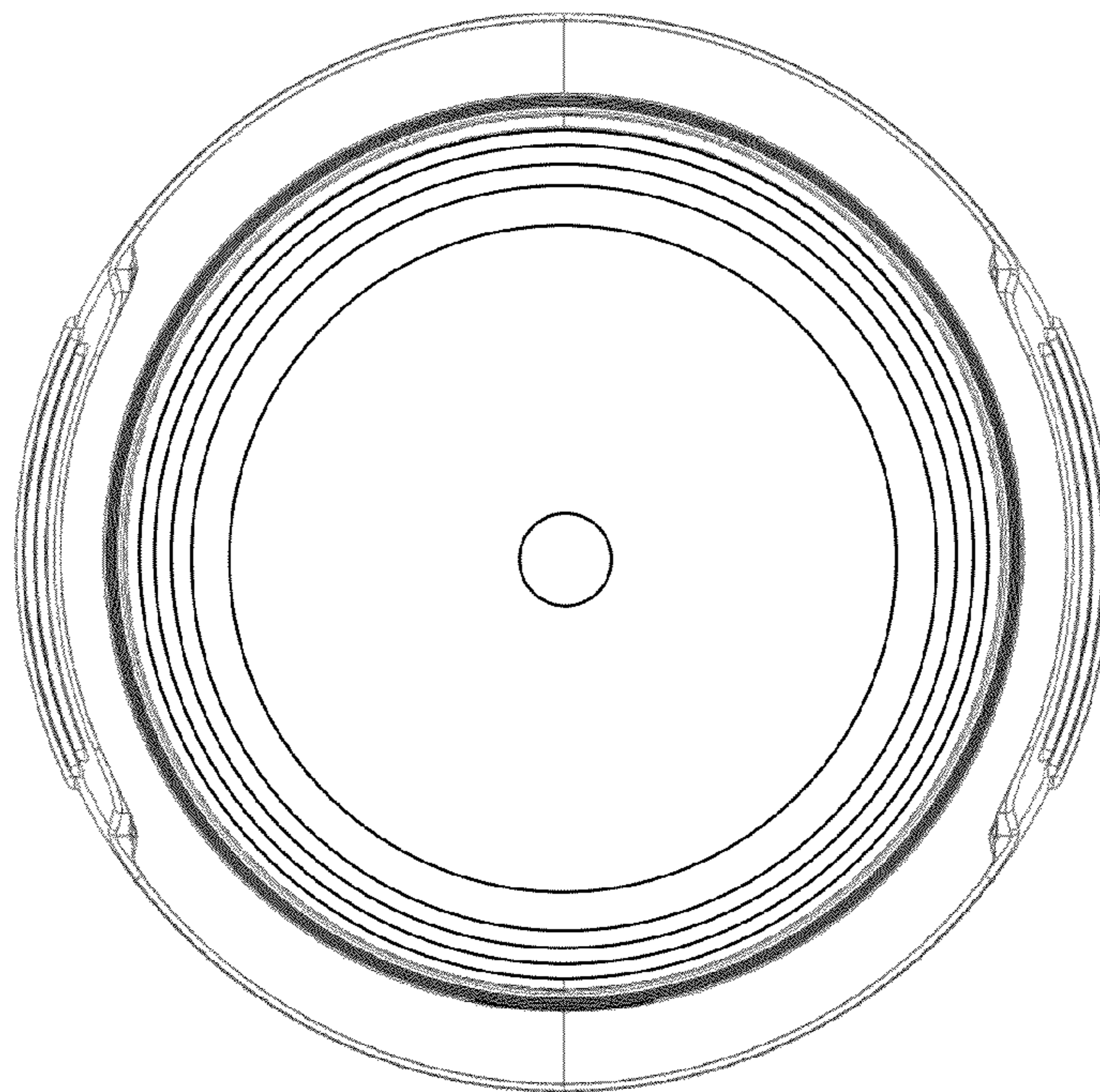

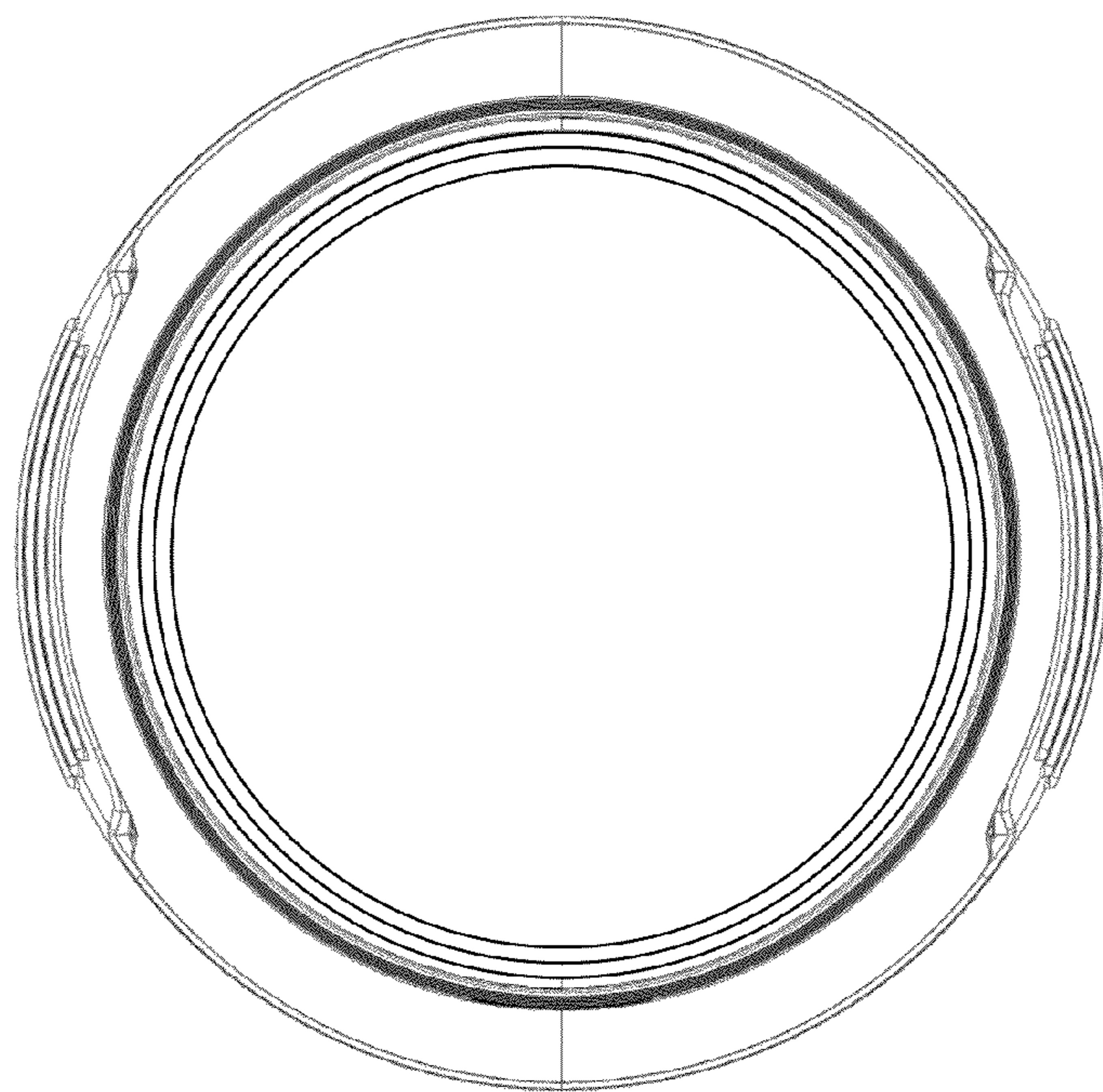

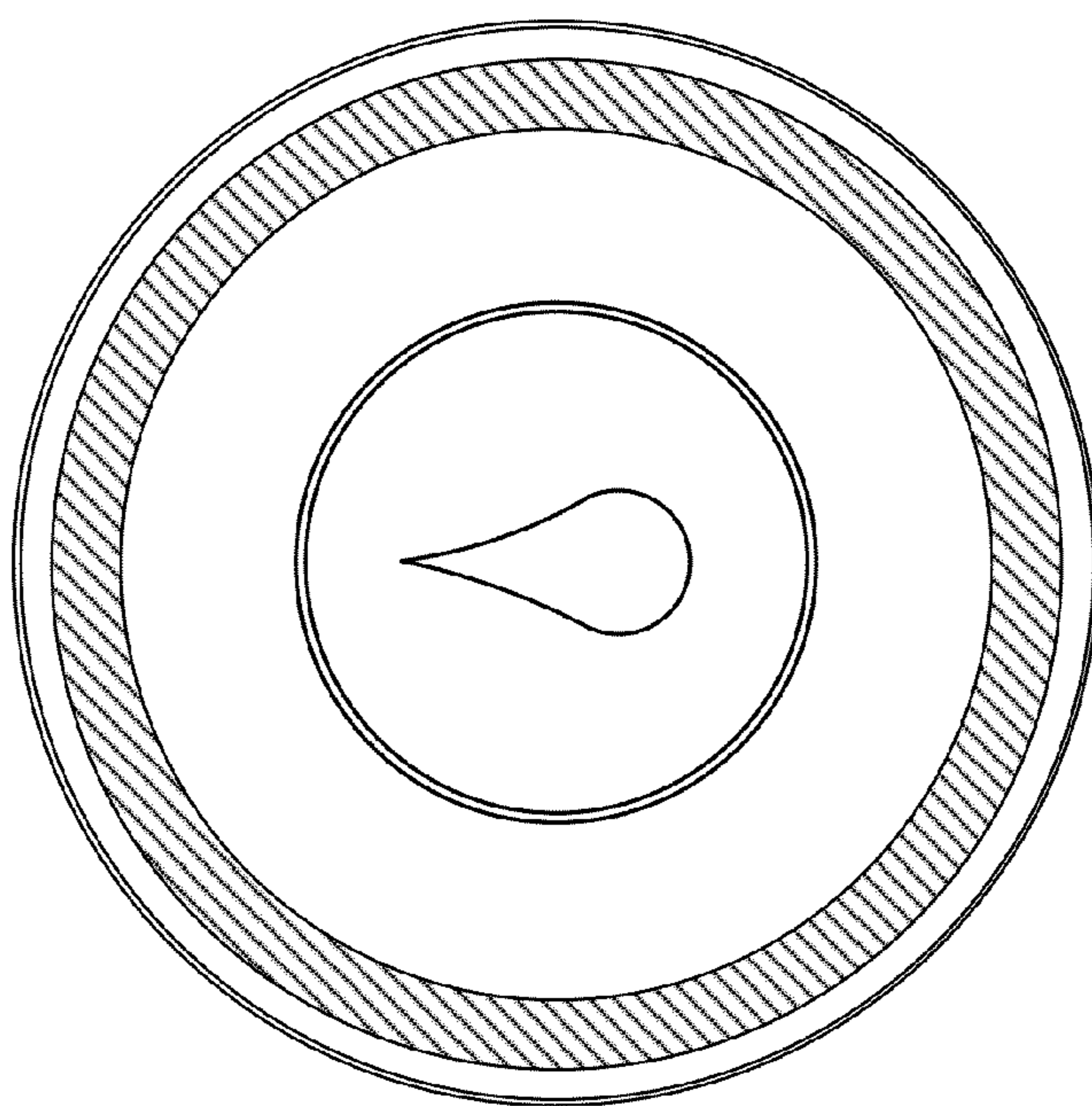

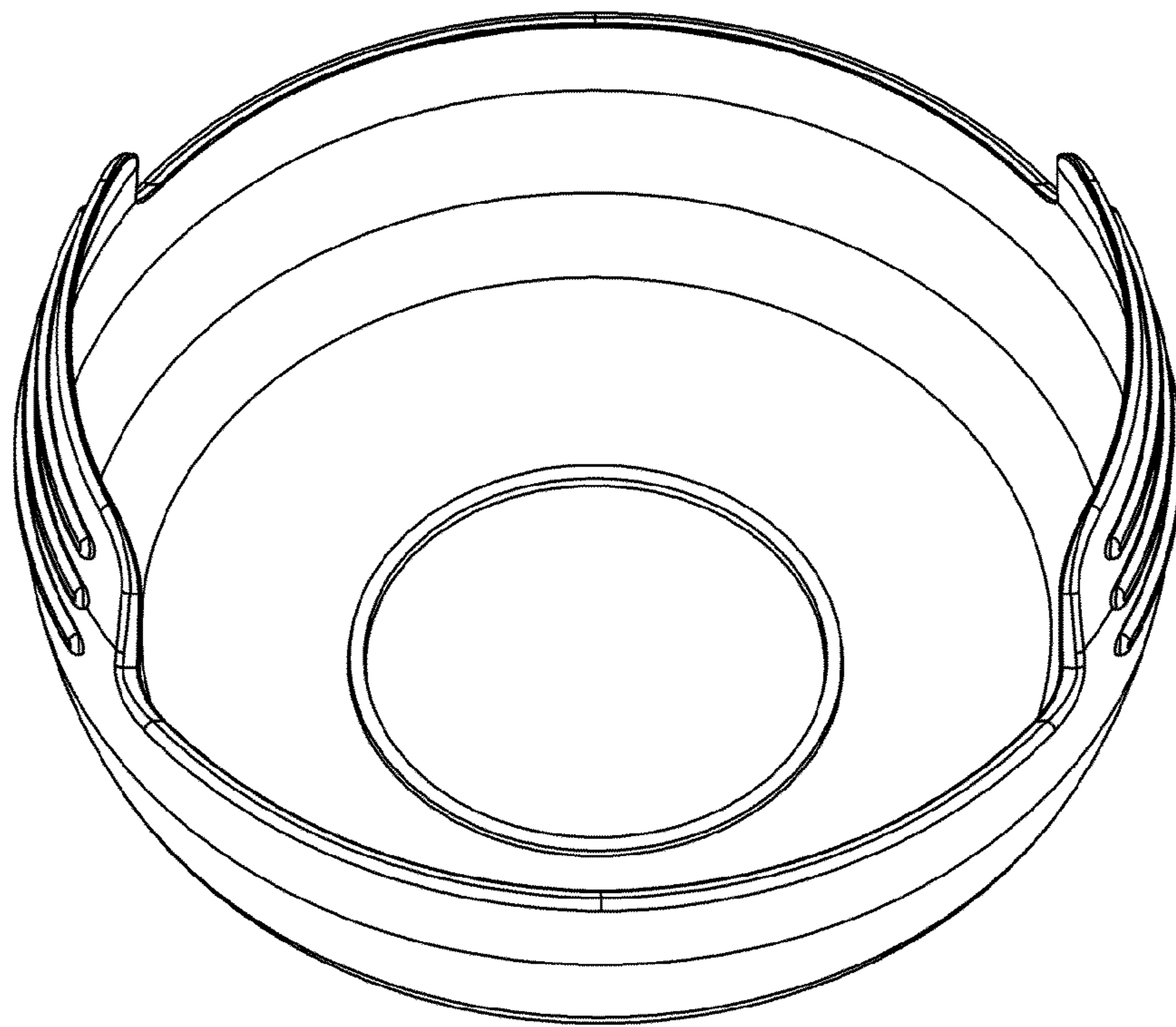
