(57) **CLAIM**

The ornamental design for a luminaire, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a luminaire showing our new design;

FIG. 2 is a bottom front perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is right end elevational view thereof;

FIG. 5 is a left end elevational view thereof;

FIG. 6 is a top plan view thereof; and

FIG. 7 is a bottom plan view thereof.

FIG. 8 is a top front perspective view of a luminaire showing an alternative embodiment of our new design;

FIG. 9 is a bottom front perspective view thereof;

FIG. 10 is a front elevational view thereof;

FIG. 11 is right end elevational view thereof;

FIG. 12 is a left end elevational view thereof;

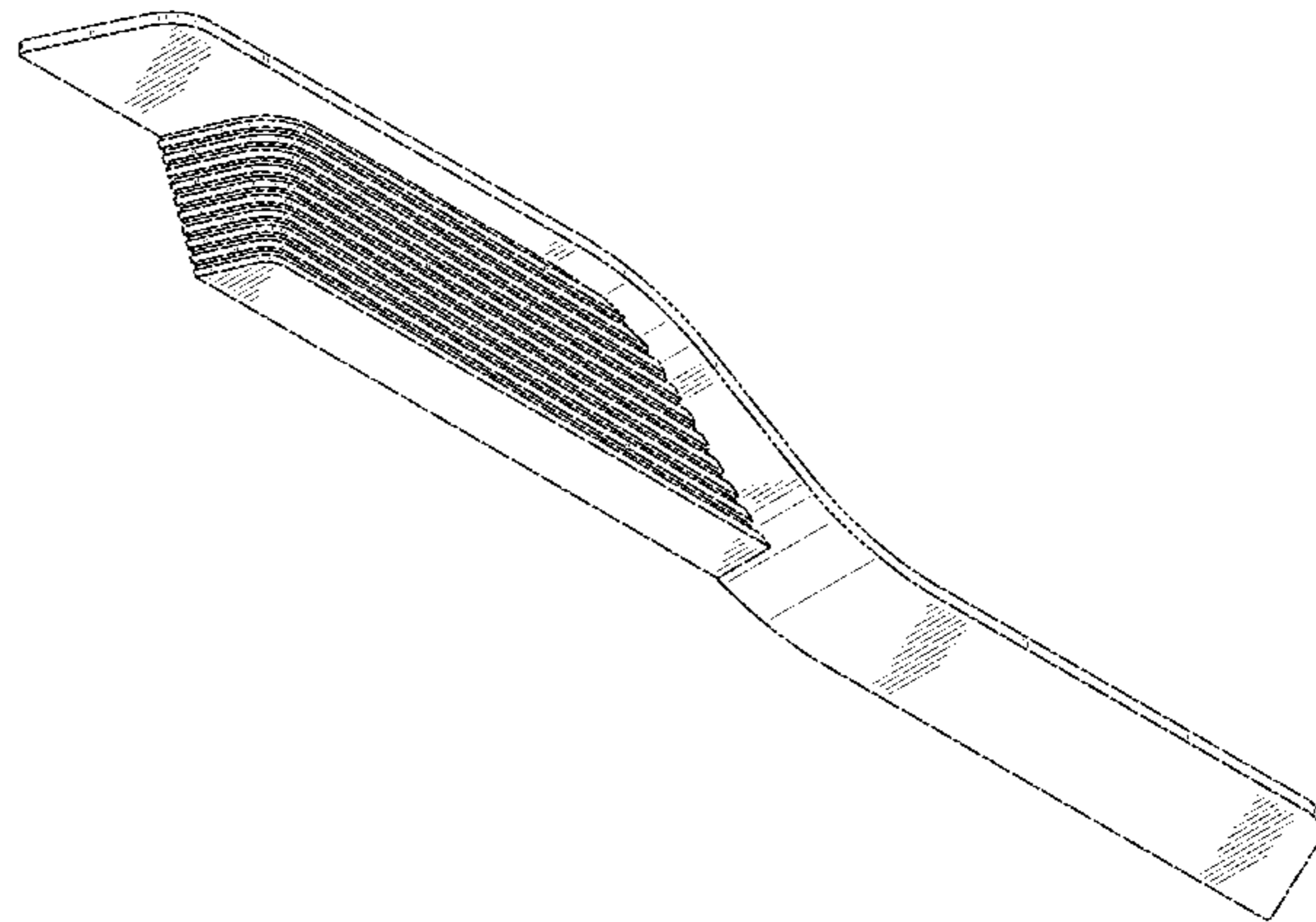
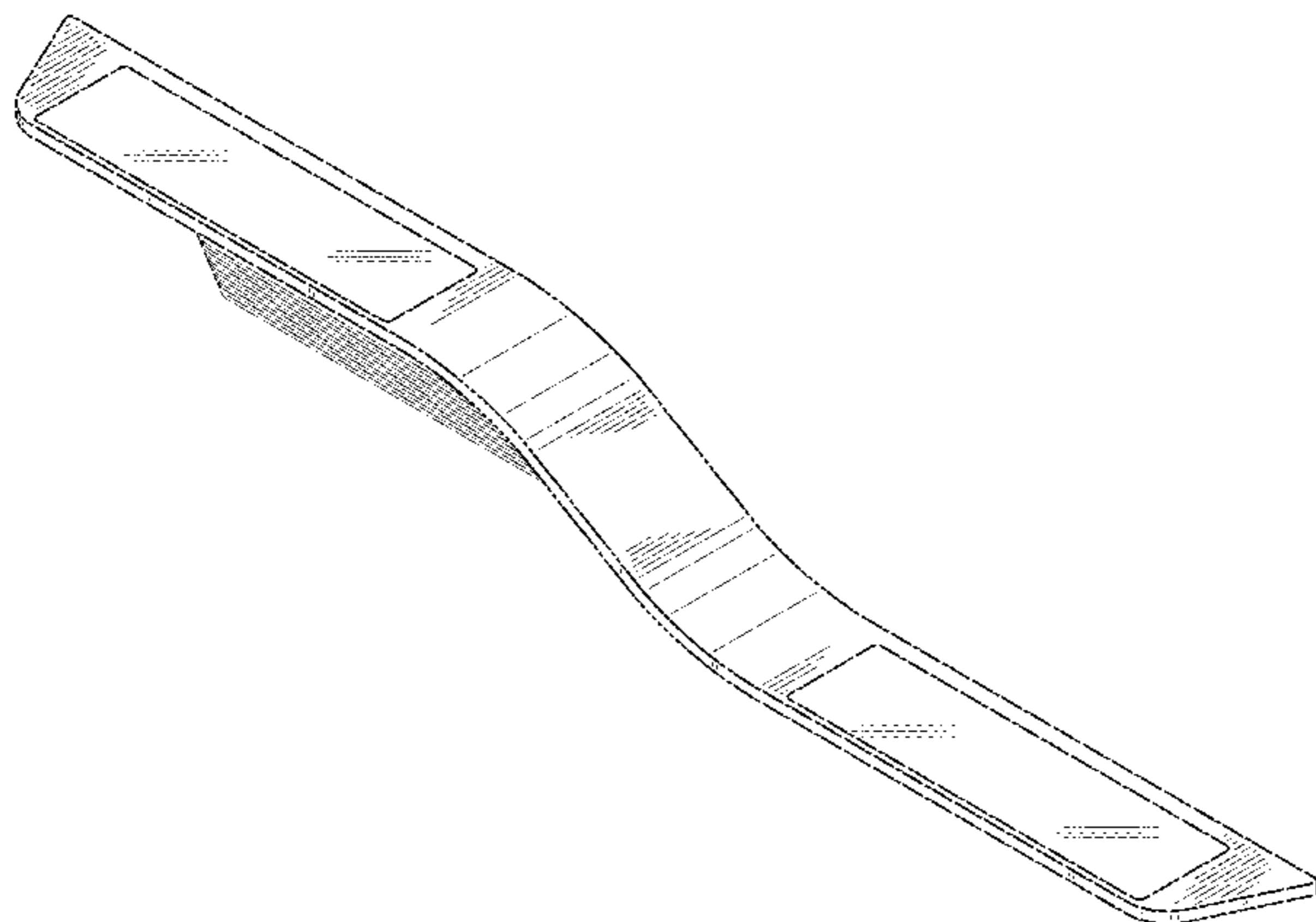
FIG. 13 is a top plan view thereof; and,

FIG. 14 is a bottom plan view thereof.

The back of the luminaire forms no part of the claimed design and is not shown.

In the embodiment shown in FIGS. 8-14, the broken line rectangles shown in FIGS. 8 and 13 represent area light sources such as OLED panels. The area light sources shown in broken lines form no part of the claimed design shown in FIGS. 8-14.

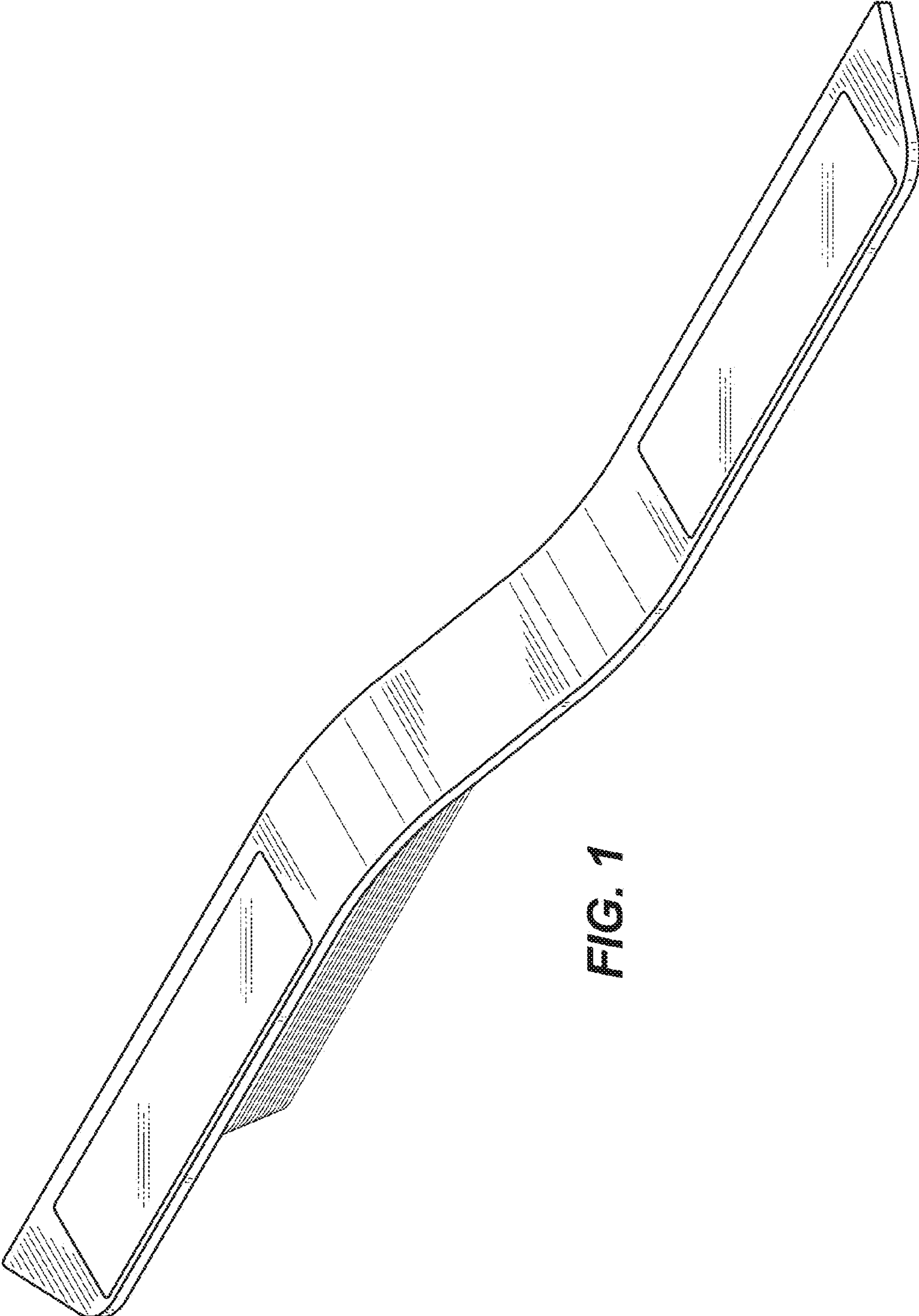

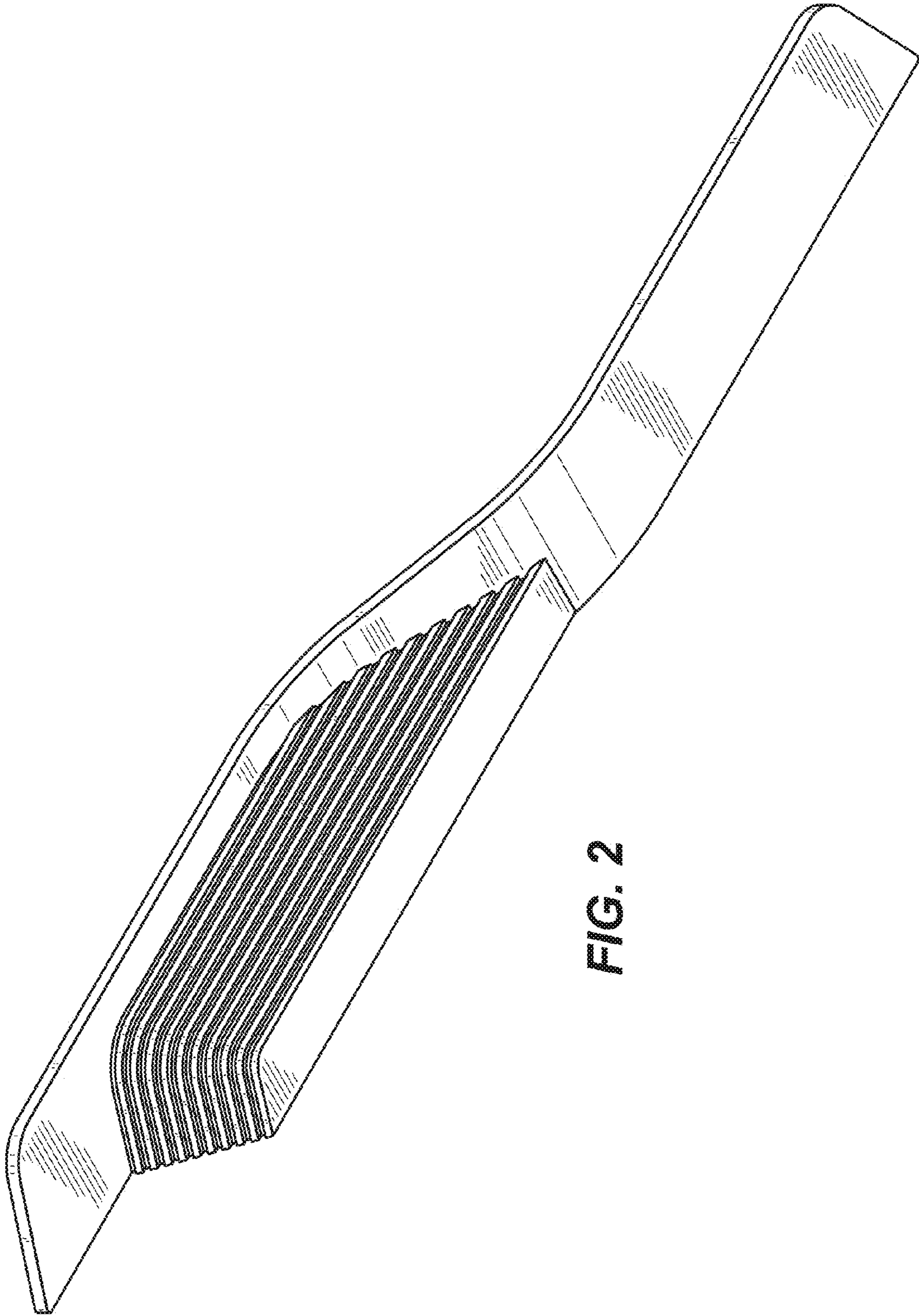

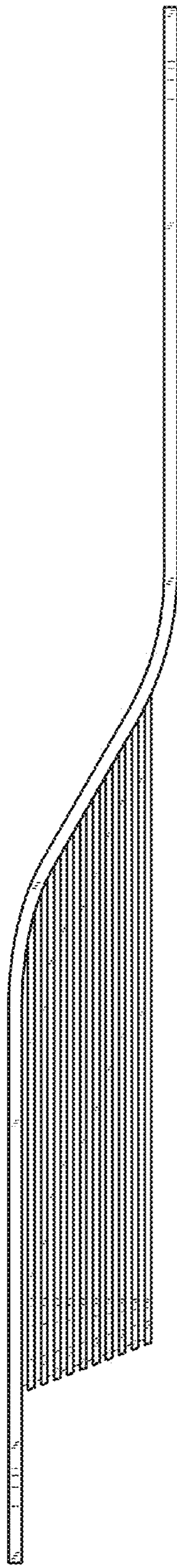

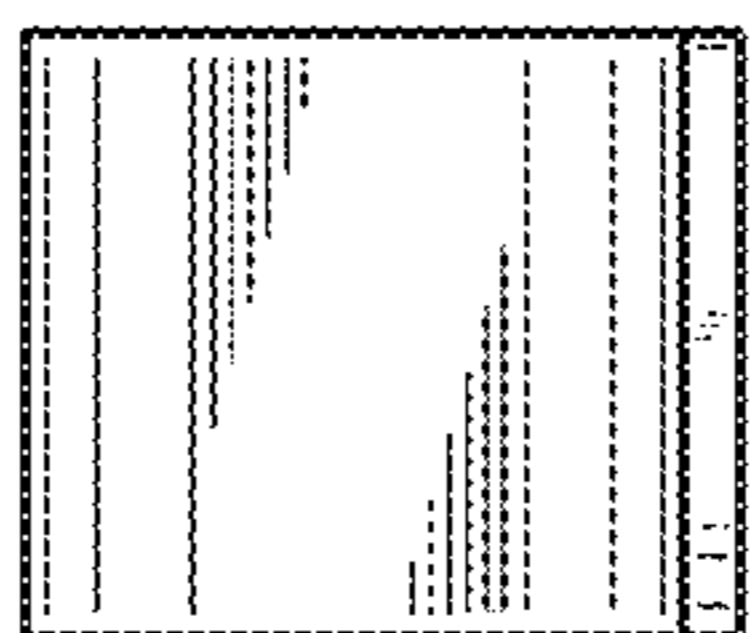
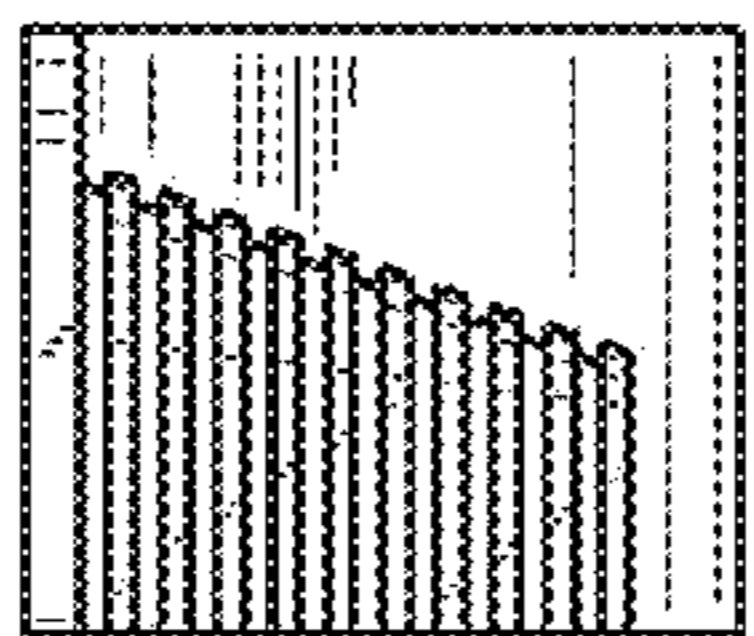


FIG. 4 FIG. 5

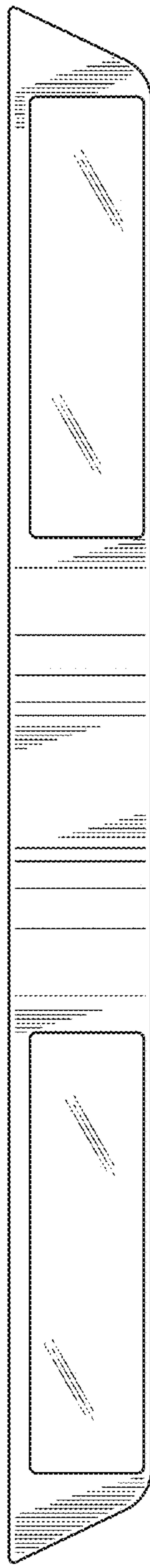

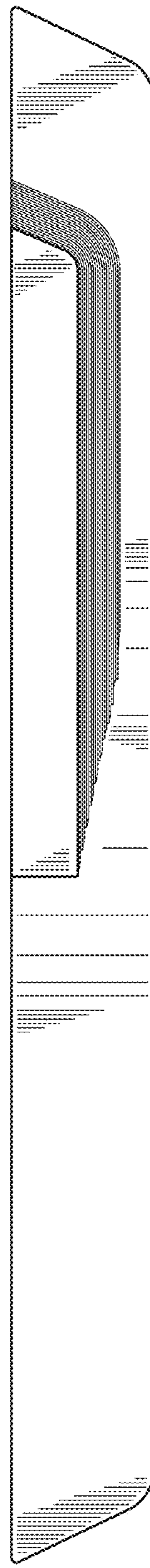

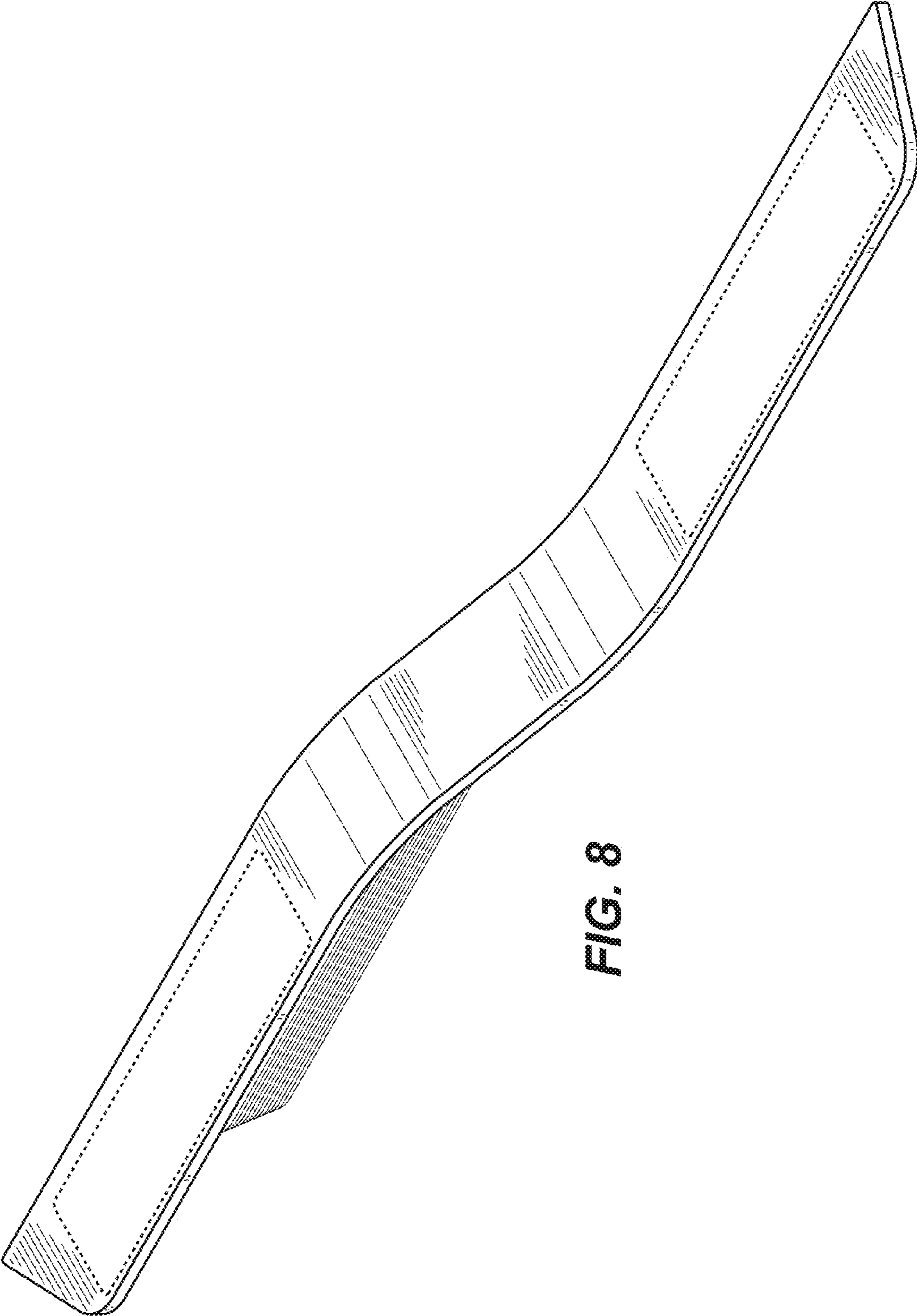

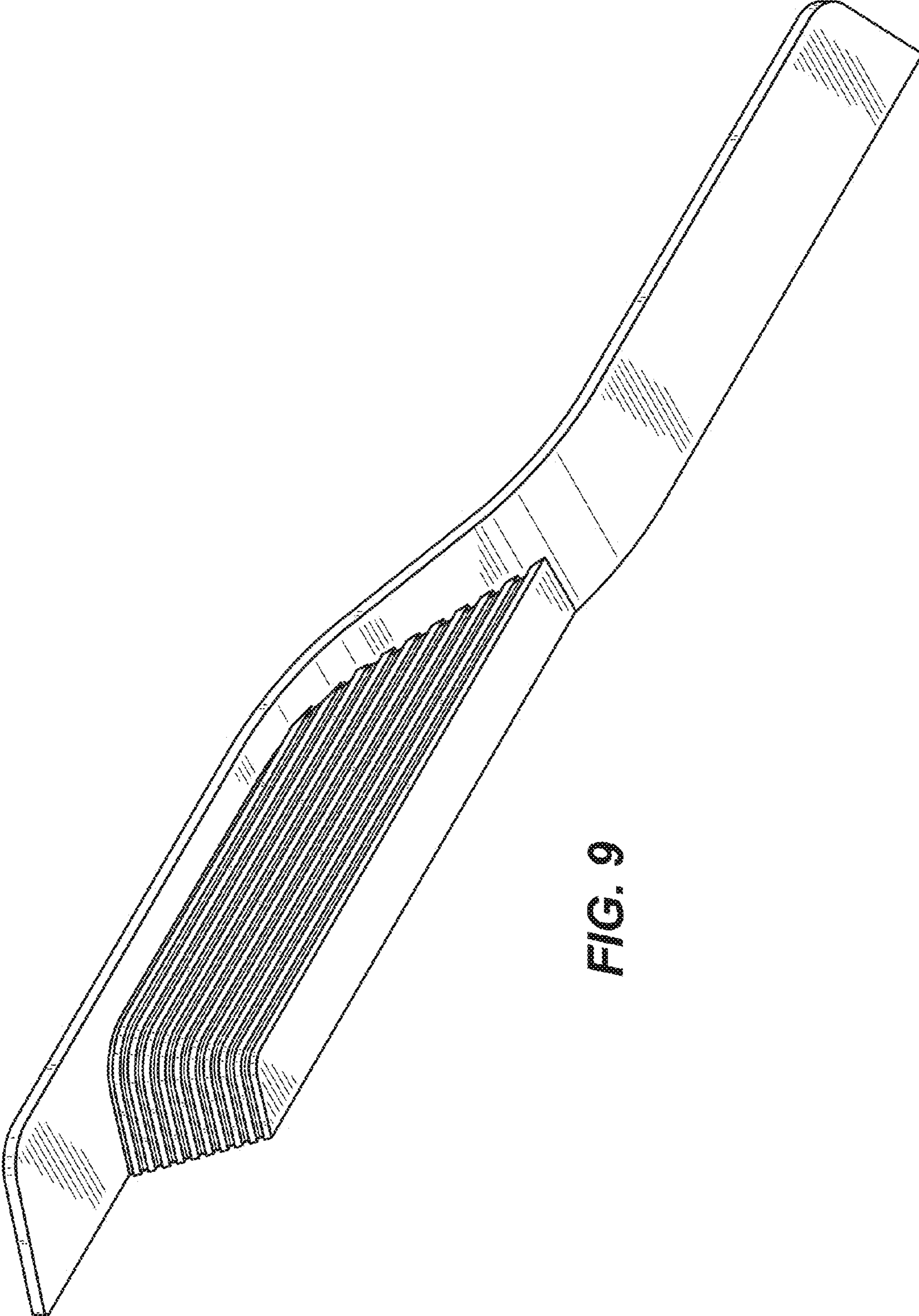

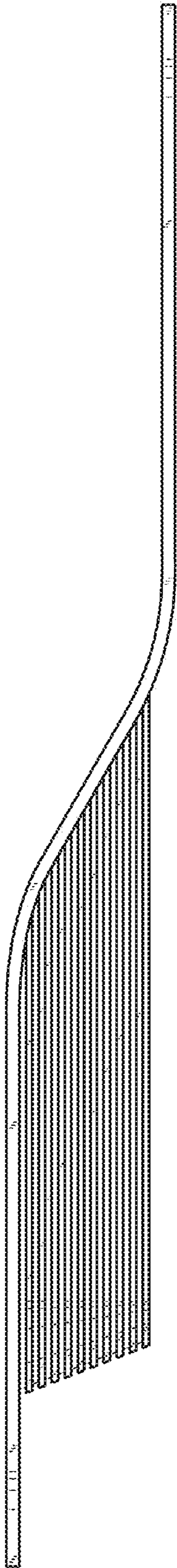

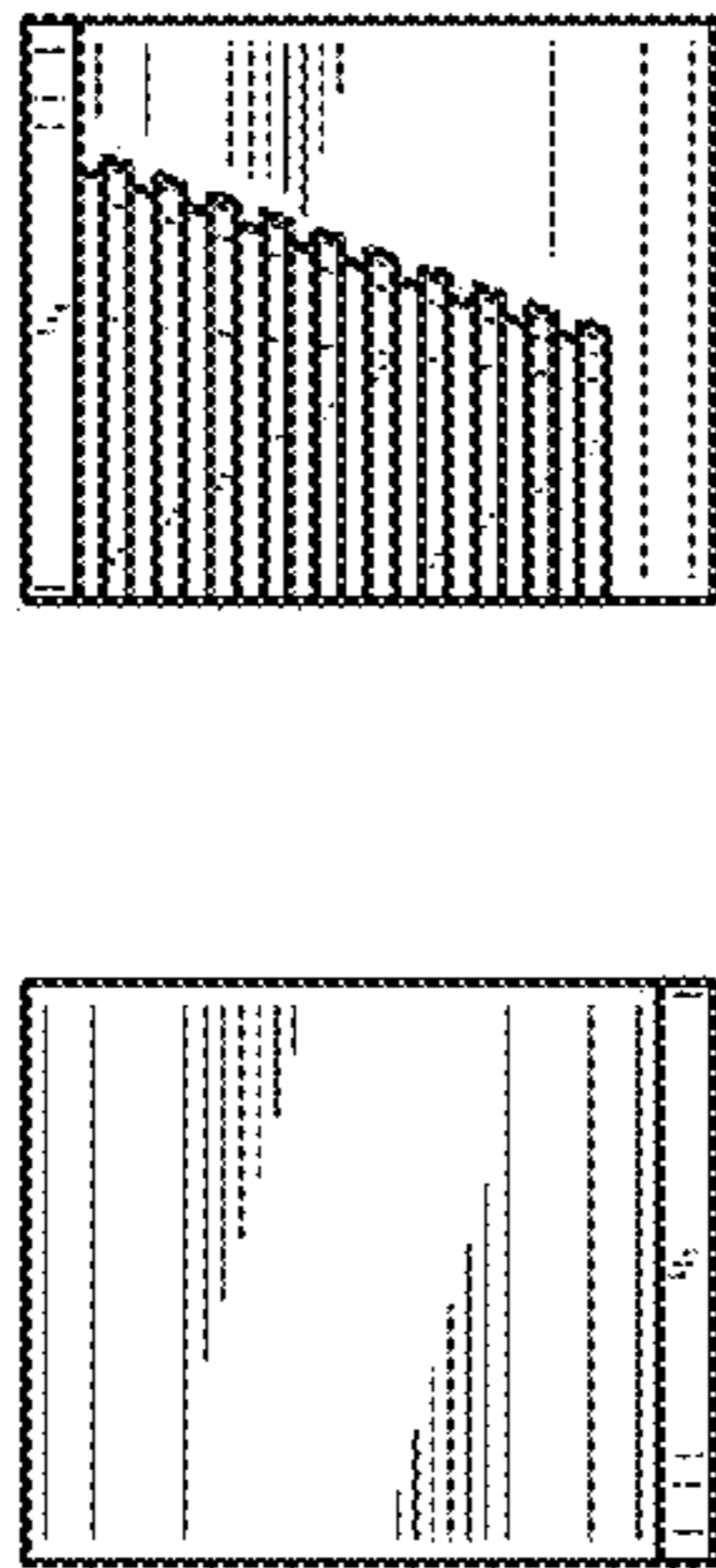


FIG. 11 FIG. 12

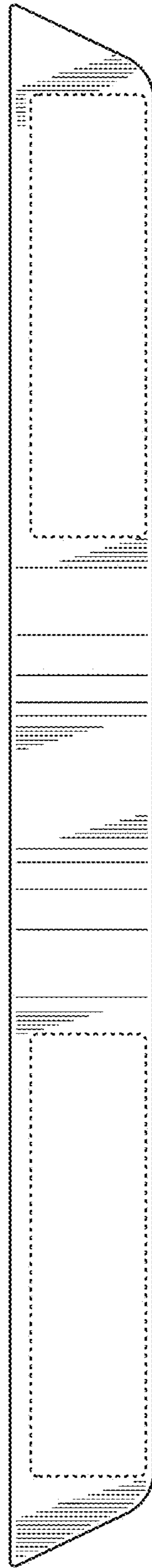

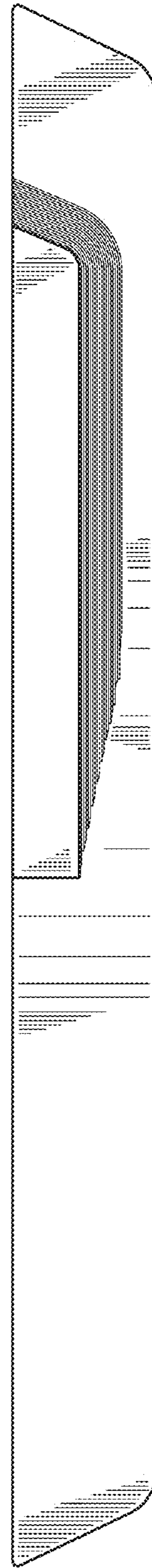
