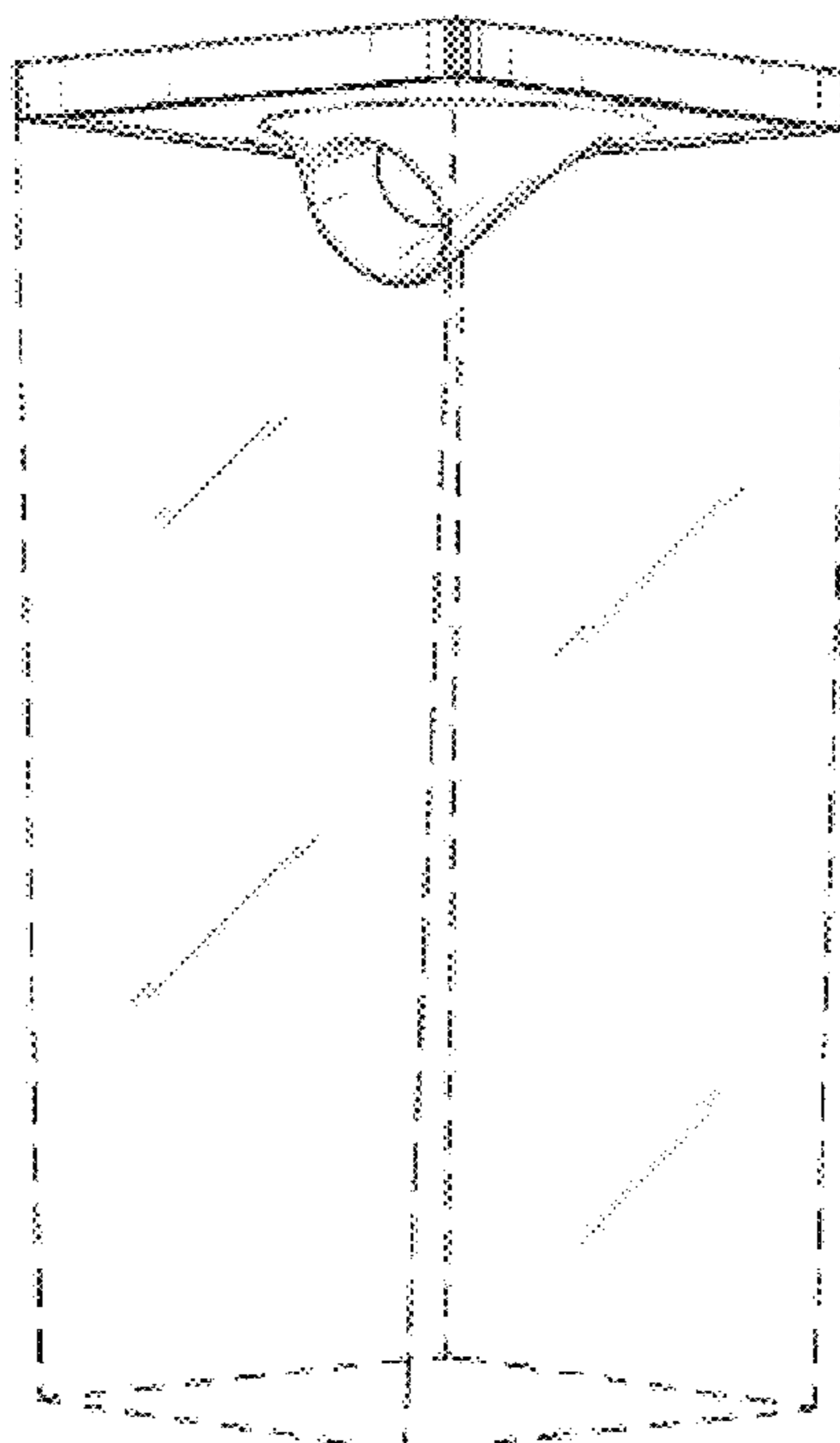
(57) **CLAIM**

The ornamental design for a table lamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my new table lamp;
FIG. 2 is a front elevational view of my new table lamp;
FIG. 3 is a rear elevational view of my new table lamp,
opposite that of FIG. 2;
FIG. 4 is a side elevational view of my new table lamp;
FIG. 5 is another side elevational view of my new table lamp

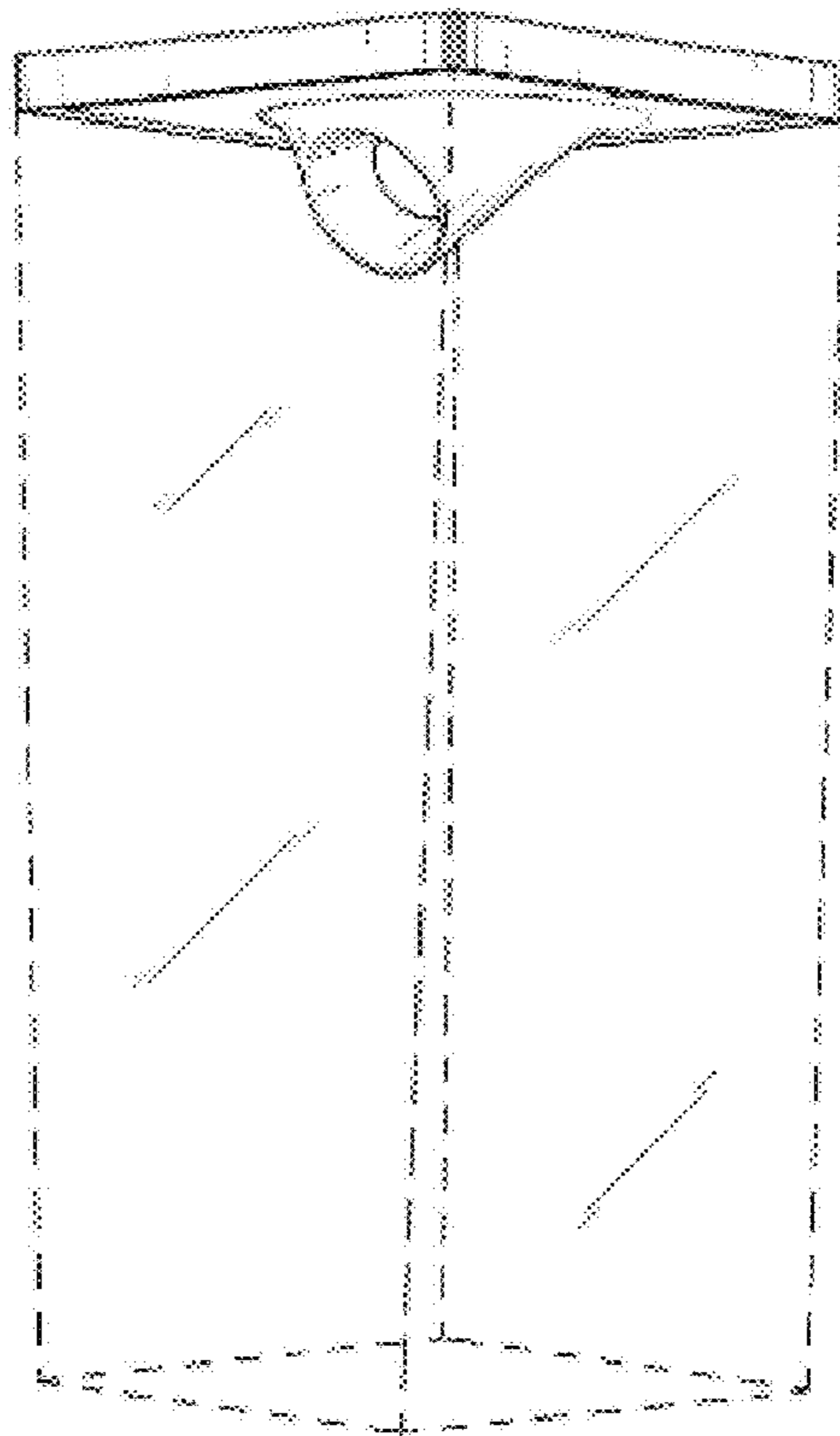

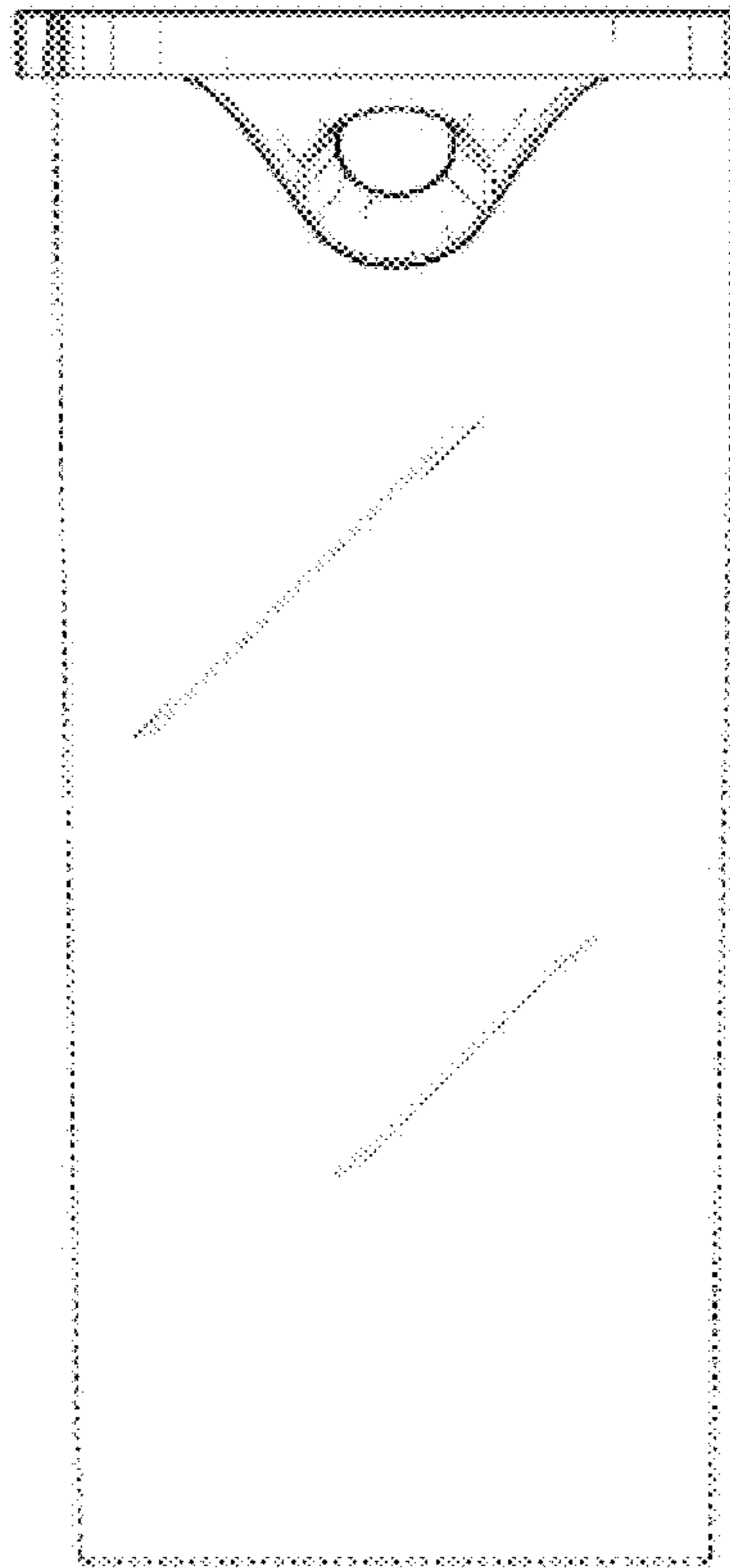

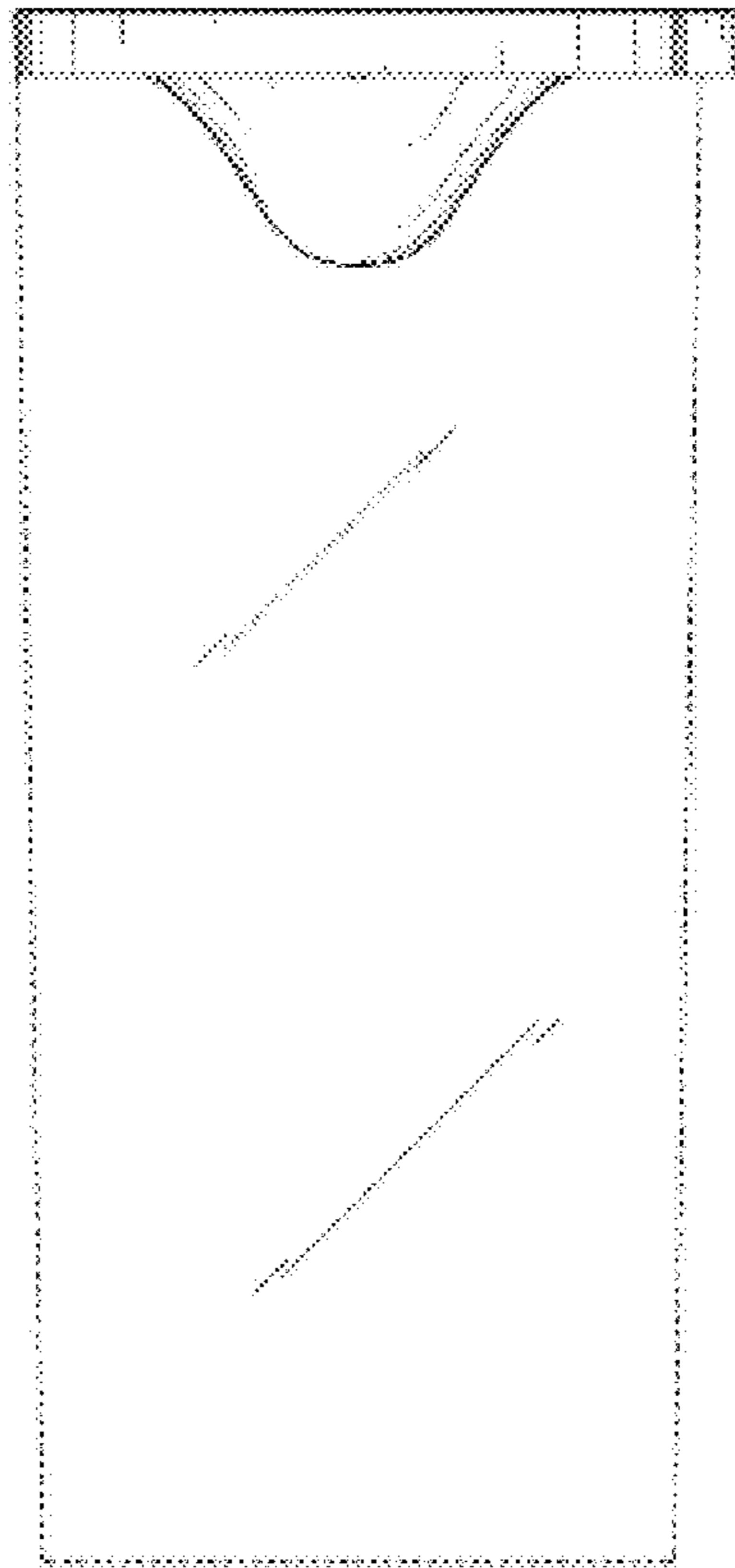

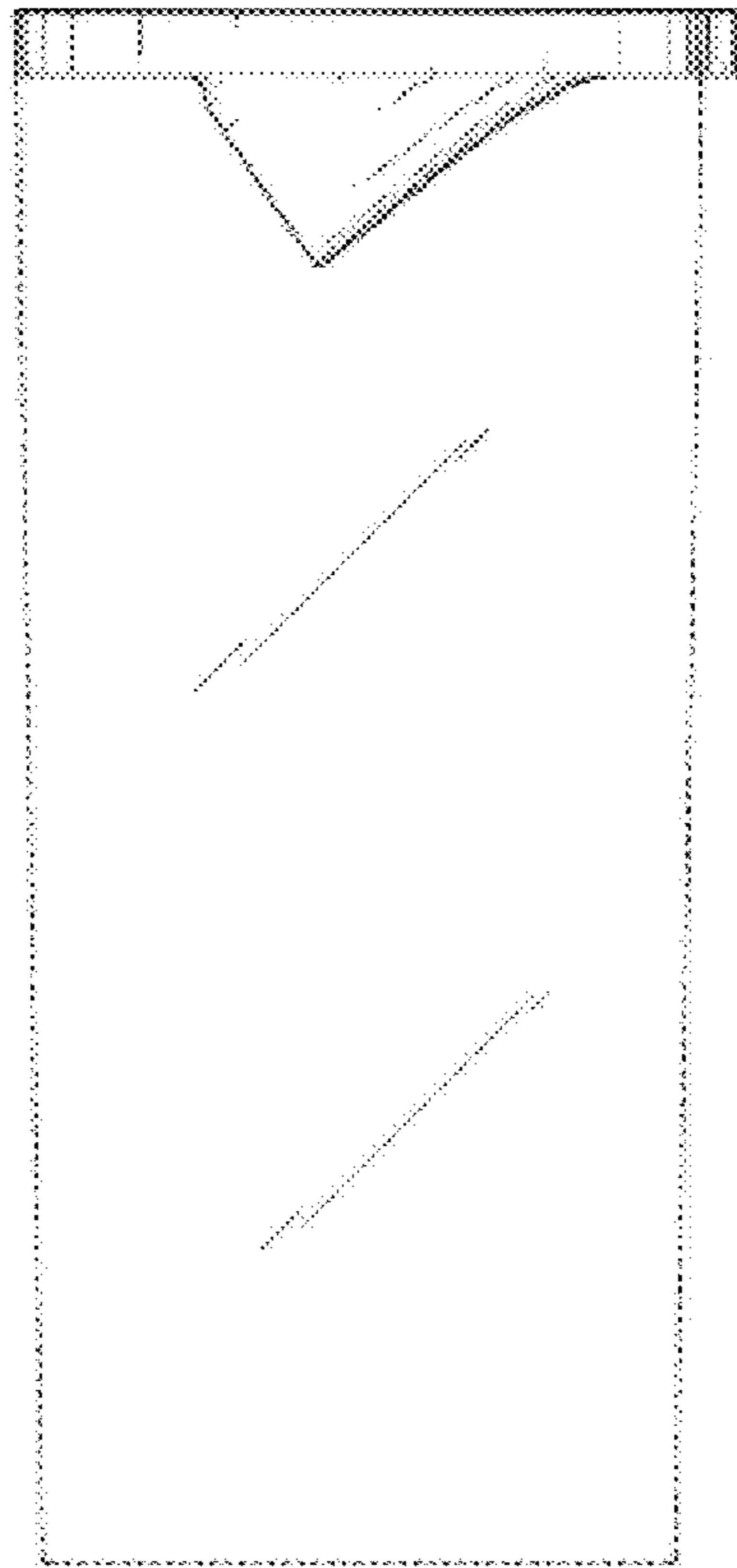

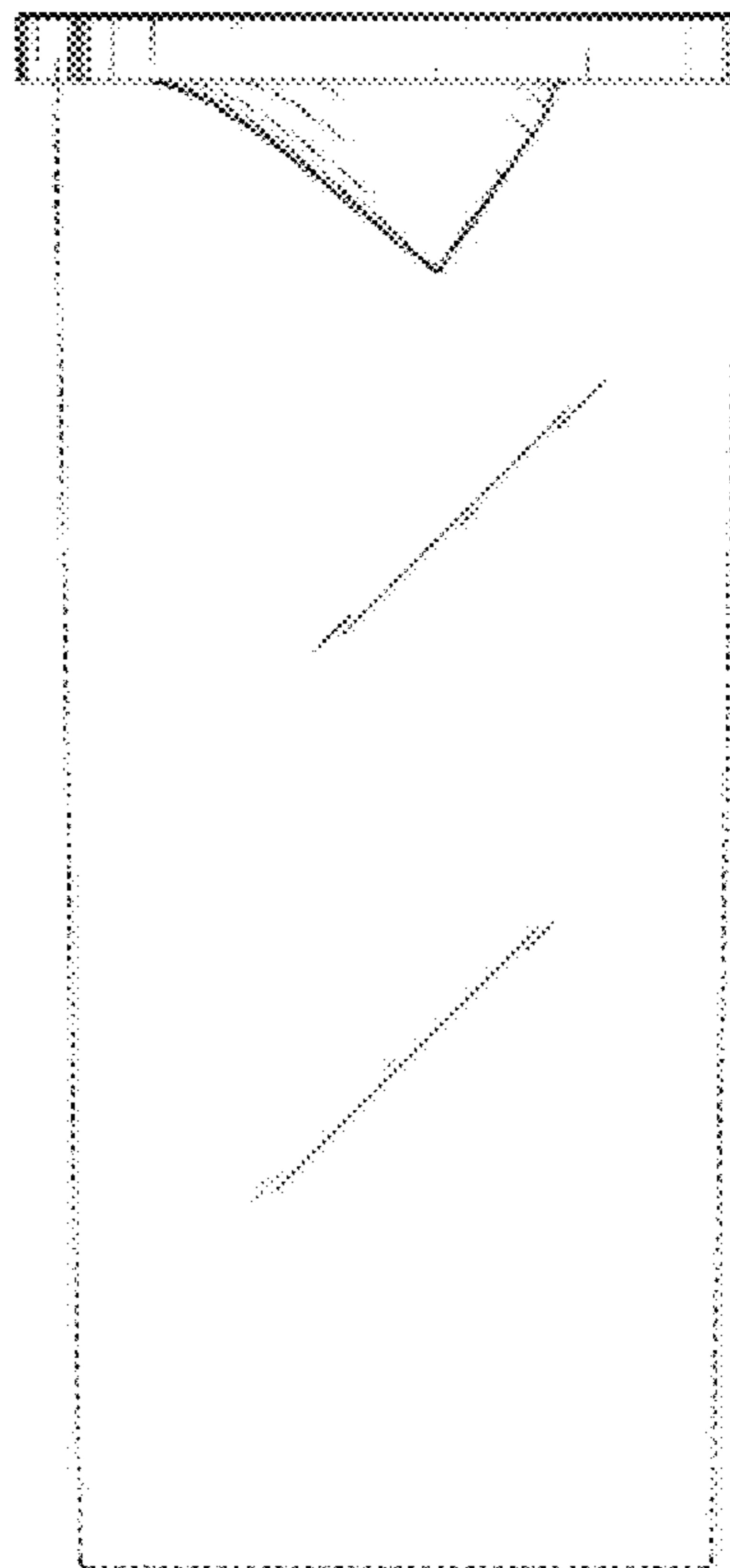

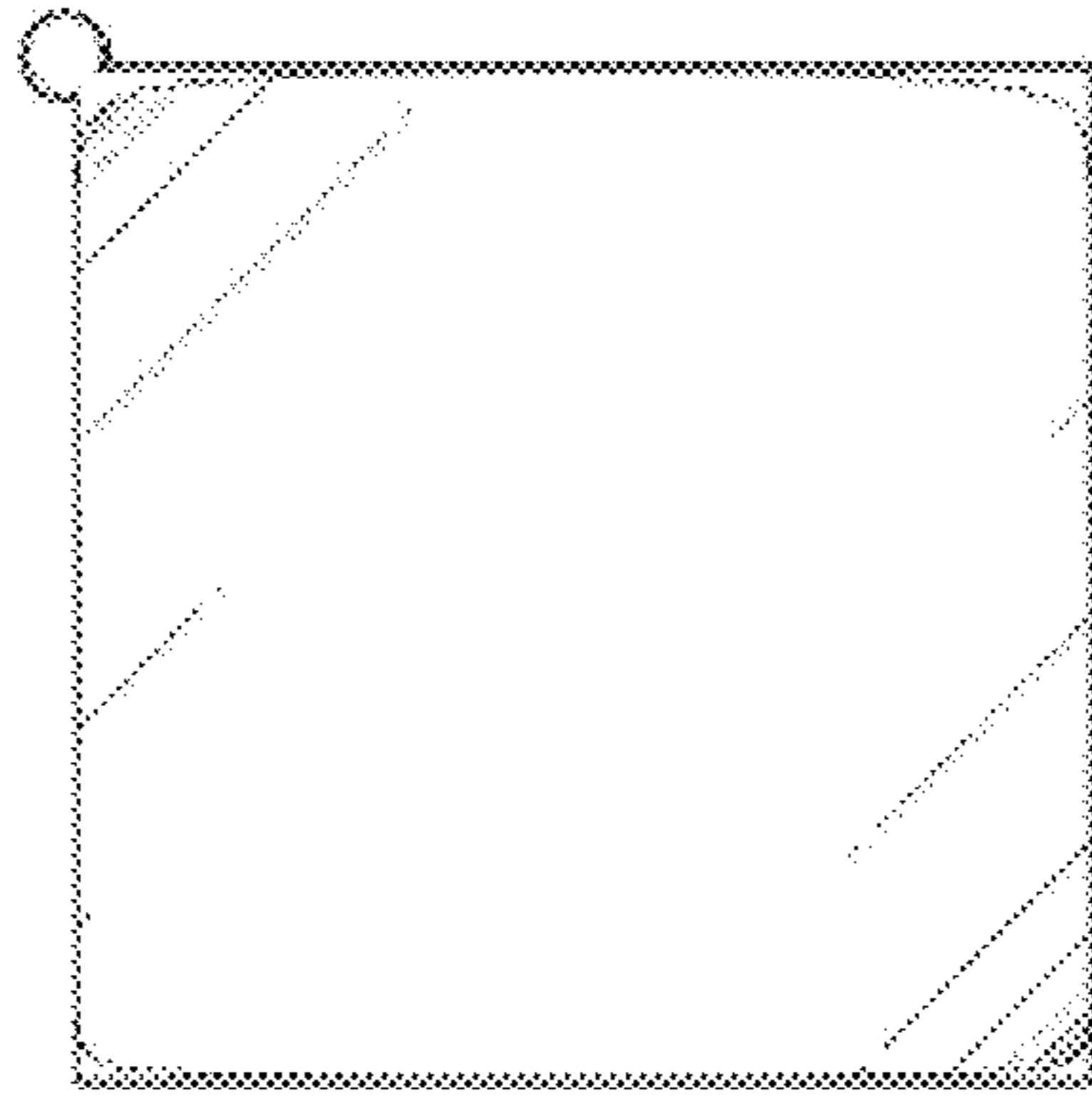

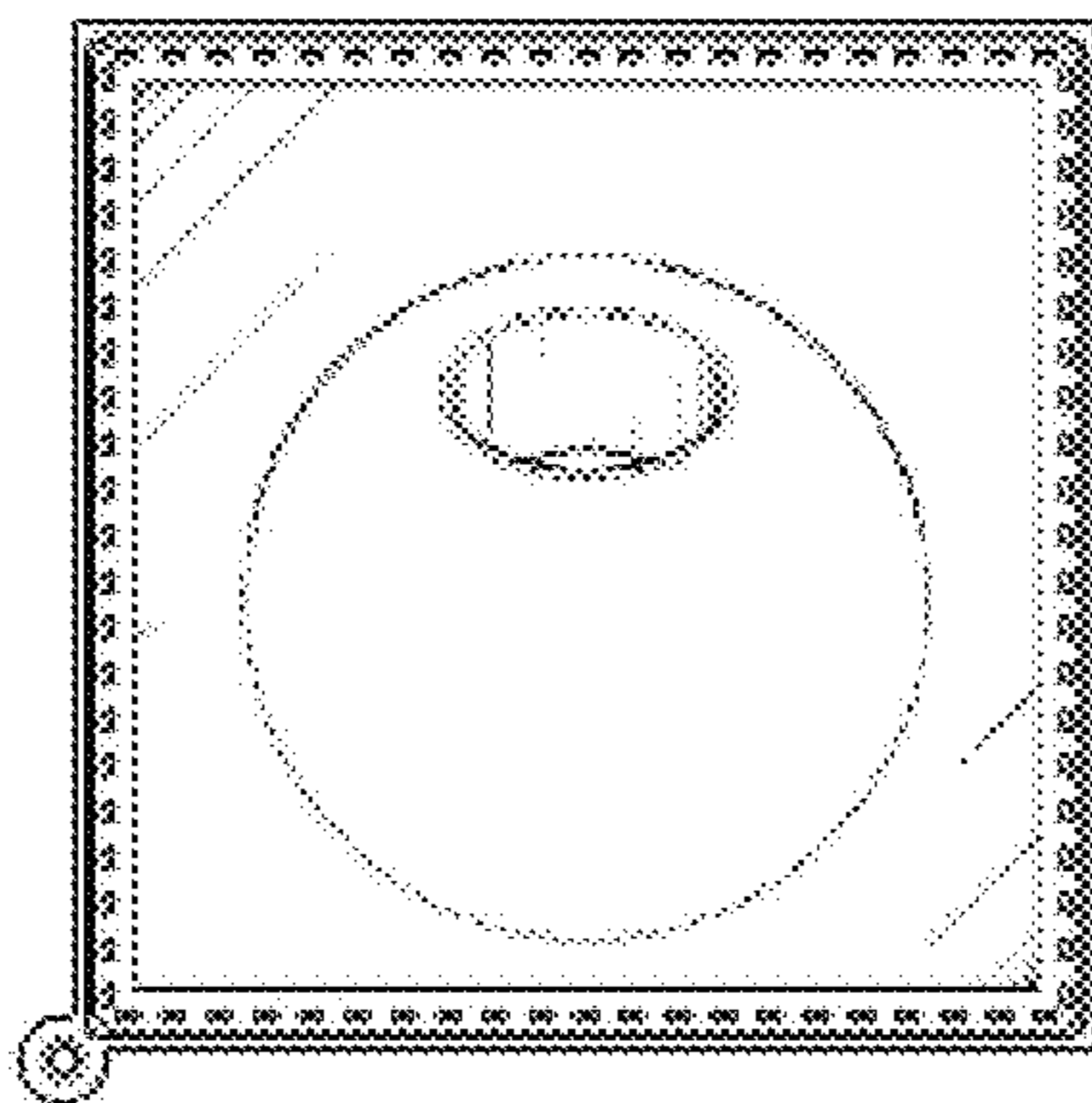
