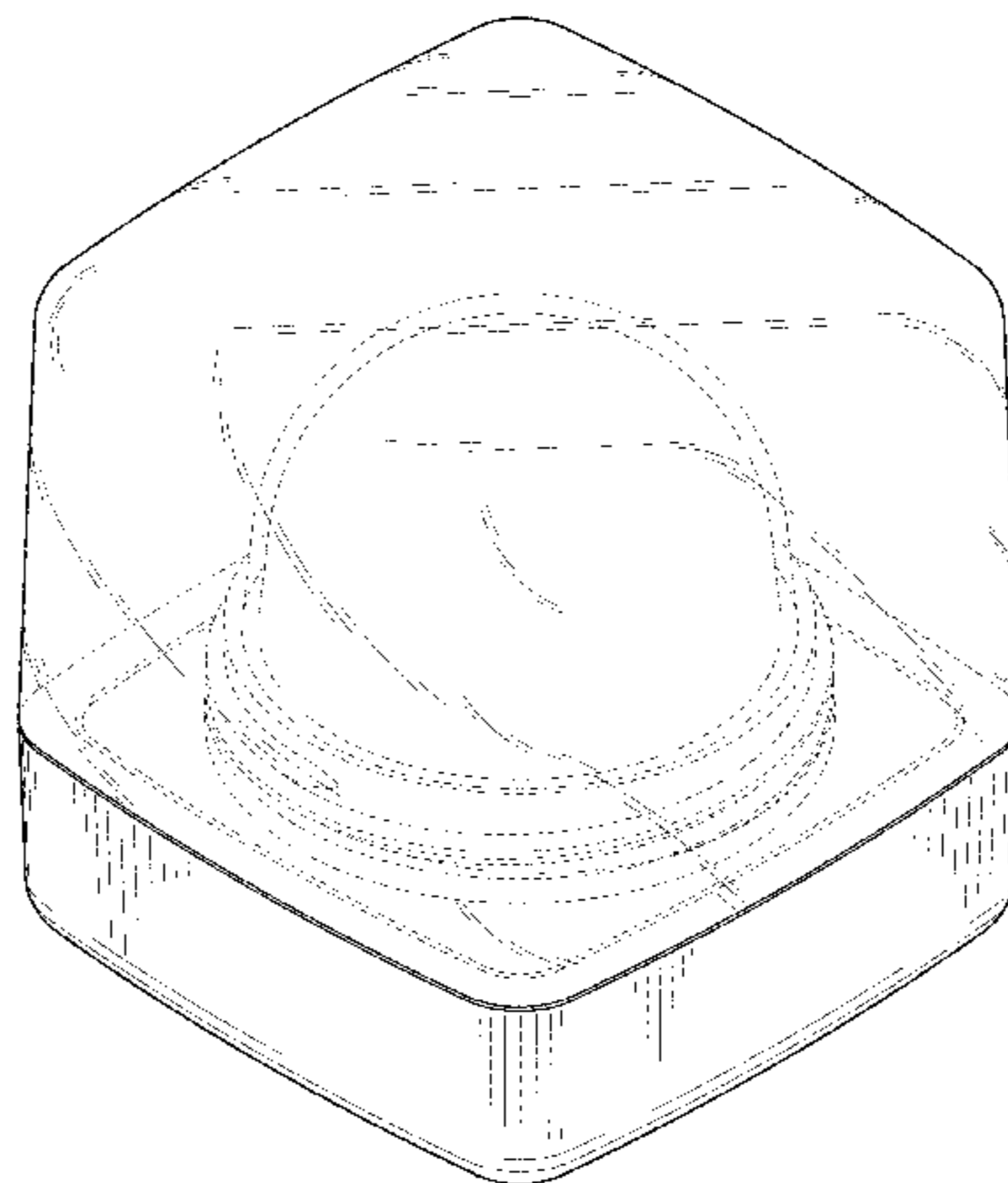
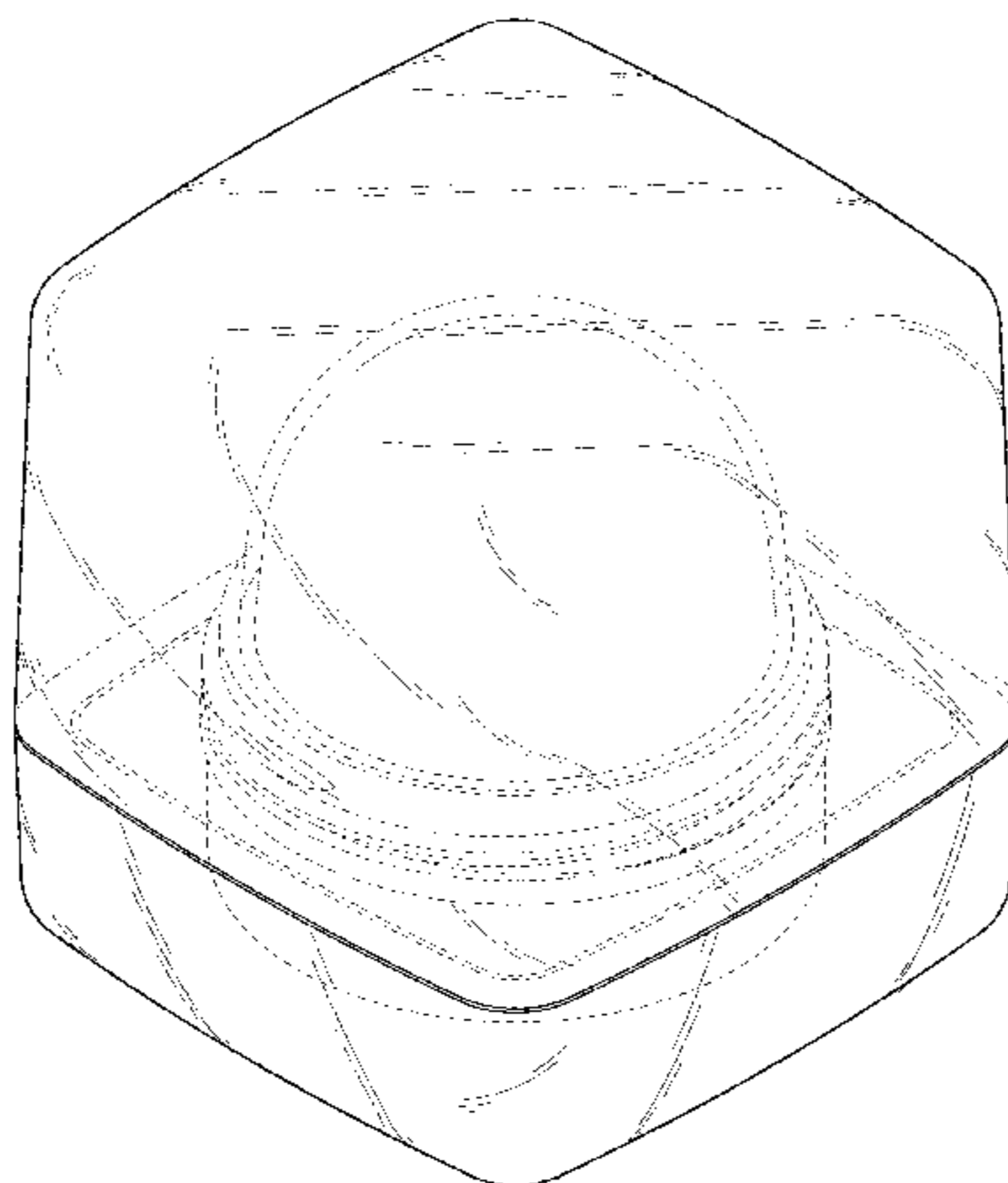

**CLAIM**

The ornamental design for a cosmetic container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a cosmetic container showing our new design;

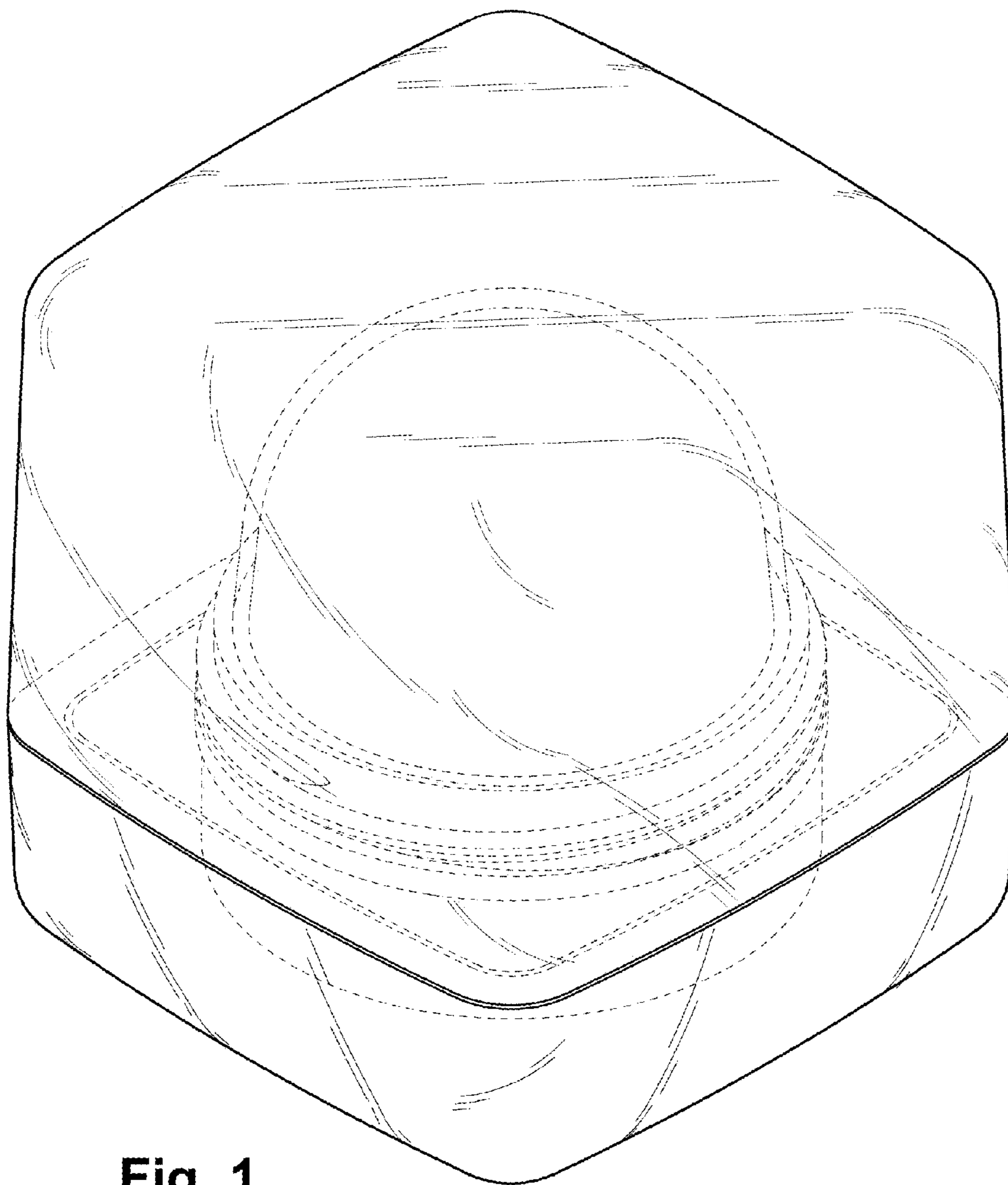

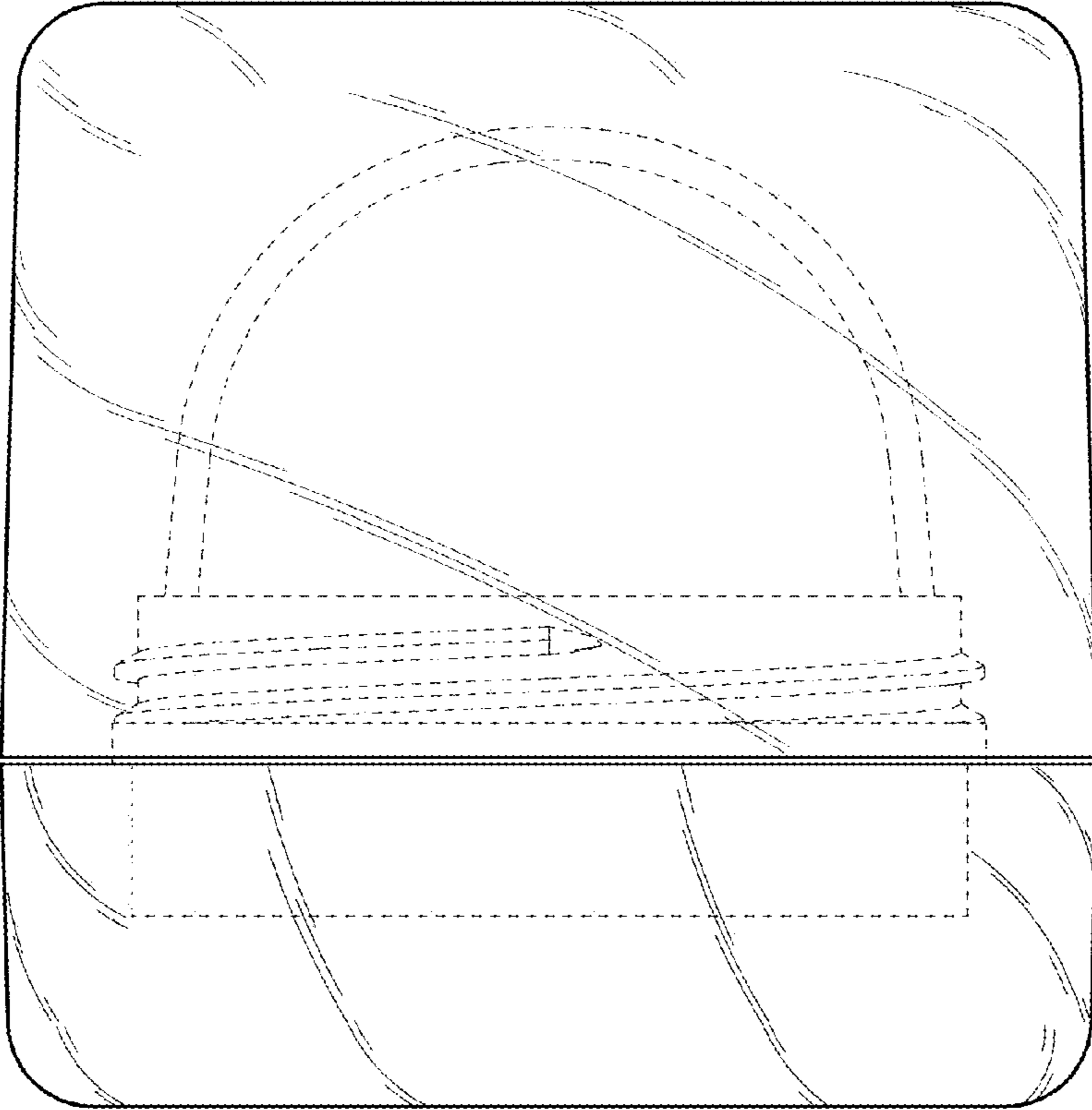

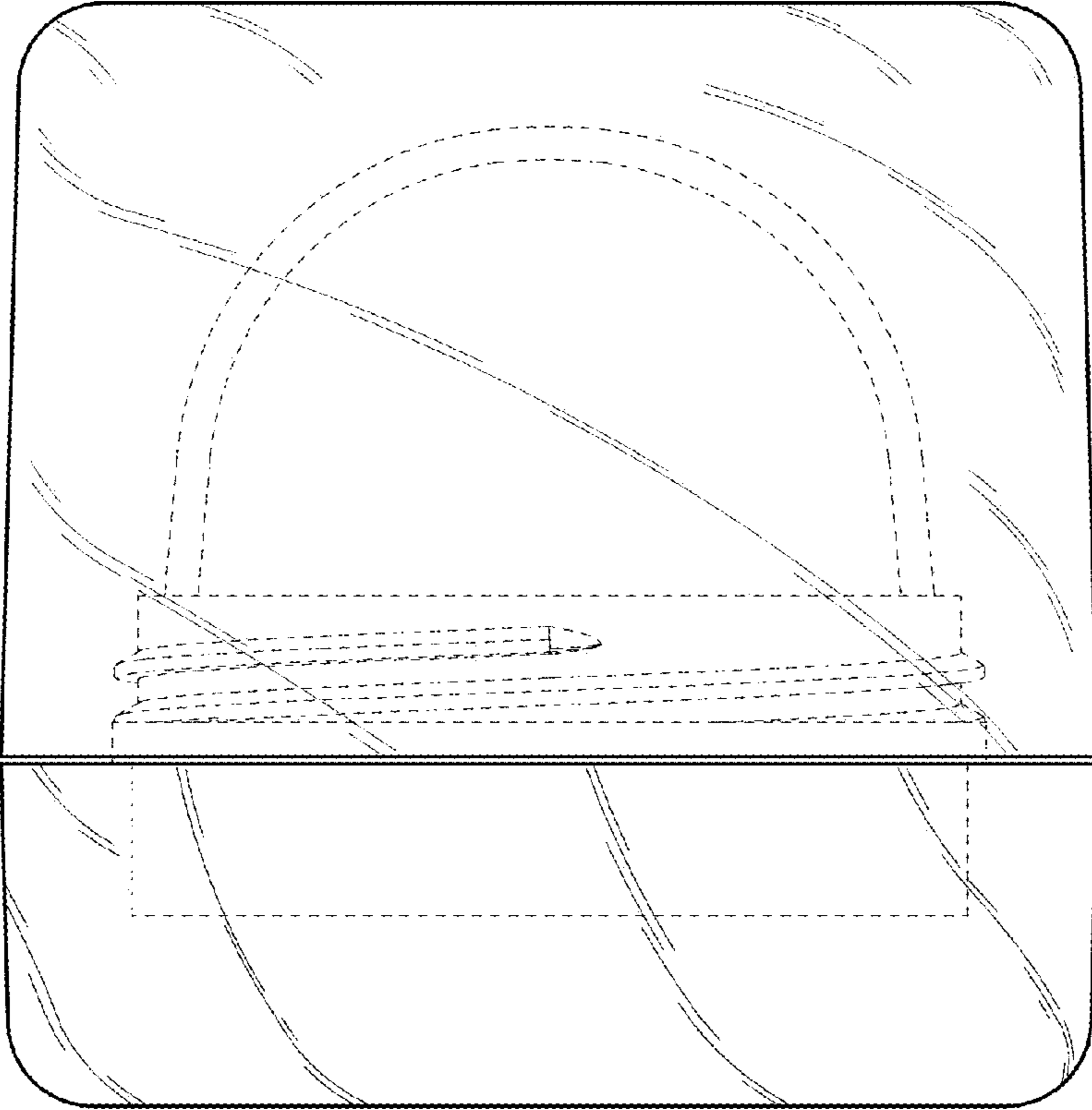

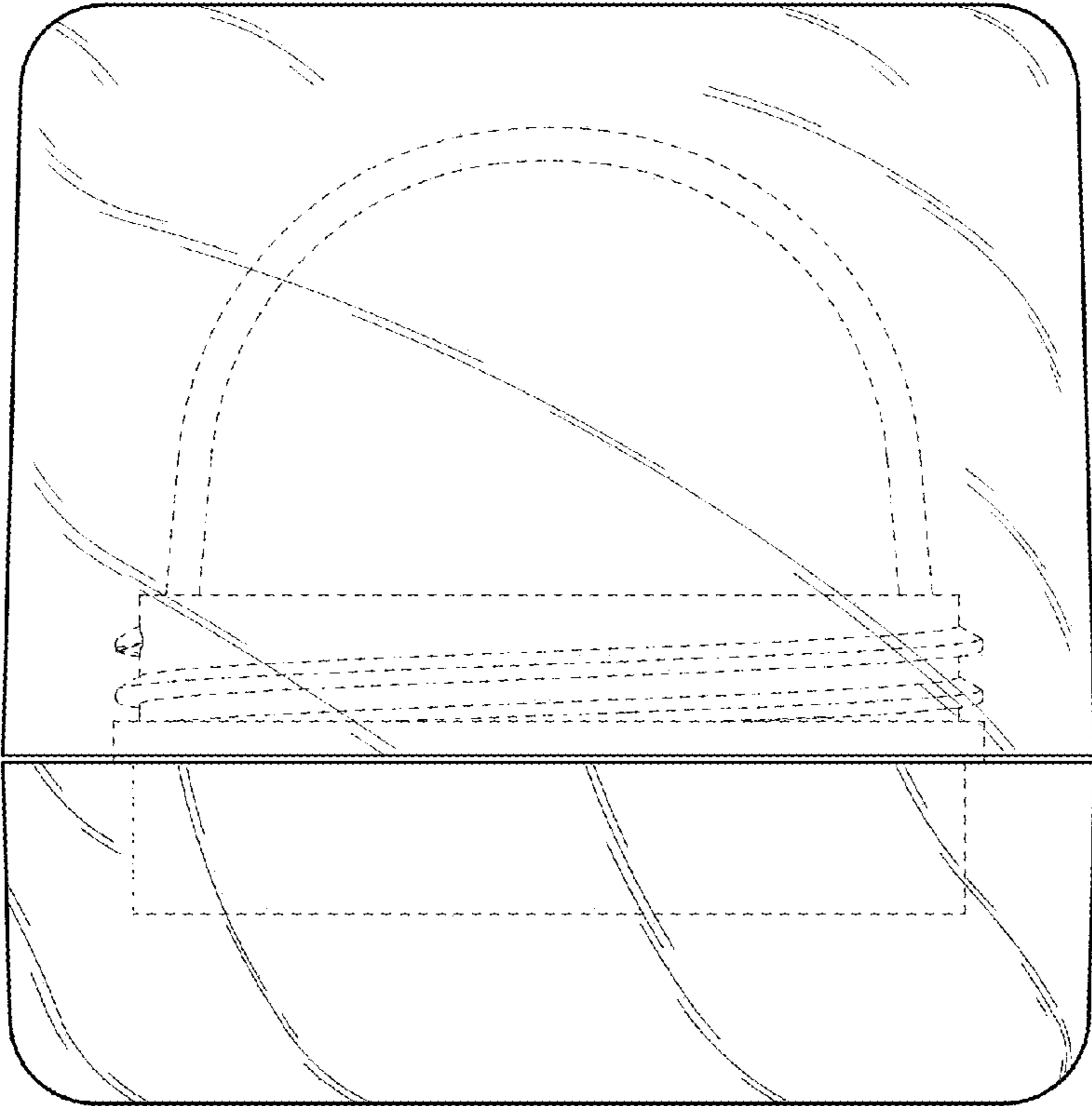
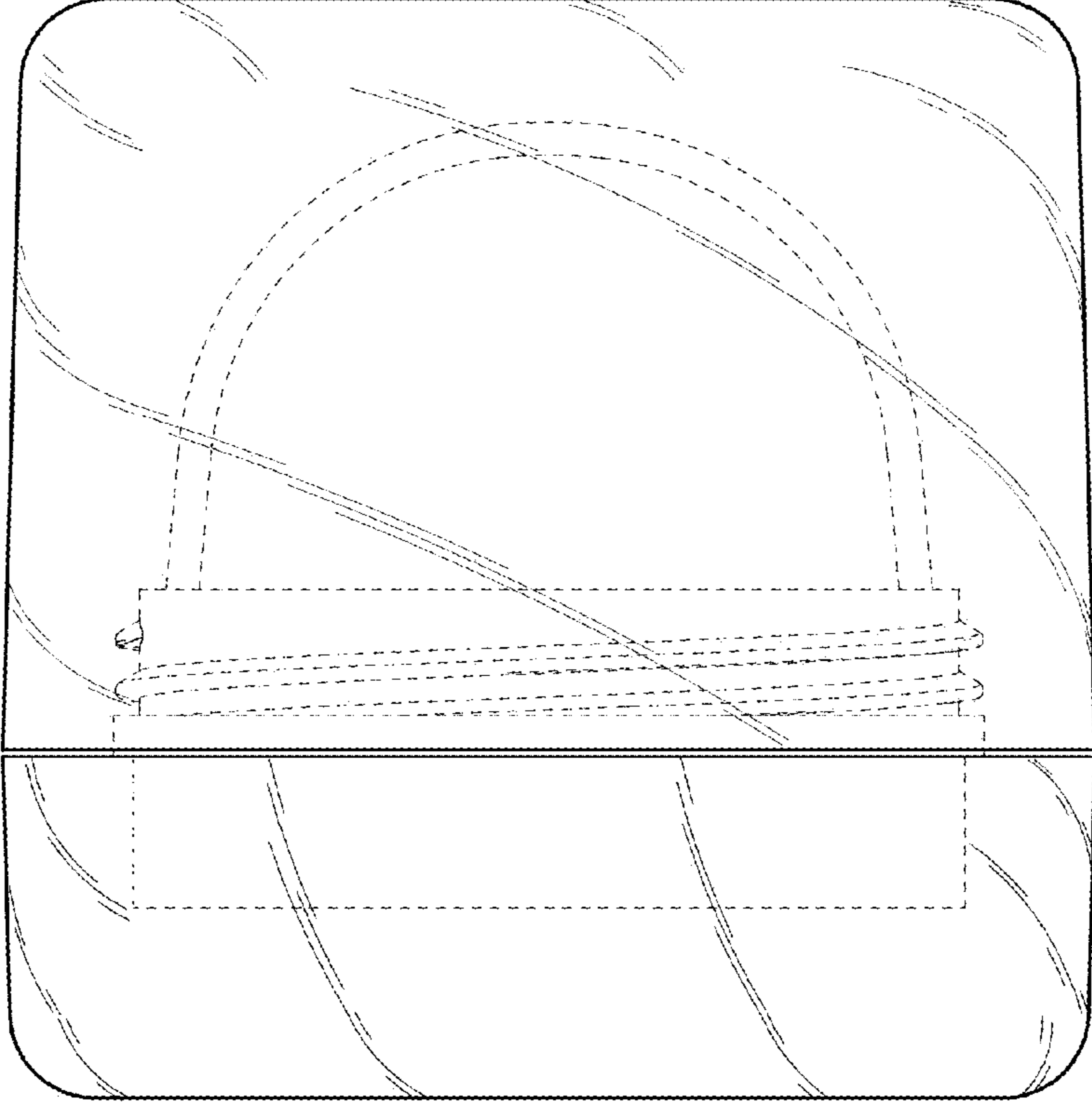
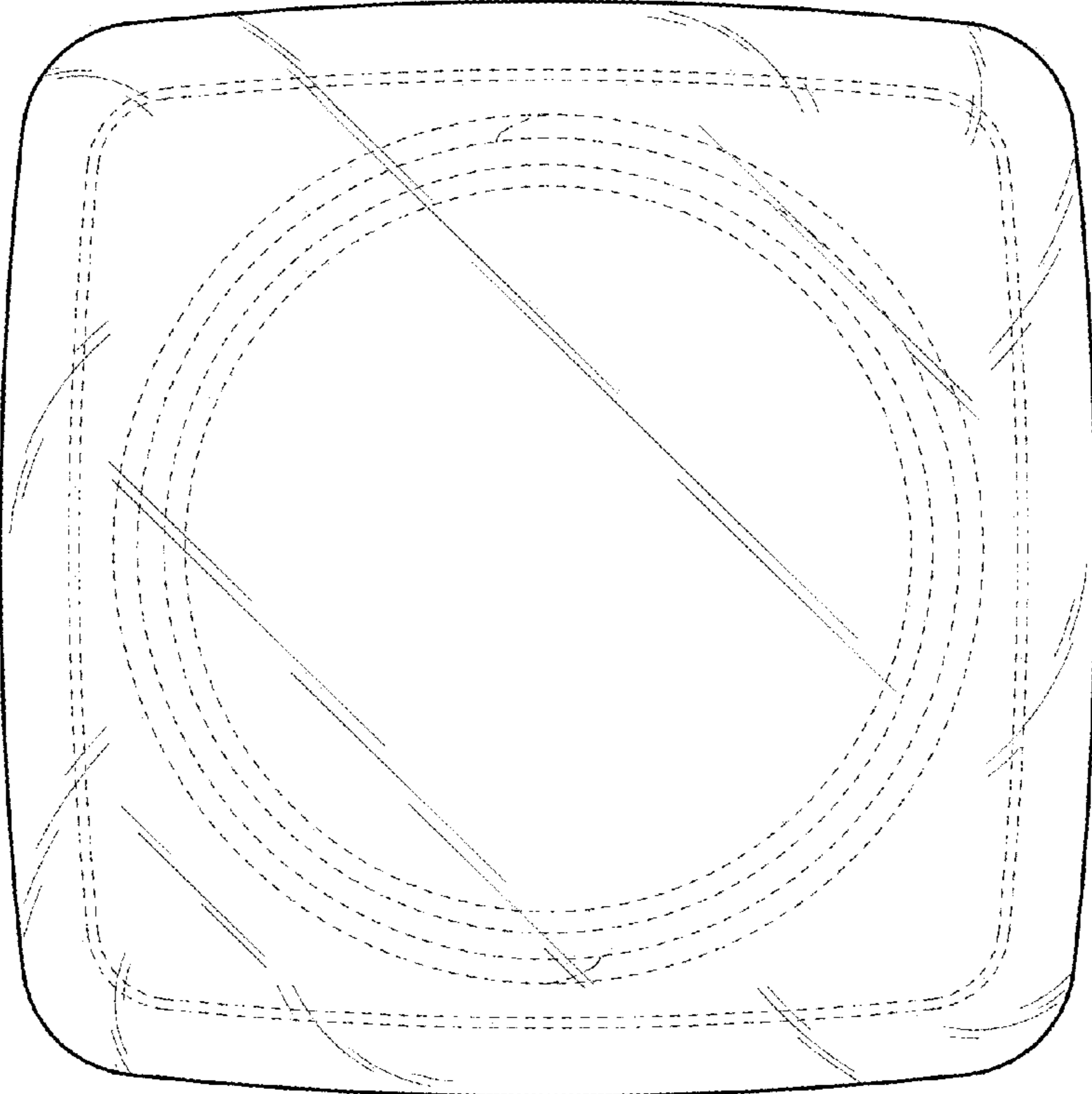


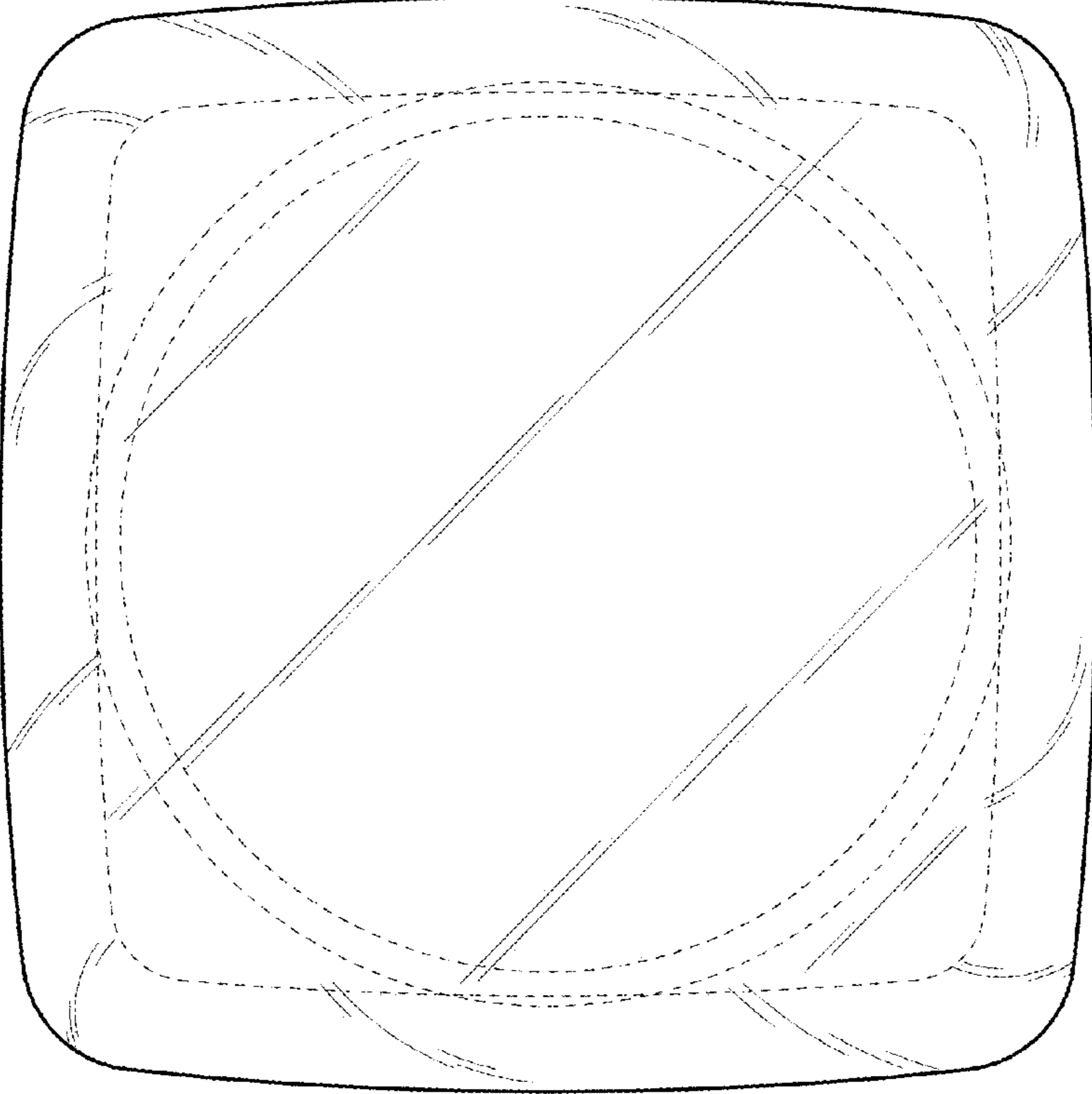

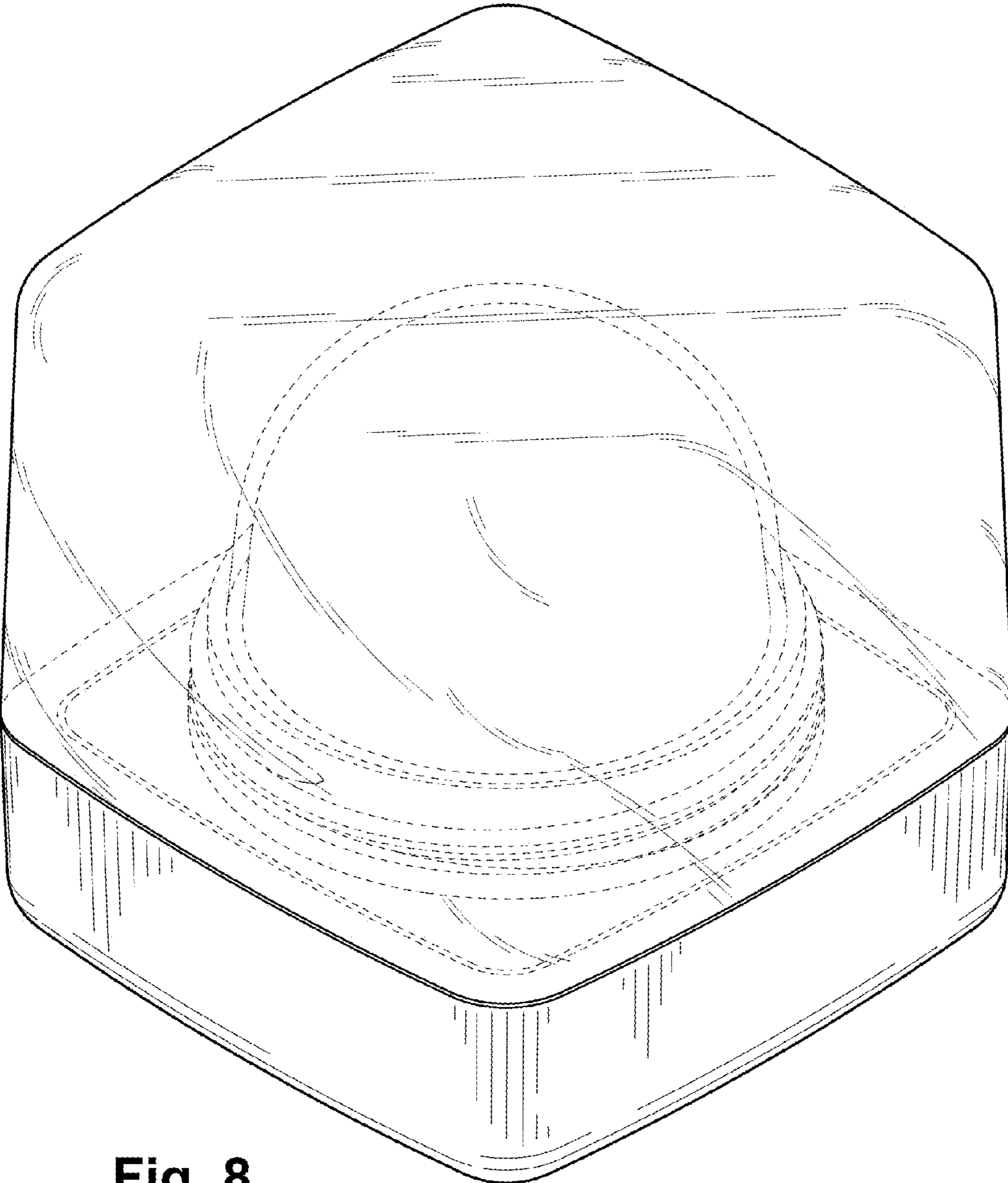

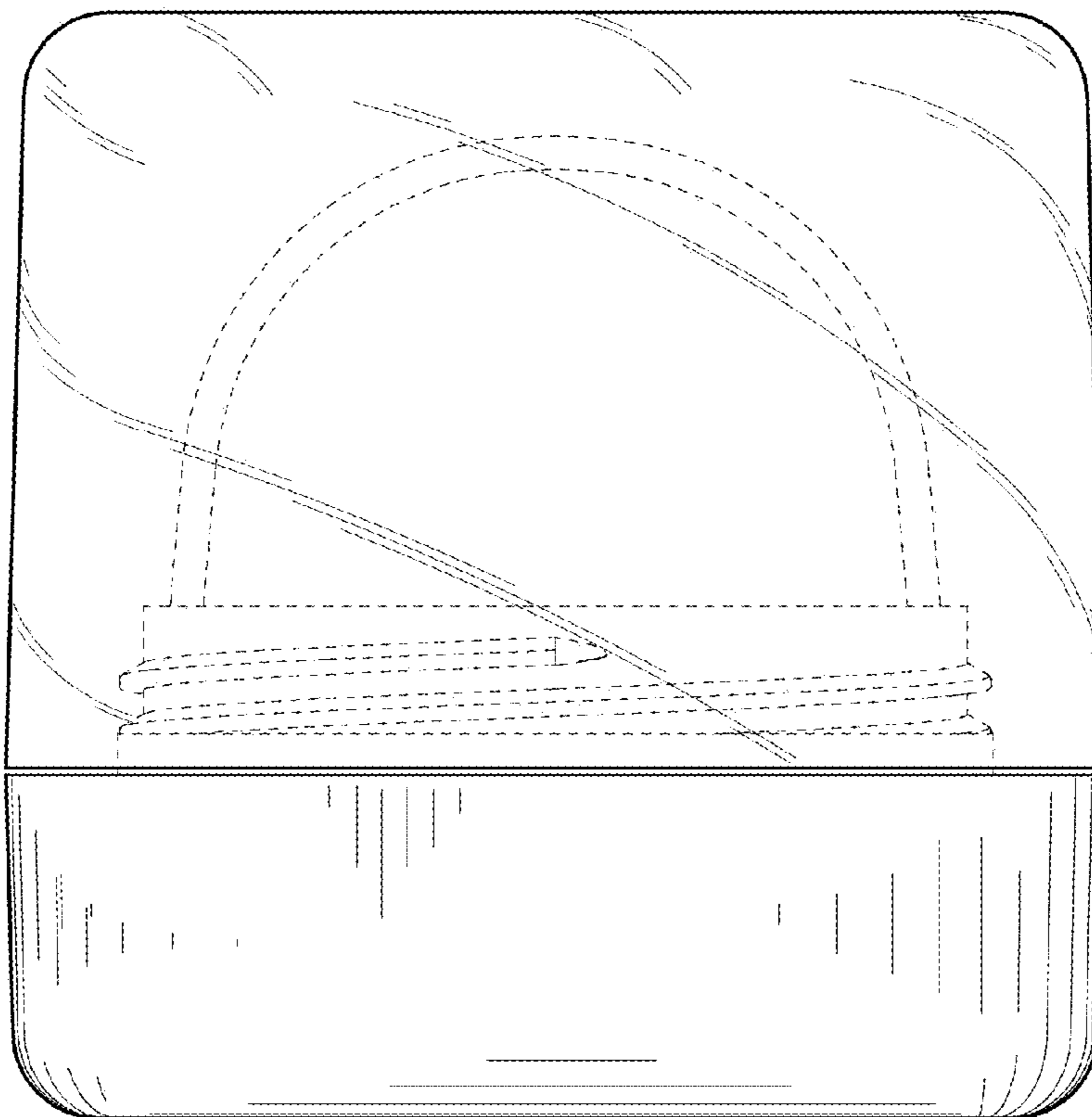

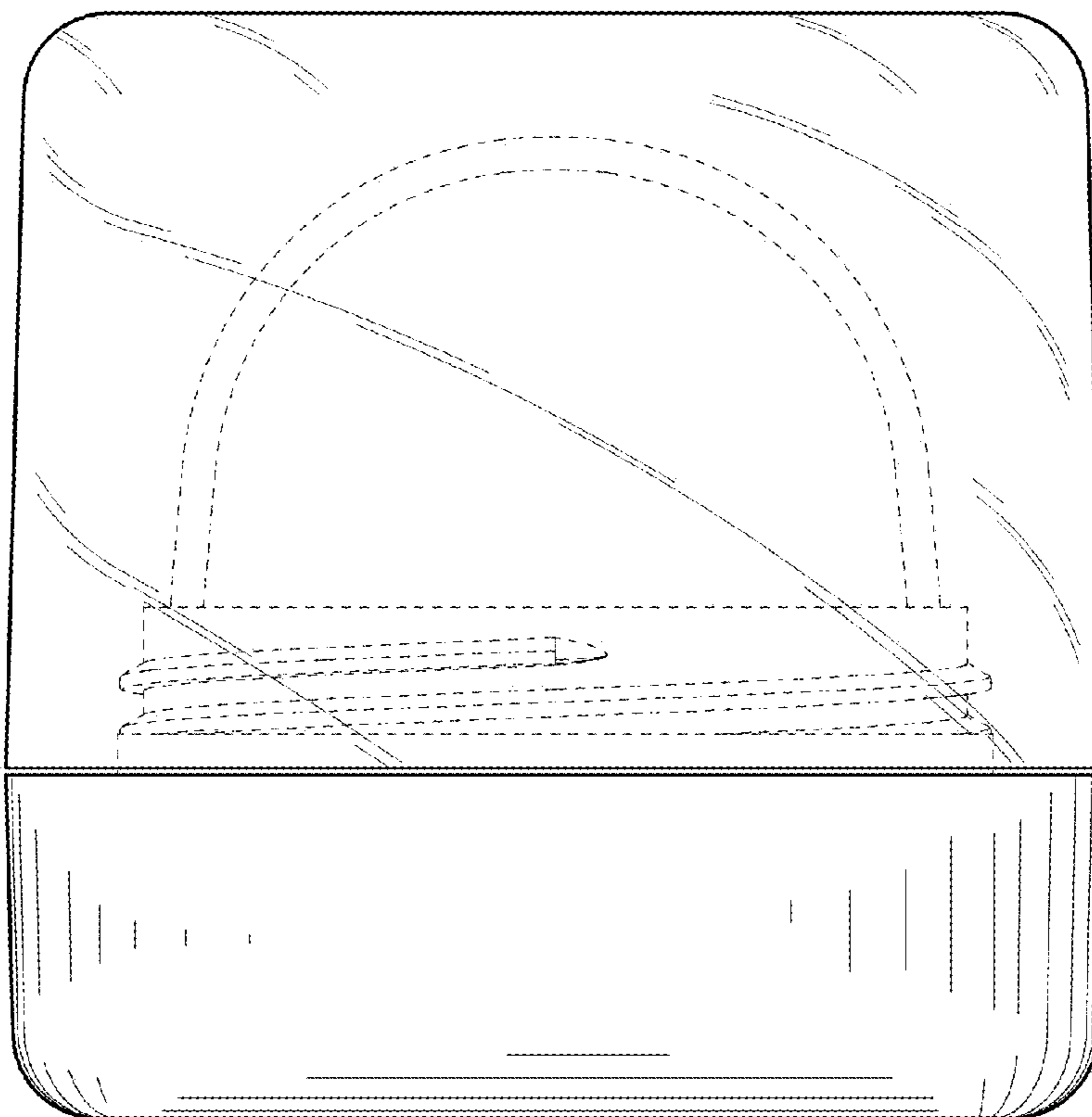

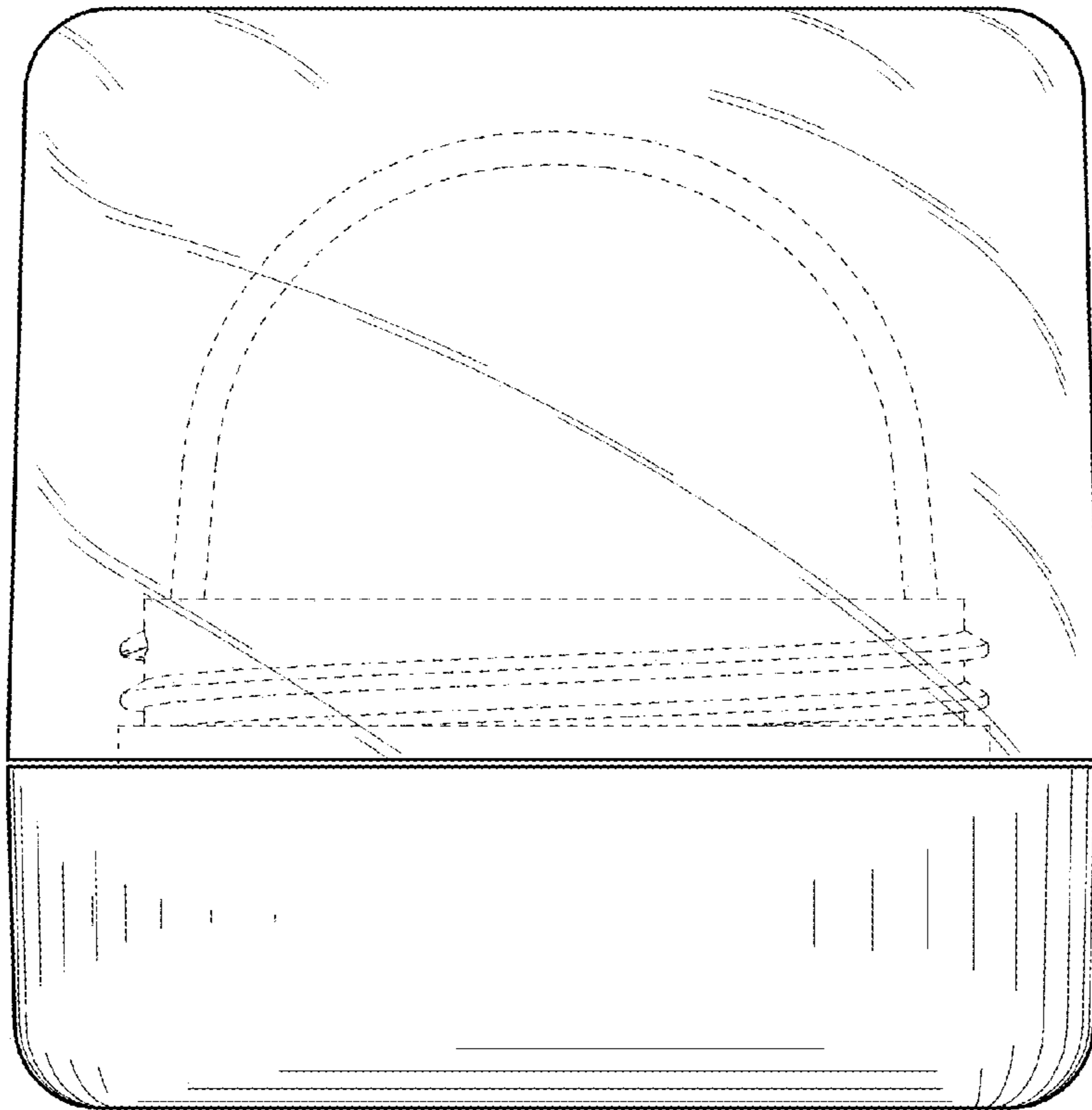
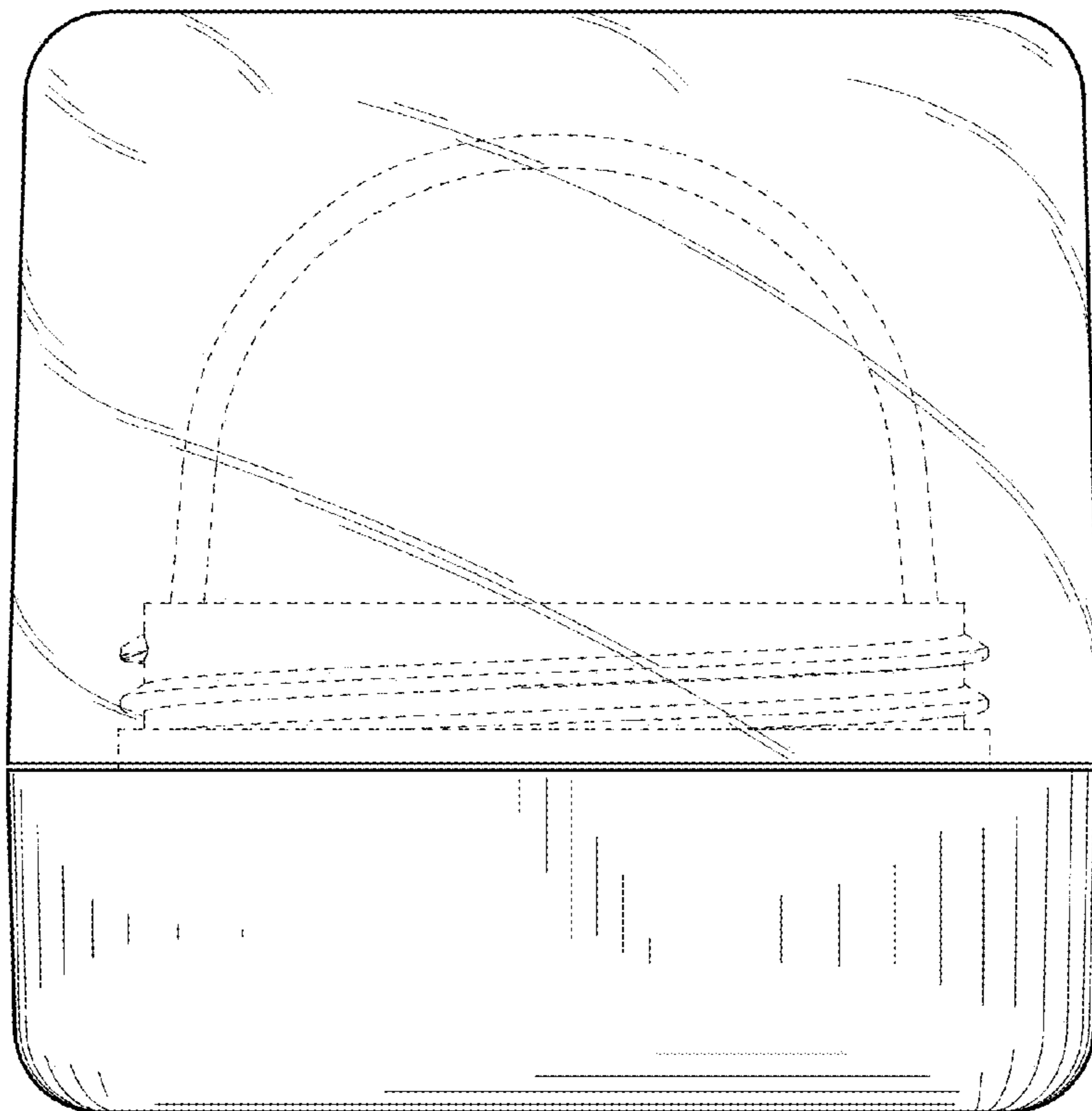
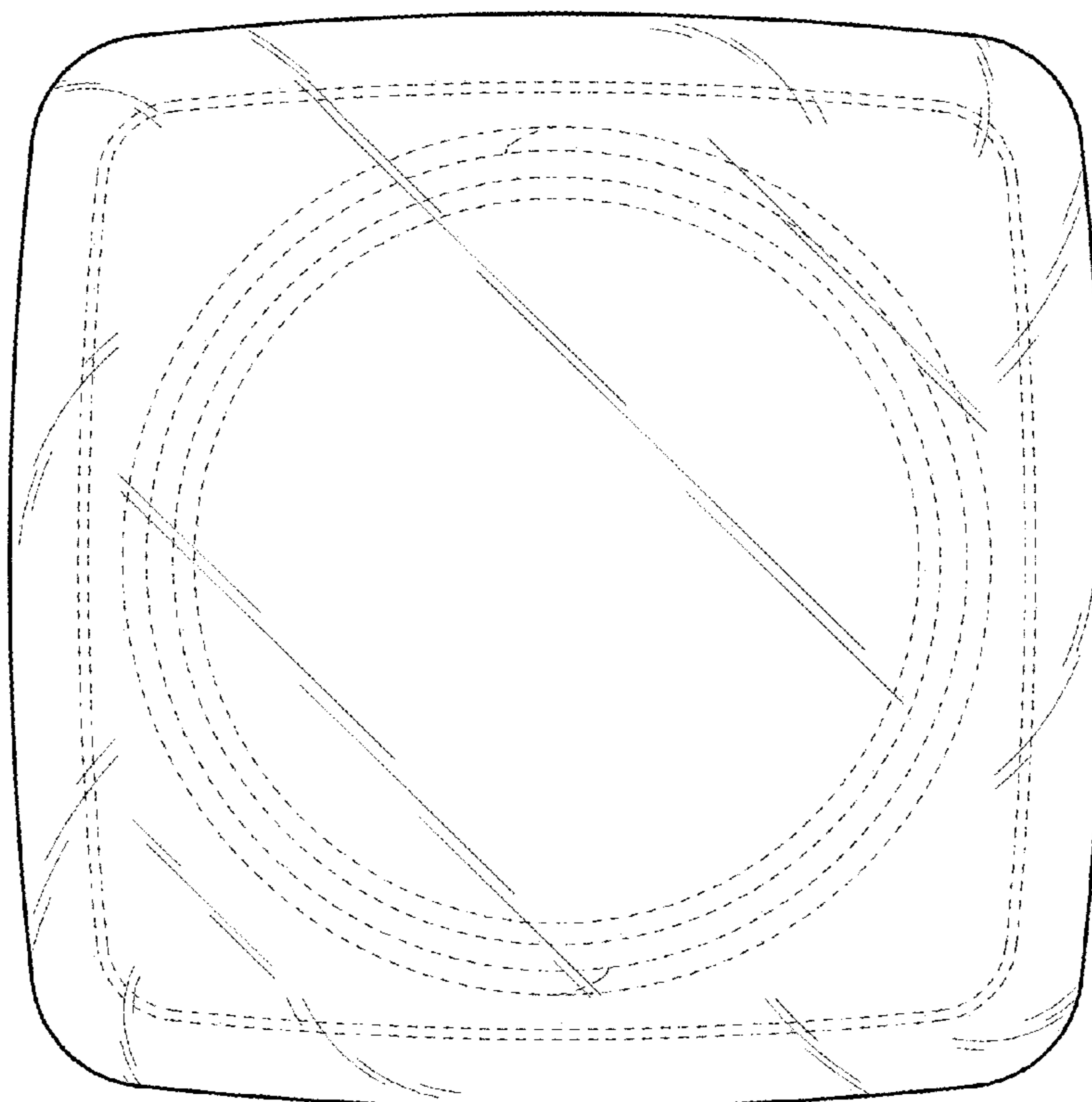


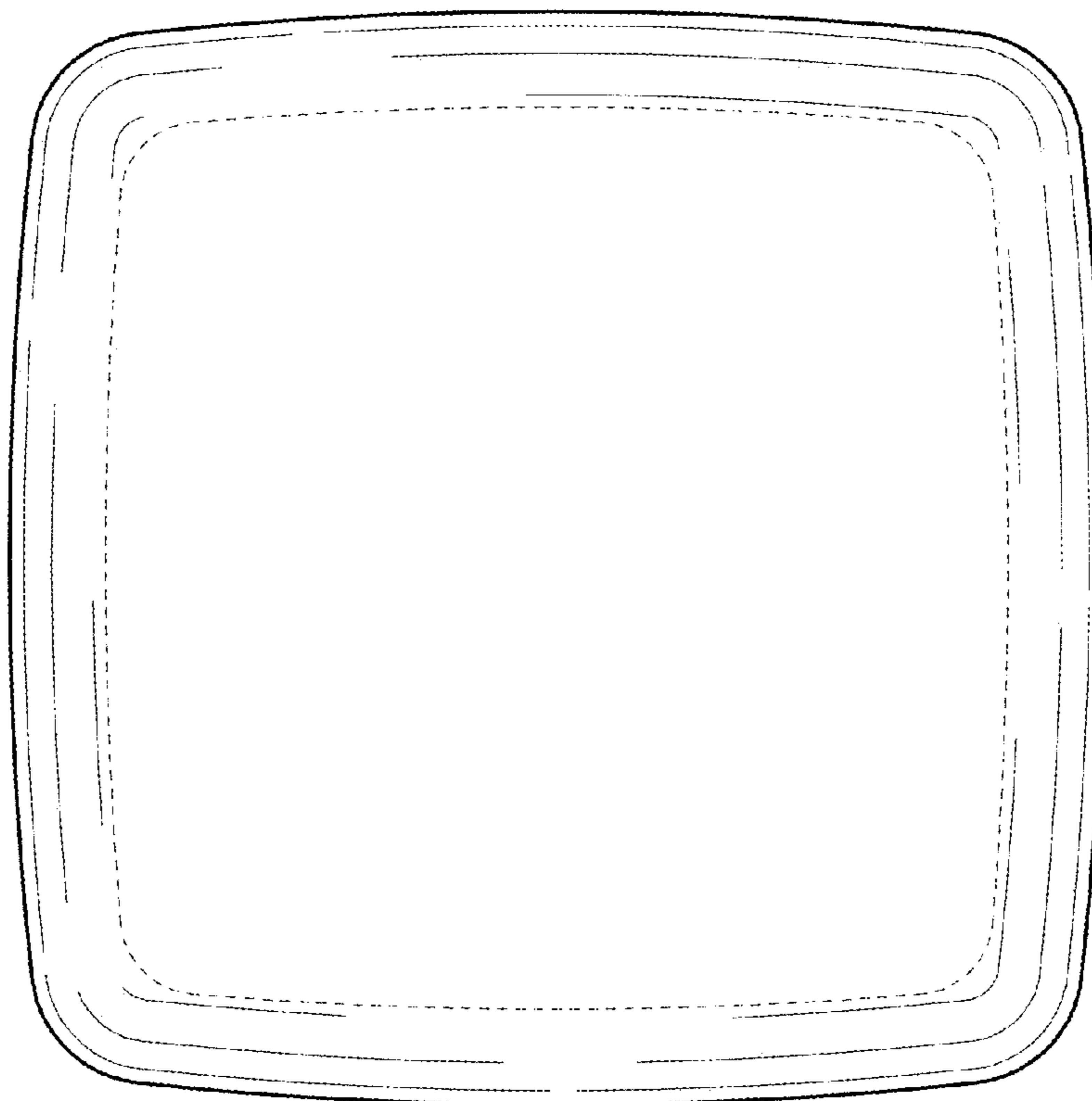

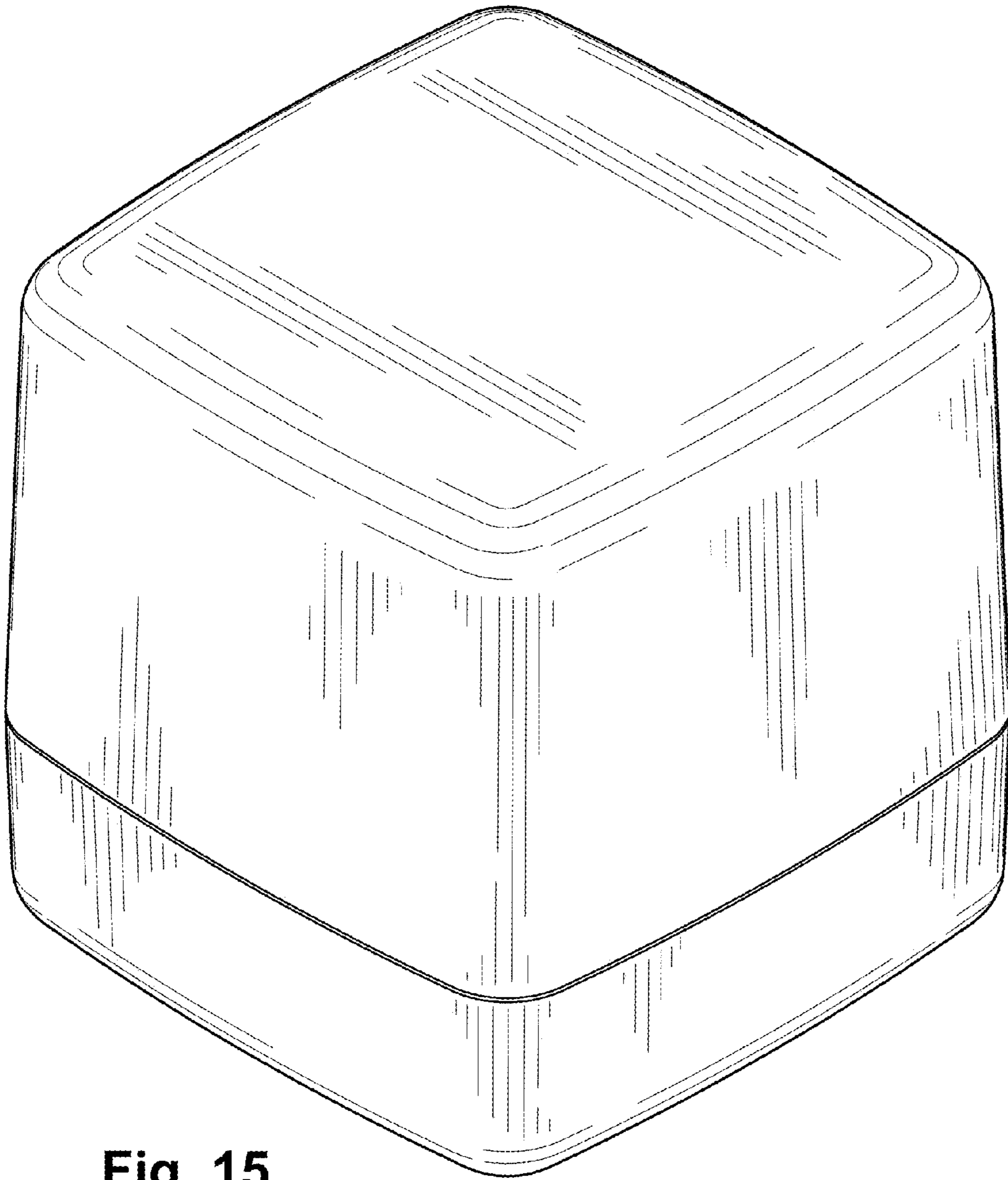

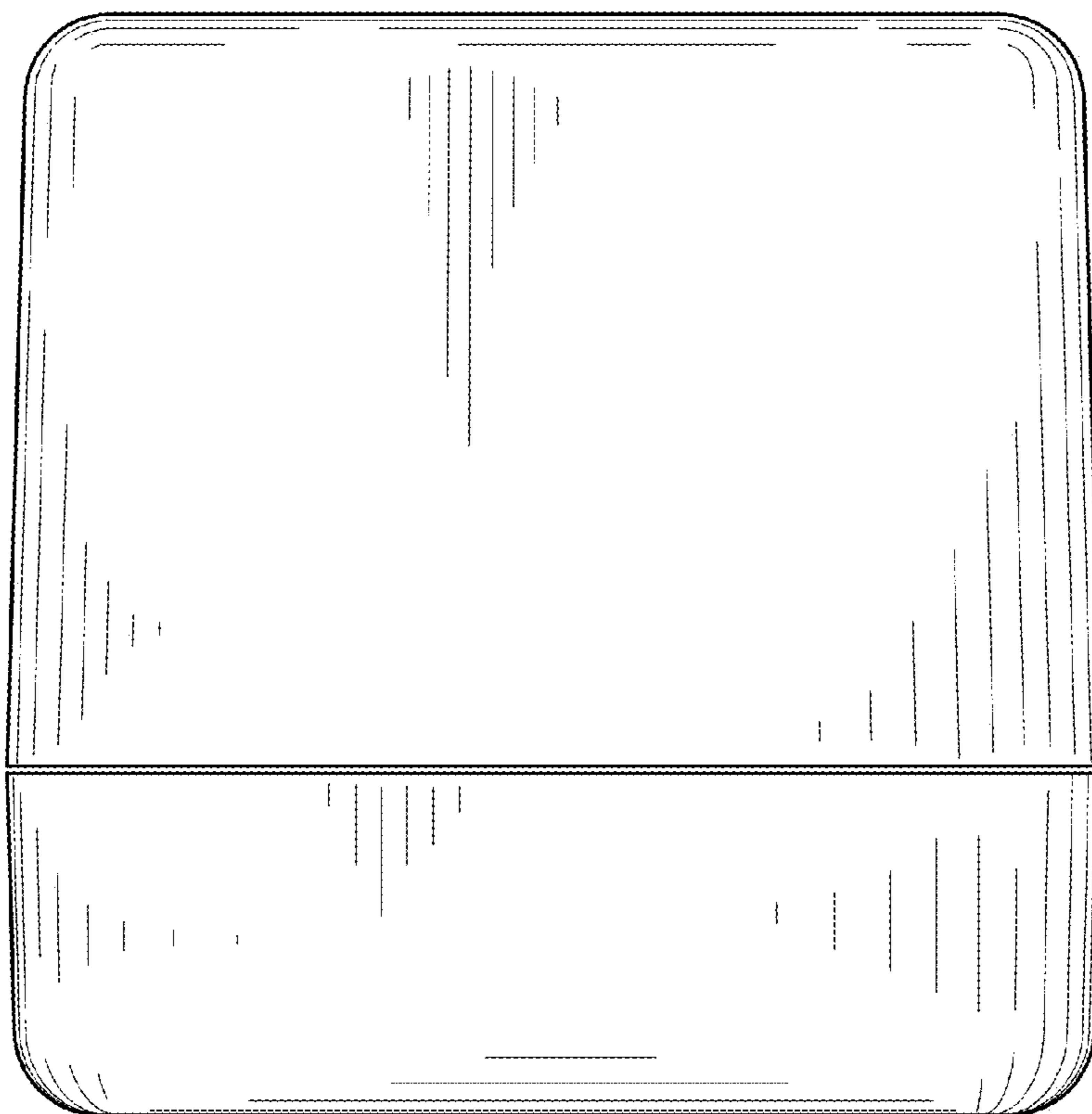

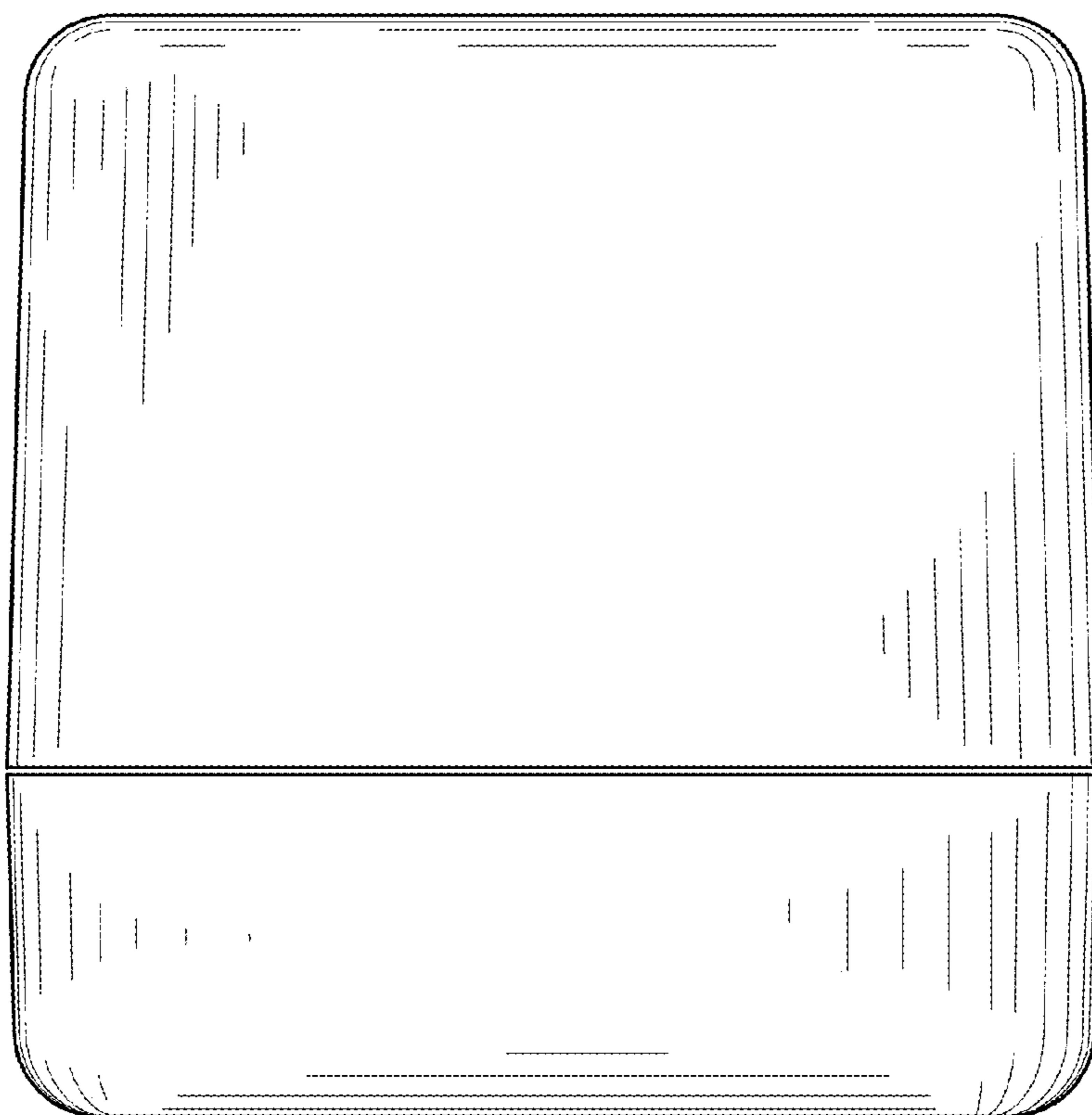

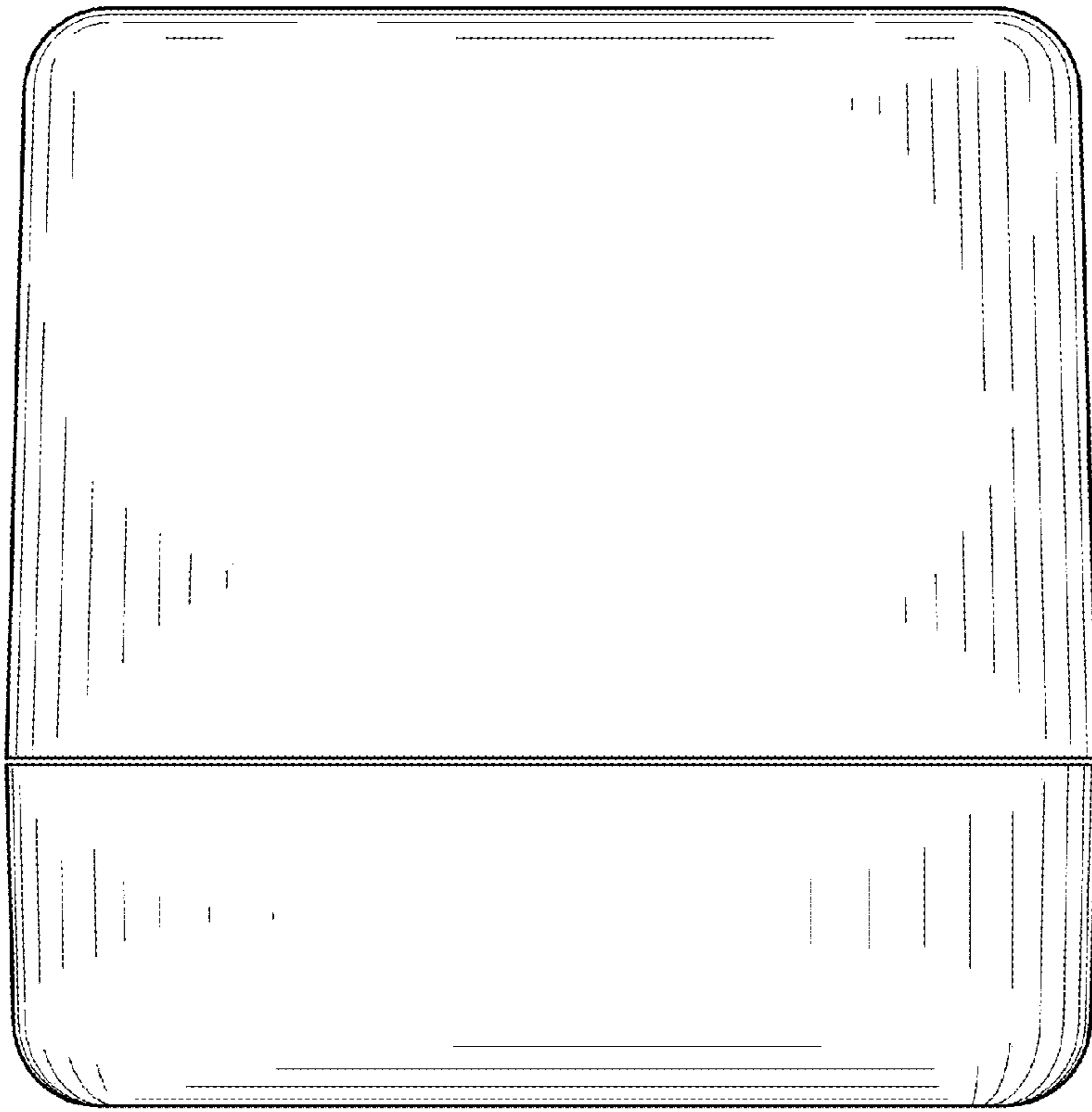

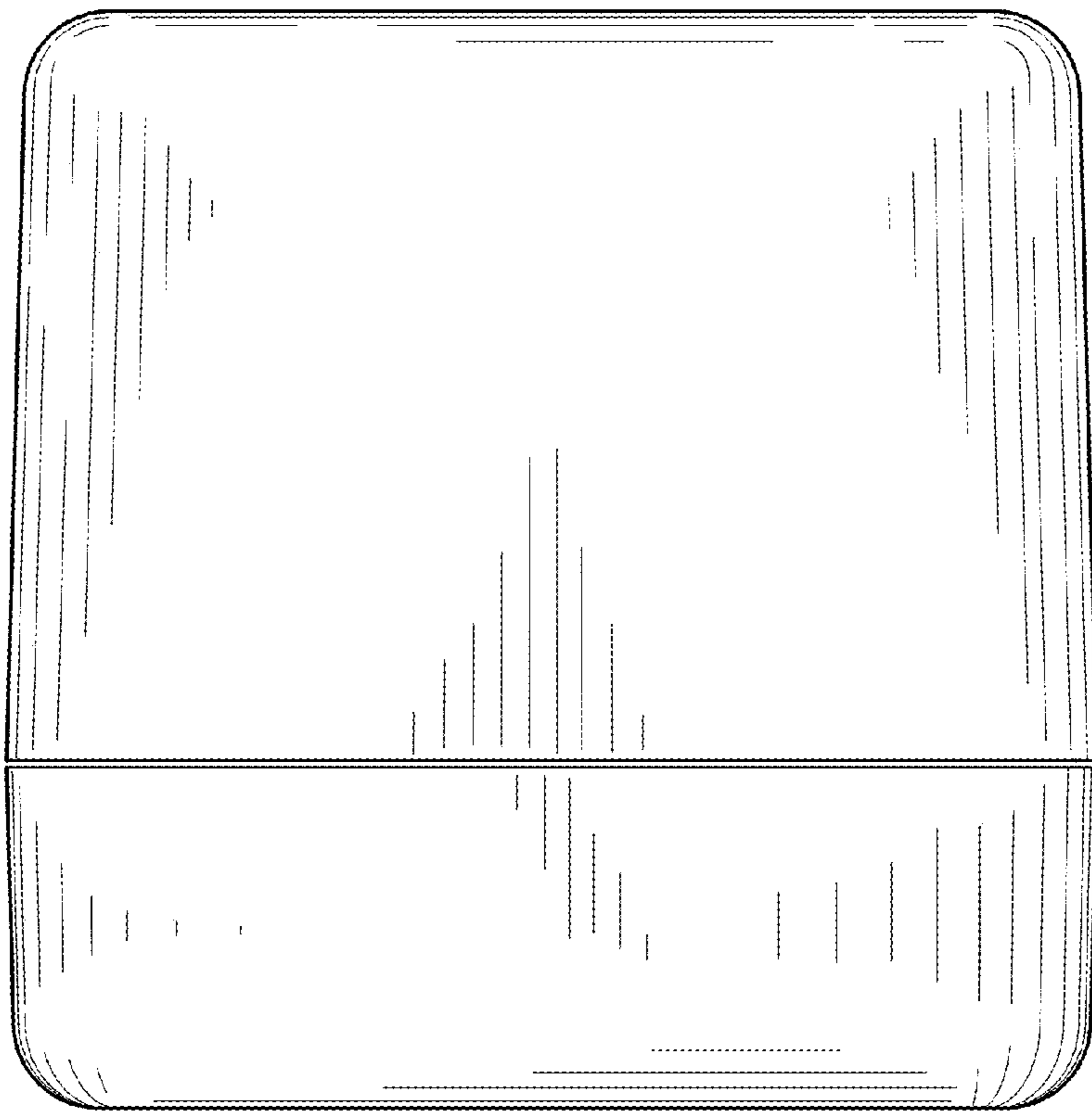

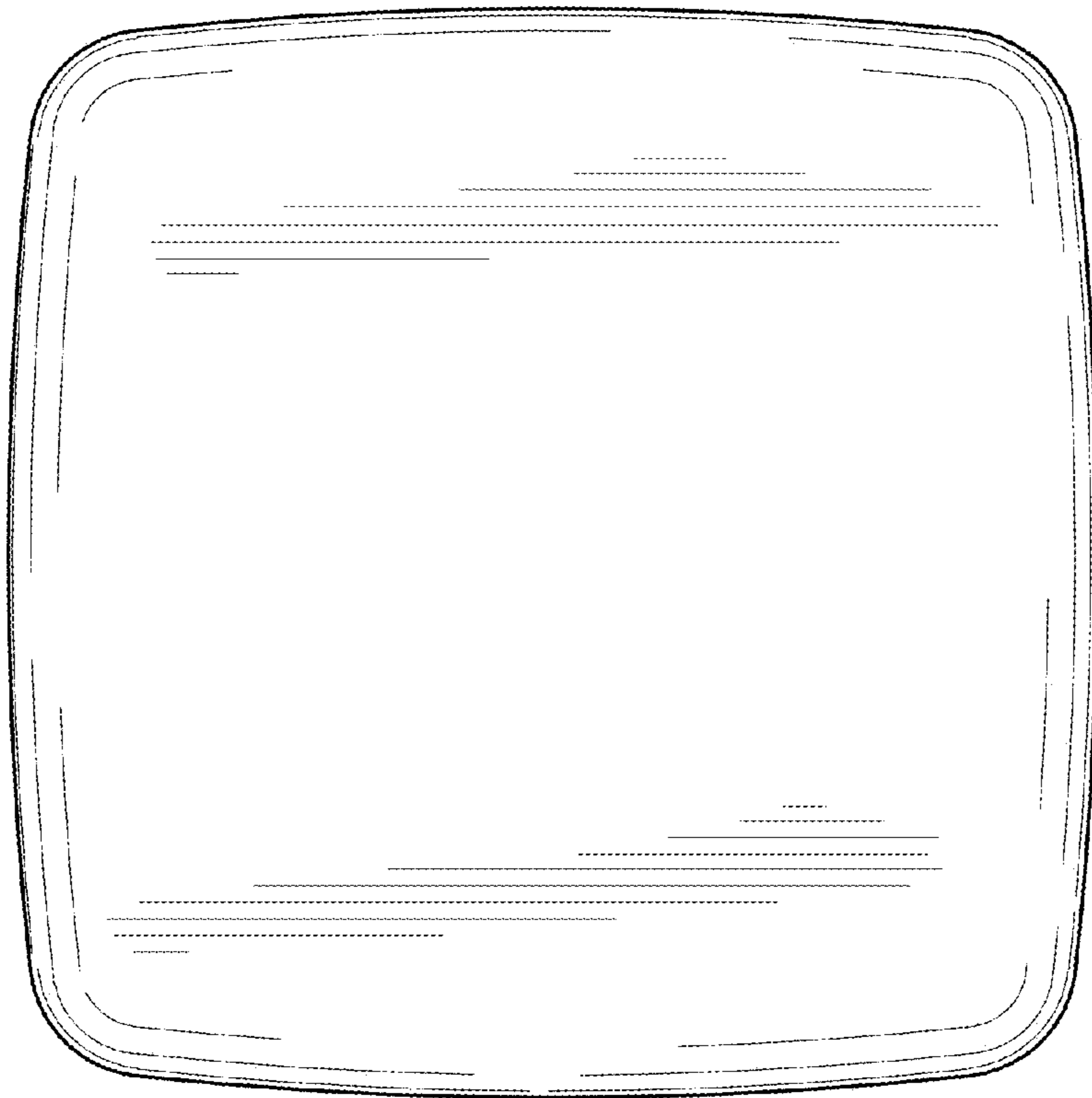
