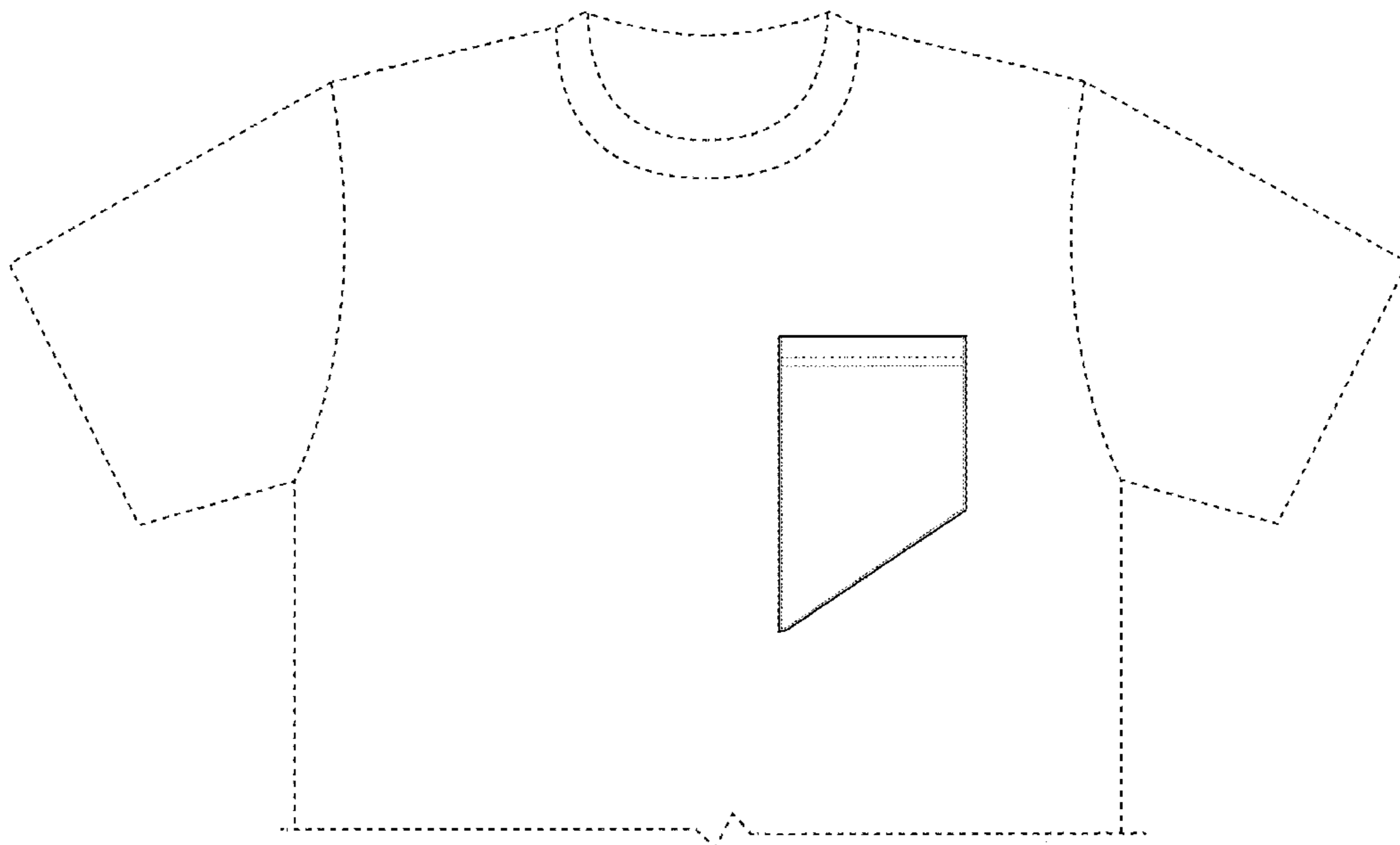
(57) **CLAIM**

The ornamental design for an E-cigarette pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an E-cigarette pocket showing my new design positioned on a representative garment, FIG. 2 is a perspective view thereof. FIG. 3 is a top view thereof. FIG. 4 is a bottom view thereof. FIG. 5 is a left side view thereof; and, FIG. 6 is a right side view thereof. The smaller broken lines shown on the surface of the pocket in the figures represent stitching and form no part of the claimed design. The larger broken lines shown in FIGS. 1-2 represent environmental structure only and form no part of the claimed design.

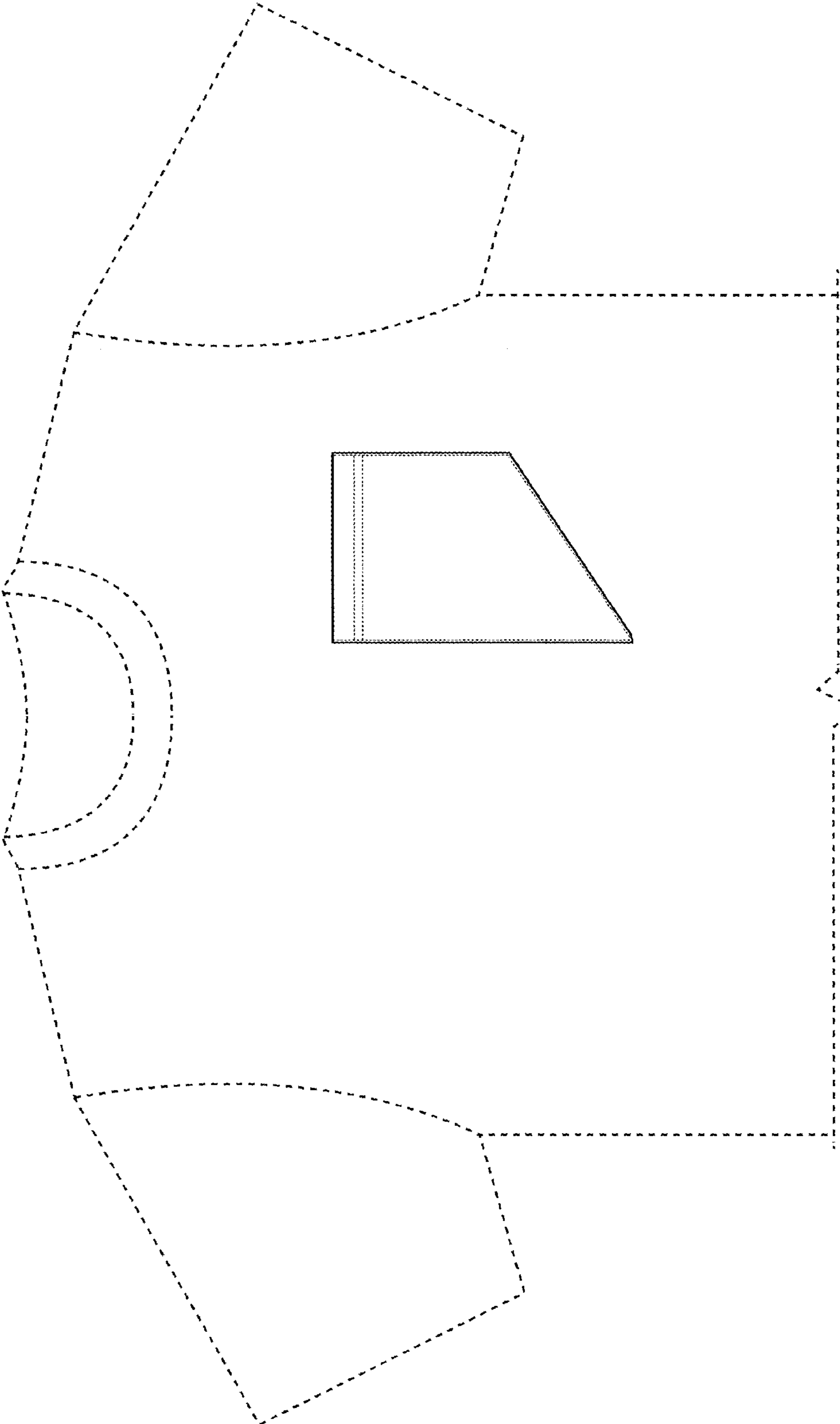

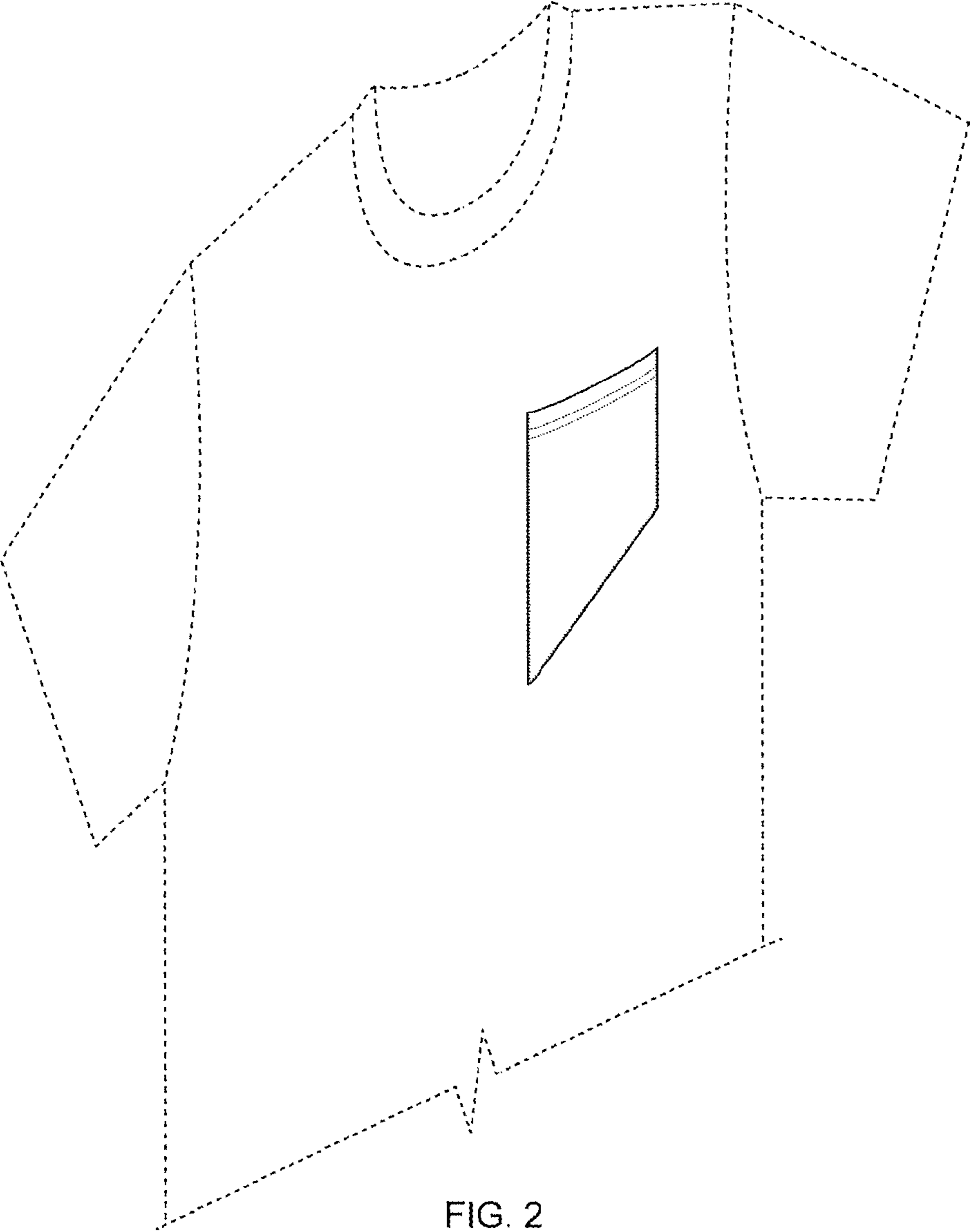

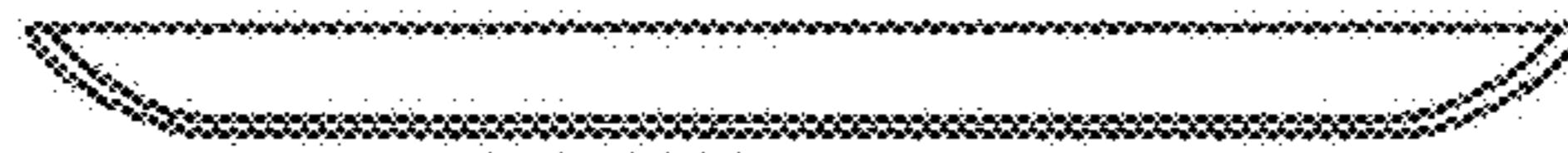

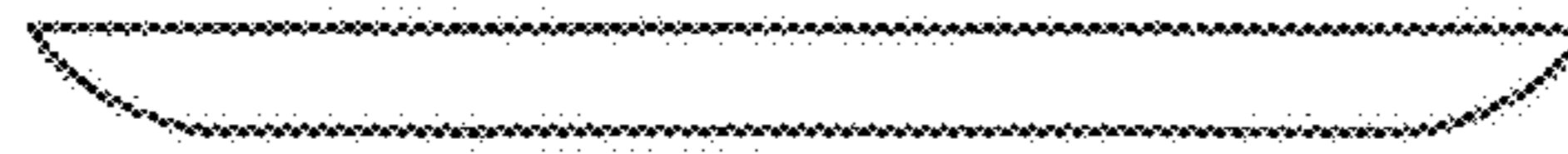

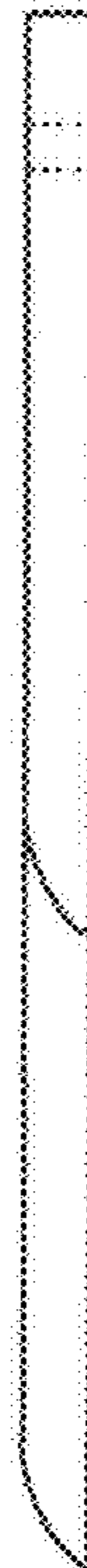
