**DESCRIPTION**

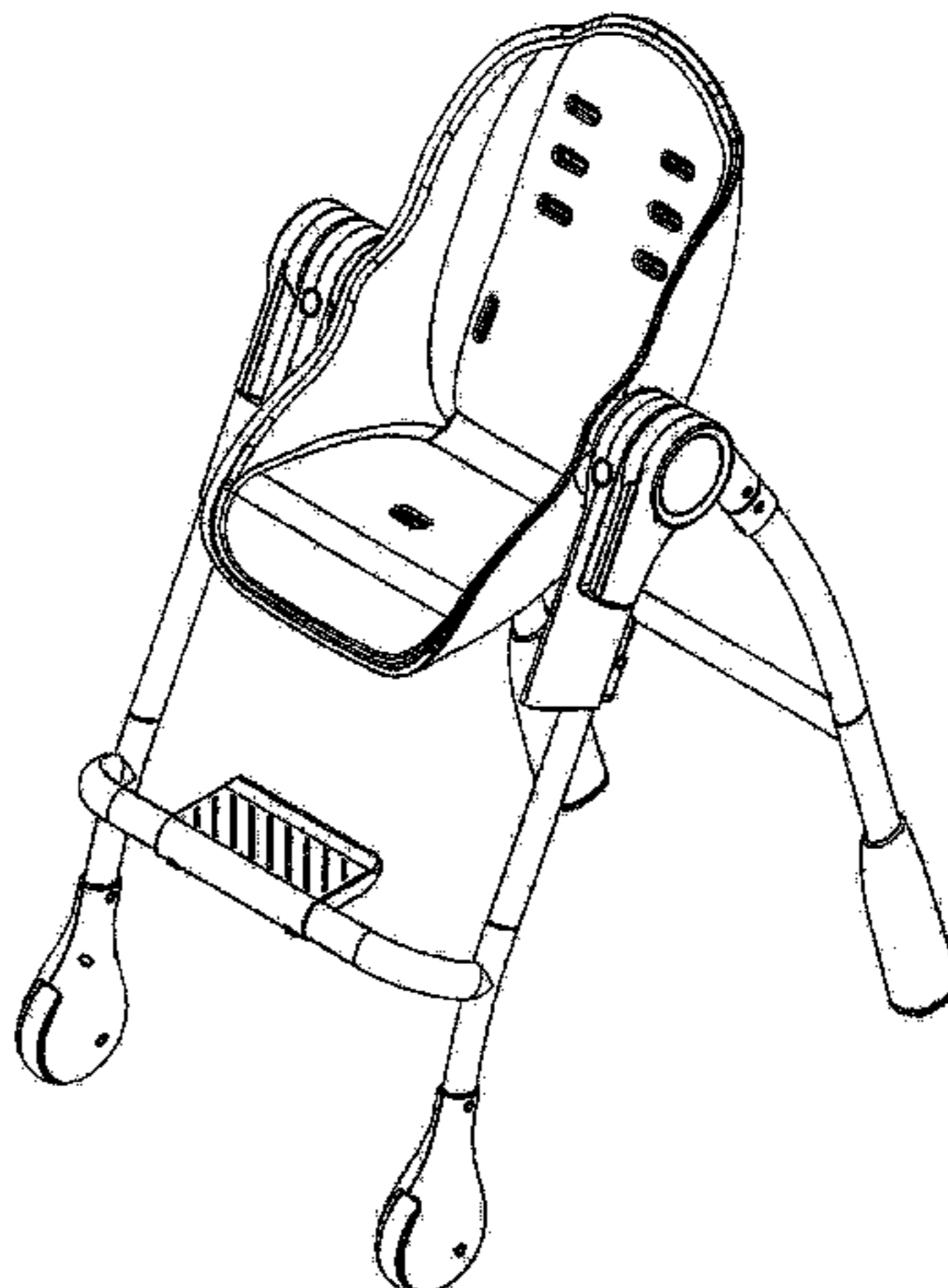
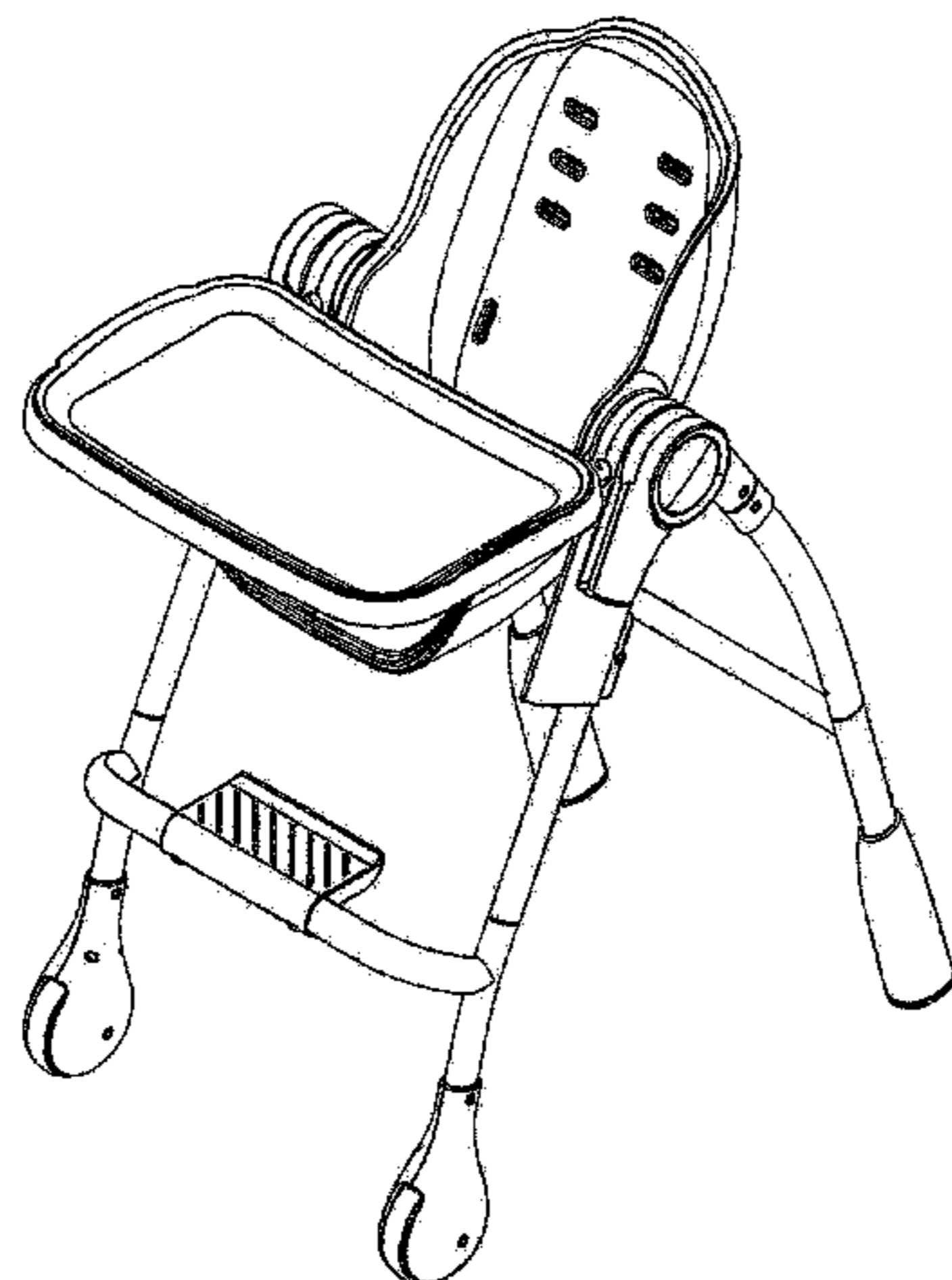

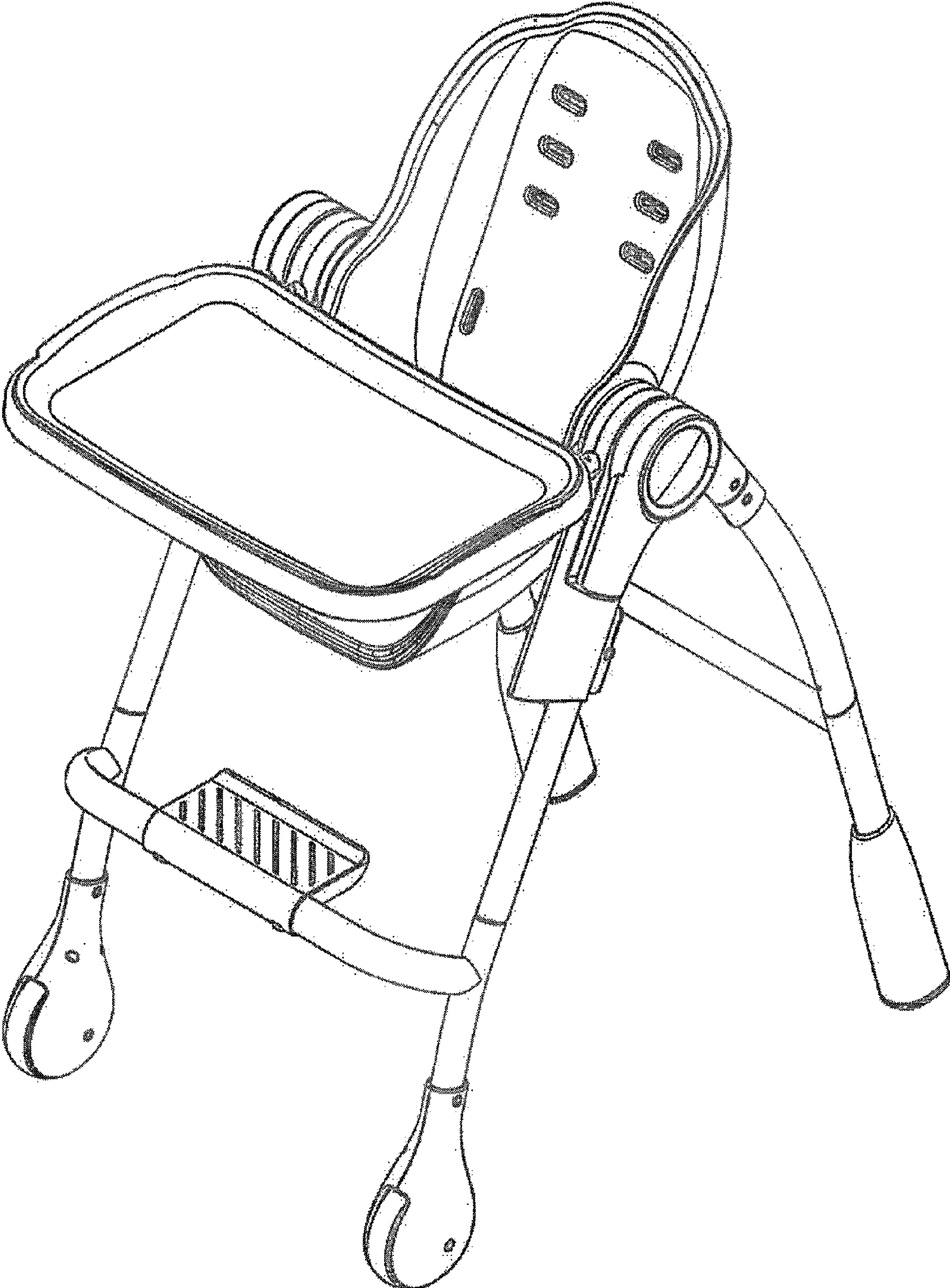

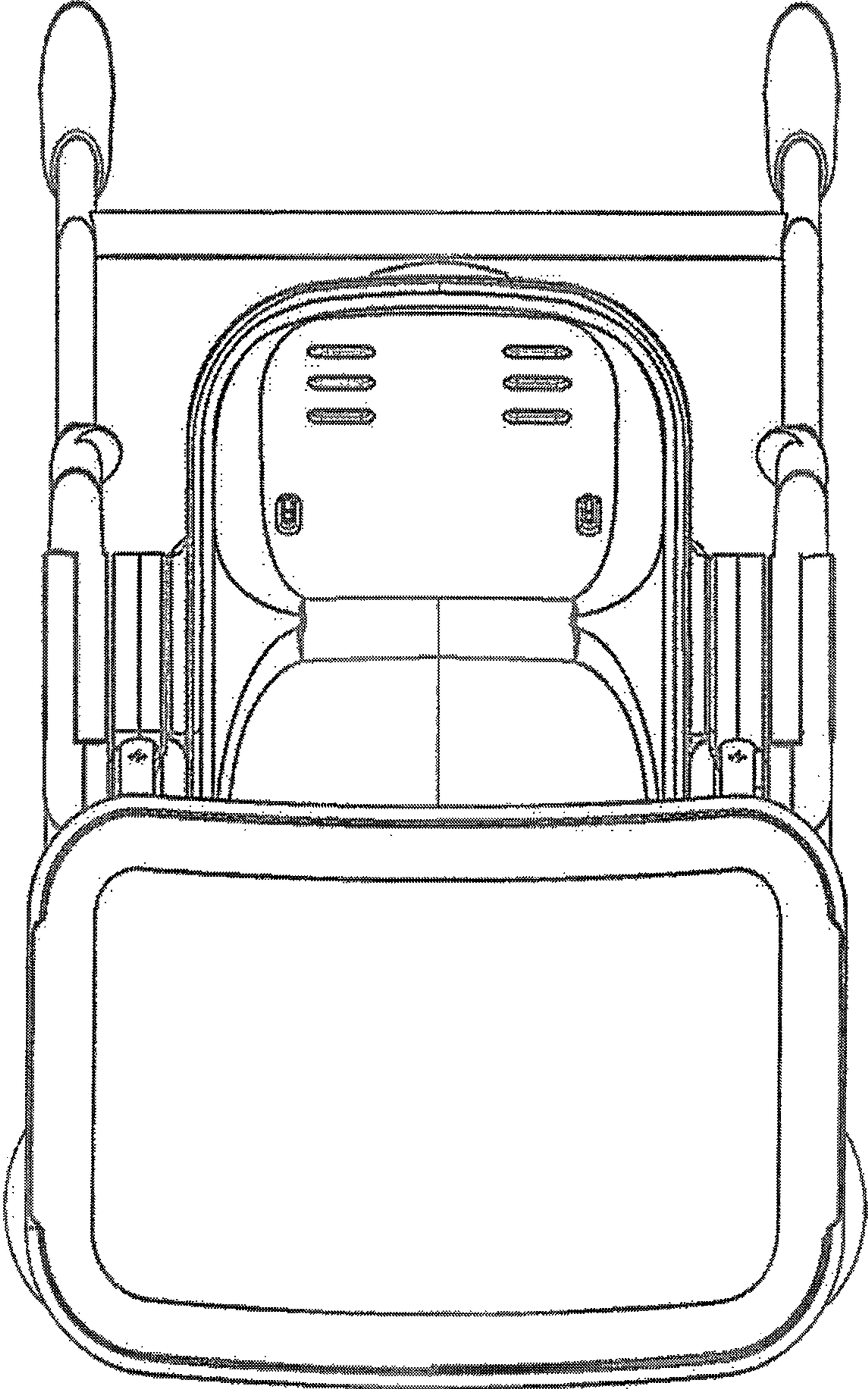

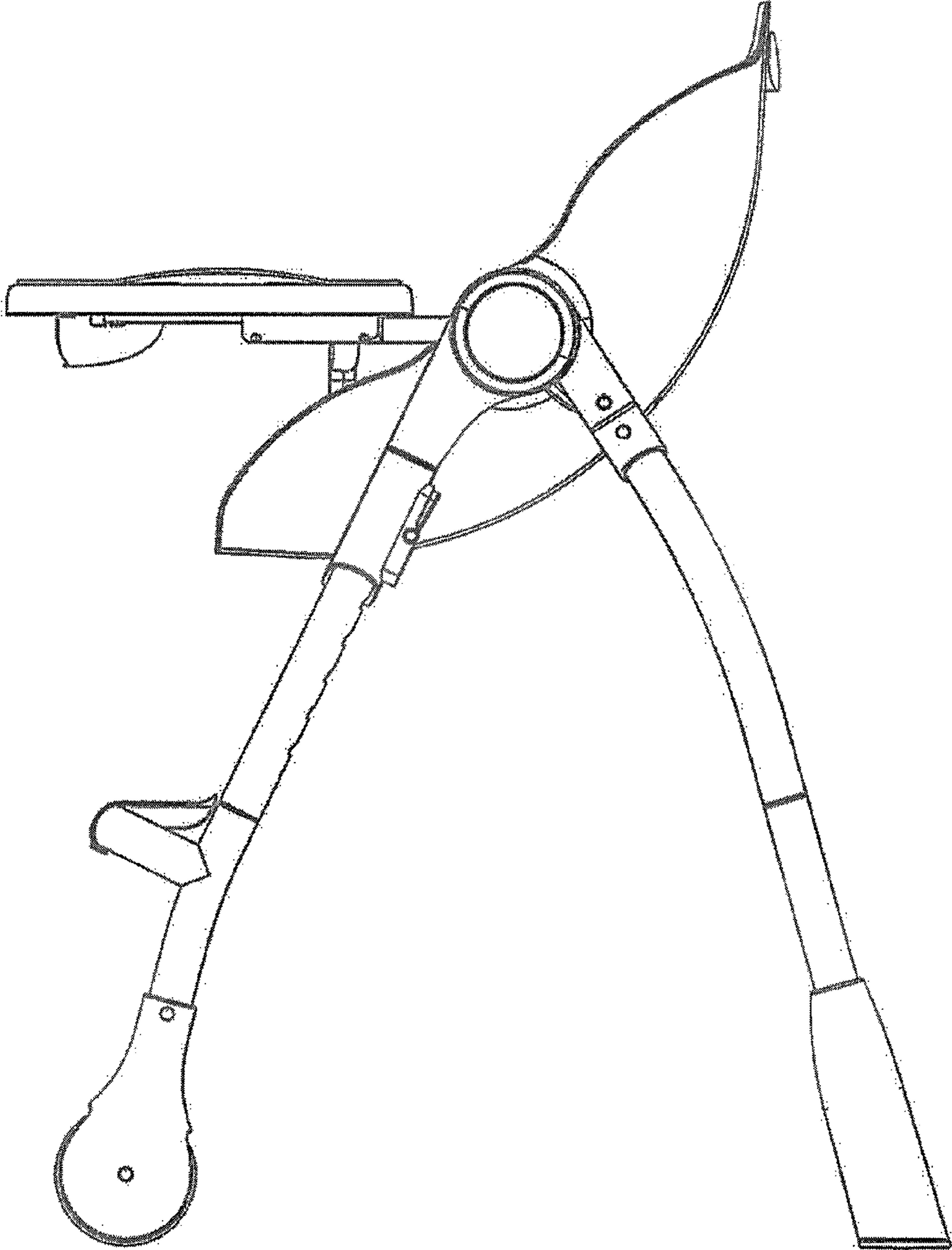

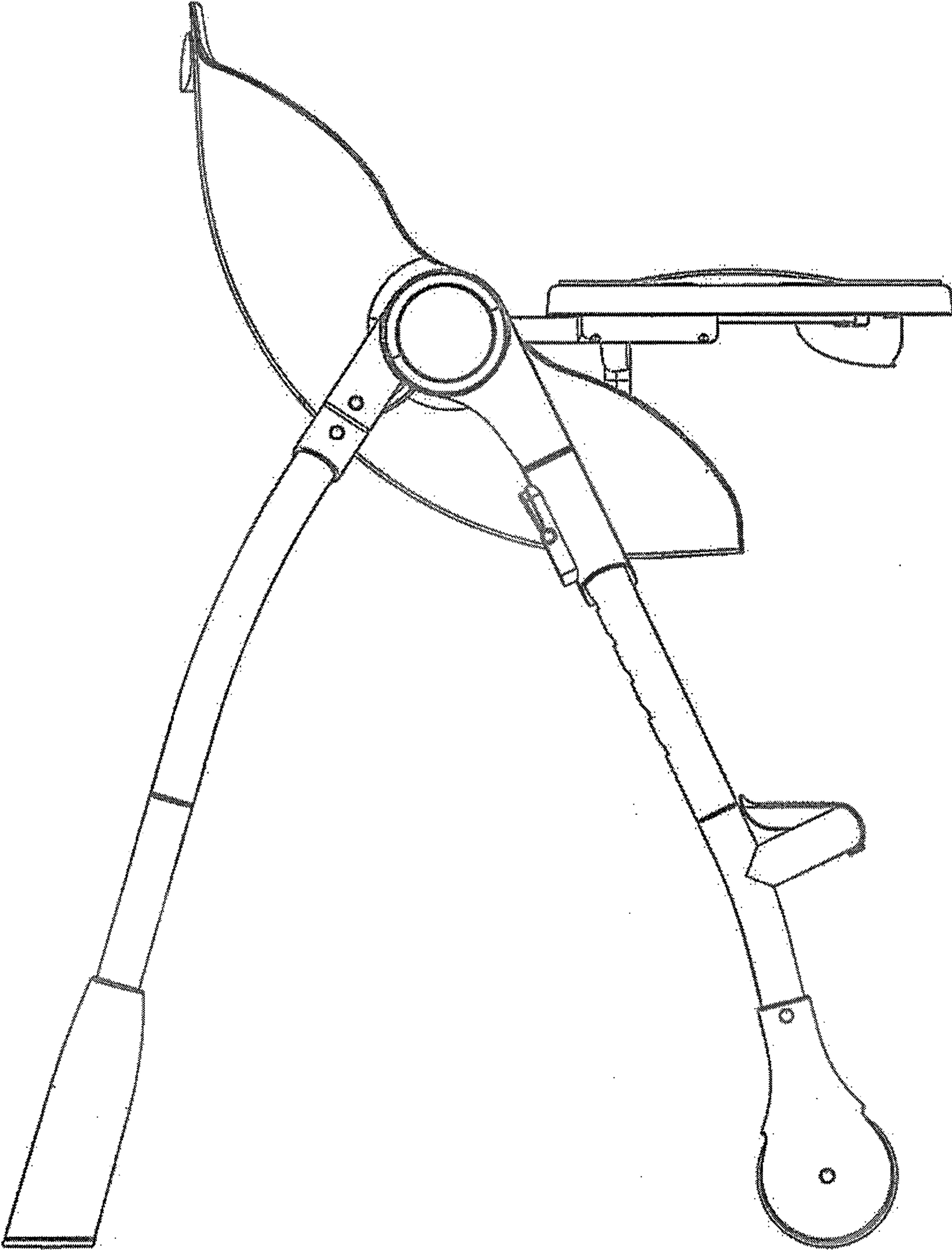

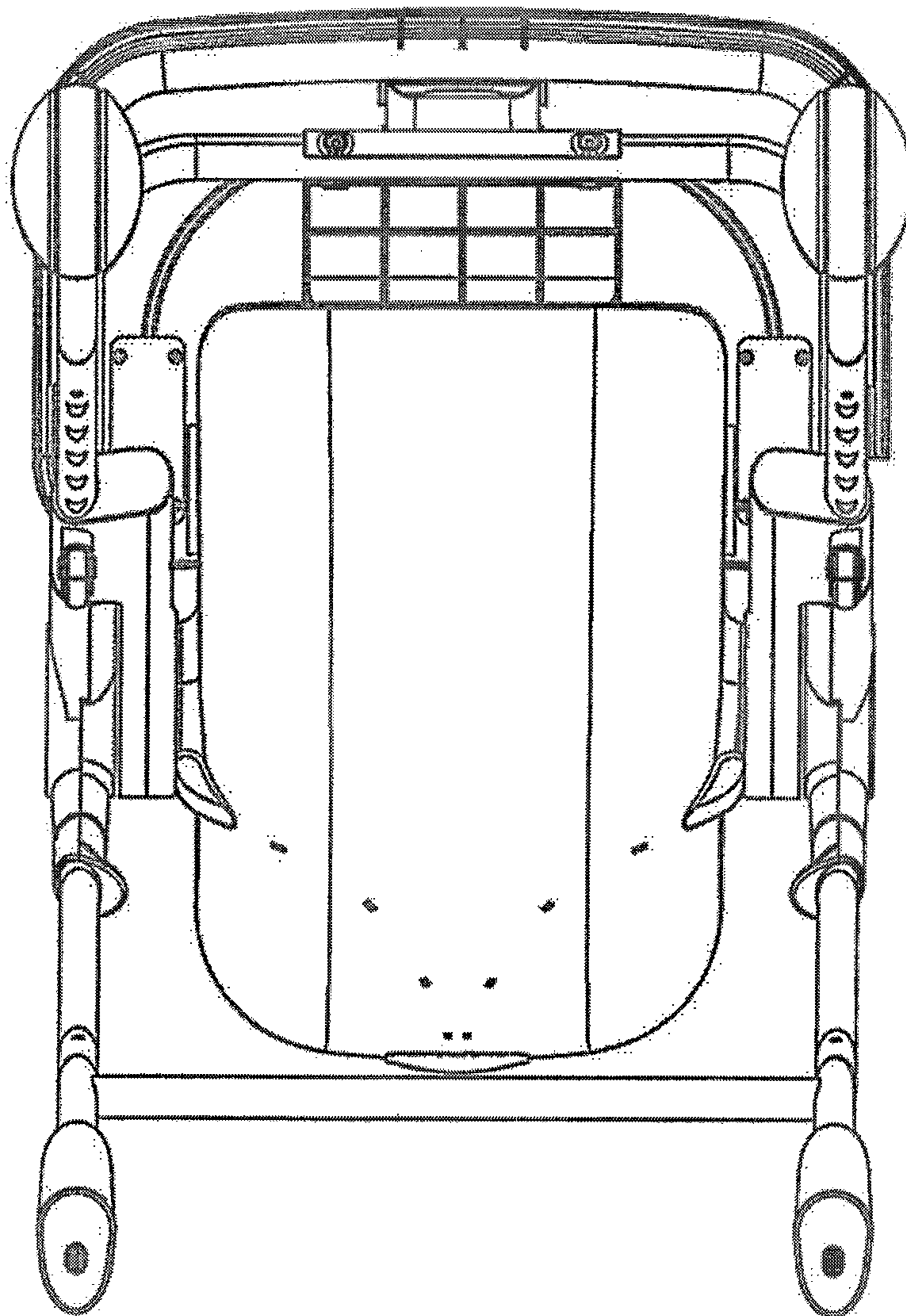

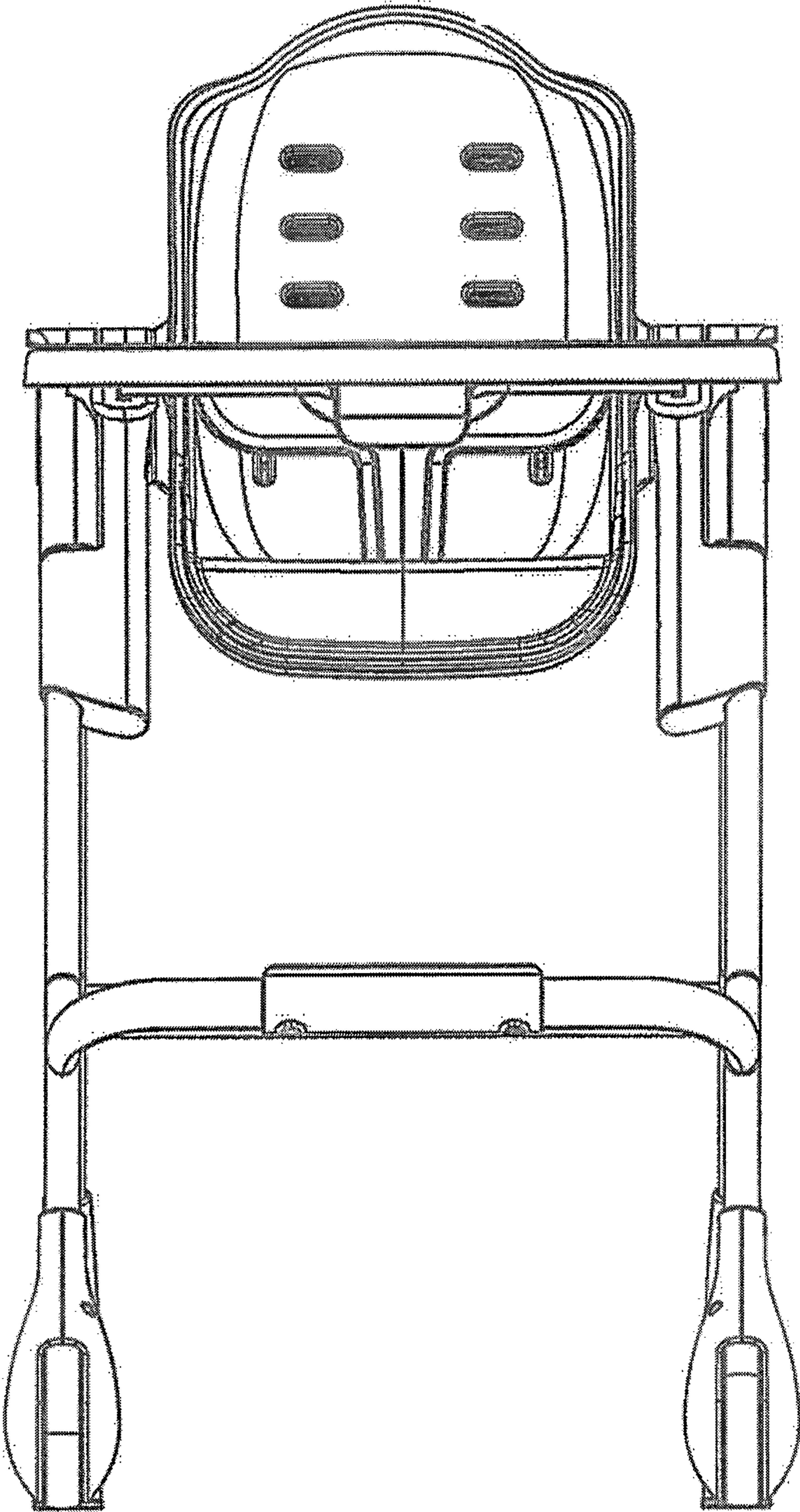

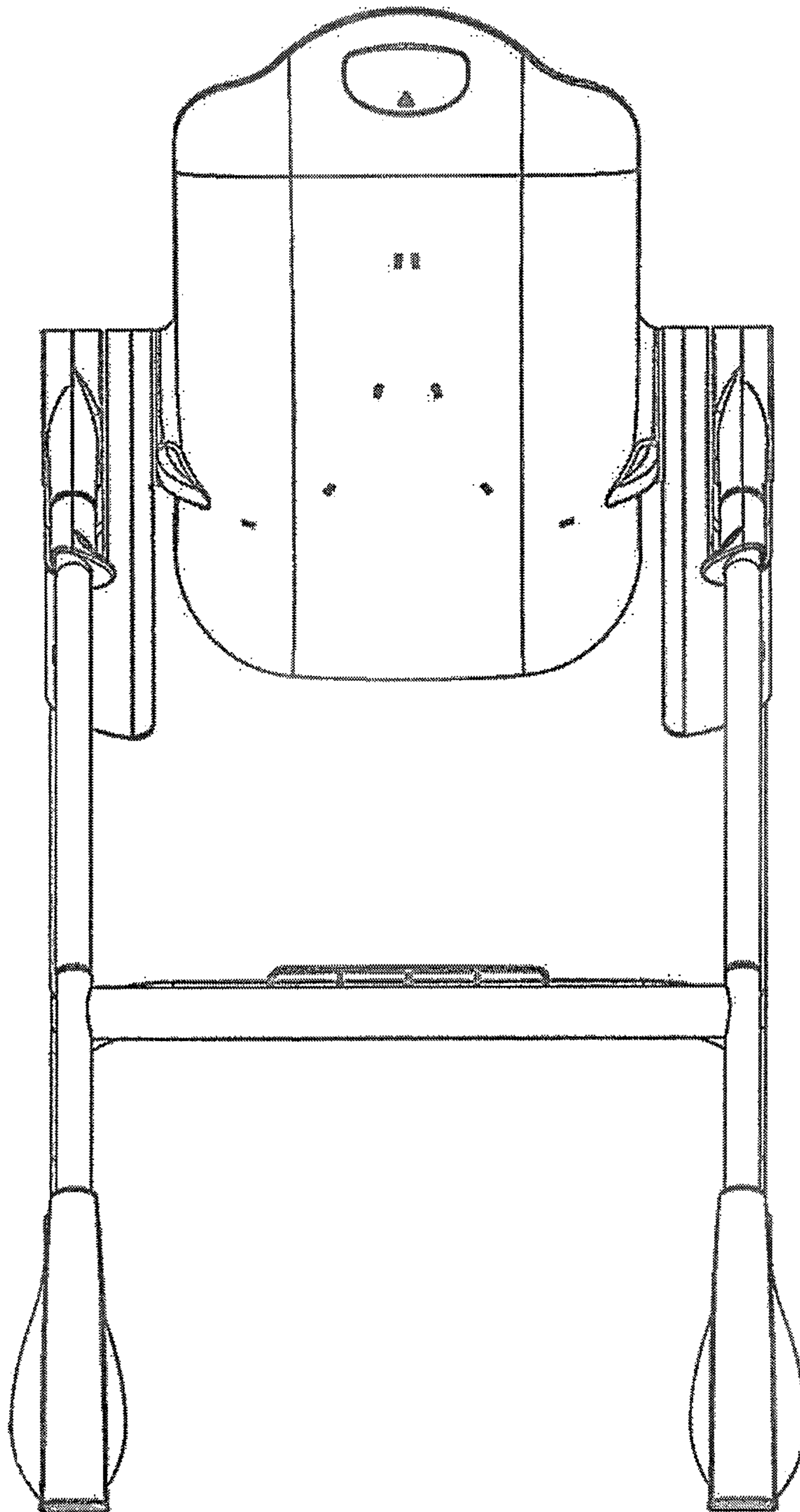

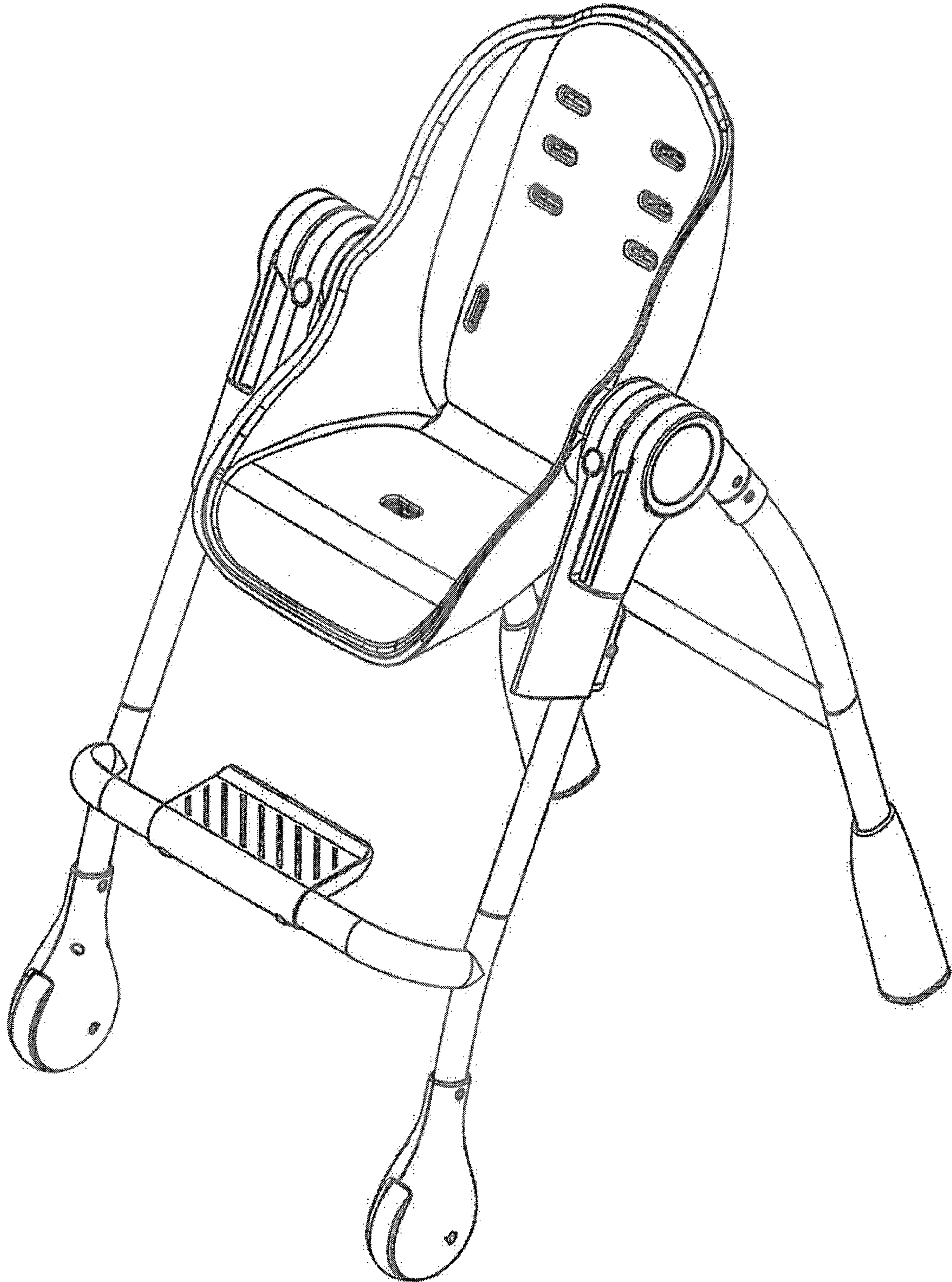

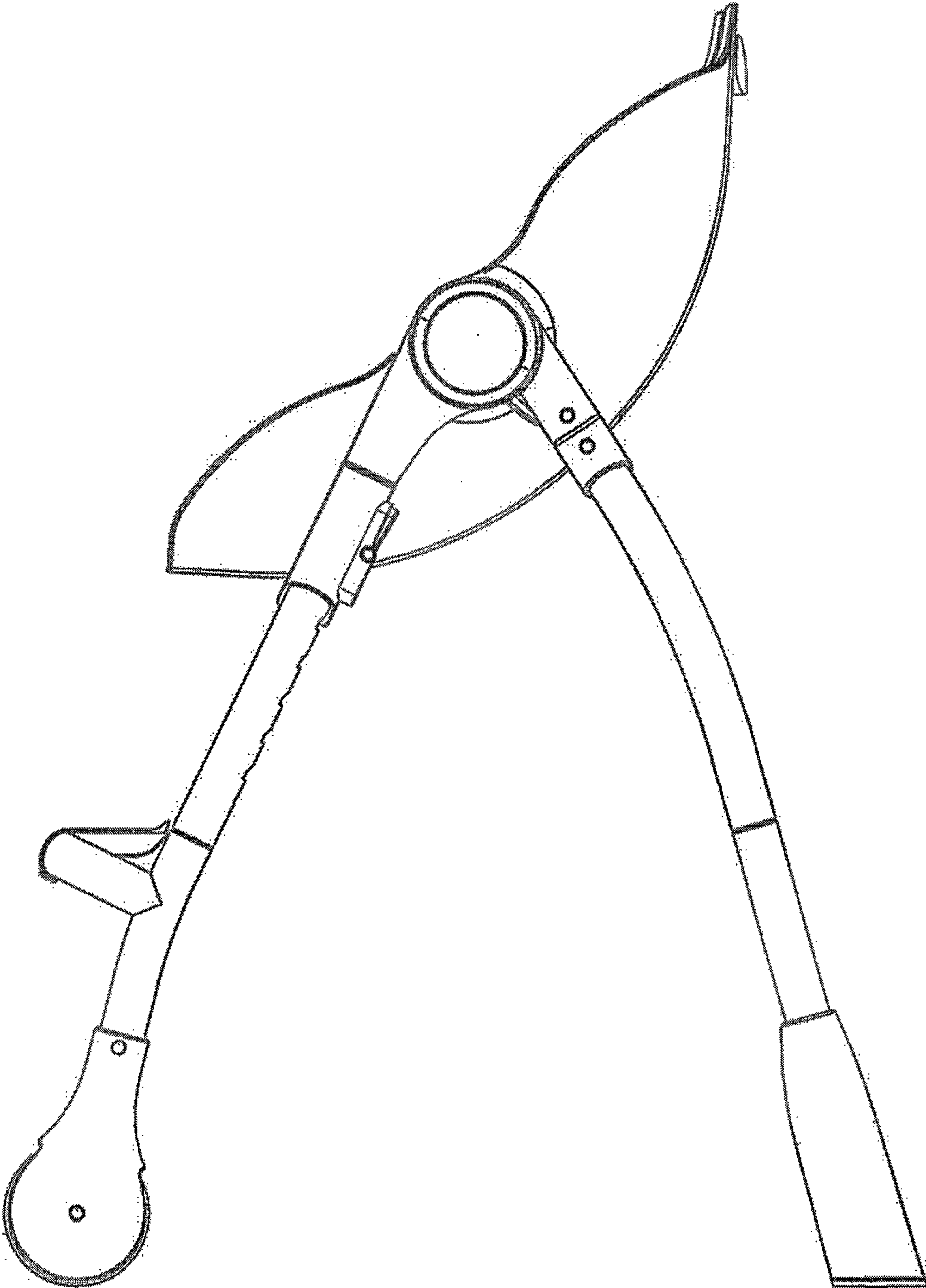

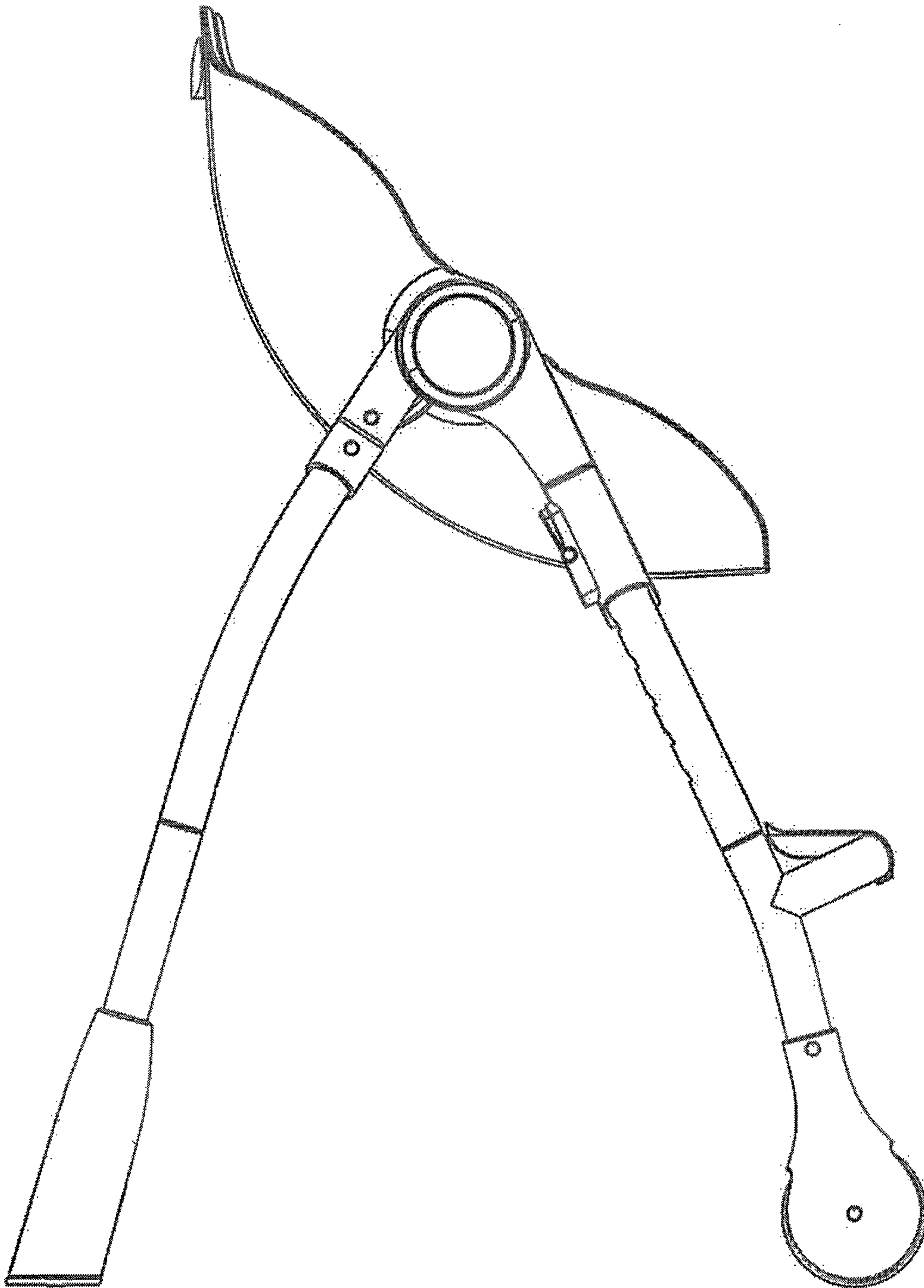

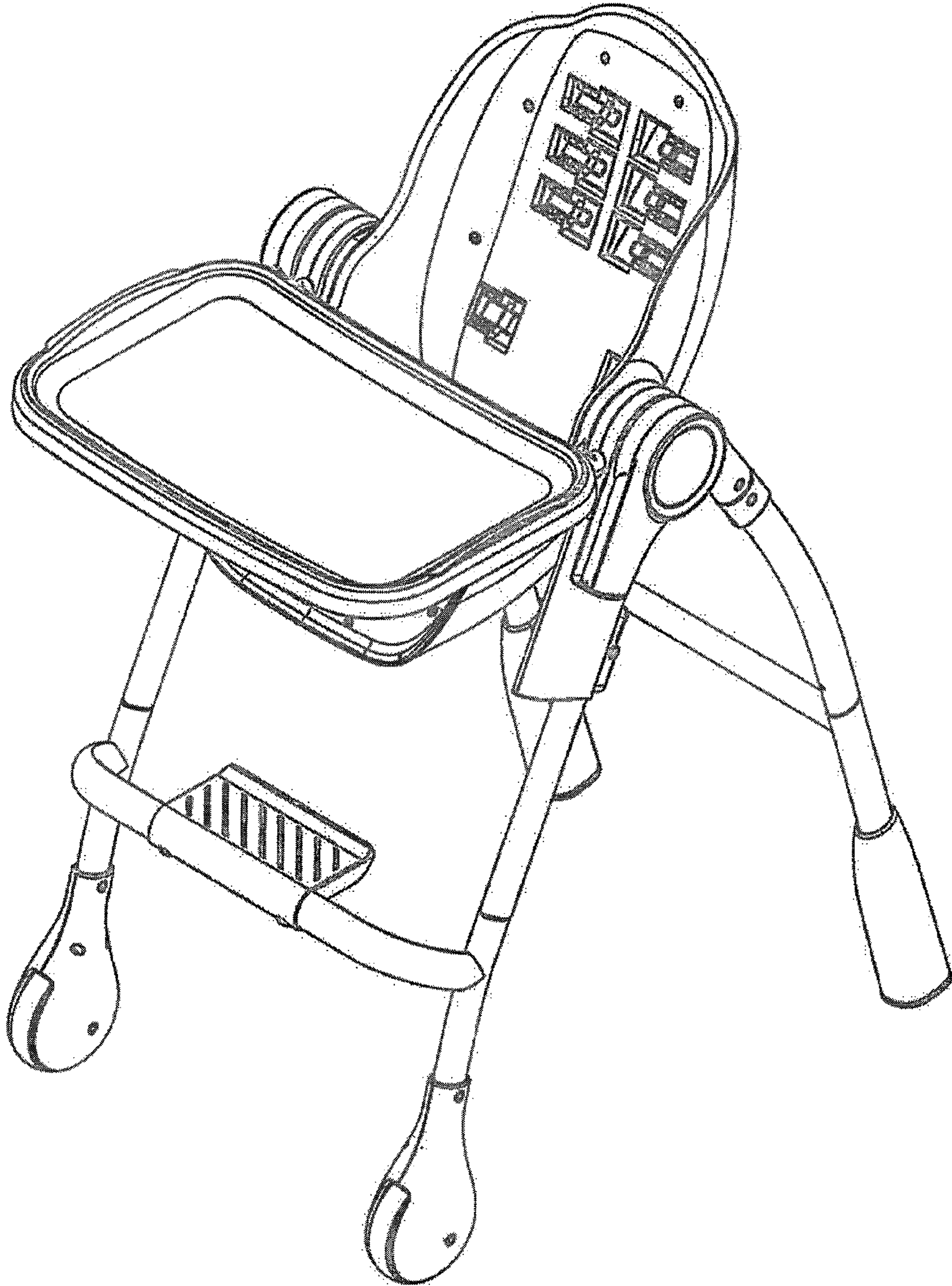

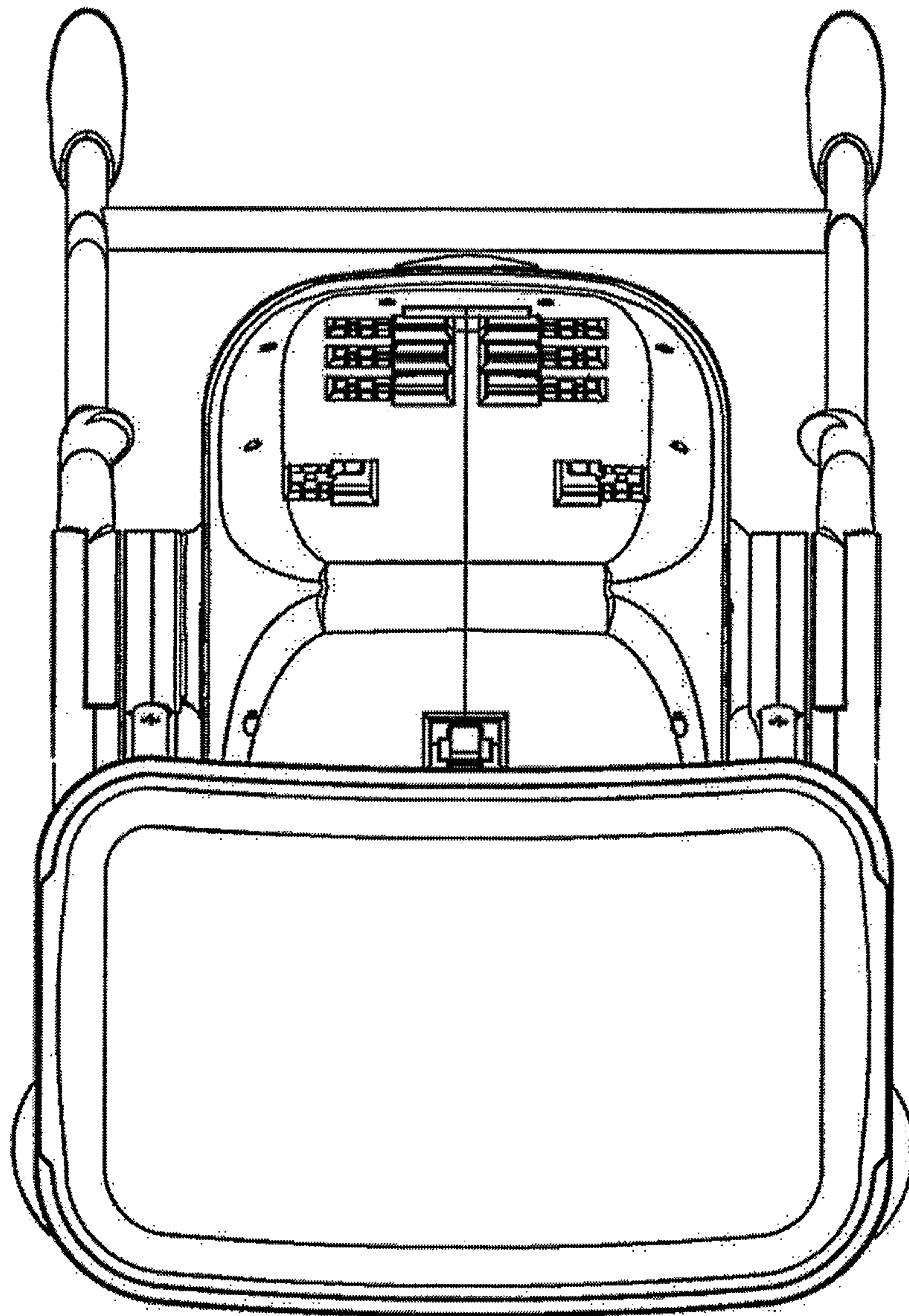

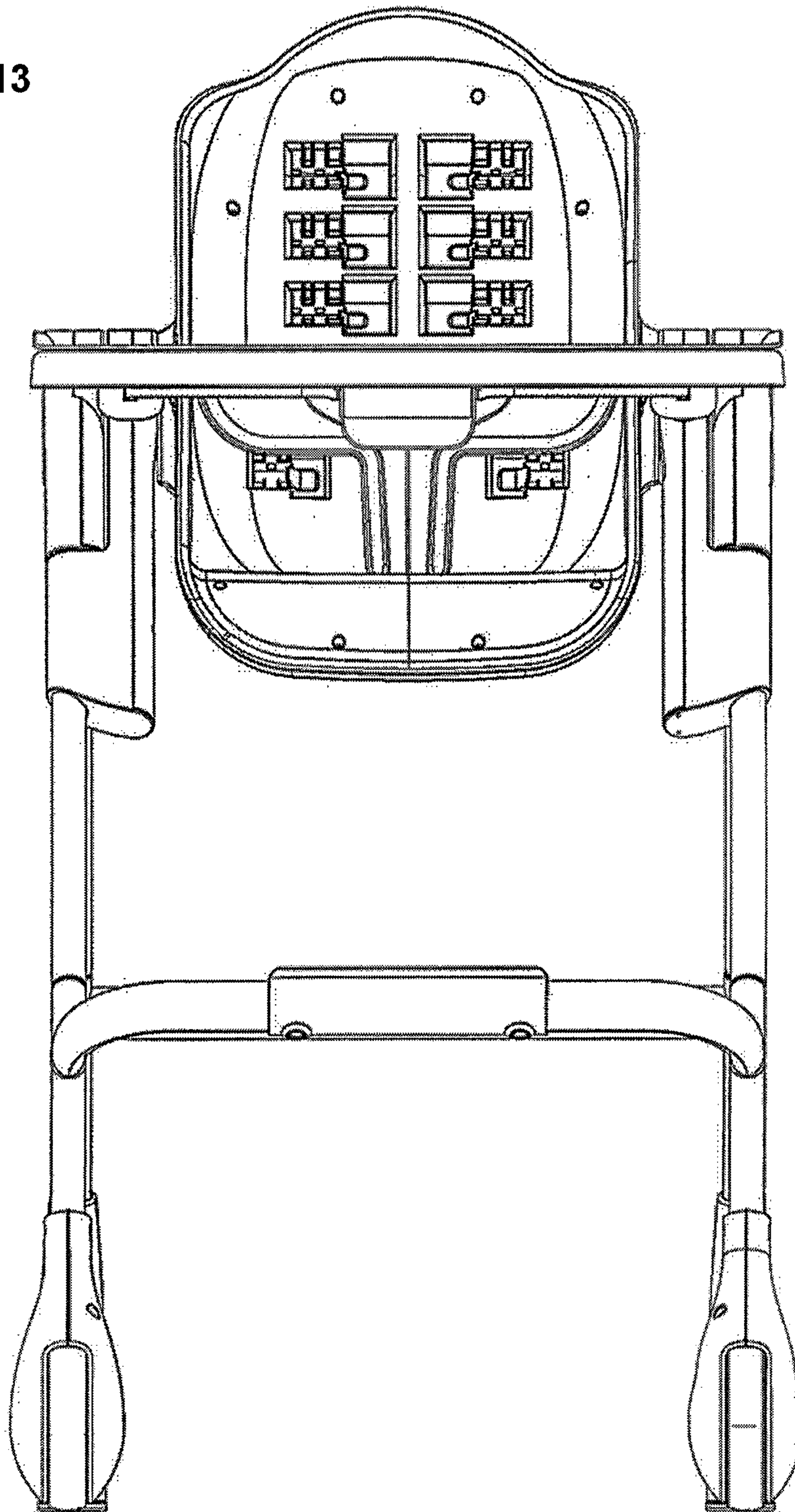

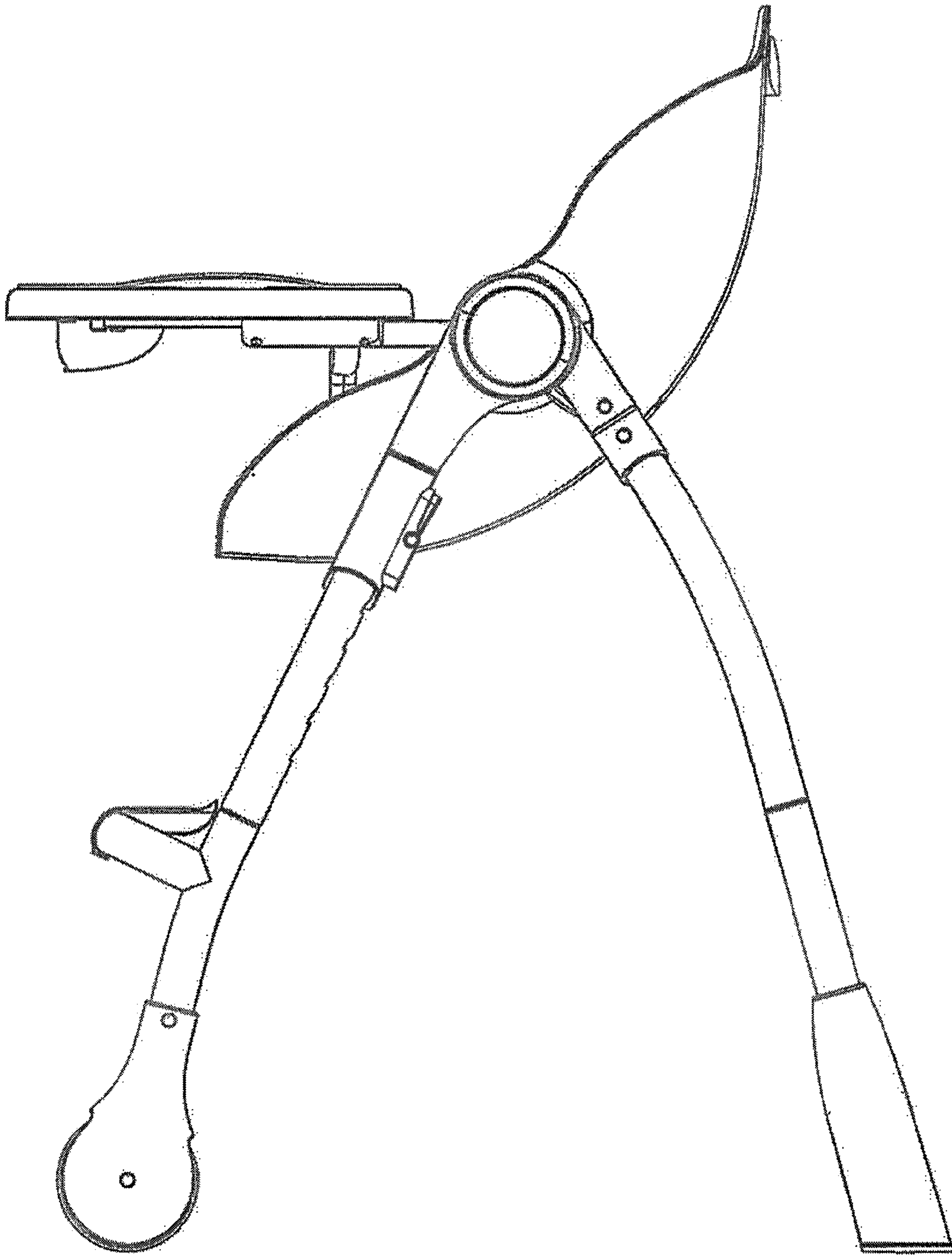

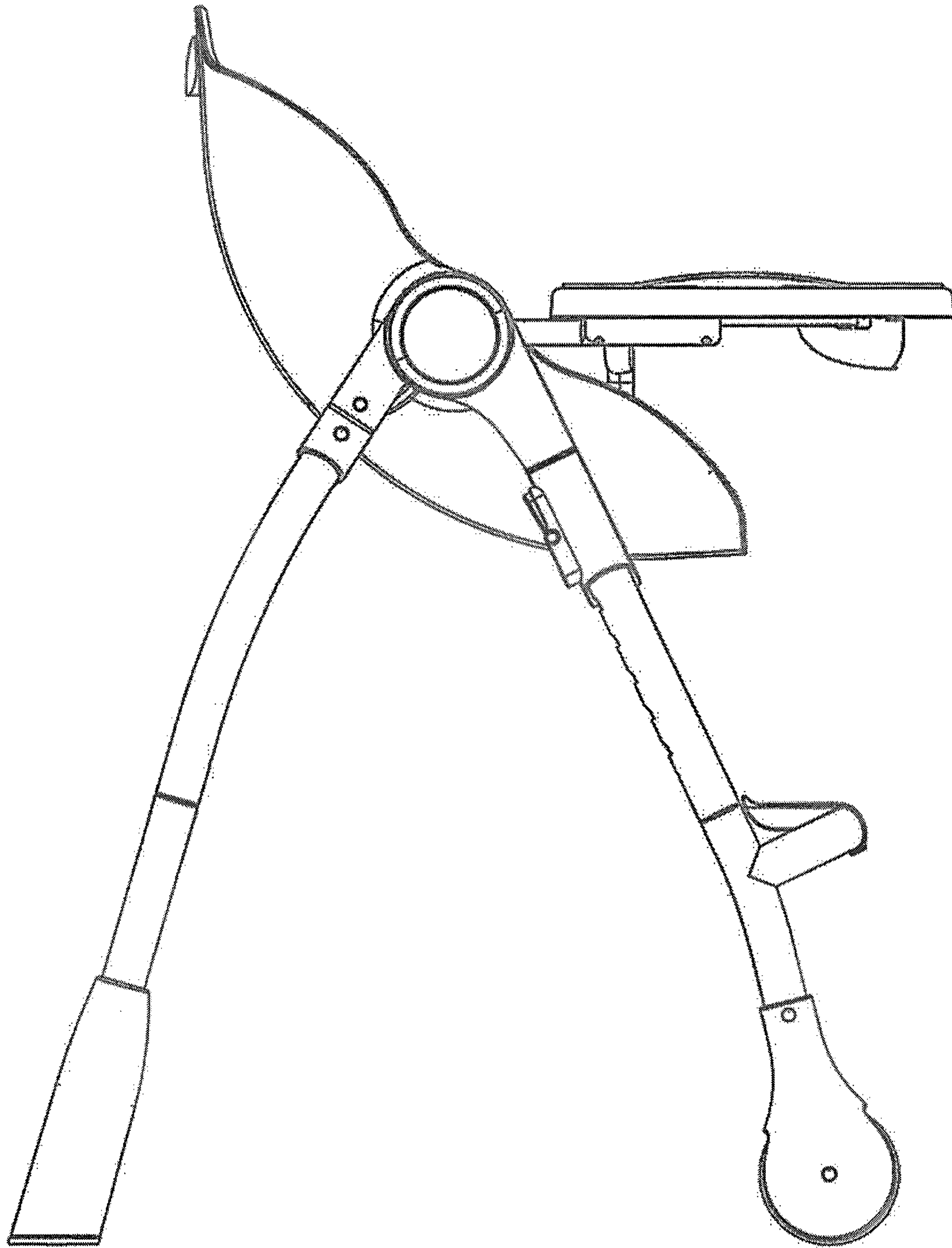

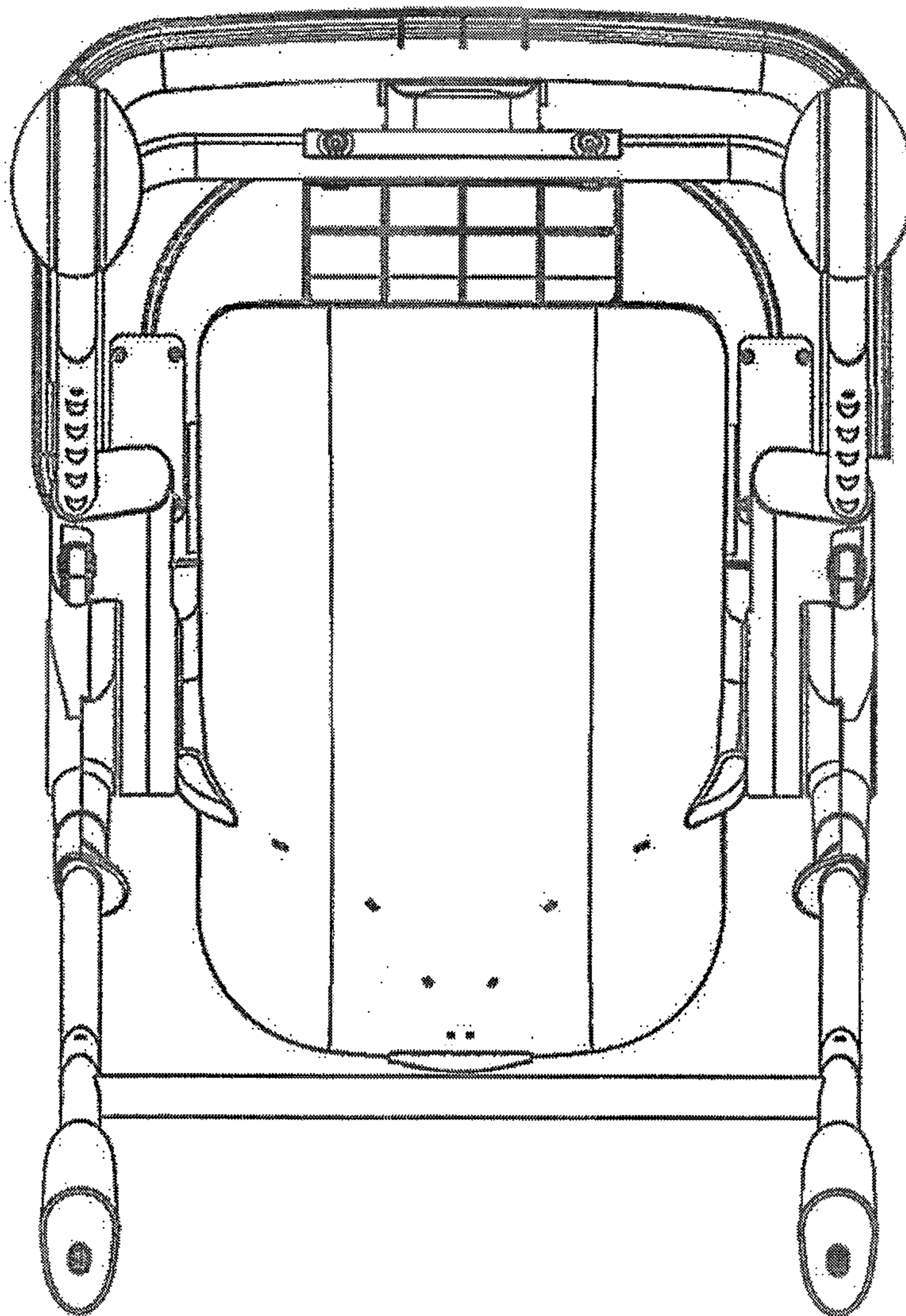

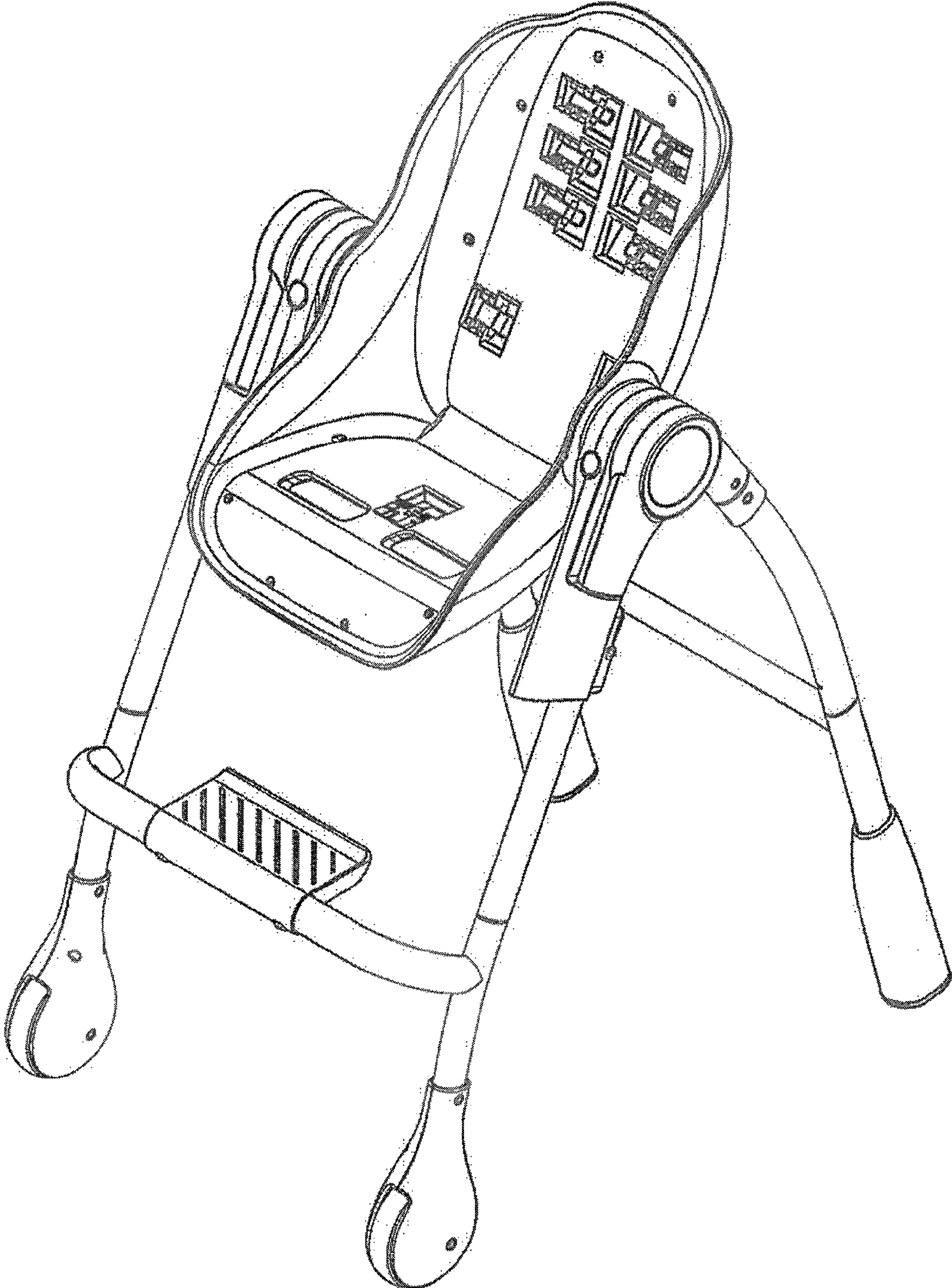

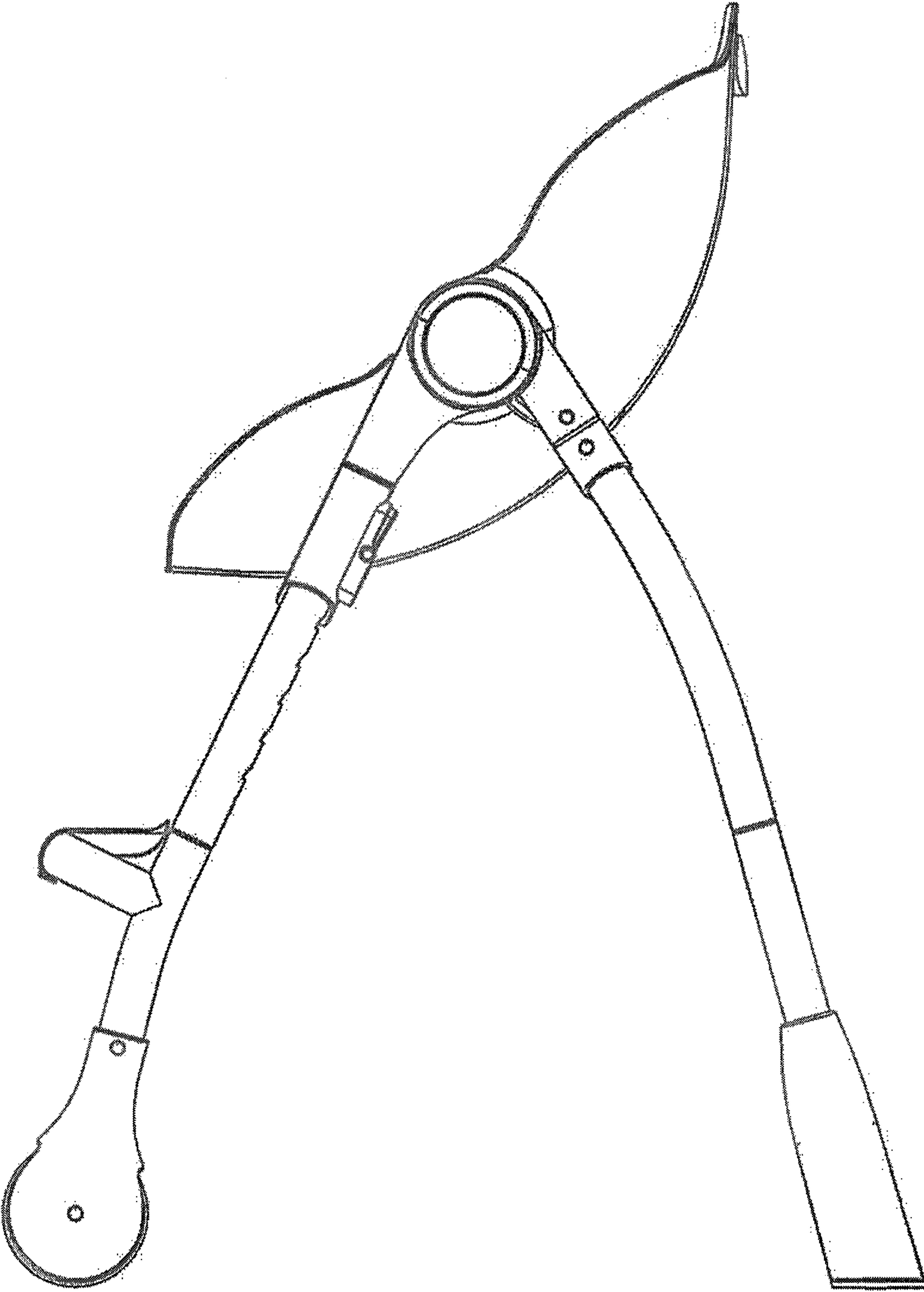

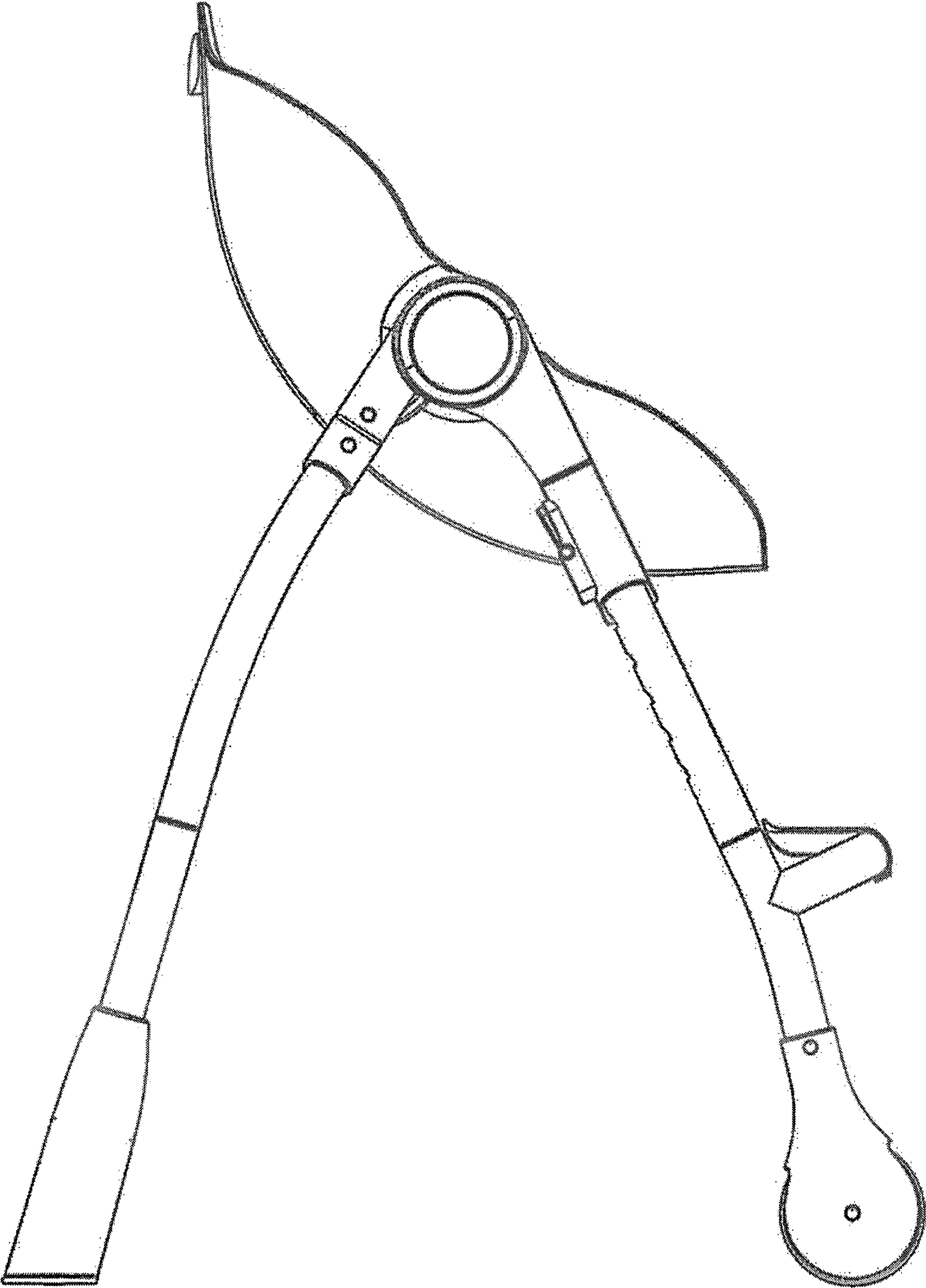

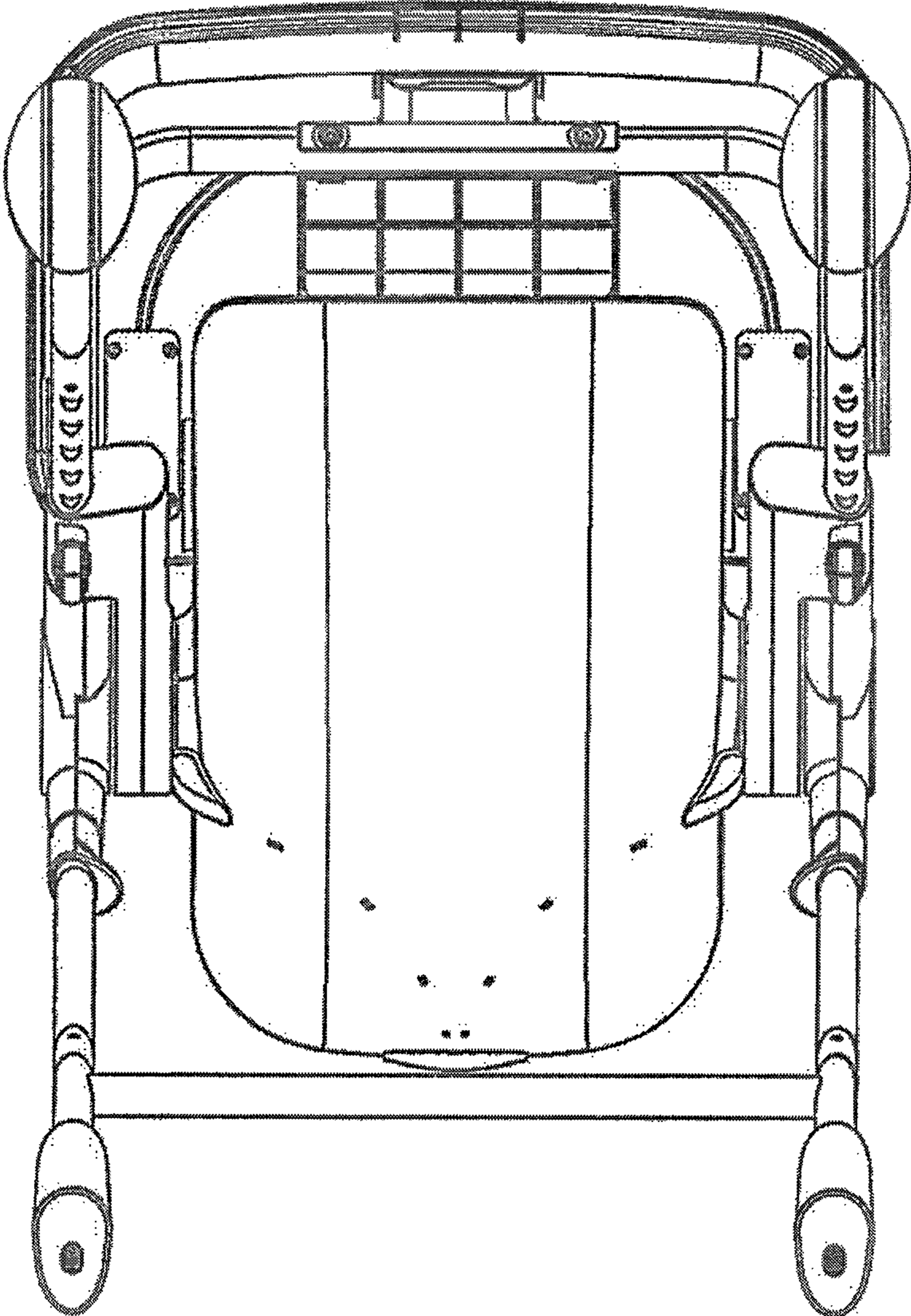

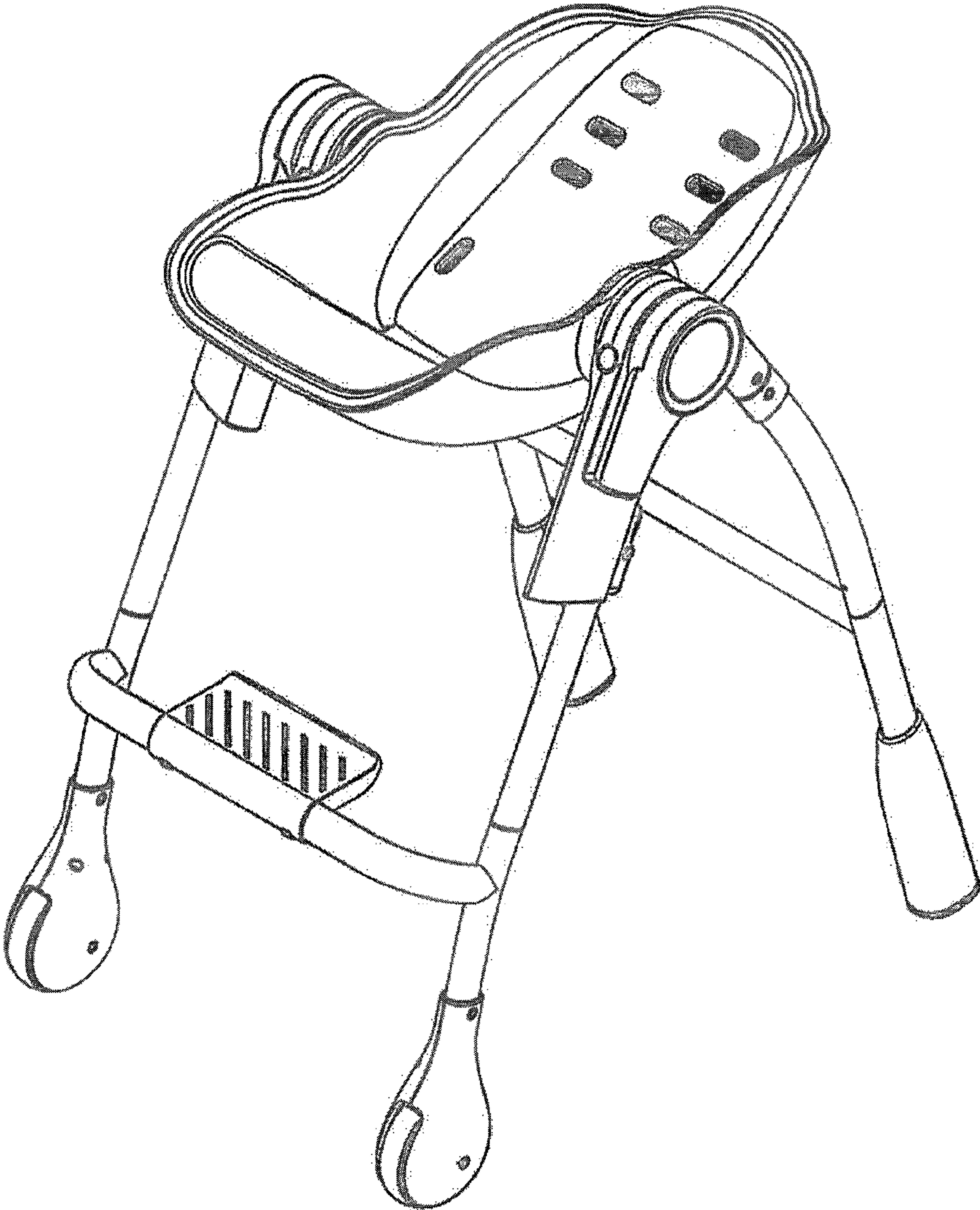

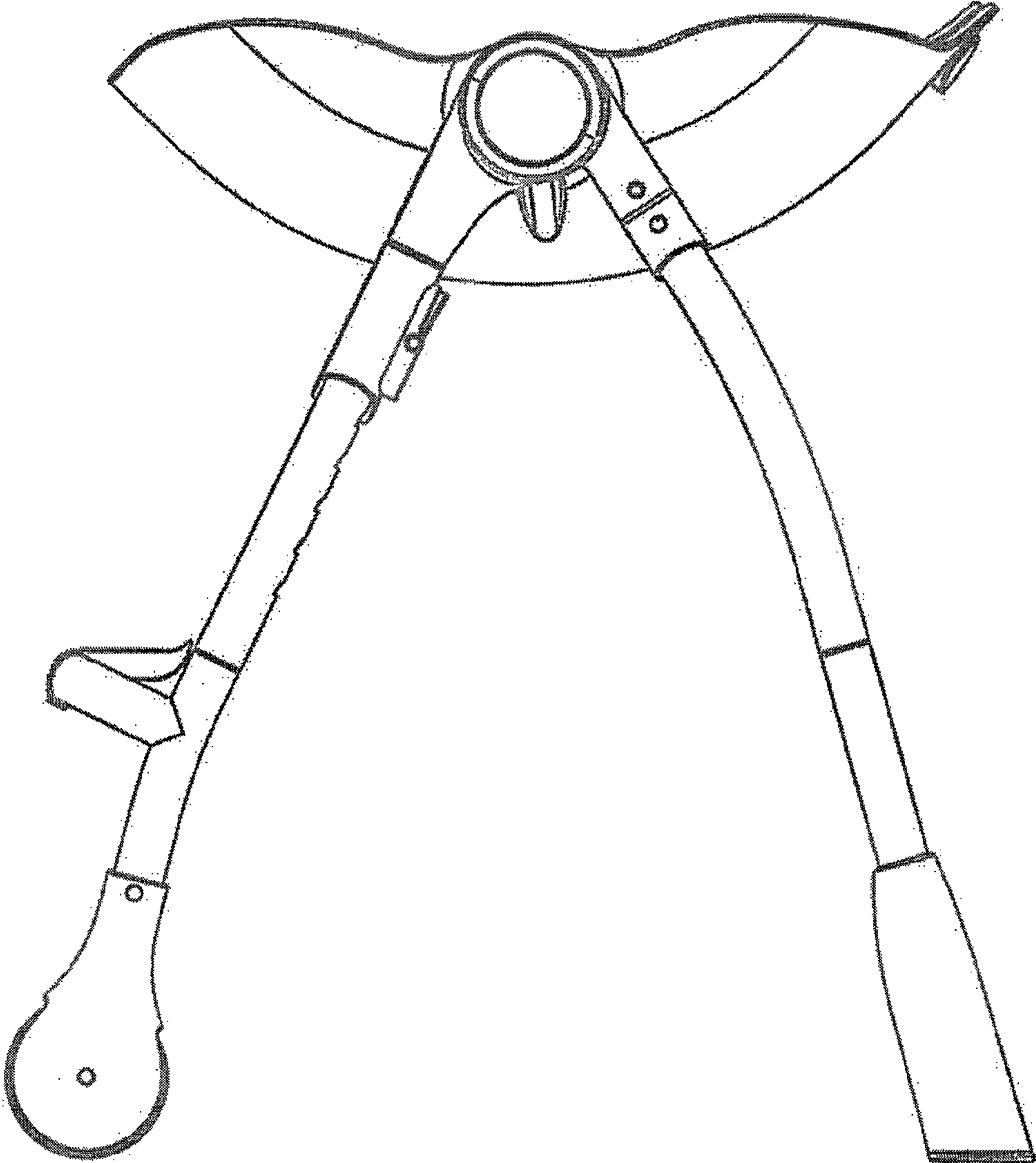

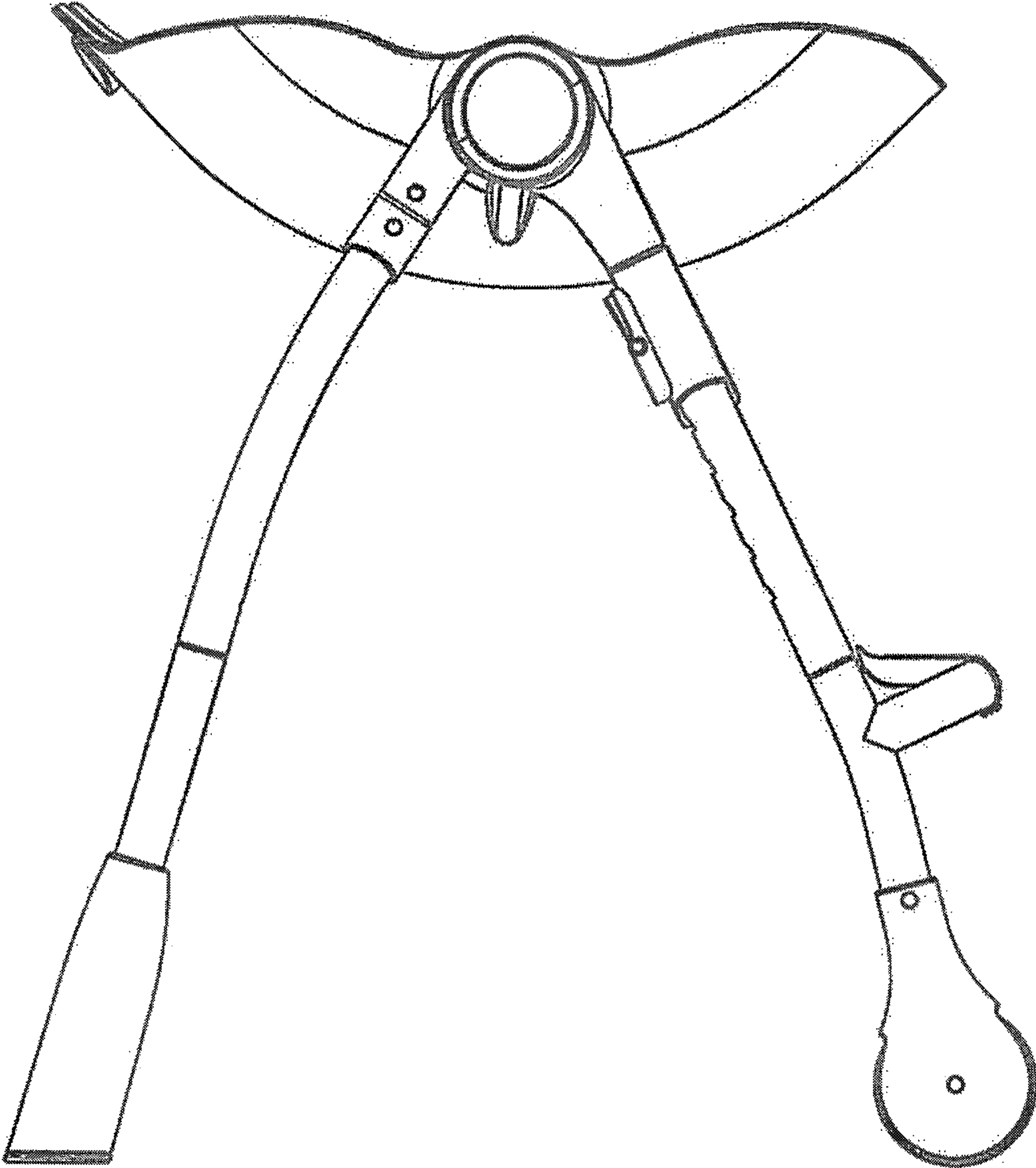

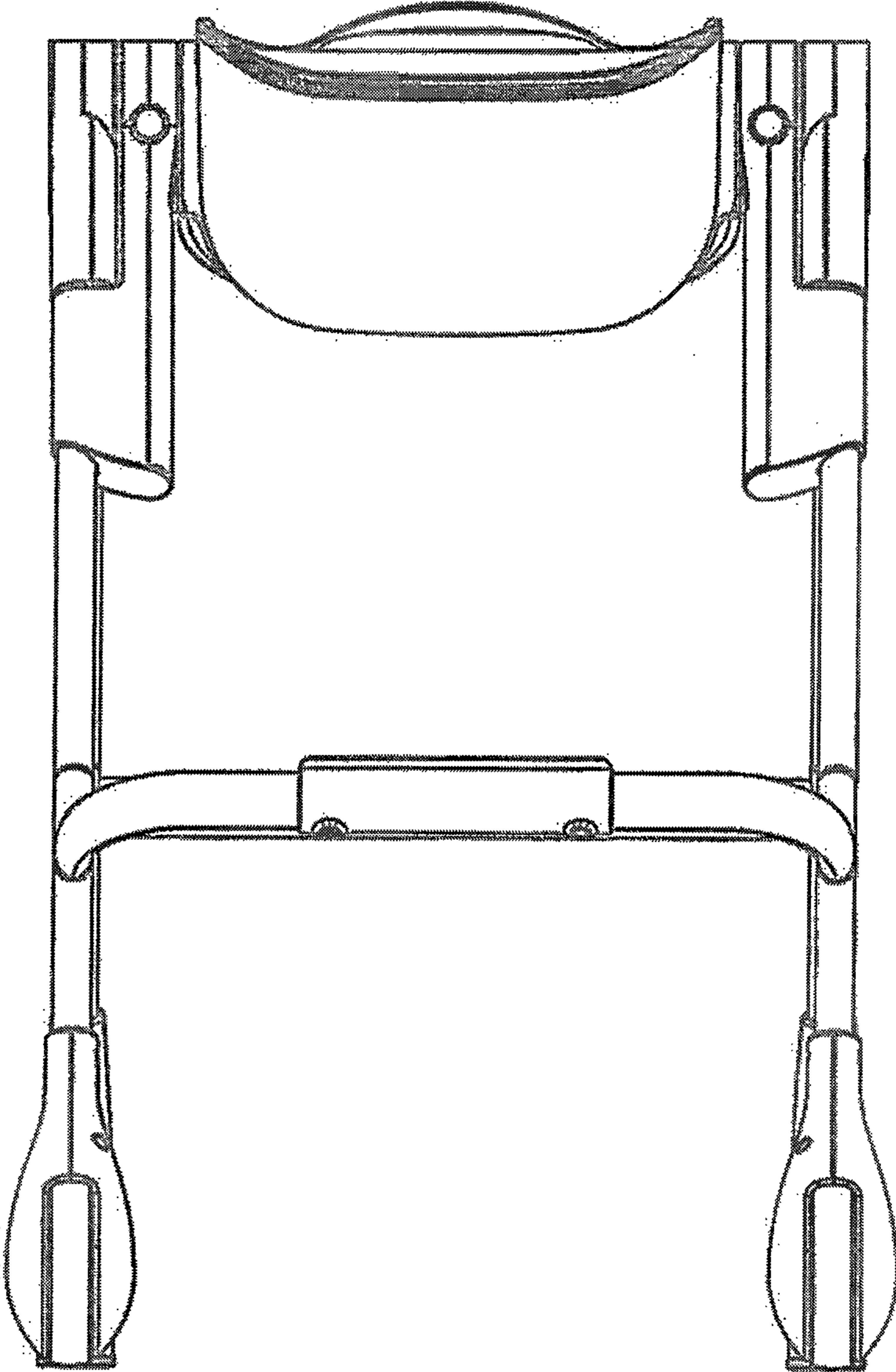

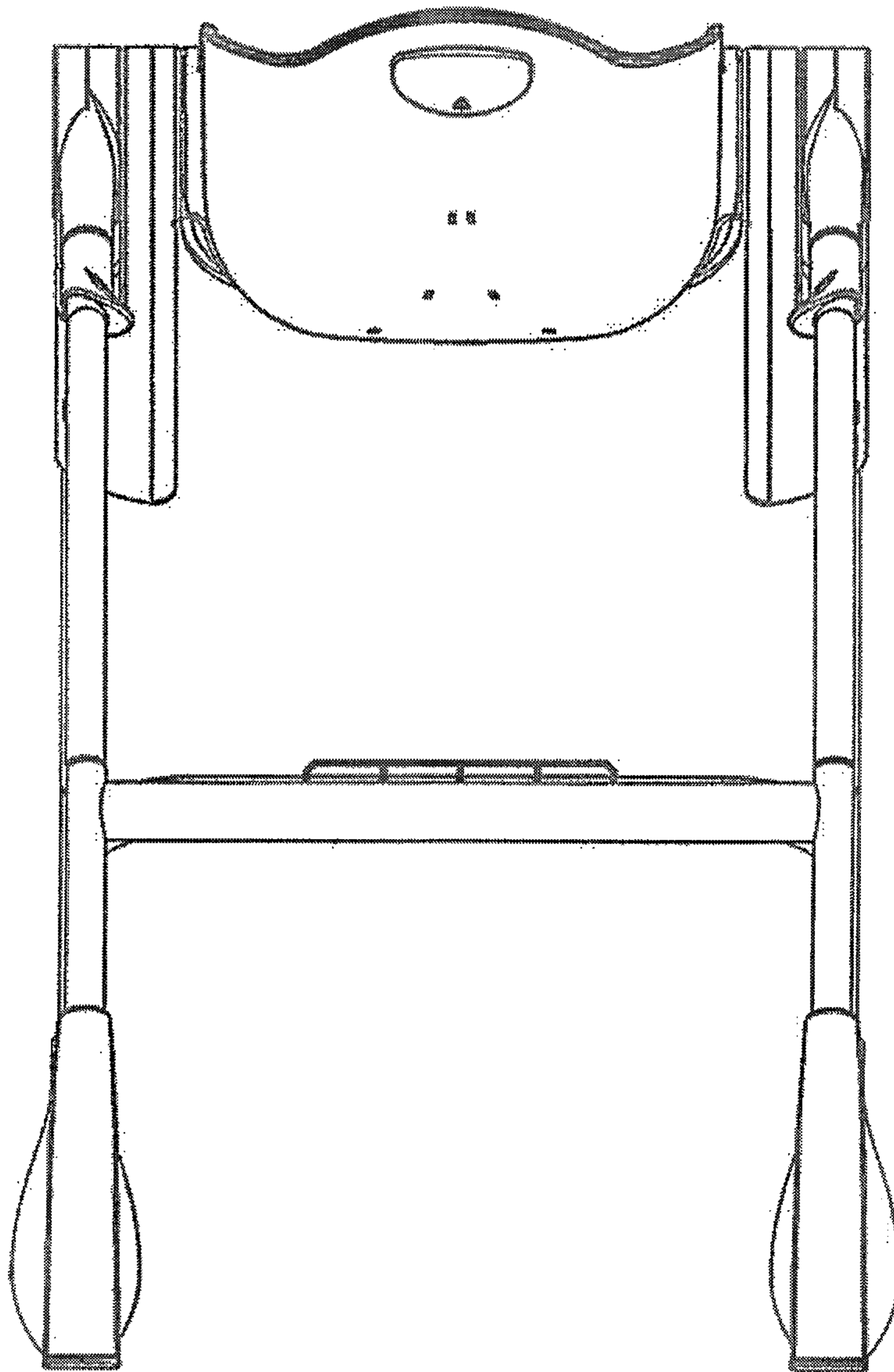

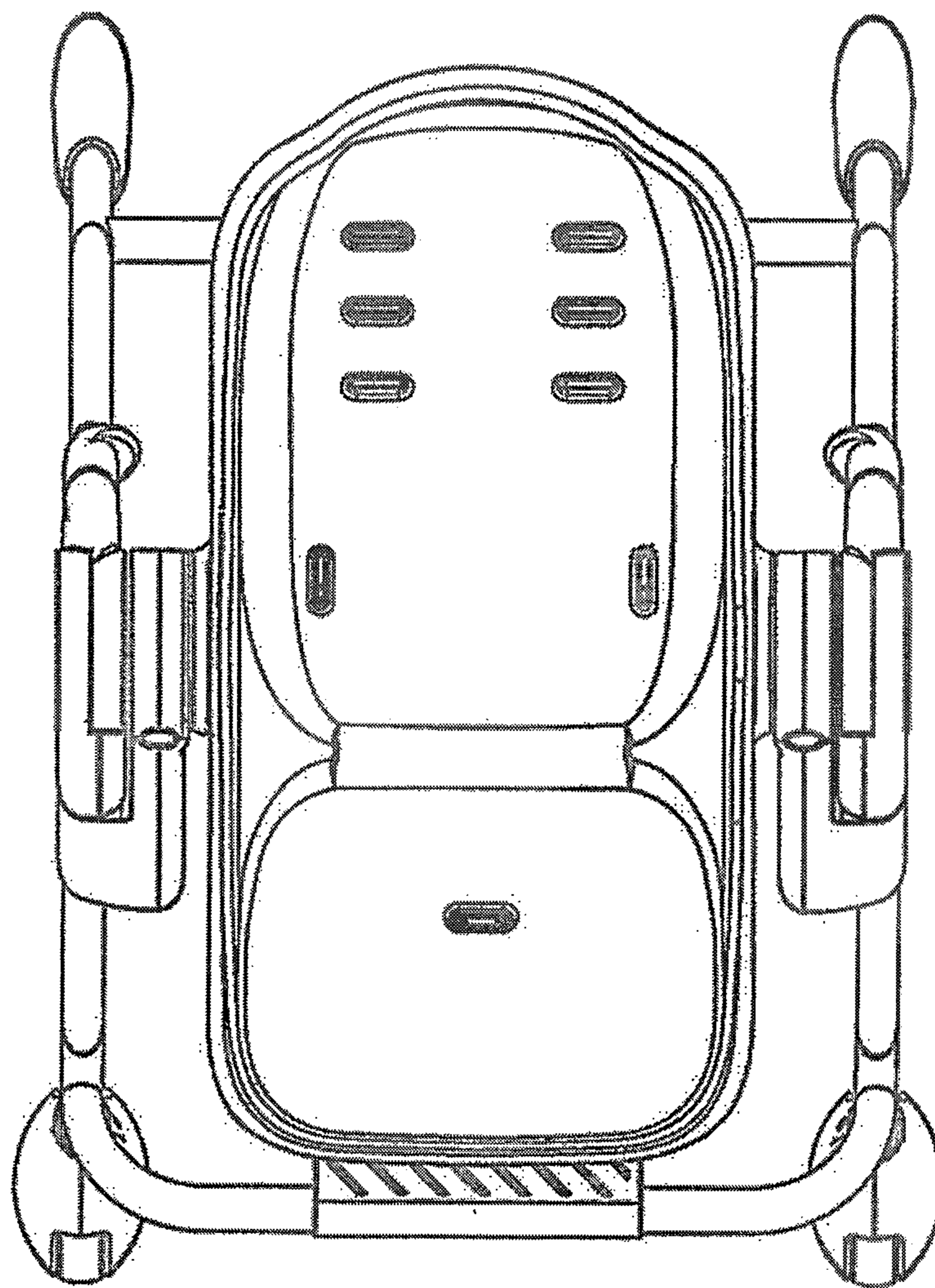

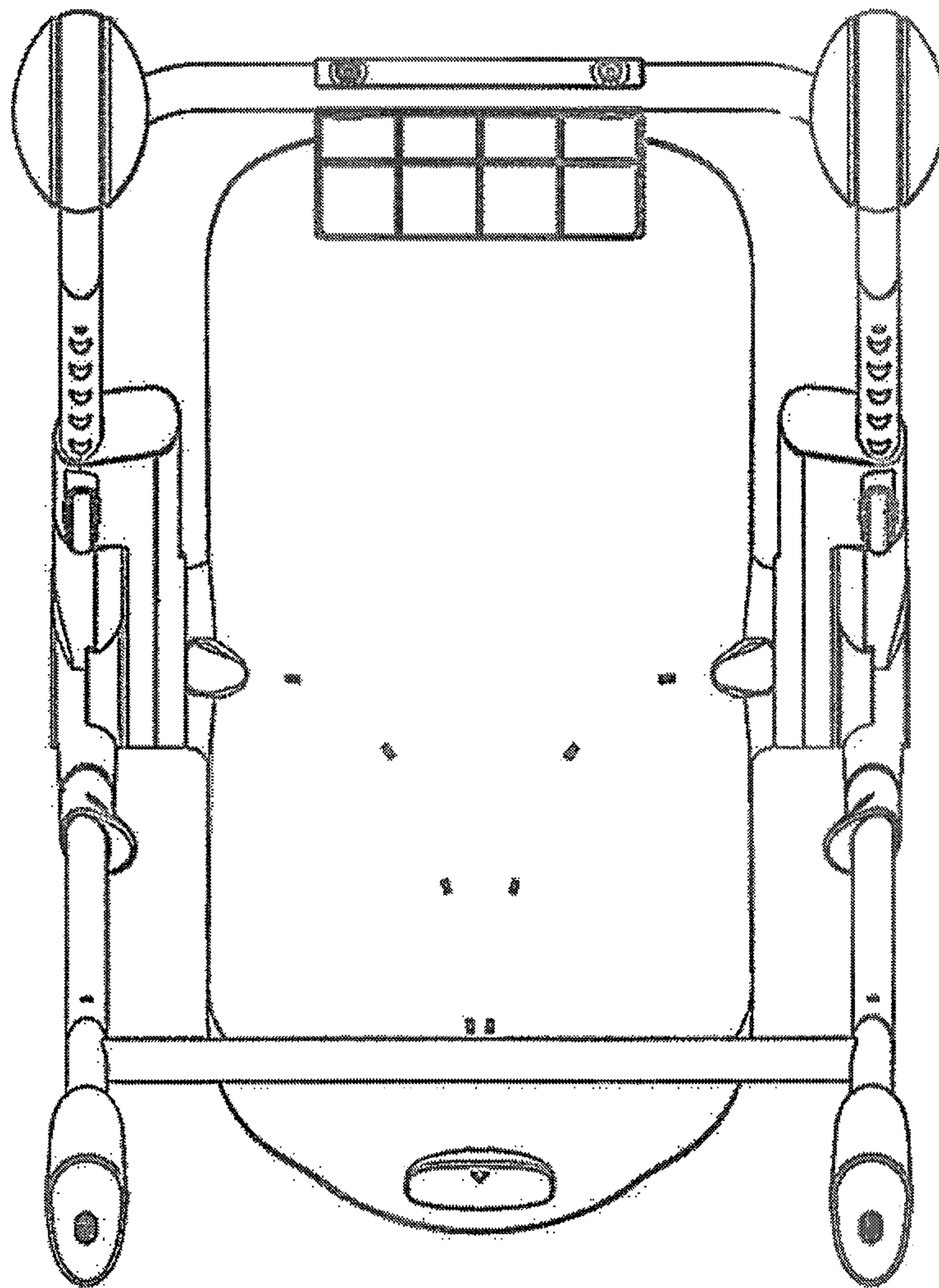

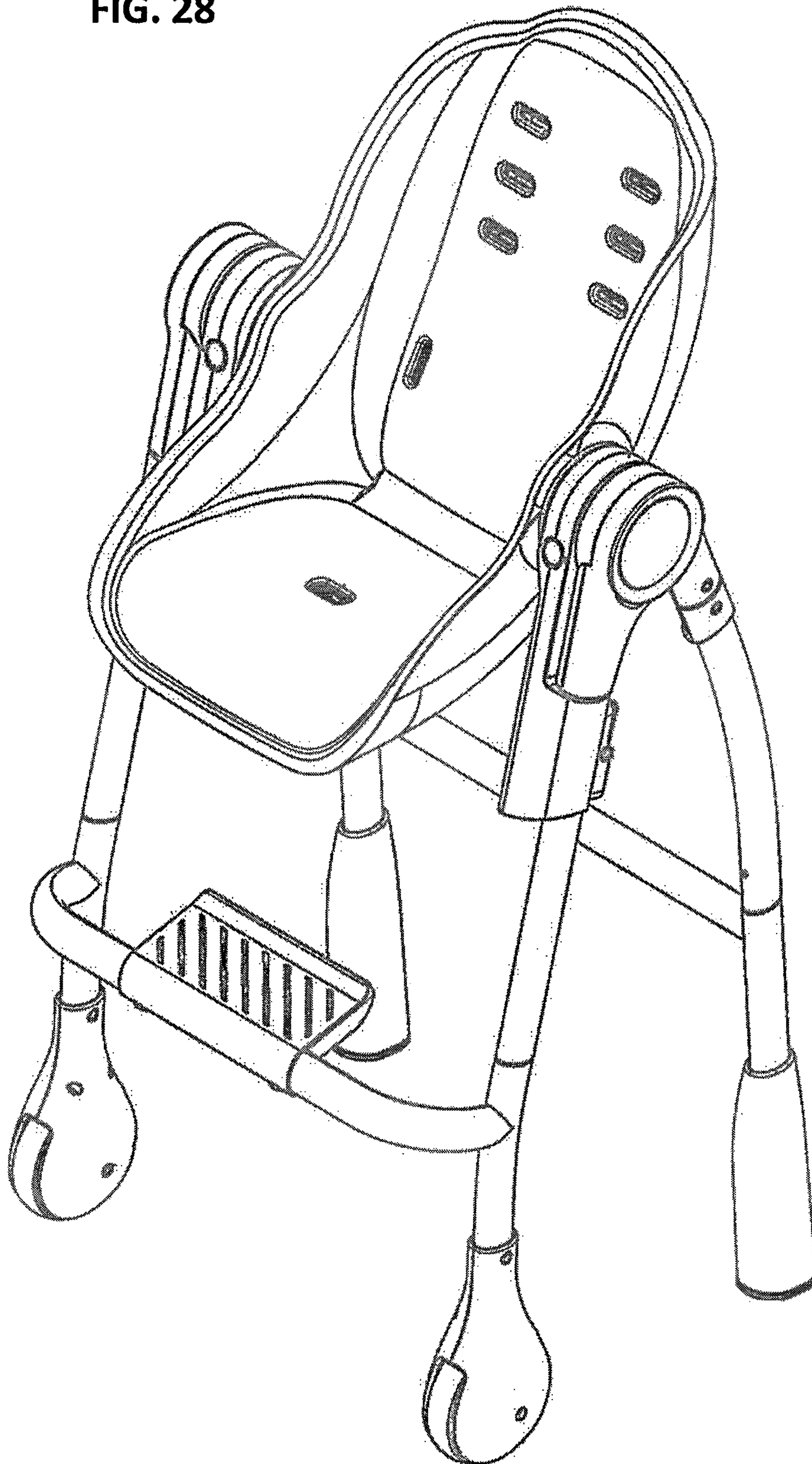
