(57) **CLAIM**

The ornamental design for an electric coffee maker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an electric coffee maker showing my new design;

FIG. 2 is a left side elevational view of the electric coffee maker of FIG. 1.

FIG. 3 is a right side elevational view of the electric coffee maker of FIG. 1.

FIG. 4 is a top plan view of the electric coffee maker of FIG. 1.

FIG. 5 is a perspective view of the electric coffee maker of FIG. 1.

FIG. 6 is a perspective view of the electric coffee maker of FIG. 1 without a carafe

FIG. 7 is a front elevational view of the electric coffee maker of FIG. 1 with different environmental elements.

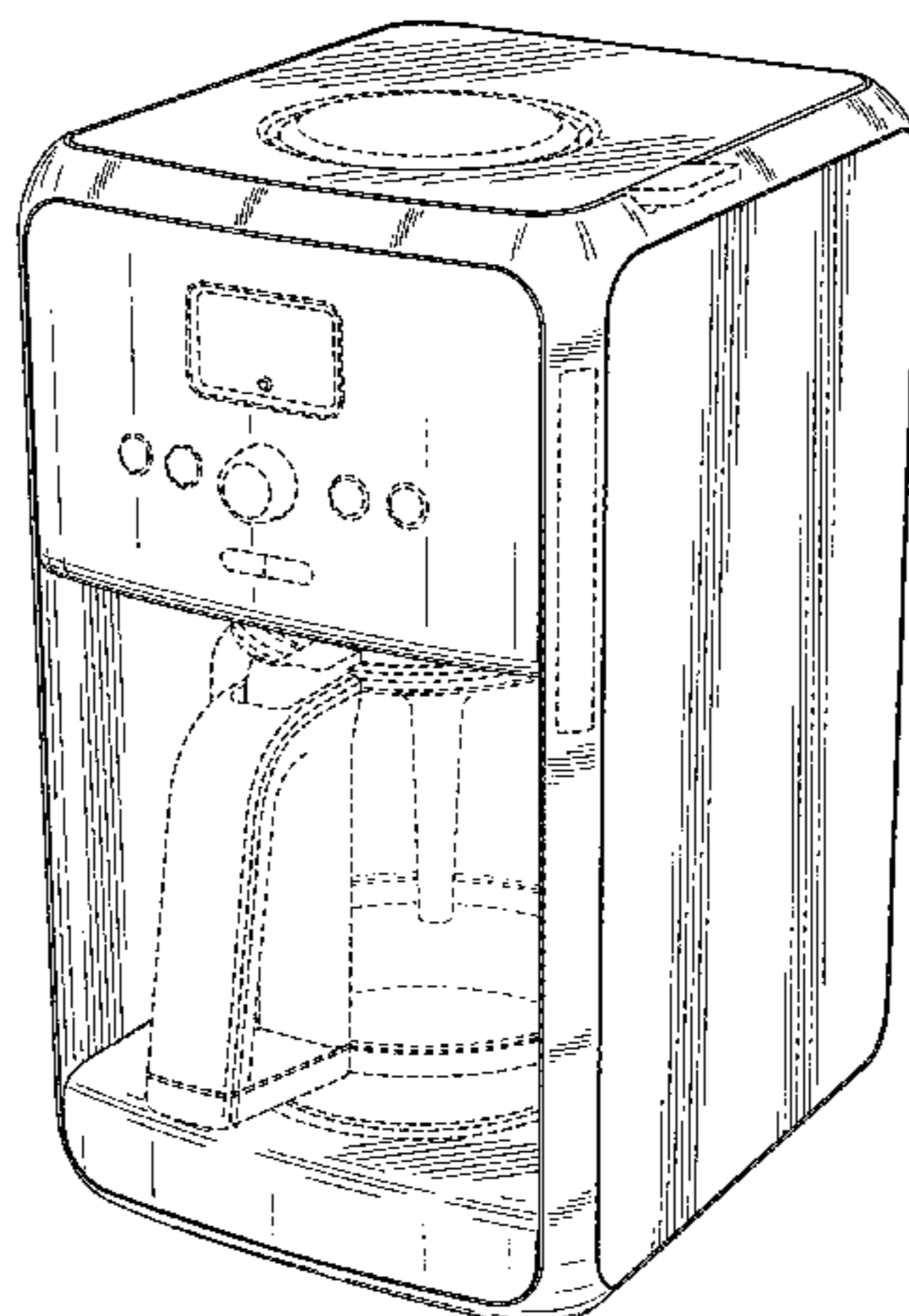
FIG. 8 is a front elevational view of the electric coffee maker of FIG. 1 with different environmental elements; and,

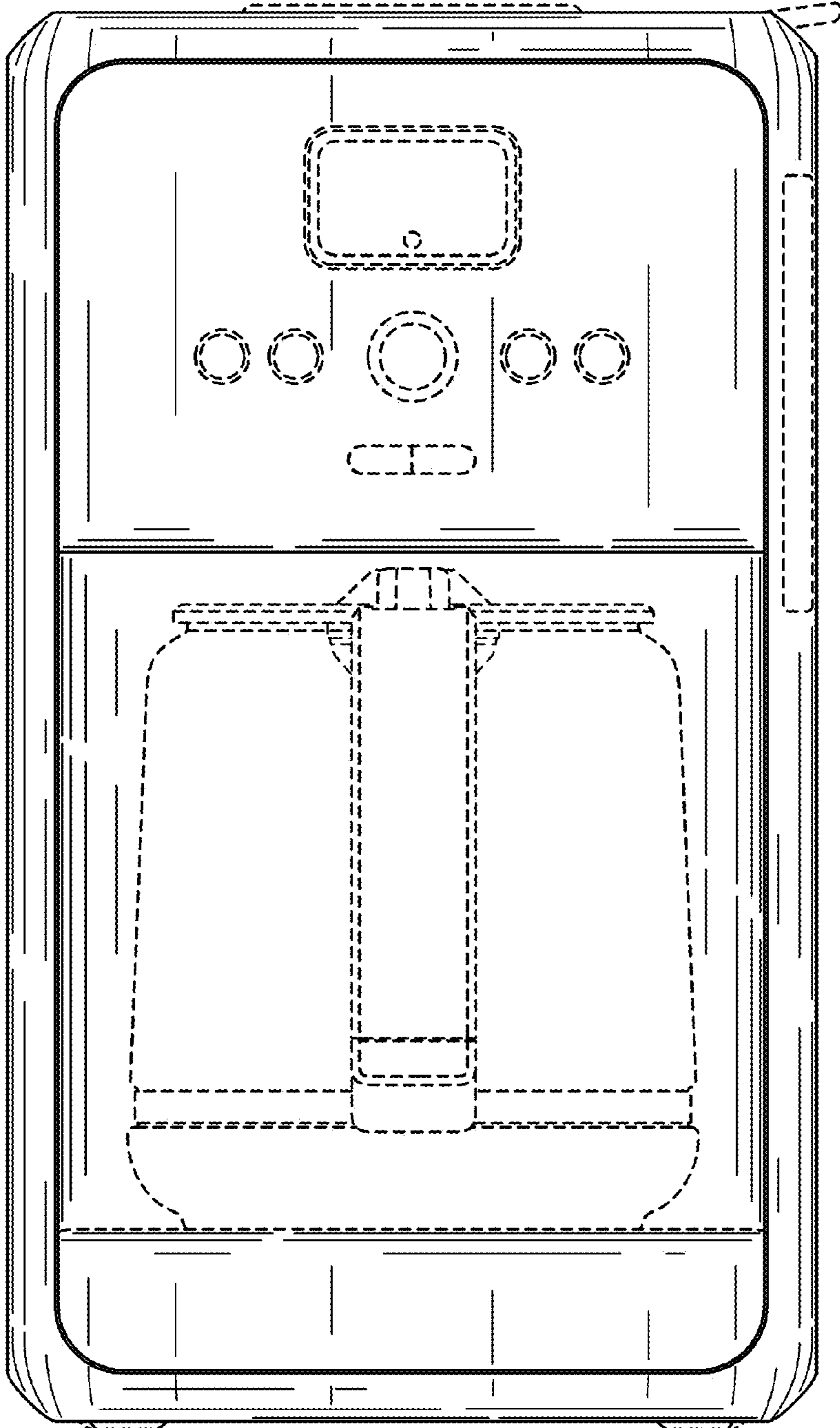

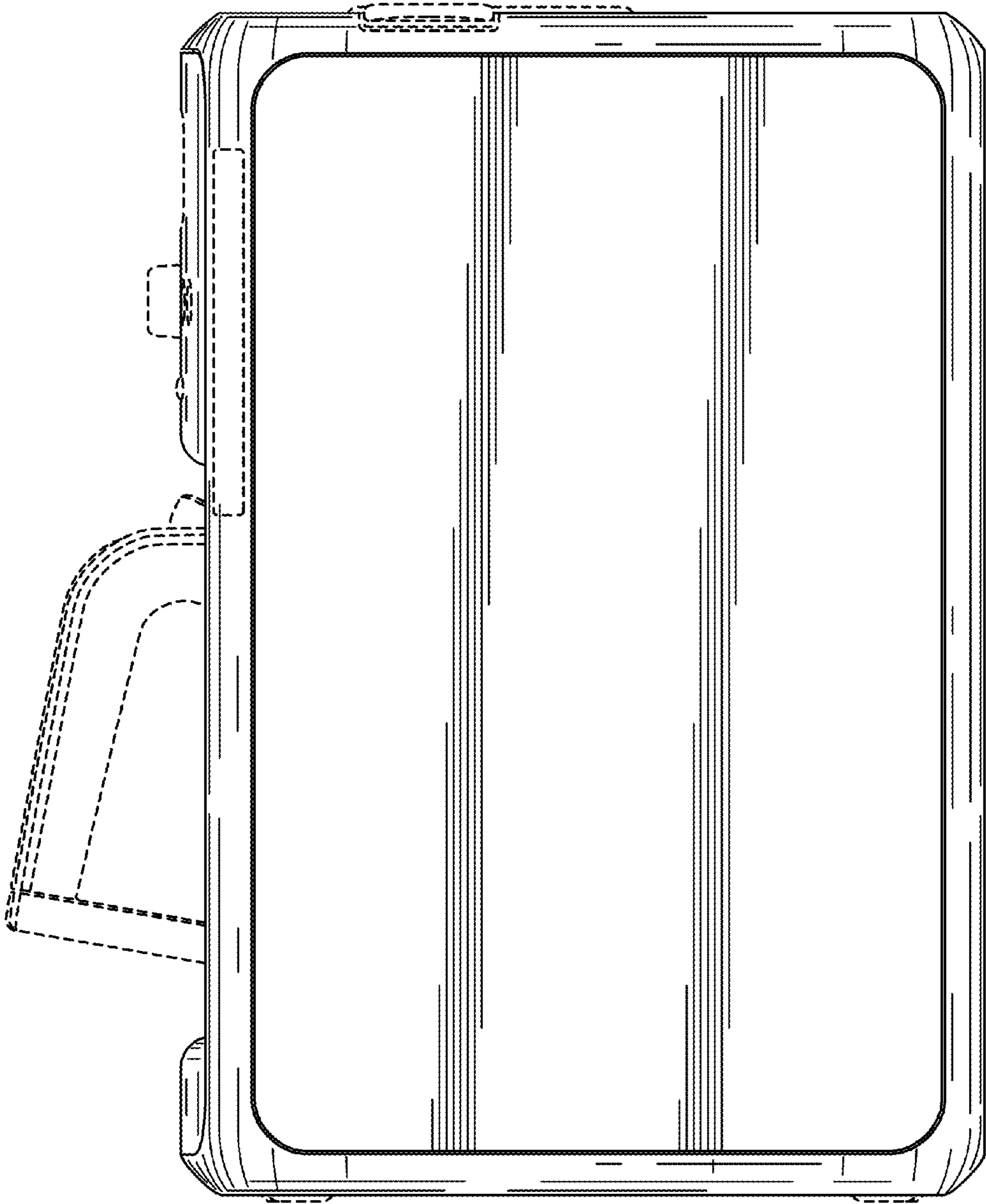

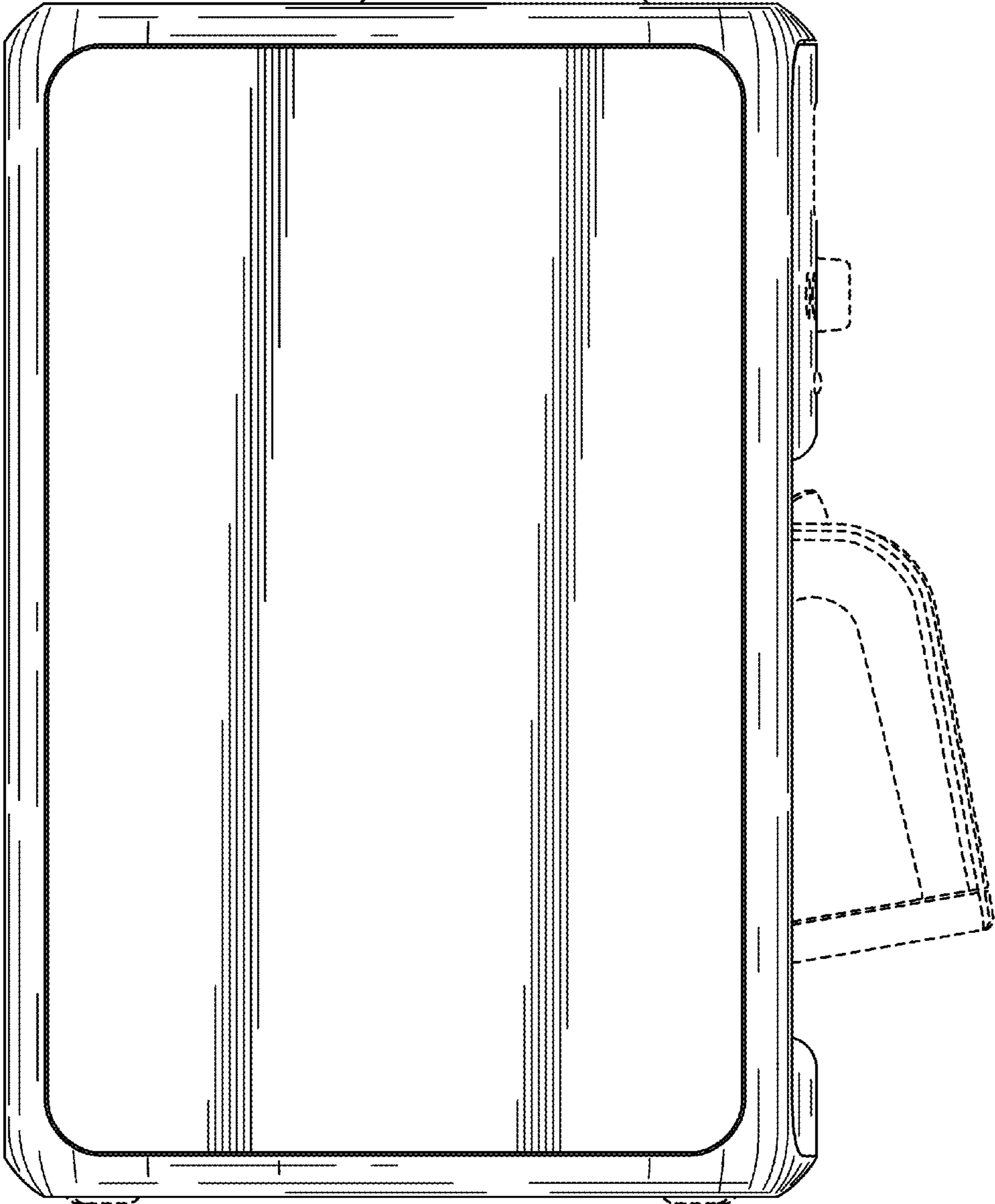

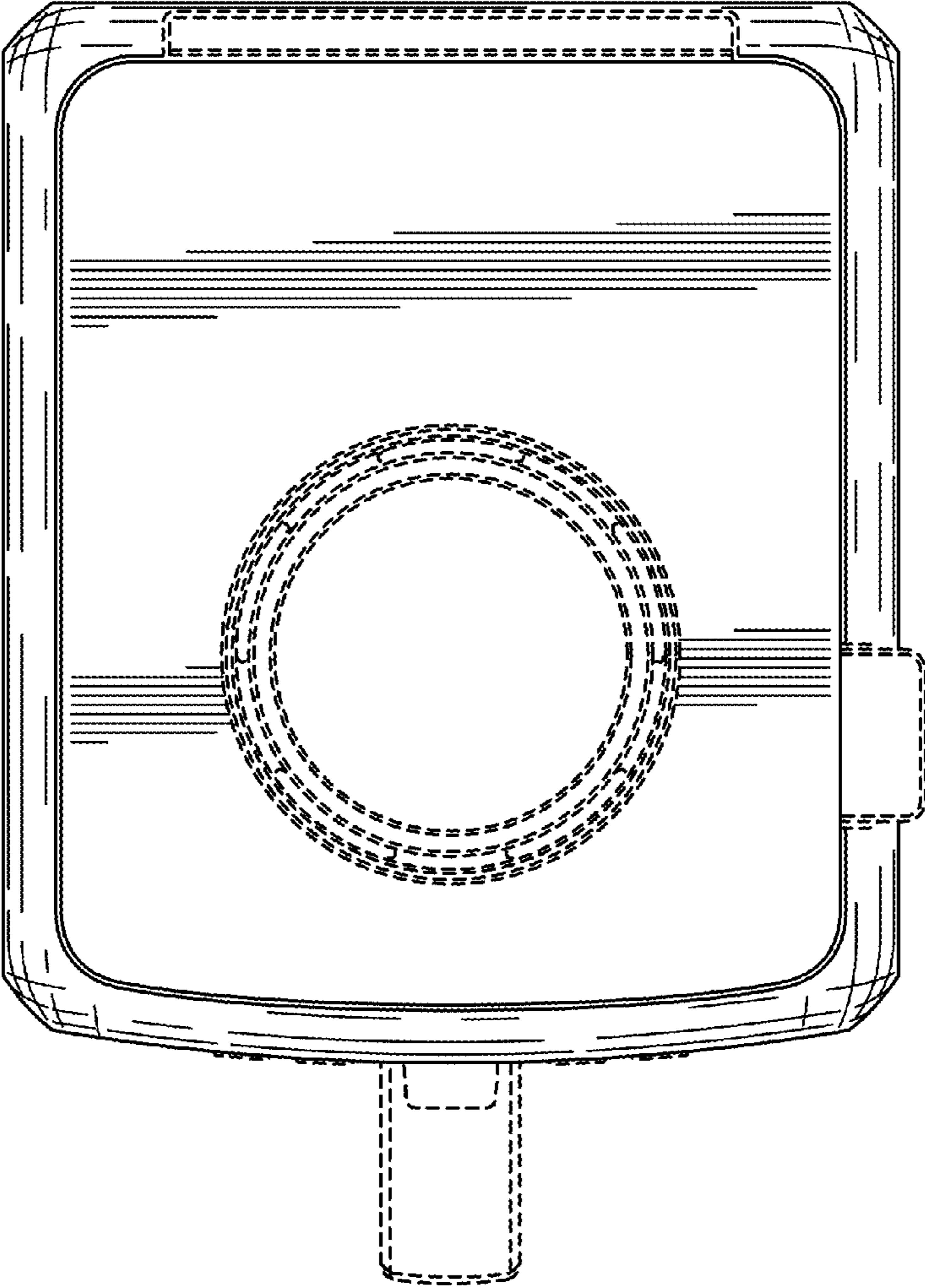

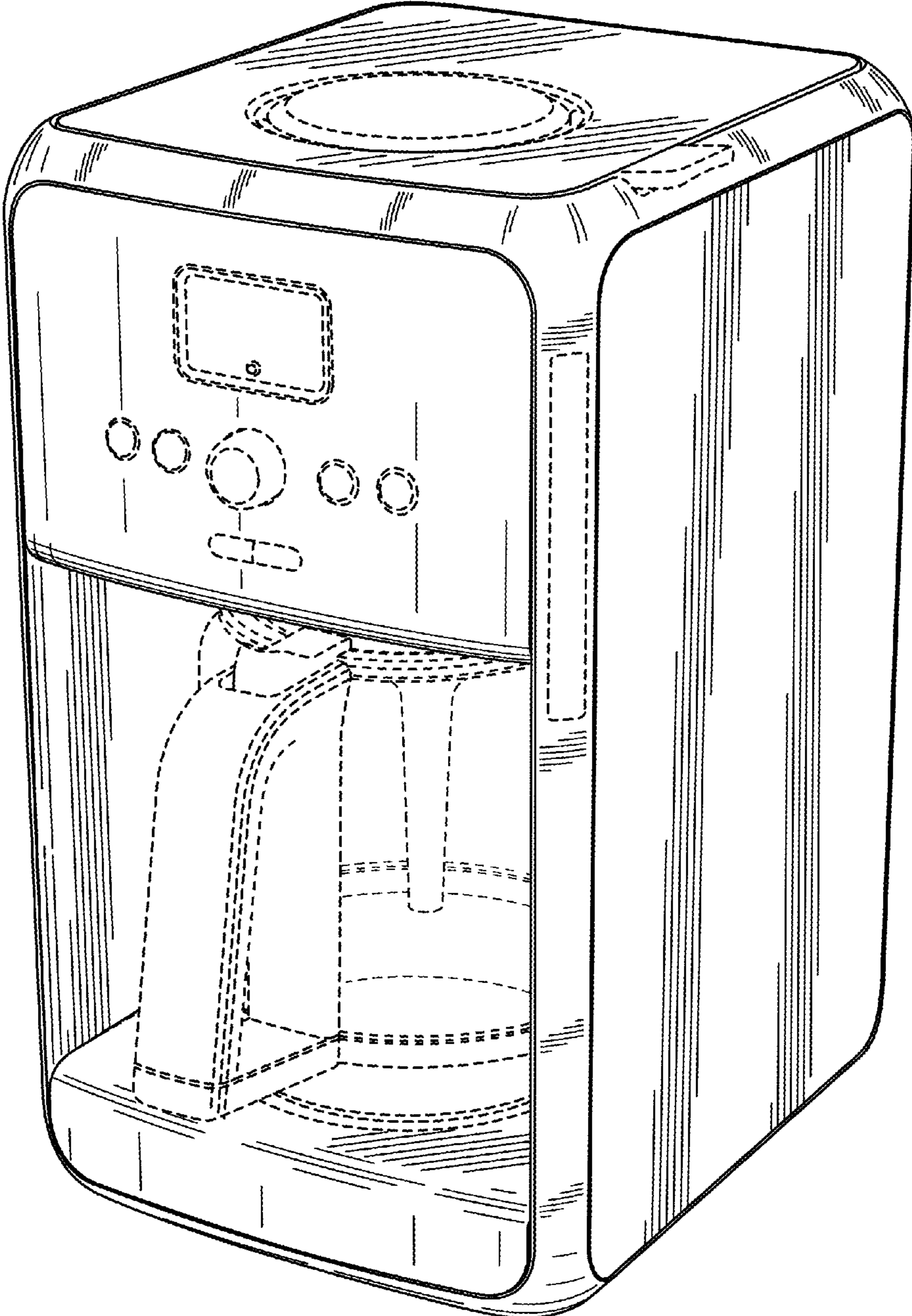

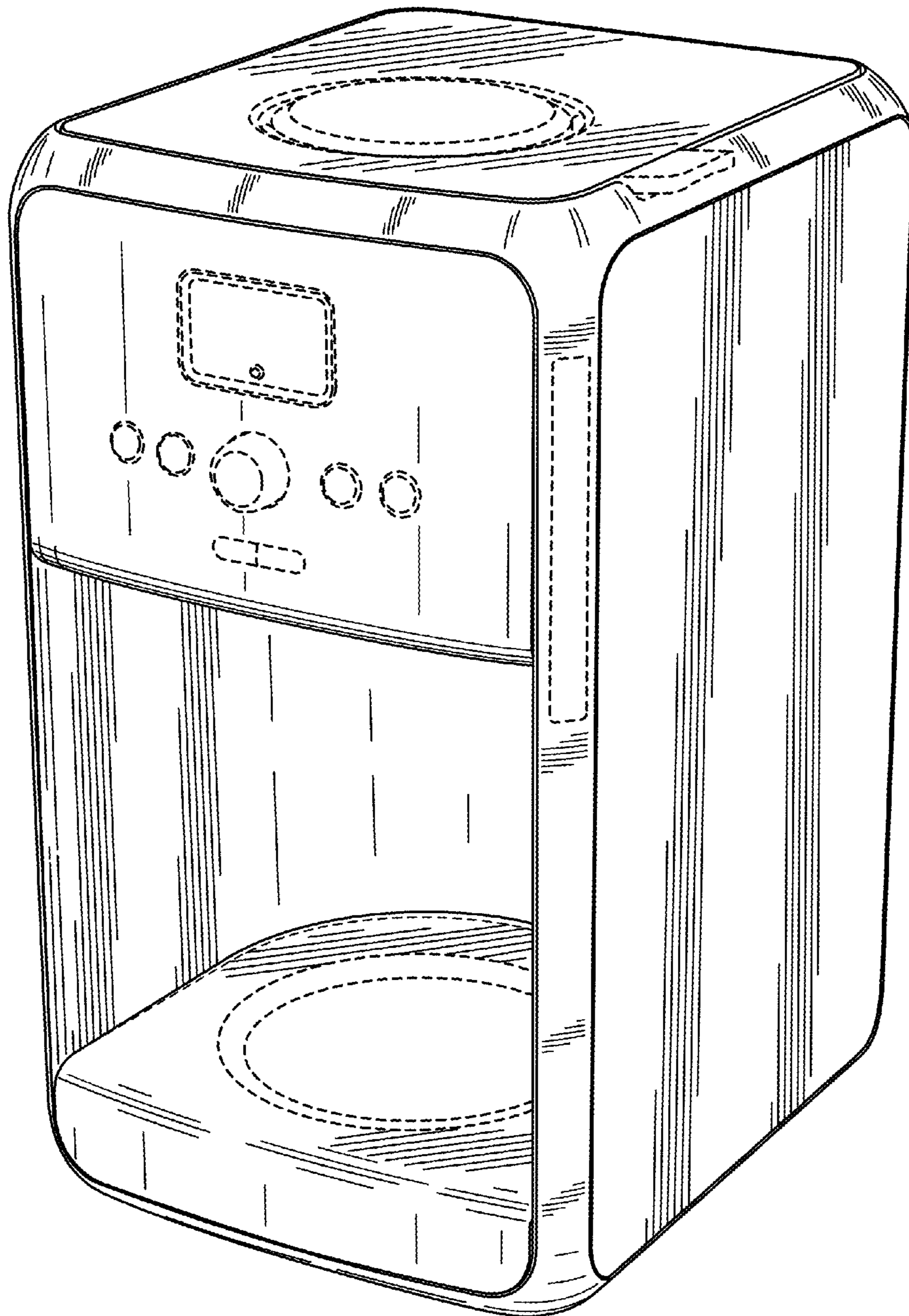

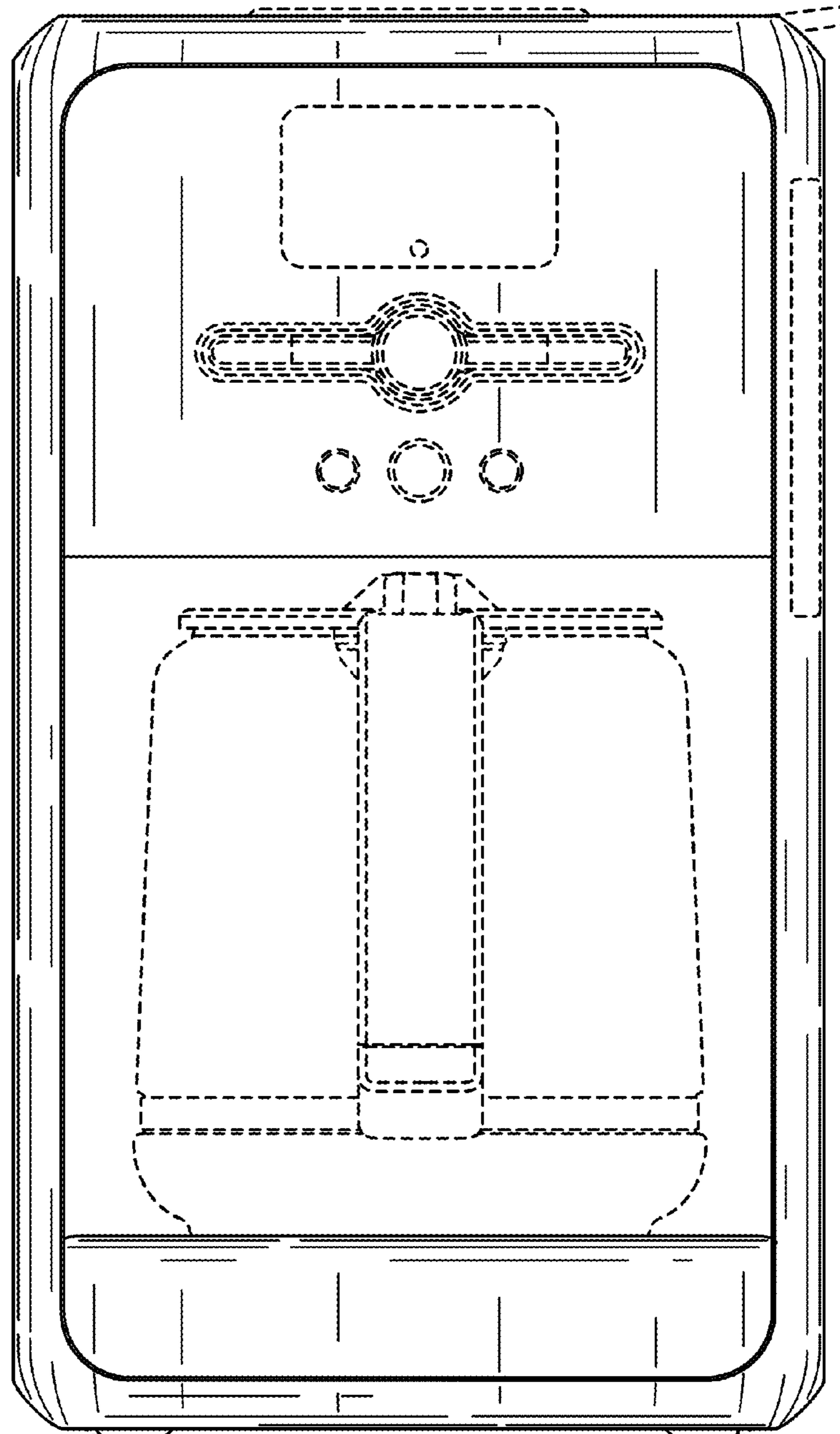

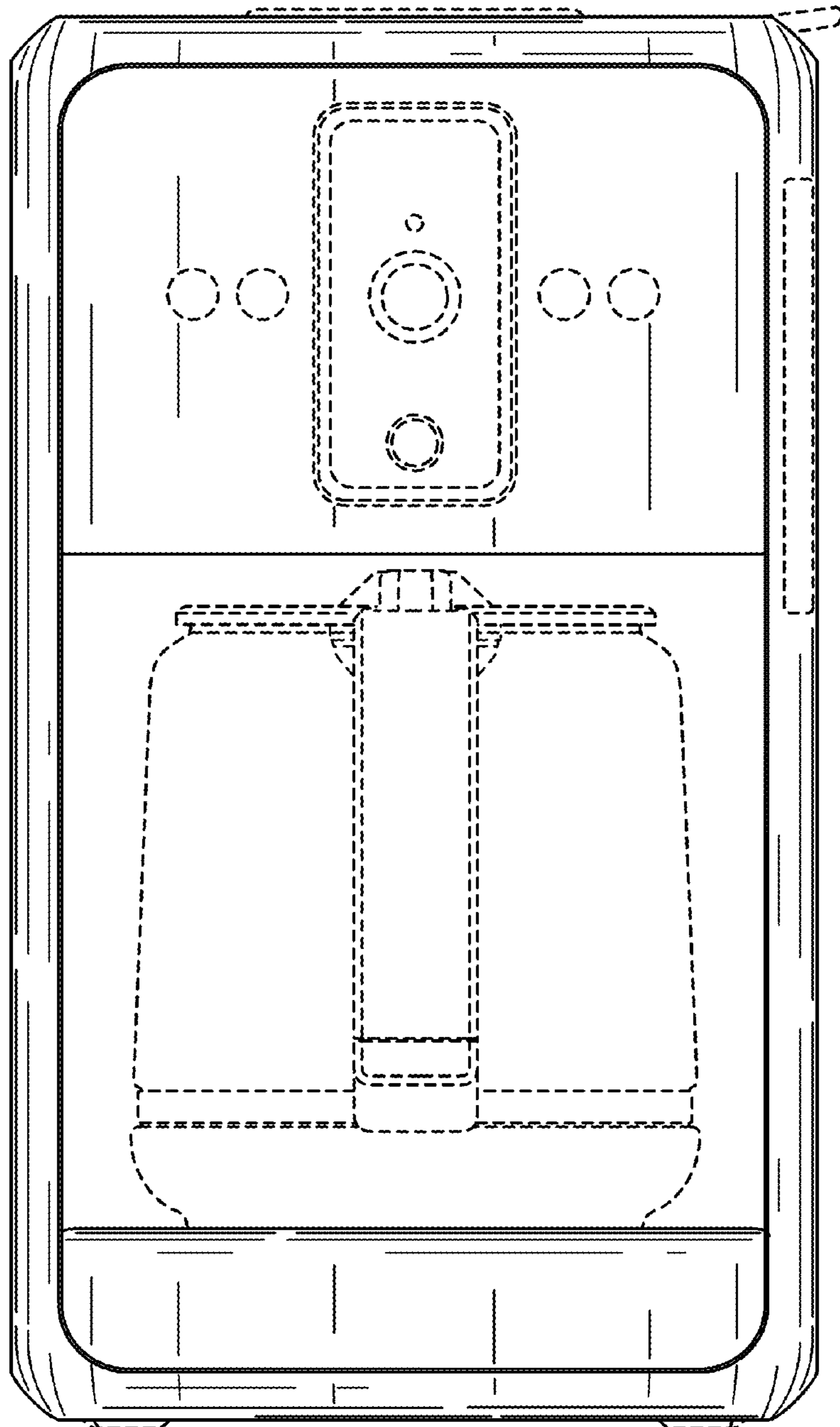

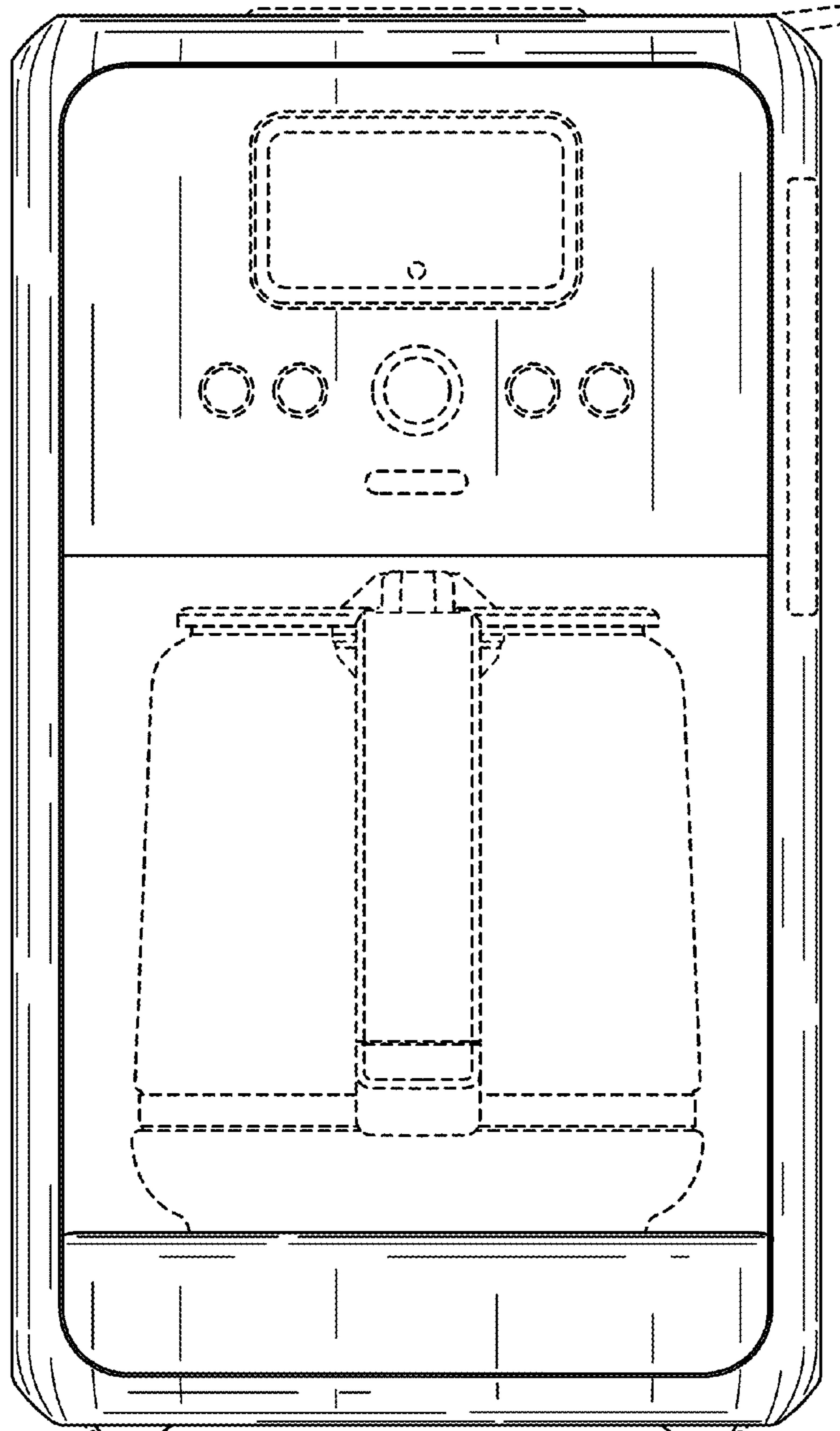
