FIG. 5 is a right-side elevation view of the flipping blade of the present invention;

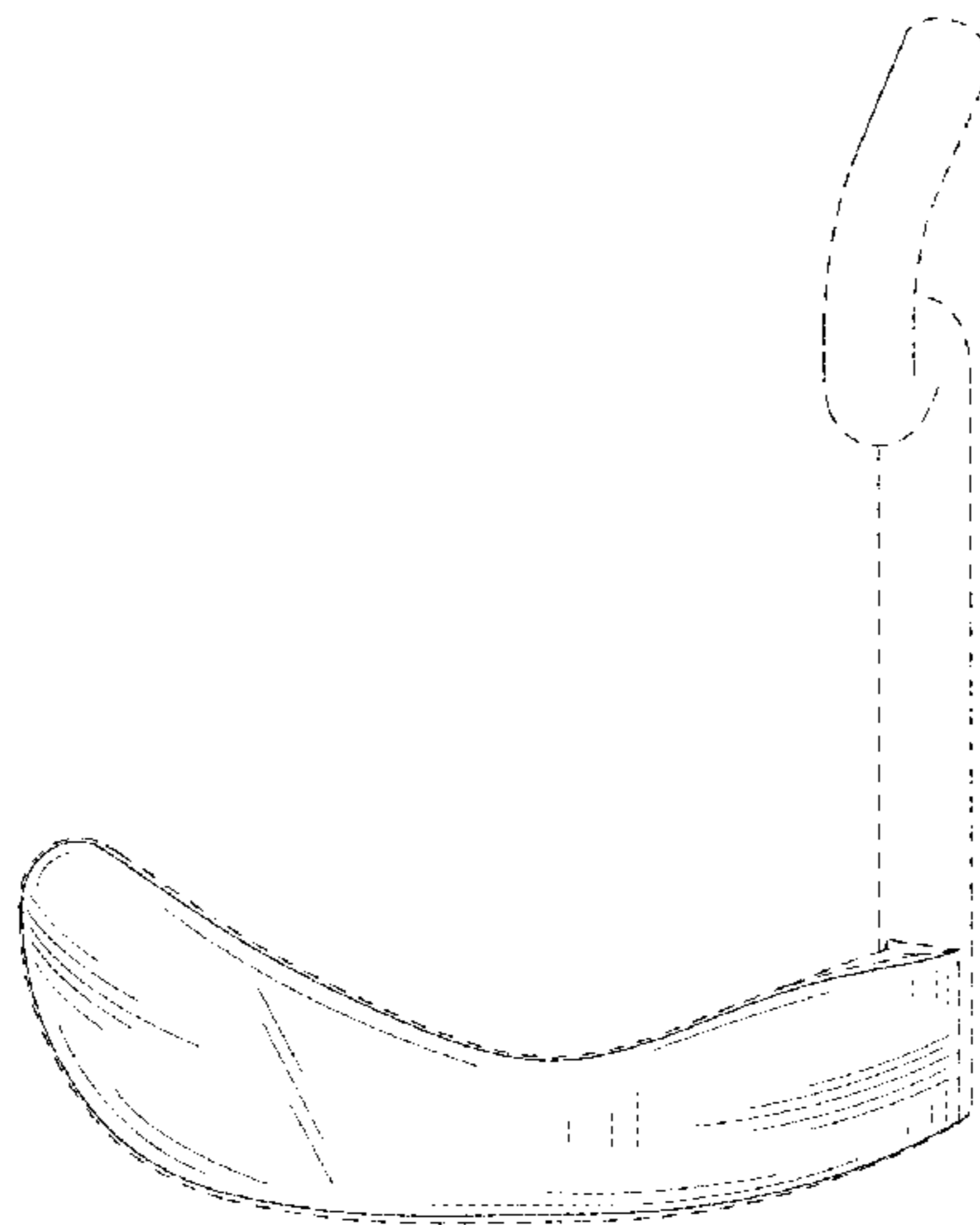
FIG. 6 is a left-side elevation view of the flipping blade of the present invention;

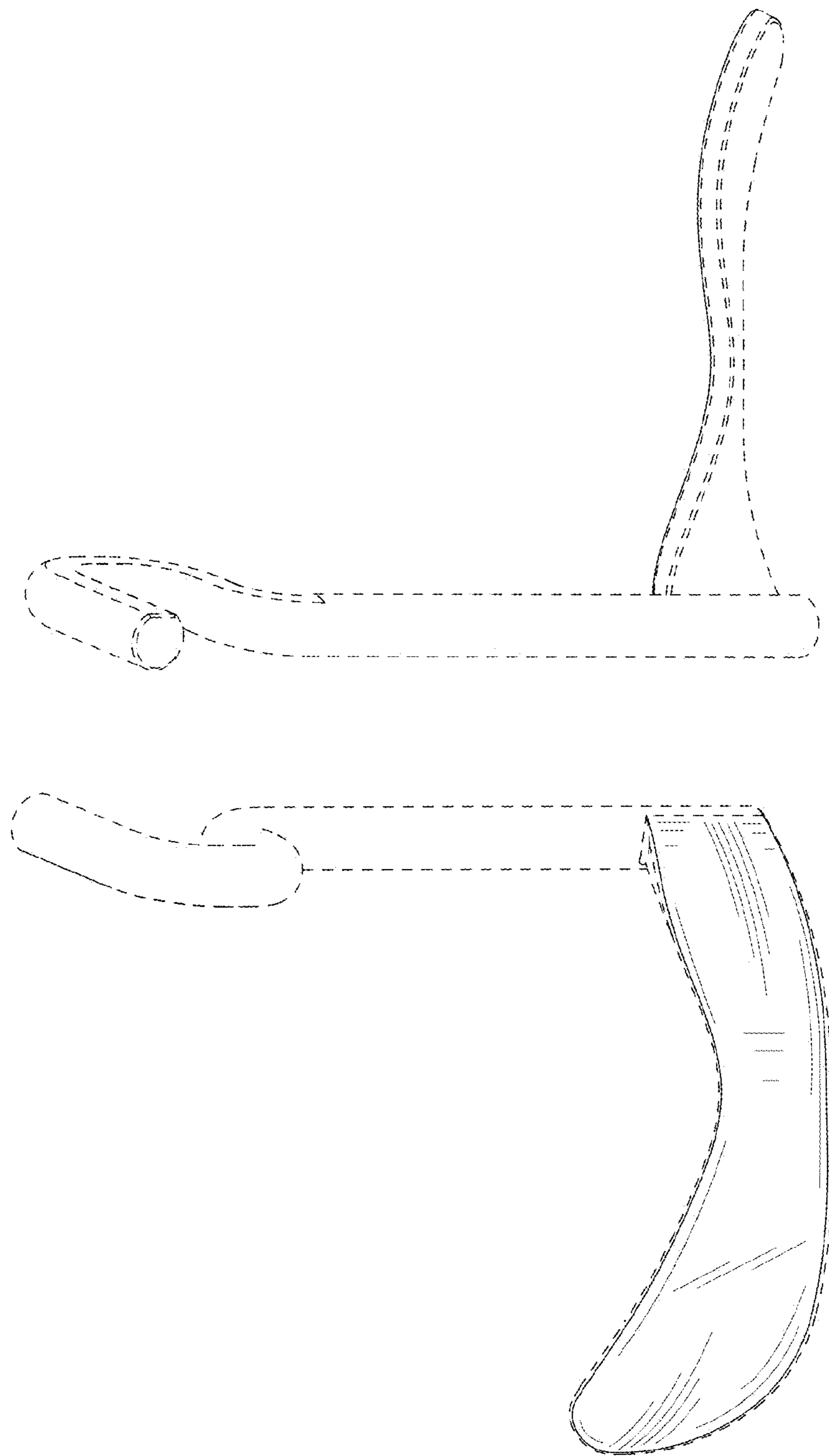

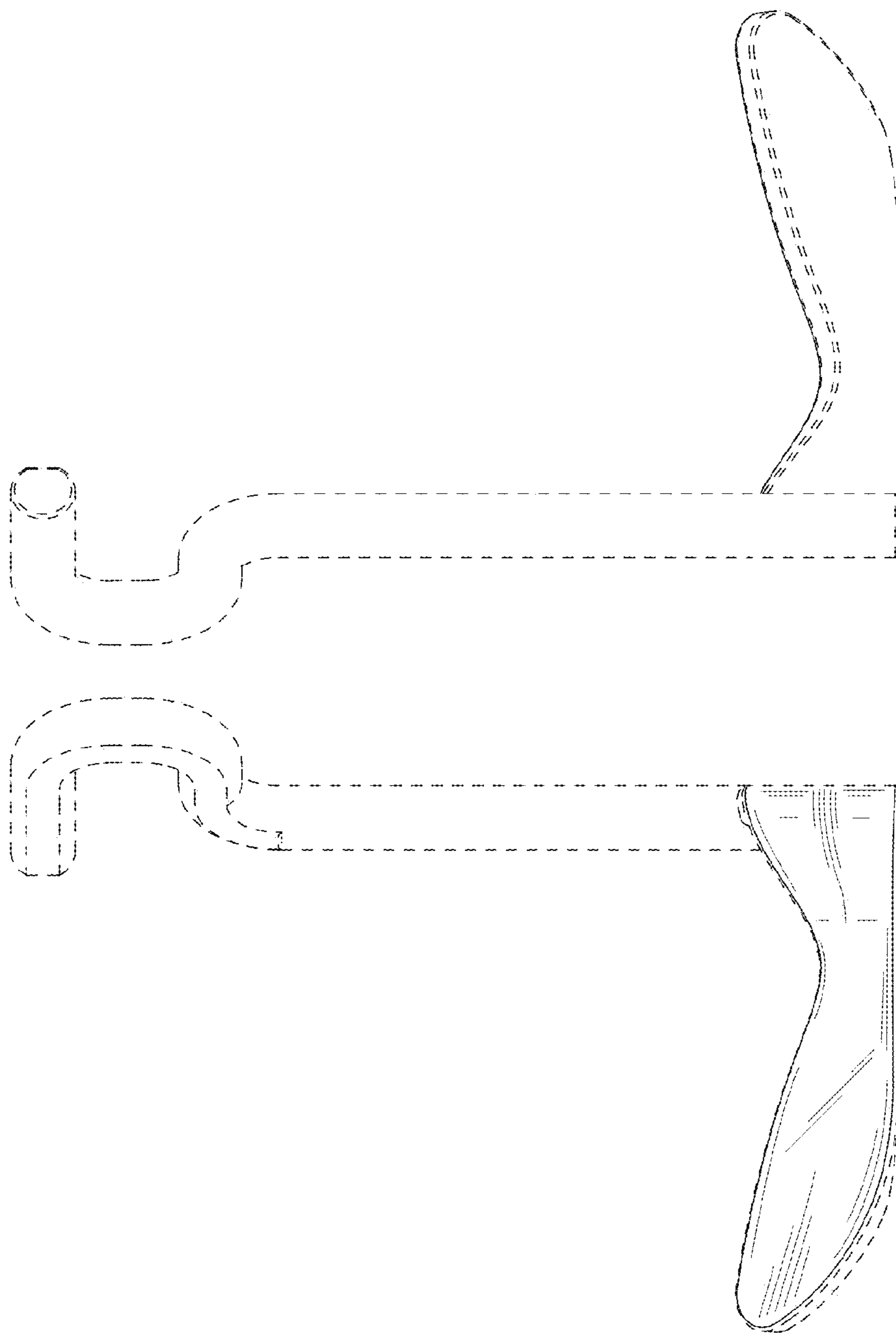

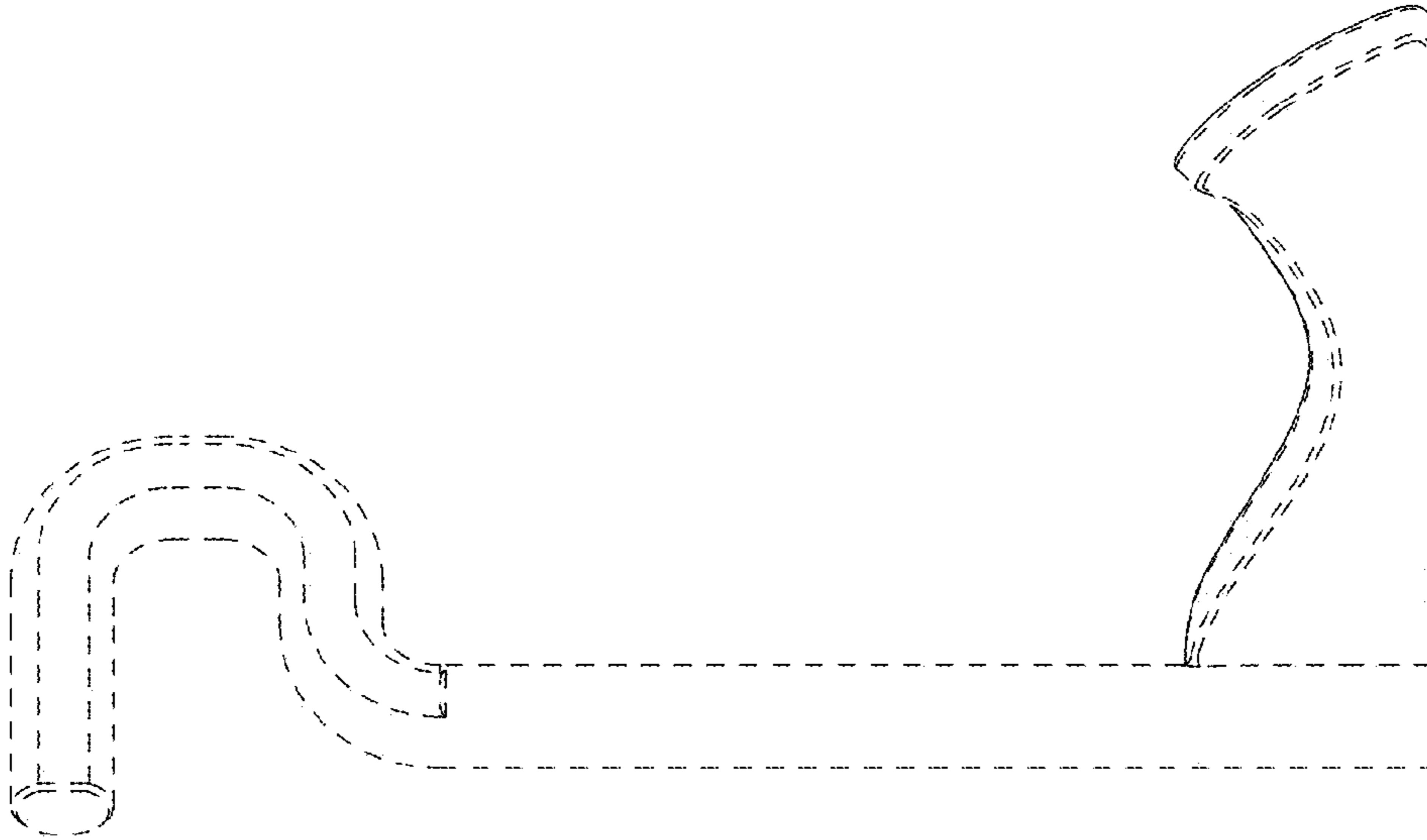

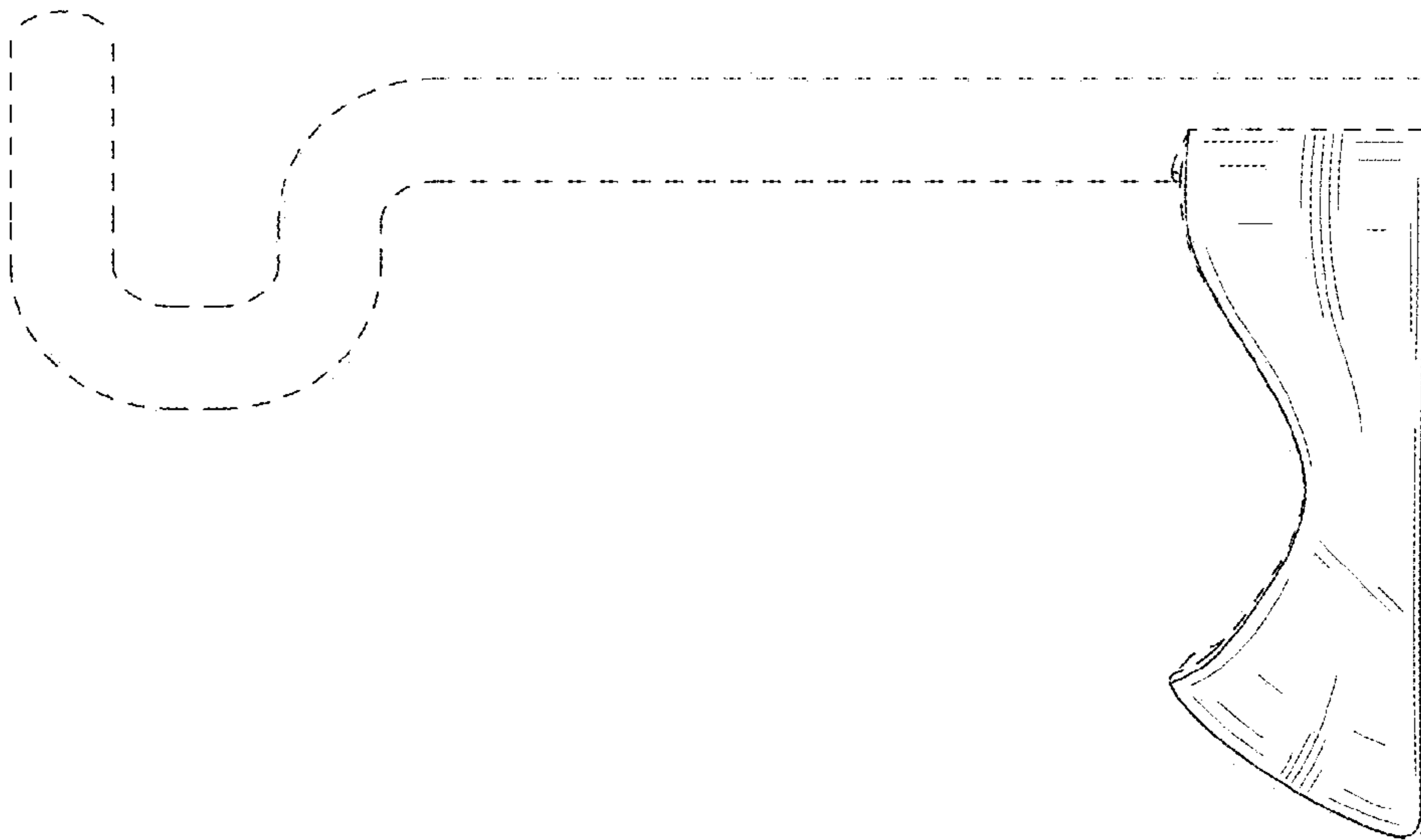

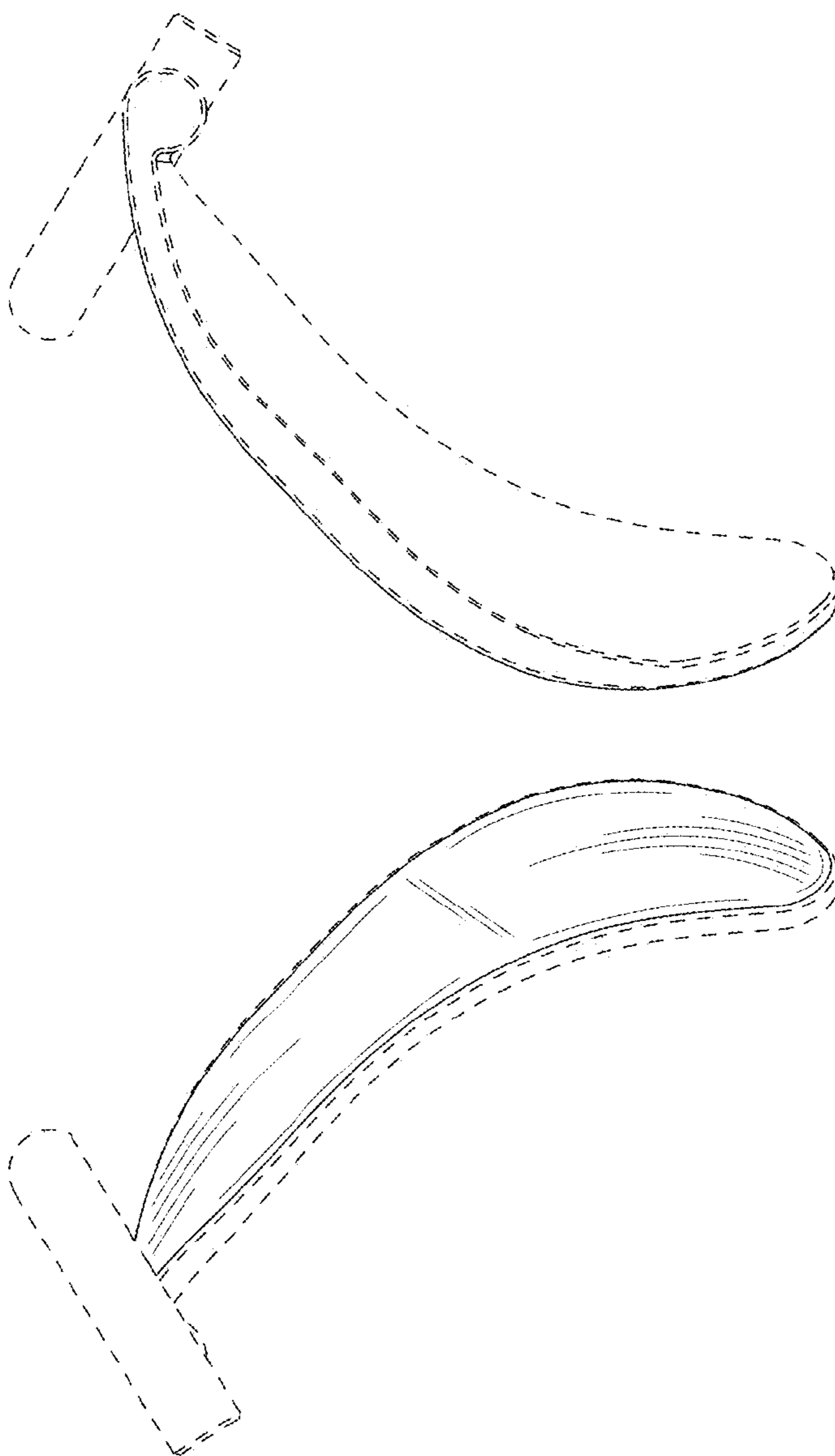
