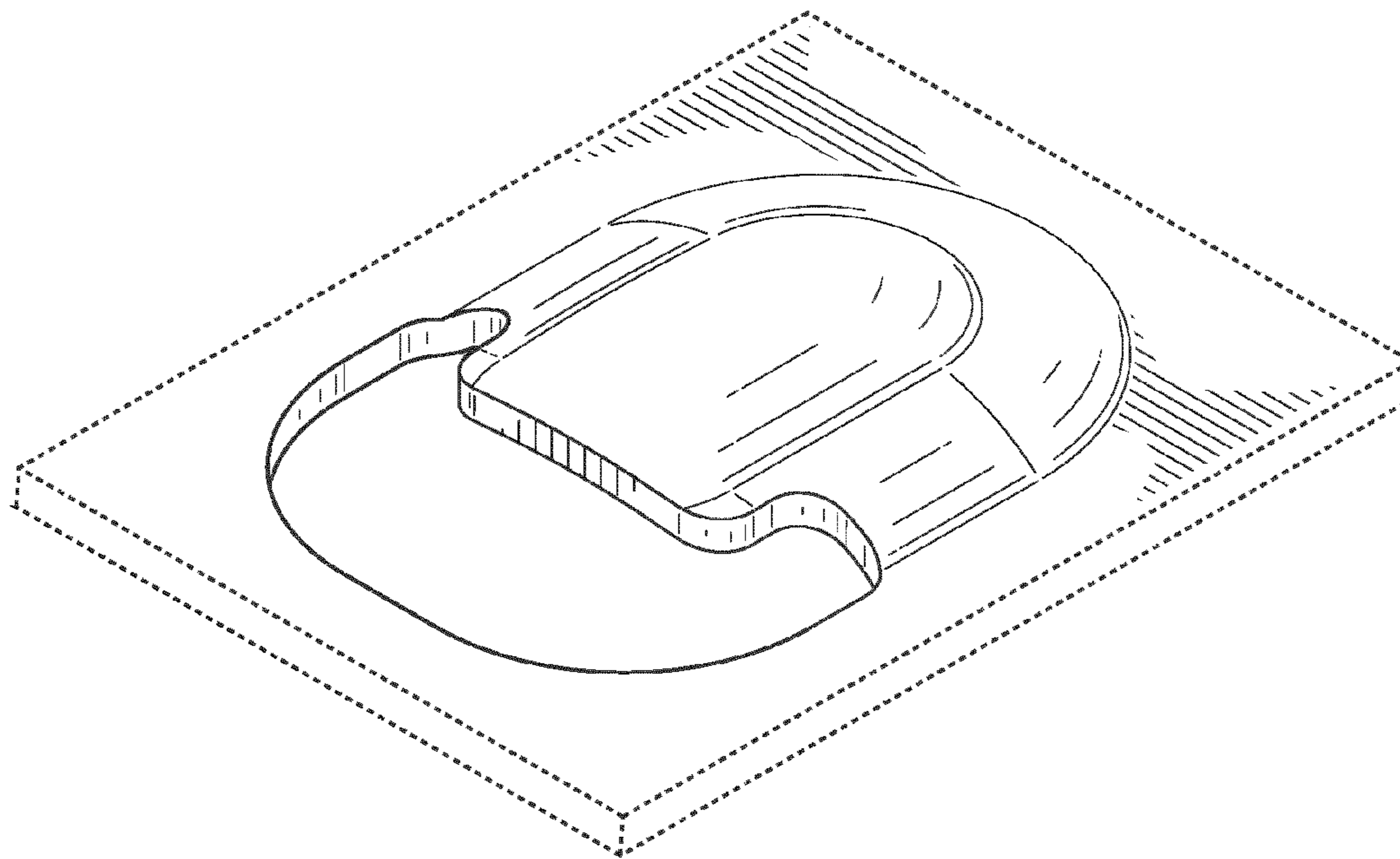
(57) **CLAIM**

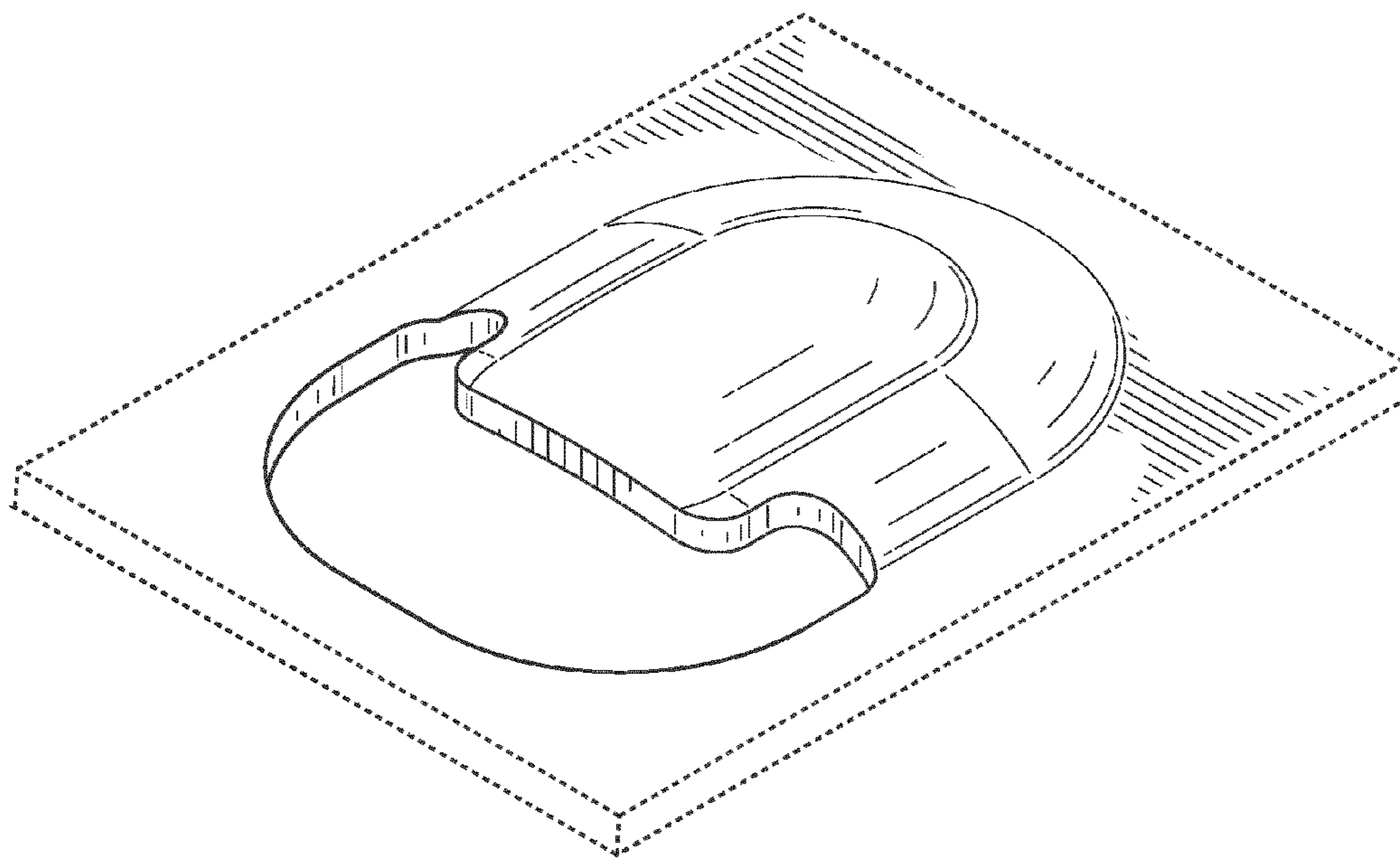
I claim the ornamental design for a grater, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a grater;

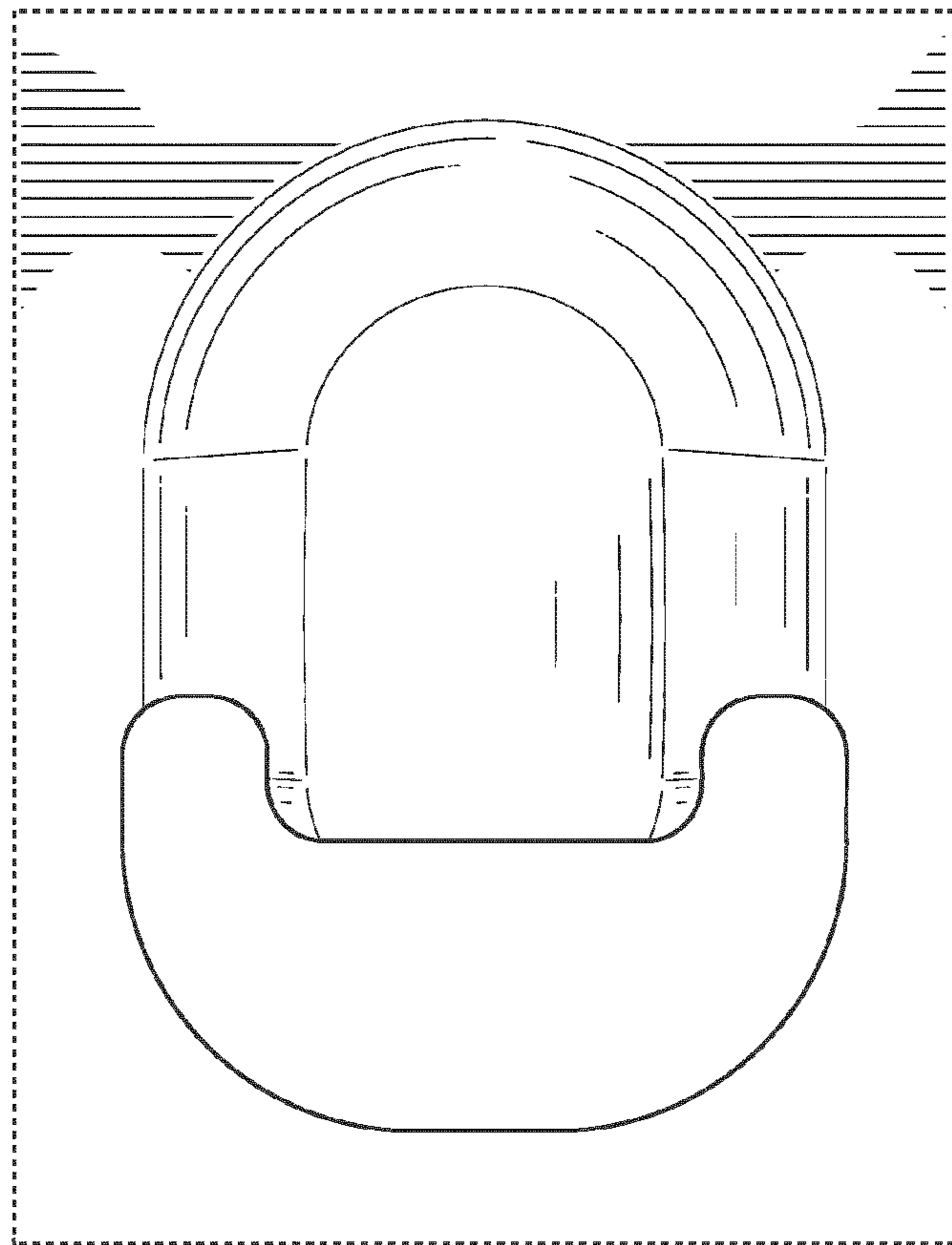
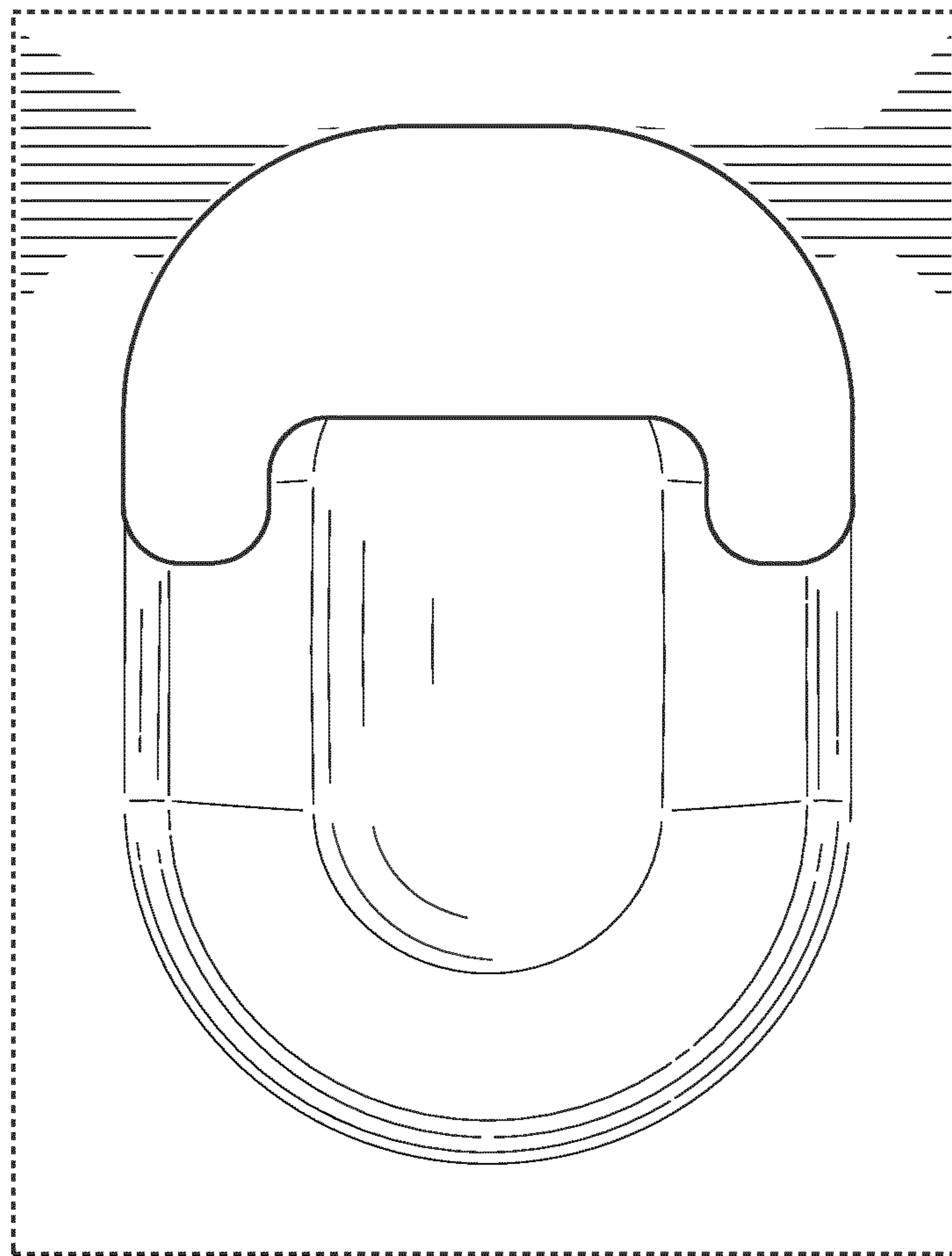
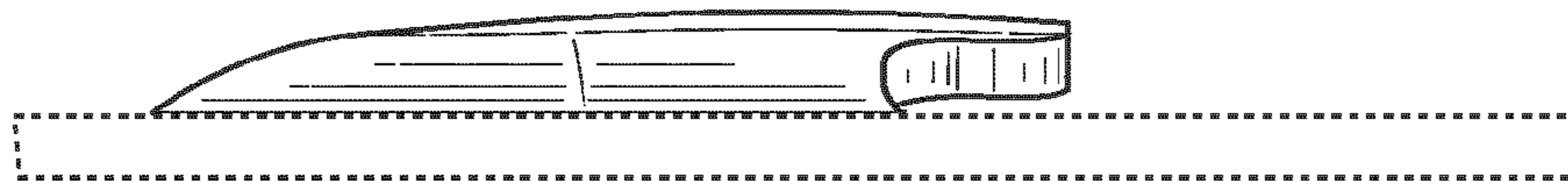


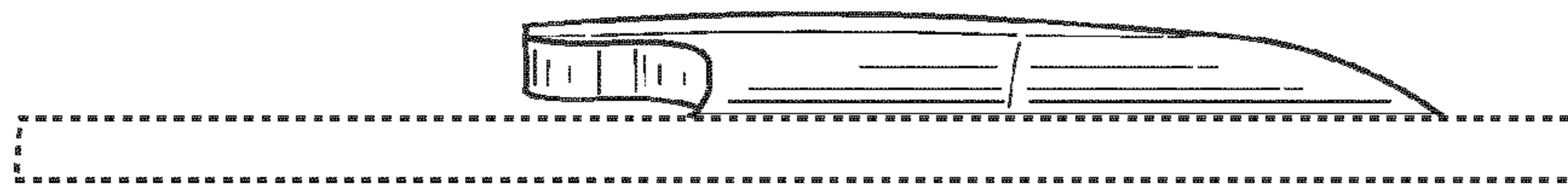

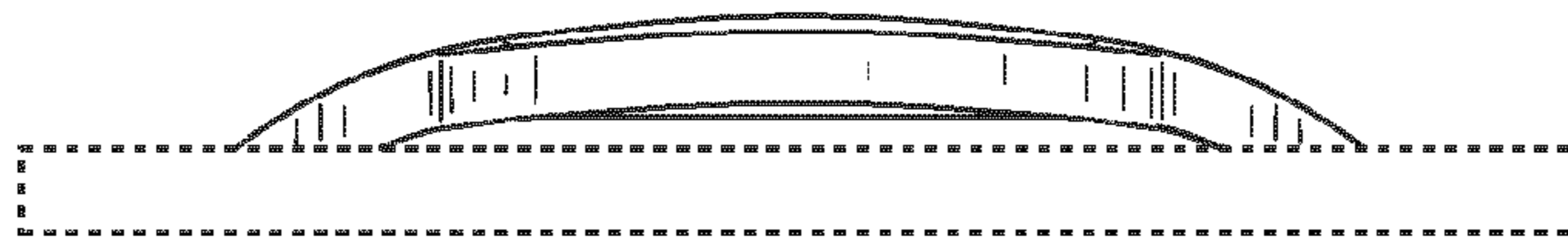

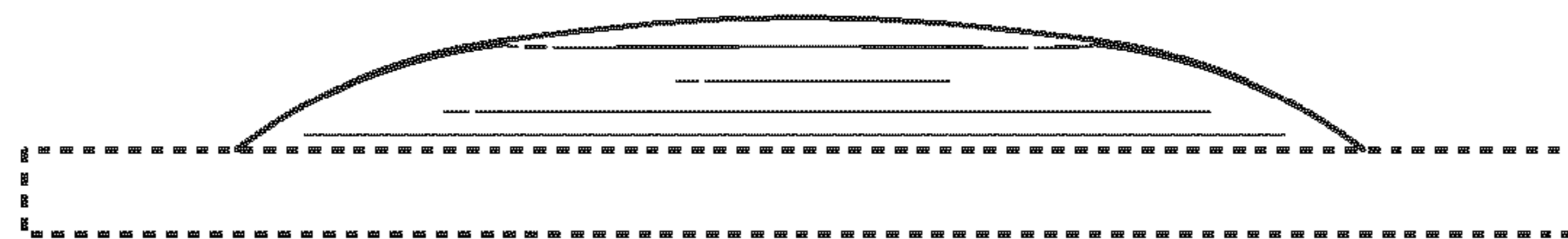
