**DESCRIPTION**

FIG. 1 is front view of a bottle showing my design, the rear view, left side view and right side view being identical thereto;

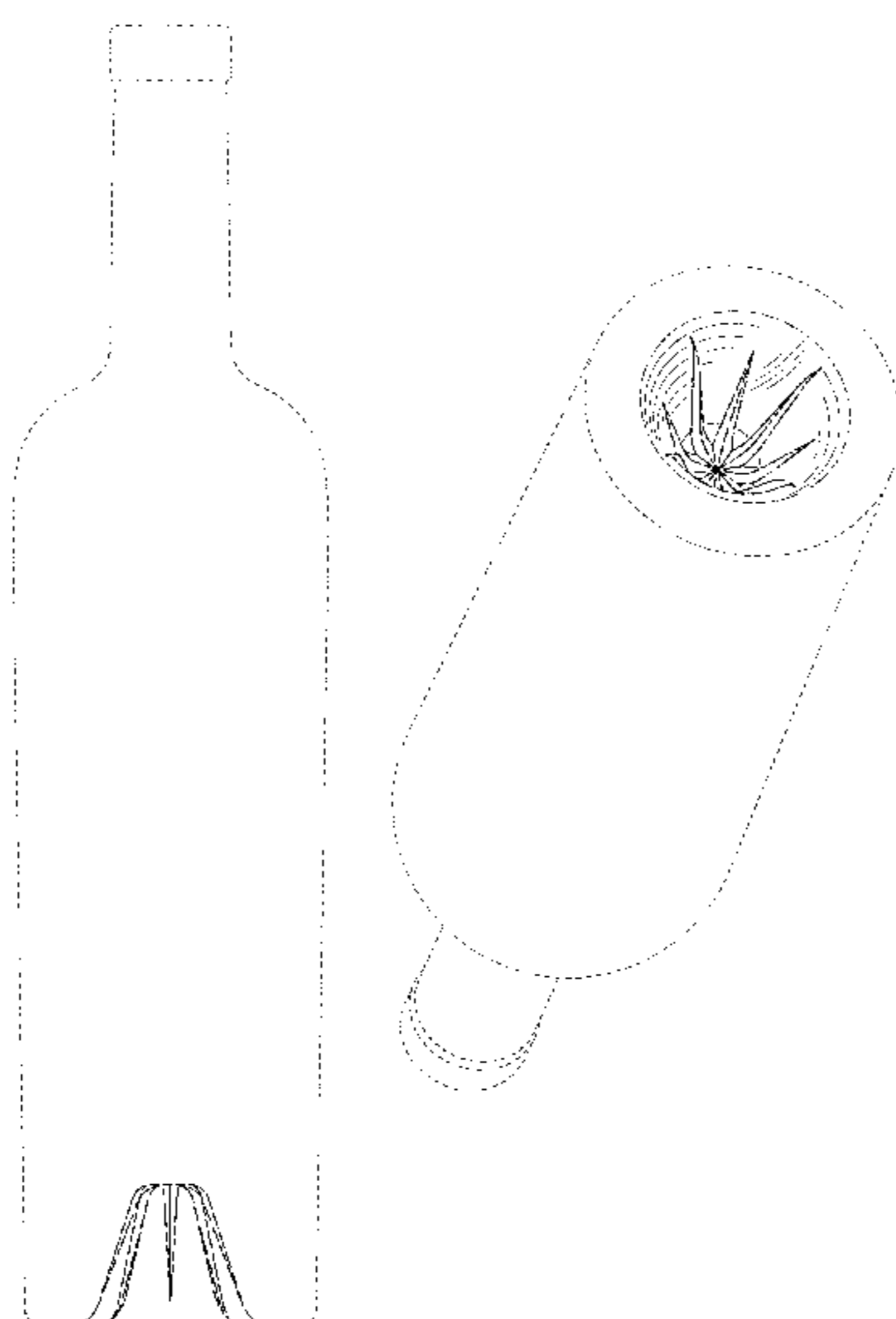
FIG. 2 is a bottom view thereof; and,

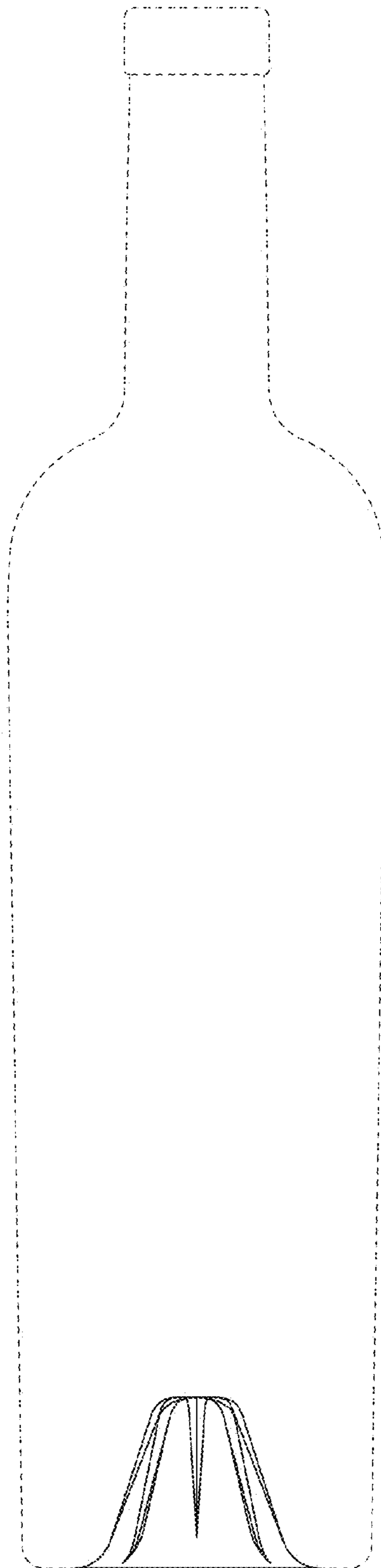

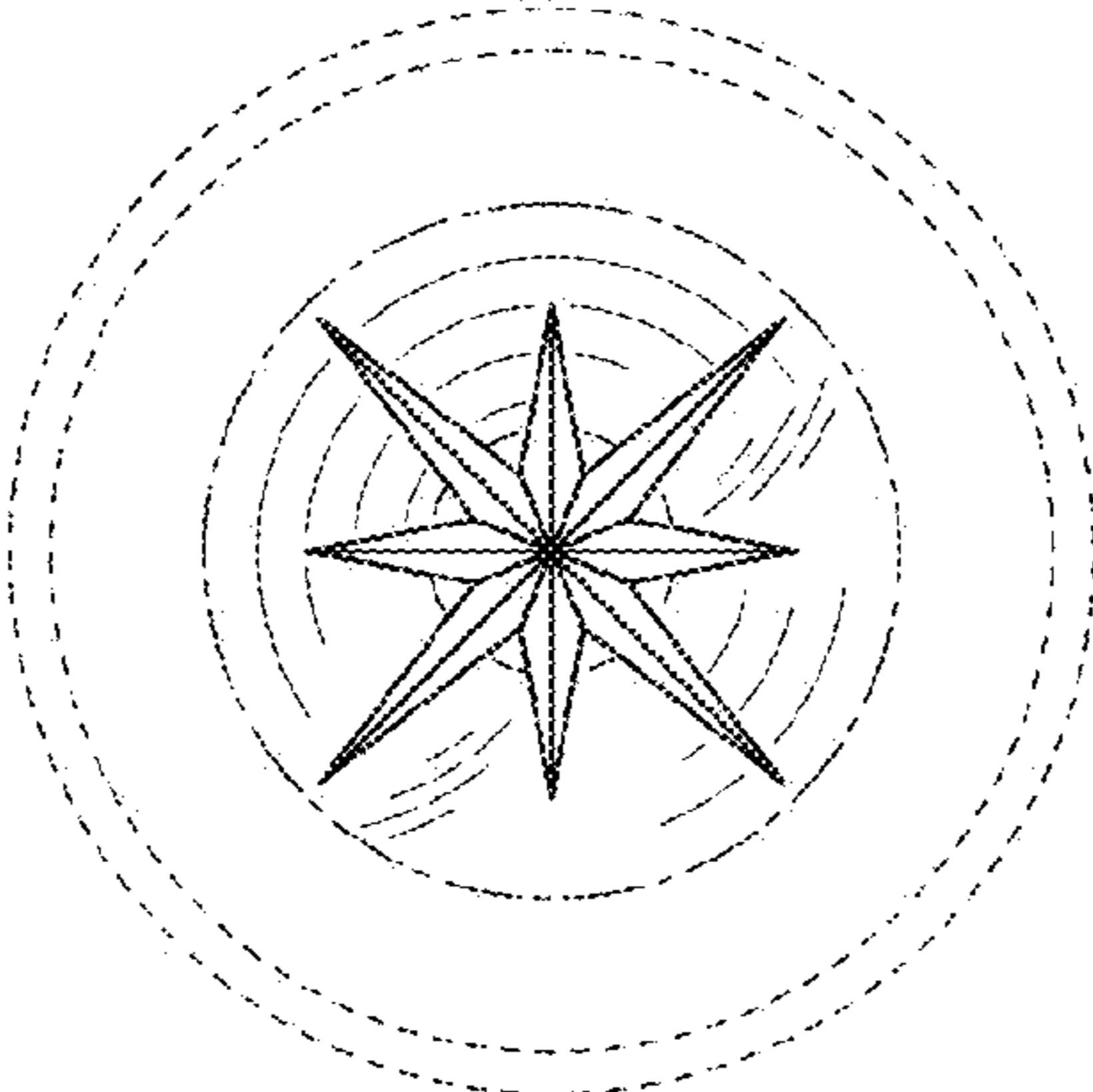

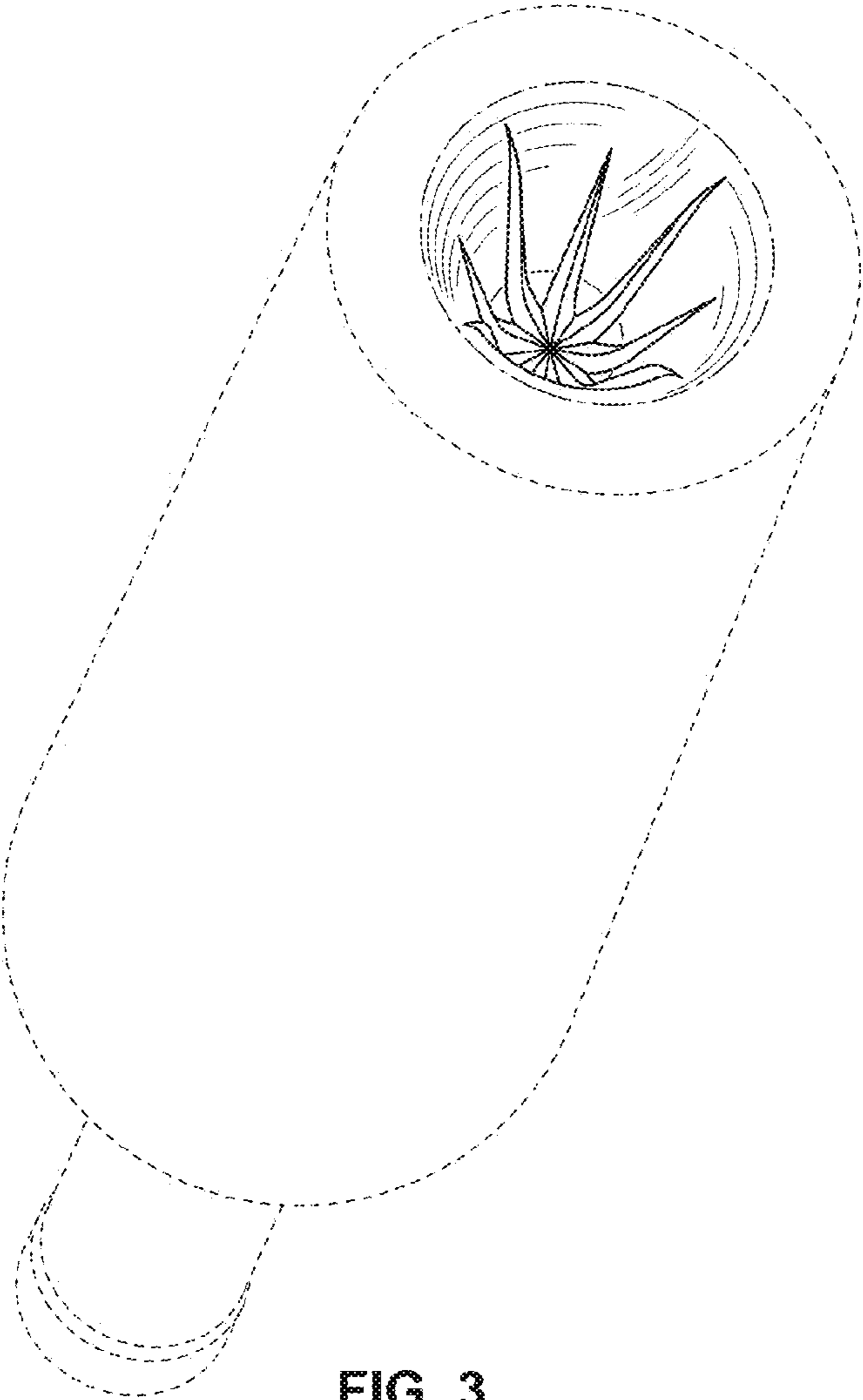
