The ornamental design for a bottle, substantially as shown and described.

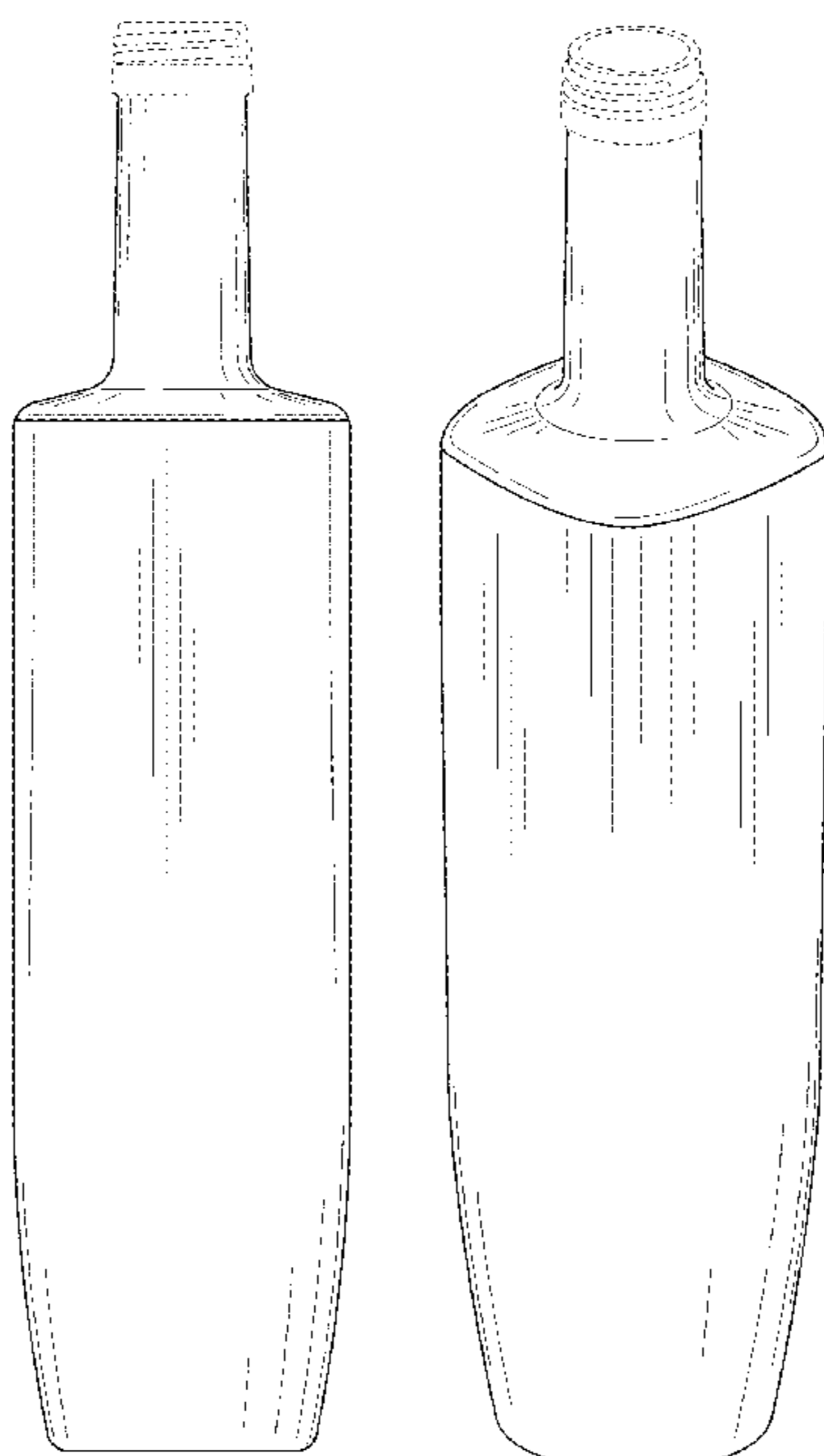
DESCRIPTION

FIG. 1 is a front elevational view of my invention, the rear elevational view, the right side elevational view, and the left side elevational view of which are mirror images; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; and, FIG. 4 is a right front perspective view thereof. The broken lines immediately adjacent the claimed areas represent the bounds of the claimed design while all other broken lines depict unclaimed portions of the bottle and form no part of the claimed design.

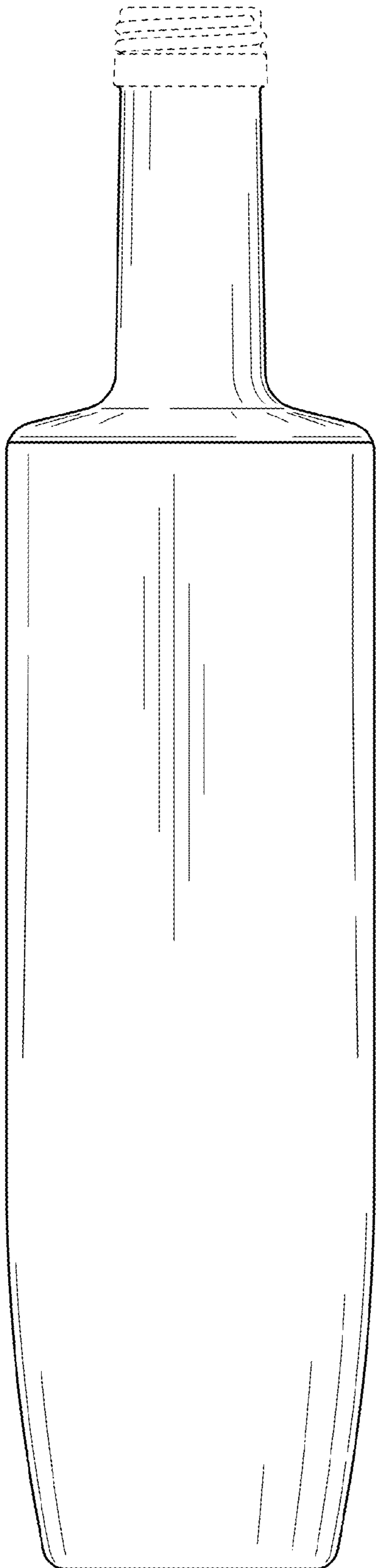

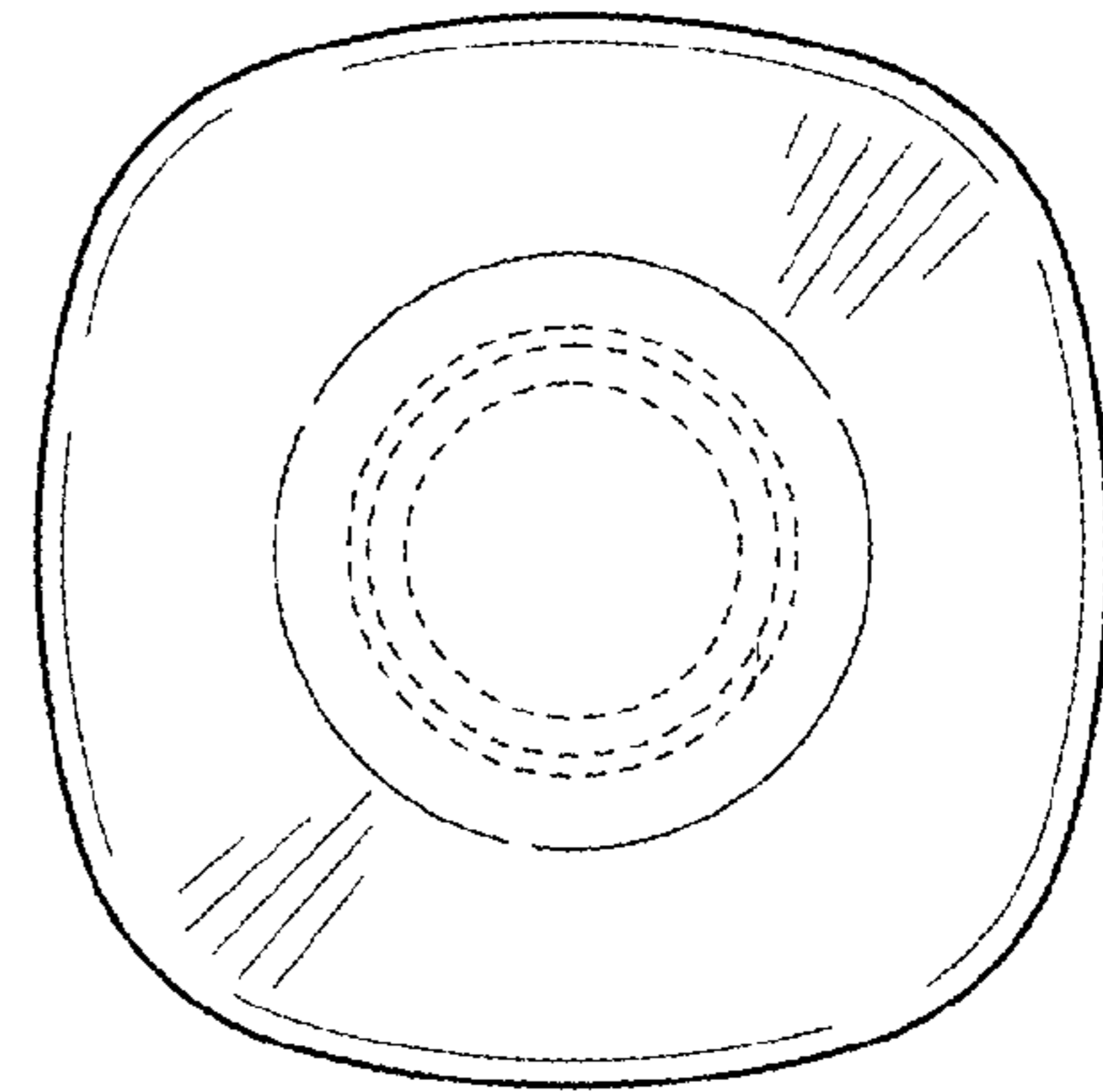

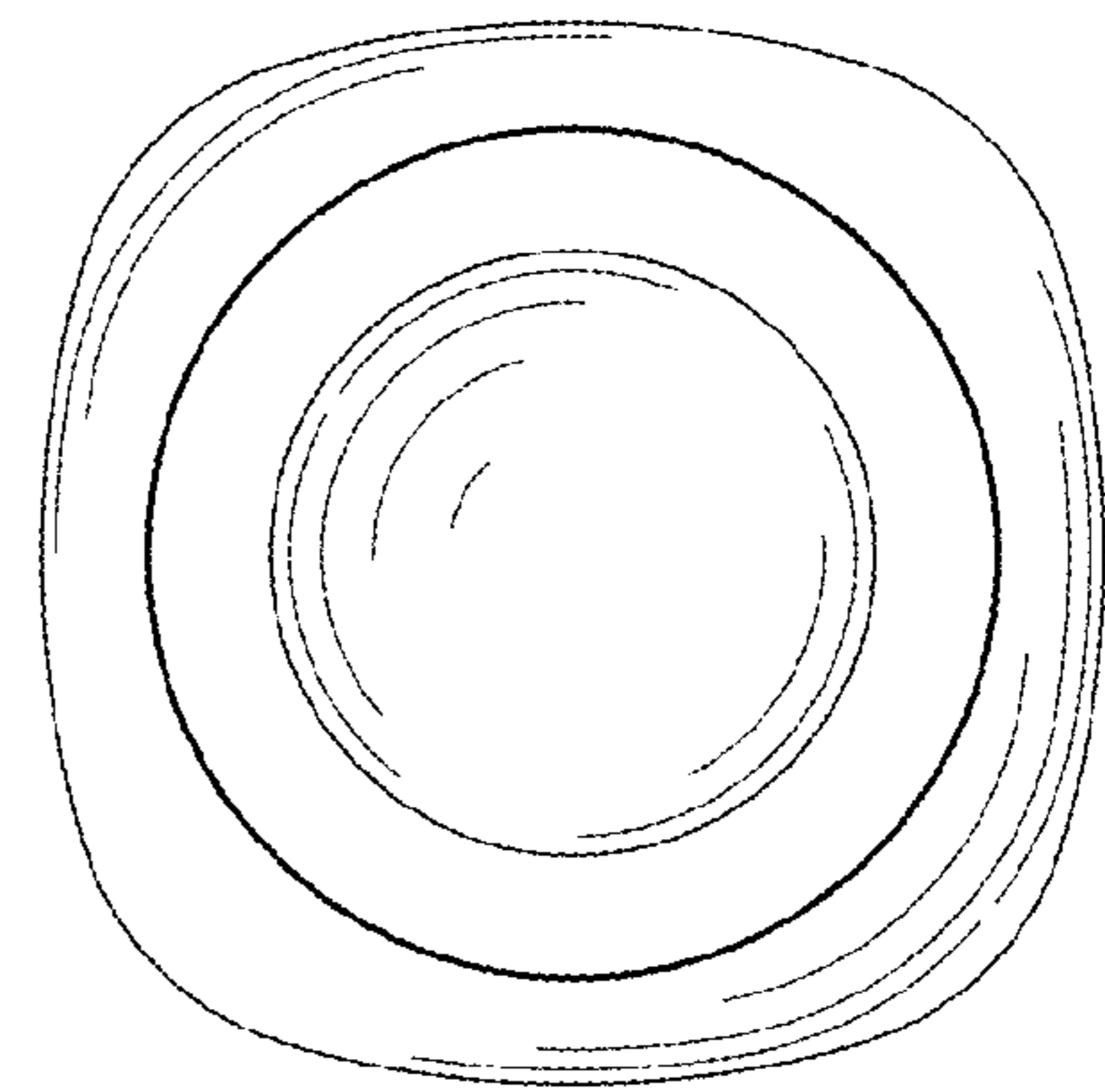

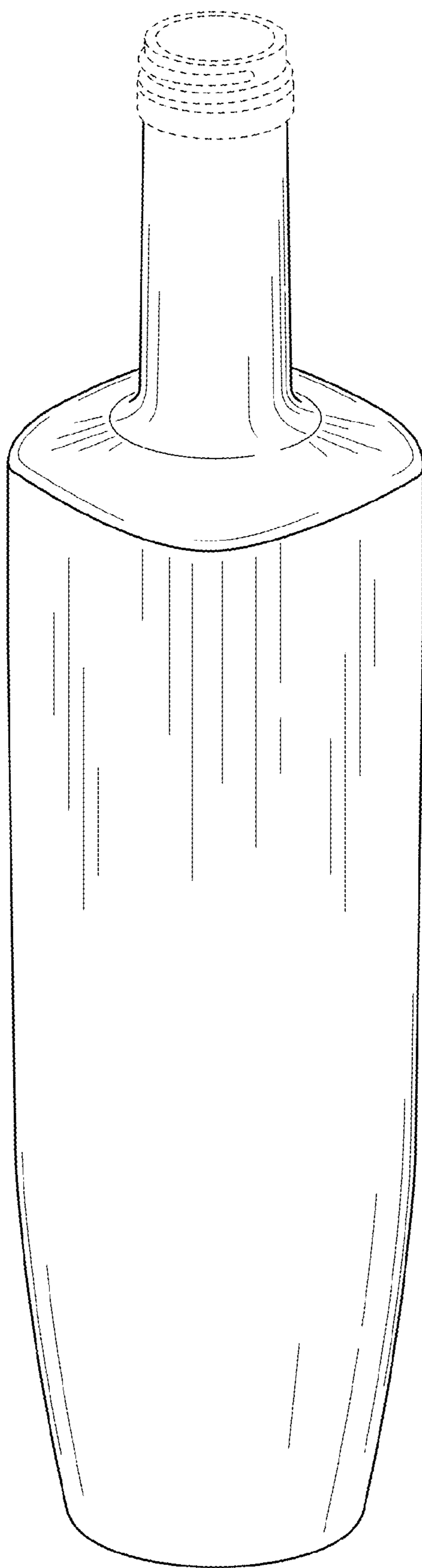
