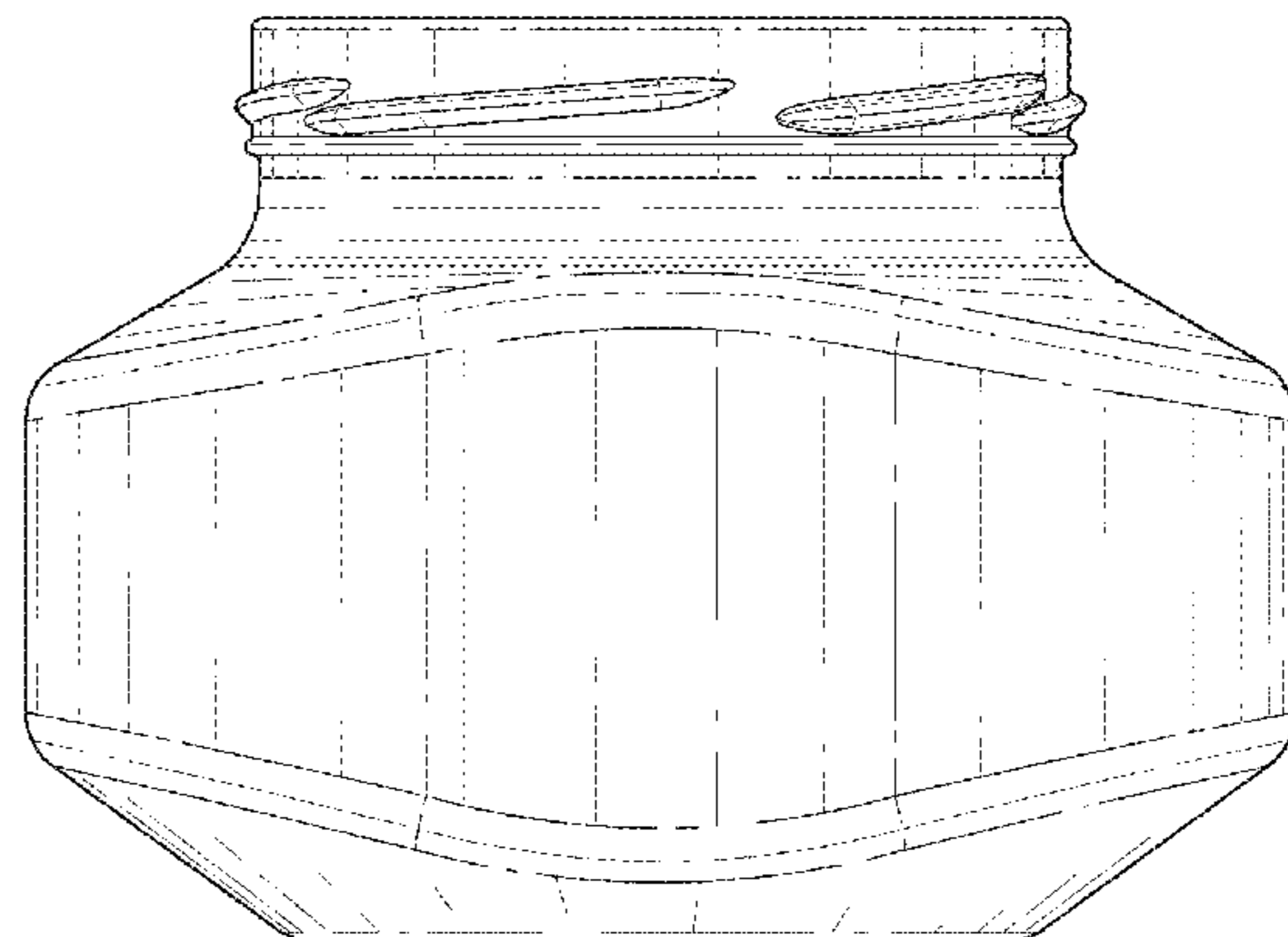
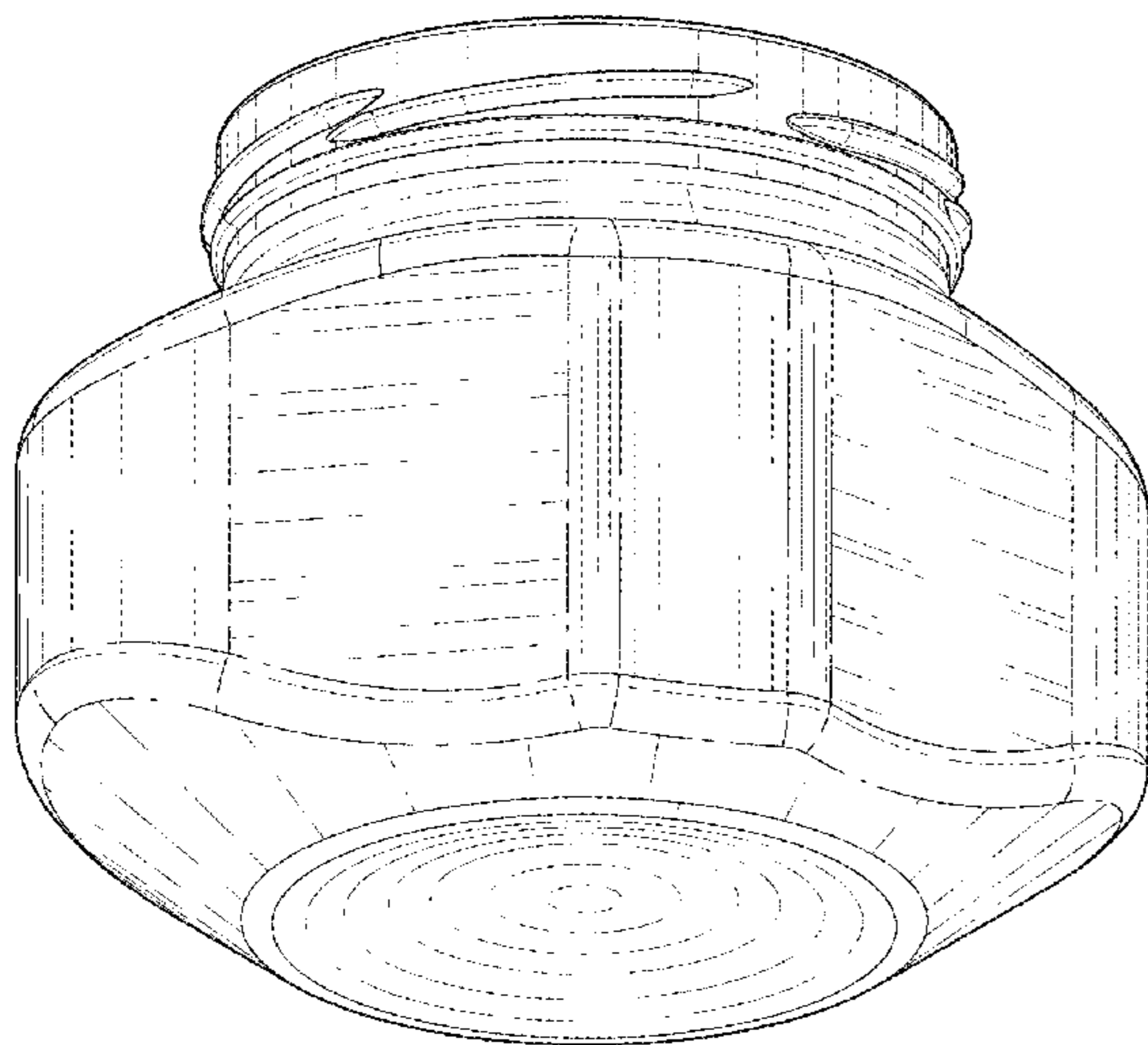
(57) **CLAIM**

The ornamental design for a jar, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a jar showing our new design;
FIG. 2 is a bottom, rear, left side perspective view of the jar of FIG. 1;
FIG. 3 is a front elevational view of the jar of FIG. 1;
FIG. 4 is a left side elevational view of the jar of FIG. 1;
FIG. 5 is a right side elevational view of the jar of FIG. 1;
FIG. 6 is a rear elevational view of the jar of FIG. 1;
FIG. 7 is a top plan view of the jar of FIG. 1; and,
FIG. 8 is a bottom plan view of the jar of FIG. 1.

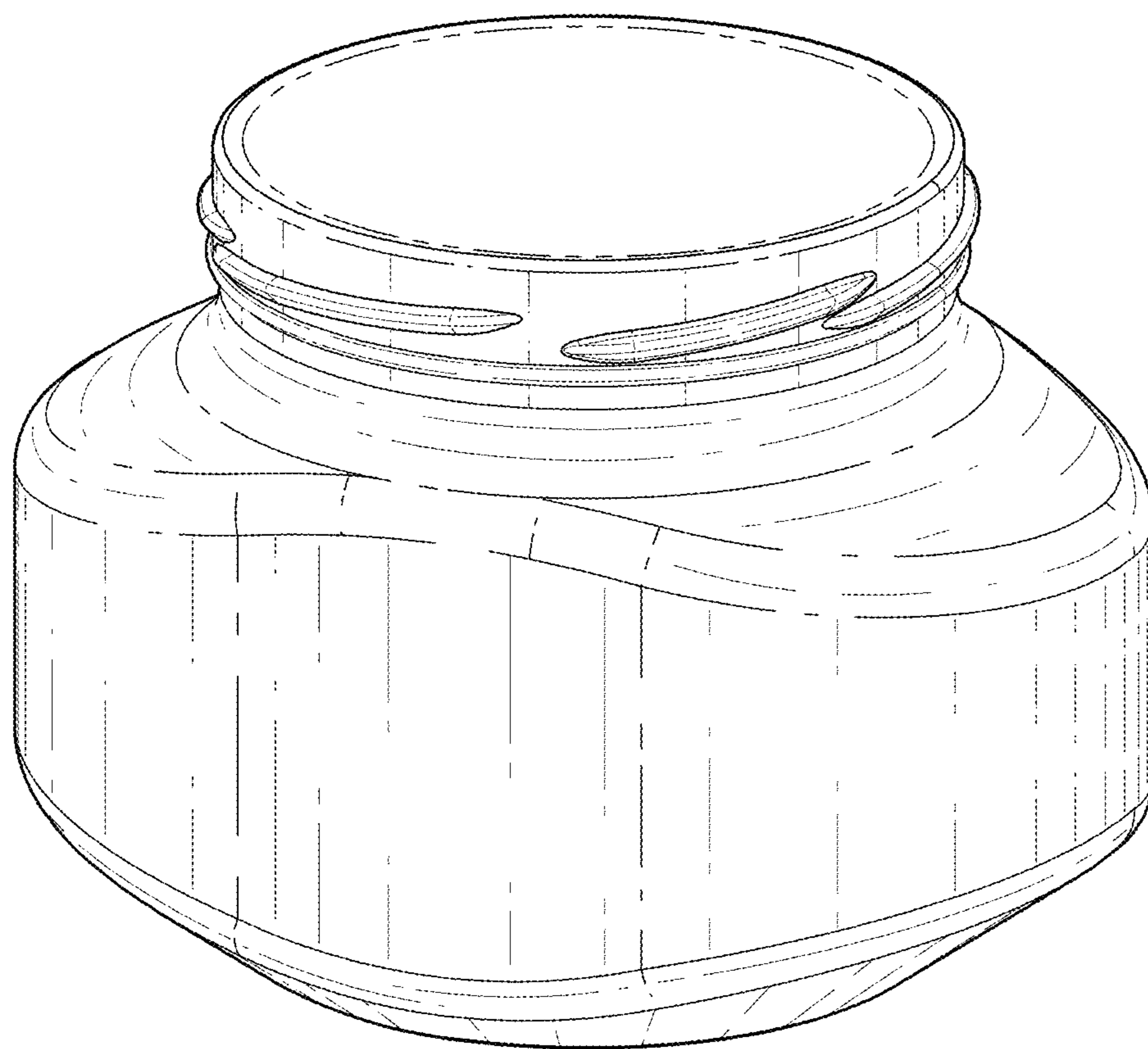

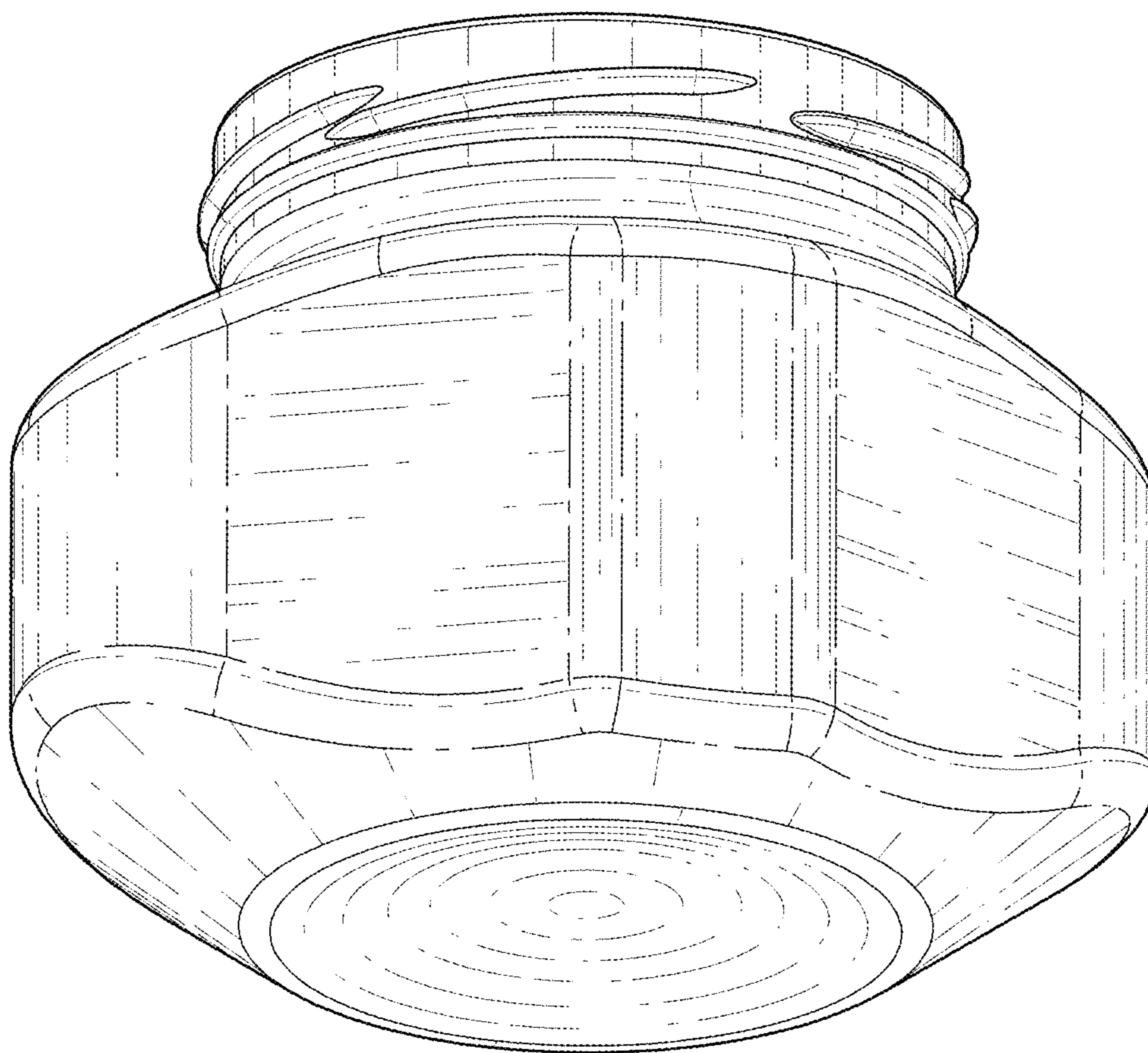

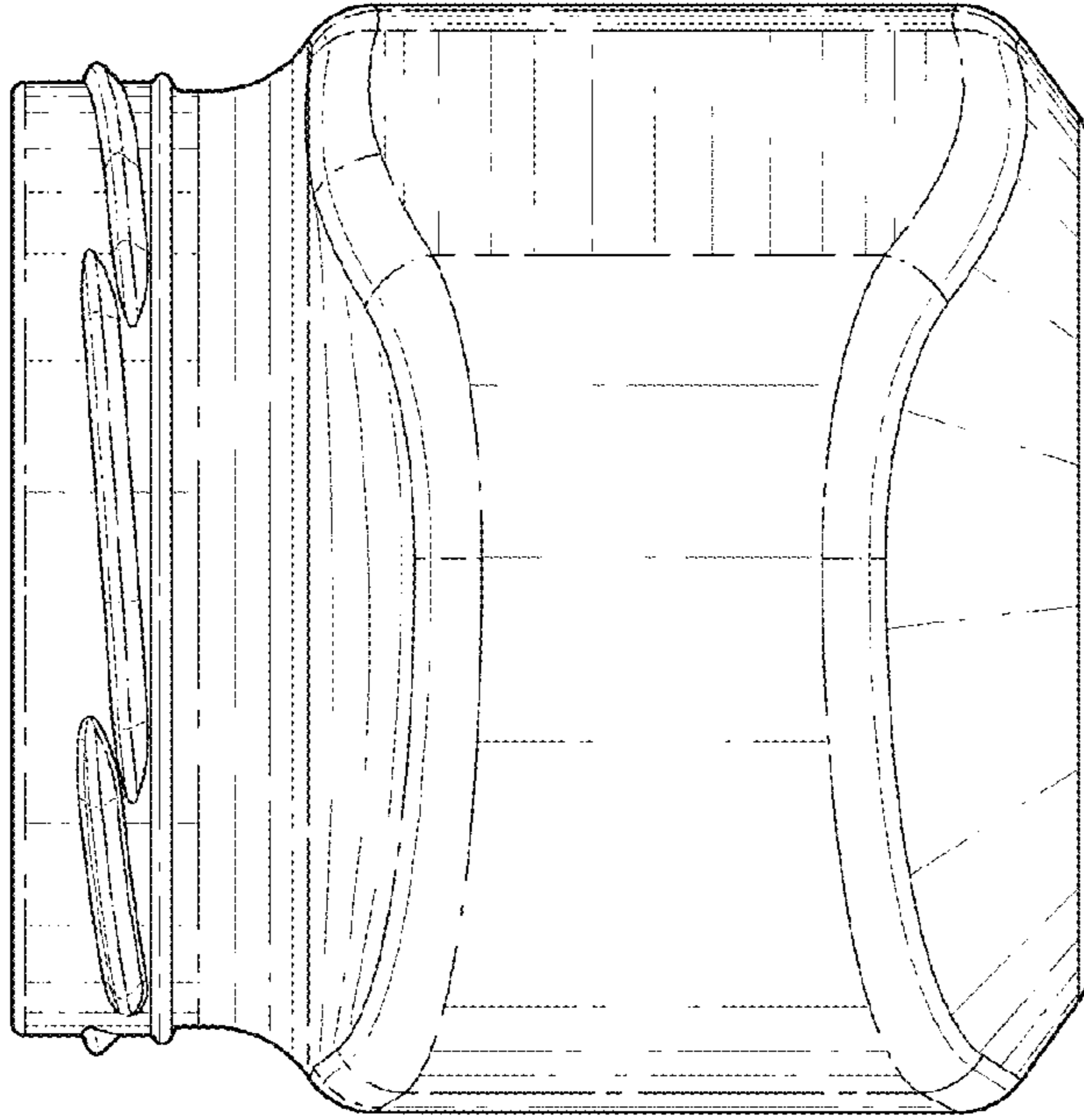

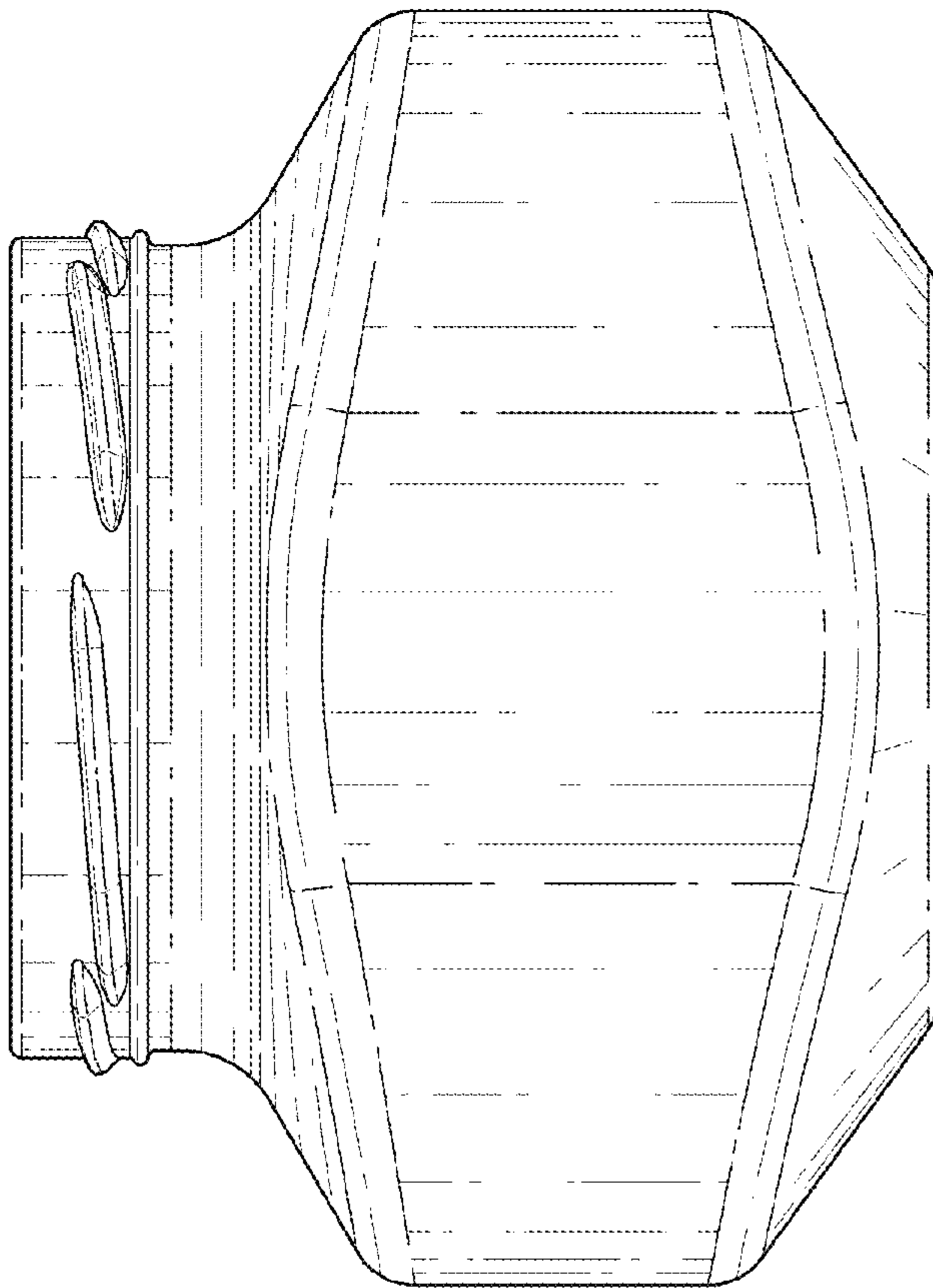

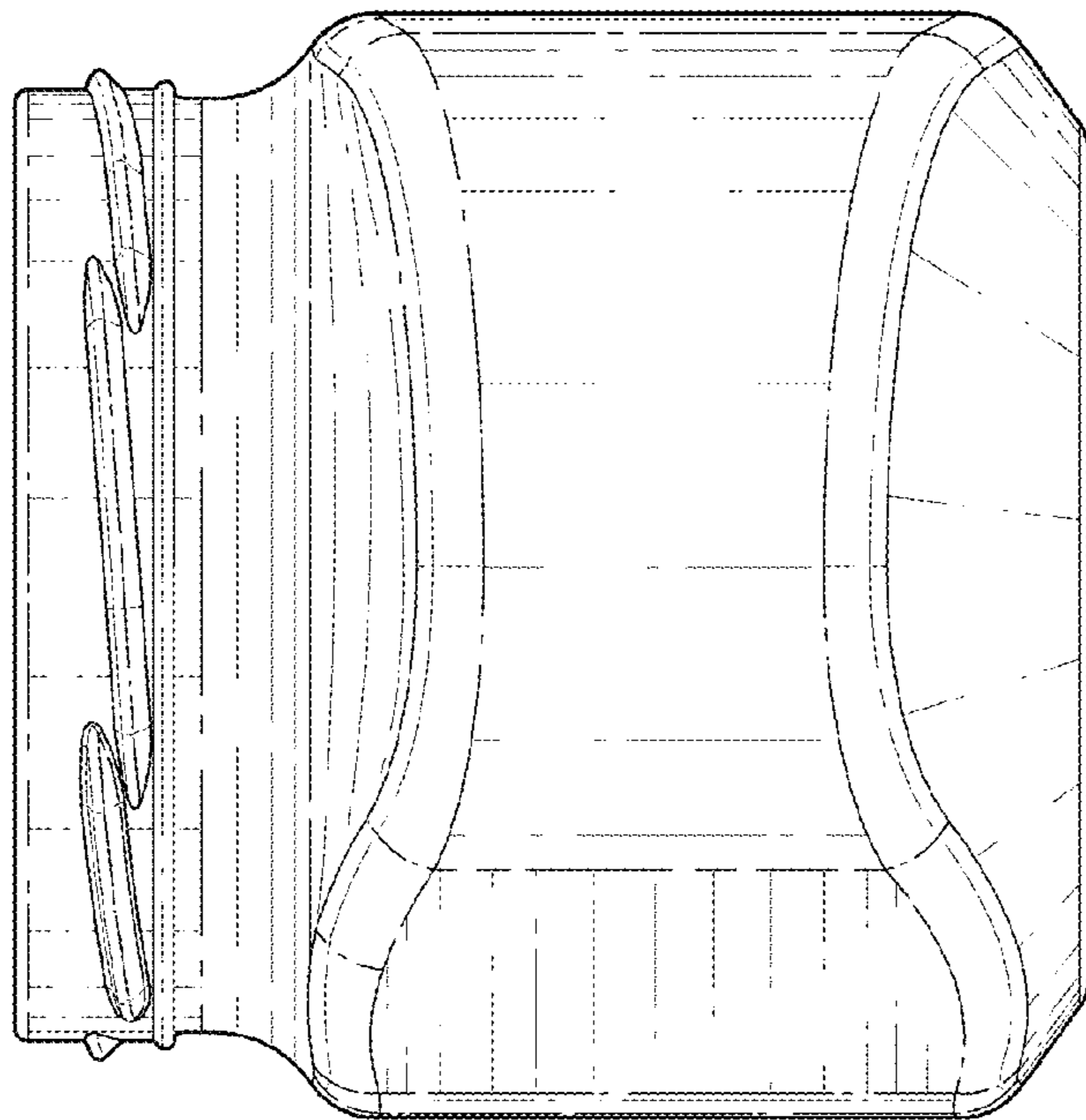

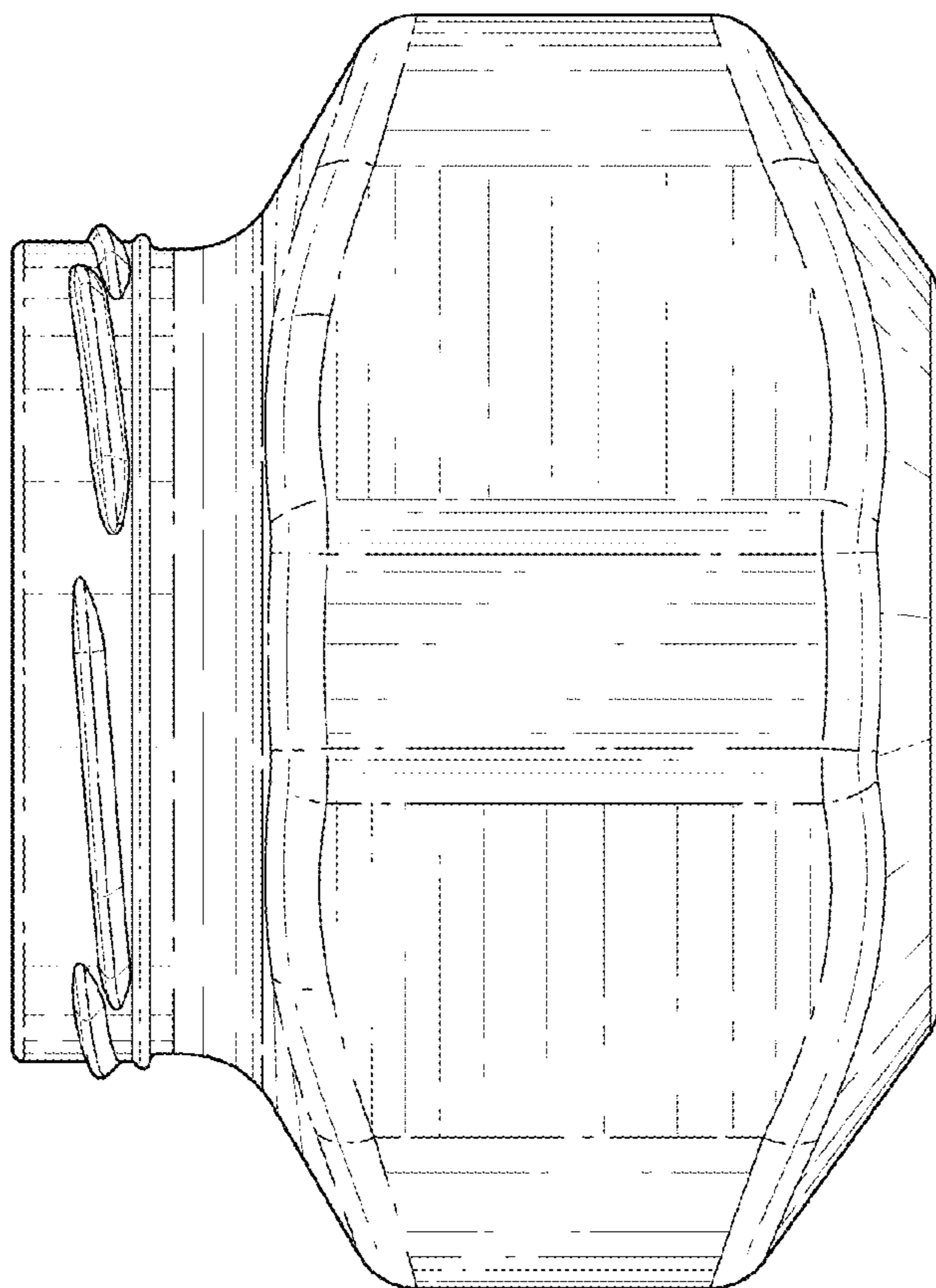

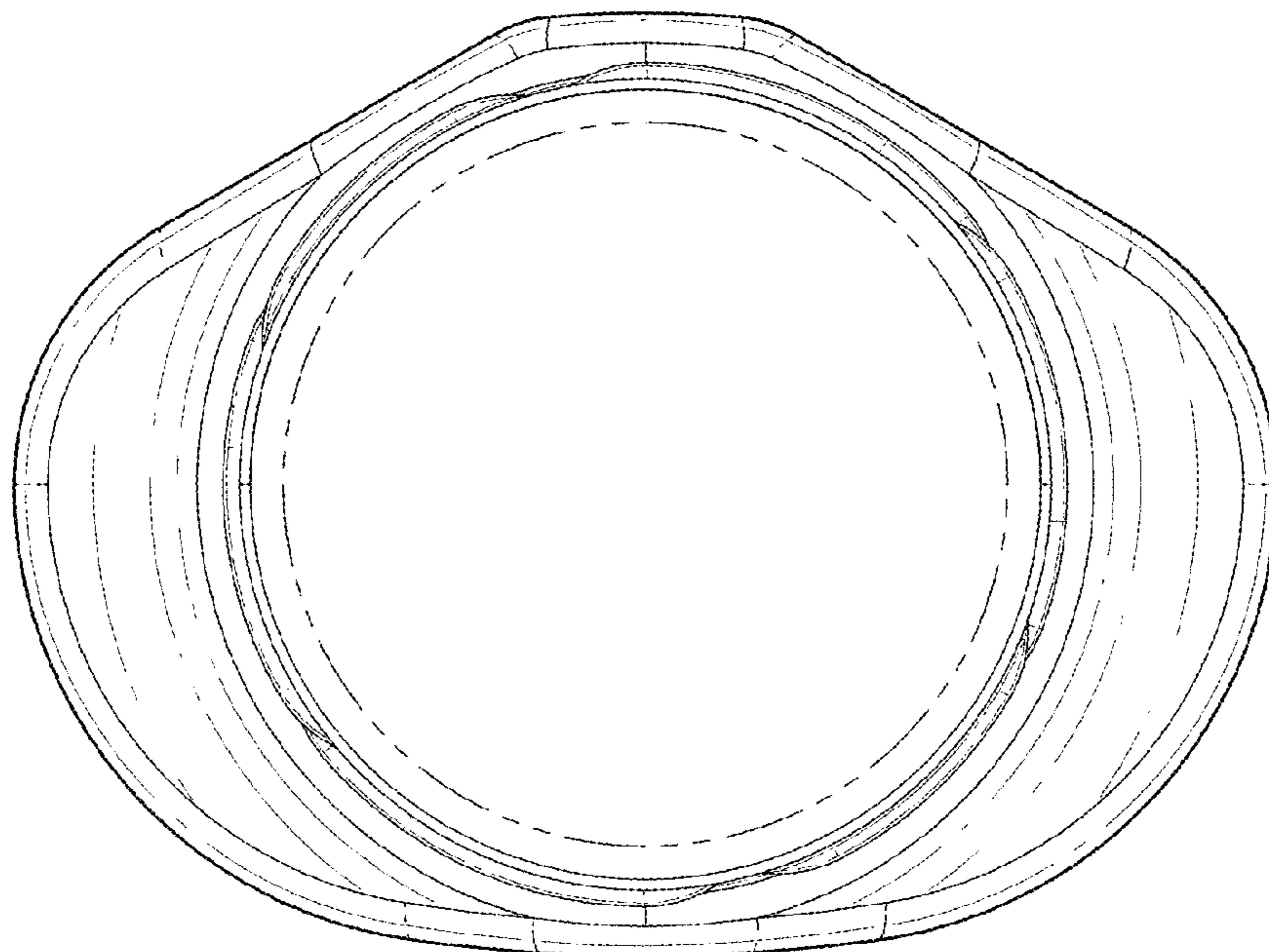

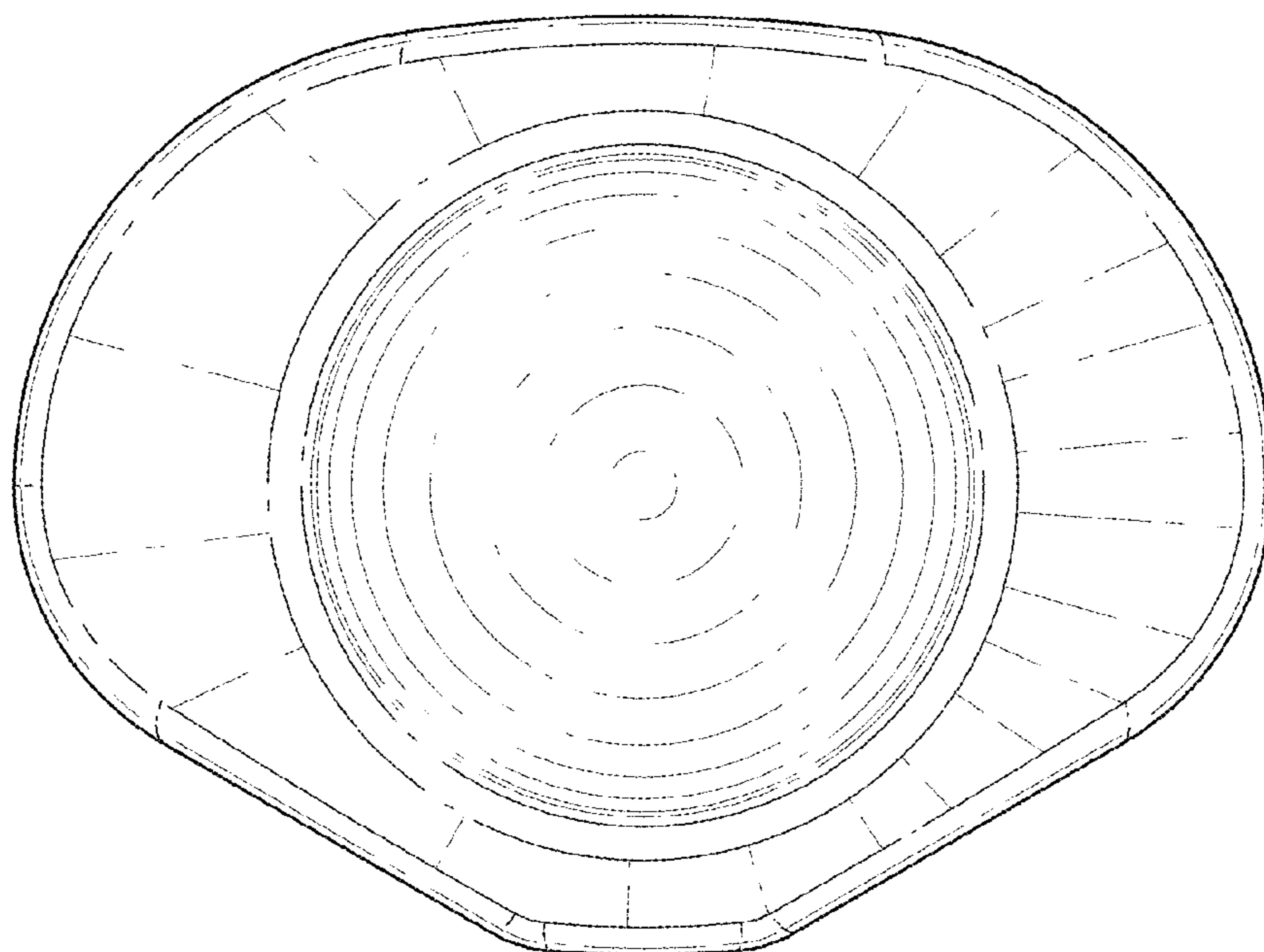
