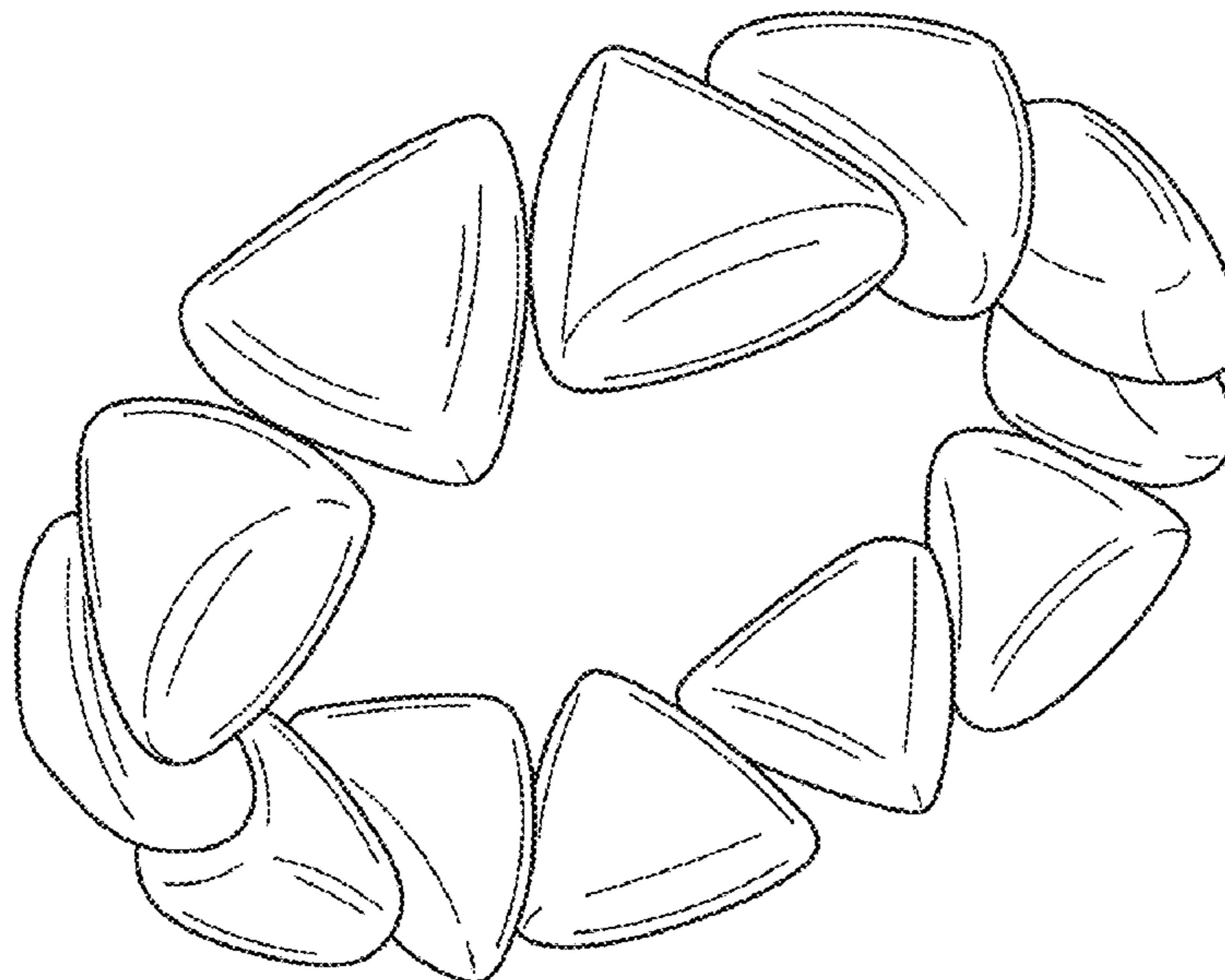

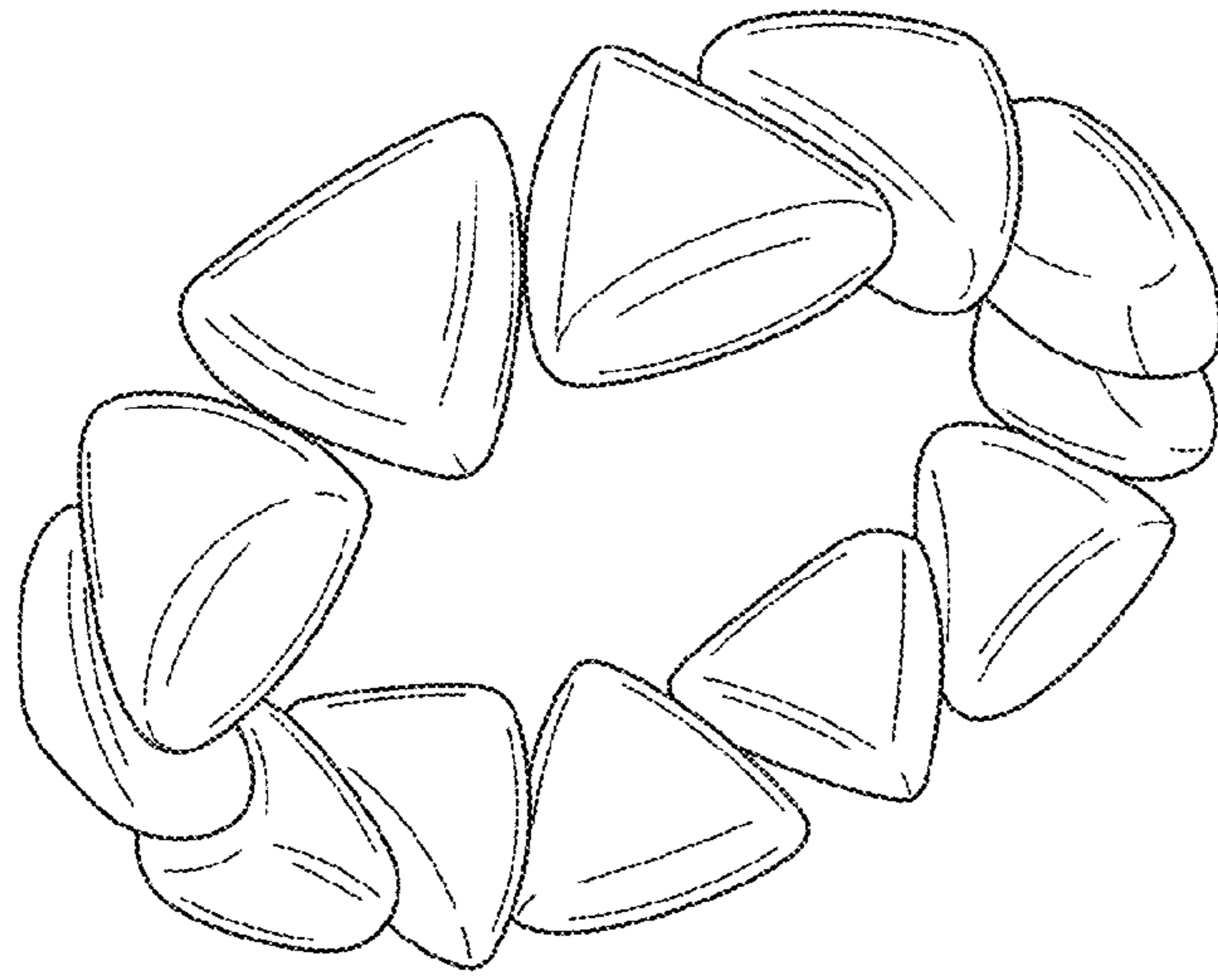
The ornamental design for a bracelet, as shown and described.

**DESCRIPTION**

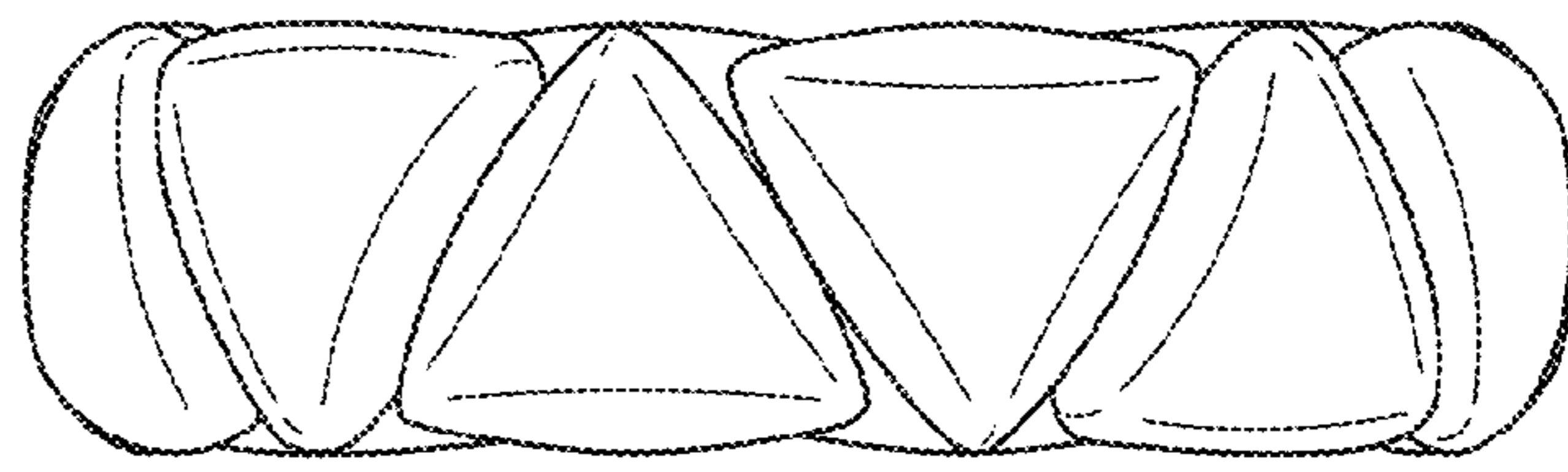

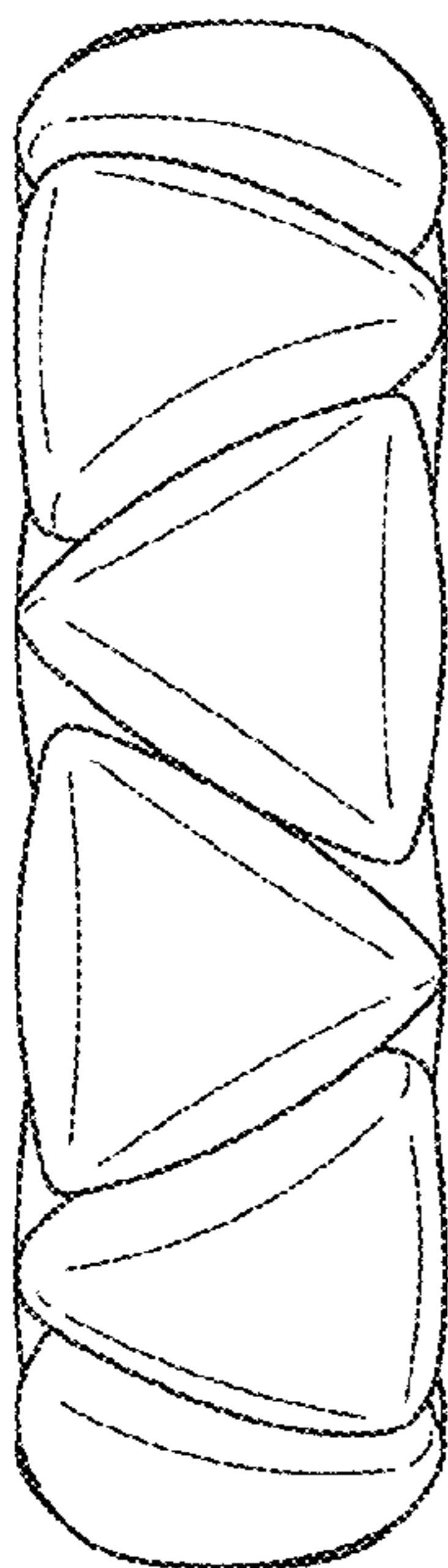




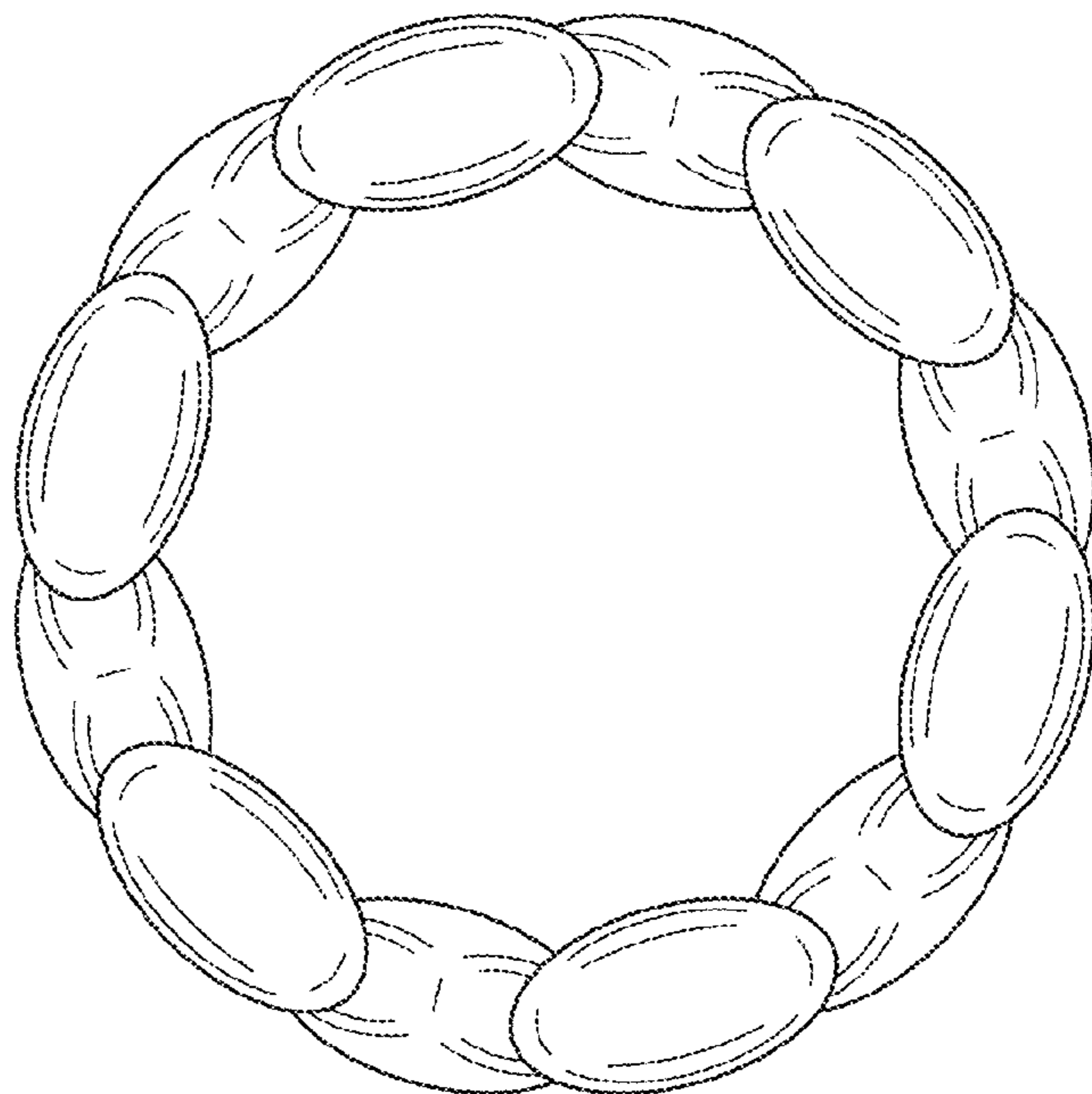

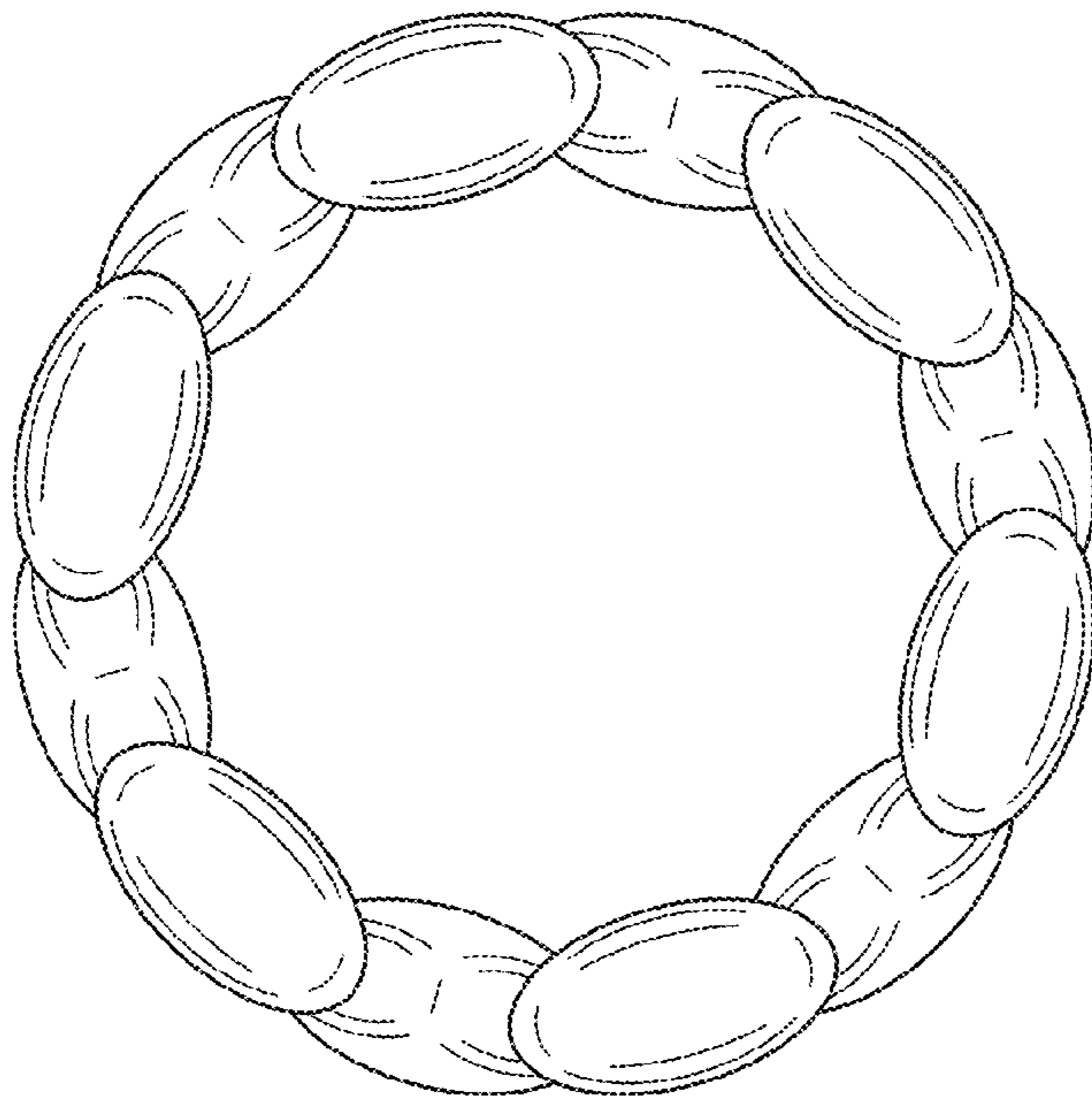

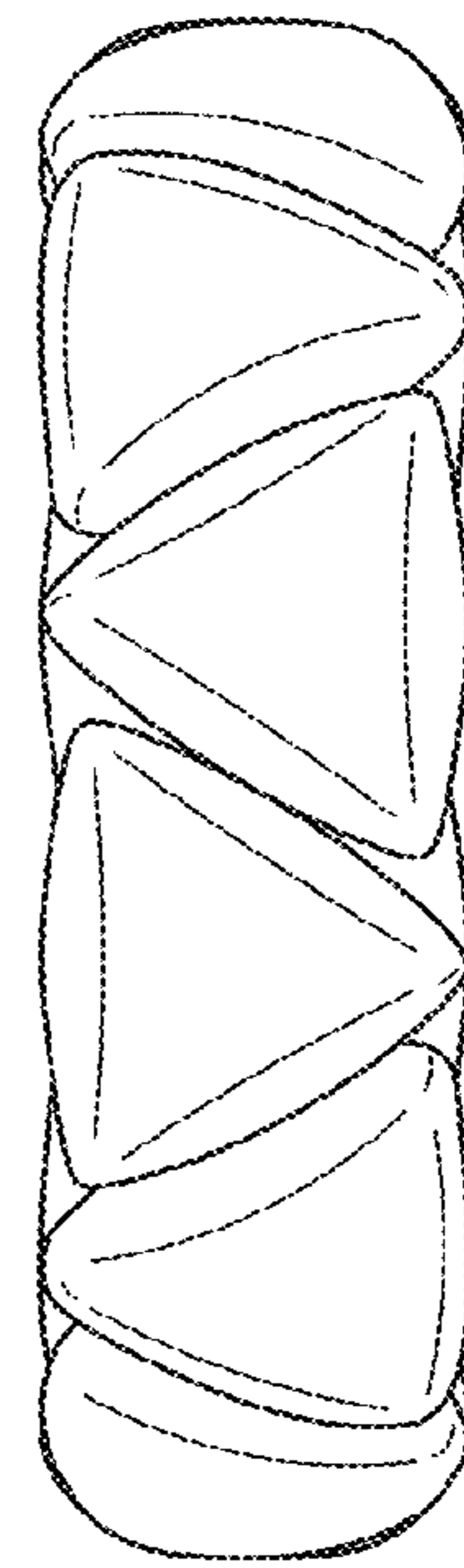

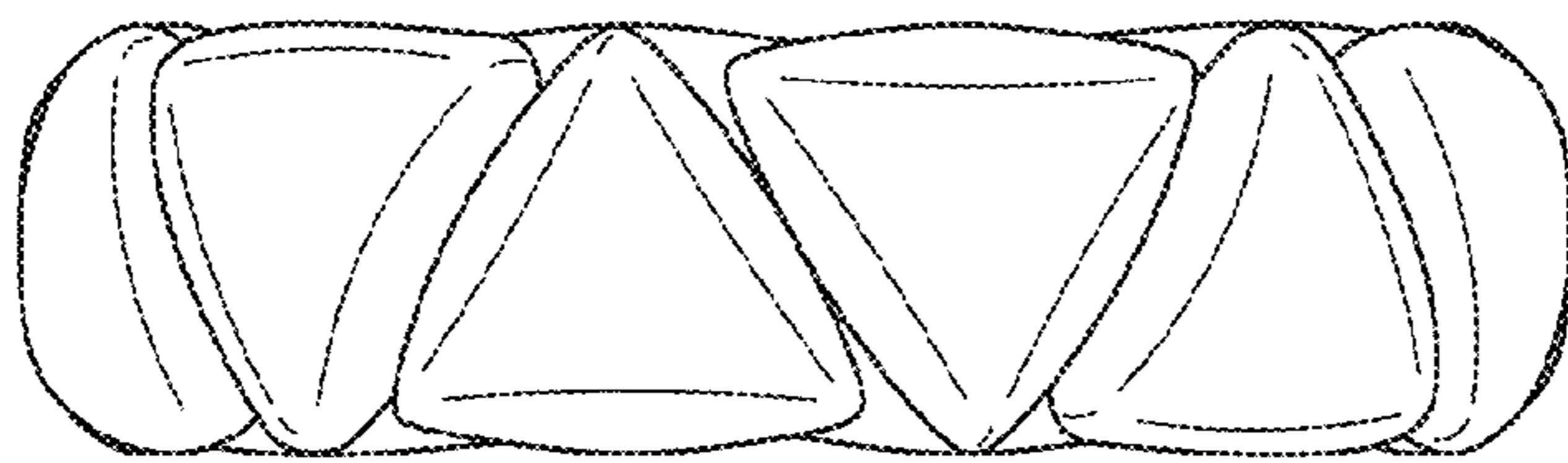
