in water showing my design.

FIG. 2 is a side elevation view thereof;

FIG. 3 is an opposite side elevation view thereof;

FIG. 4 is a top plan view thereof; and

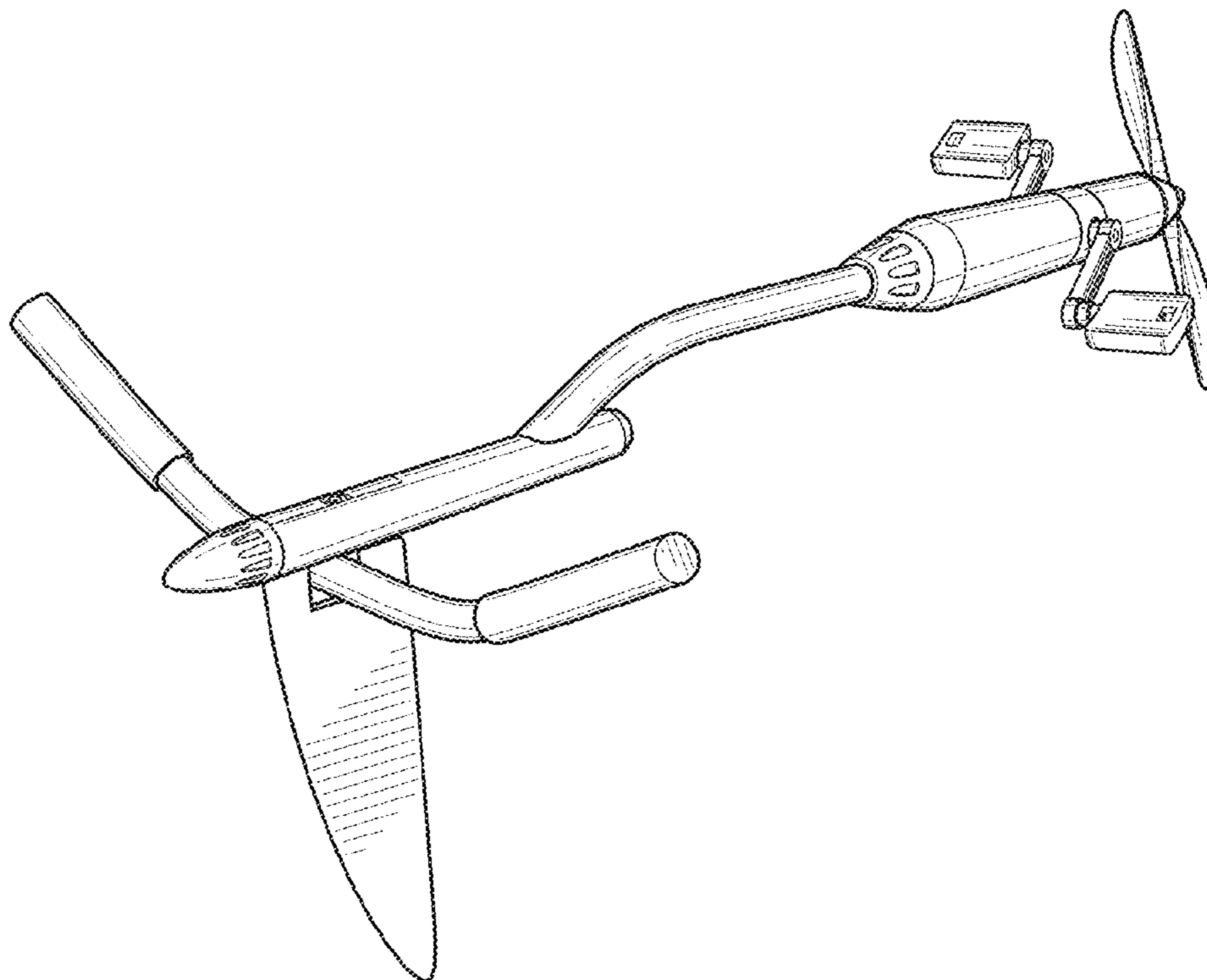
FIG. 5 is a bottom plan view thereof

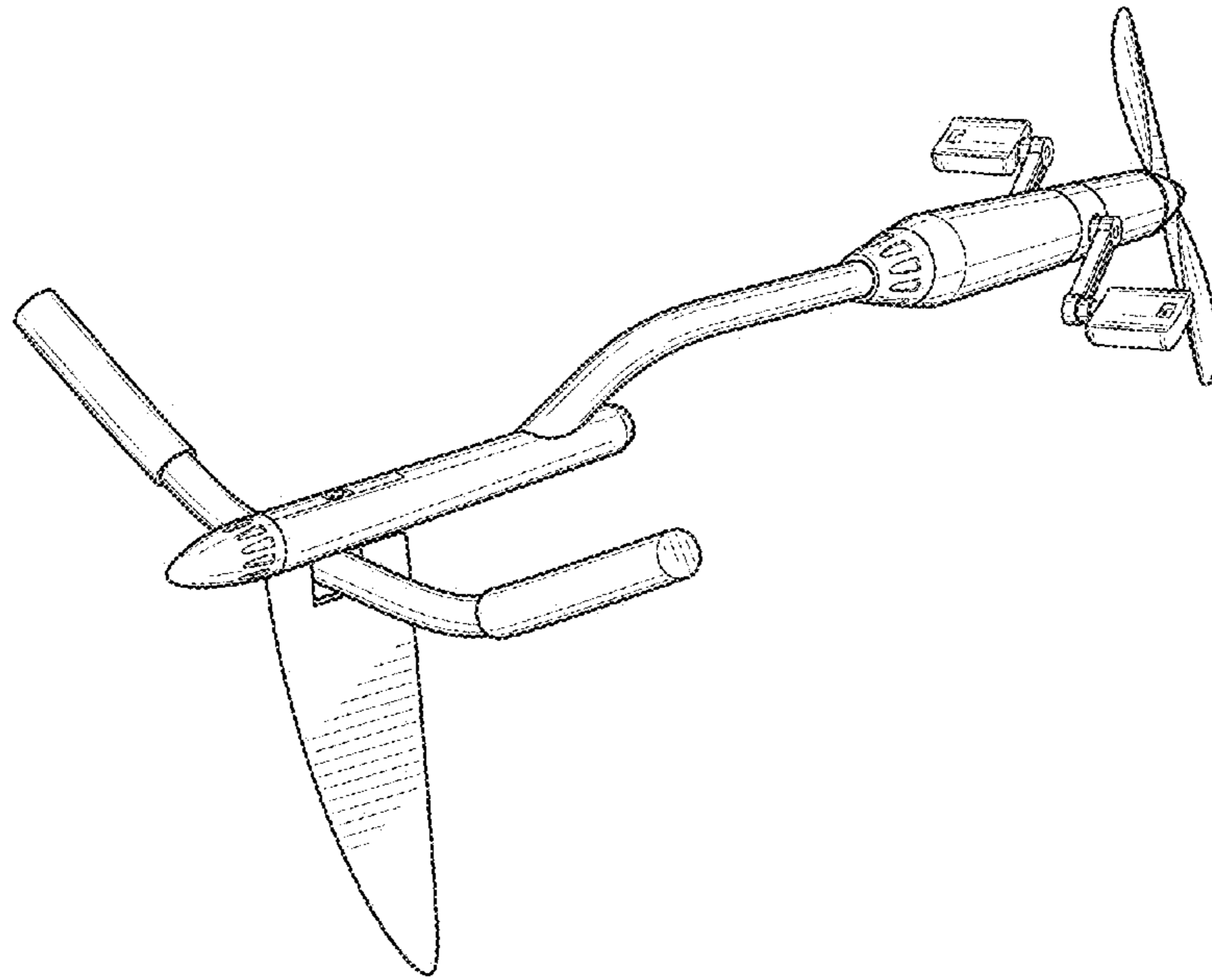

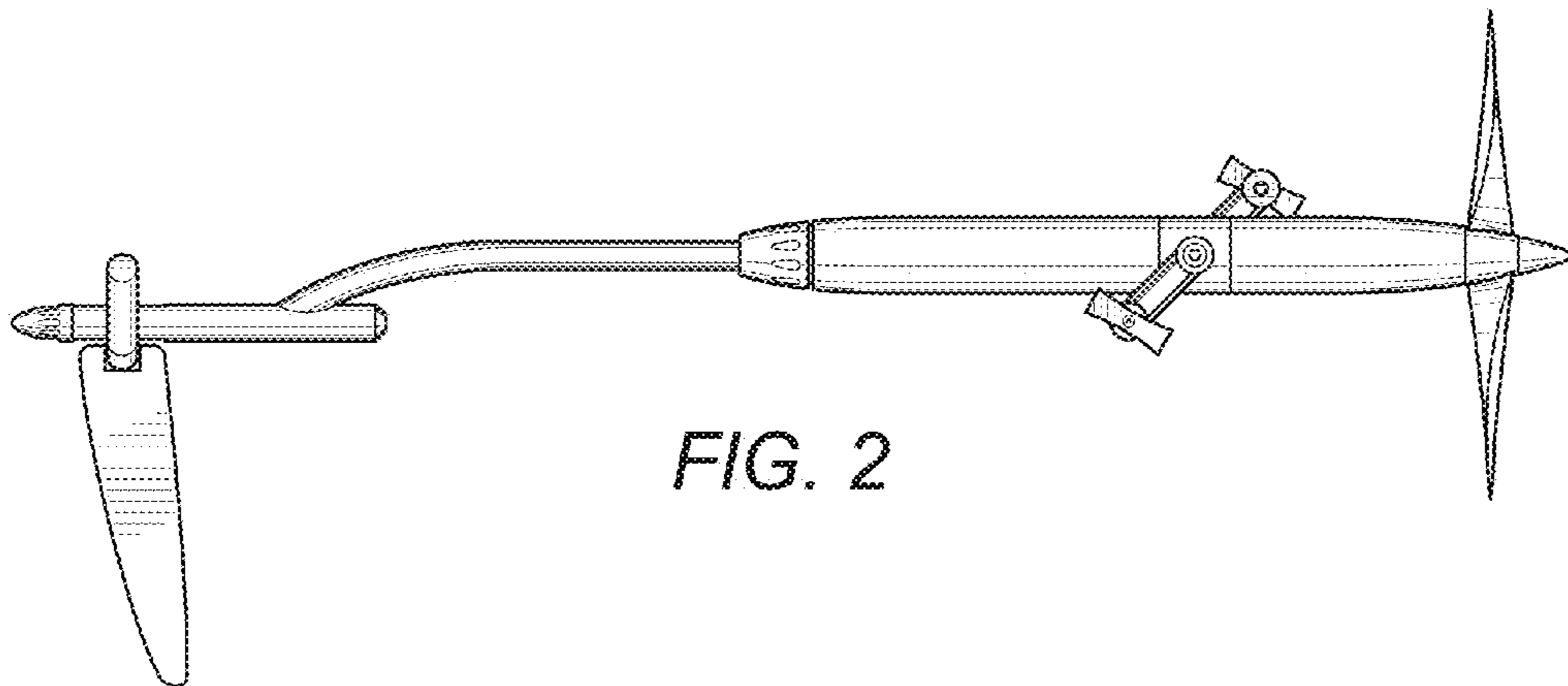

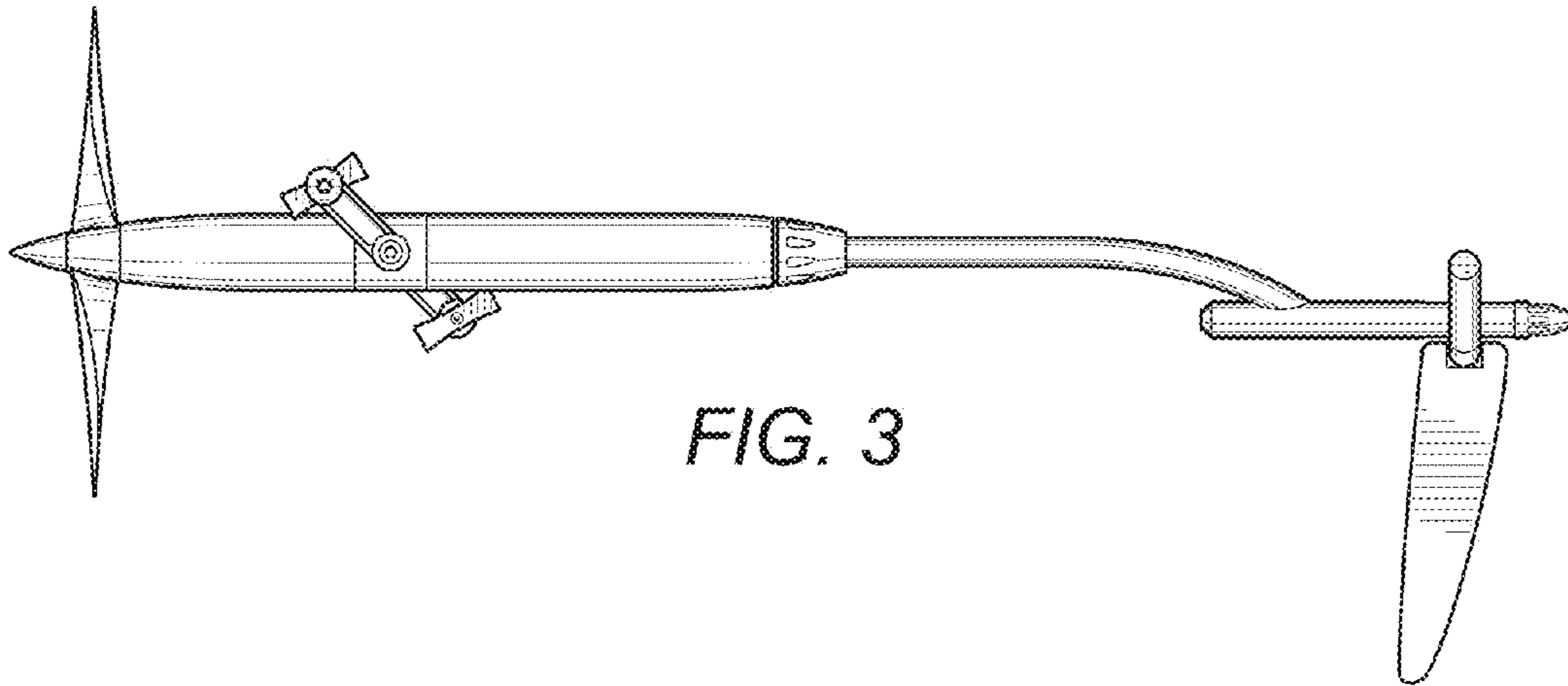

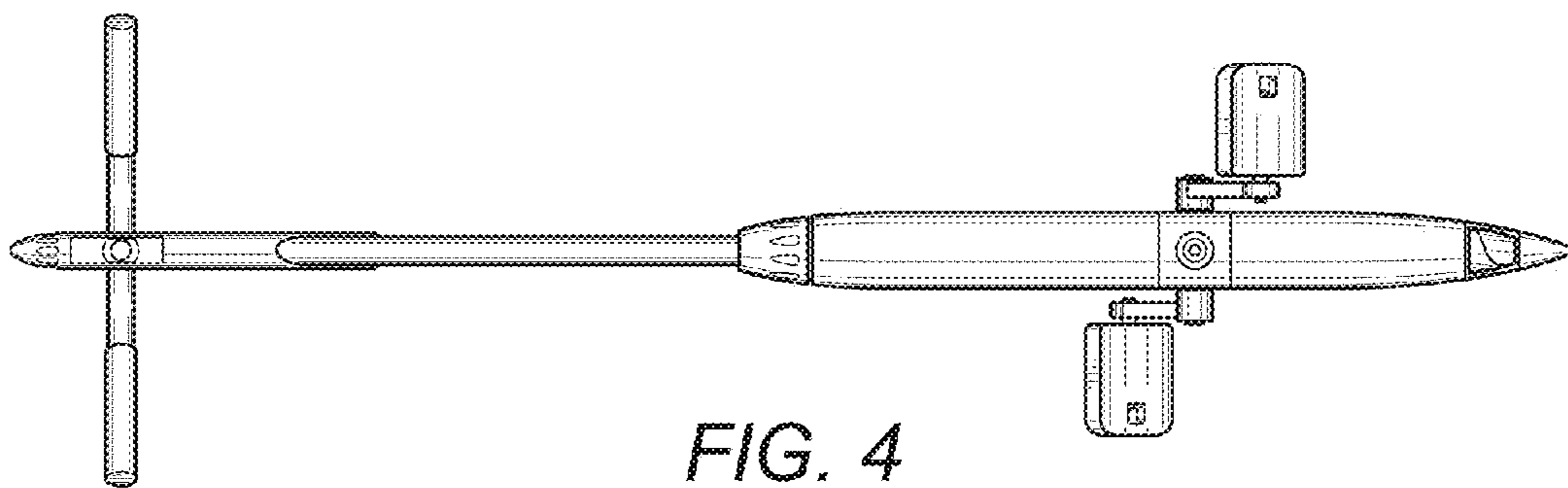

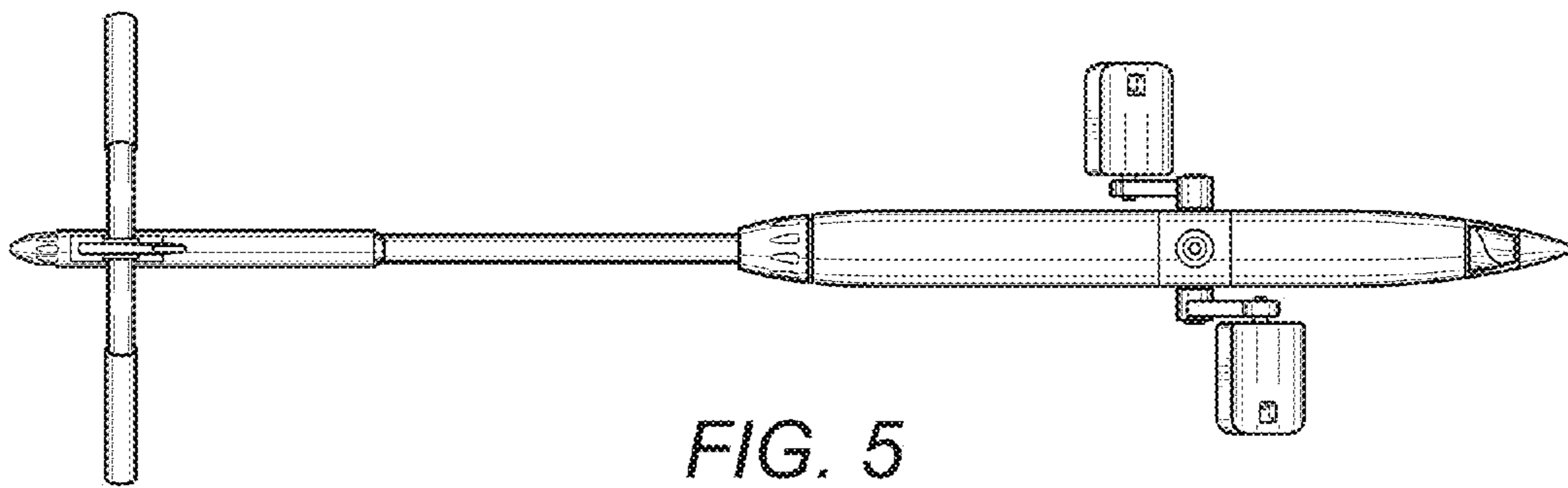

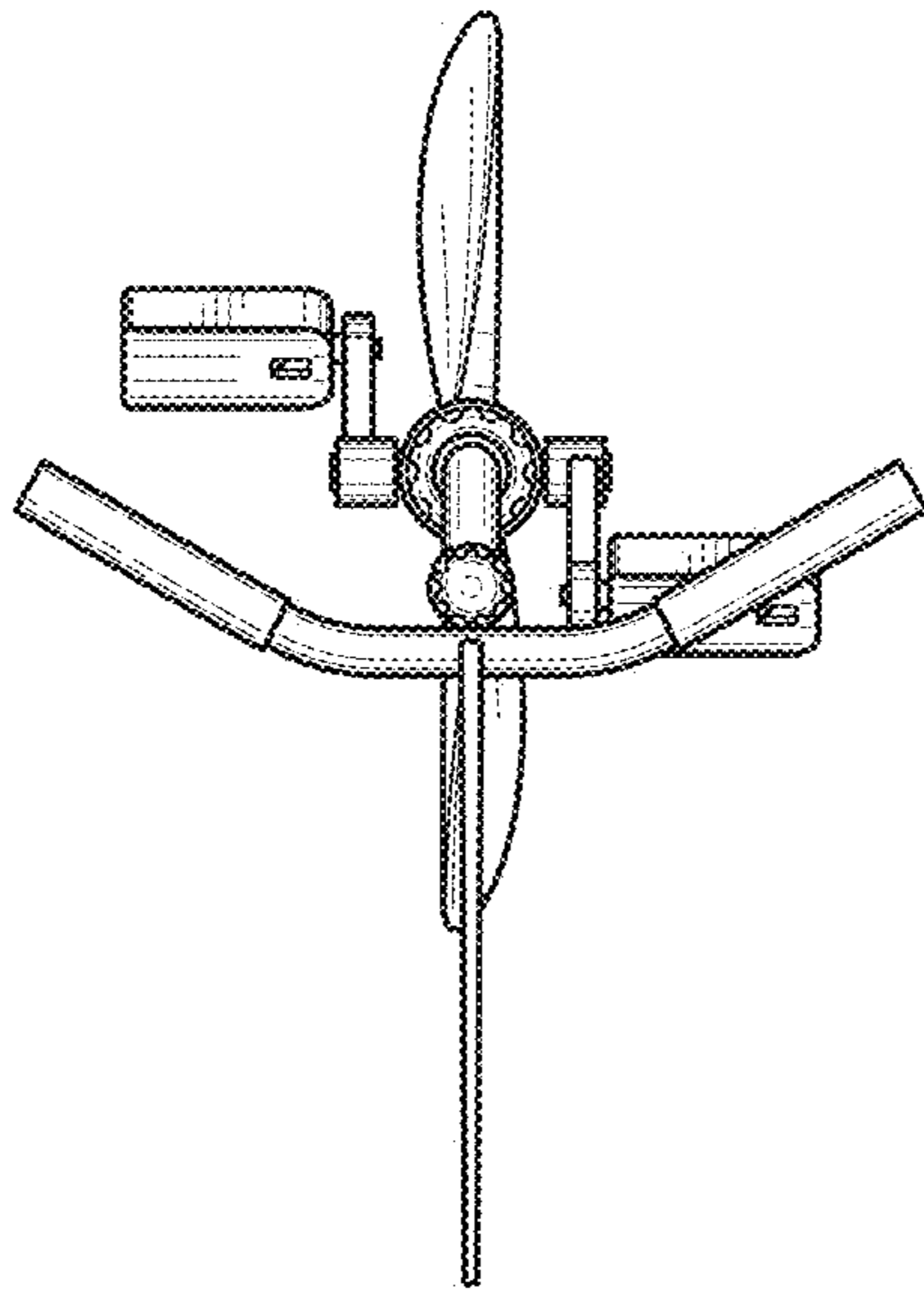

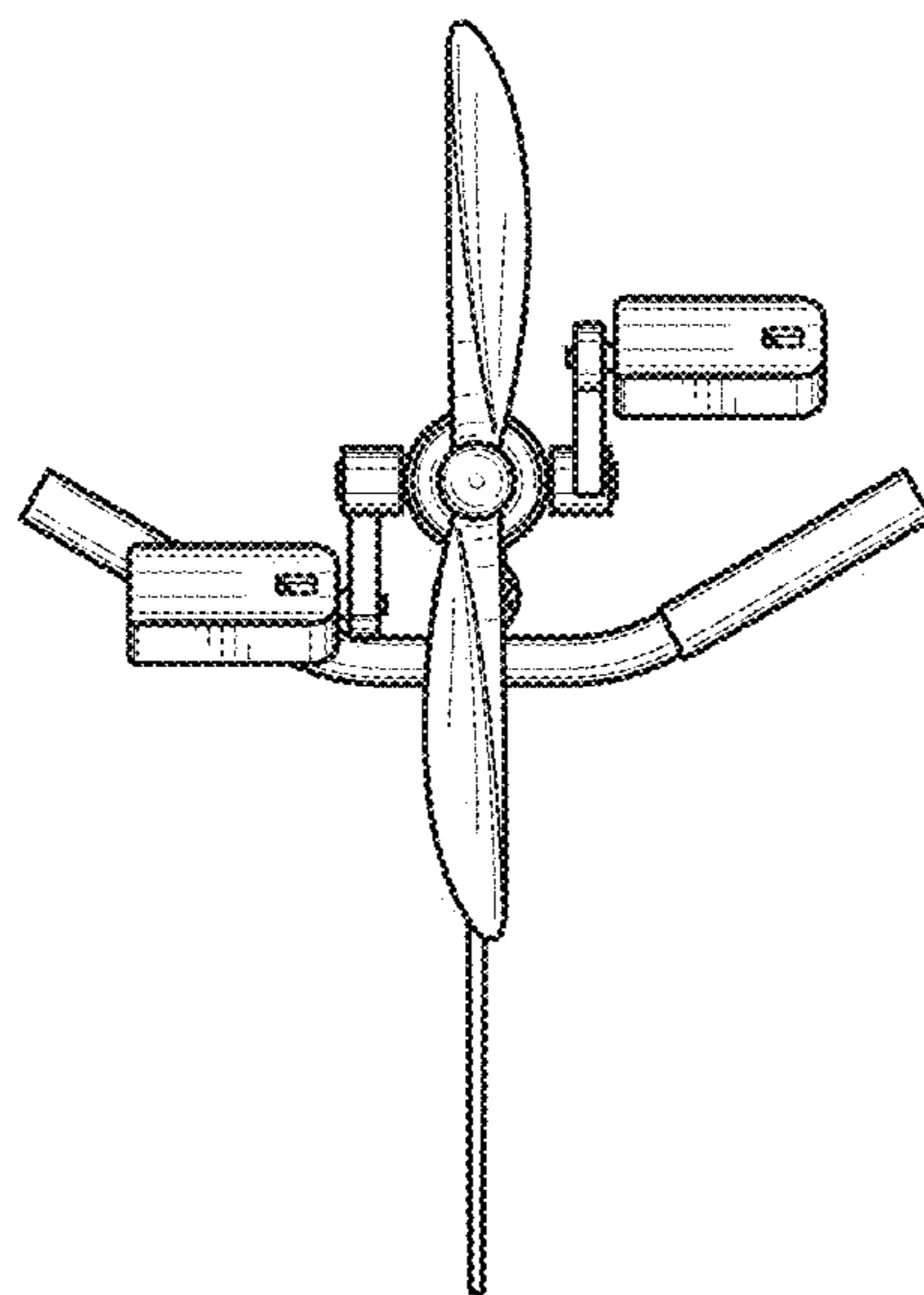
