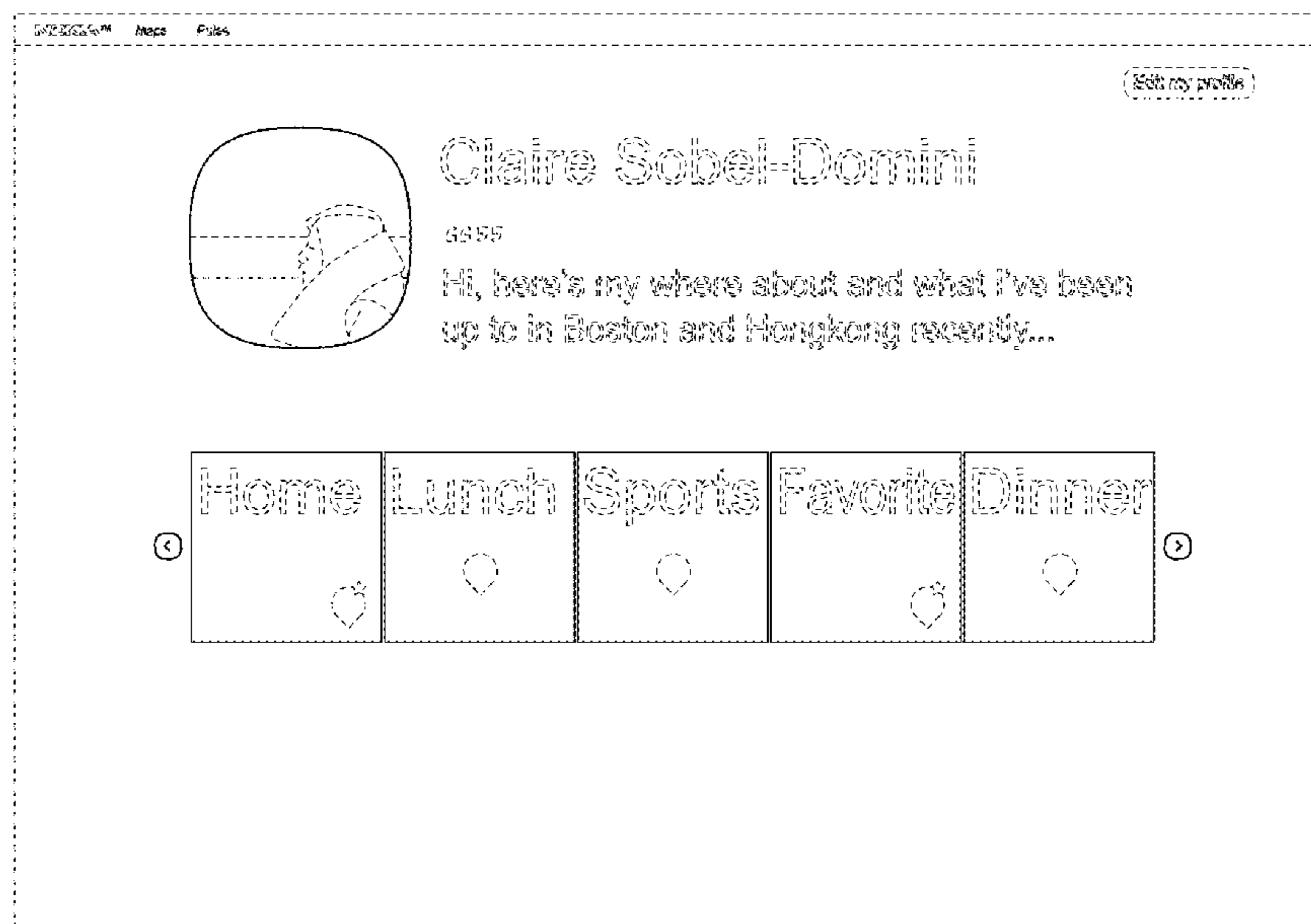
The ornamental design for a display screen with graphical user interface, as shown and described.

The FIGURE is a front view of a display screen with graphical user interface showing my new design.

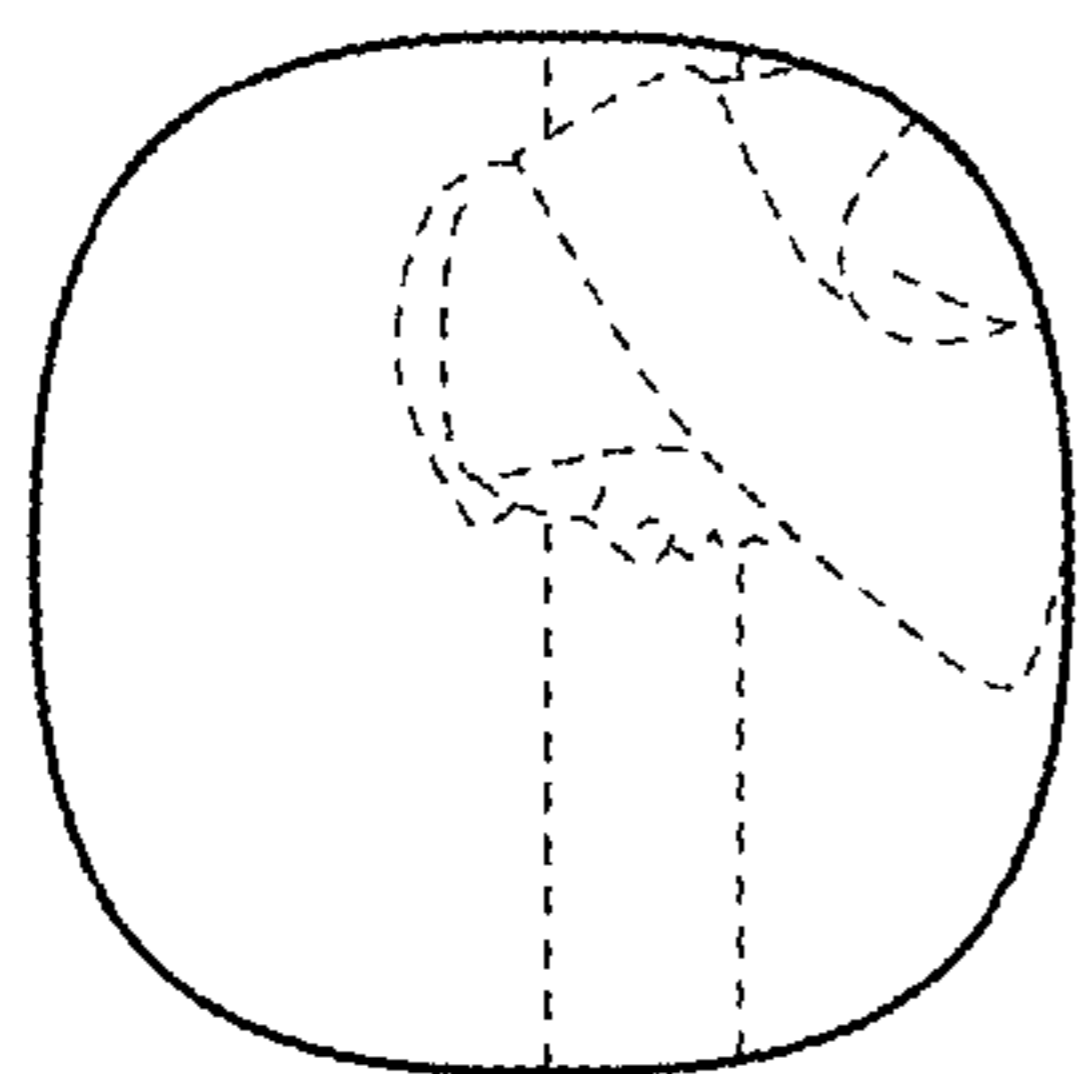
The broken lines in the FIGURE represent portions of the display screen with graphical user interface that form no part of the claimed design.
