FIG. 1 is a front view of the display screen or portion thereof with icon showing our new design in a first environment.

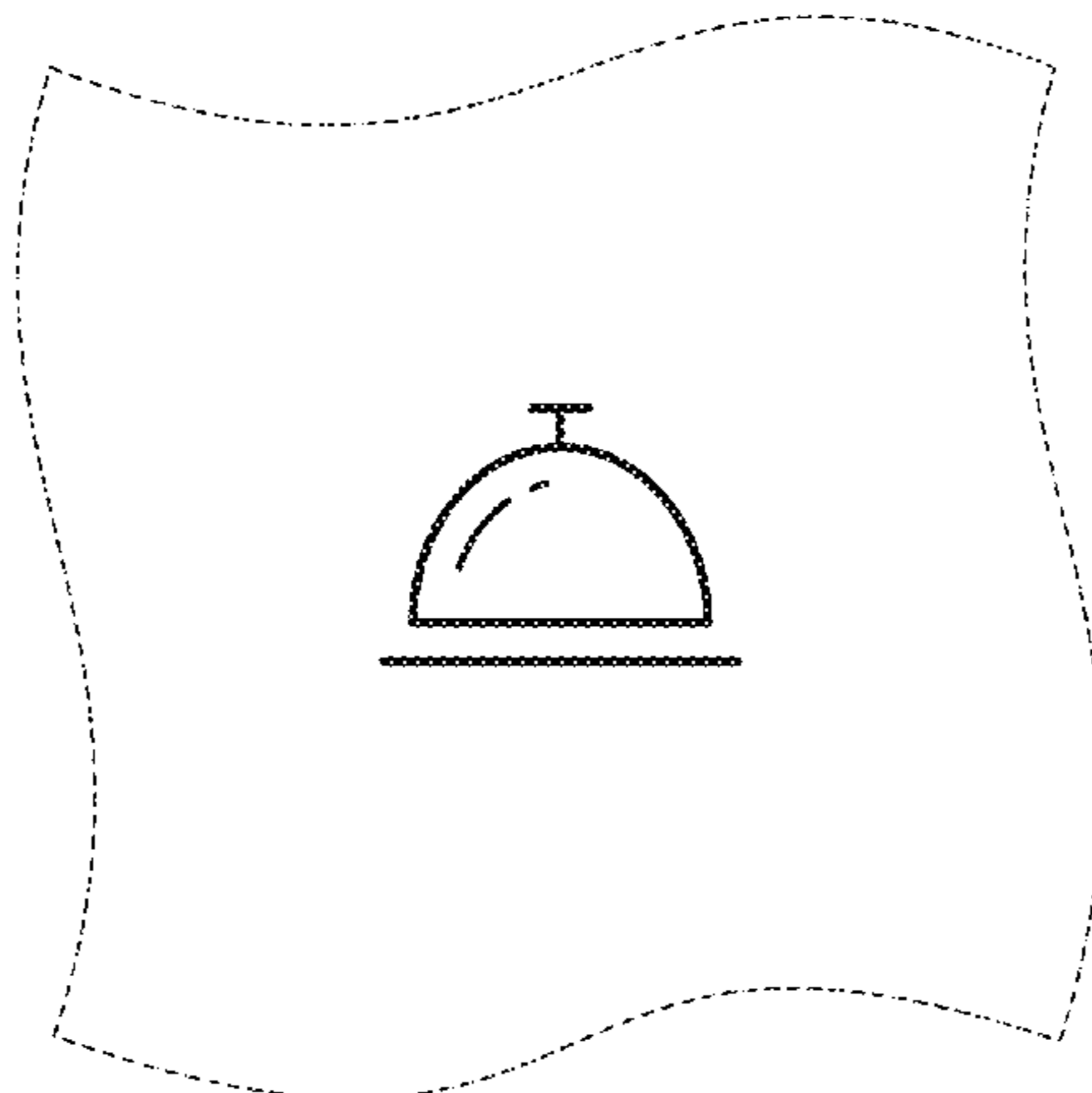
FIG. 2 depicts the interaction of the display screen or portion thereof with icon in the first environment with additional environmental elements.

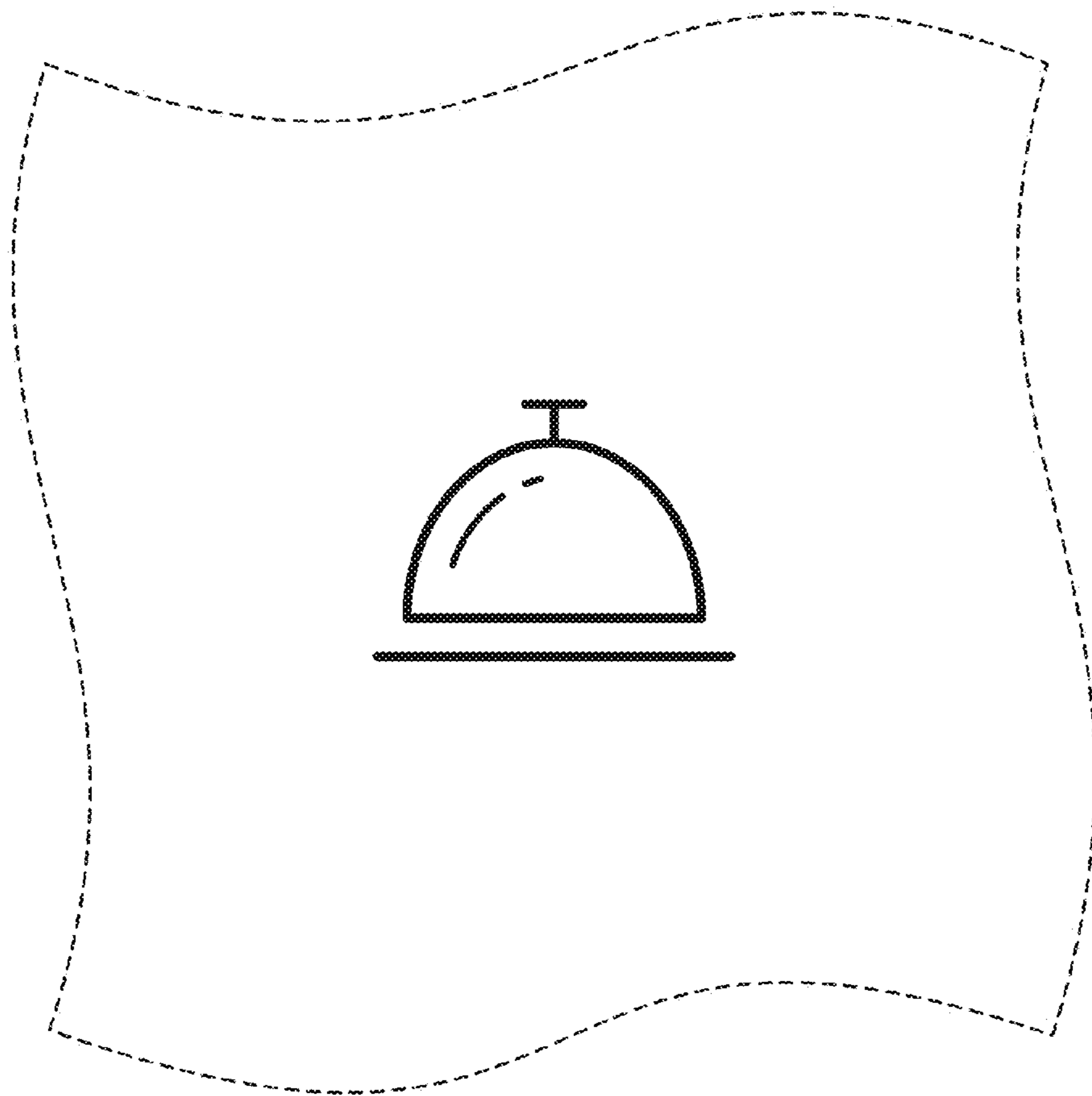

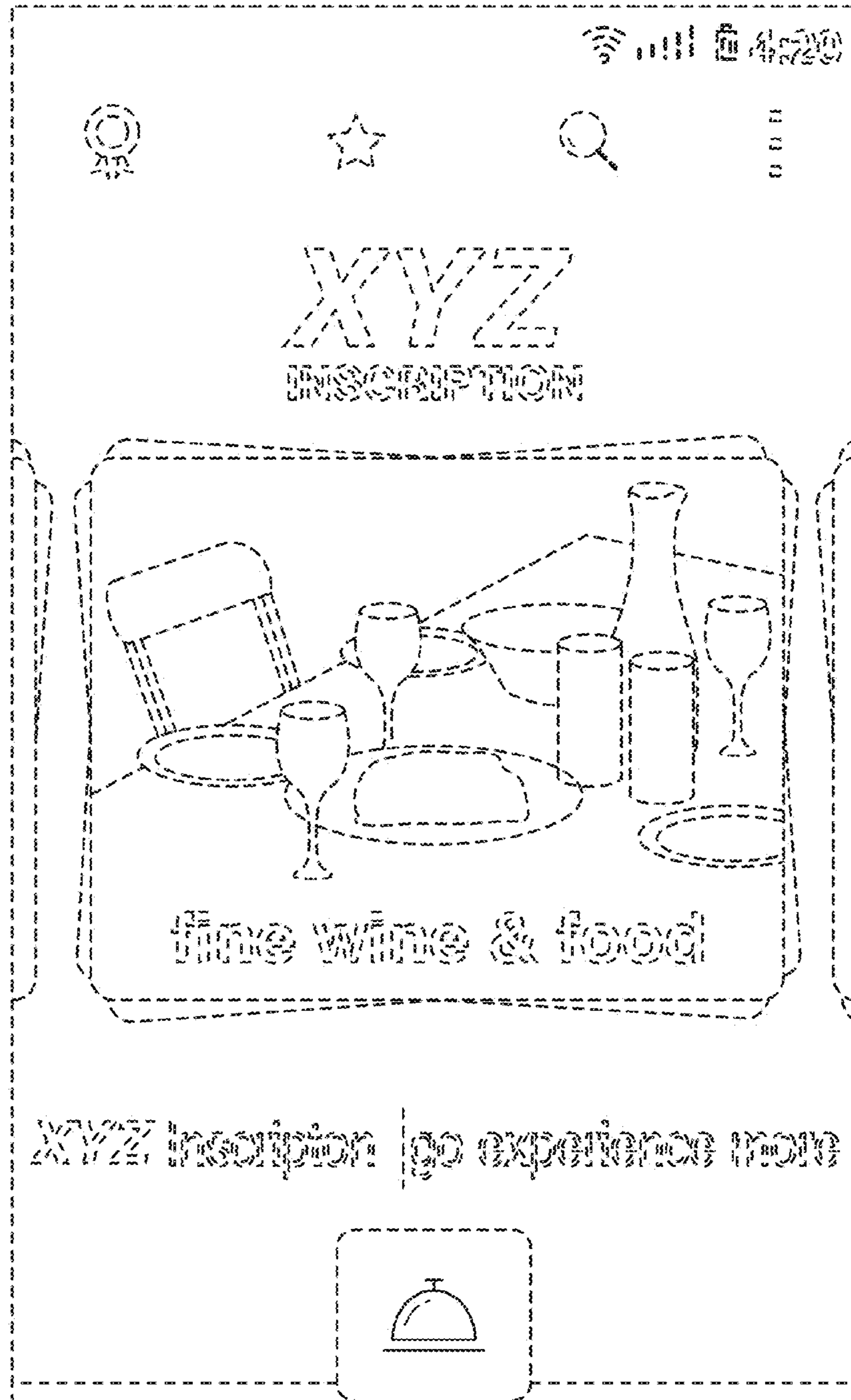

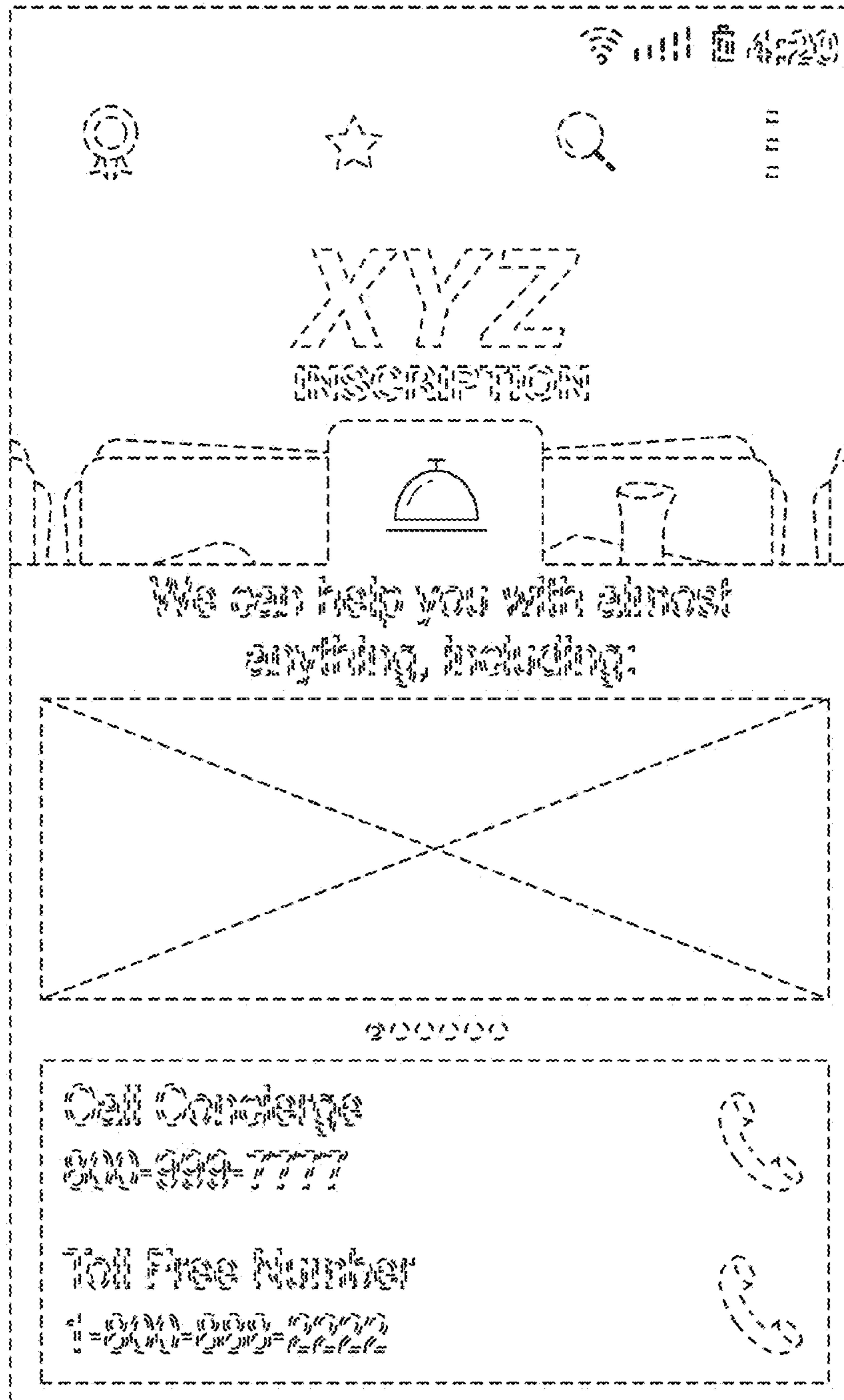

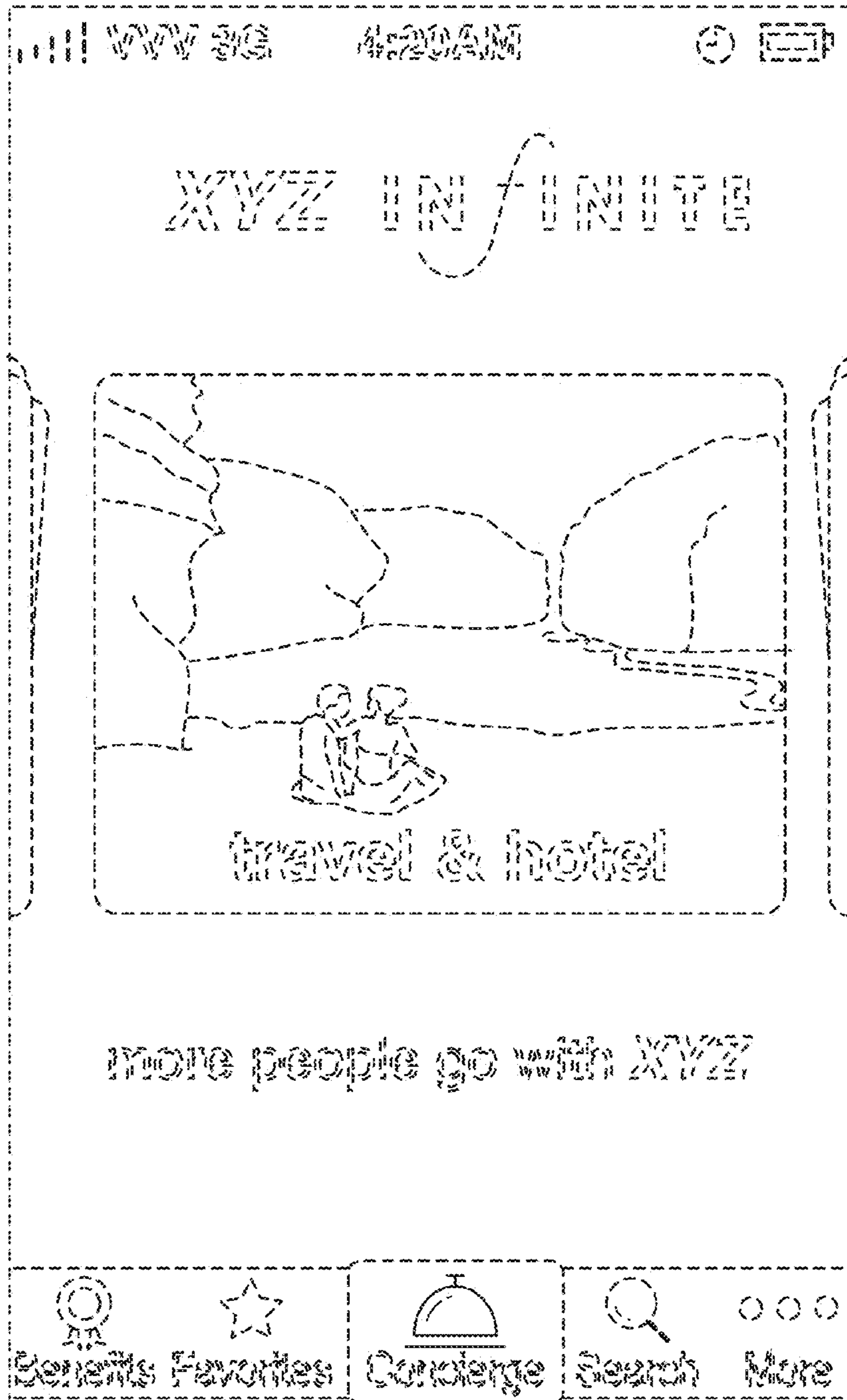
