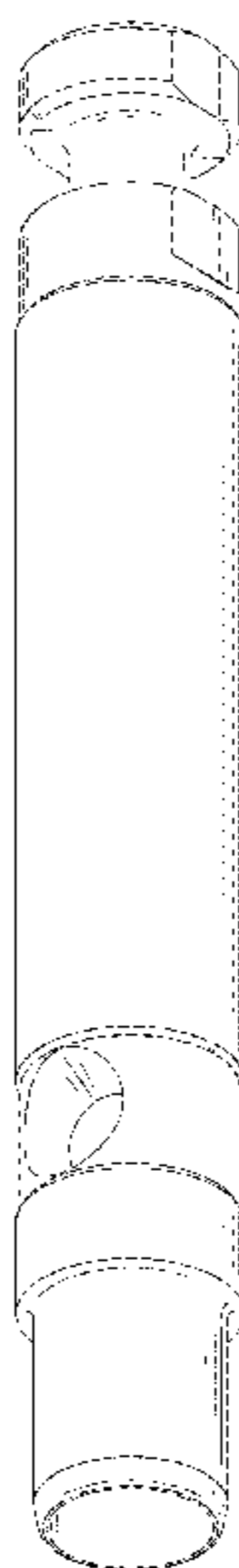

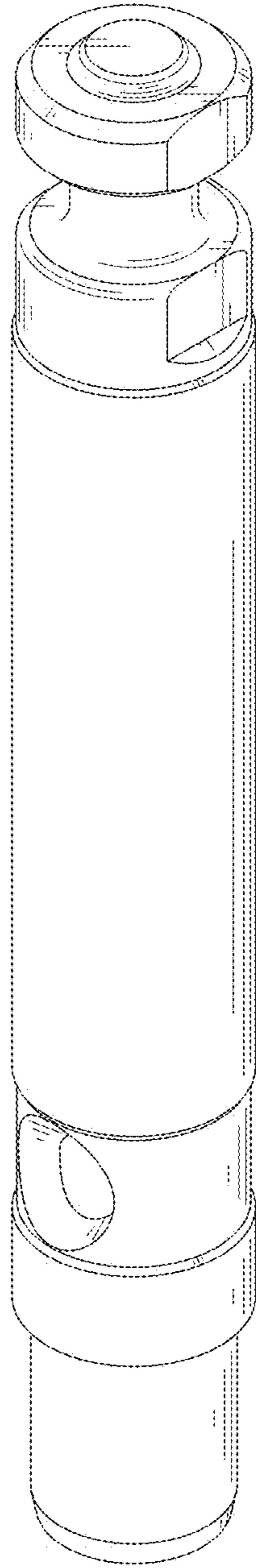
The ornamental design for a pump rod, as shown and

**DESCRIPTION**

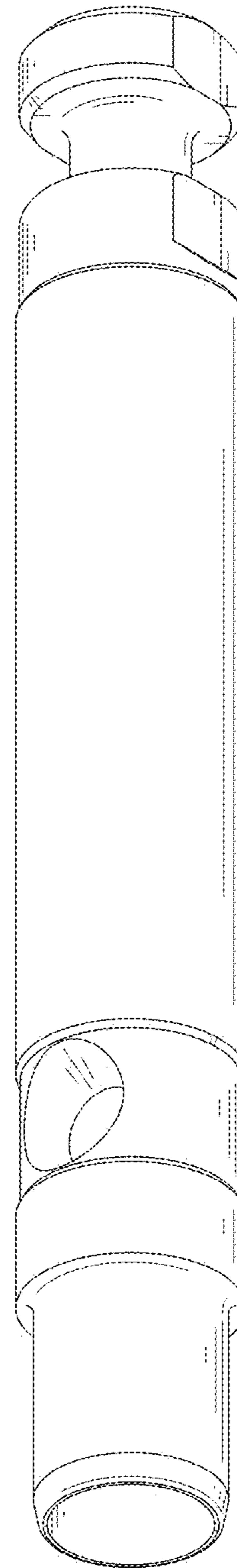
FIG. 1 is a front right isometric view from the top of a pump

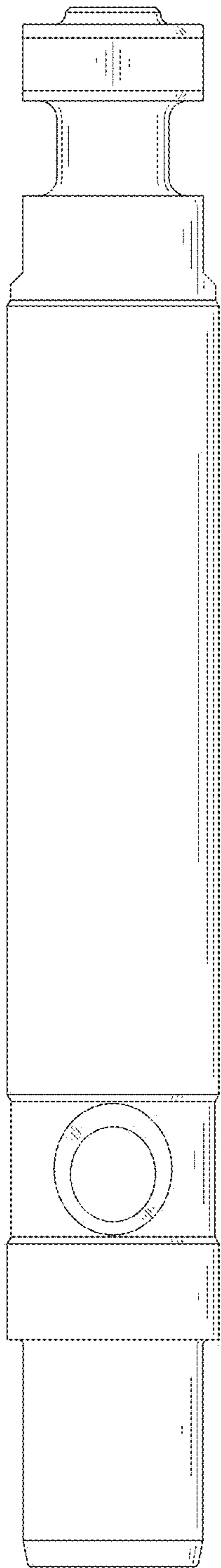




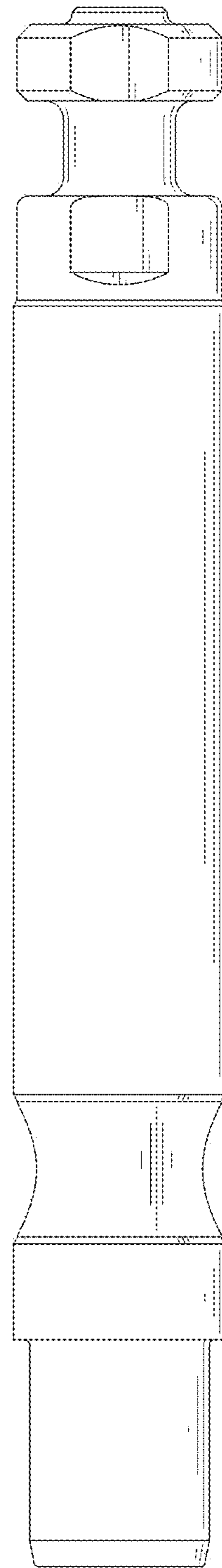

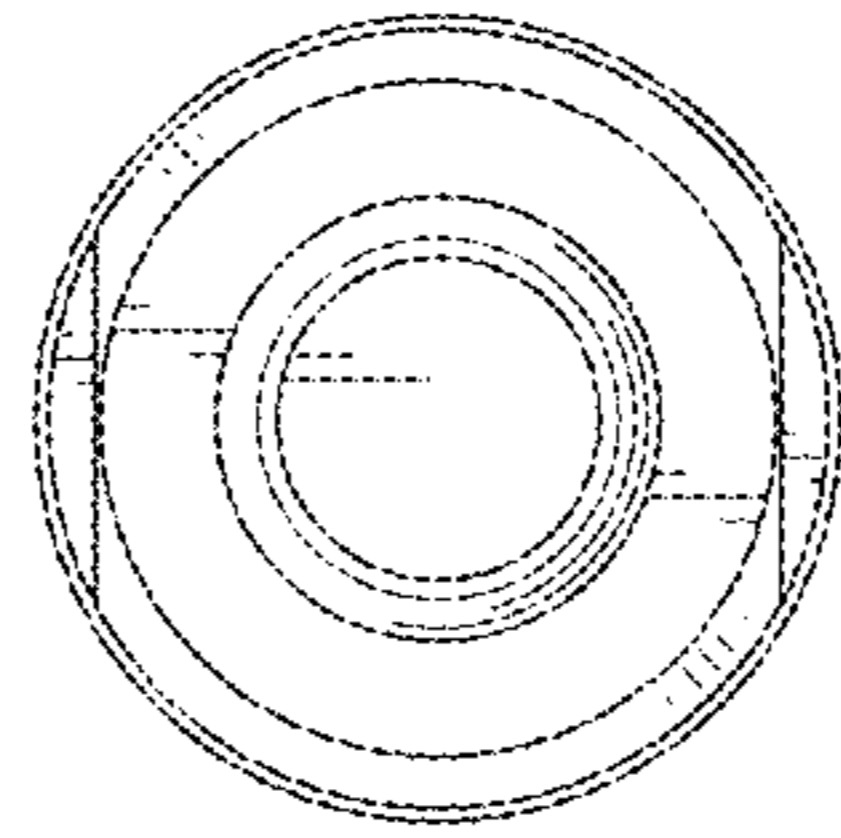

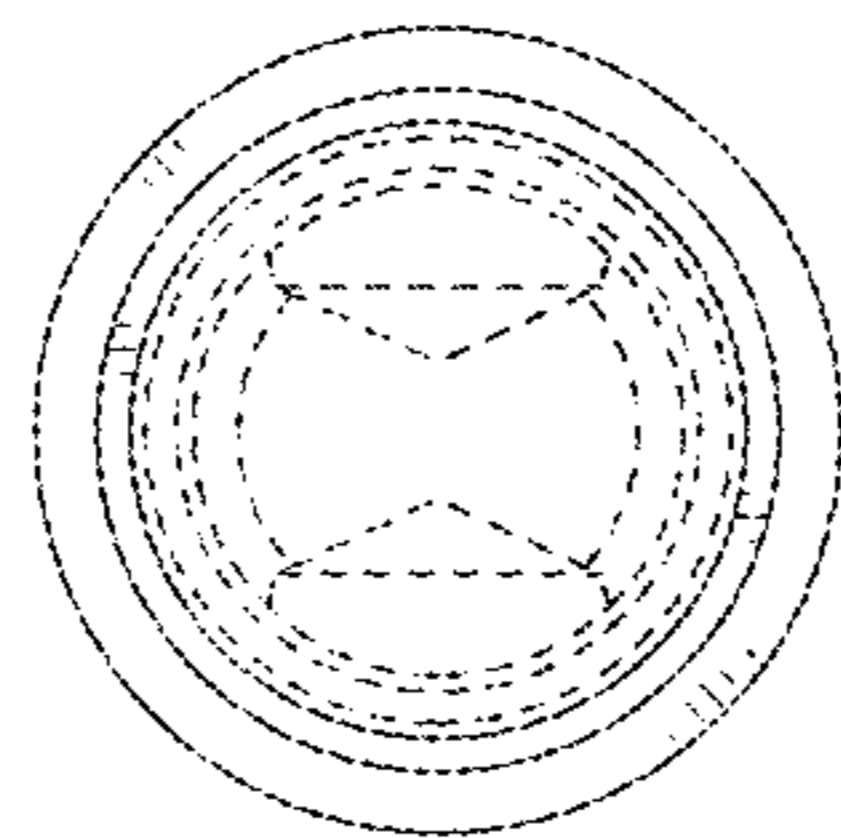
