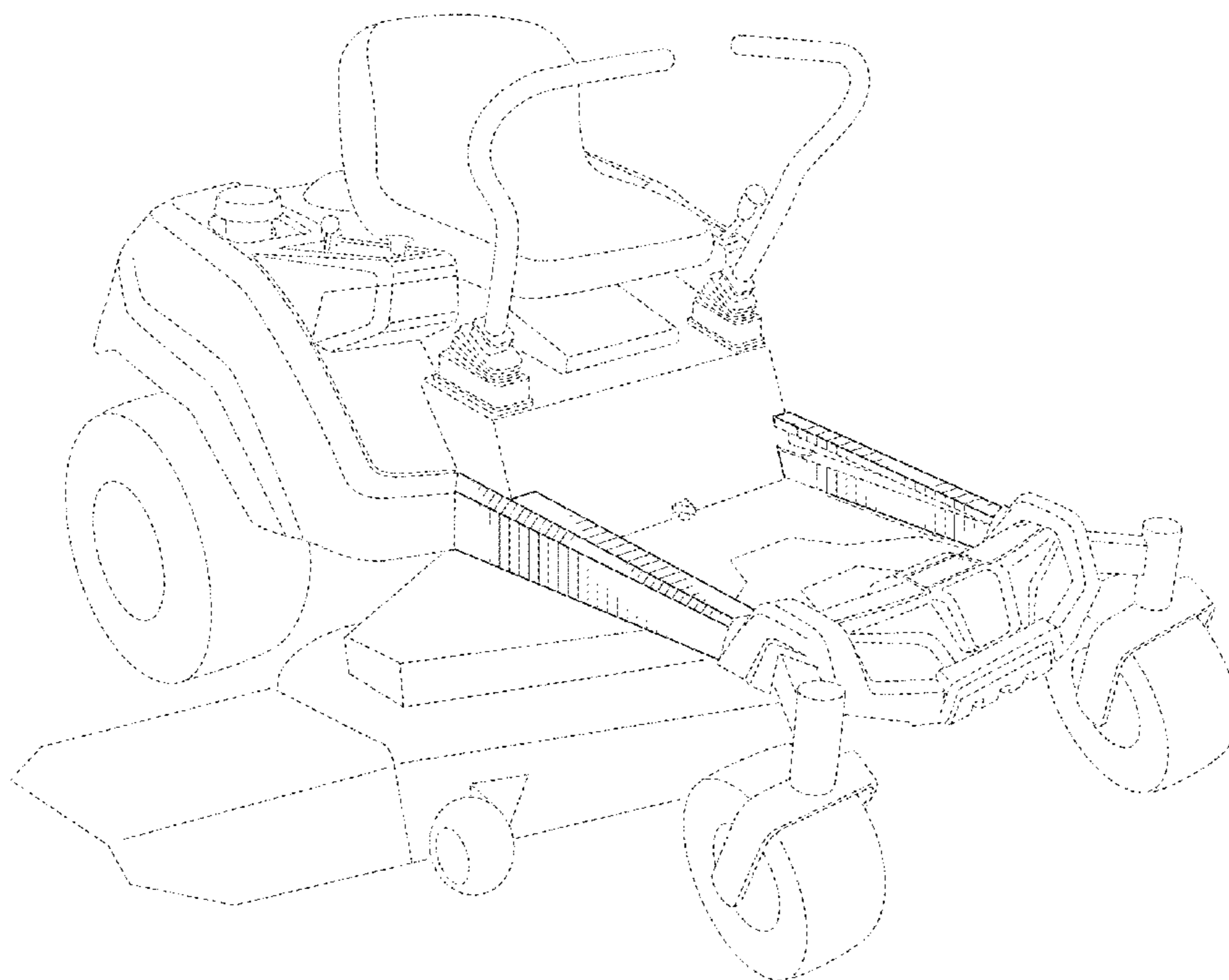
(57) **CLAIM**

The ornamental design for a side tapered panel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a side tapered panel showing our new design in use condition mounted to a lawn mower; FIG. 2 is a right side view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; and, FIG. 6 is a top plan view thereof. The broken lines of FIGS. 1-6 are illustrative of the visible environmental structure of the side tapered panel and form no part of the claimed design.

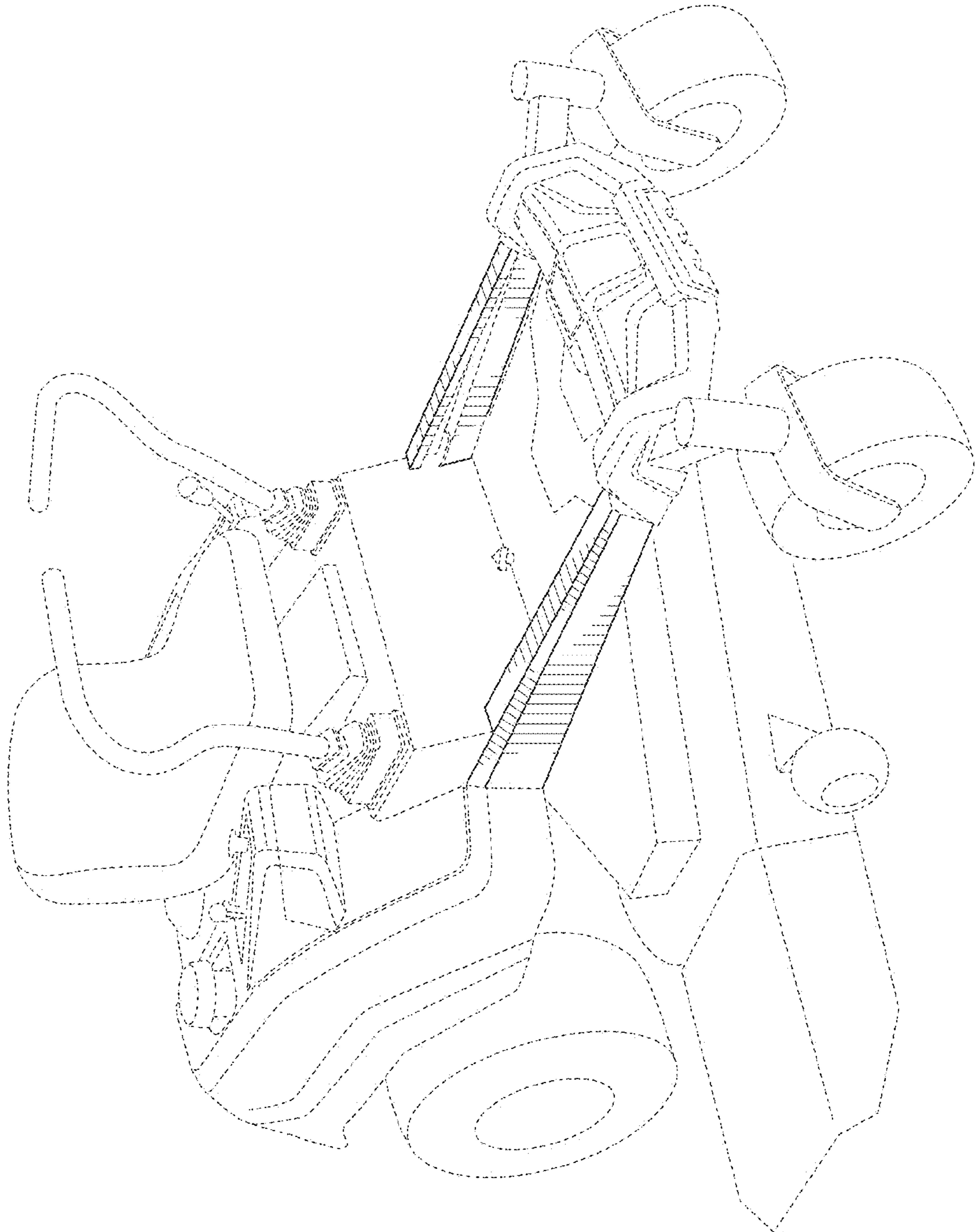

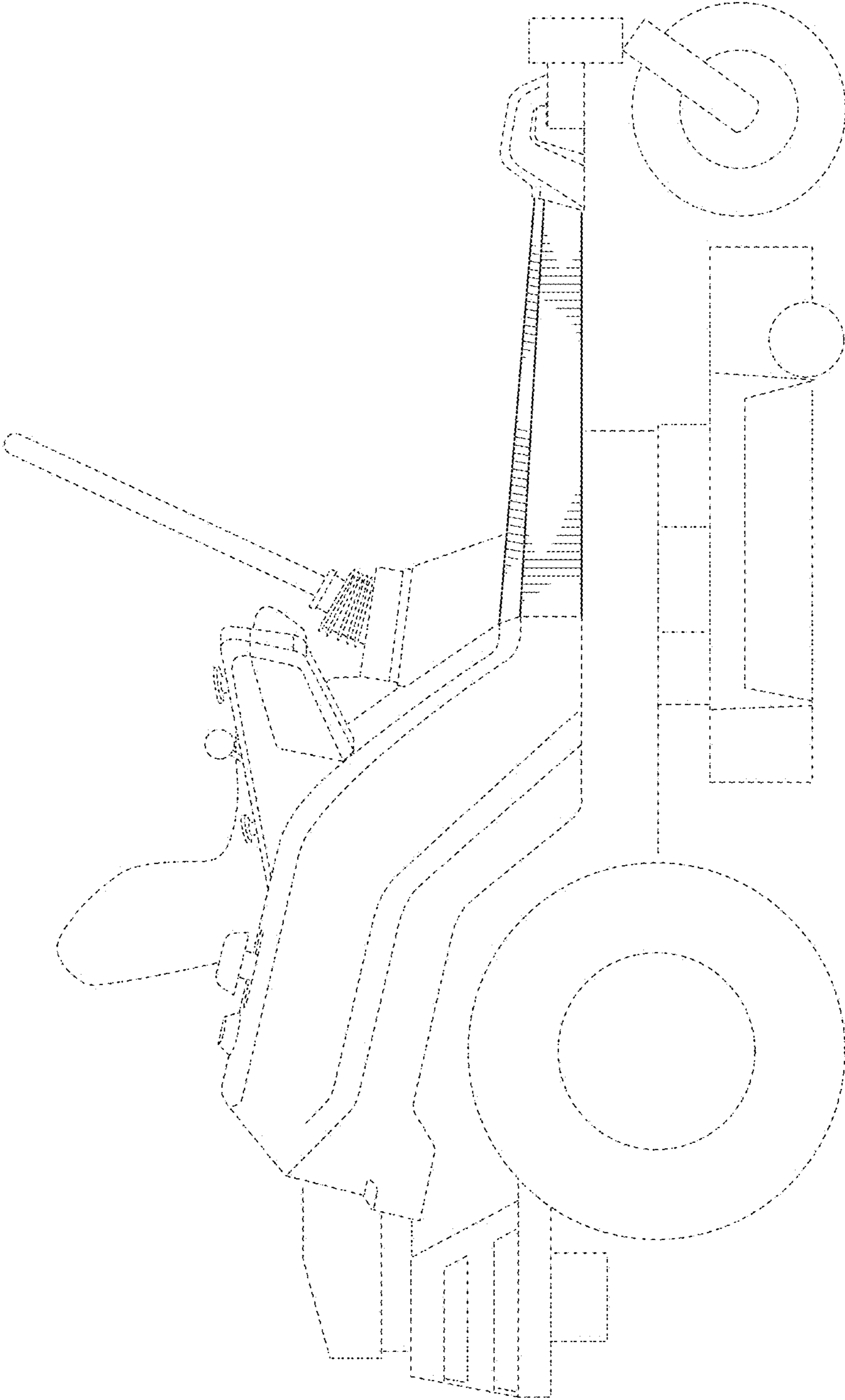

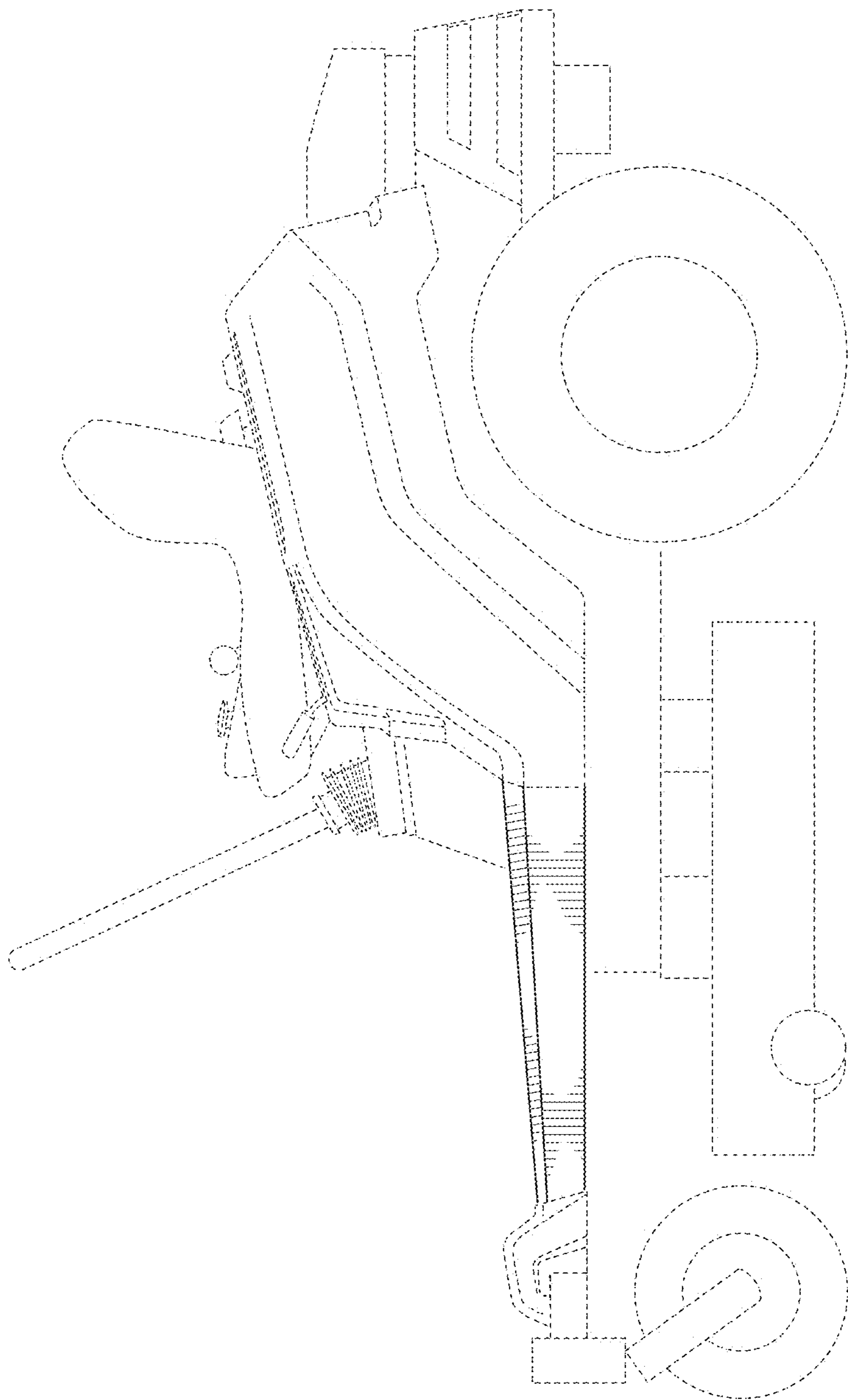

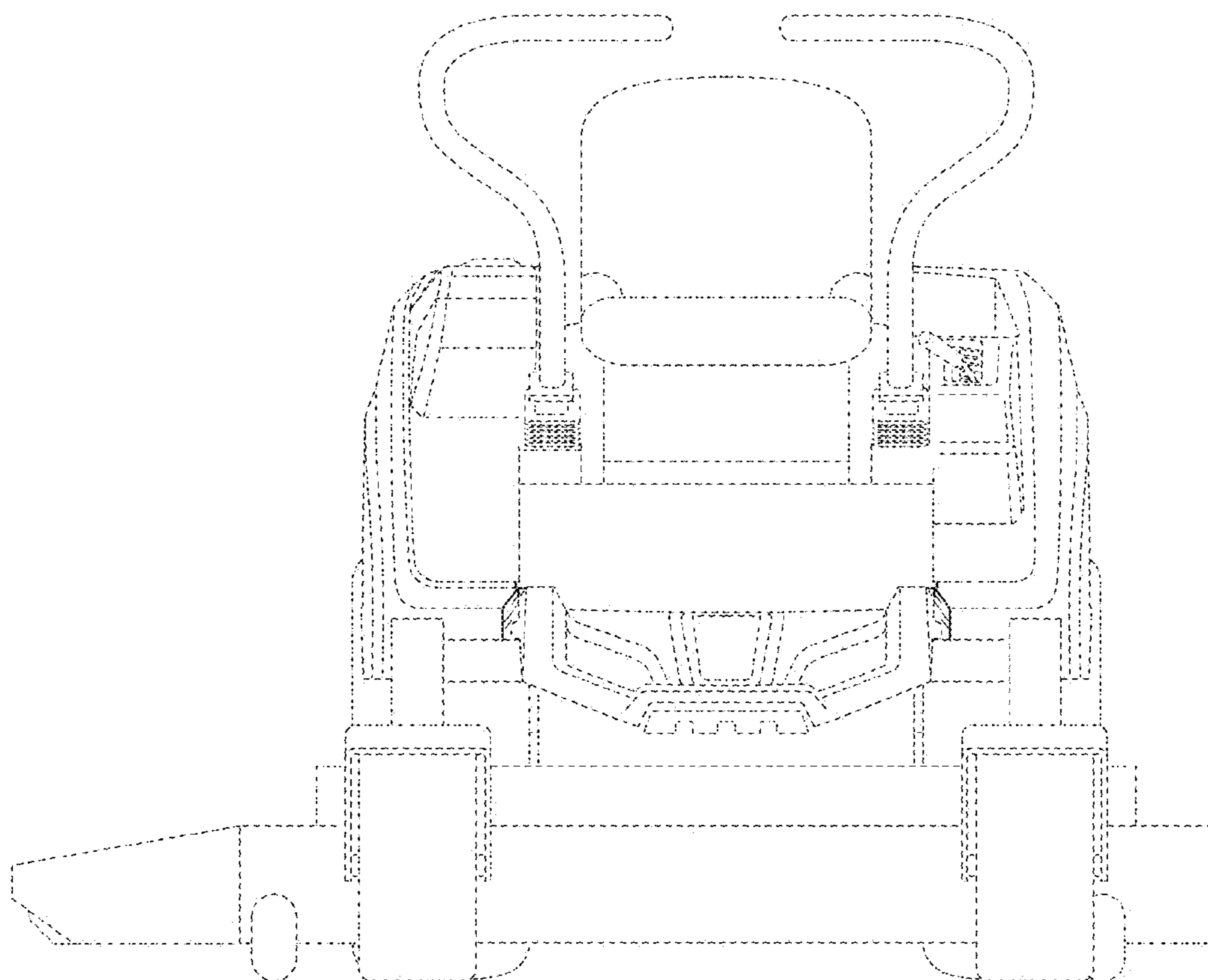

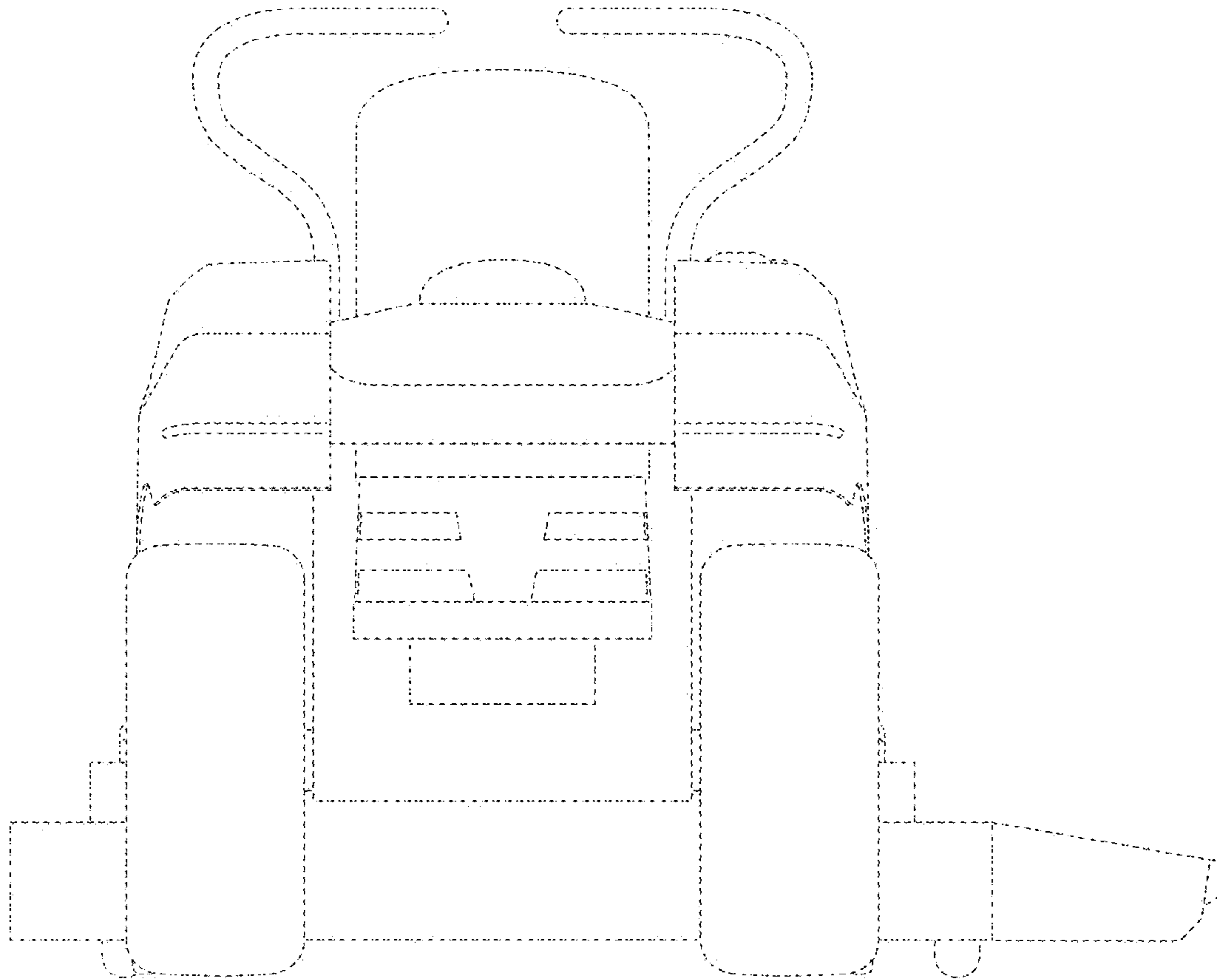

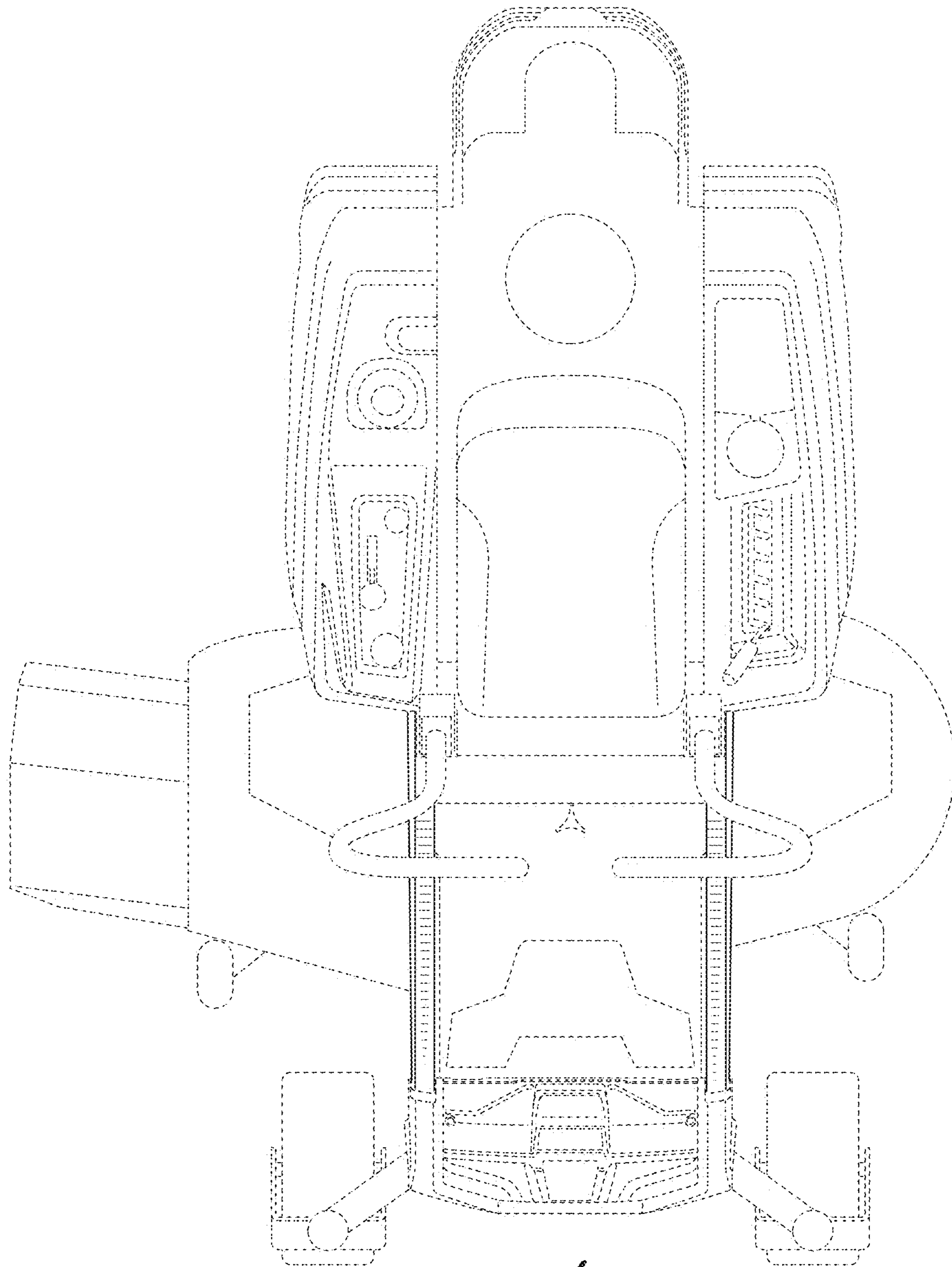
