(57) **CLAIM**

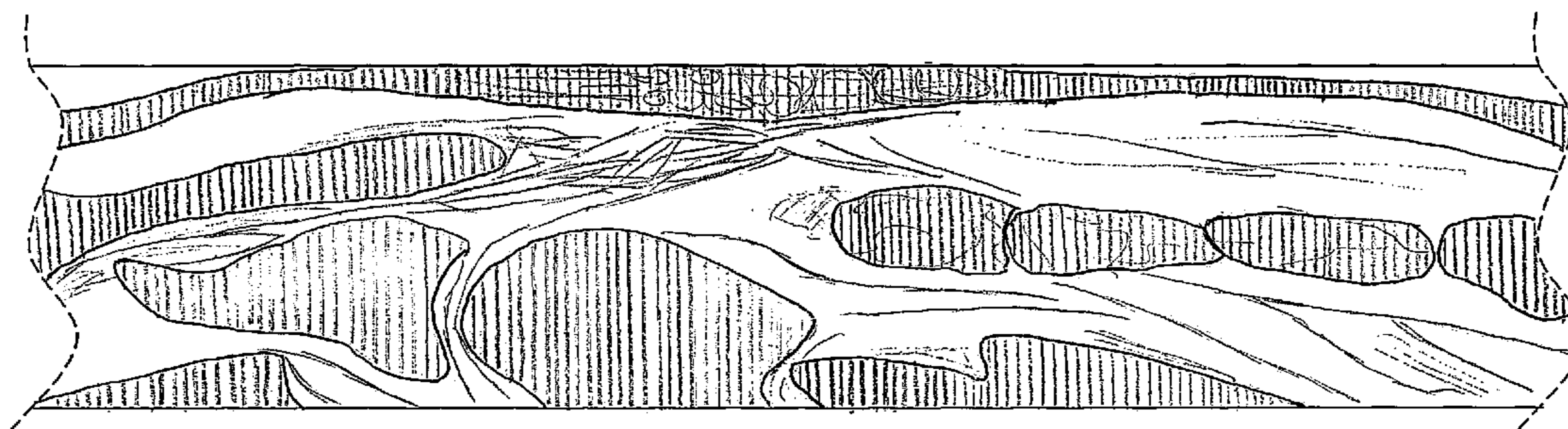
I claim the ornamental design for the duct tape with bacon pattern, as shown.

DESCRIPTION

FIG. 1 is a top plan view thereof;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is an end view thereof; and,
FIG. 4 is a right side elevational view thereof.

The tape is cut off at either end in FIGS. 1, 2 and 4 to indicate no particular length is claimed. The broken lines shown in the drawings are for information purposes only and no form or part of the claimed design.

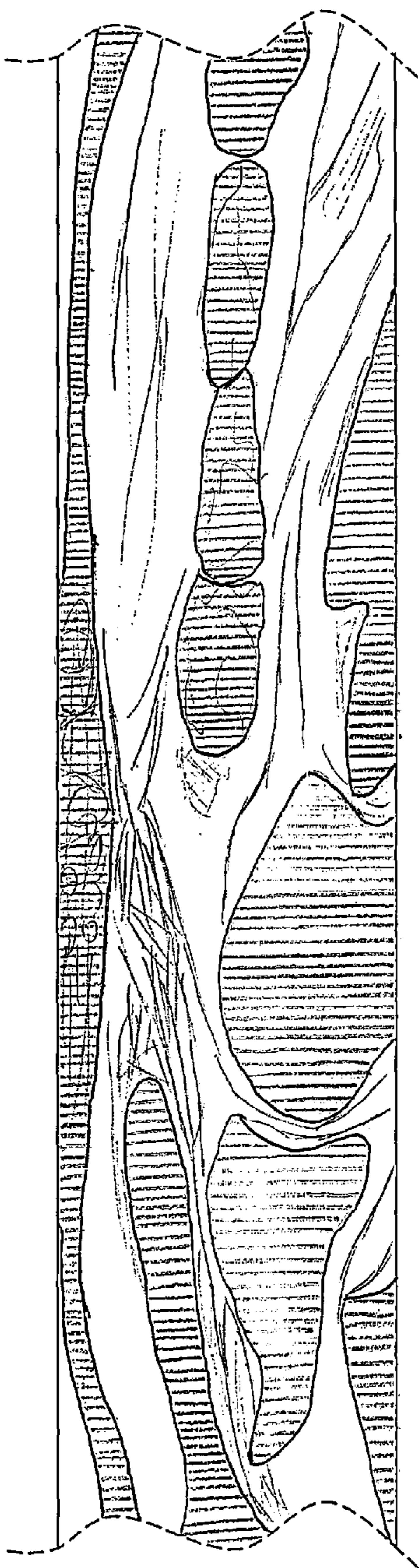

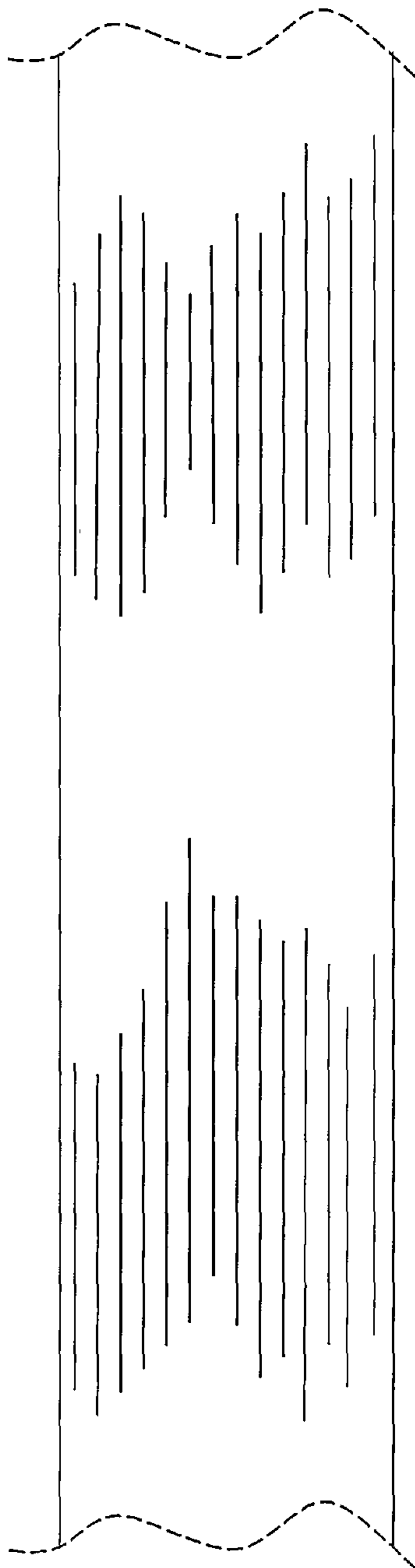

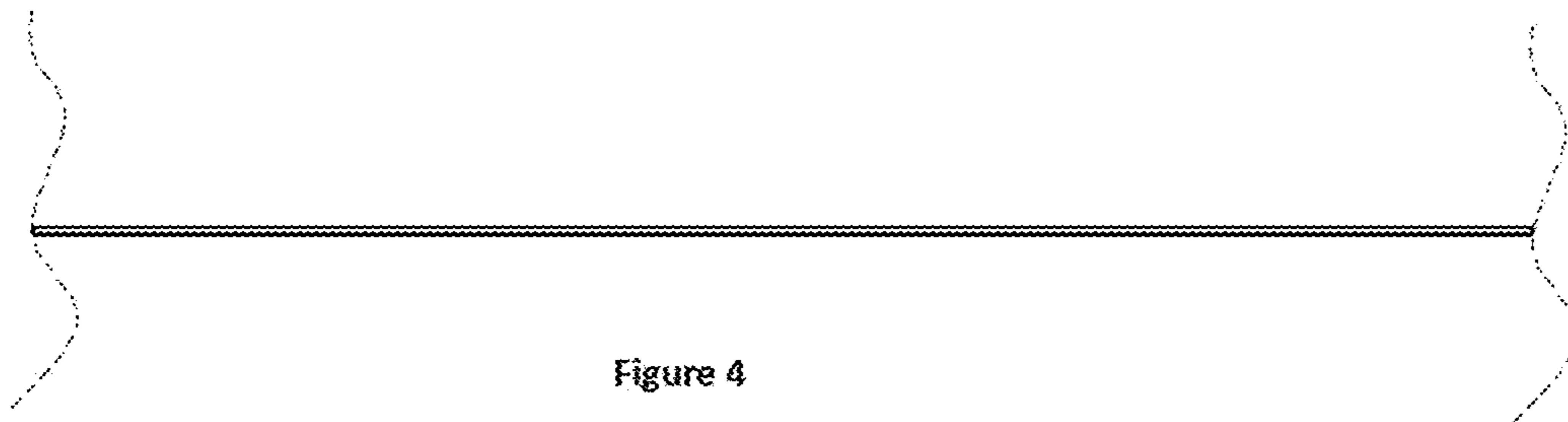
