(57) **CLAIM**

I claim the ornamental design for a training bag cover with fighter, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the training bag cover with fighter showing my new design;
FIG. 2 is a back perspective view thereof;
FIG. 3 is a front view showing the design in an alternate, flattened configuration;
FIG. 4 is a back view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a left side view thereof; and,
FIG. 8 is a right side view thereof.

In FIGS. 1 and 2, the training bag and chains are shown in broken lines for illustrative purposes only and do not form part of the claimed design.

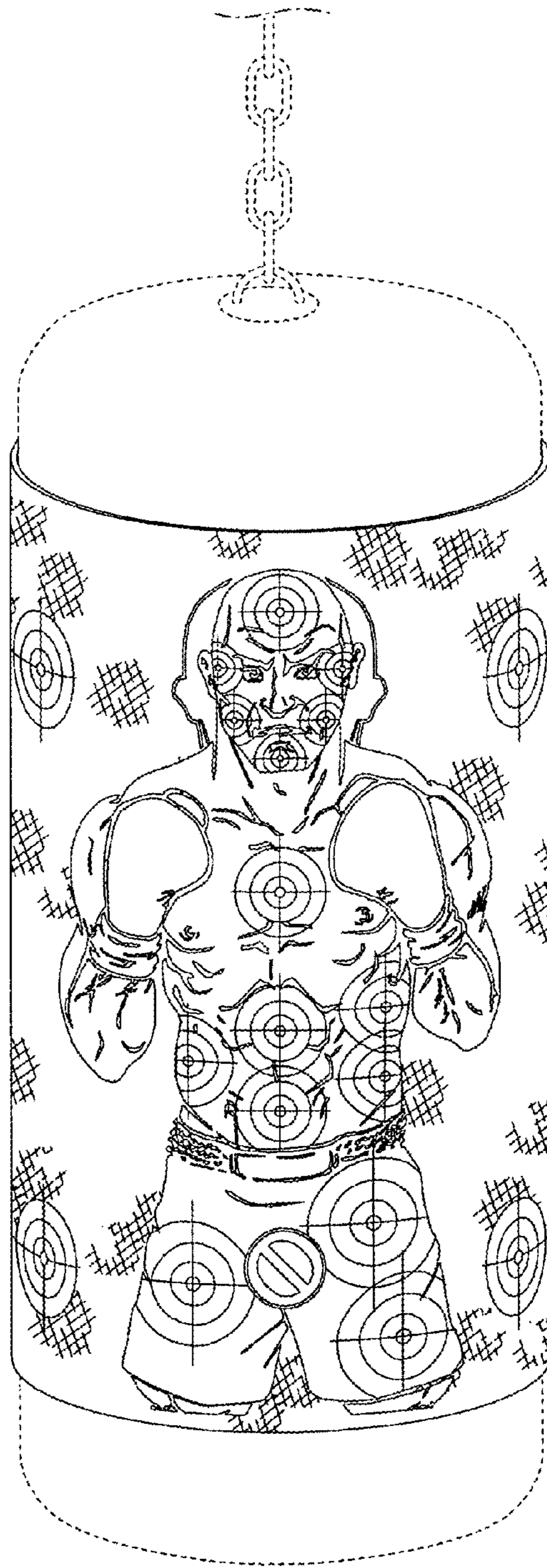

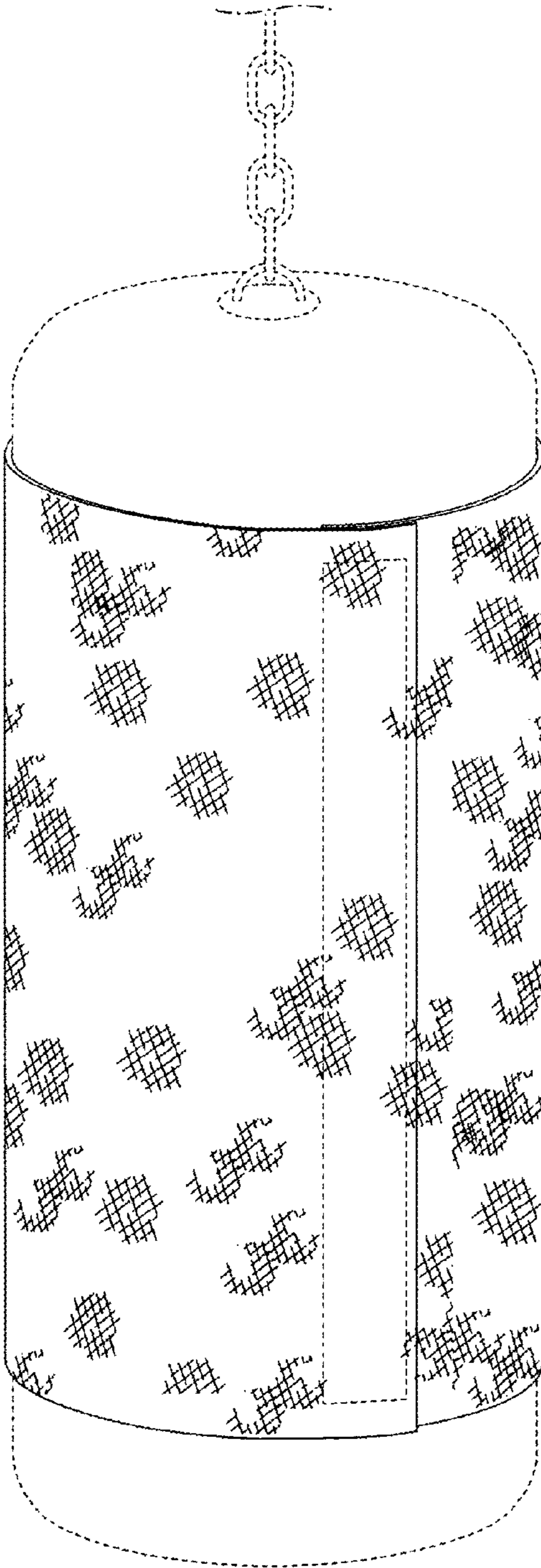

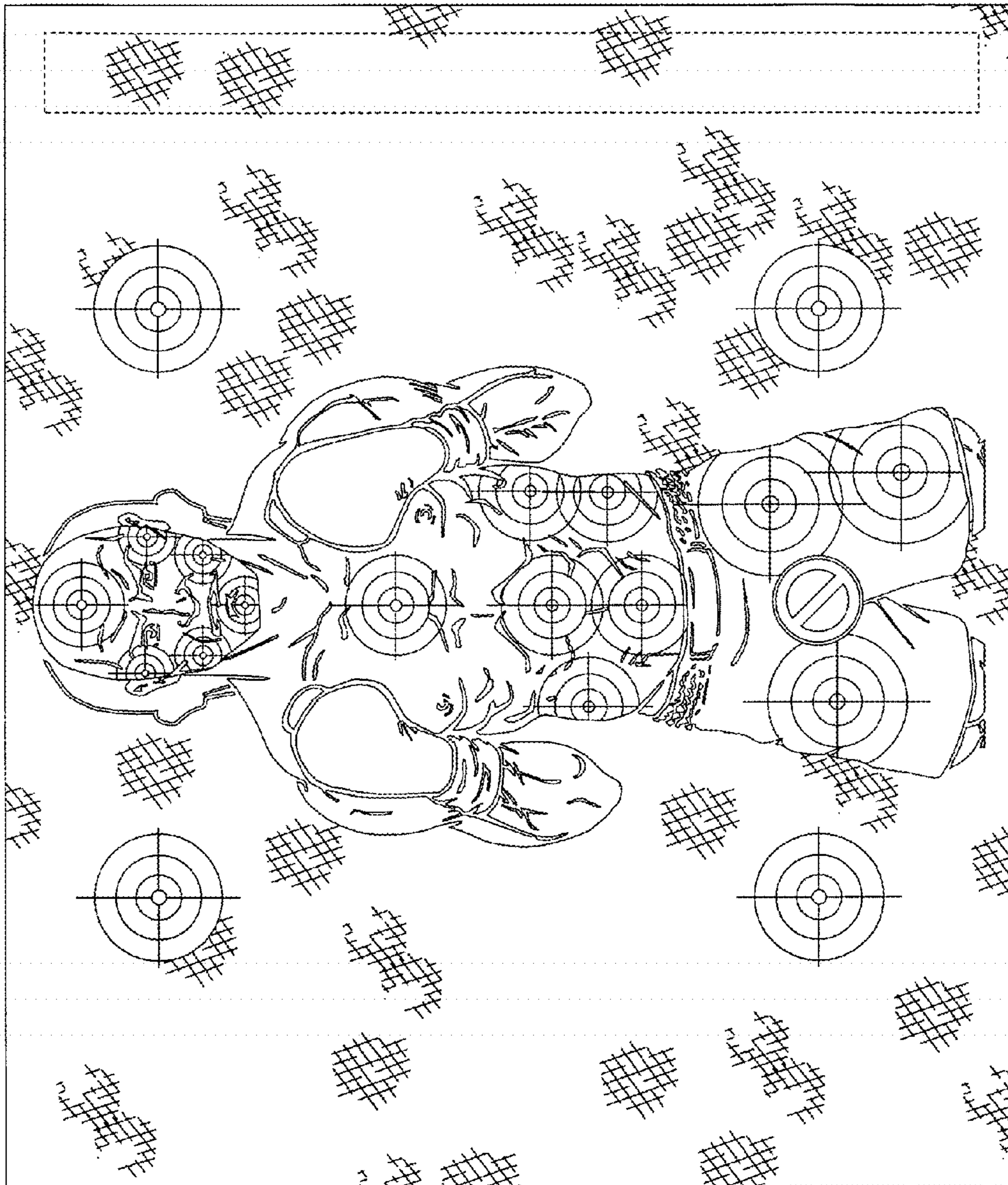

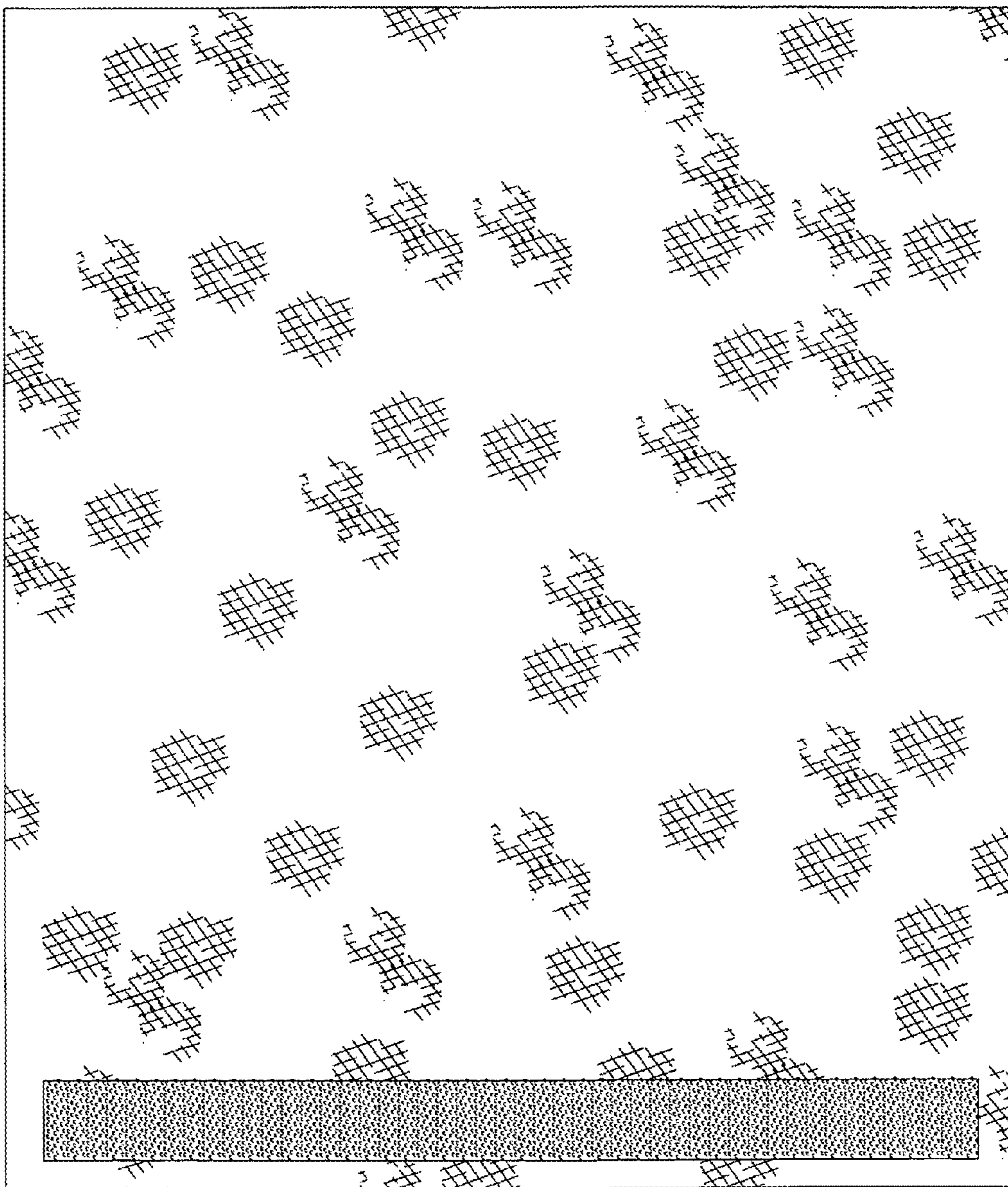

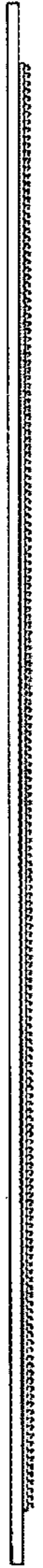

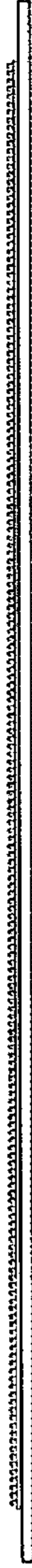

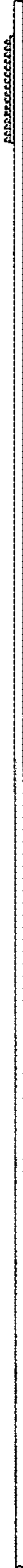
