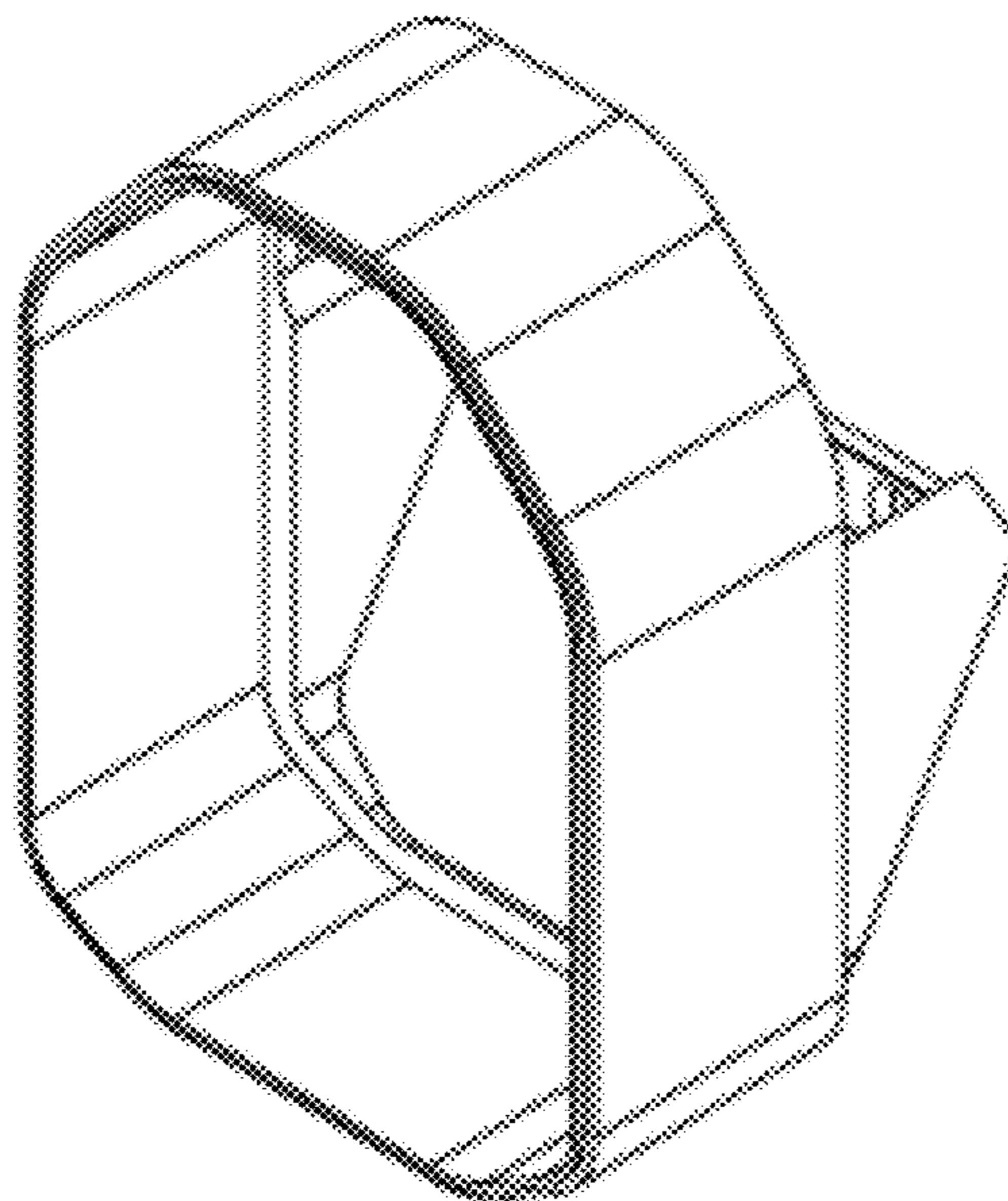
(57) **CLAIM**

The ornamental design for a baffle unit for a shotgun sound suppressor, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of an embodiment of baffle unit for a shotgun sound suppressor;
FIG. 2 is a front view of the embodiment of baffle unit shown in FIG. 1;
FIG. 3 is a left side view of the embodiment of baffle unit shown in FIG. 1;
FIG. 4 is a right side view of the embodiment of baffle unit shown in FIG. 1;
FIG. 5 is a top view of the embodiment of sound suppressor shown in FIG. 1;
FIG. 6 is a bottom view of the embodiment of baffle unit shown in FIG. 1;

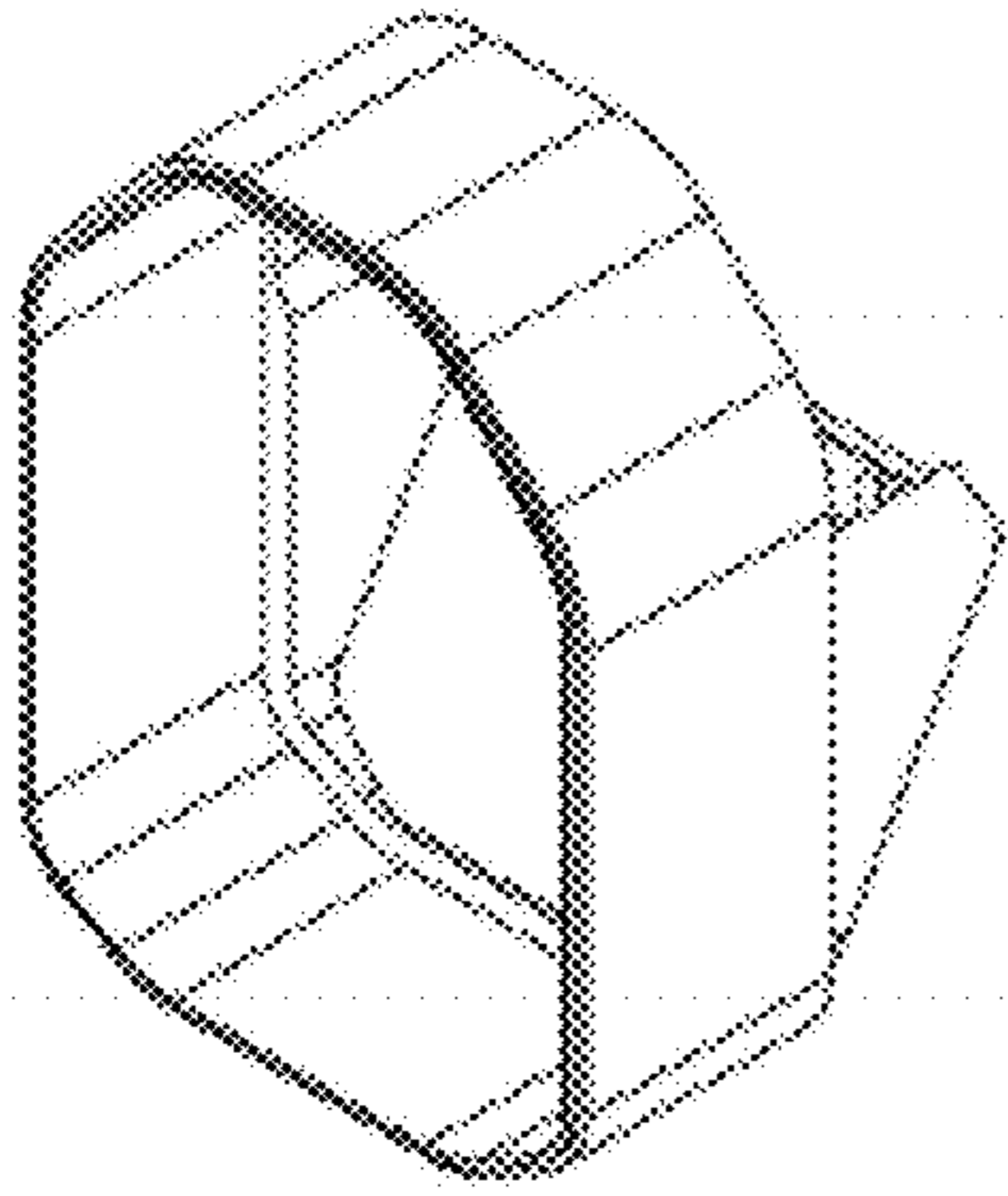

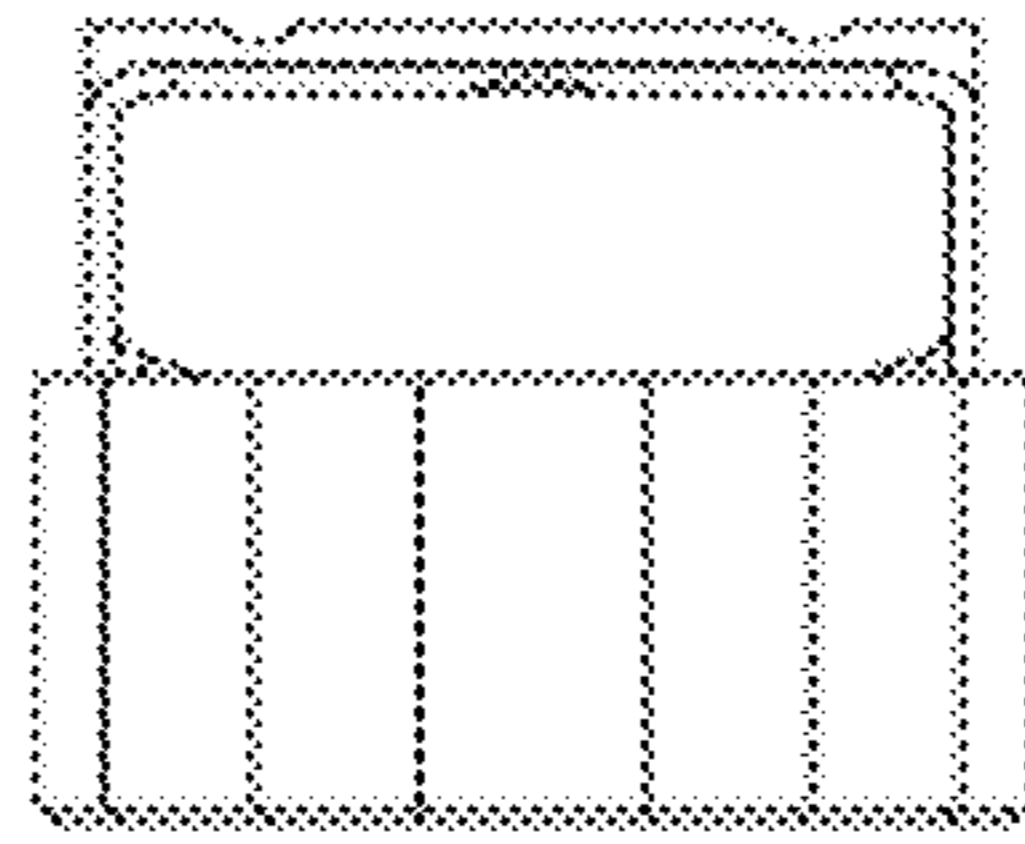

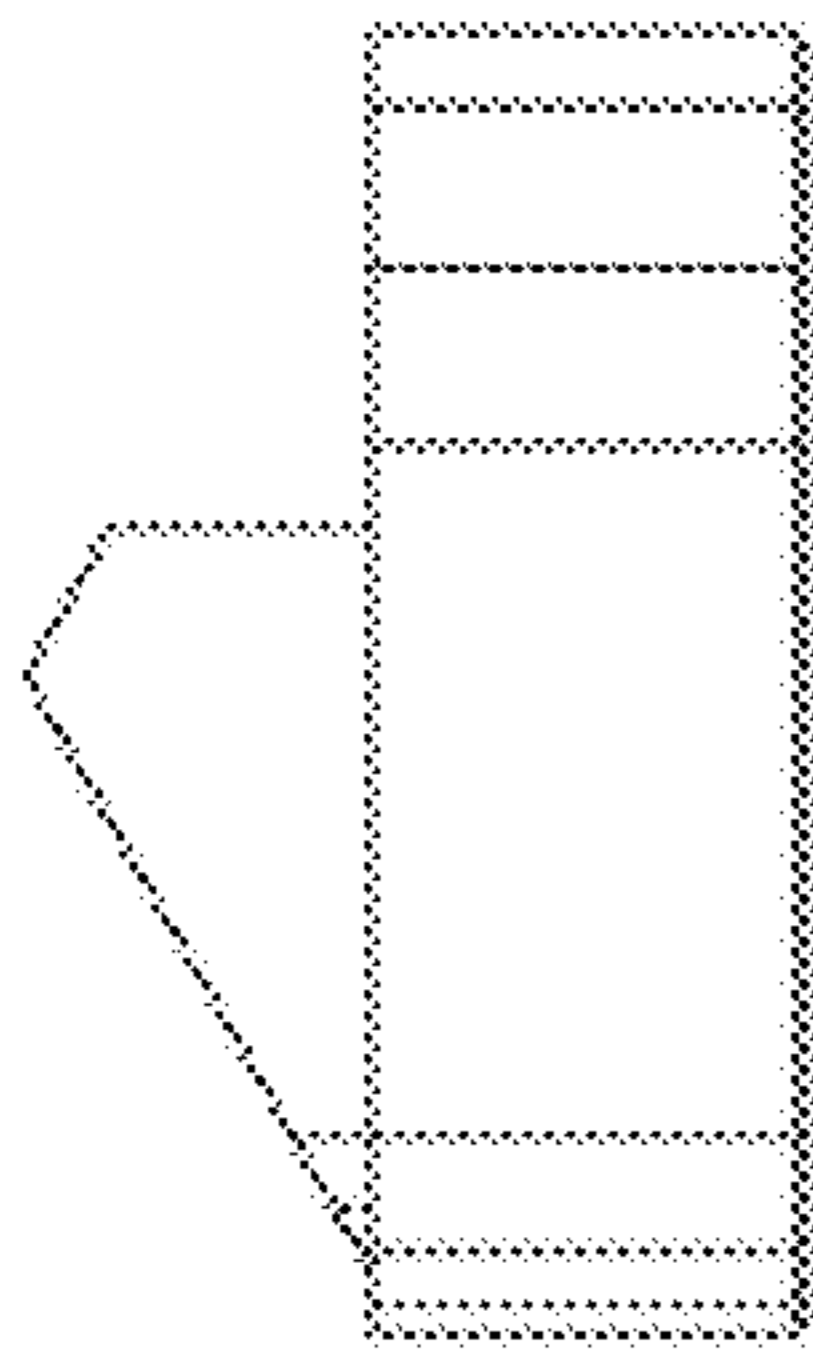

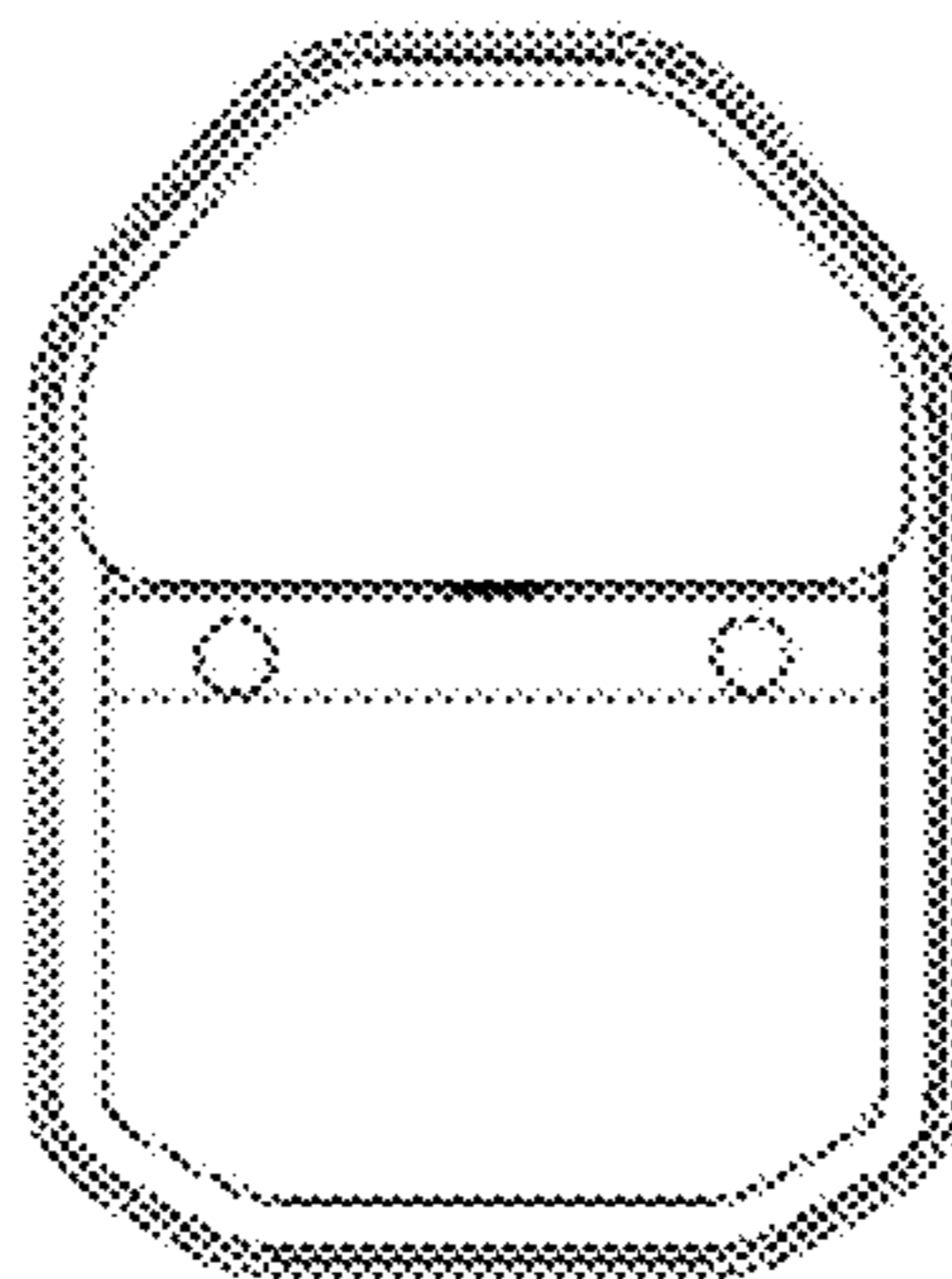

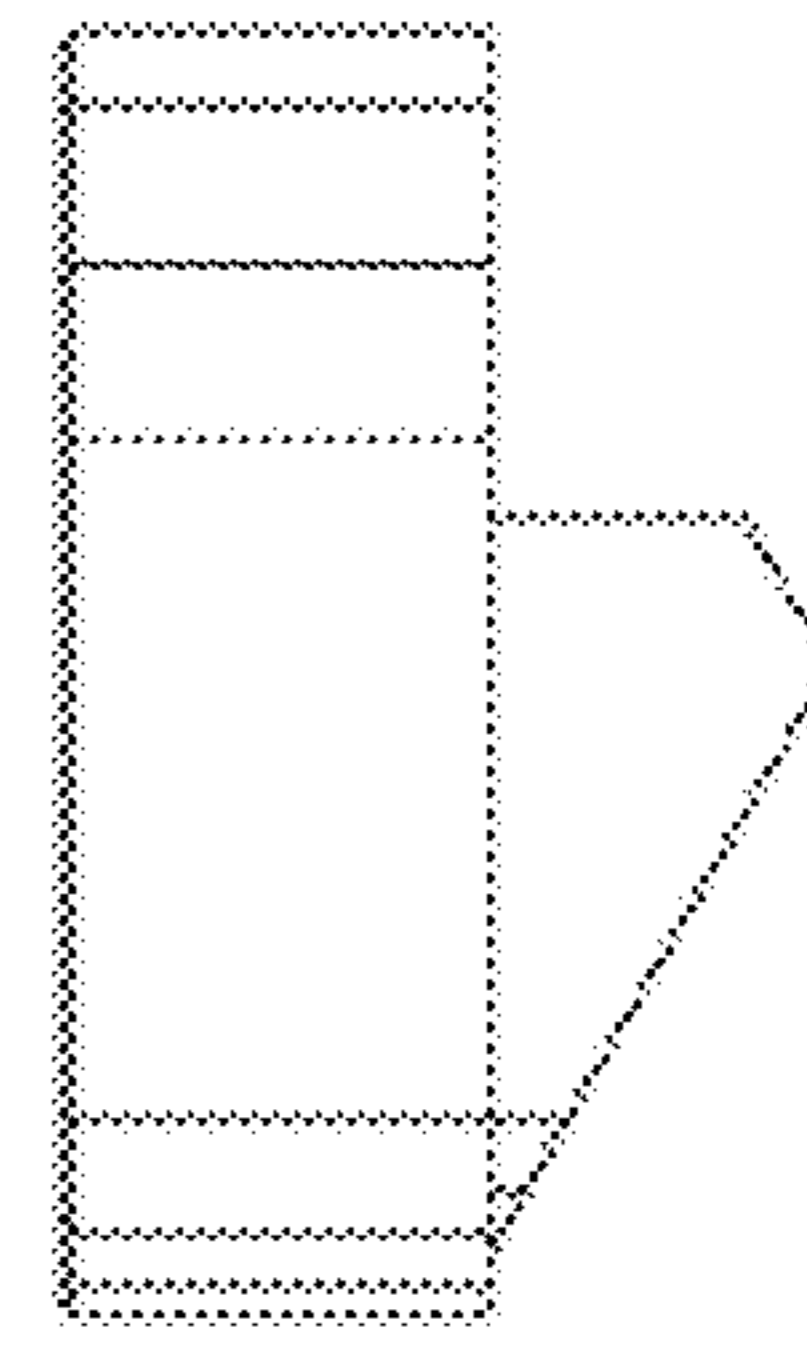

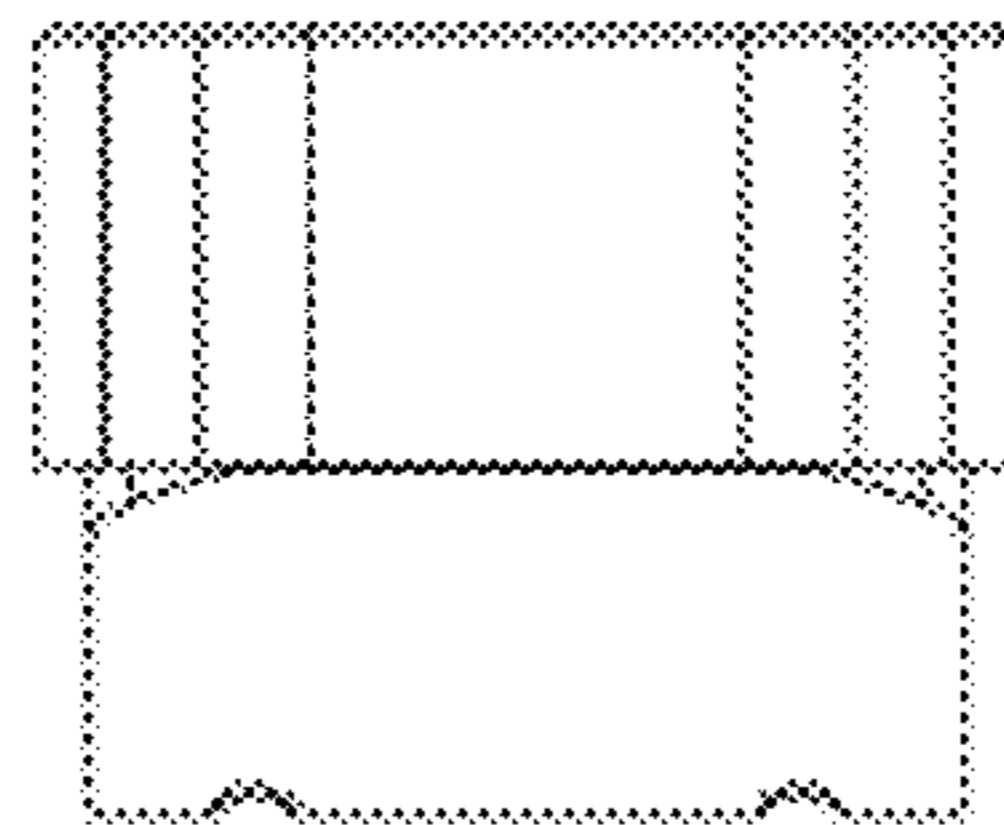

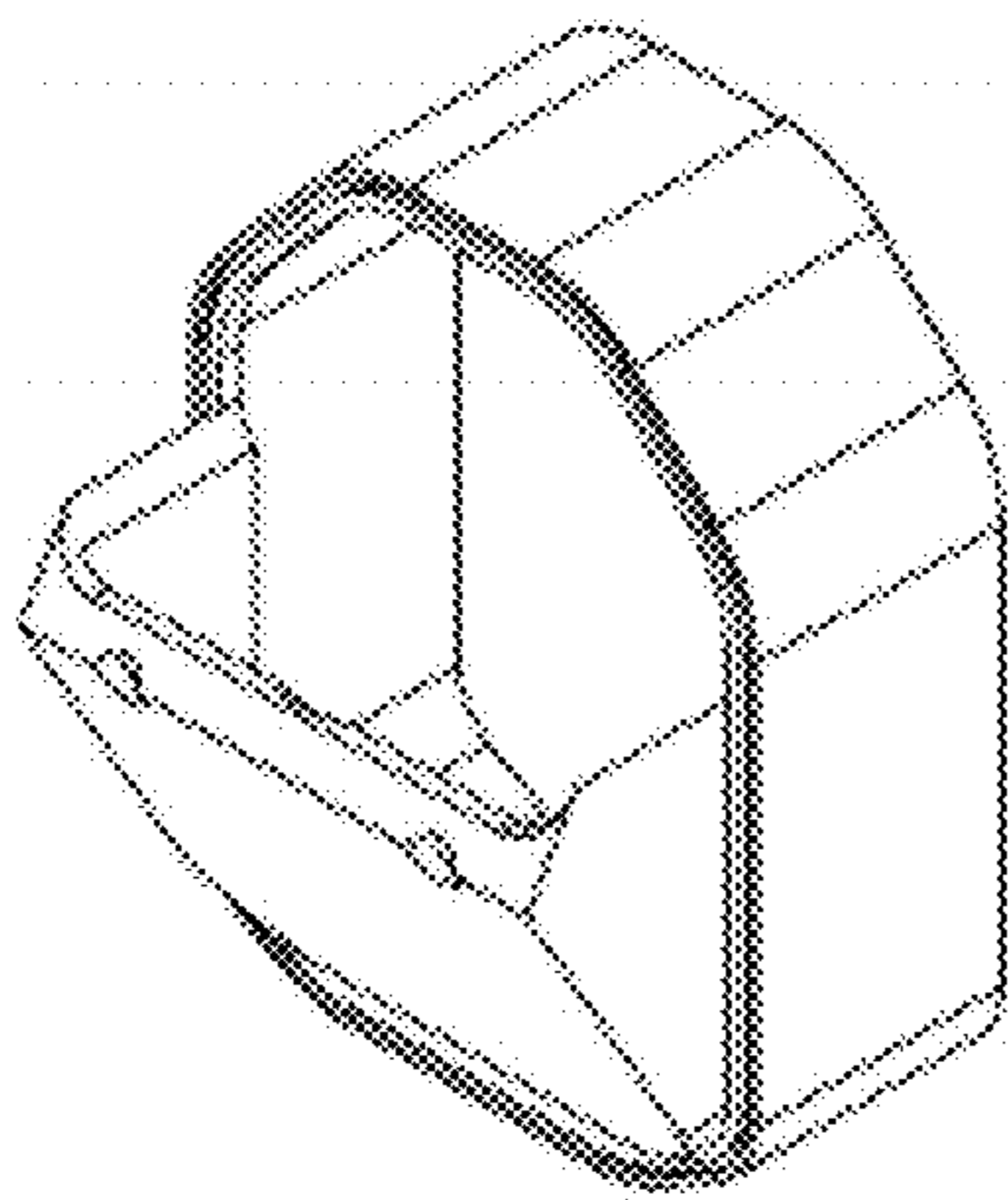

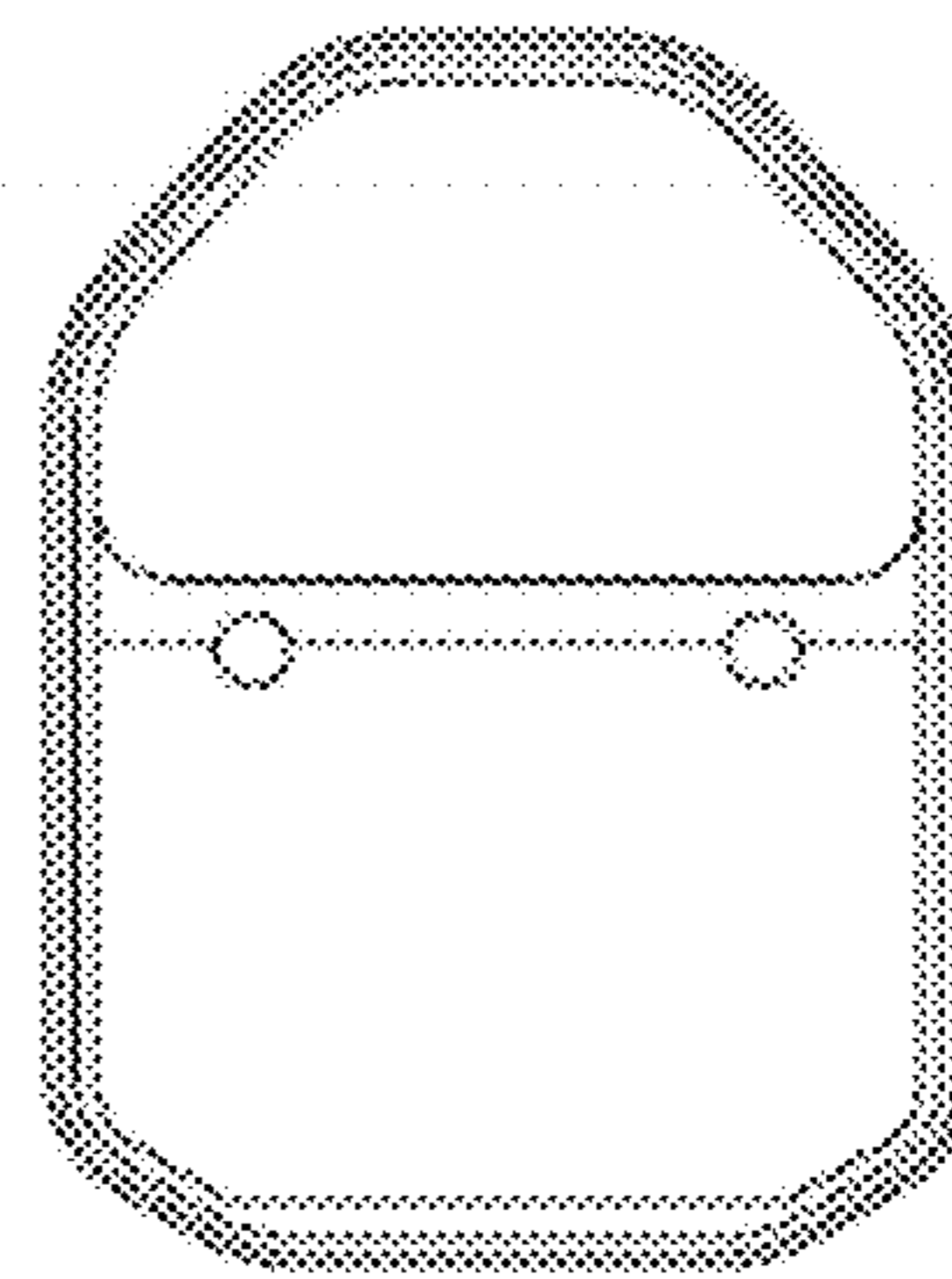
