(57) **CLAIM**

I claim the ornamental design for a sports helmet fin, as shown and described.

DESCRIPTION

FIG. 1 is a top left-side perspective view of a sports helmet fin showing my new design;

FIG. 2 is a top right-side perspective view thereof;

FIG. 3 is a left-side view thereof;

FIG. 4 is a right-side view thereof;

FIG. 5 is a rear left-side perspective view thereof;

FIG. 6 is a rear right-side perspective view thereof; and,

FIG. 7 is a top plan view thereof.

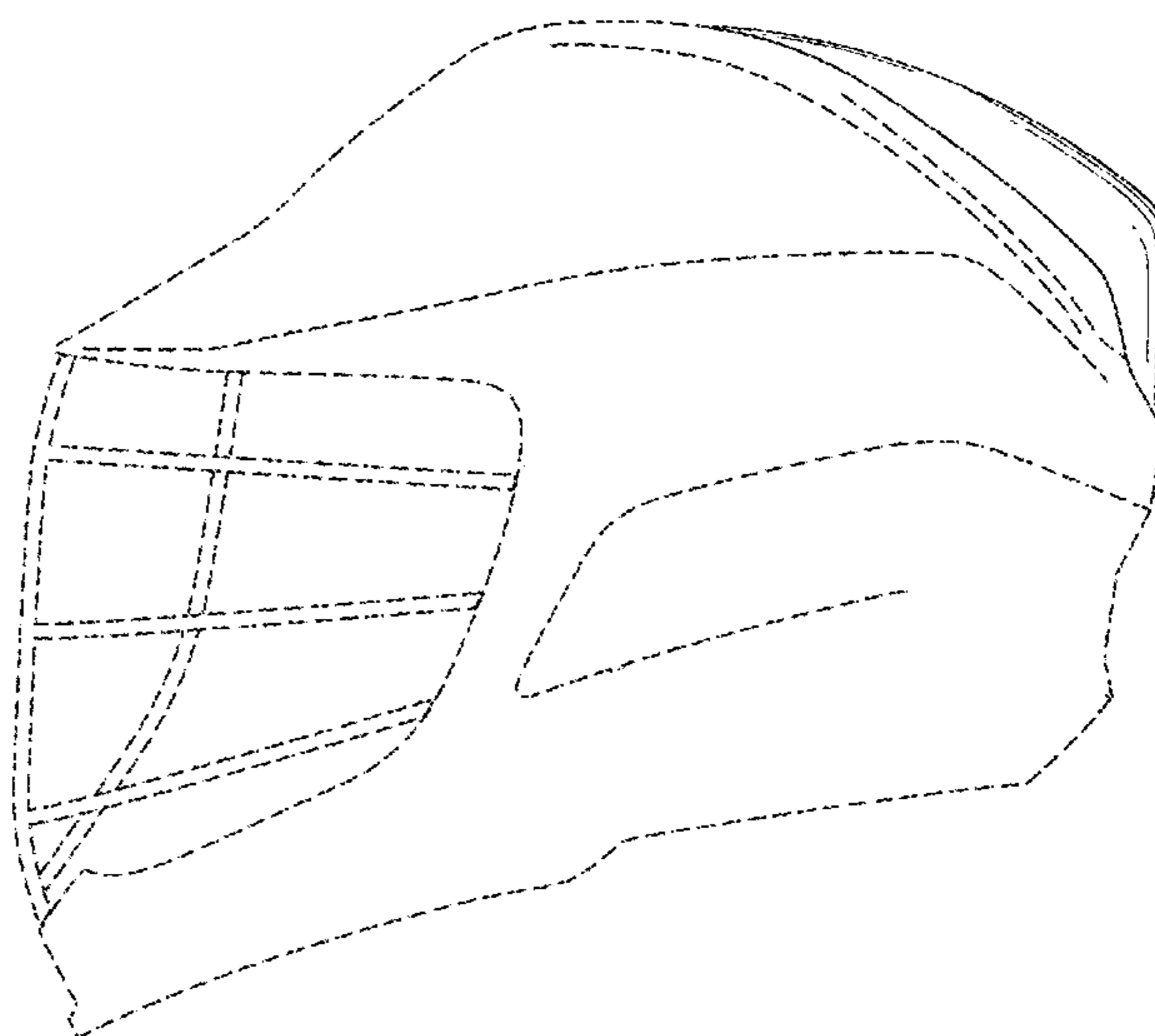
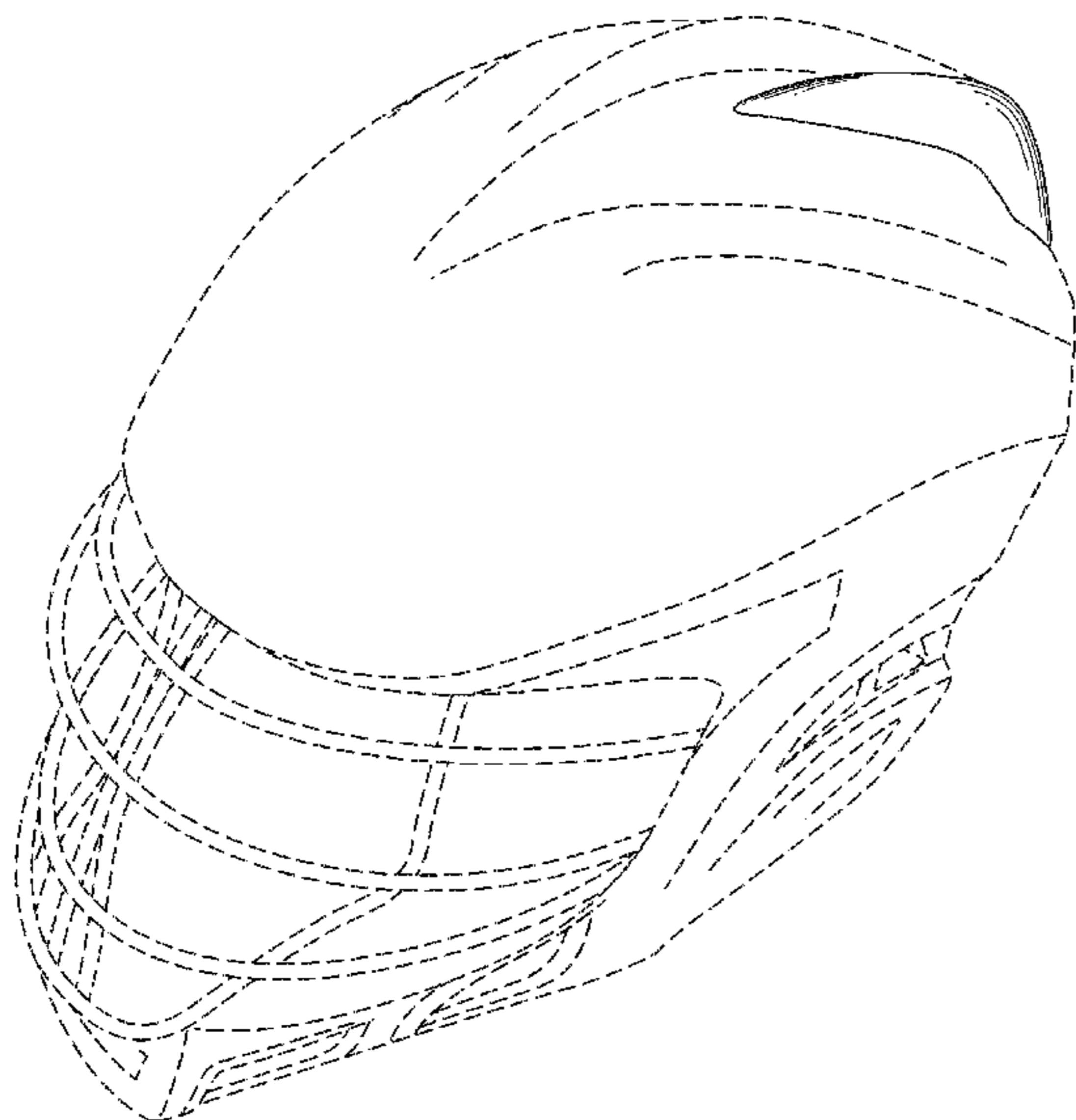

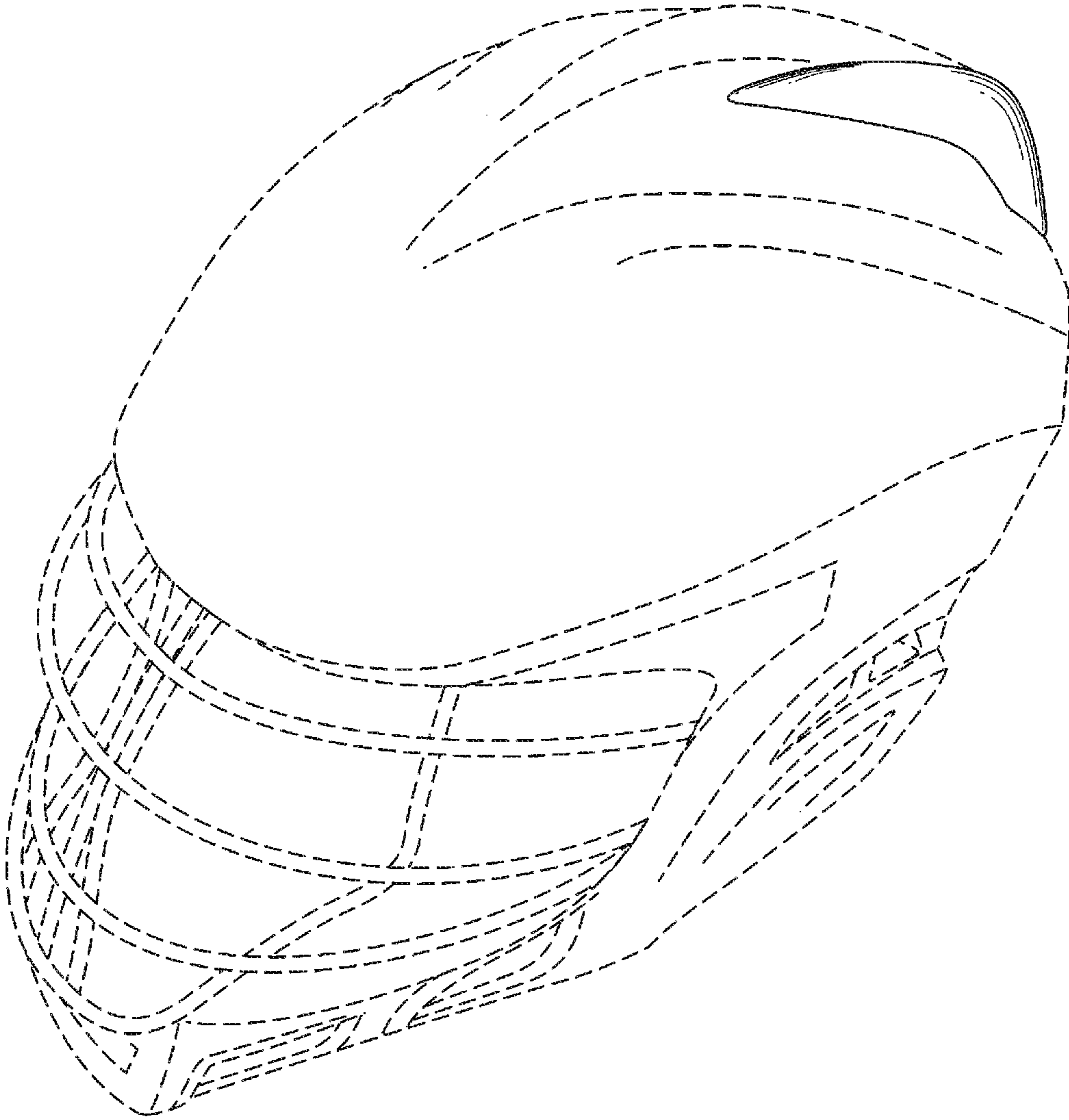

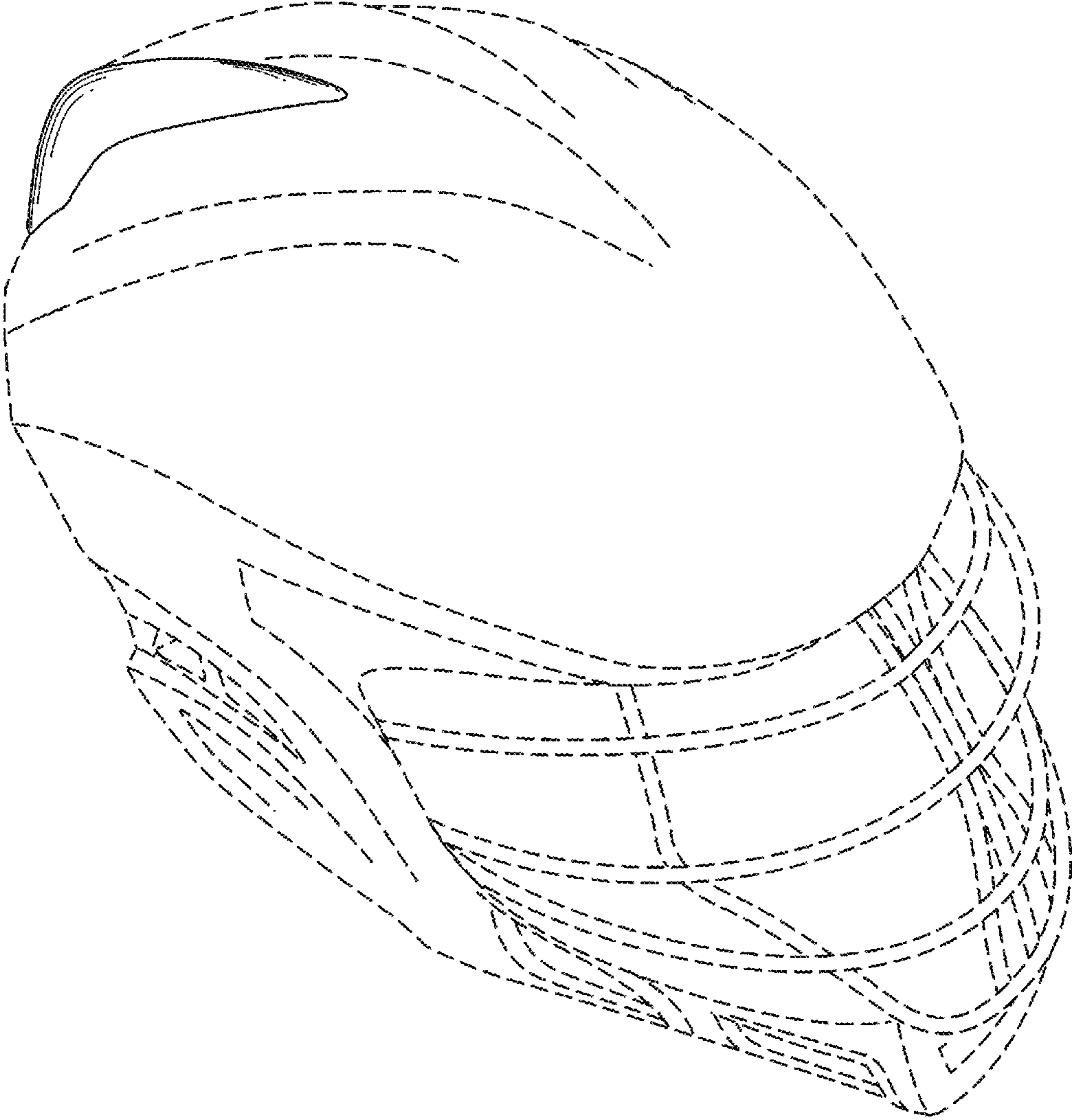

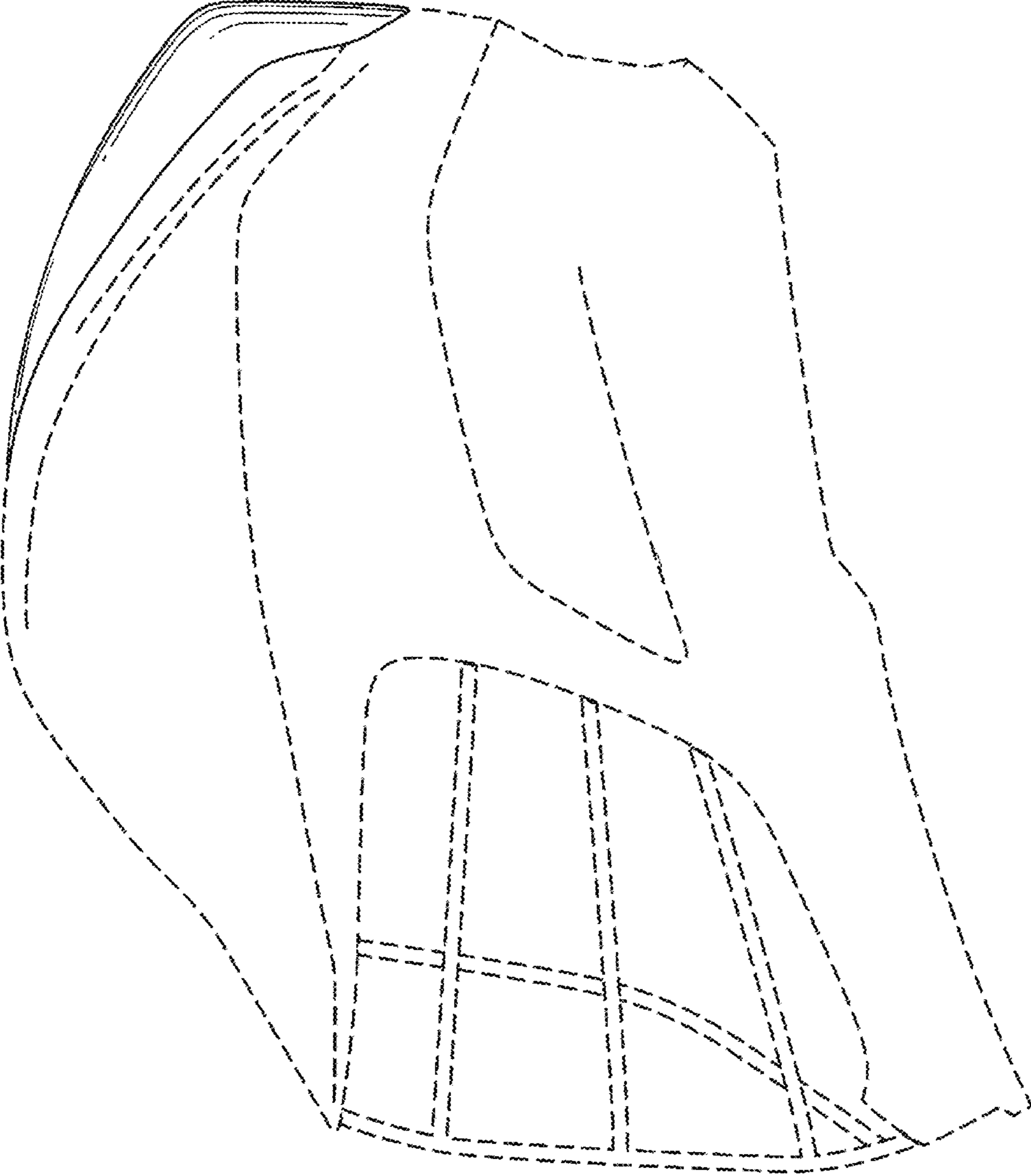

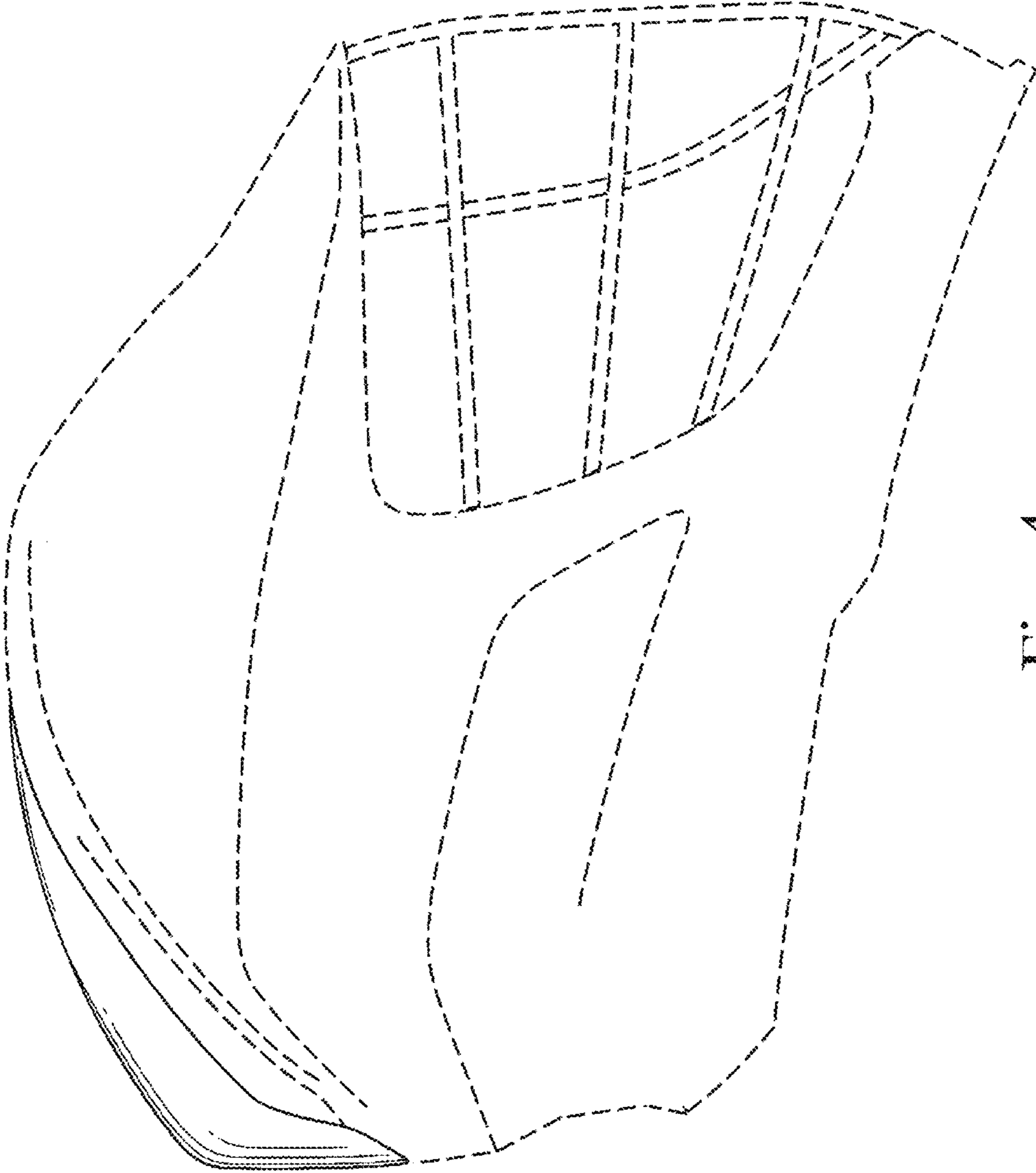

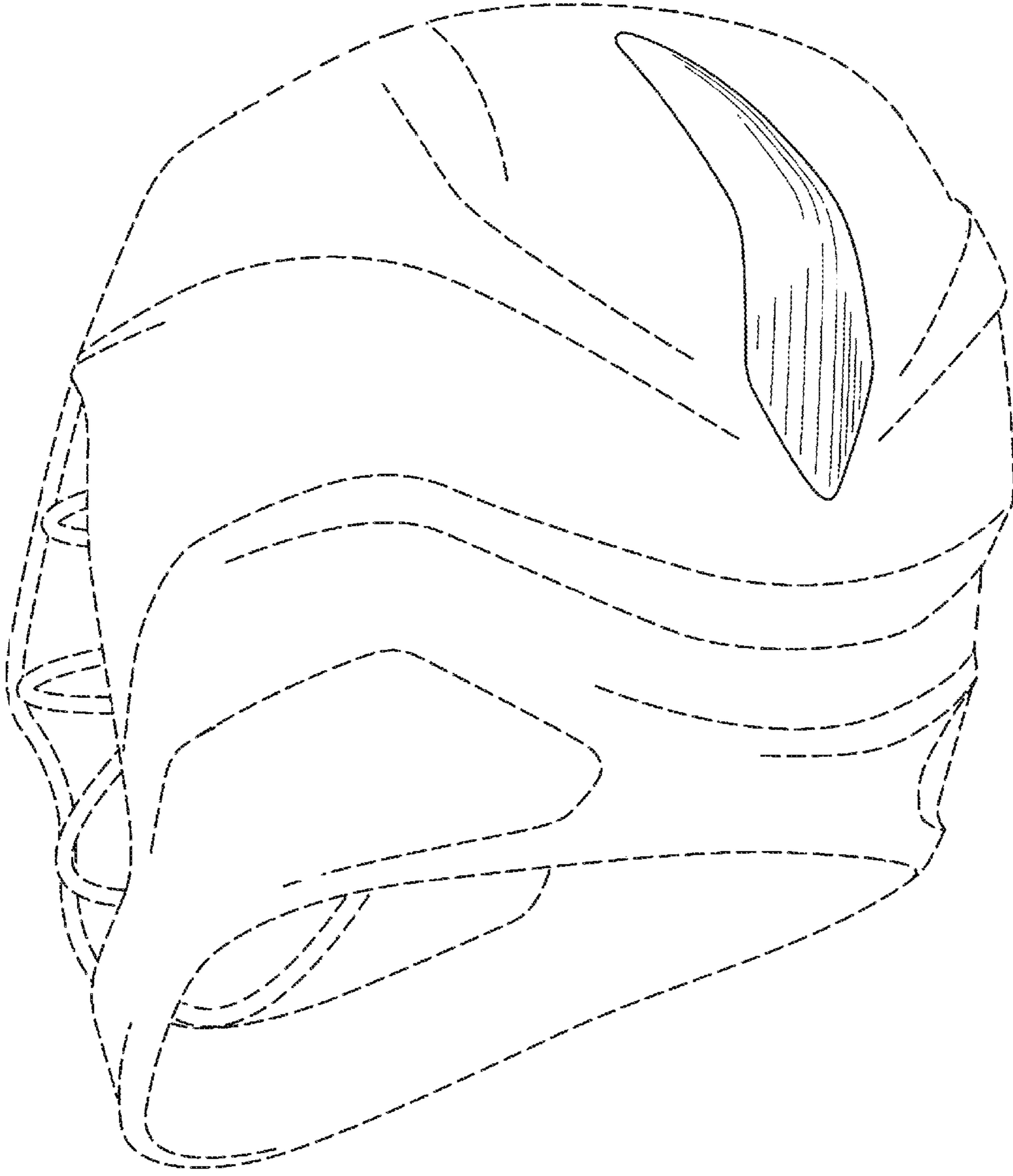

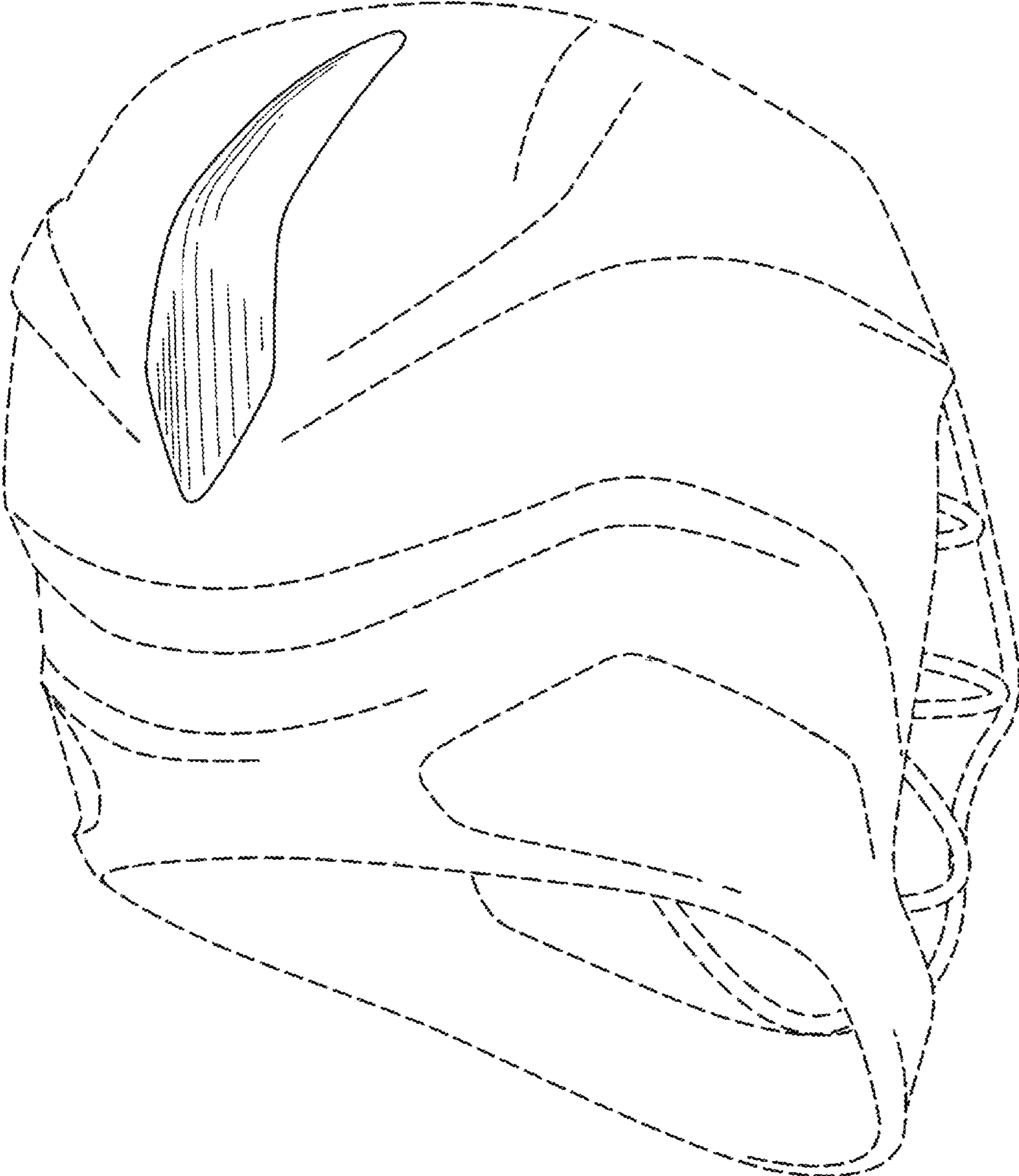

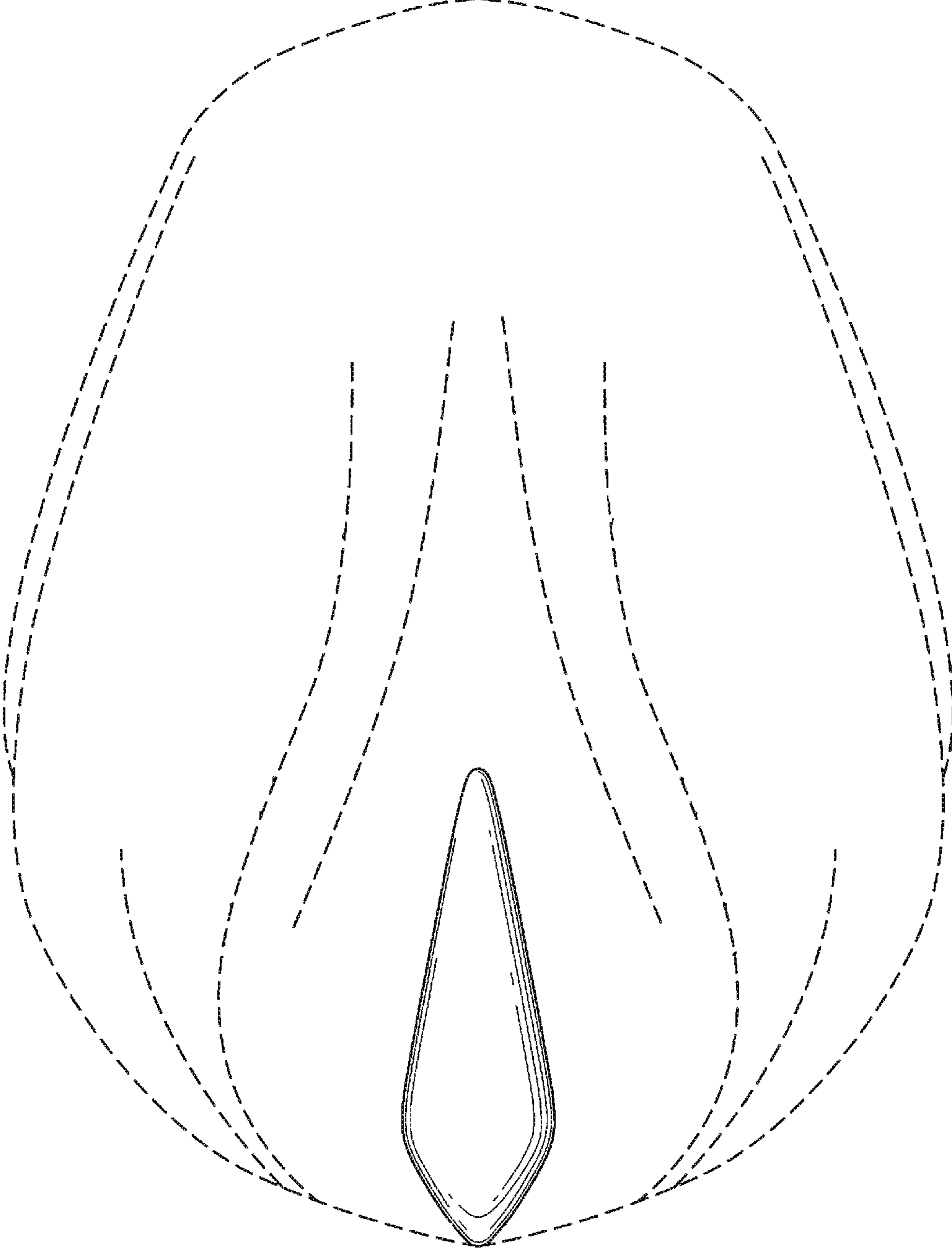
