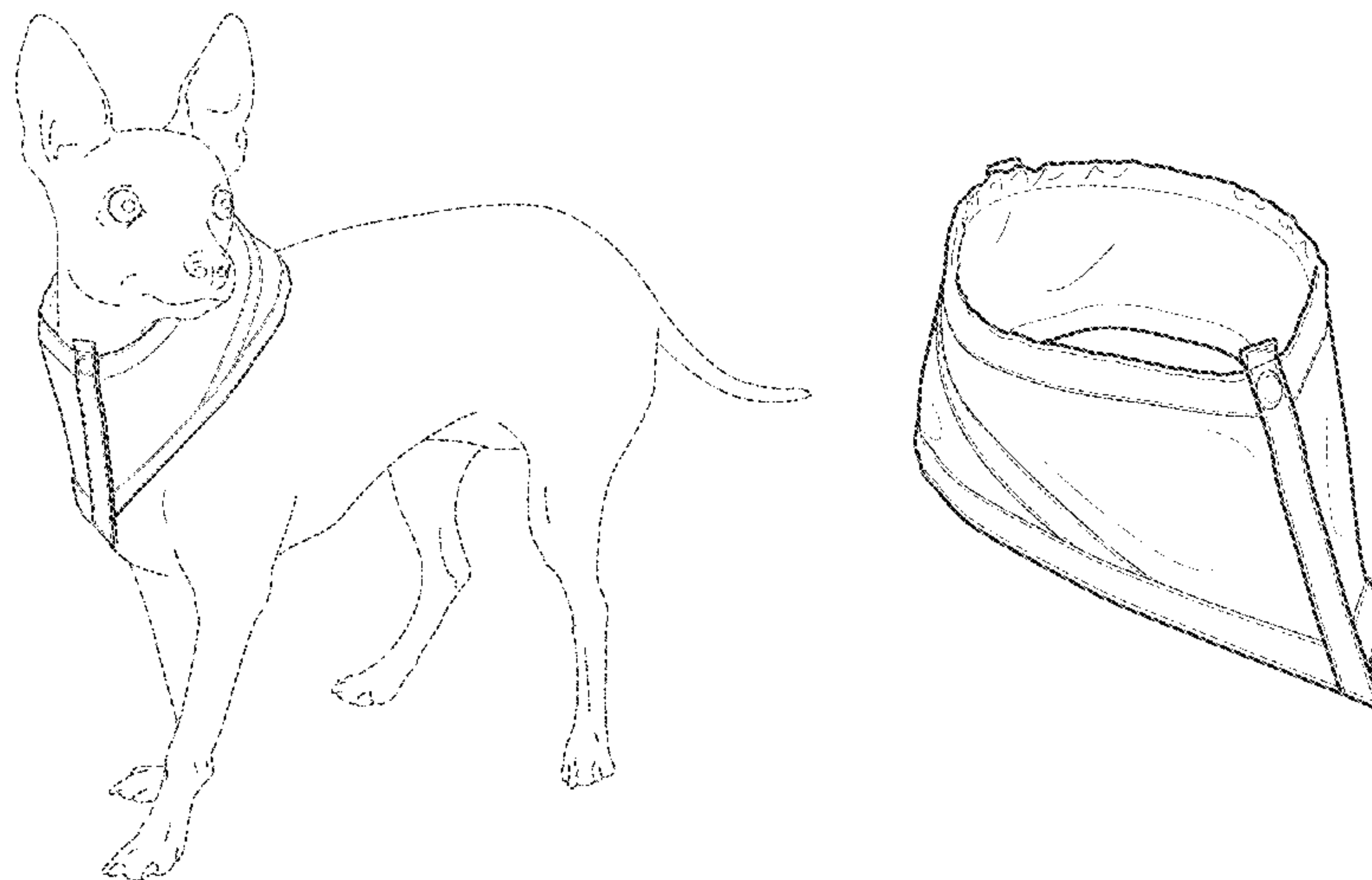
(57) **CLAIM**

I claim the ornamental design for an animal neck covering, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an animal neck covering worn by an animal;

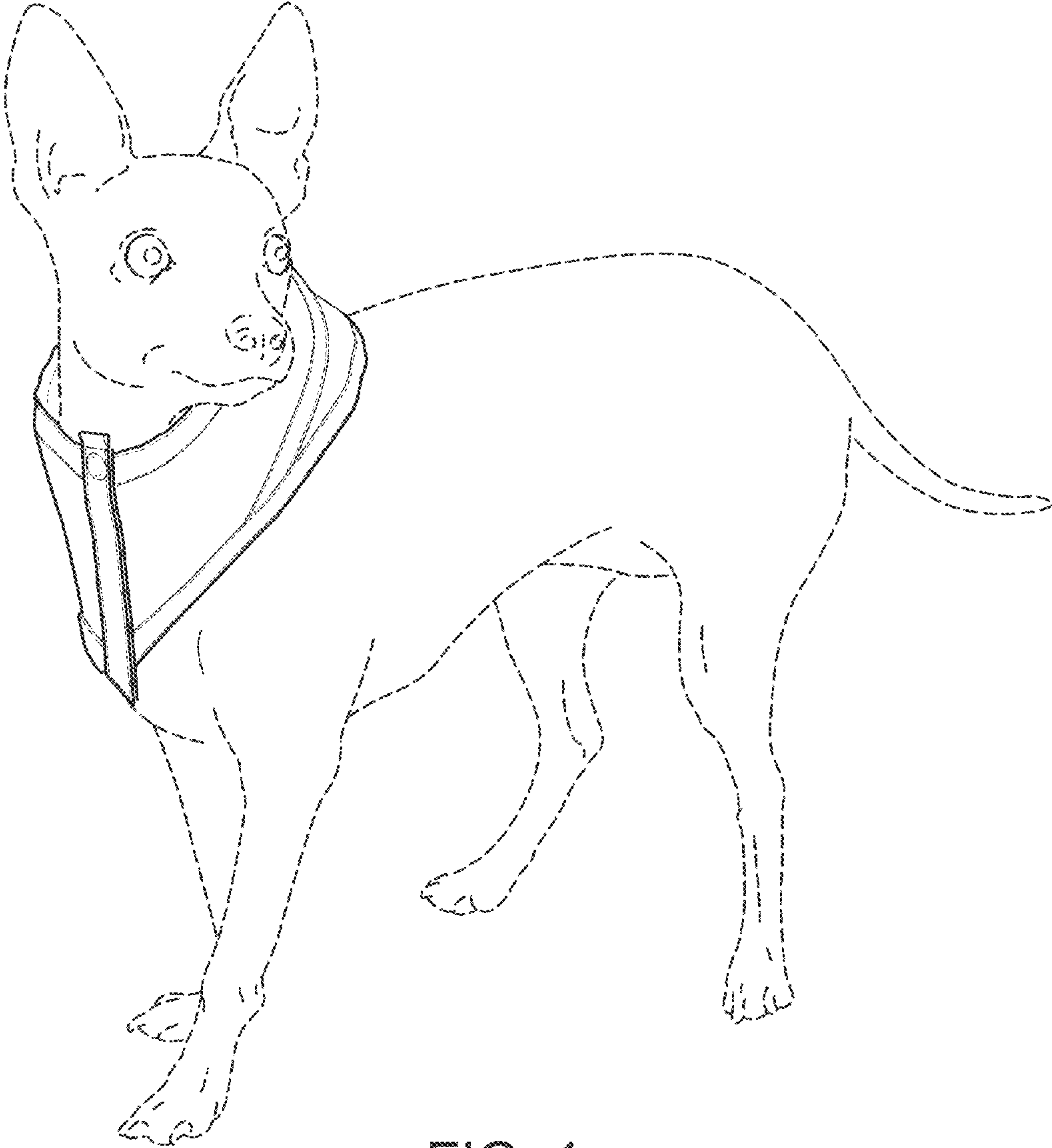

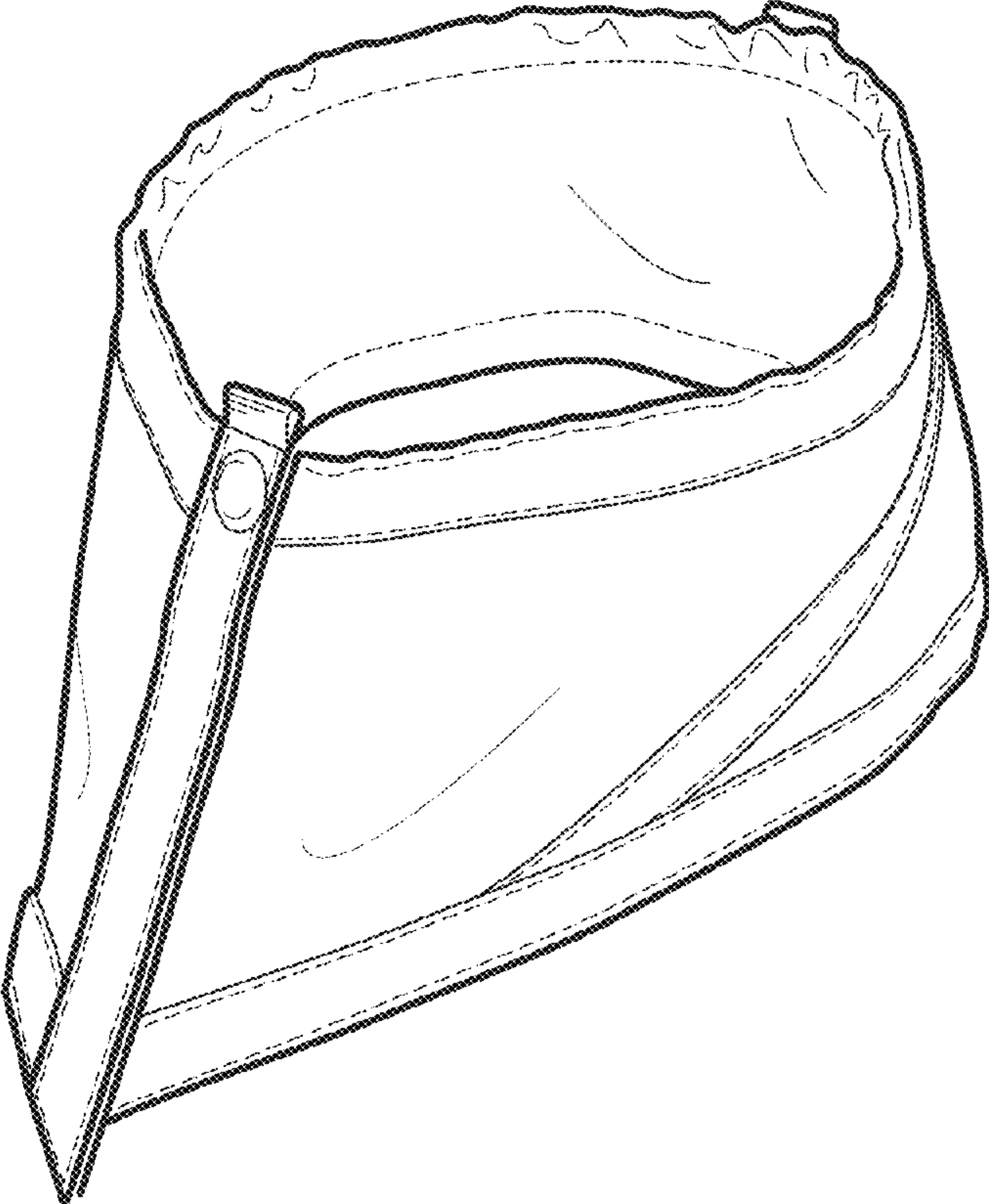

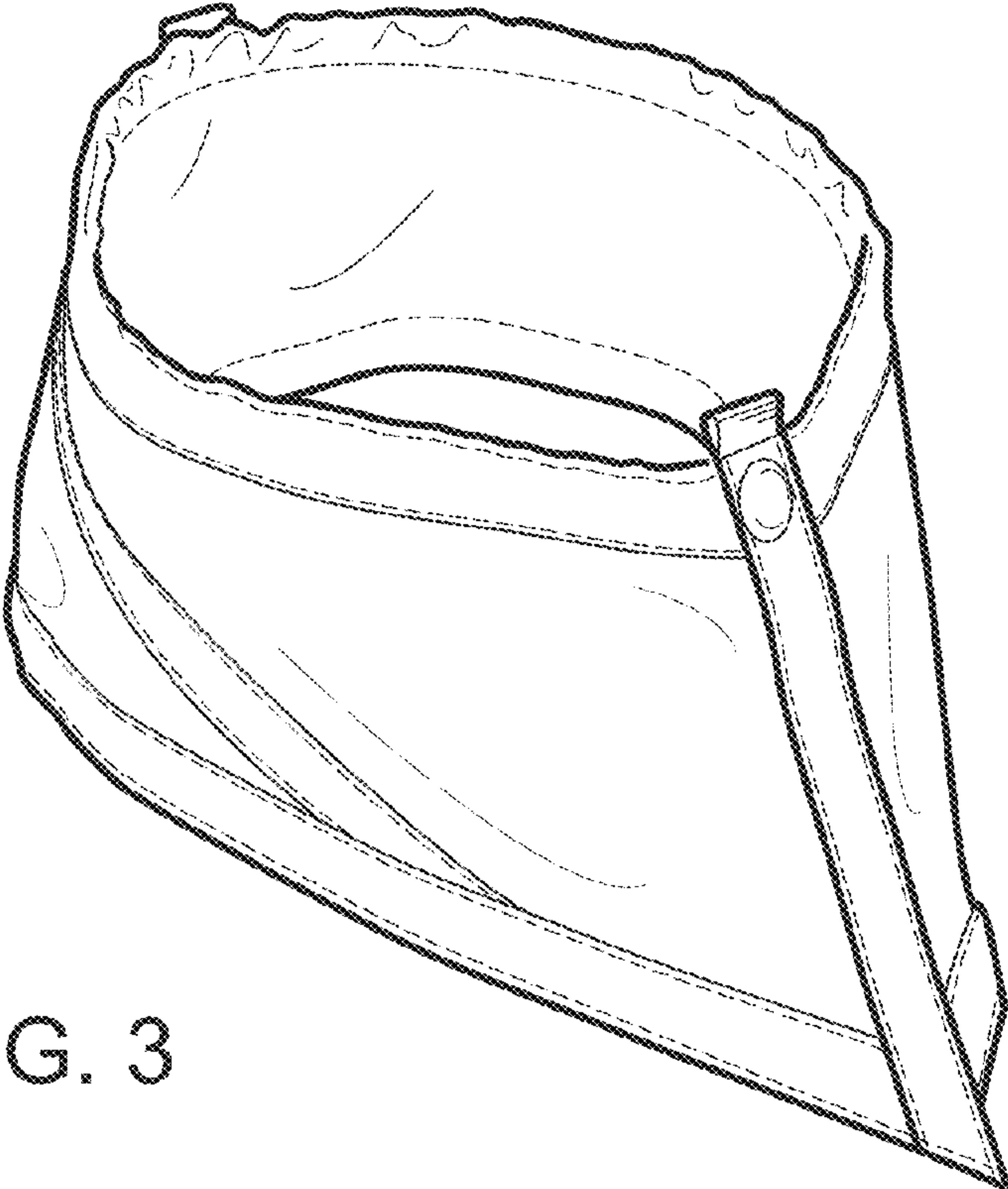

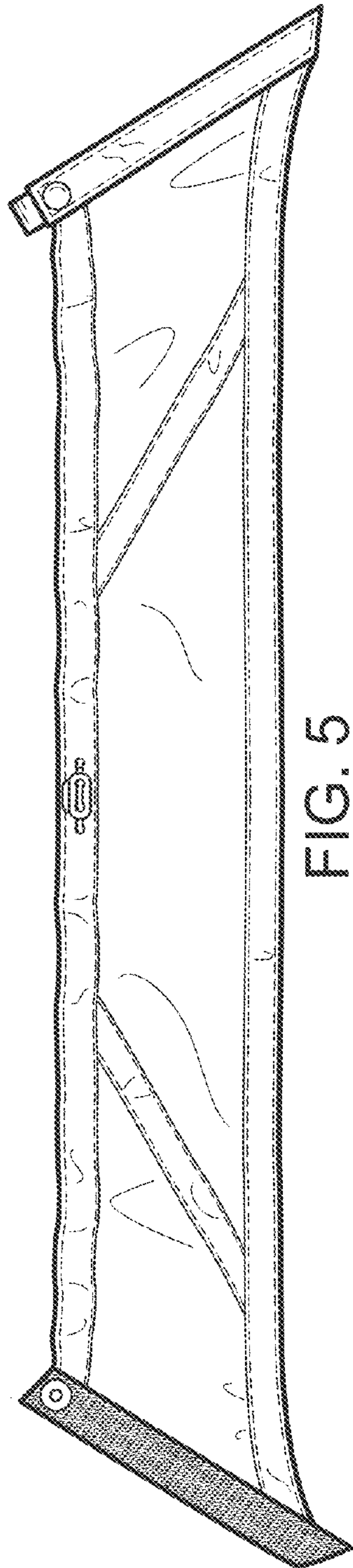

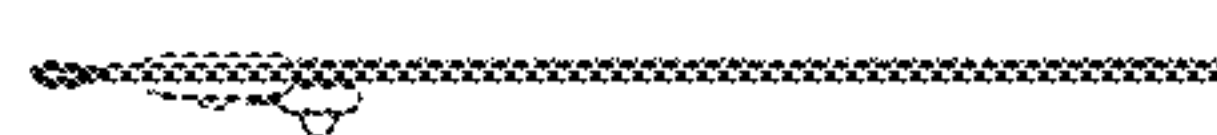

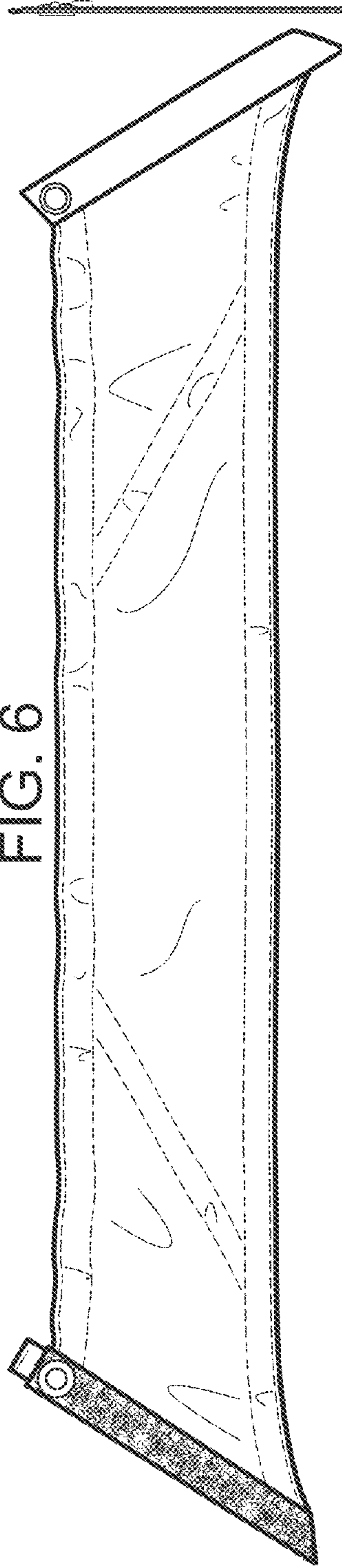
