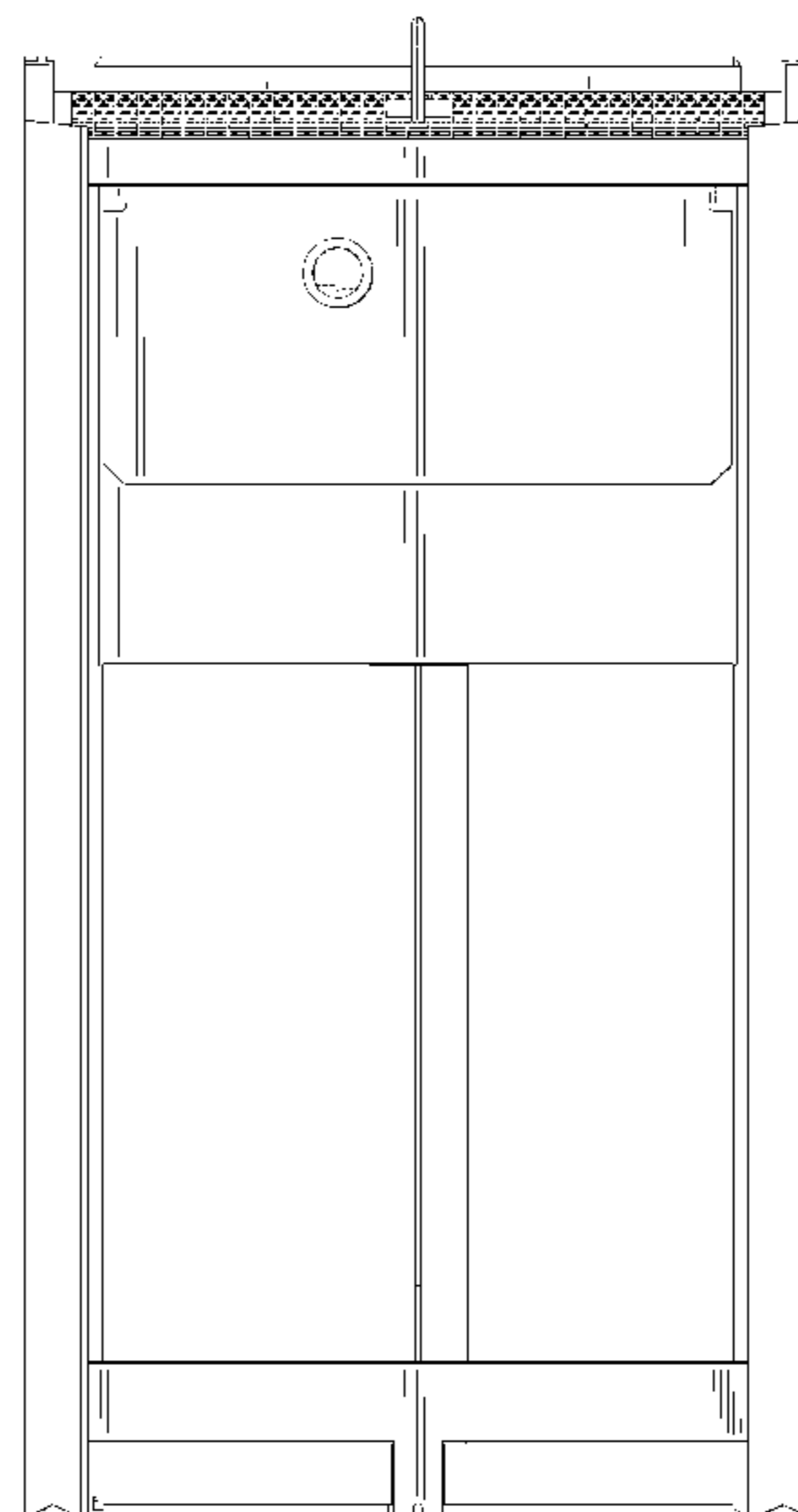
FIG. 6 is left-front isometric perspective view thereof.

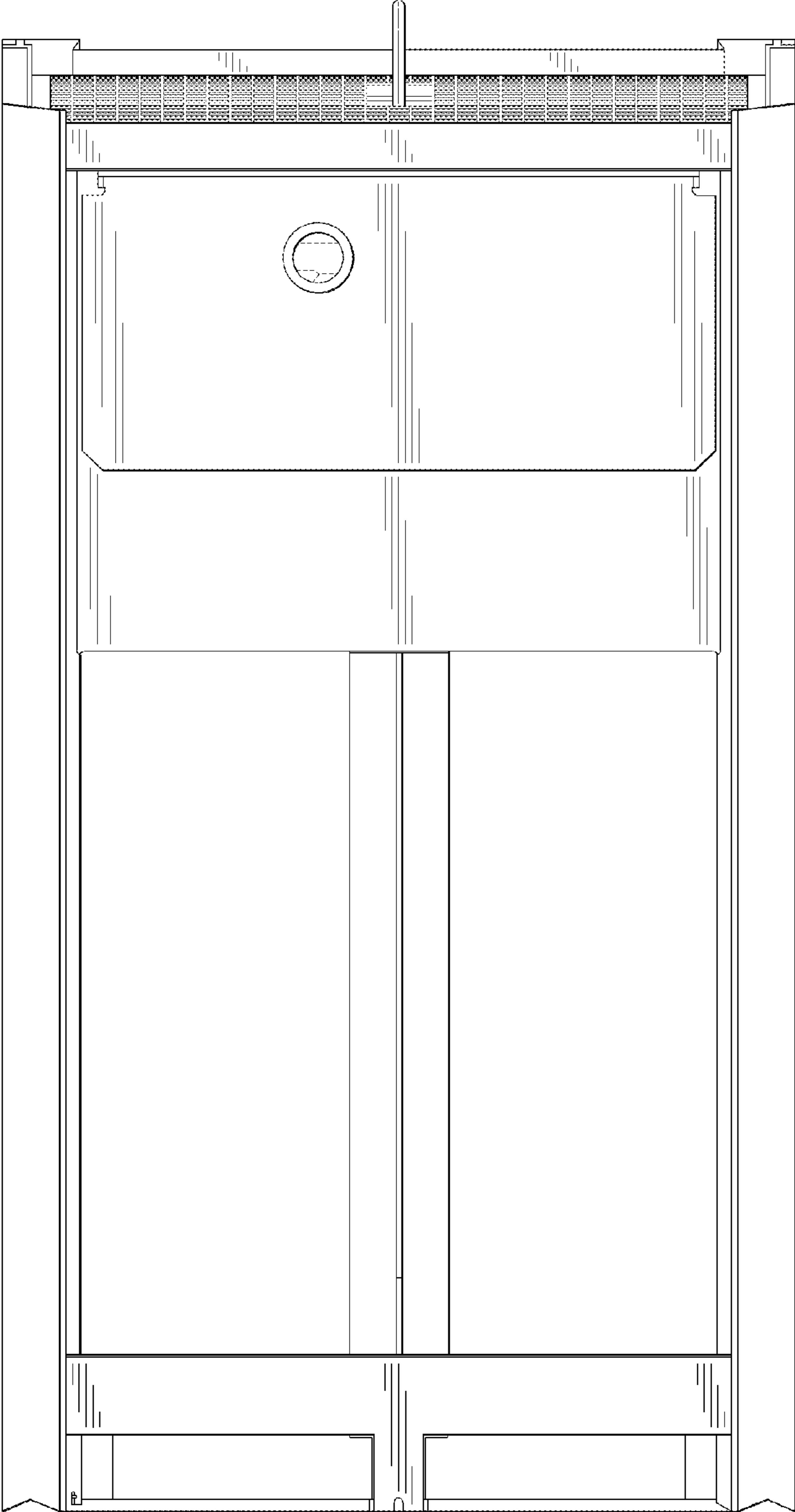

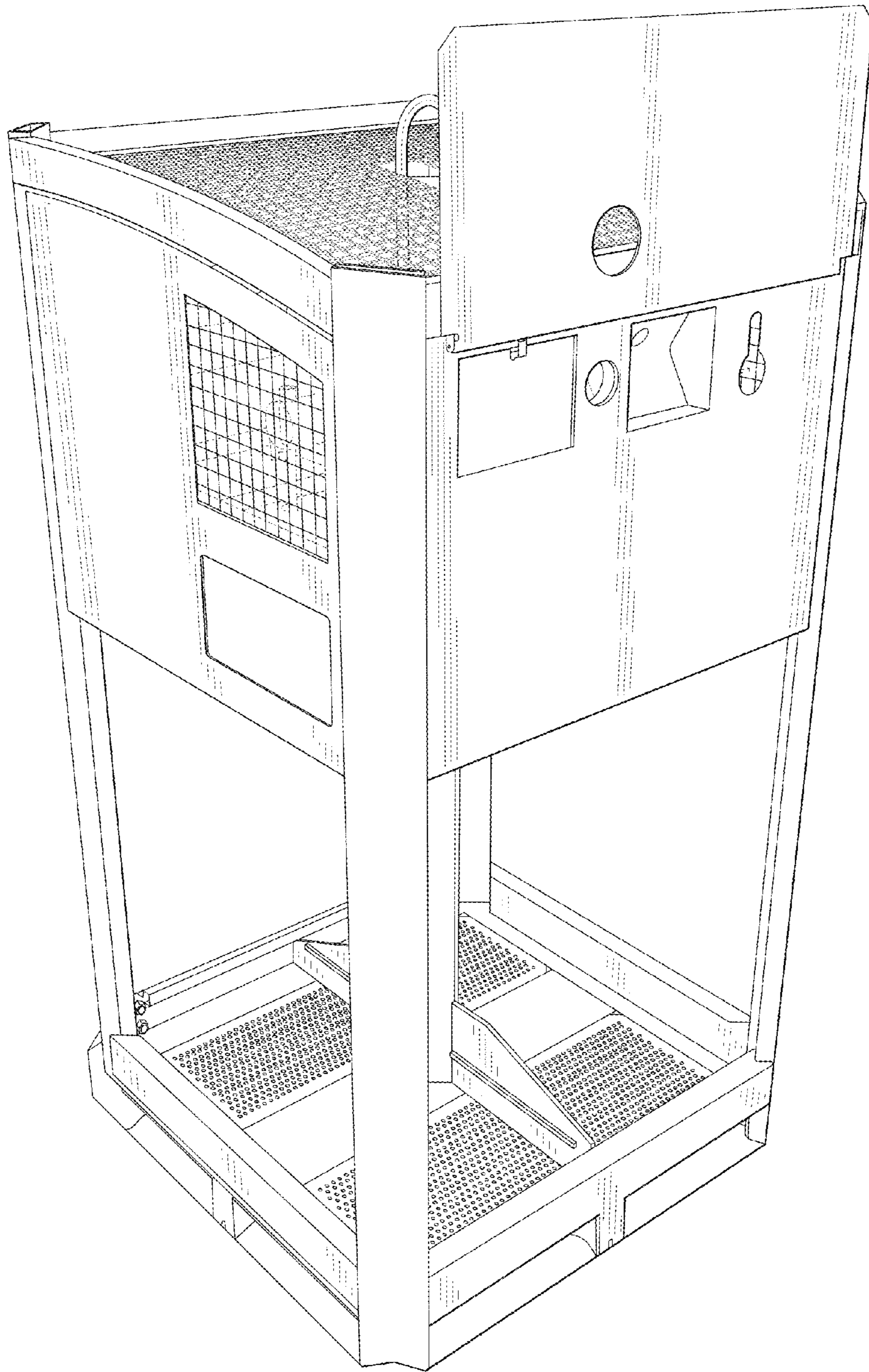

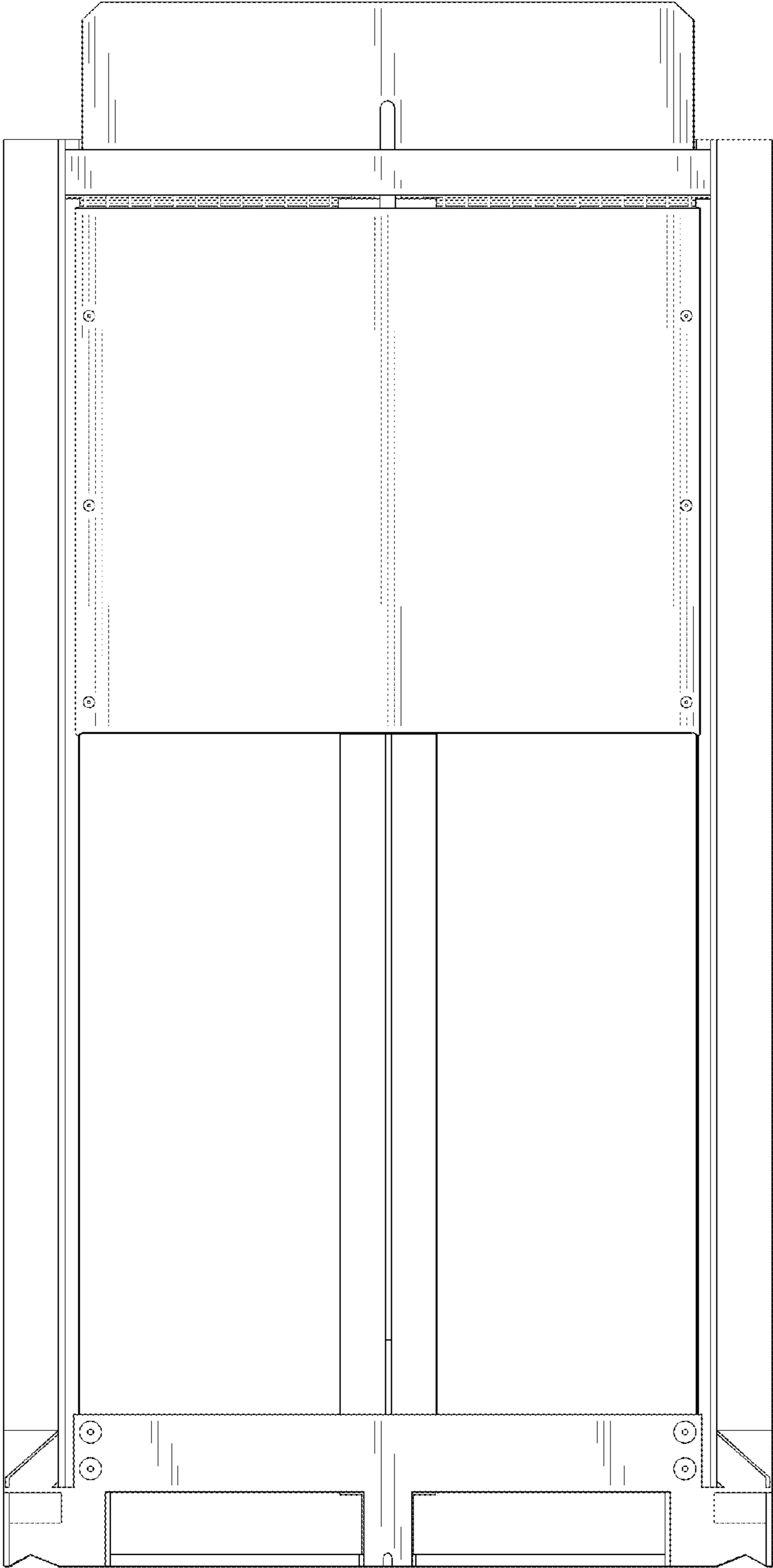

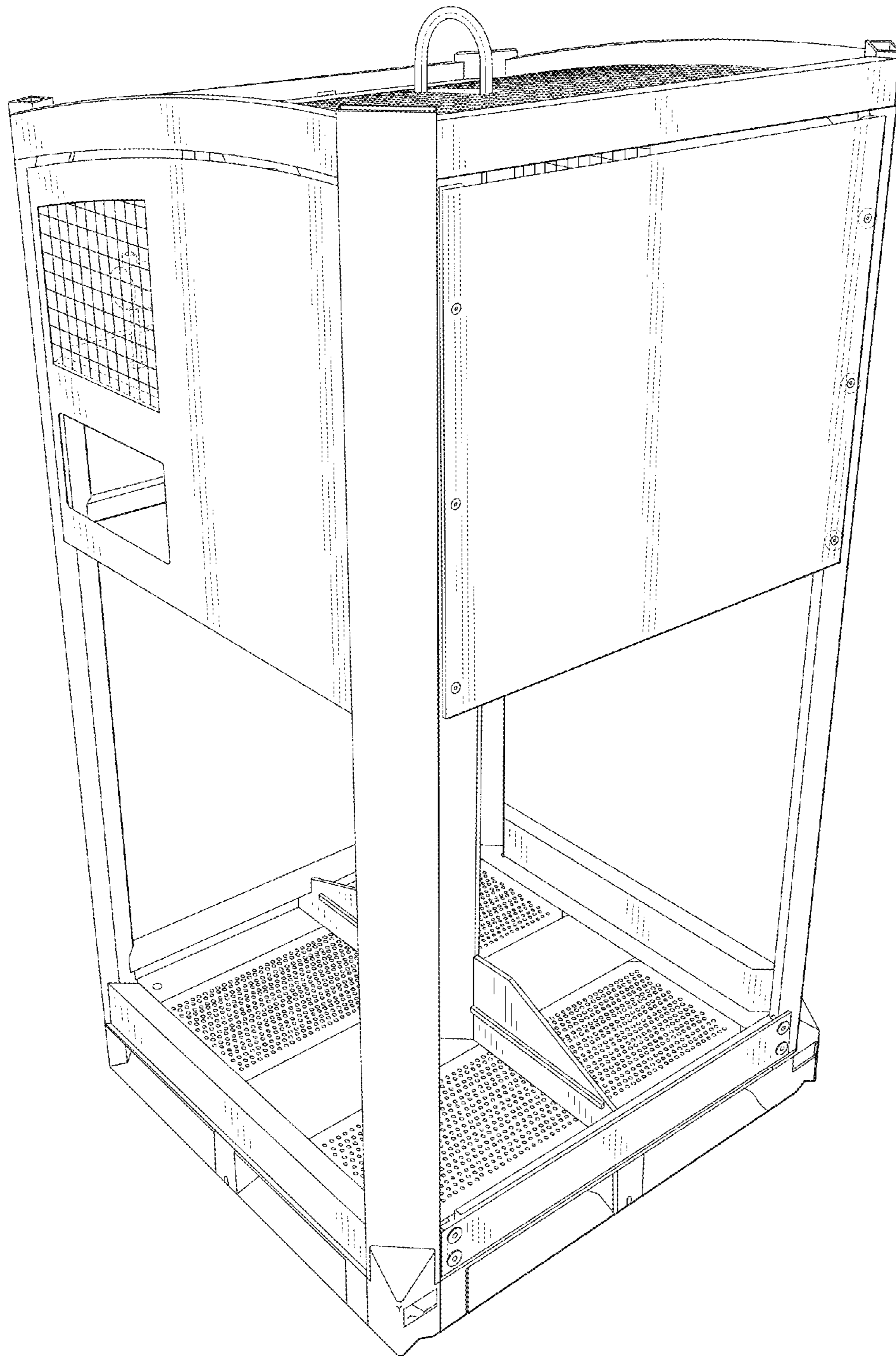

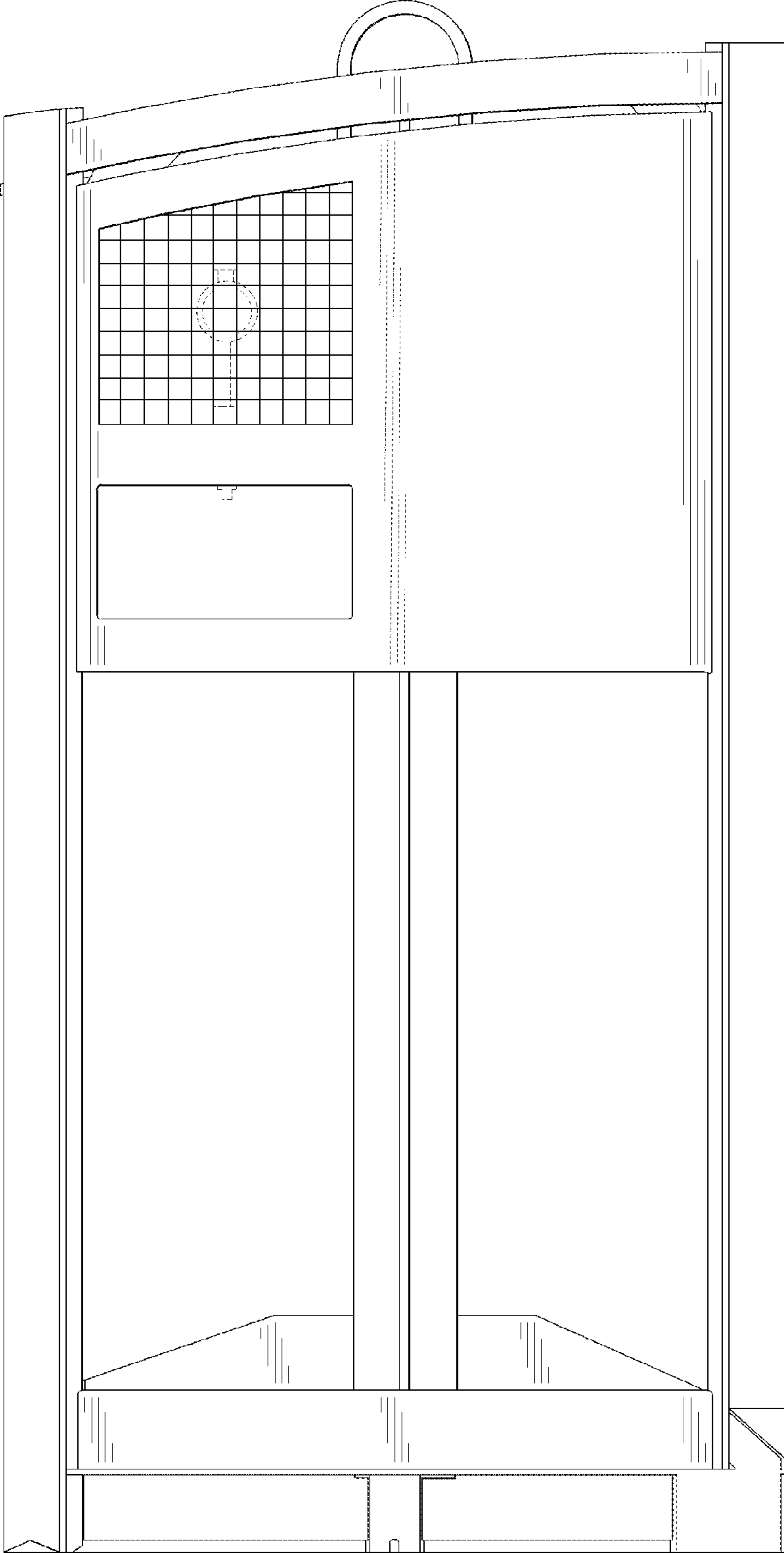

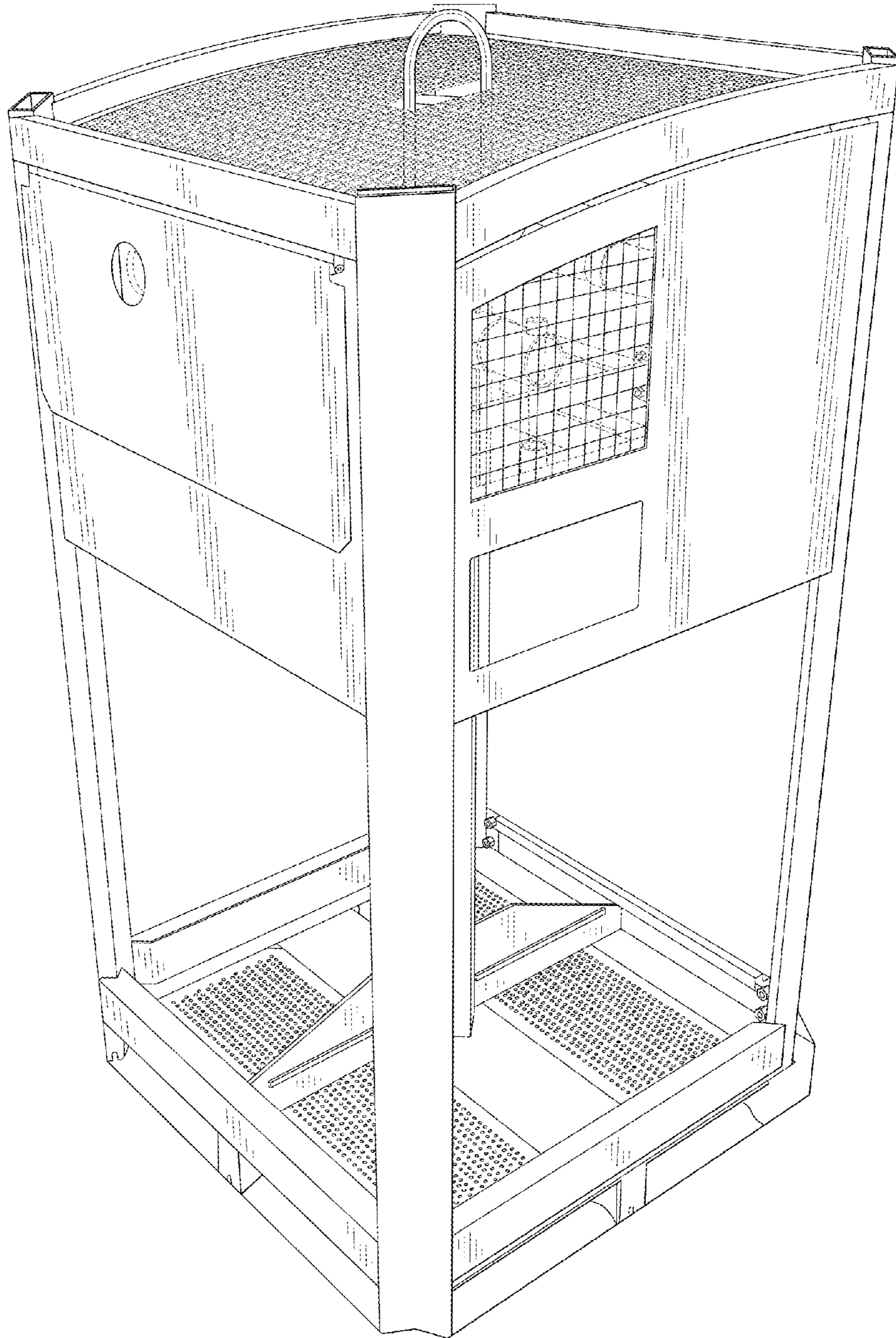
