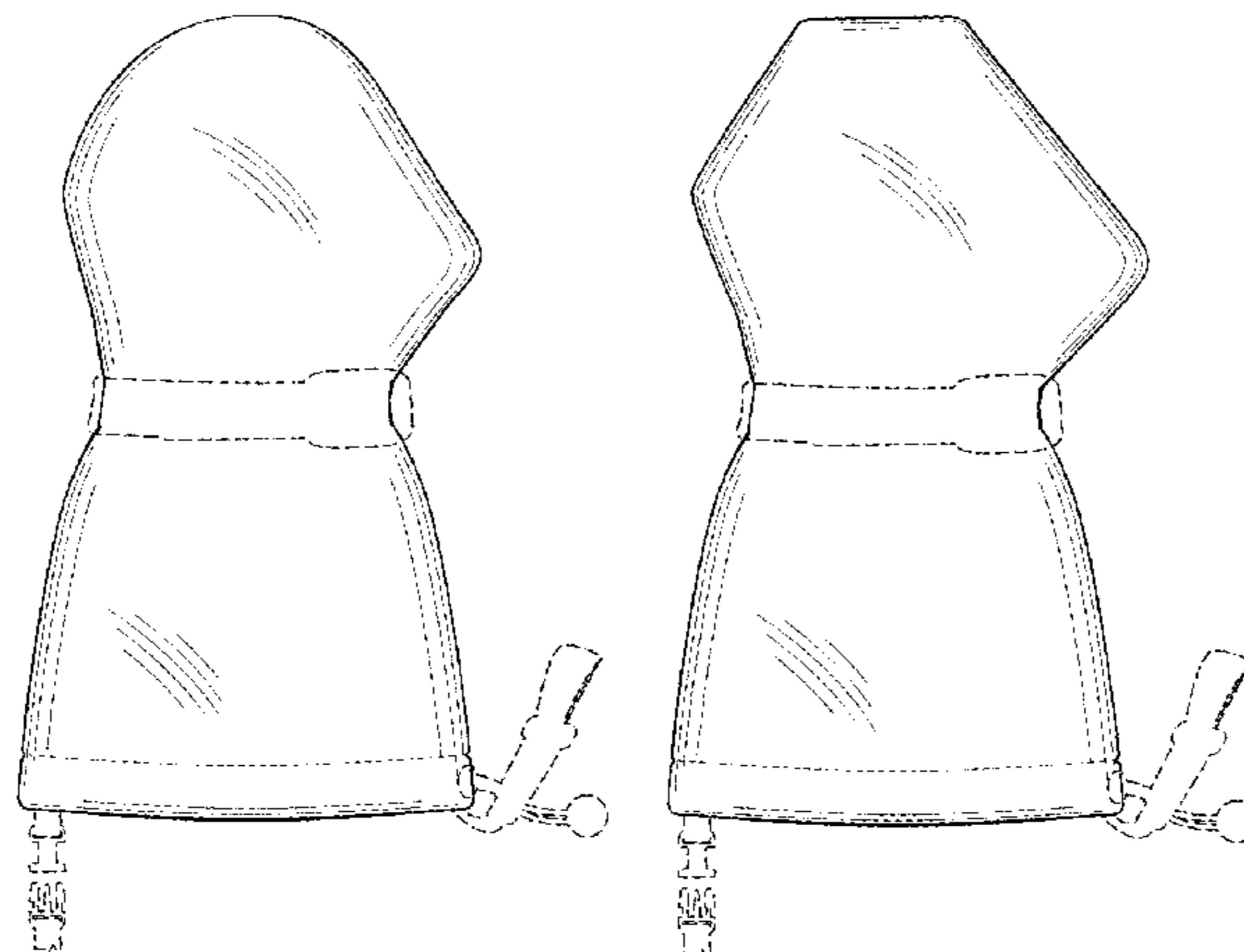
(57) **CLAIM**

I claim the ornamental design for a children's glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevation view of a first embodiment of a children's glove;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a perspective view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a rear elevation view thereof;  
FIG. 7 is a right side elevation view thereof;  
FIG. 8 is a left side elevation view of a second embodiment of a children's glove;  
FIG. 9 is a front elevation view of the embodiment of FIG. 8;  
FIG. 10 is a top plan view thereof;  
FIG. 11 is a perspective view thereof;  
FIG. 12 is a bottom plan view thereof;  
FIG. 13 is a rear elevation view thereof; and,  
FIG. 14 is a right side elevation view thereof.

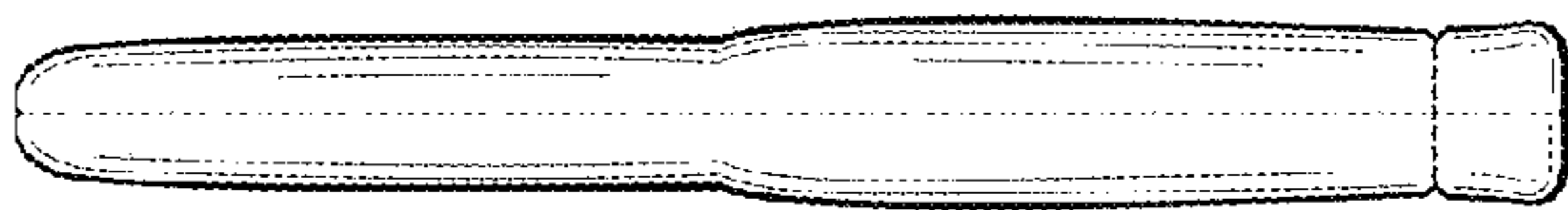

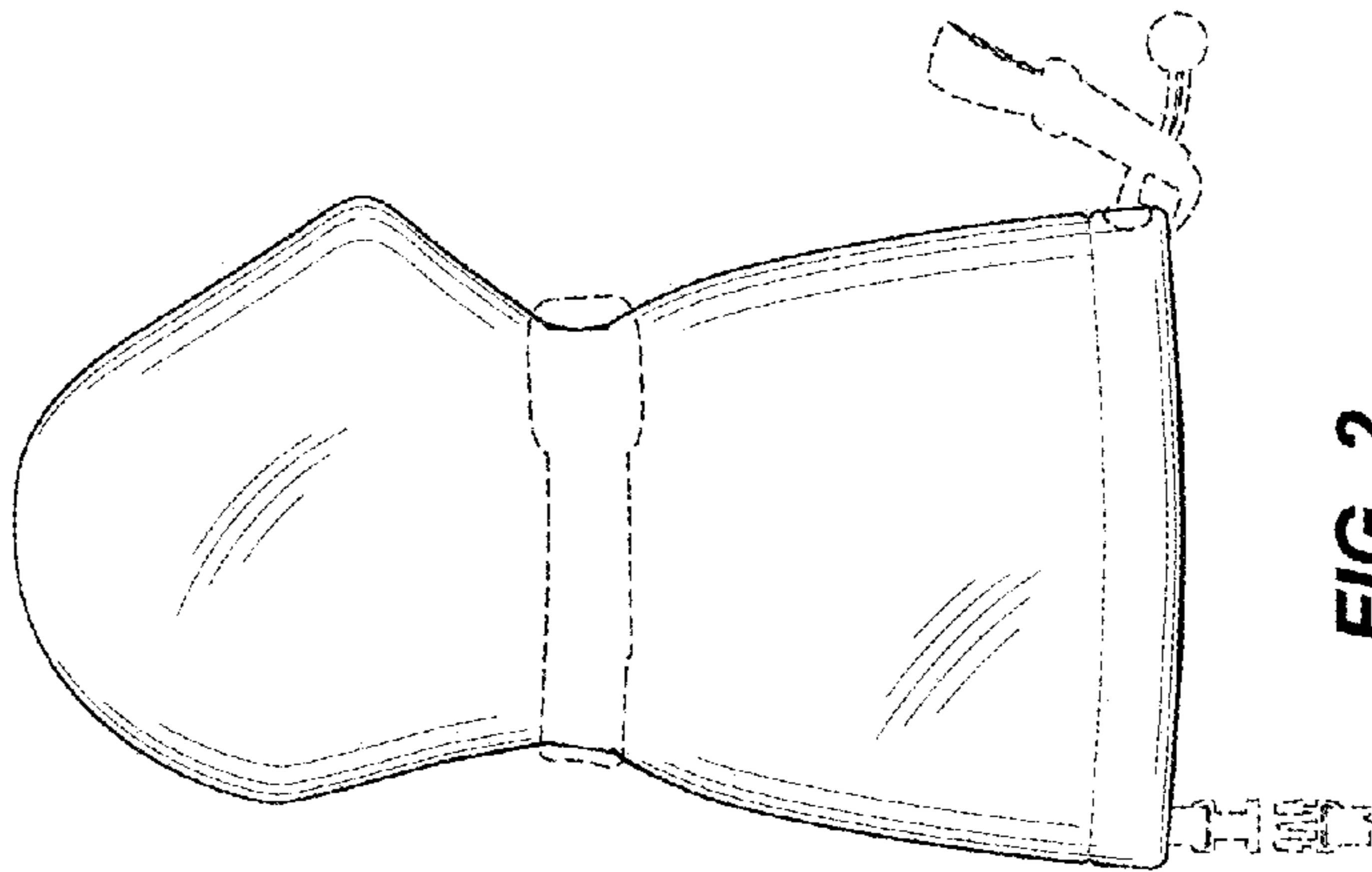

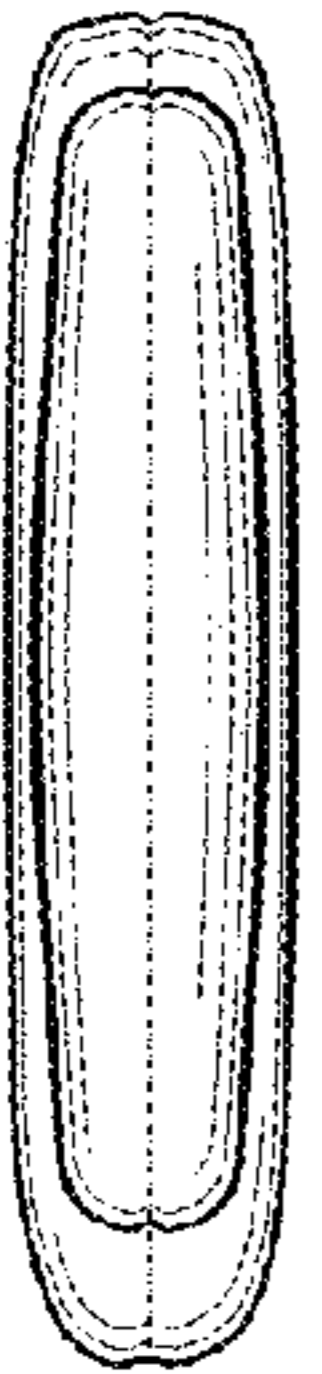

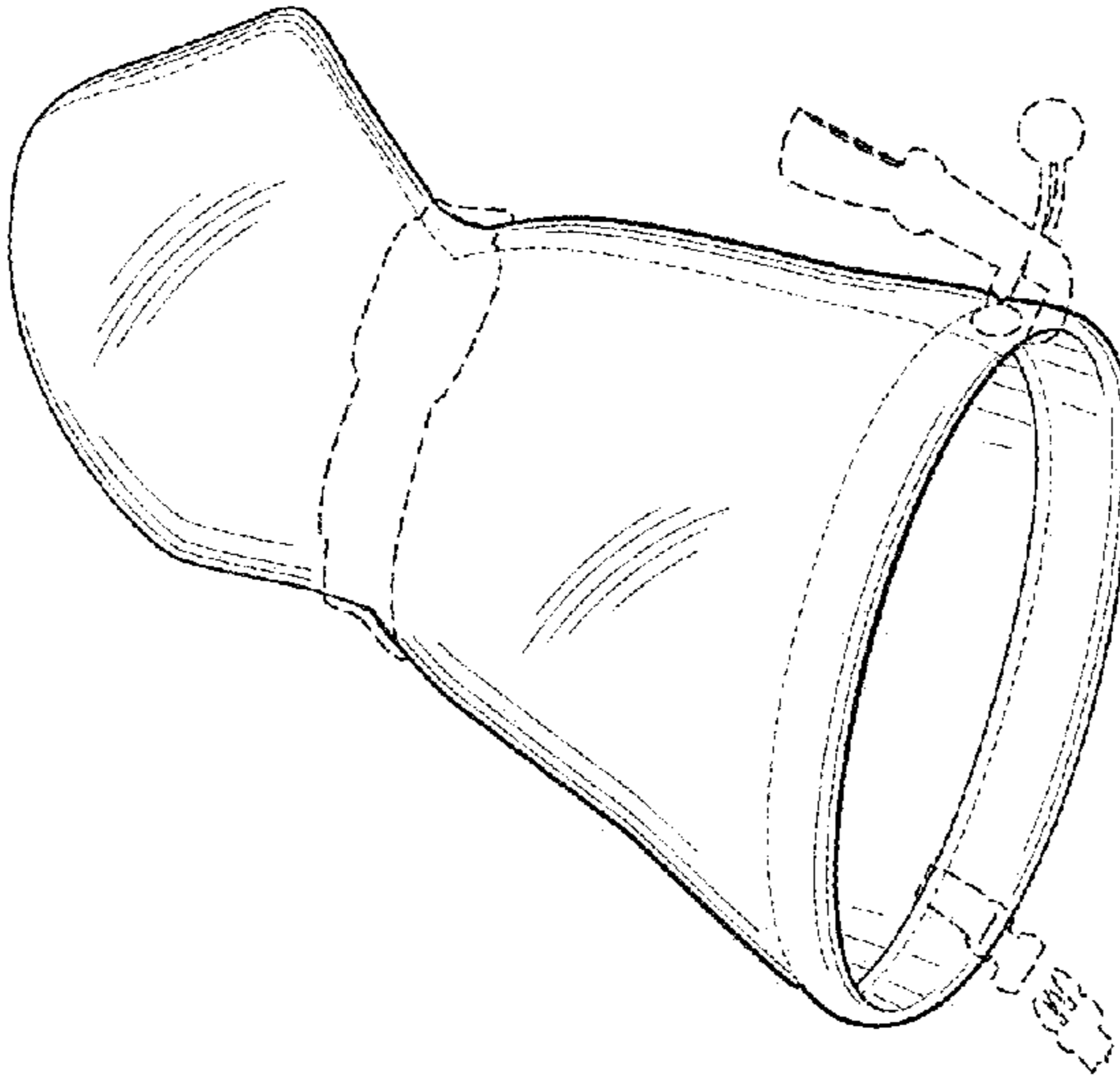

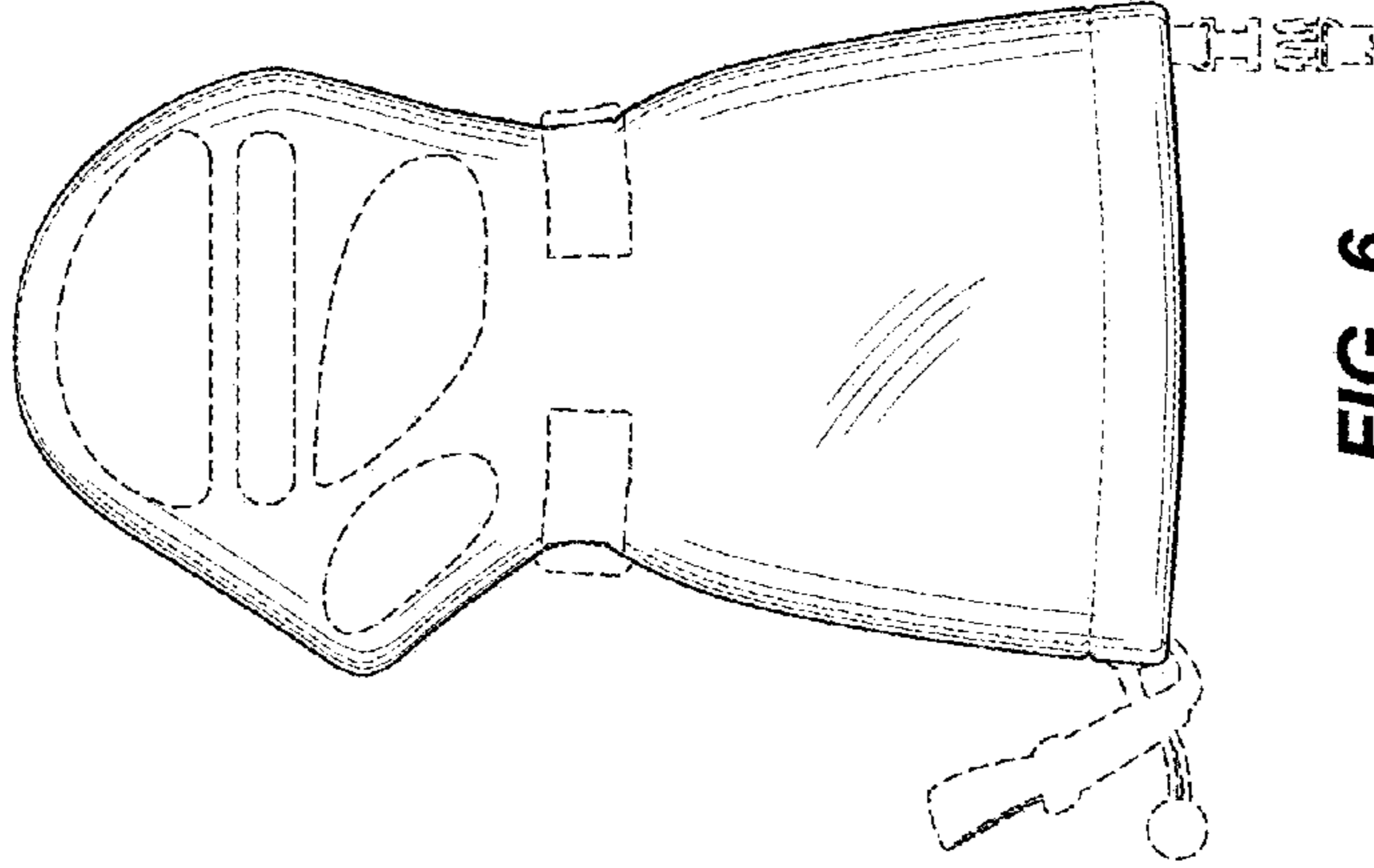

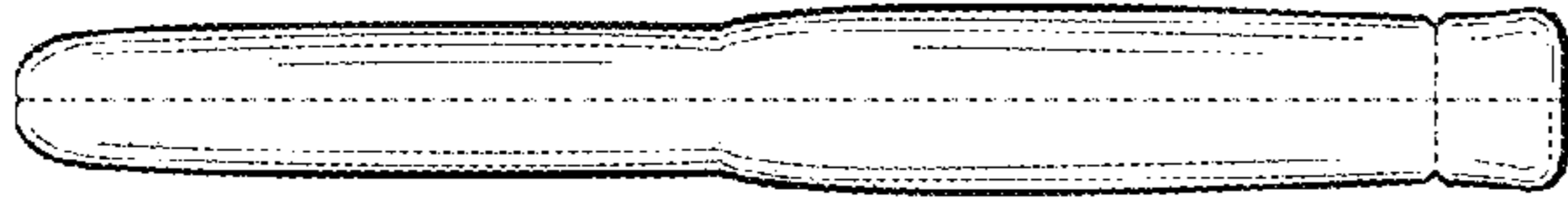

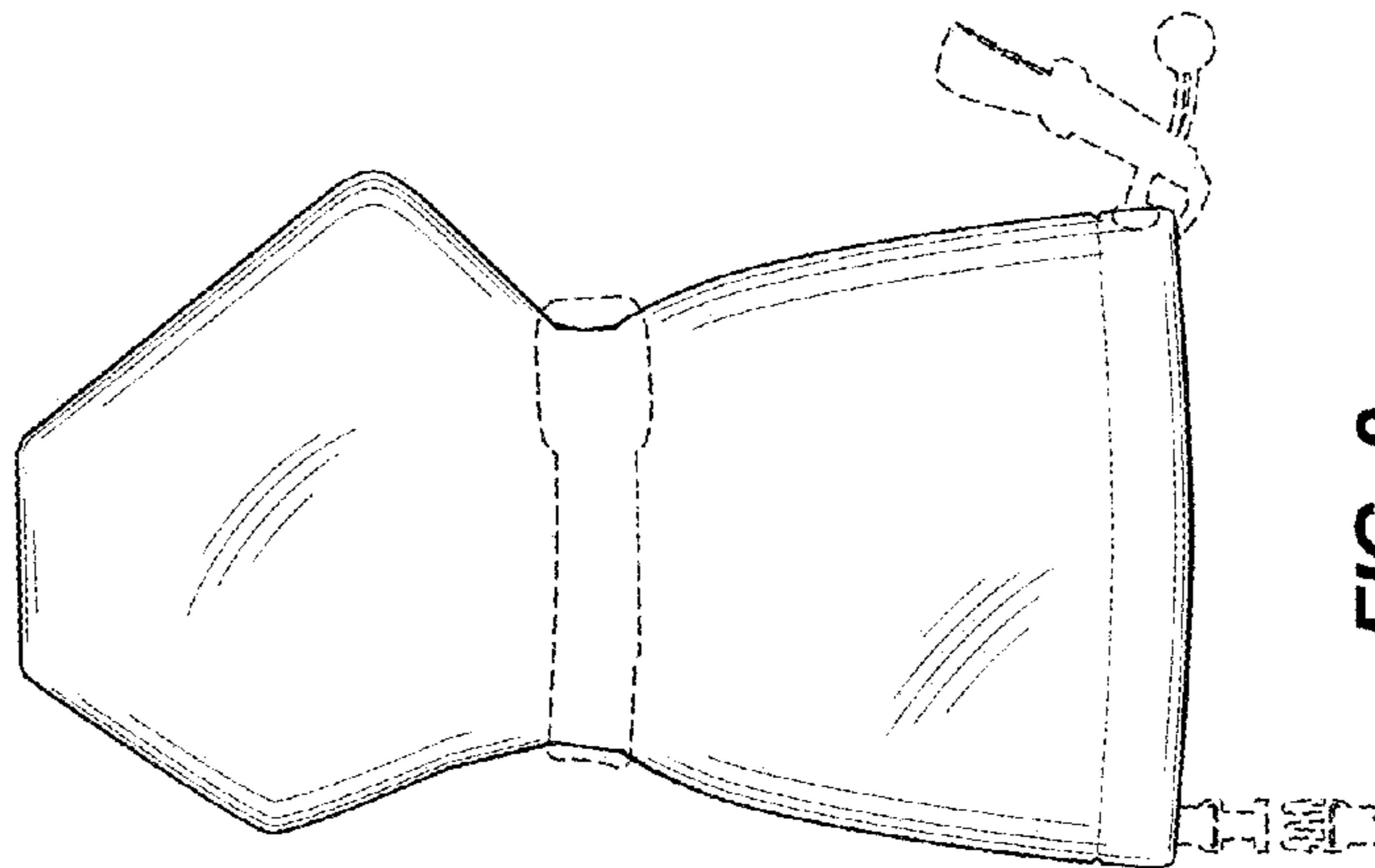

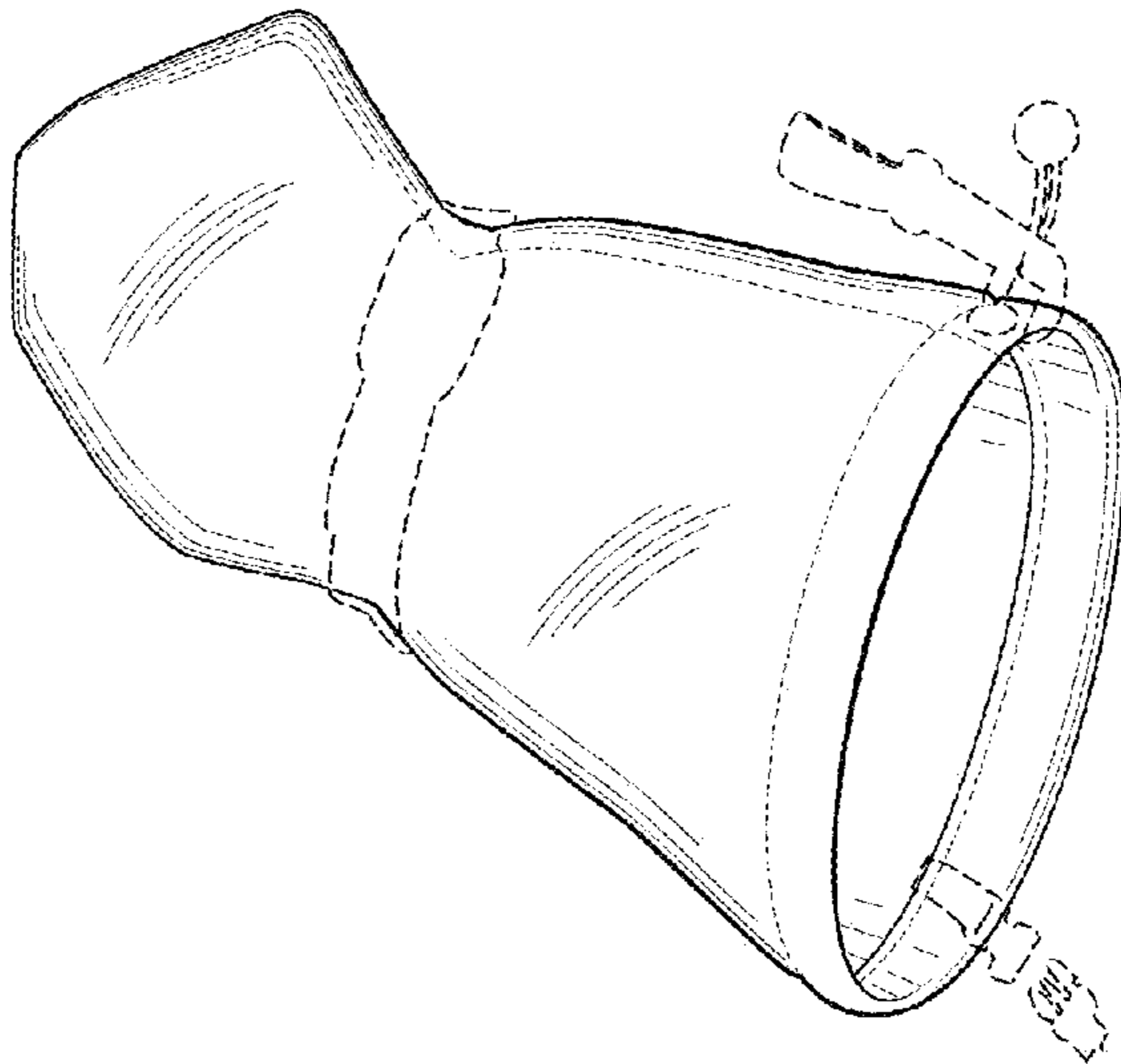

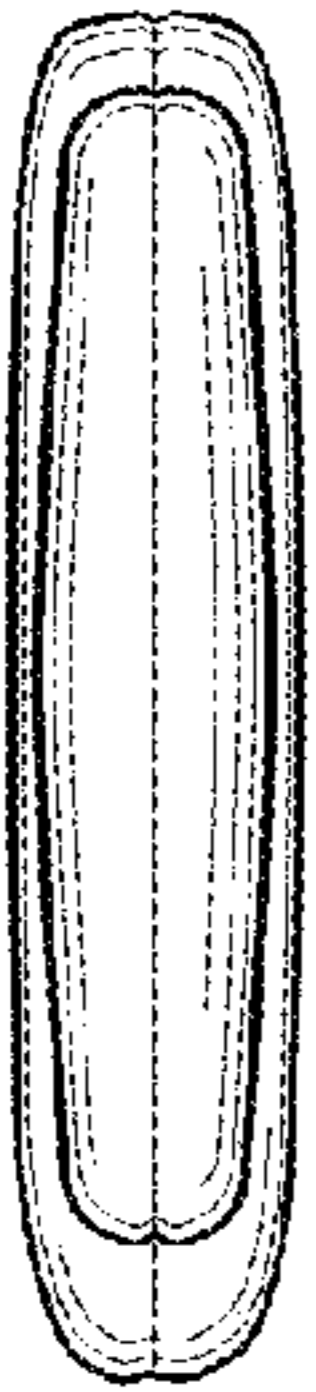

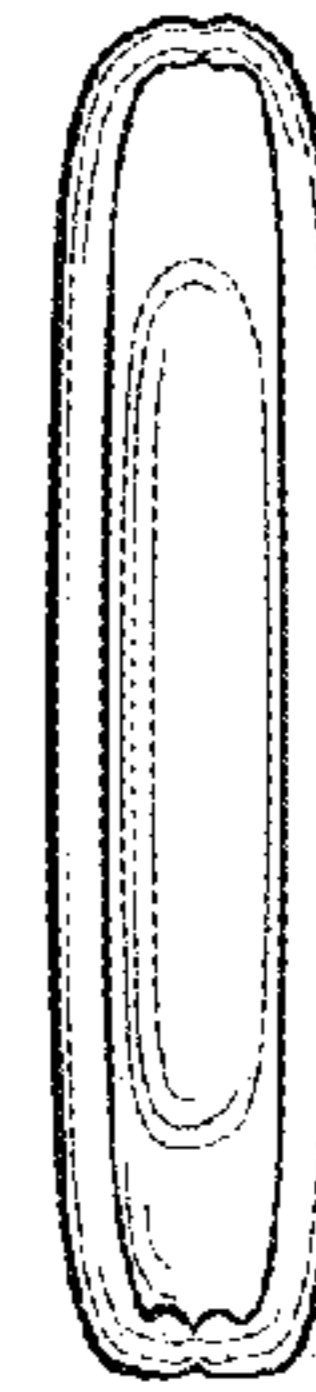

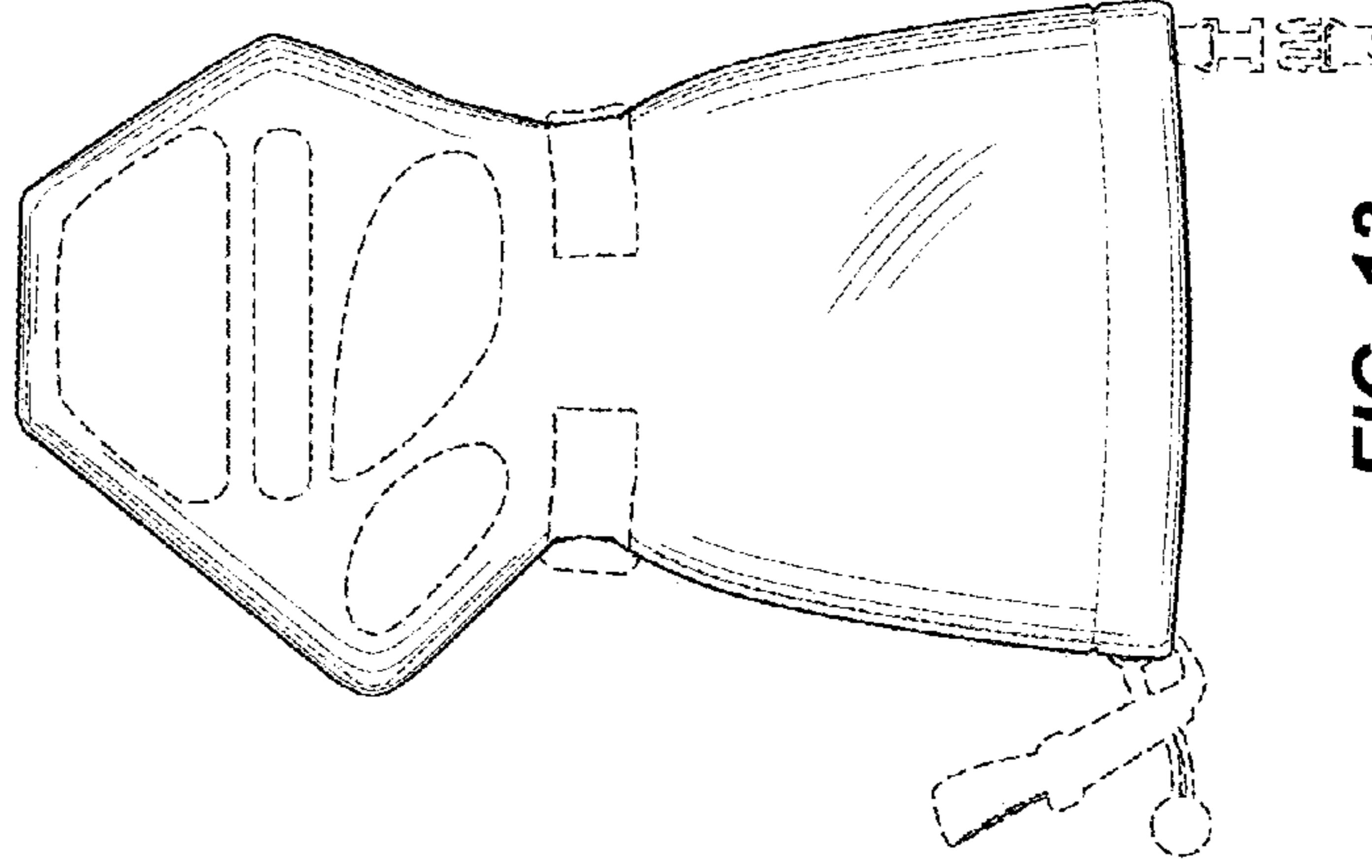

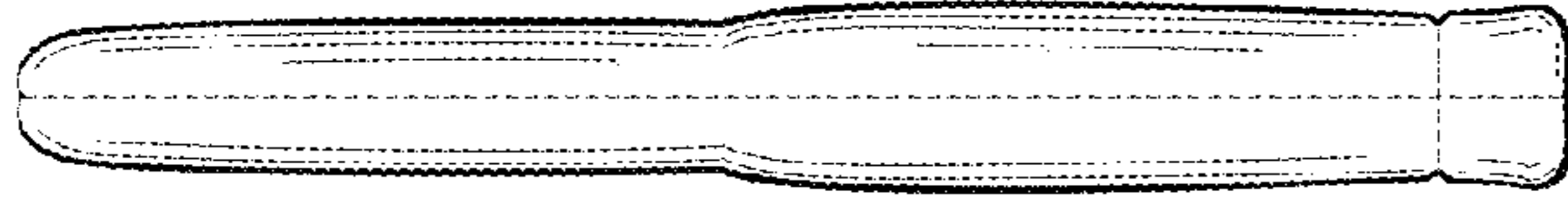
