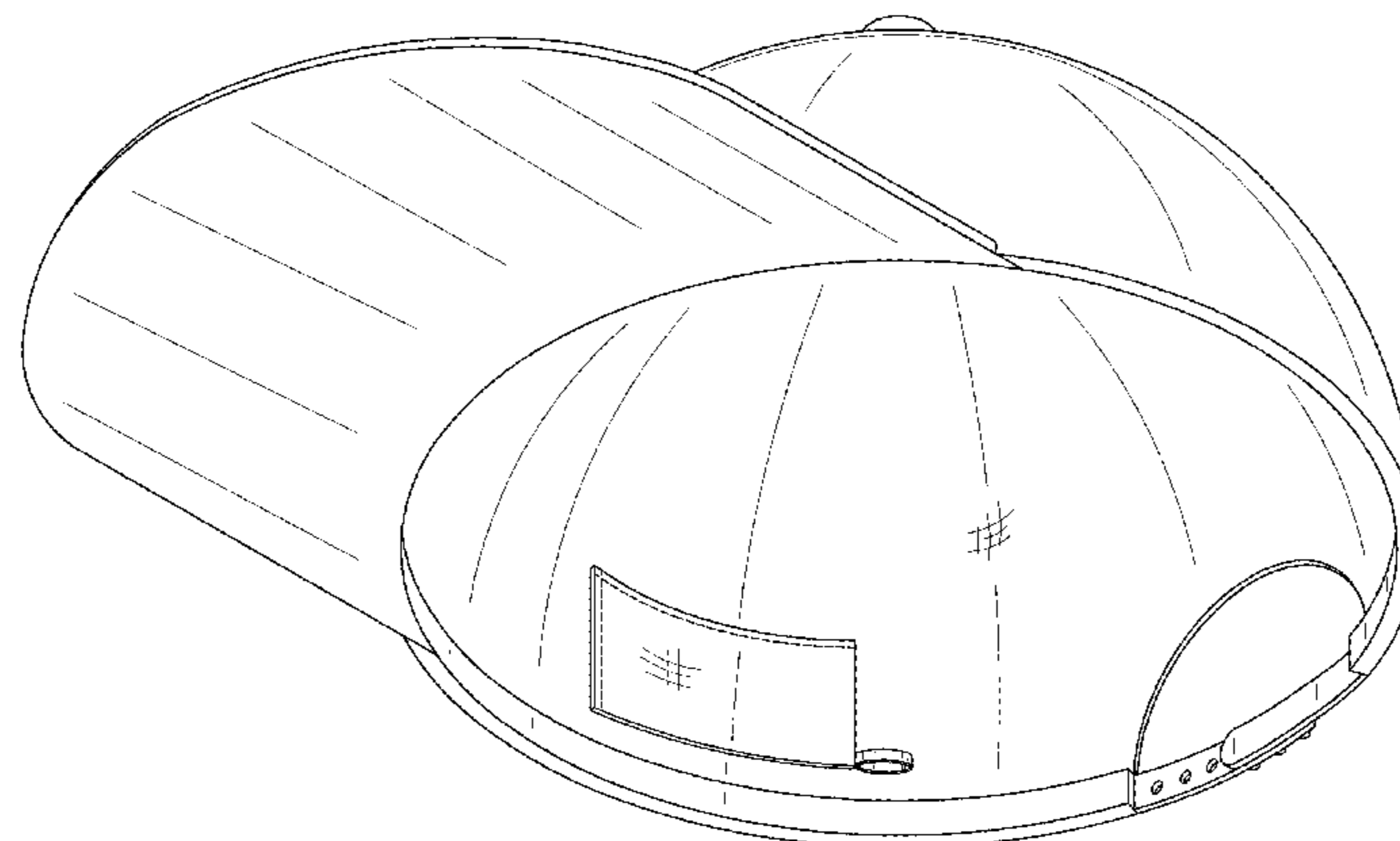
(57) **CLAIM**

The ornamental design for a hat with waterproof storage pocket, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevation view of a Hat With Waterproof Storage Pocket showing my new design; FIG. 2 is a right side elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is an isometric view thereof; and, FIG. 8 is a bottom isometric view. The dashed lines in FIGS. 1, 3, 4, 5, 6, 7 and 8 of the drawings depict stitches which form a part of the claimed design.

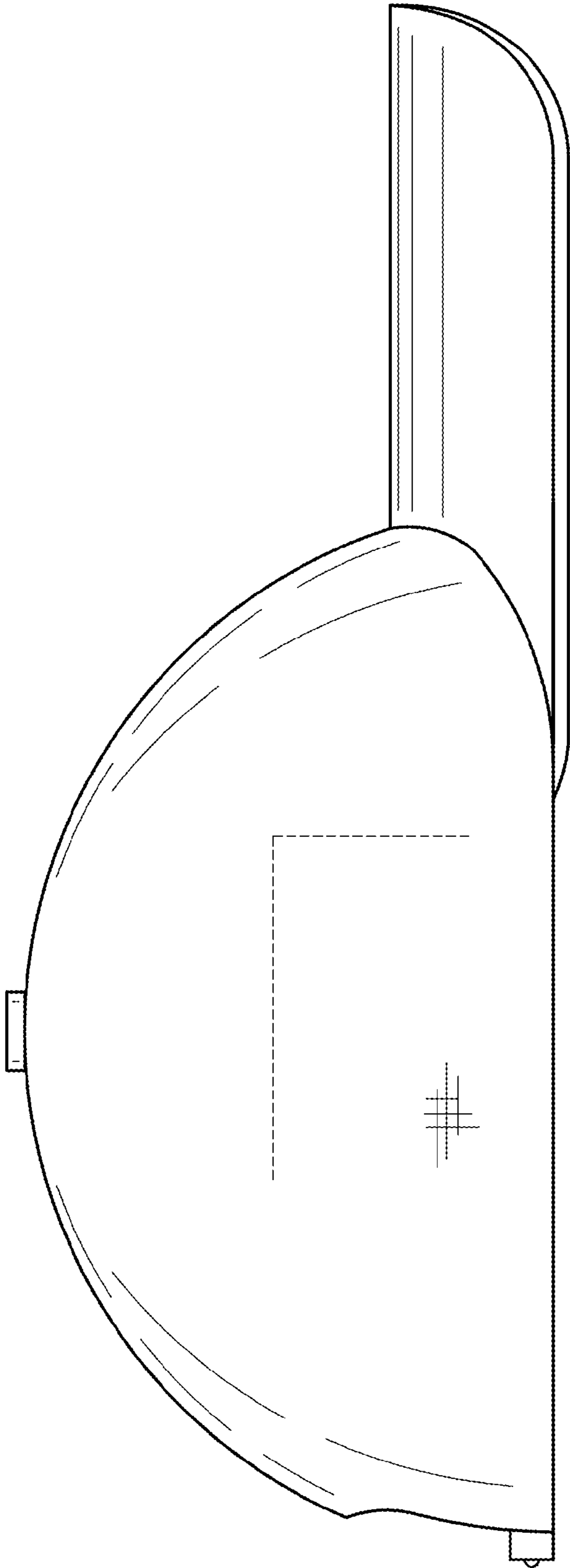

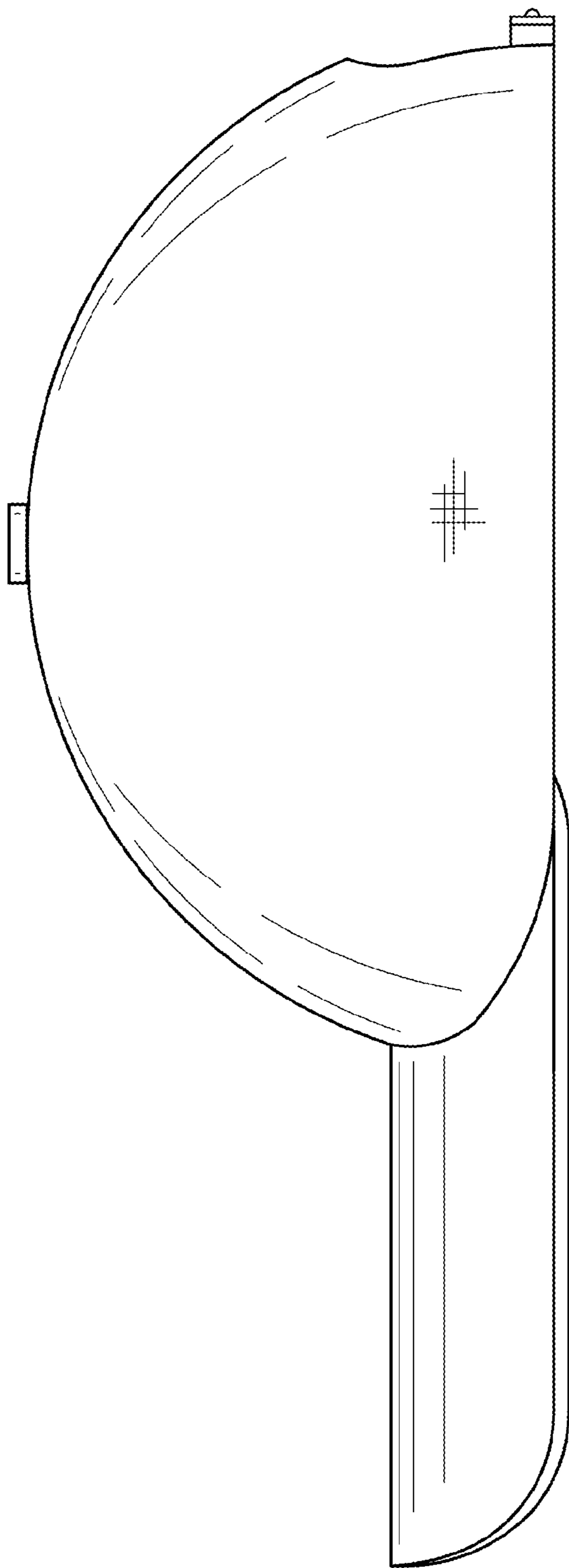

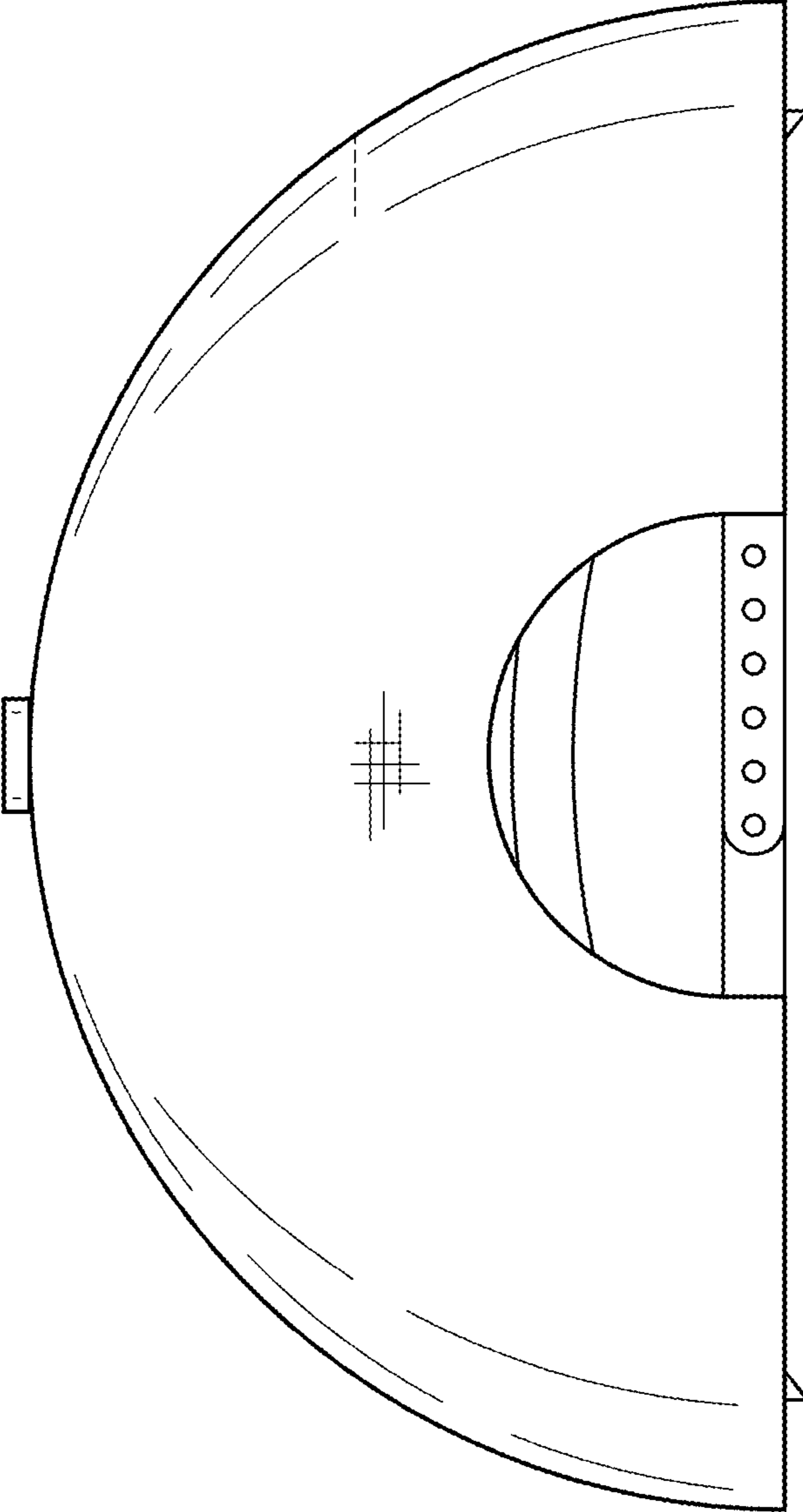

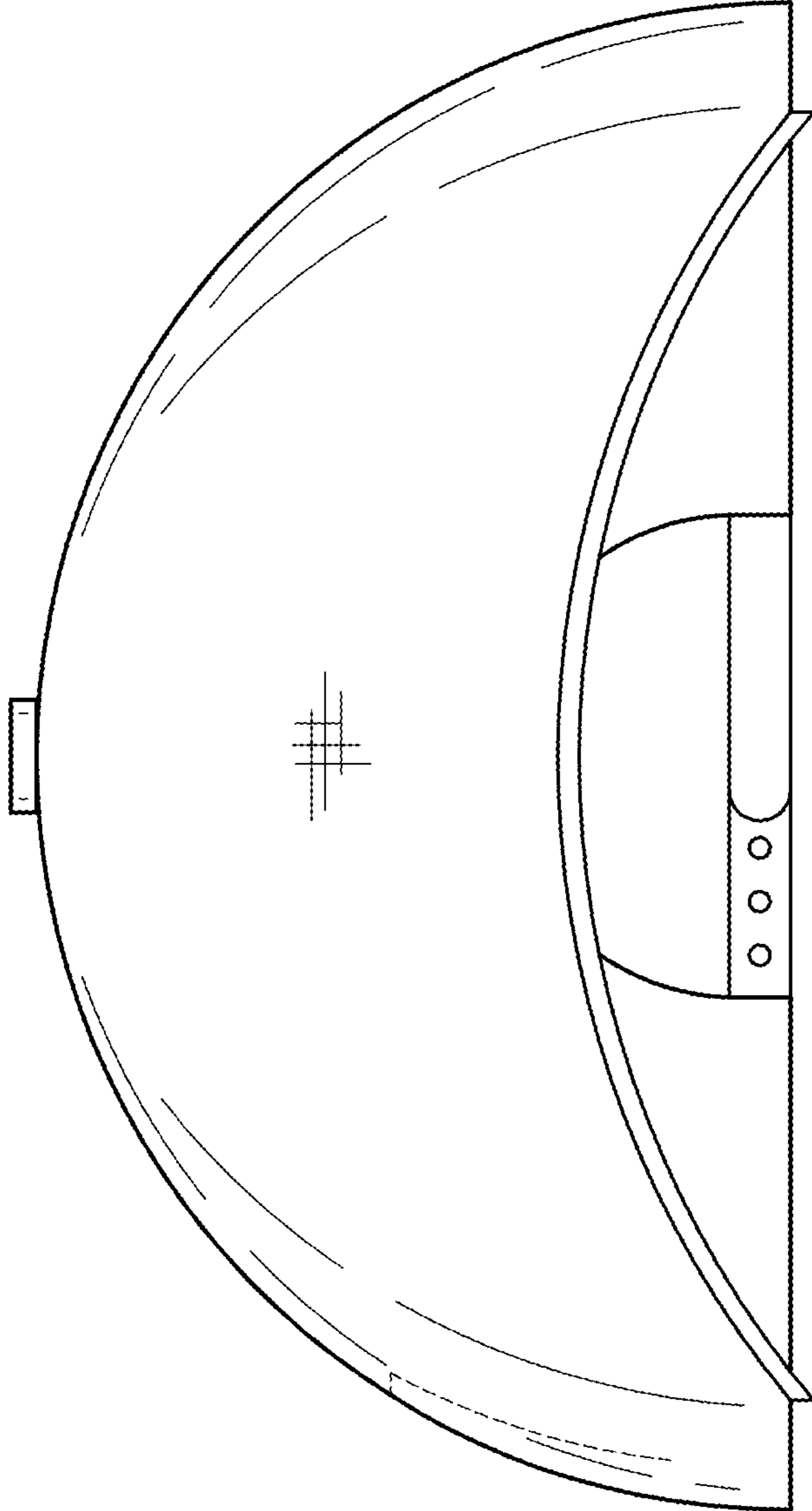

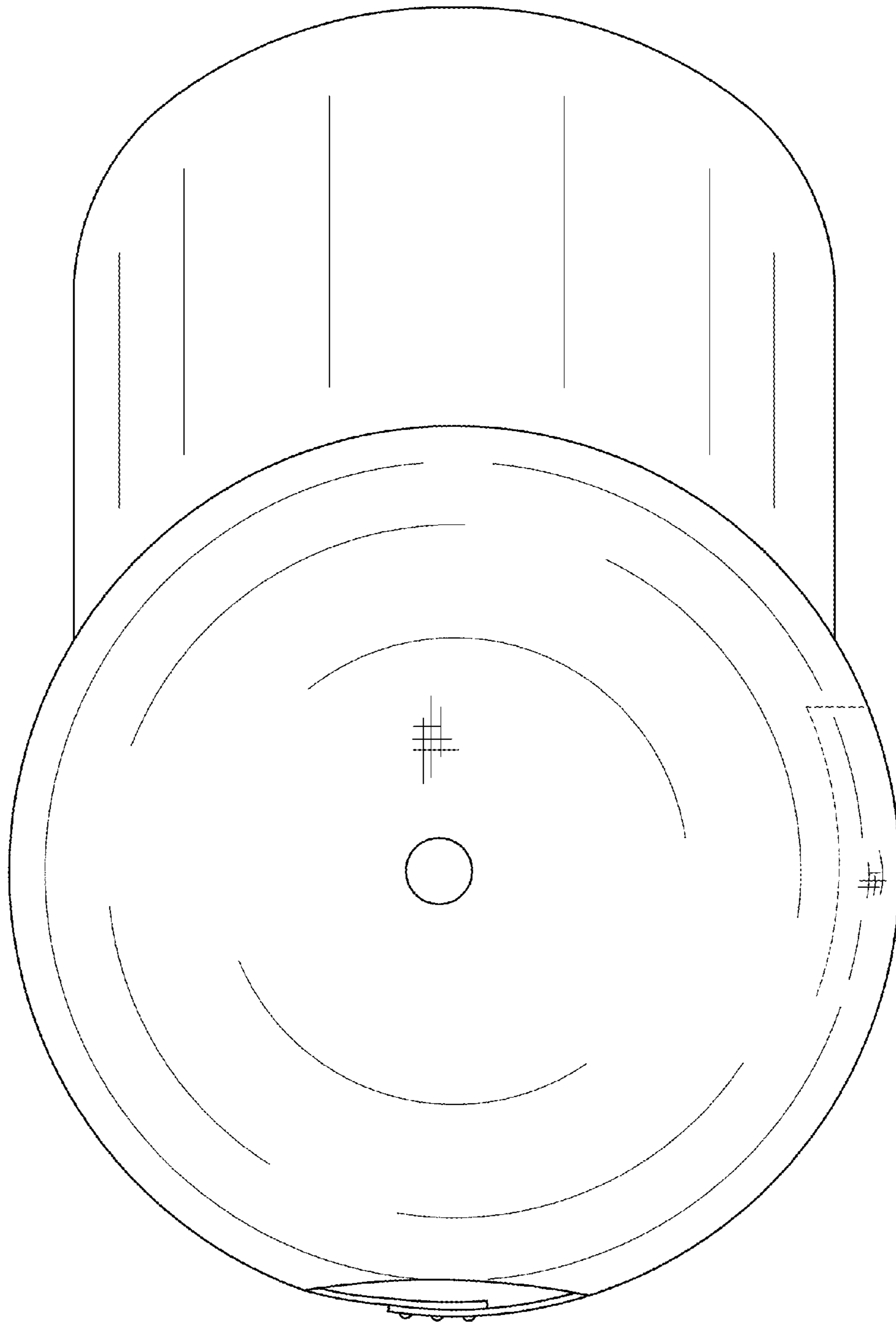

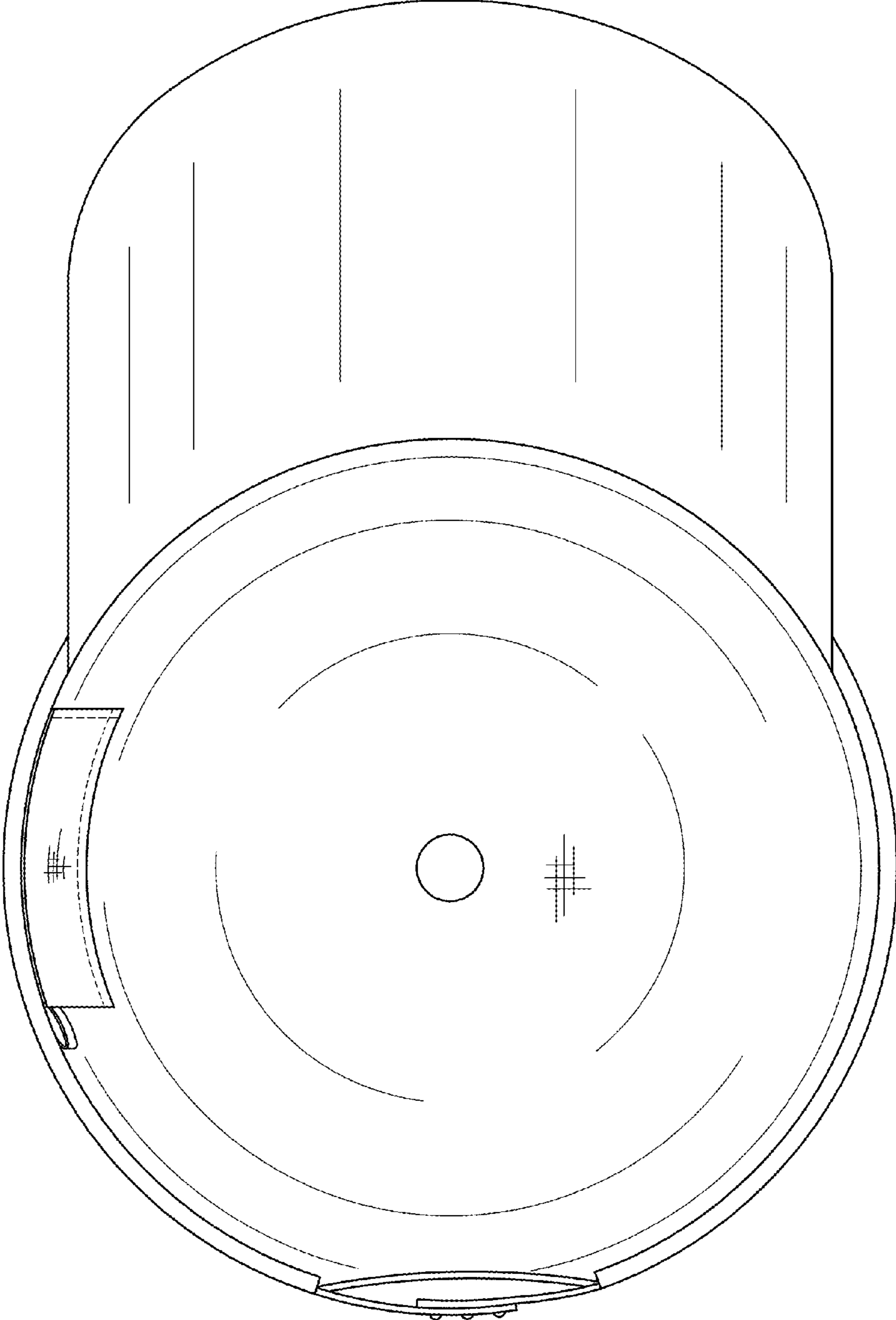

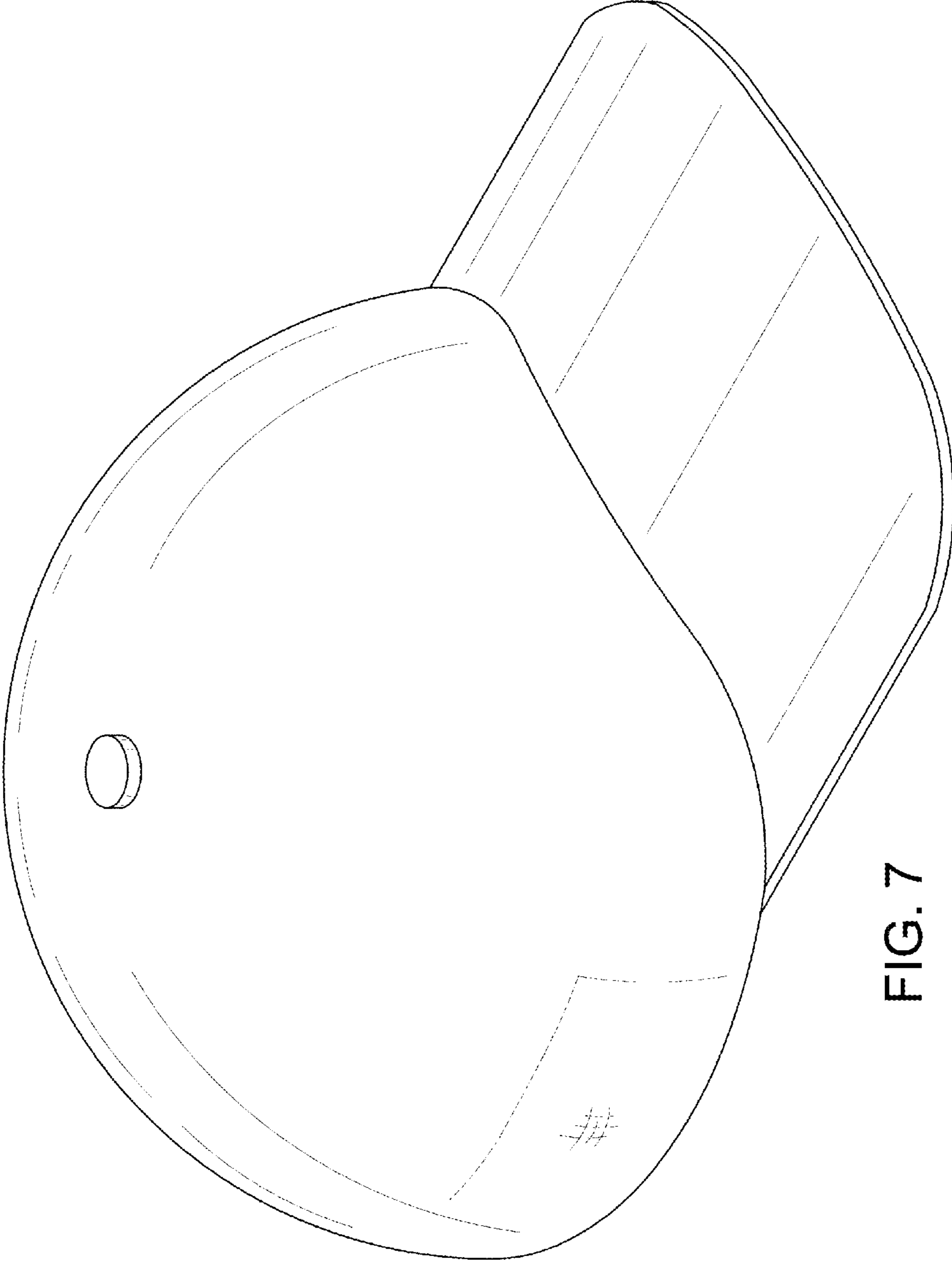

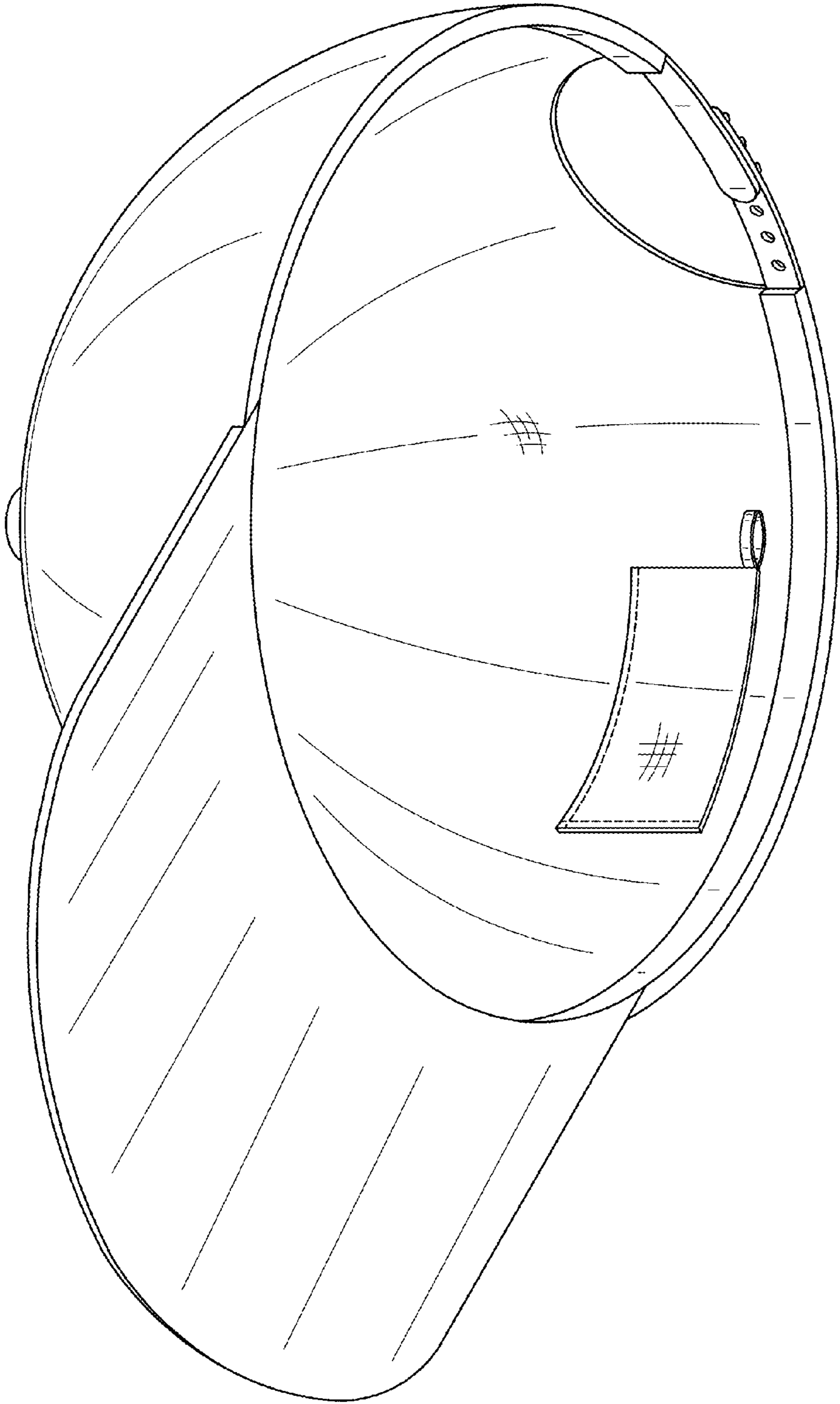
