The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe showing my new design; FIG. 2 is a left side view of a shoe showing my new design; FIG. 3 is a right side view of a shoe showing my new design; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a top plan view thereof.

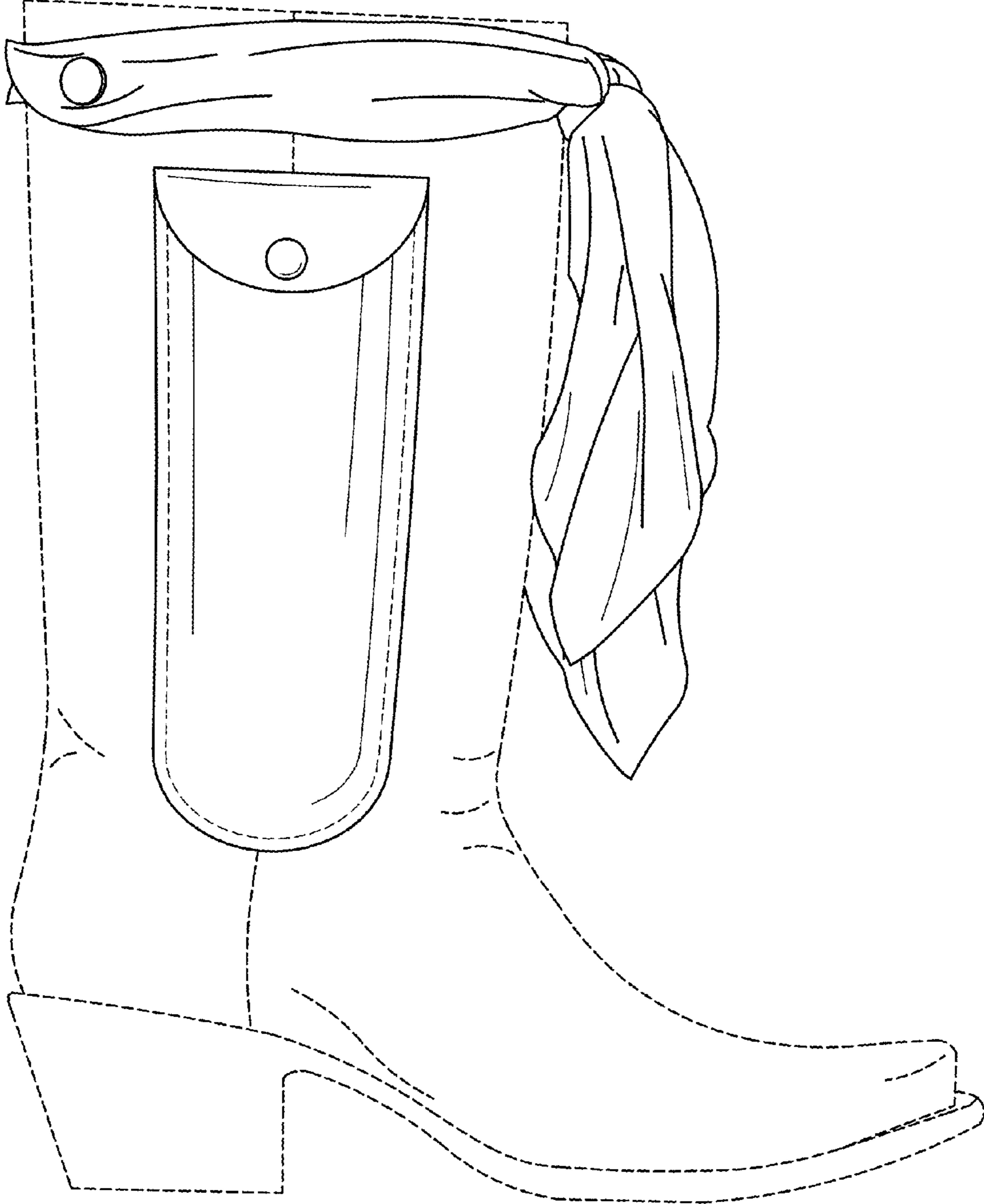

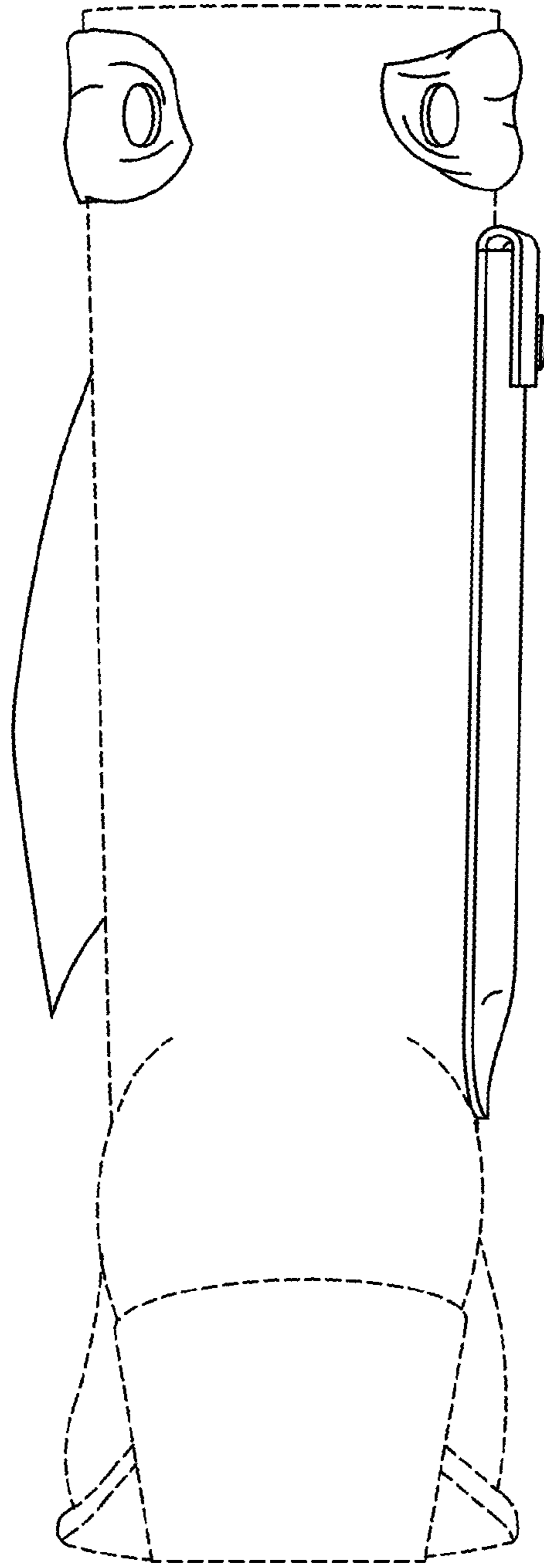

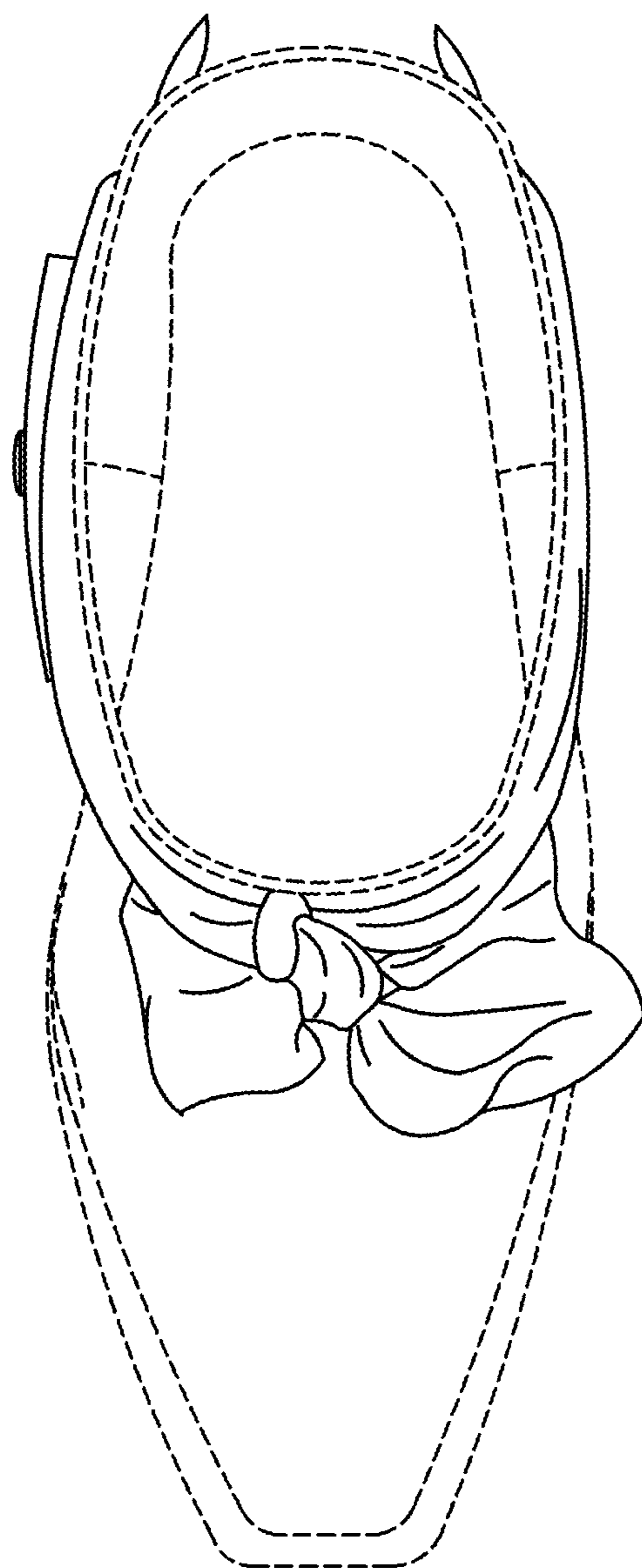
