The ornamental design for a coffin purse bag, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of the coffin purse bag showing my design;
 FIG. 2 is a second perspective view of the coffin purse bag shown in FIG. 1;
 FIG. 3 is a top-side perspective view of the coffin purse bag shown in FIG. 1;
 FIG. 4 is an enlarged top-front perspective view of the coffin purse bag shown in FIG. 1;
 FIG. 5 is a first top-side perspective view of the coffin purse bag shown in FIG. 1;
 FIG. 6 is a second top-side perspective view of the coffin purse bag shown in FIG. 1;
 FIG. 7 is a third top-side perspective view of the coffin purse bag shown in FIG. 1;
 FIG. 8 top perspective view of the coffin purse bag shown in FIG. 1; and,

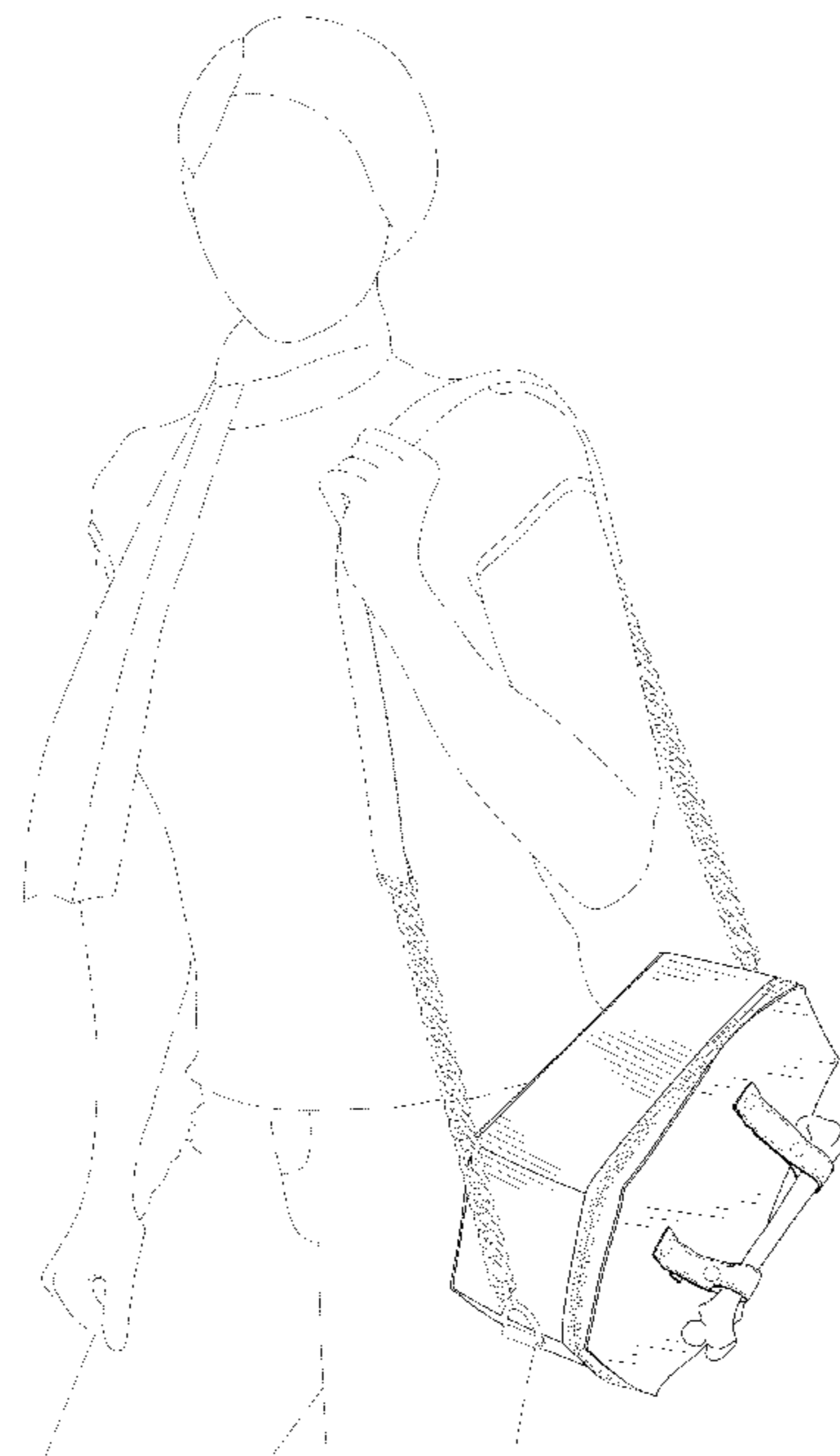

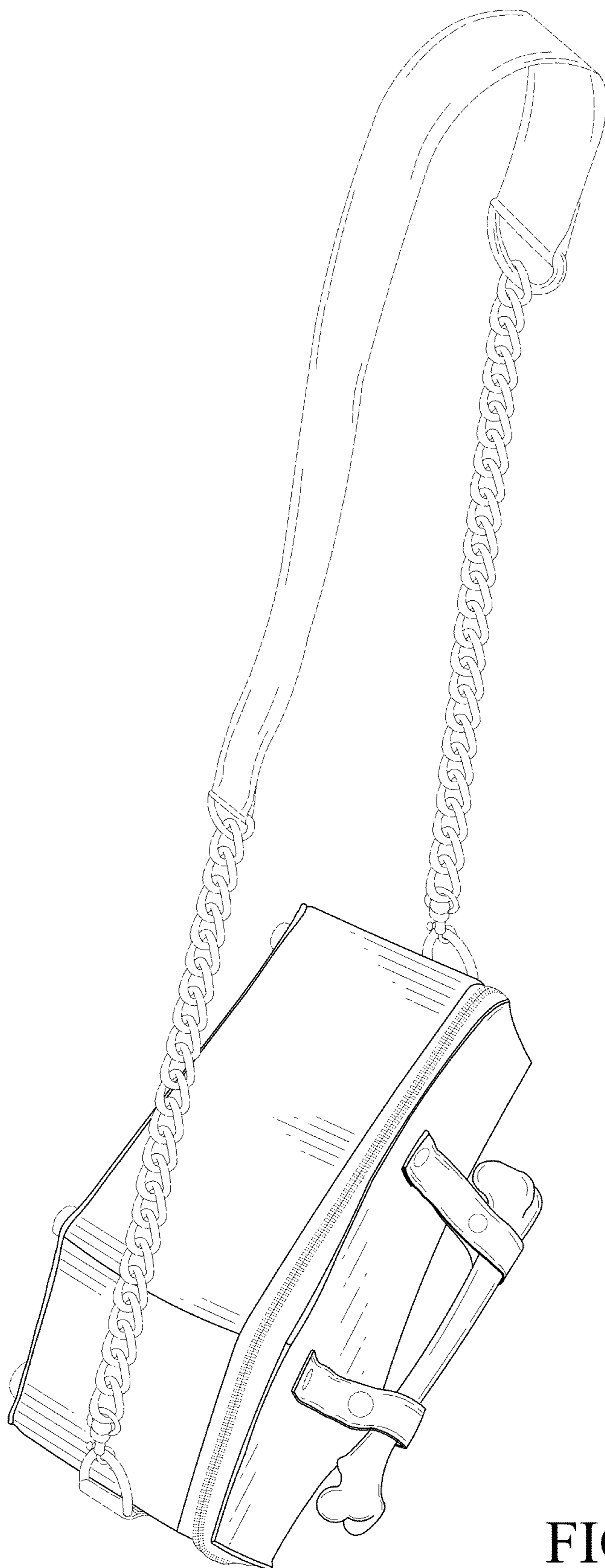

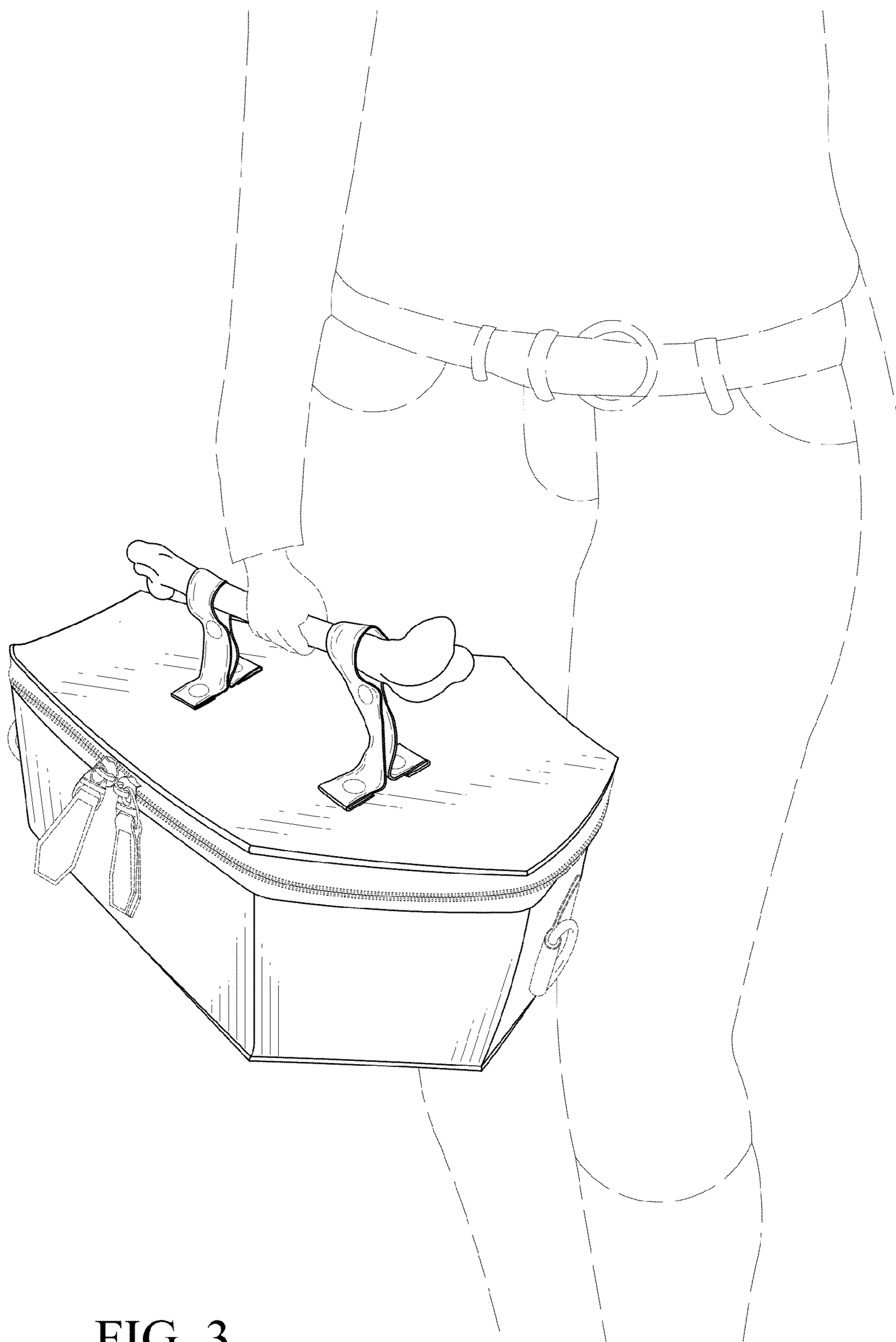

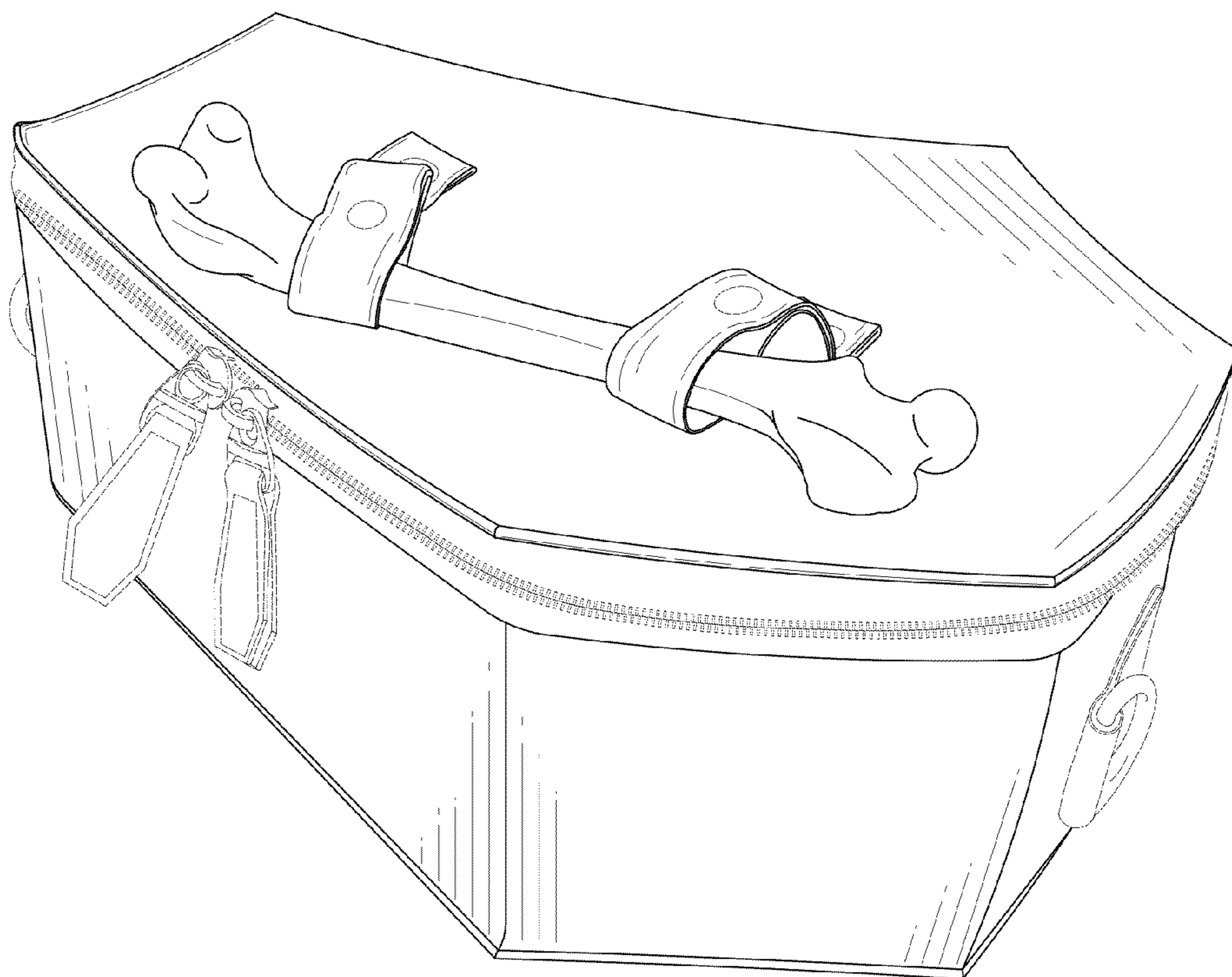

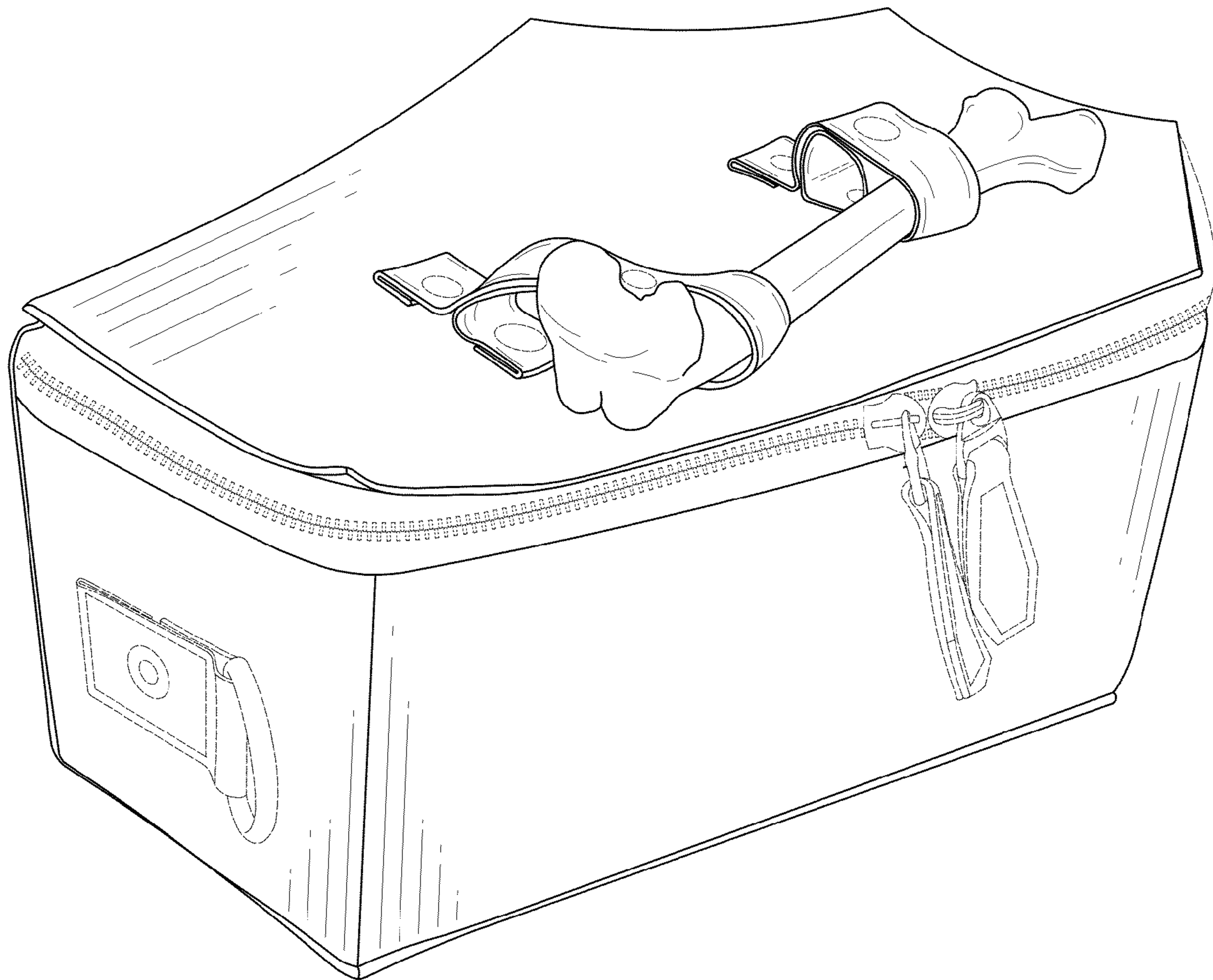

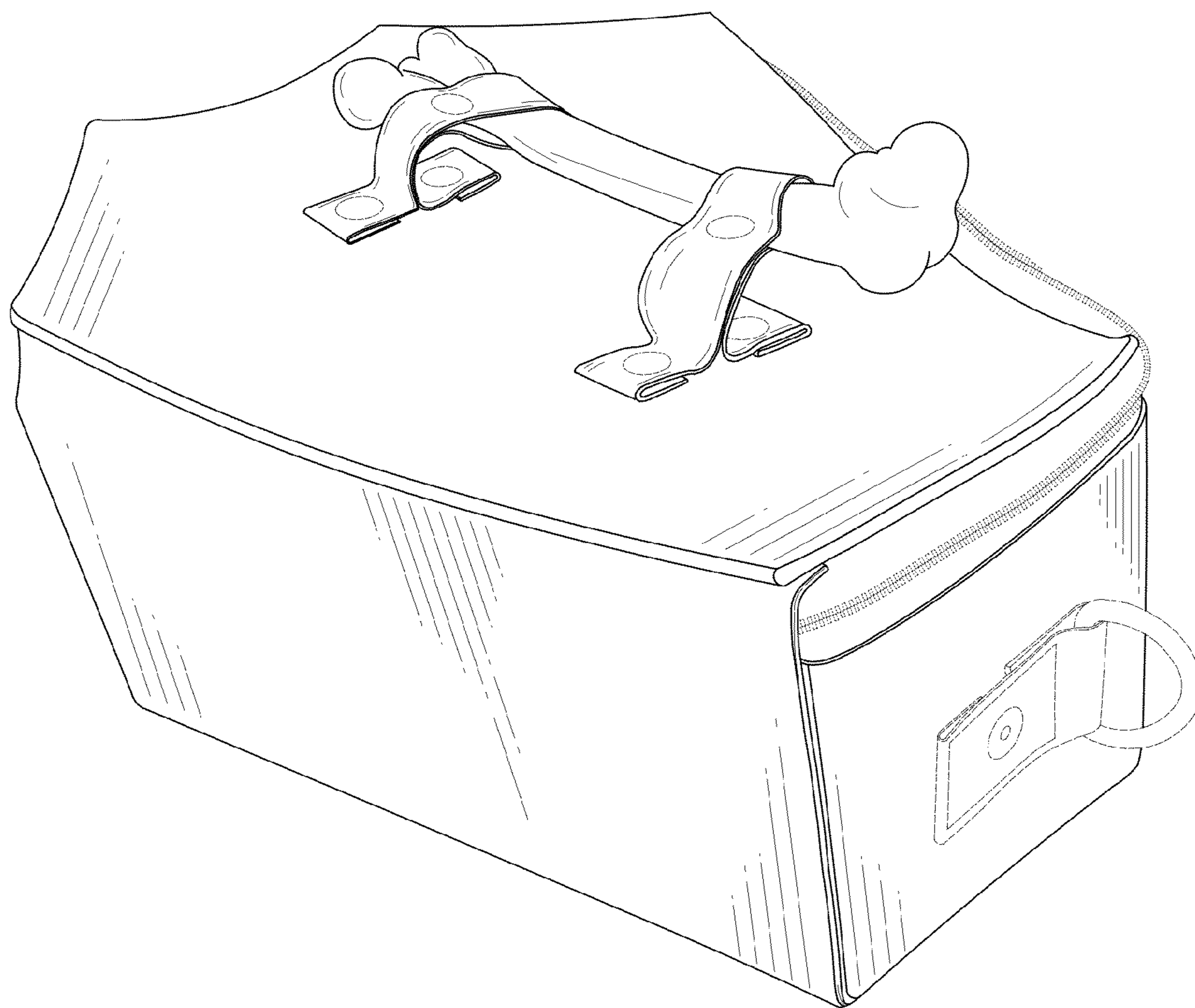

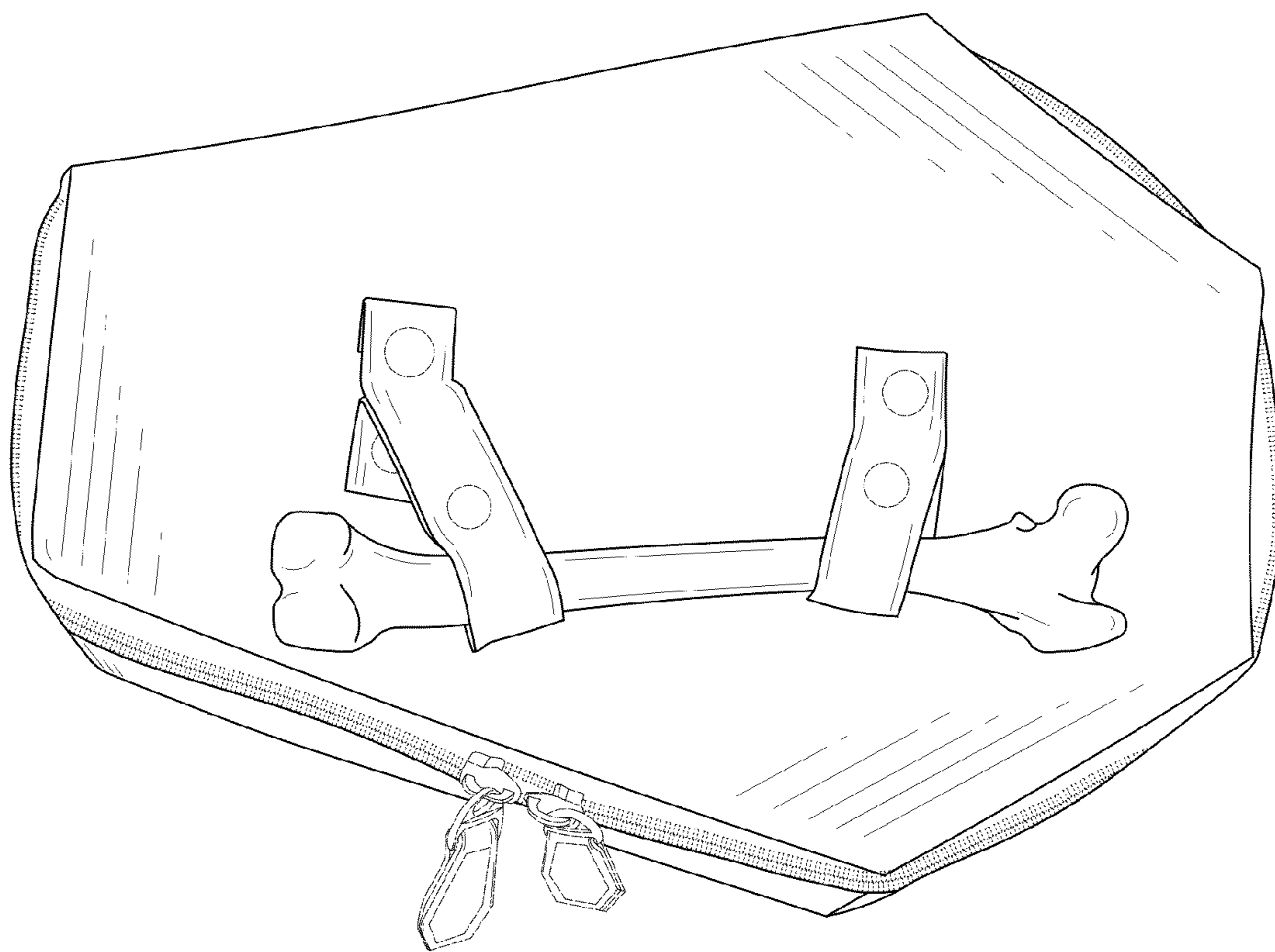

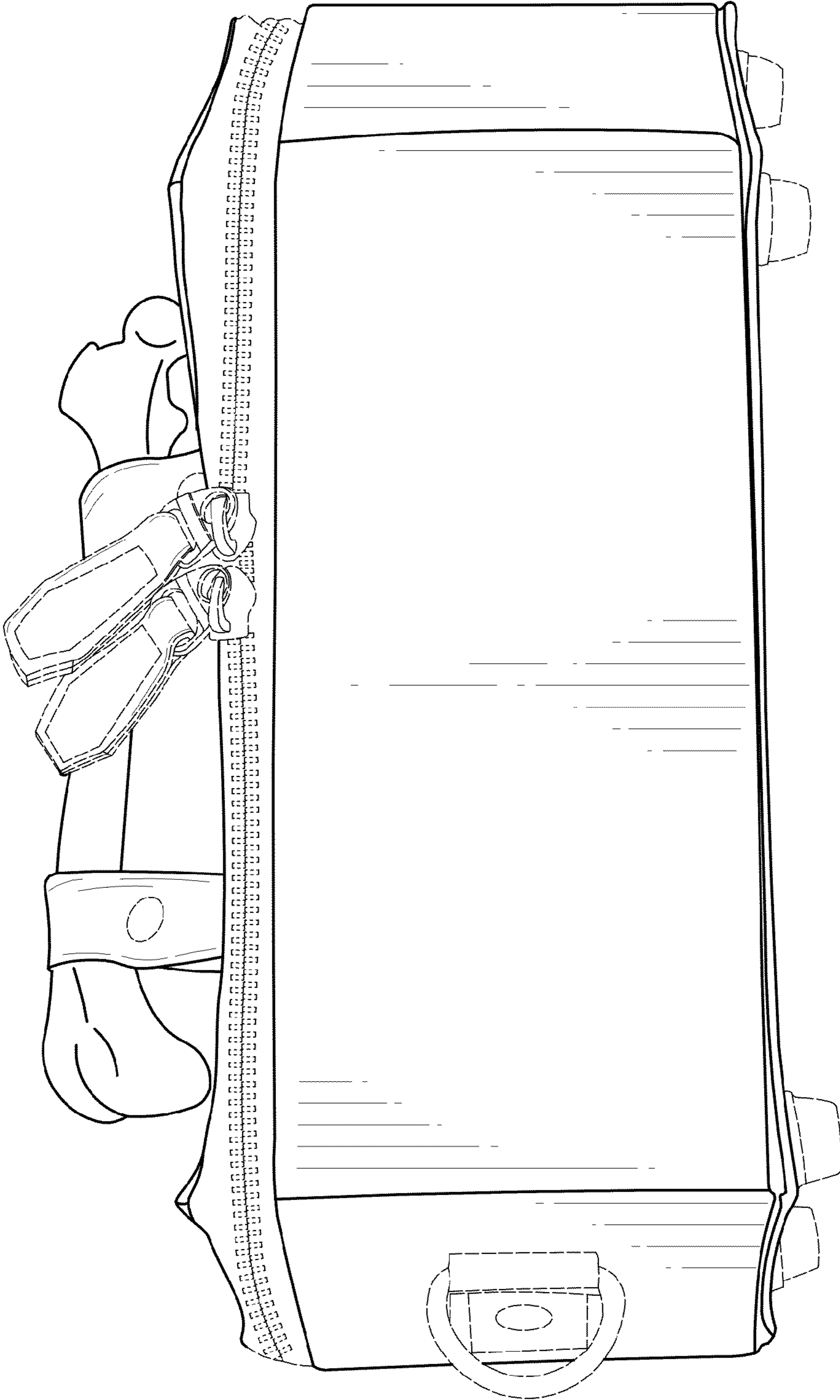
