The ornamental design for a luggage, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a luggage; FIG. 2 is a right side elevational view of the luggage; FIG. 3 is a front elevational view of the luggage; FIG. 4 is a left side elevational view of the luggage; FIG. 5 is a rear elevational view of the luggage; FIG. 6 is a top plan view of the luggage; and, FIG. 7 is a bottom plan view of the luggage. The broken lines illustrate portions of the luggage and form no part of the claimed design.

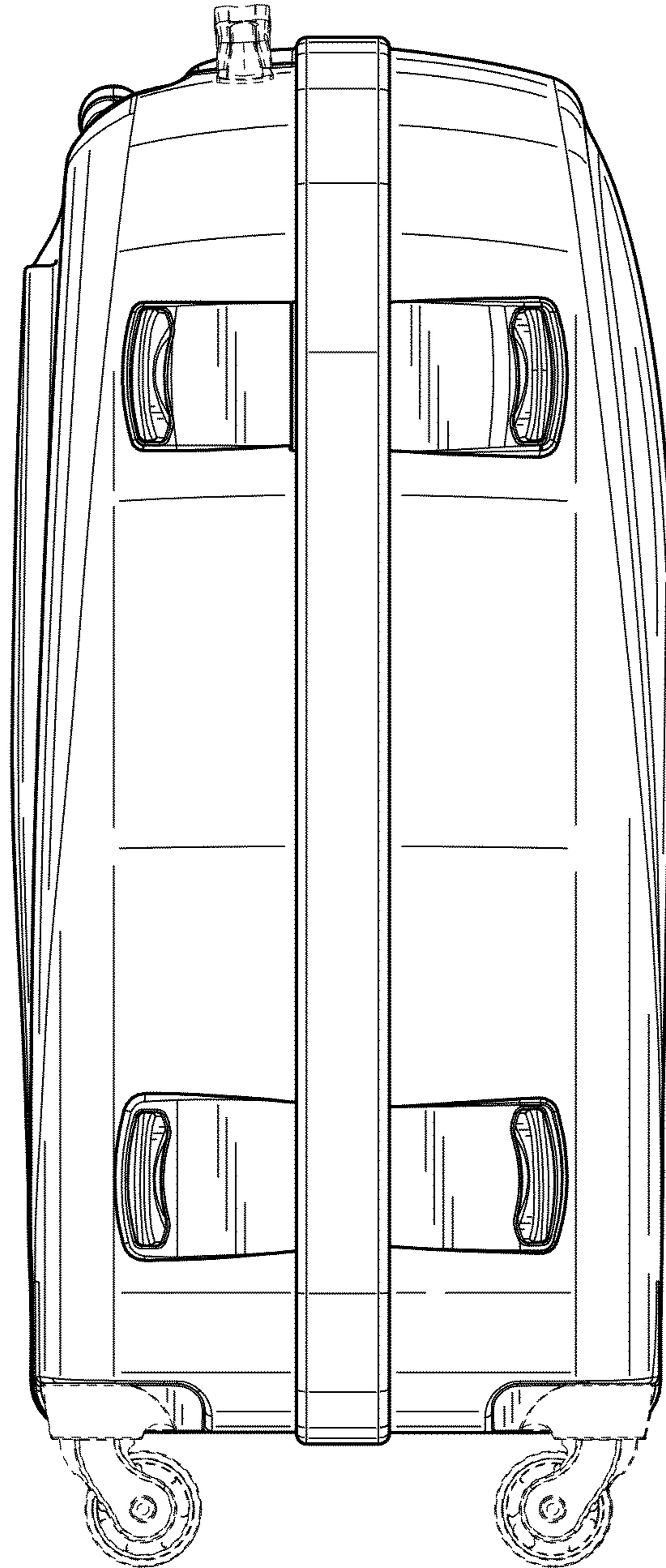

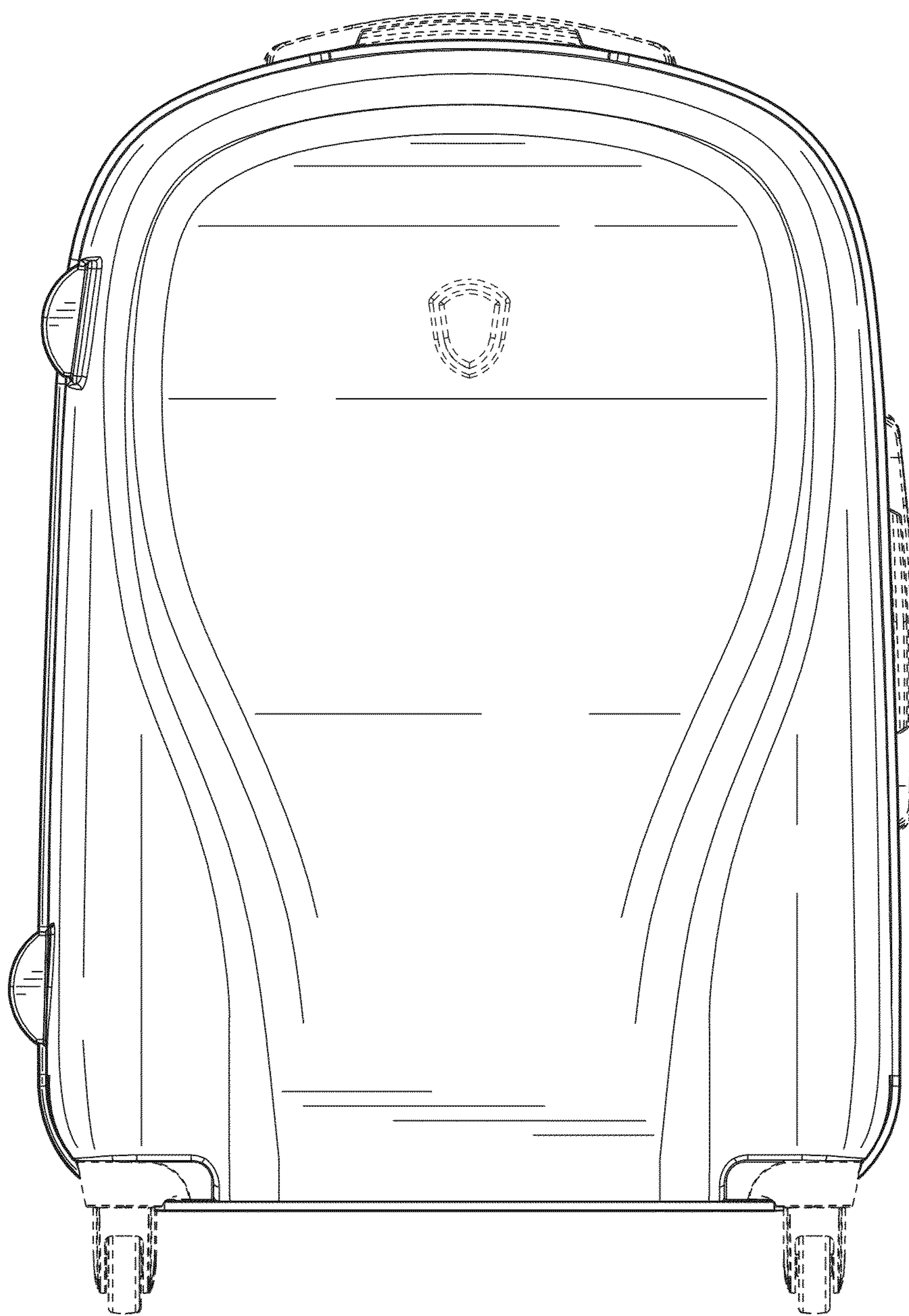

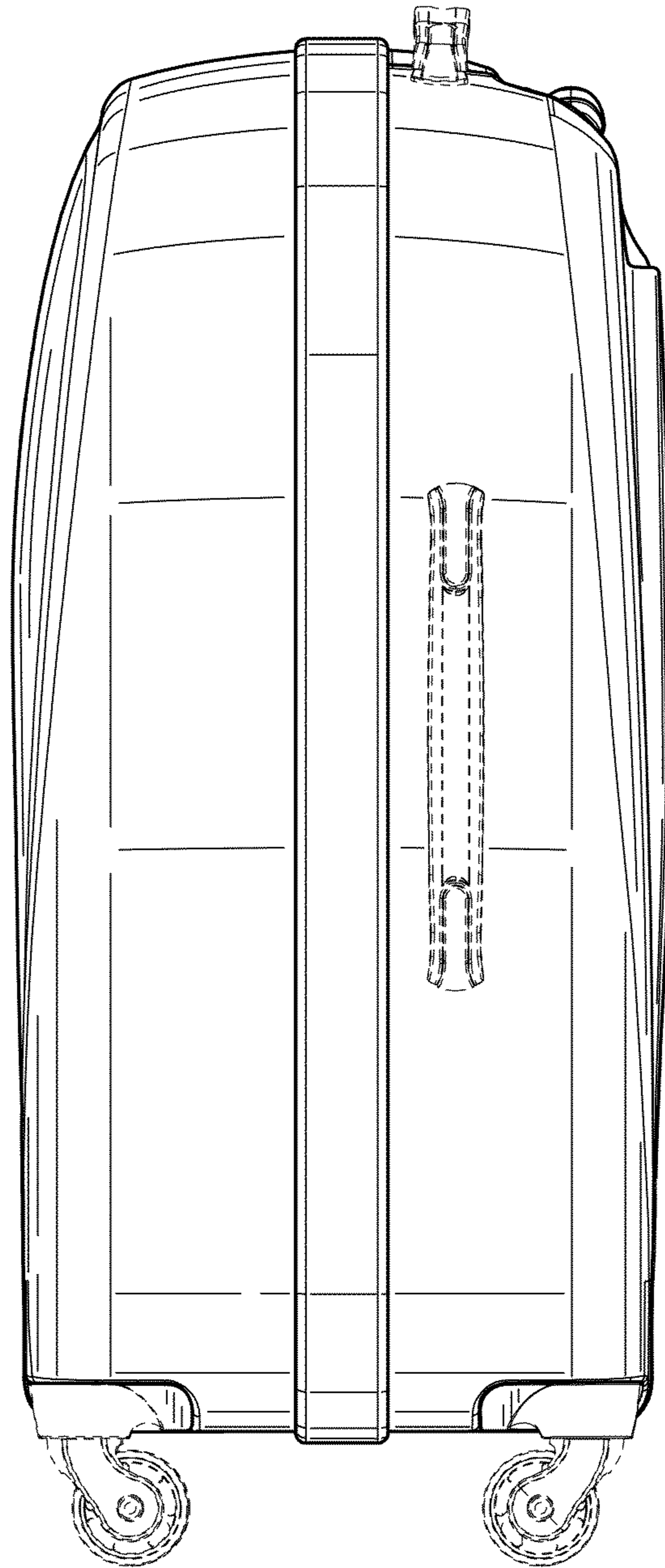

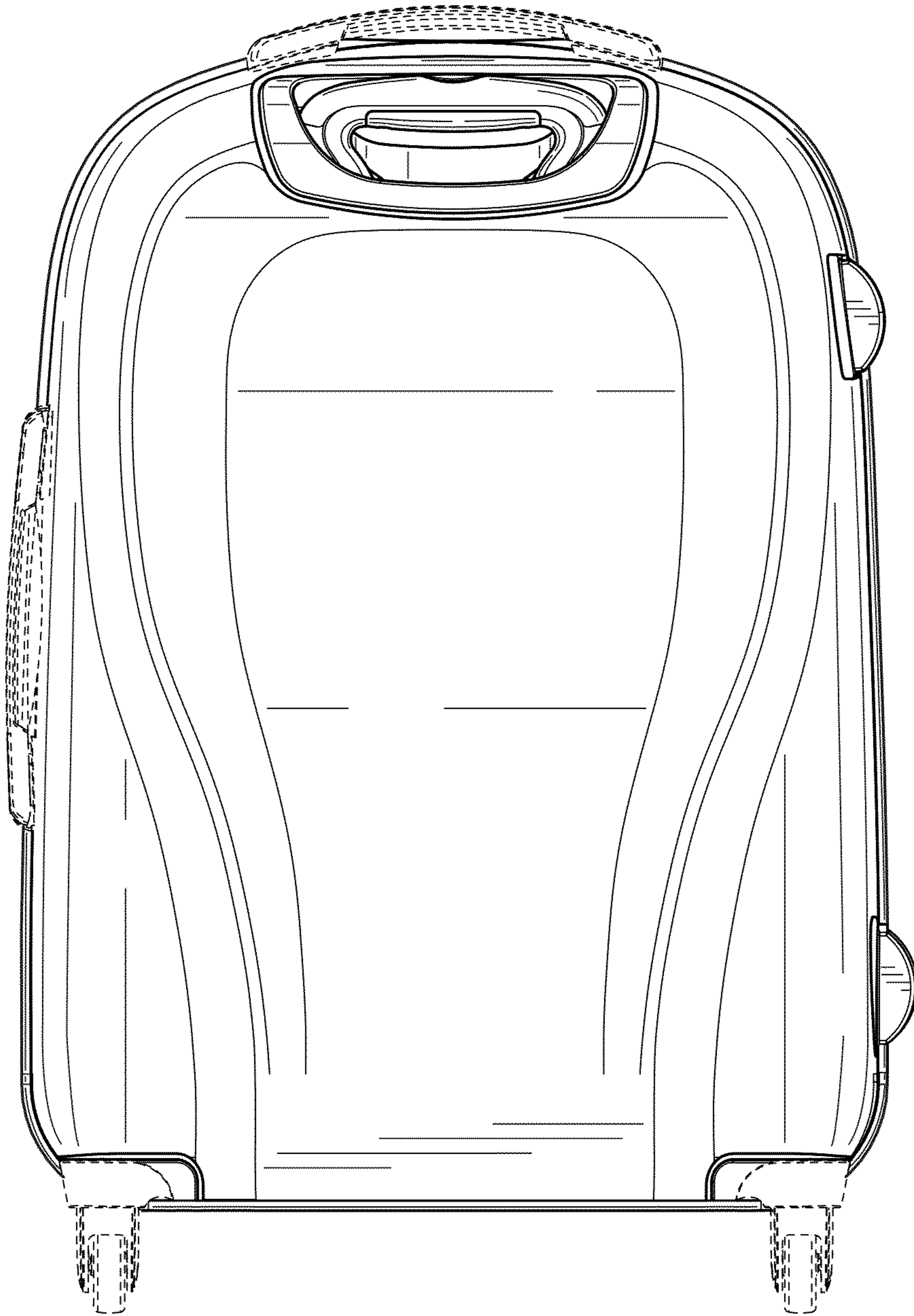

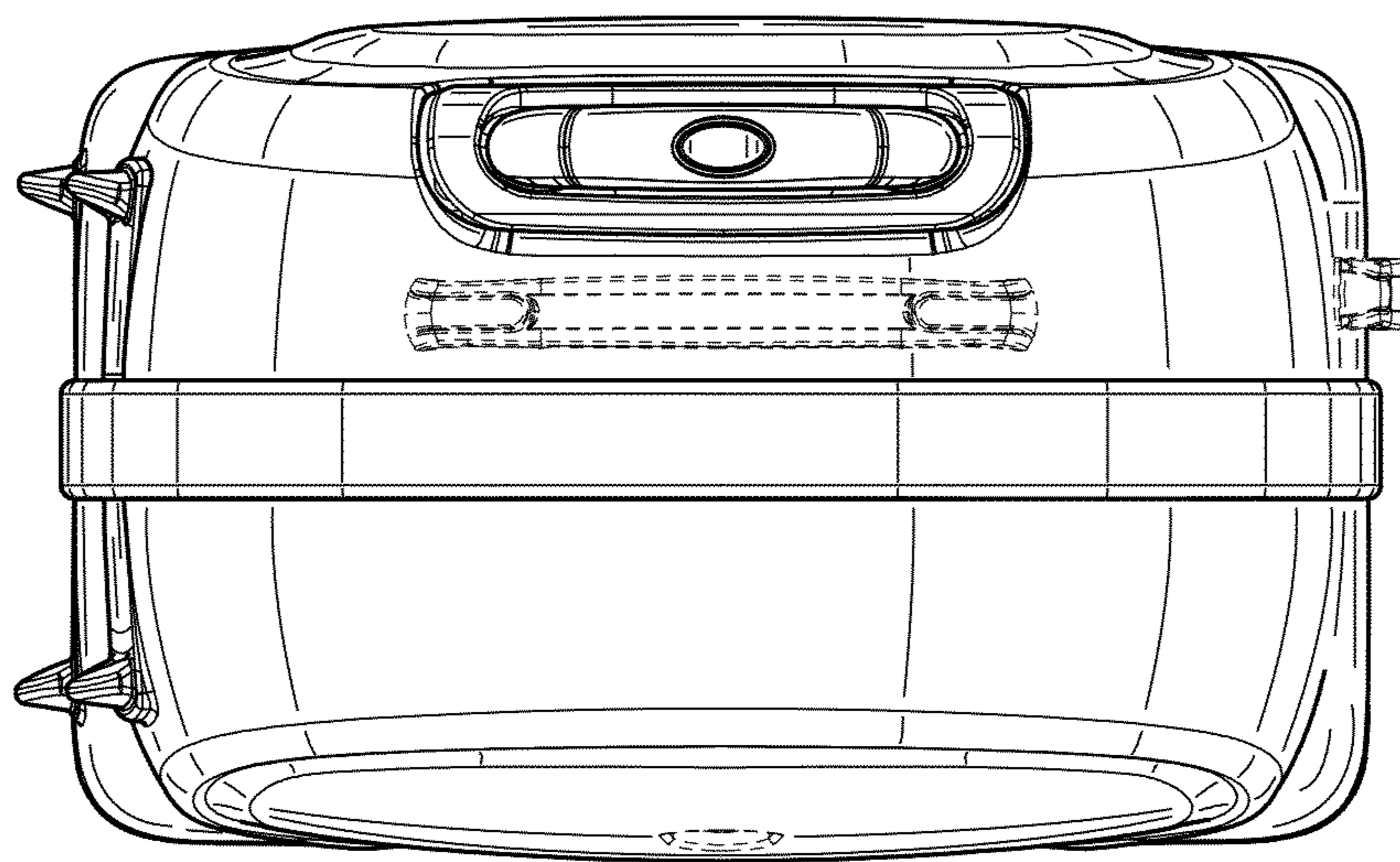

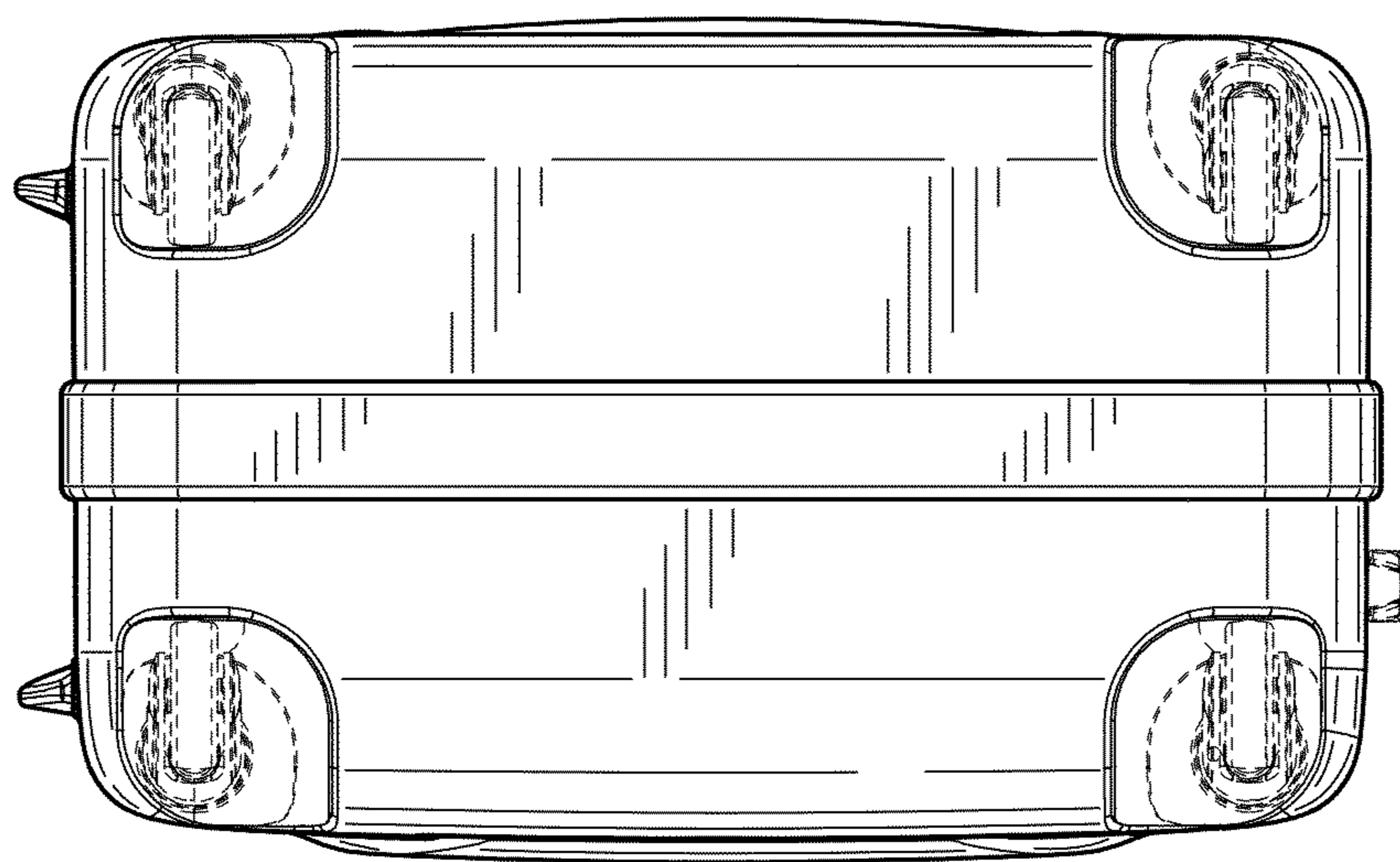
