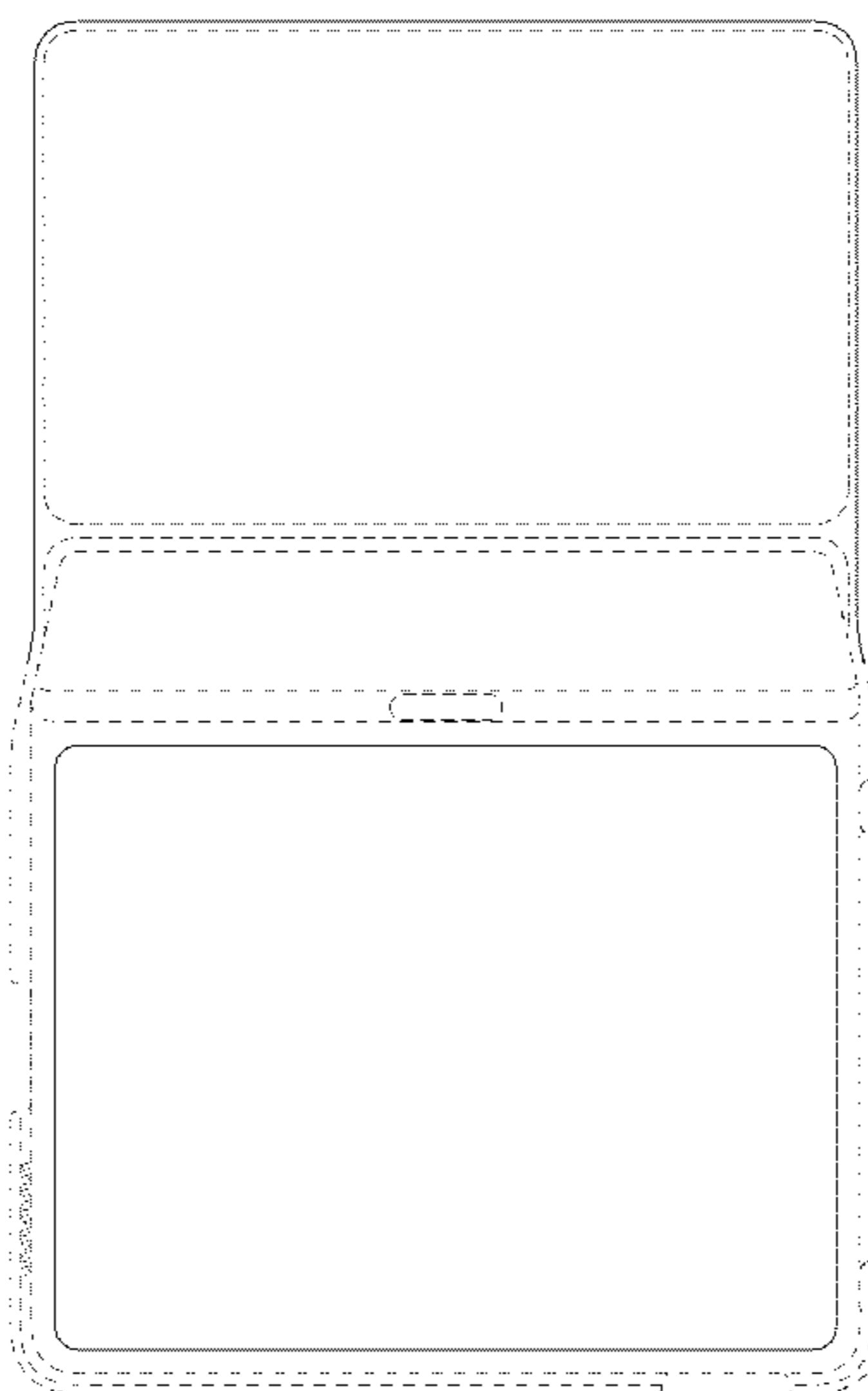
(57) **CLAIM**

The case is shown in an open position; FIG. 2 is another top plan view thereof with the unclaimed flap in a closed position; and, FIG. 3 is a rear view thereof. The broken lines in the Figures show portions of the case that form no part of the claimed design.

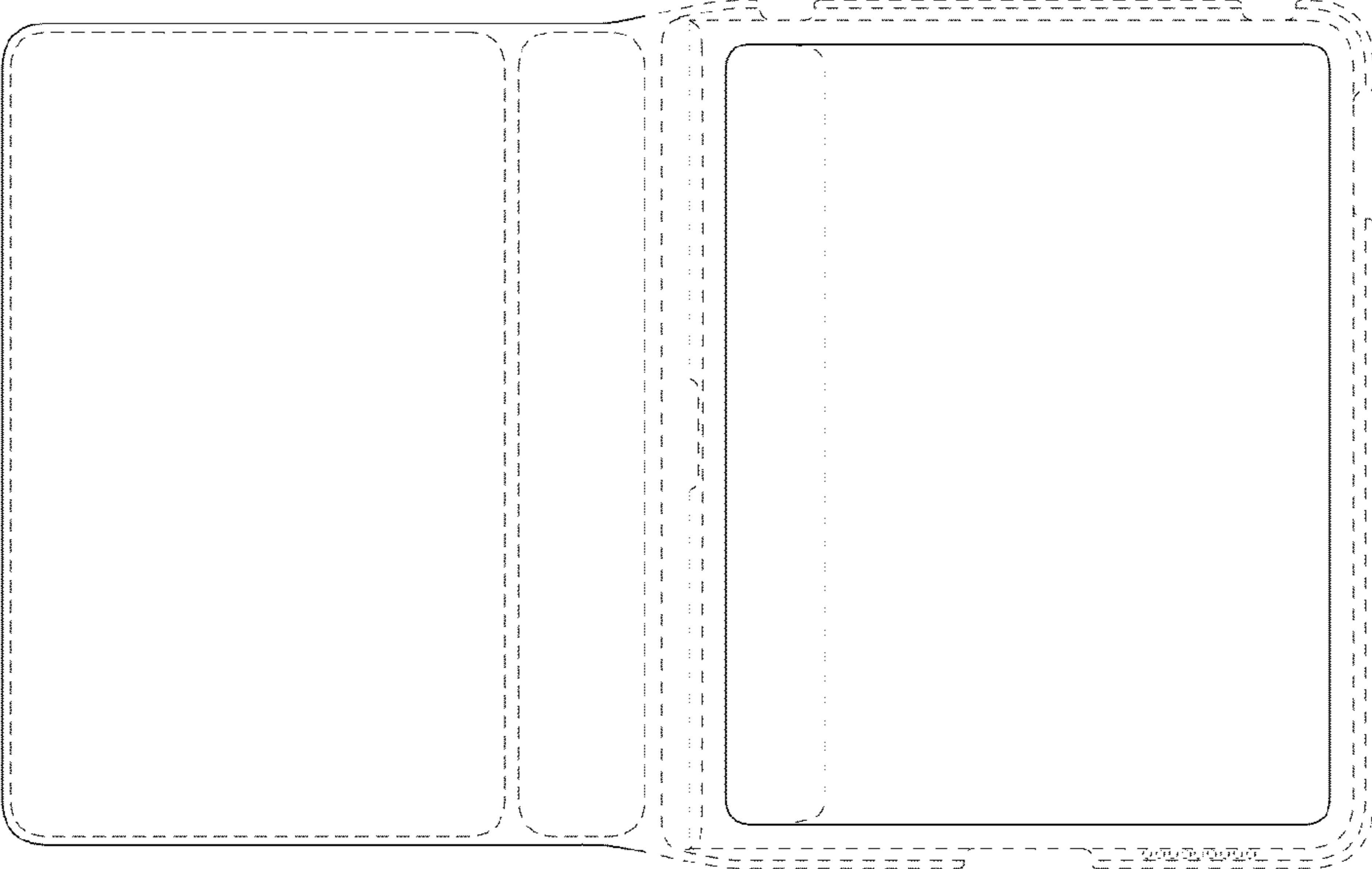

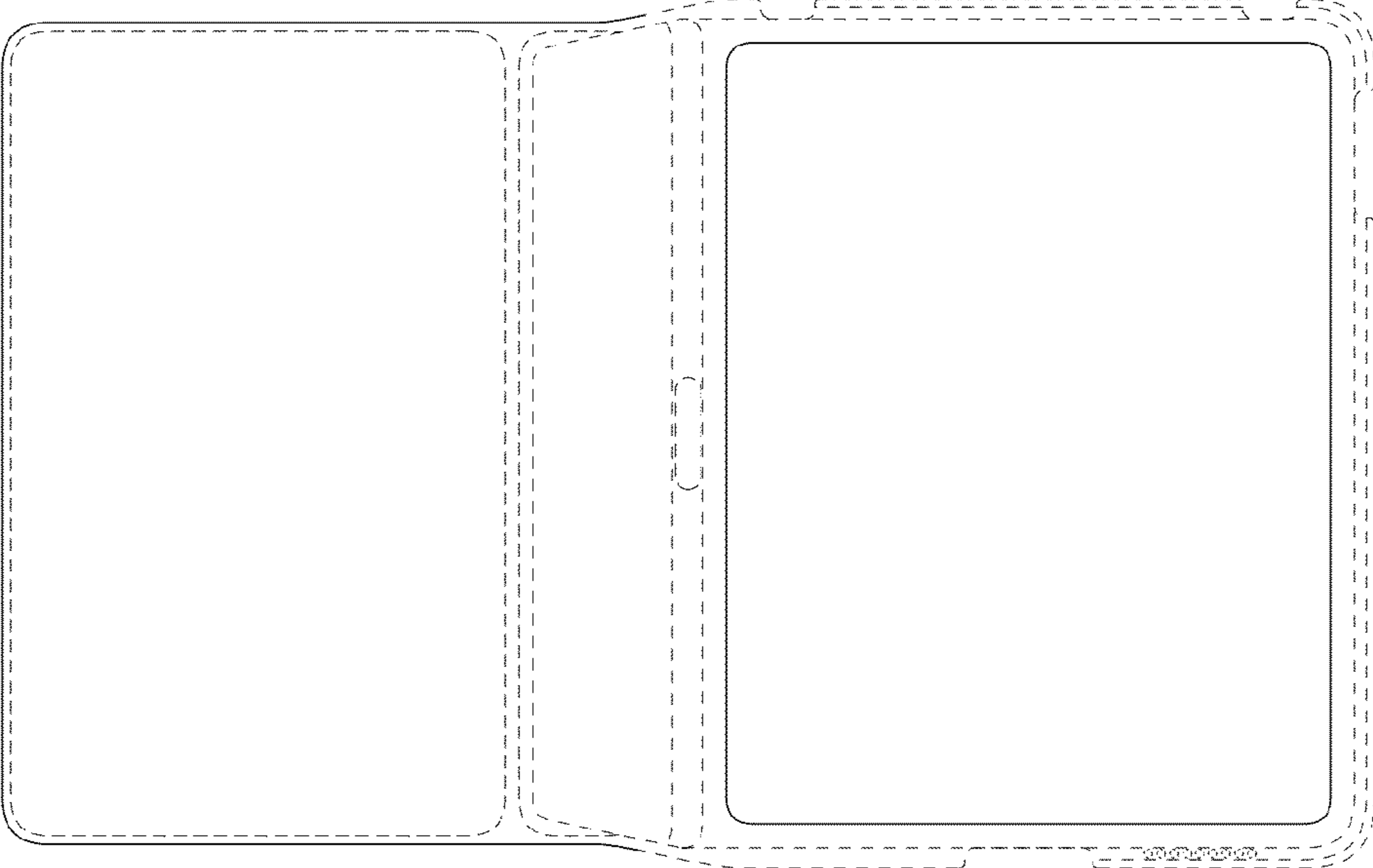

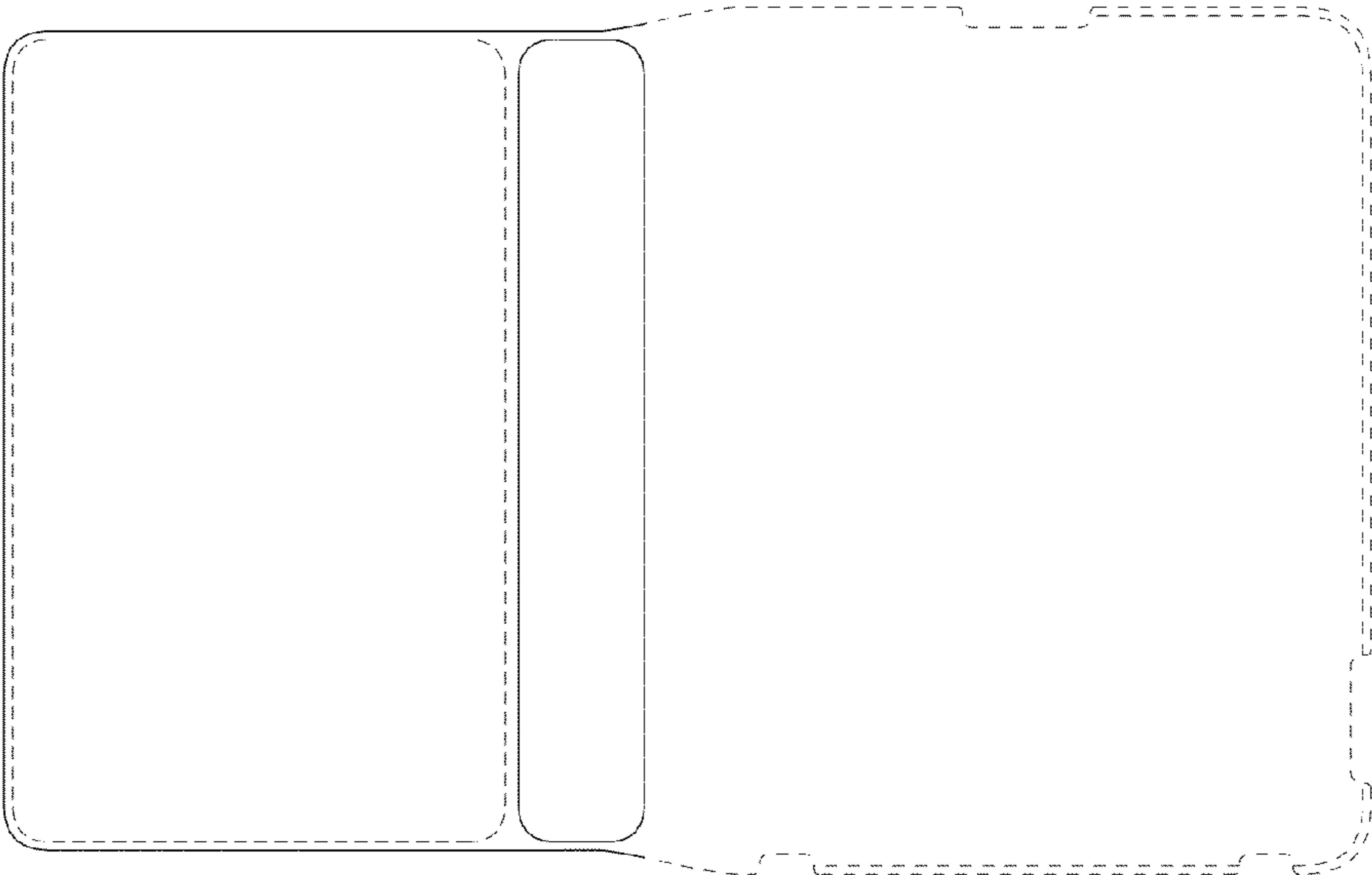
