(57) **CLAIM**

The ornamental design for a food mat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a food mat showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front view thereof, the back view being identical;

FIG. 4 is a sectional view taken along line 4-4 of FIG. 2;

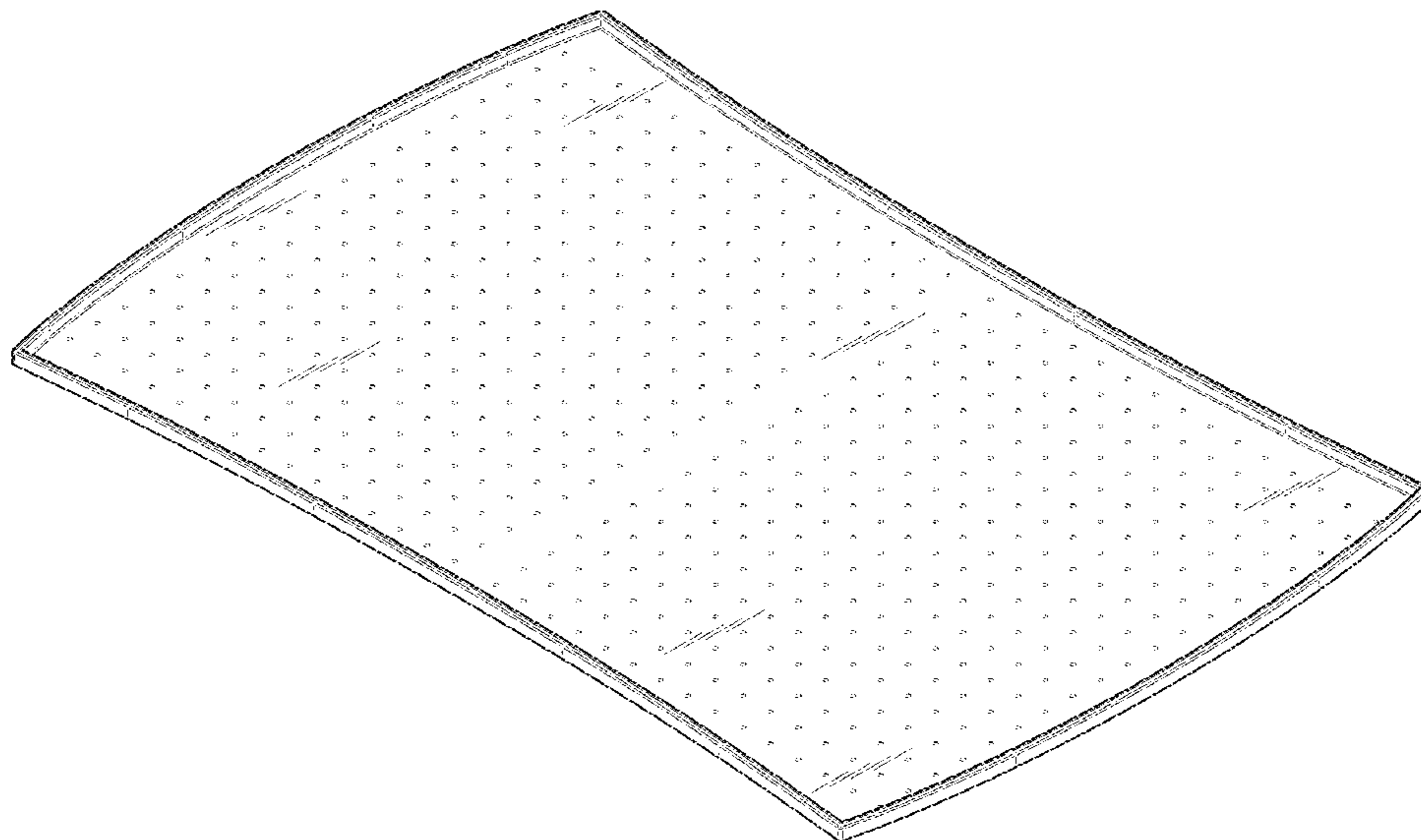
FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side elevation view thereof, the left side elevation being identical; and,

FIG. 7 is an enlarged detail view of the area labeled "7" in FIG. 4.

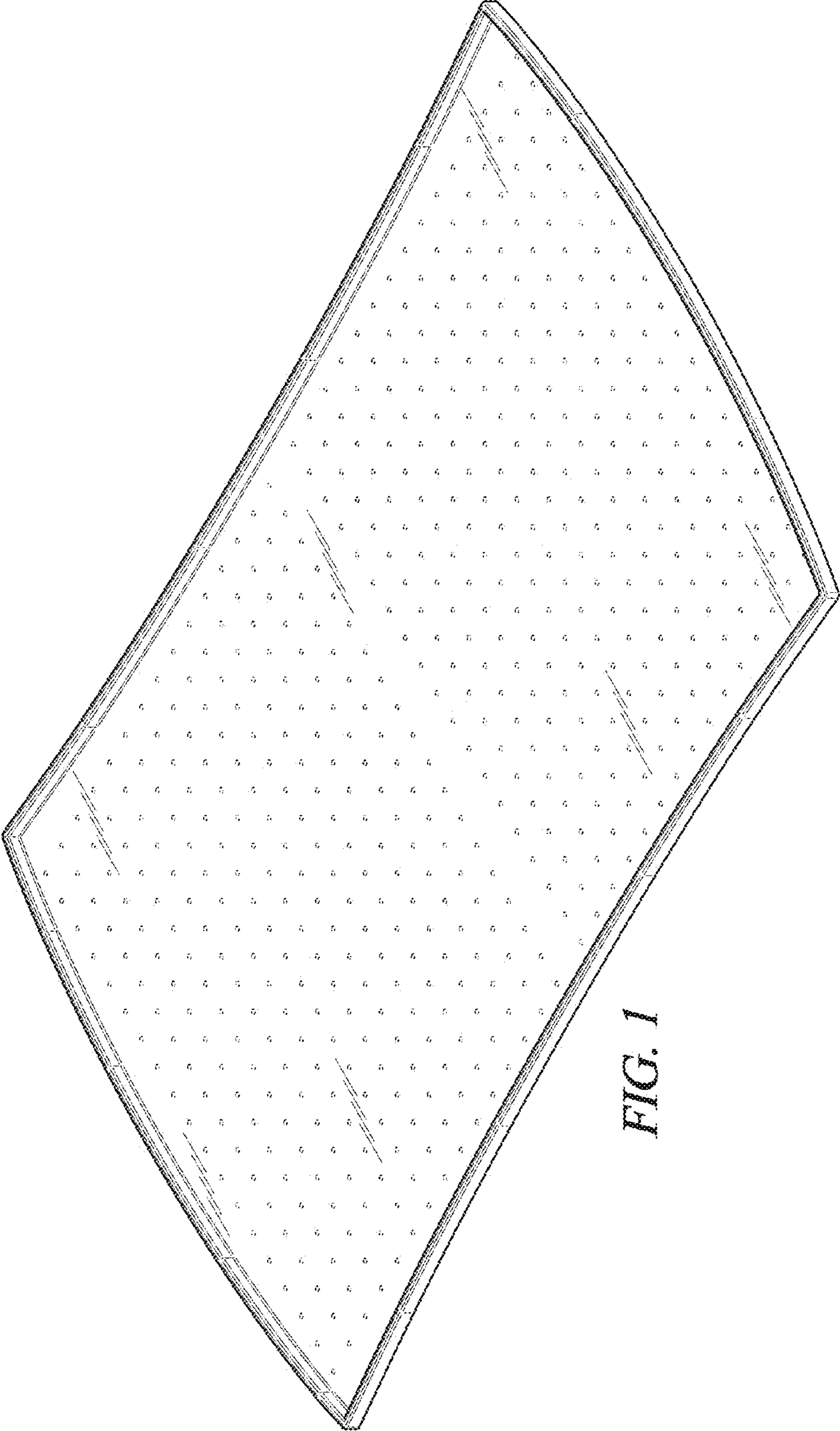

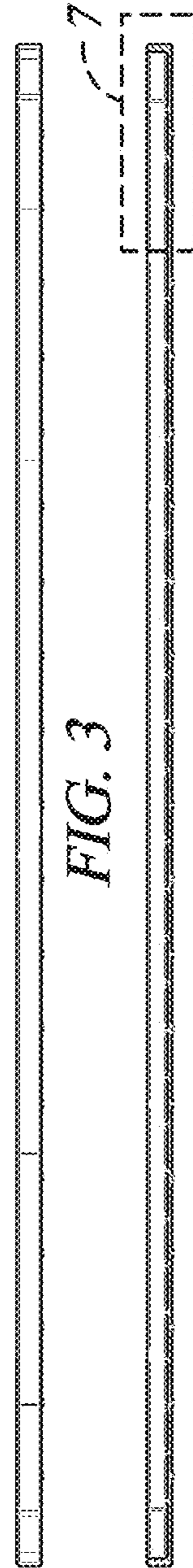
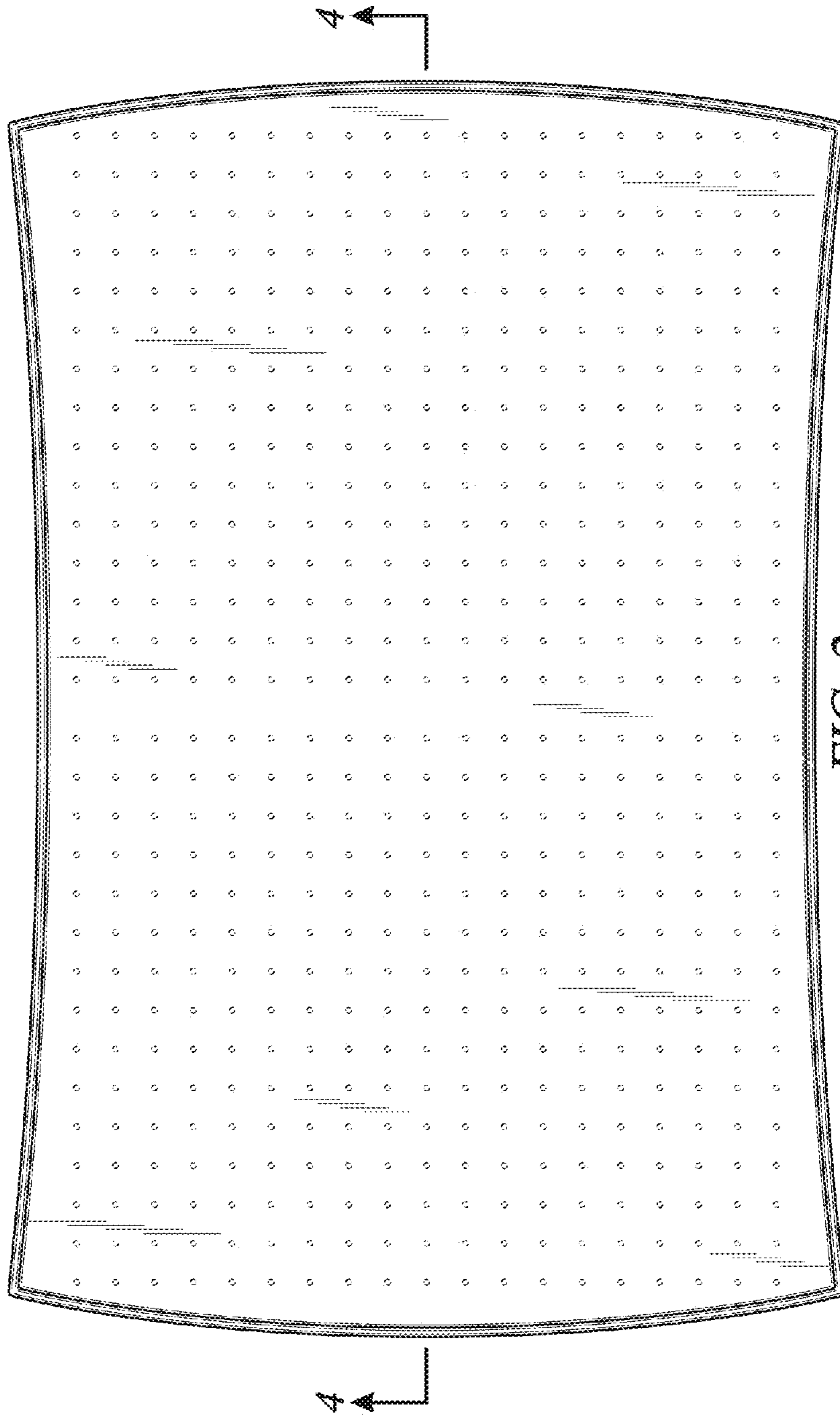

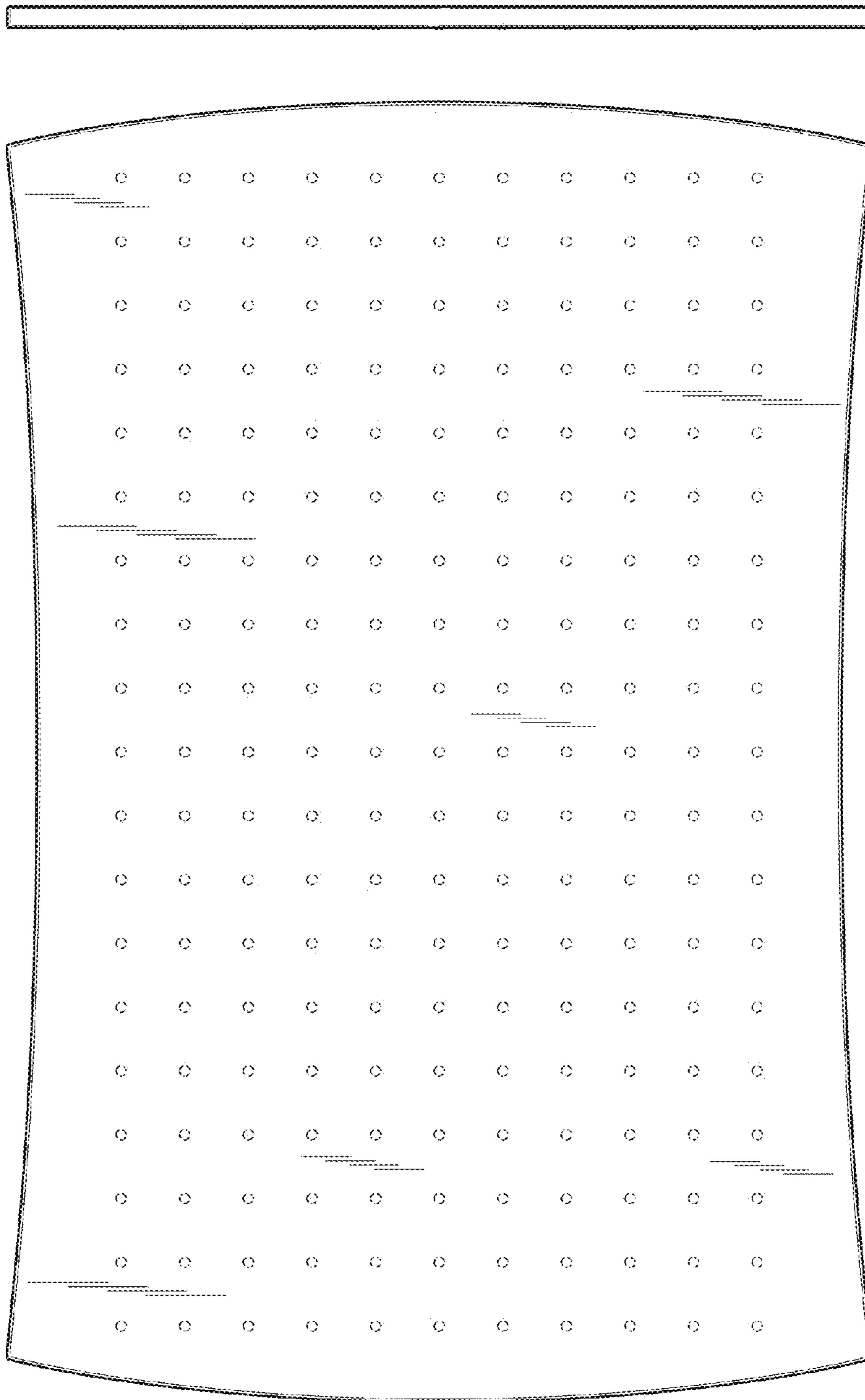

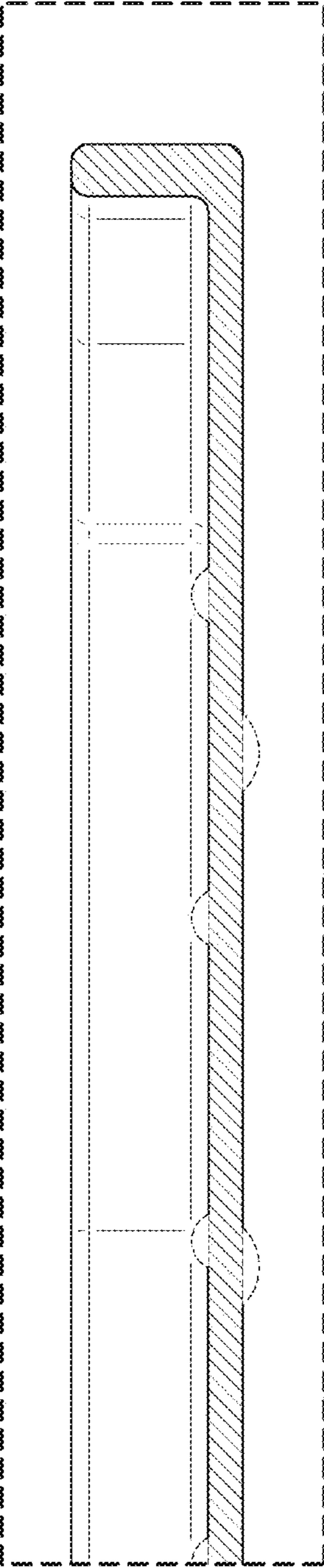
